DESCRIPTION

FIG. 1 is a top plan view of a double towel bar incorporating my new design;

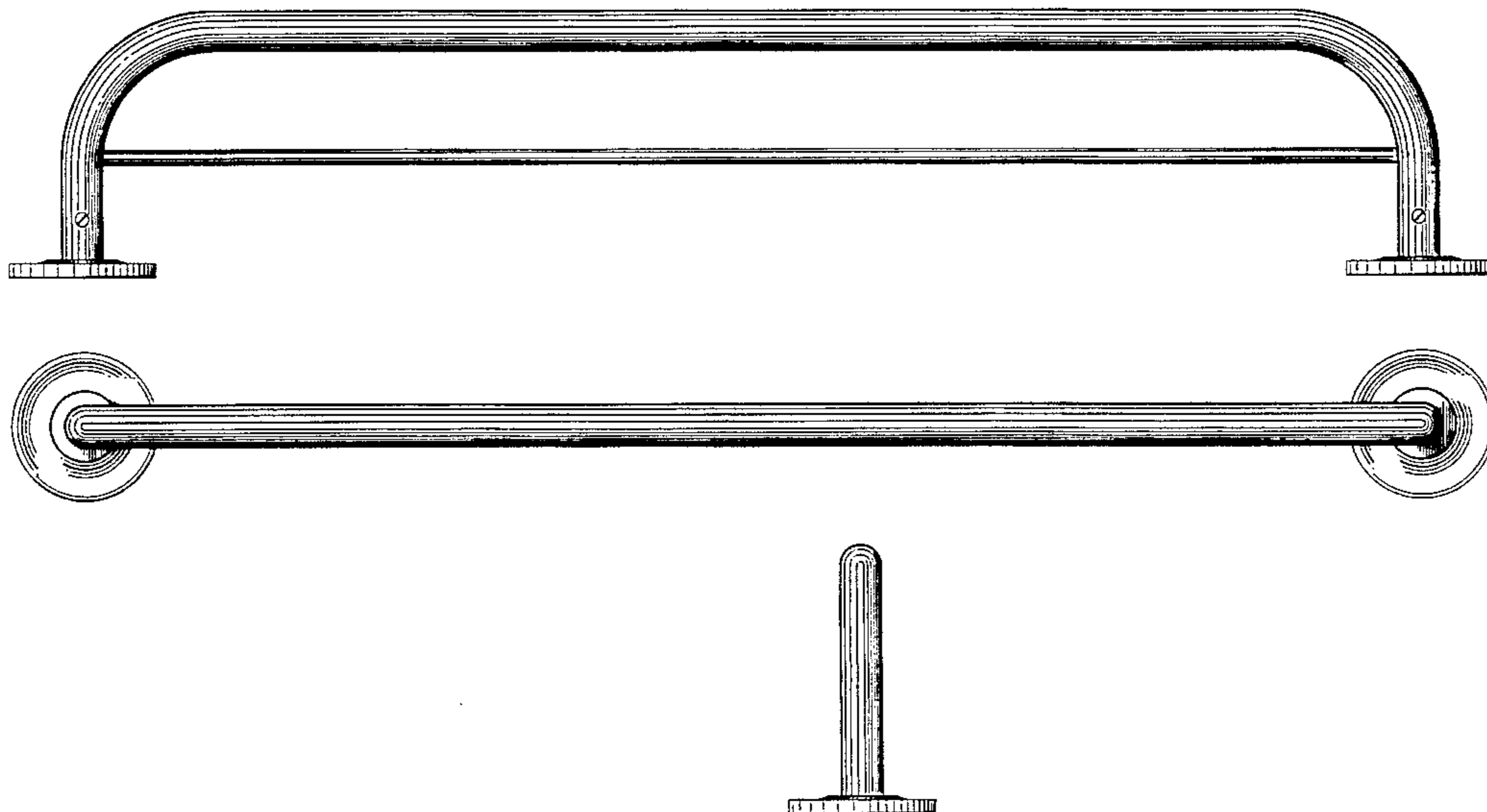

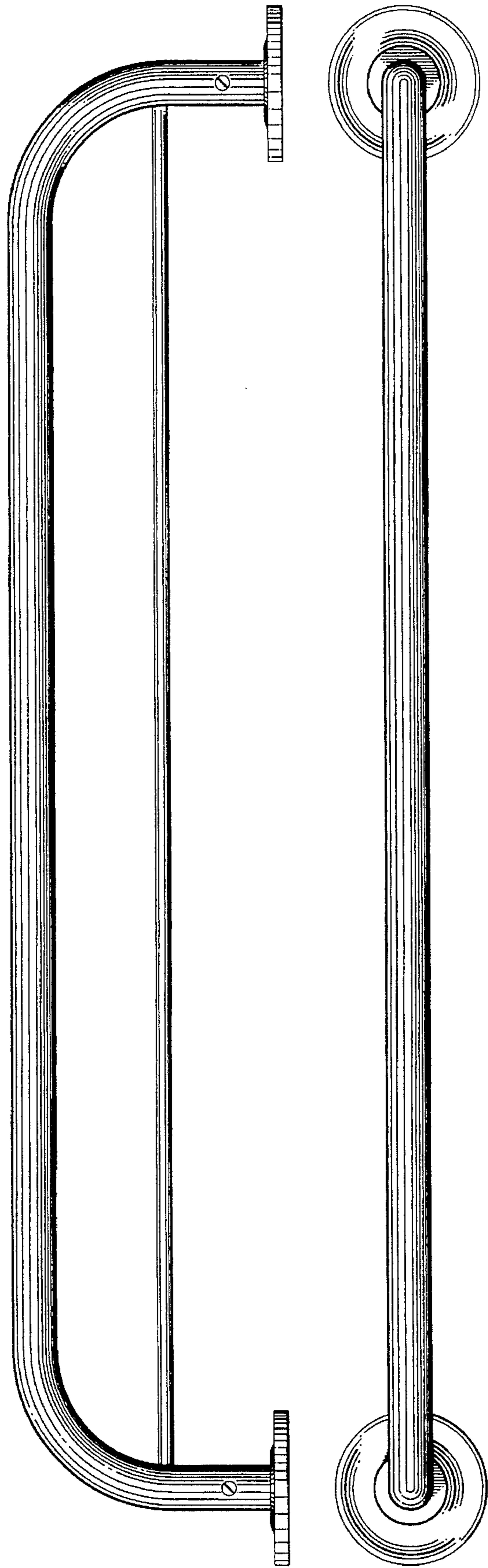

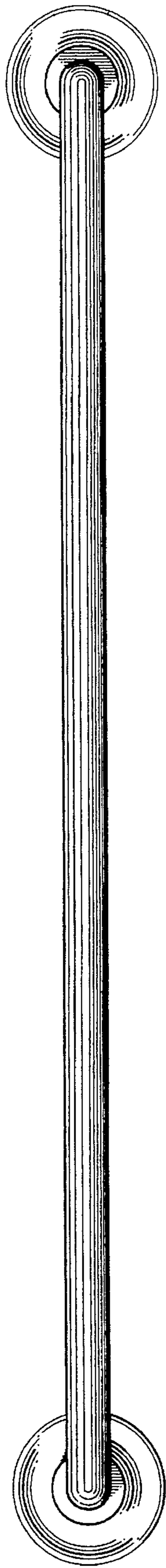

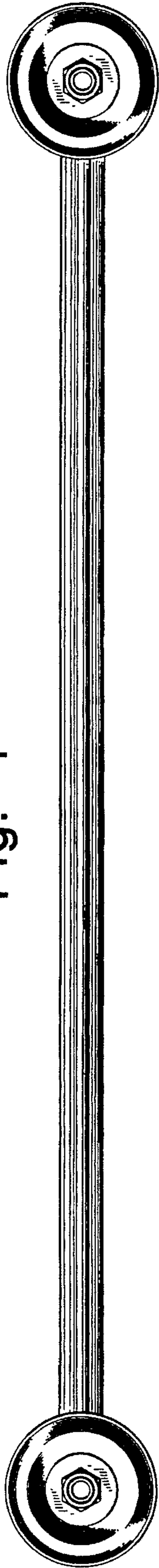
