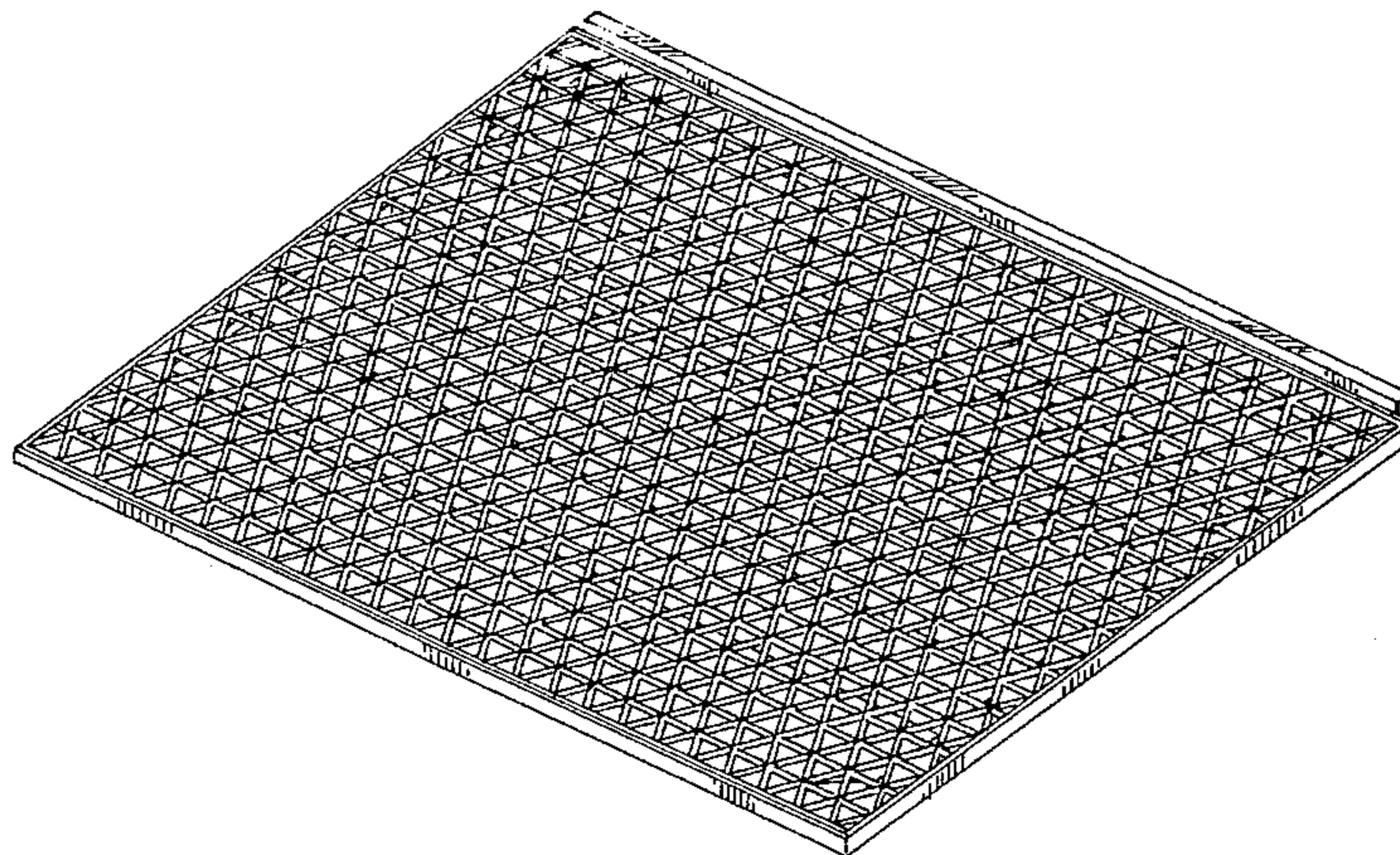
### [57] CLAIM

### DESCRIPTION

FIG. 1 is a perspective view of a screen according to the present invention;  
 FIG. 2 is a top view of the screen of FIG. 1;  
 FIG. 3 is a bottom view of the screen of FIG. 1;  
 FIG. 4 is a side view of one side of the screen of FIG. 1;  
 FIG. 5 is a side view of another side of the screen of FIG. 1 opposite the side shown in FIG. 4;  
 FIG. 6 is an end view of the screen of FIG. 1; and,  
 FIG. 7 is another end view of the screen of FIG. 1 opposite the end shown in FIG. 6.

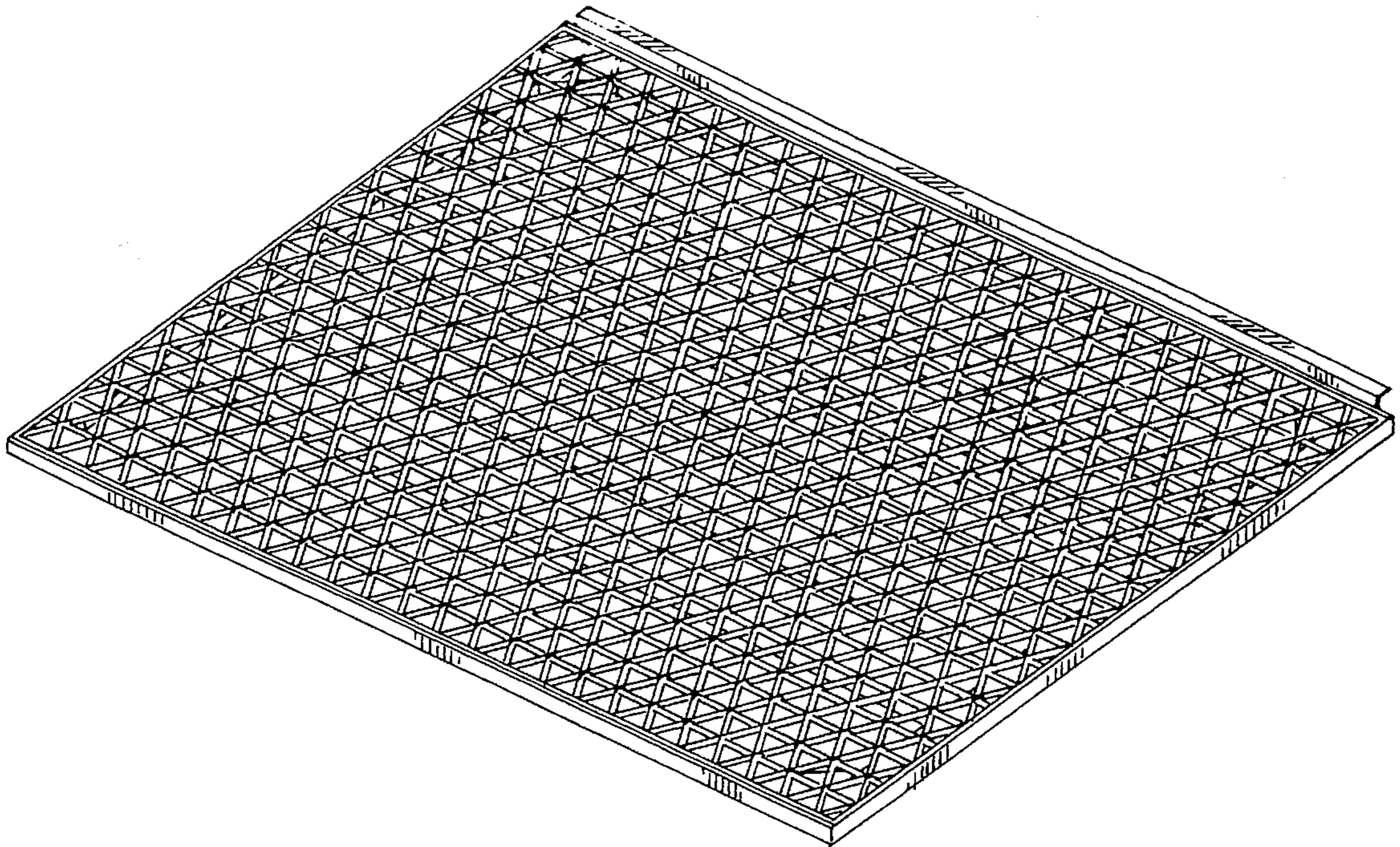

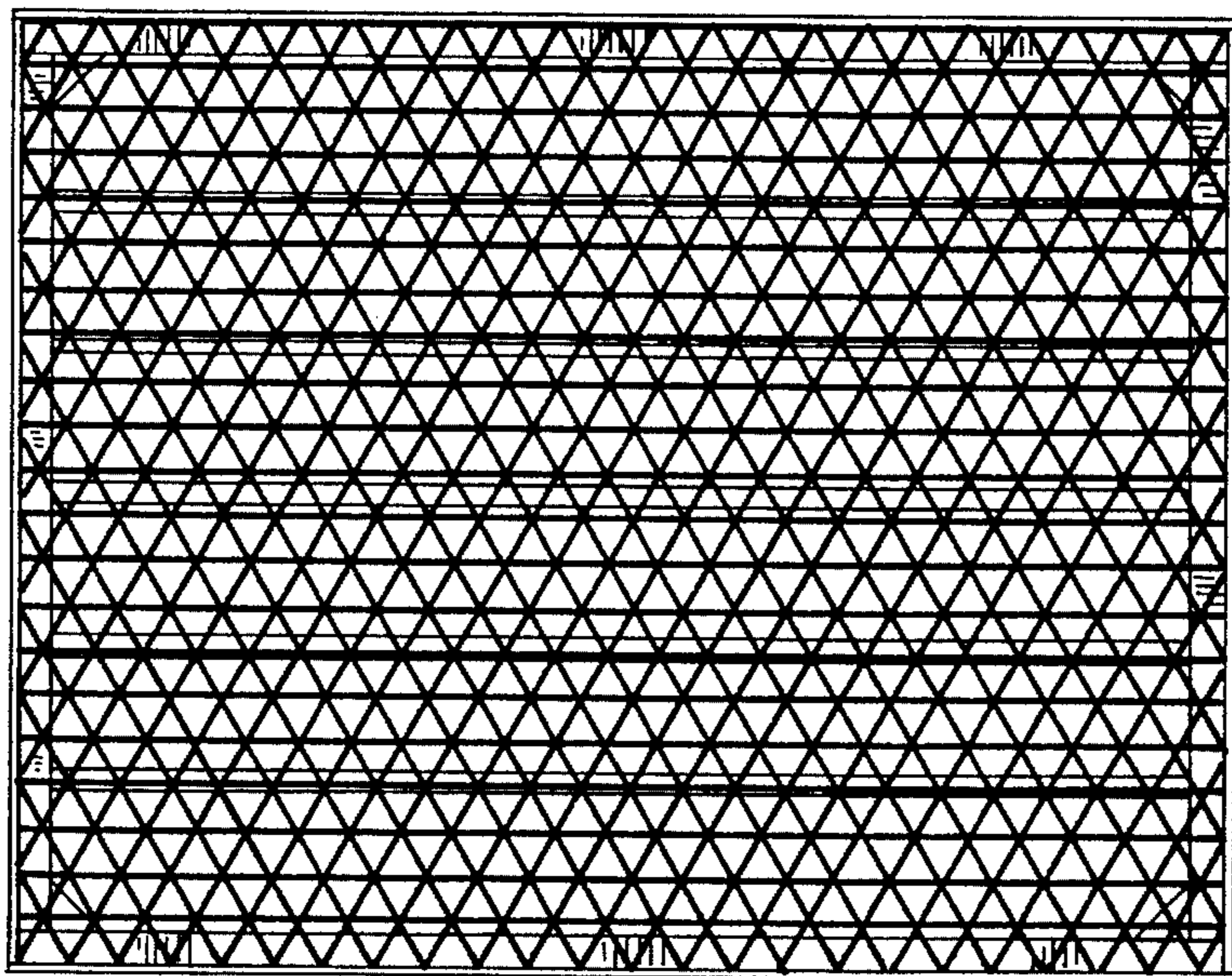

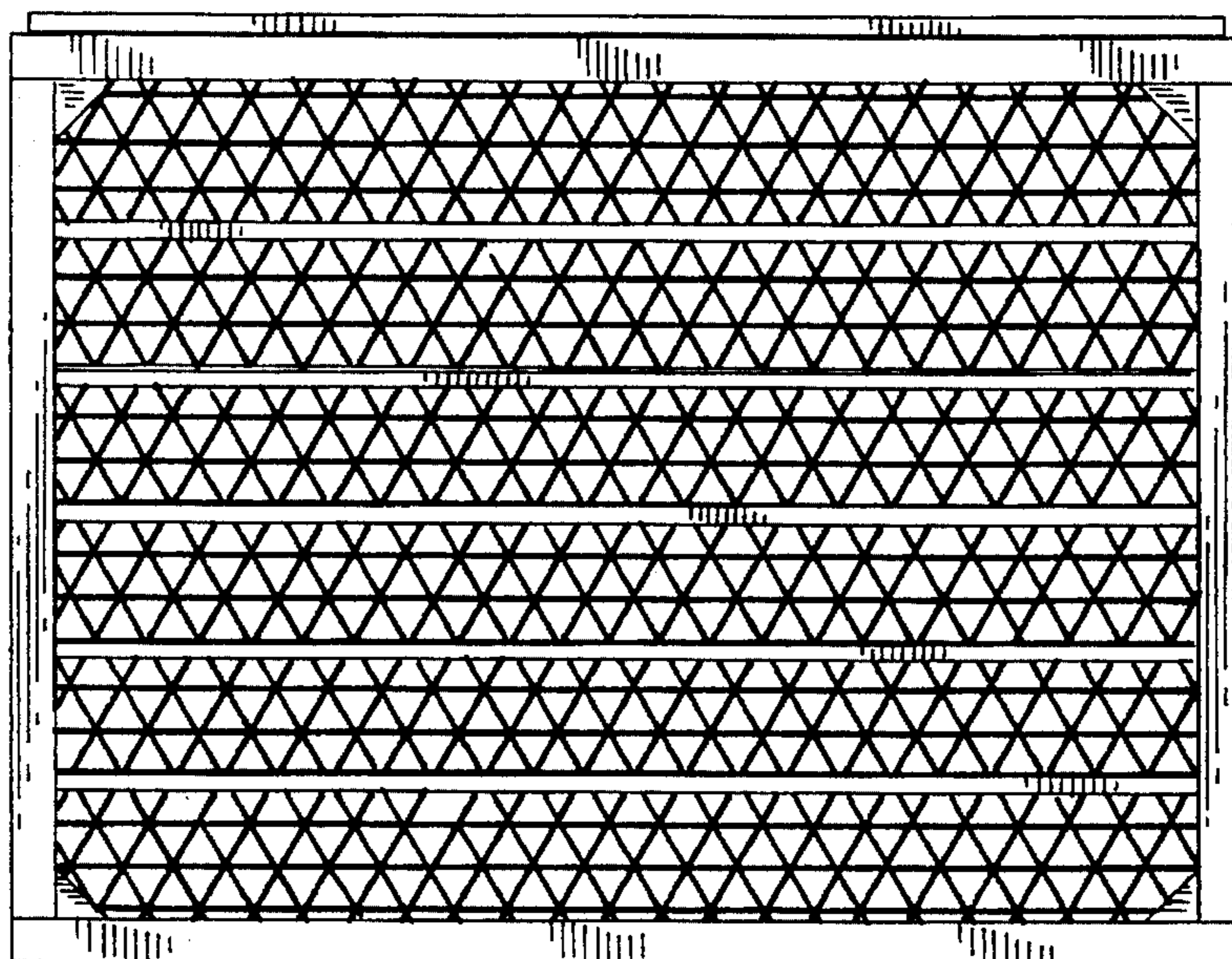

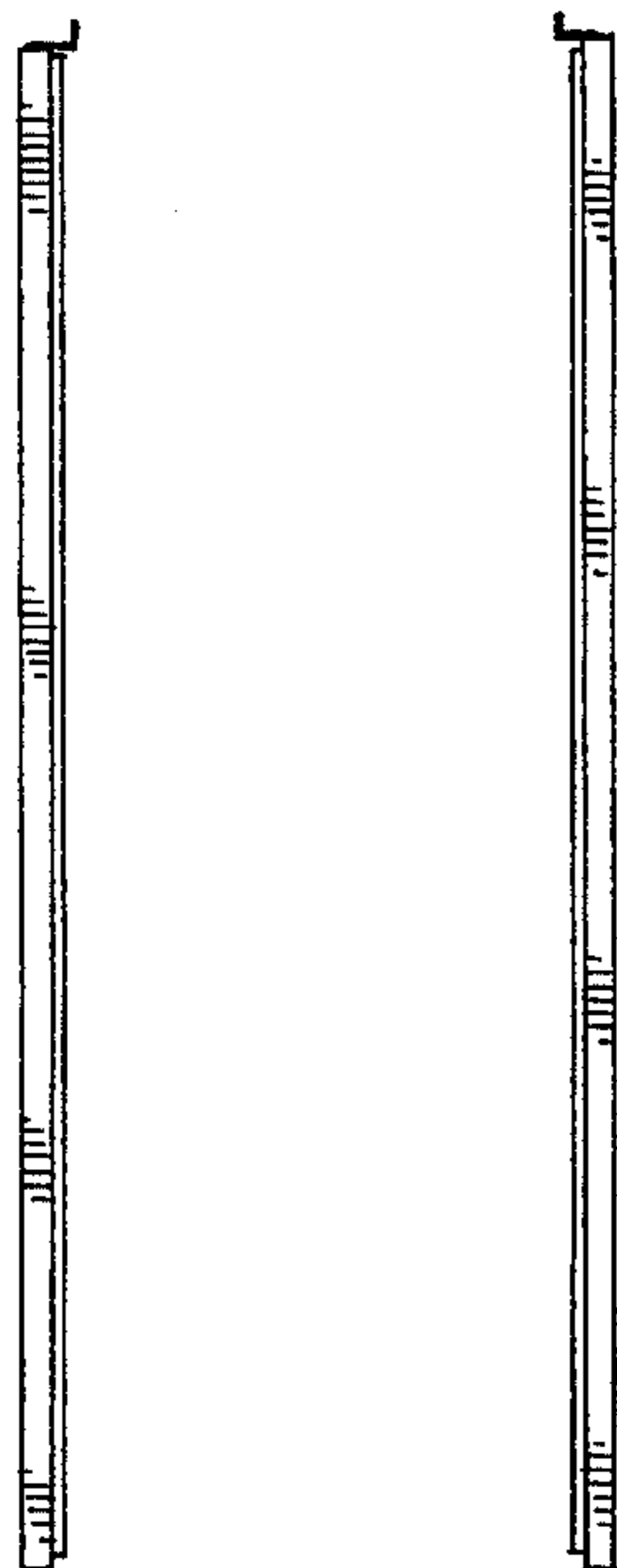

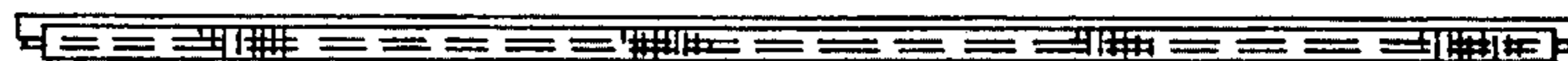

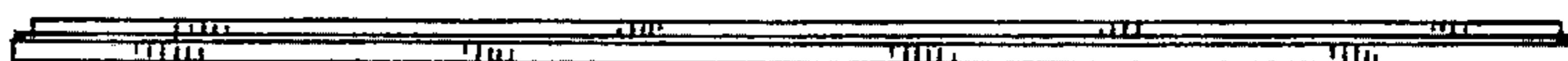
