FIG. 6 is a left side elevation view thereof.

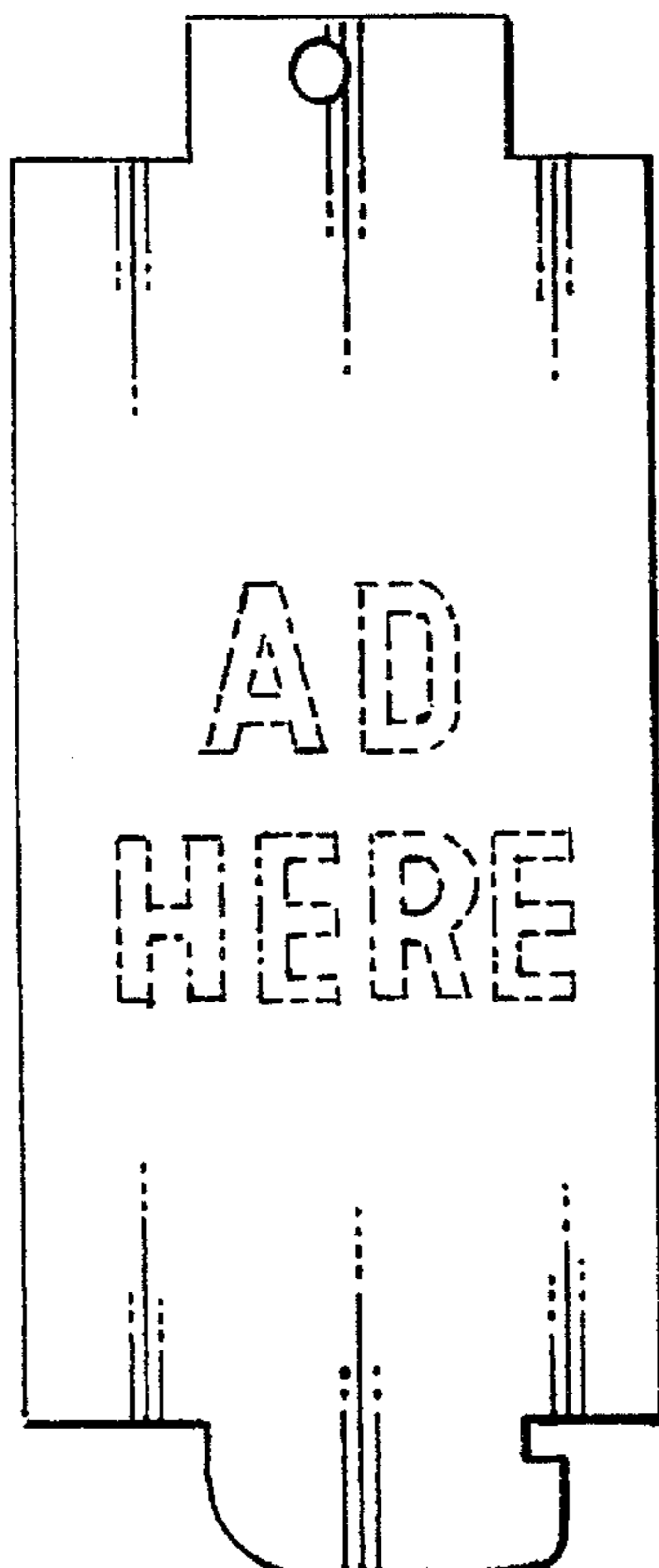

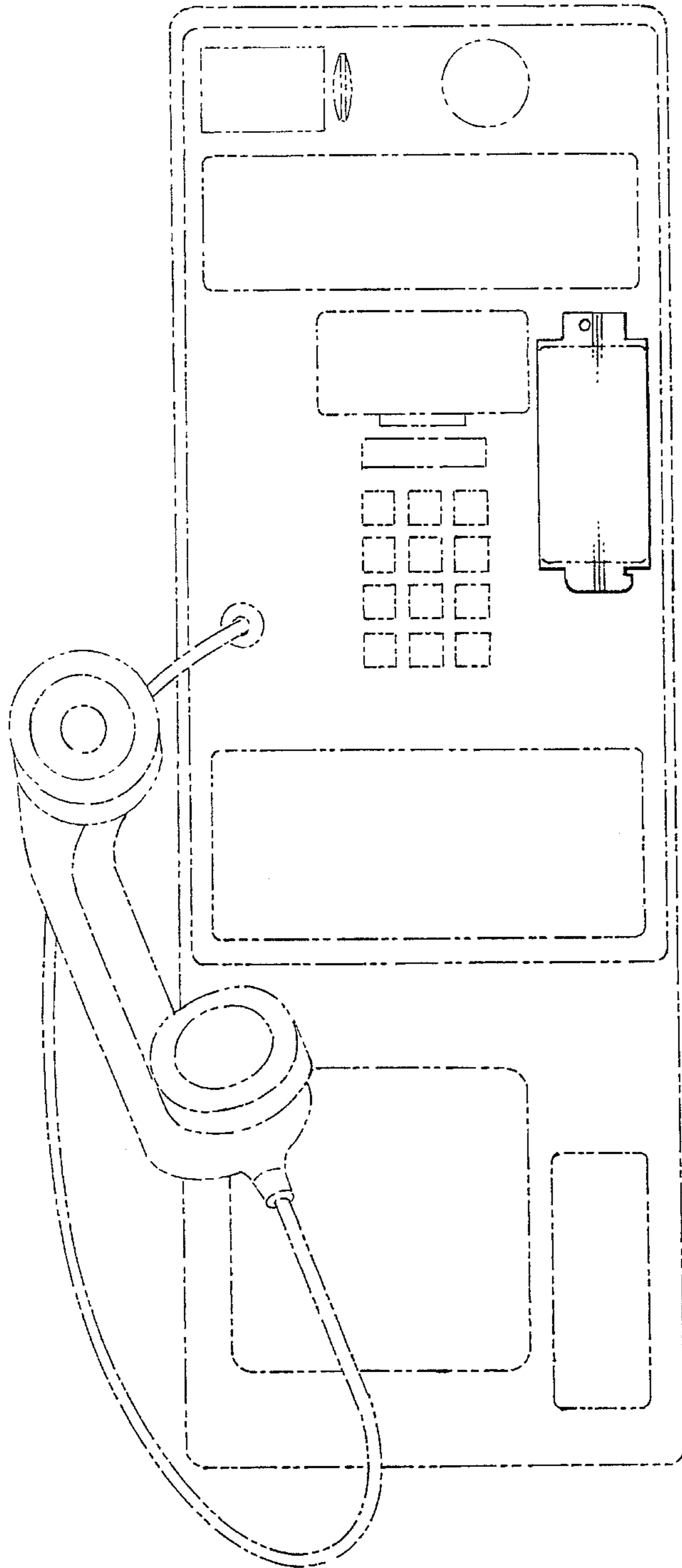

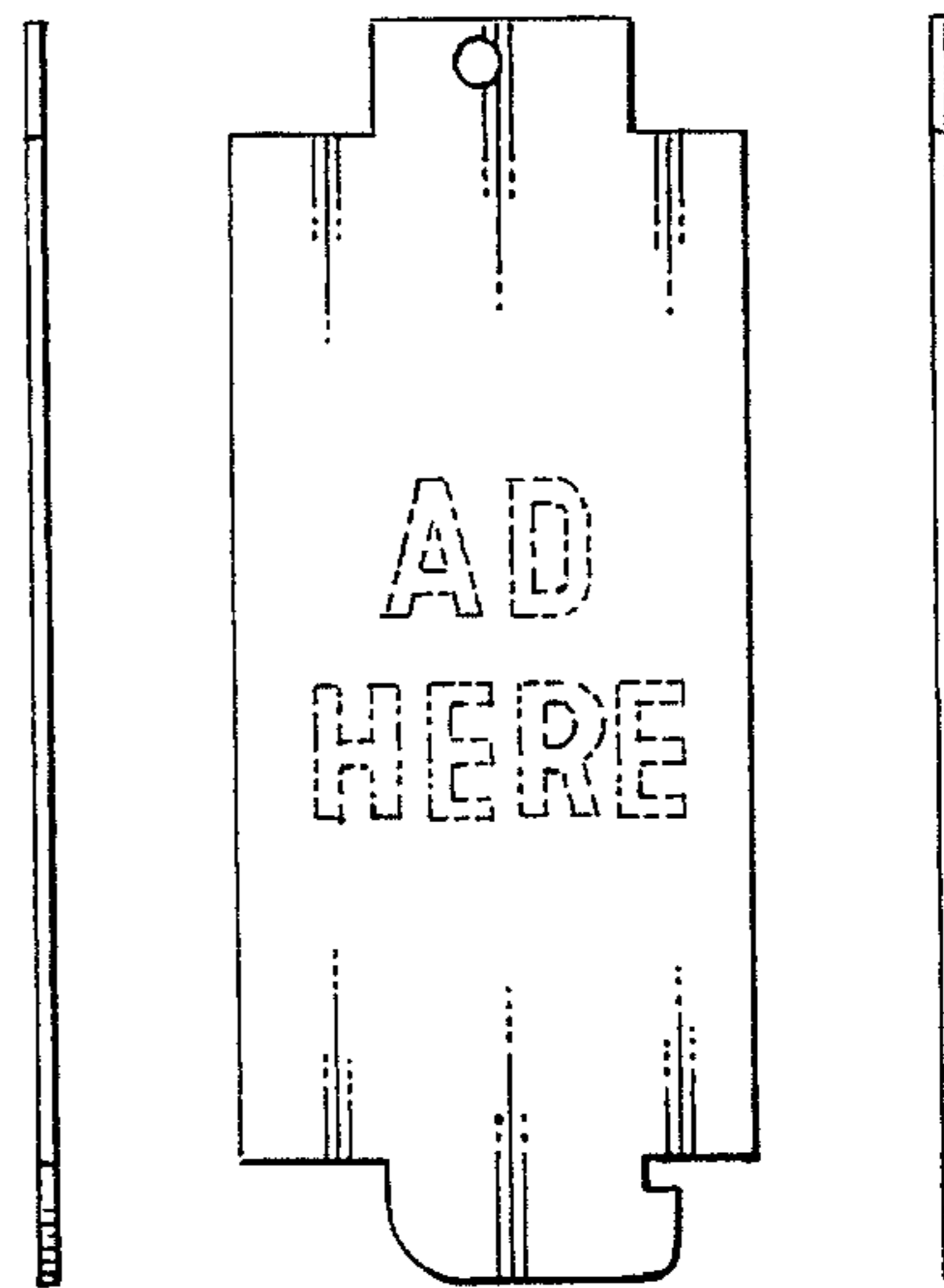

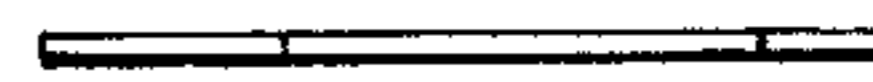
