DESCRIPTION

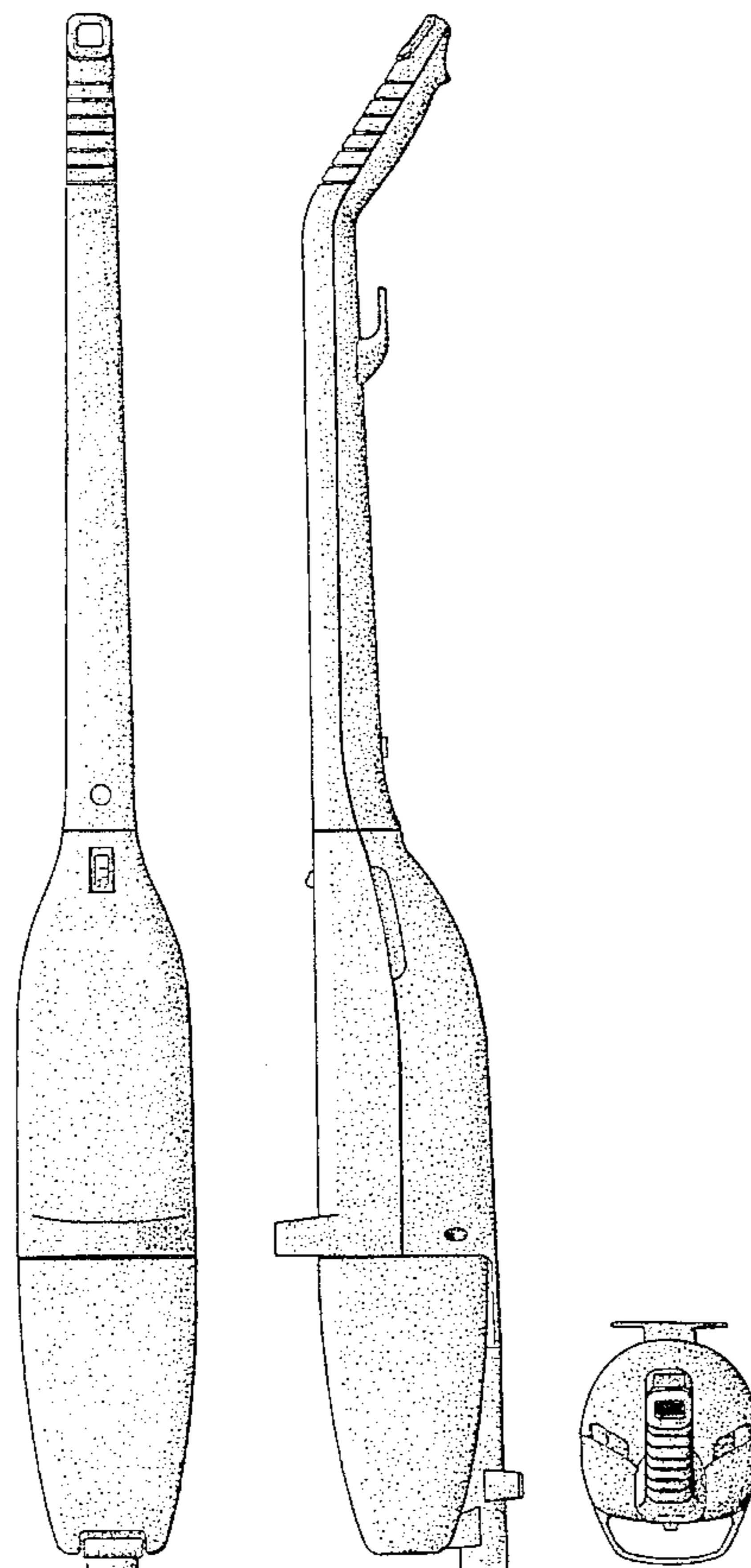

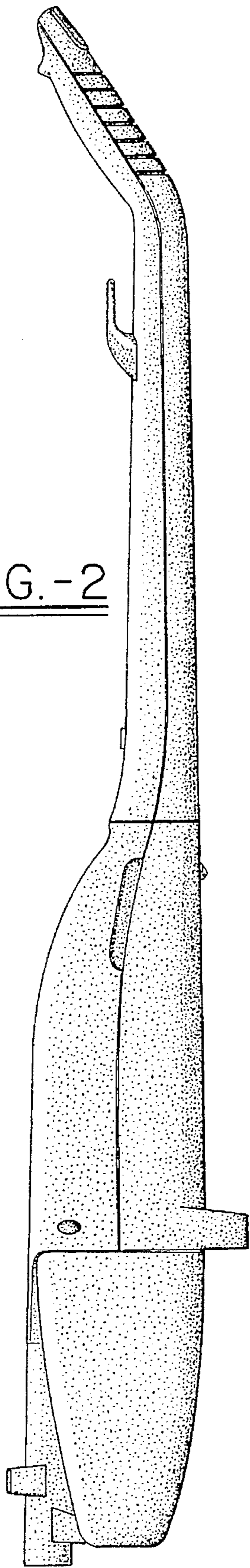

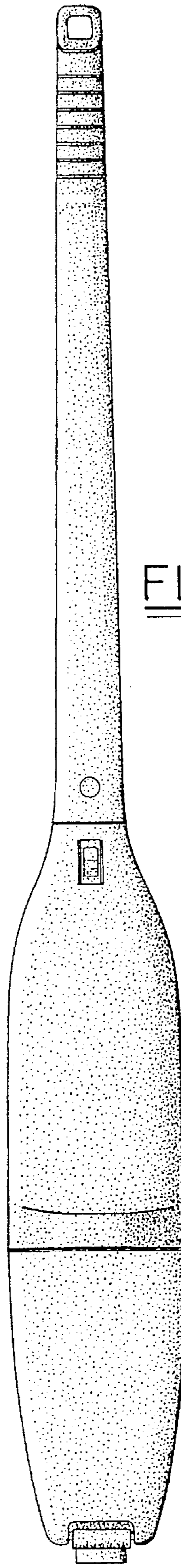
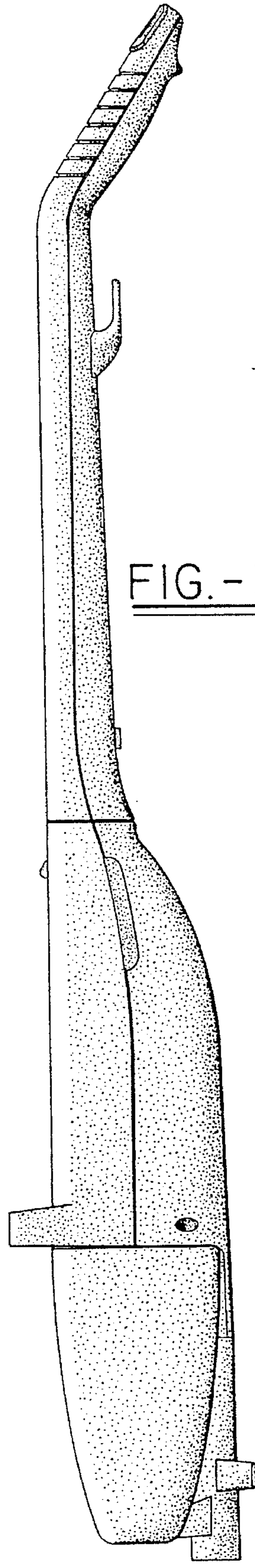

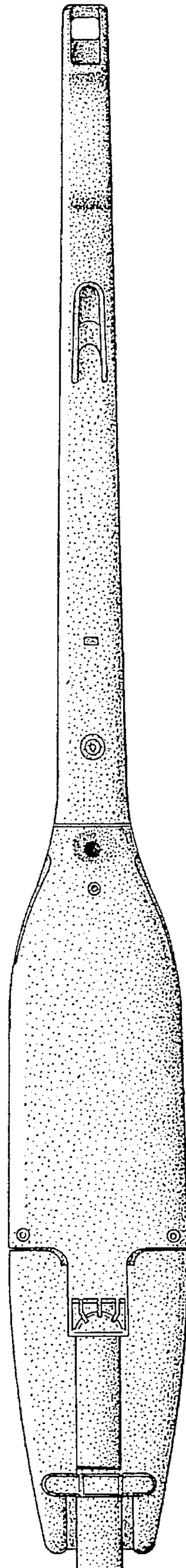

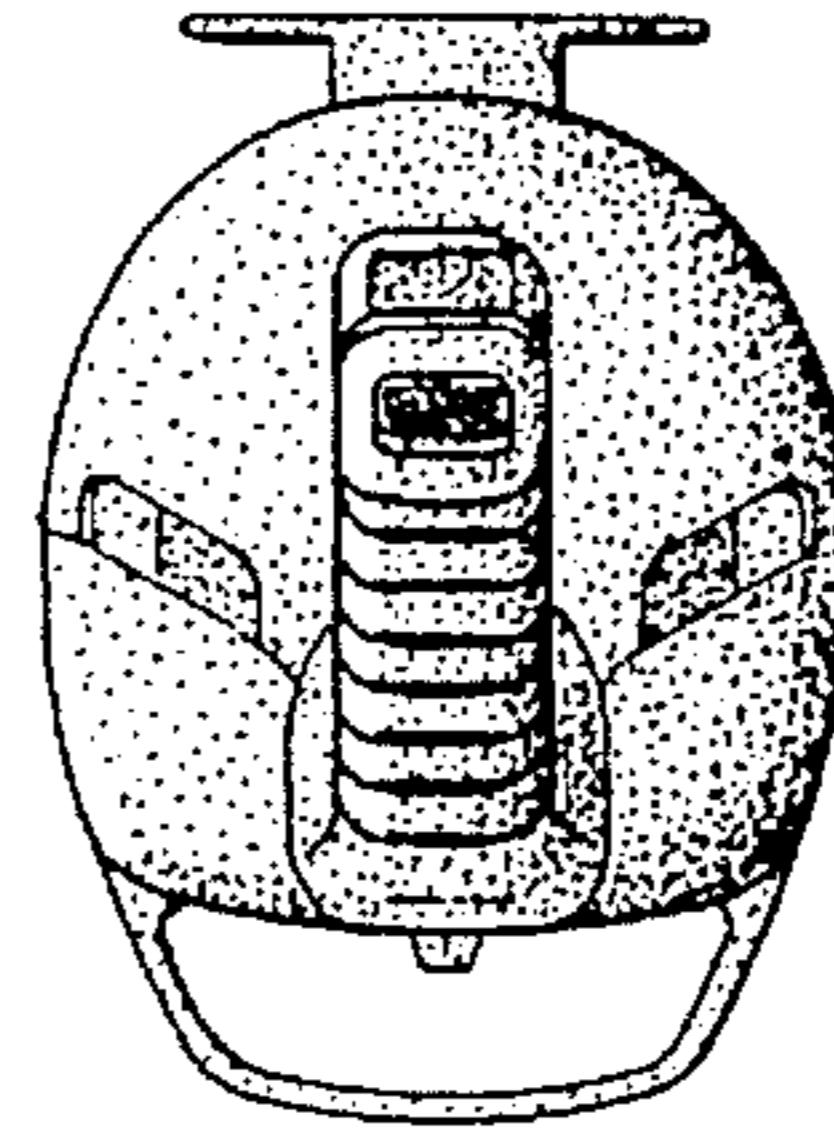

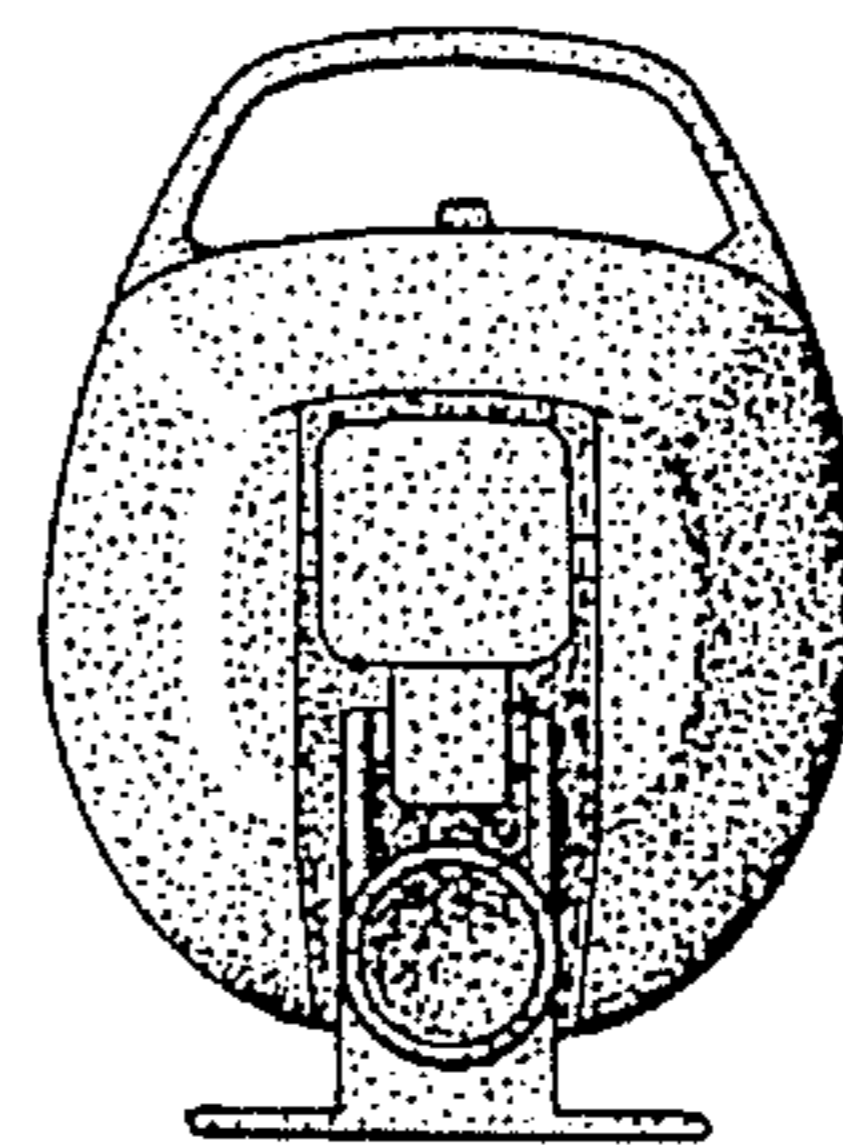
