**DESCRIPTION**

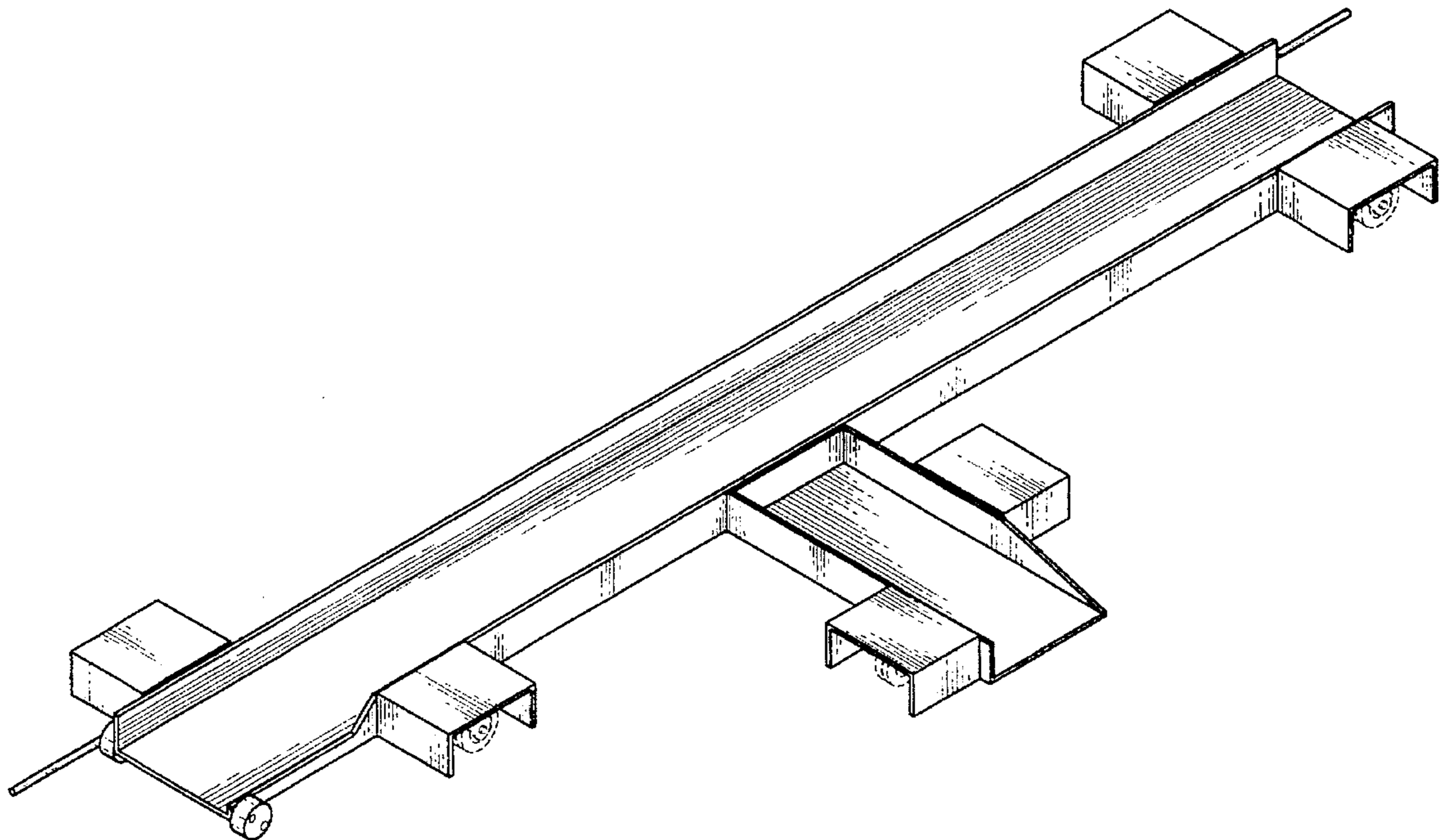
FIG. 1 is a front perspective view of a motor vehicle dolly frame showing my new design;

 The broken lines are for illustrative purposes only and form no part of the claimed design.

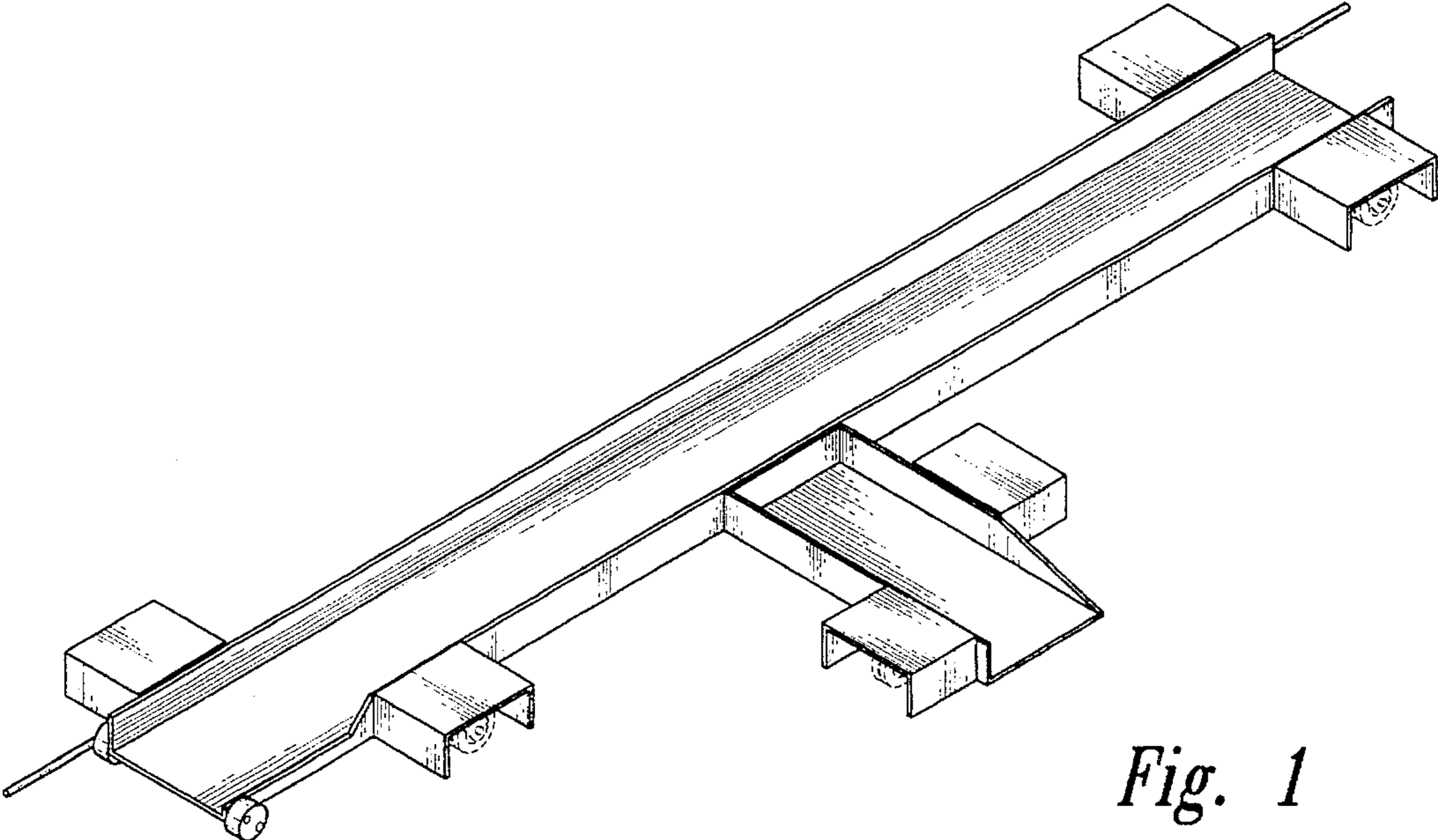

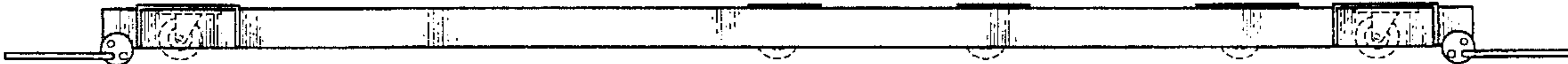

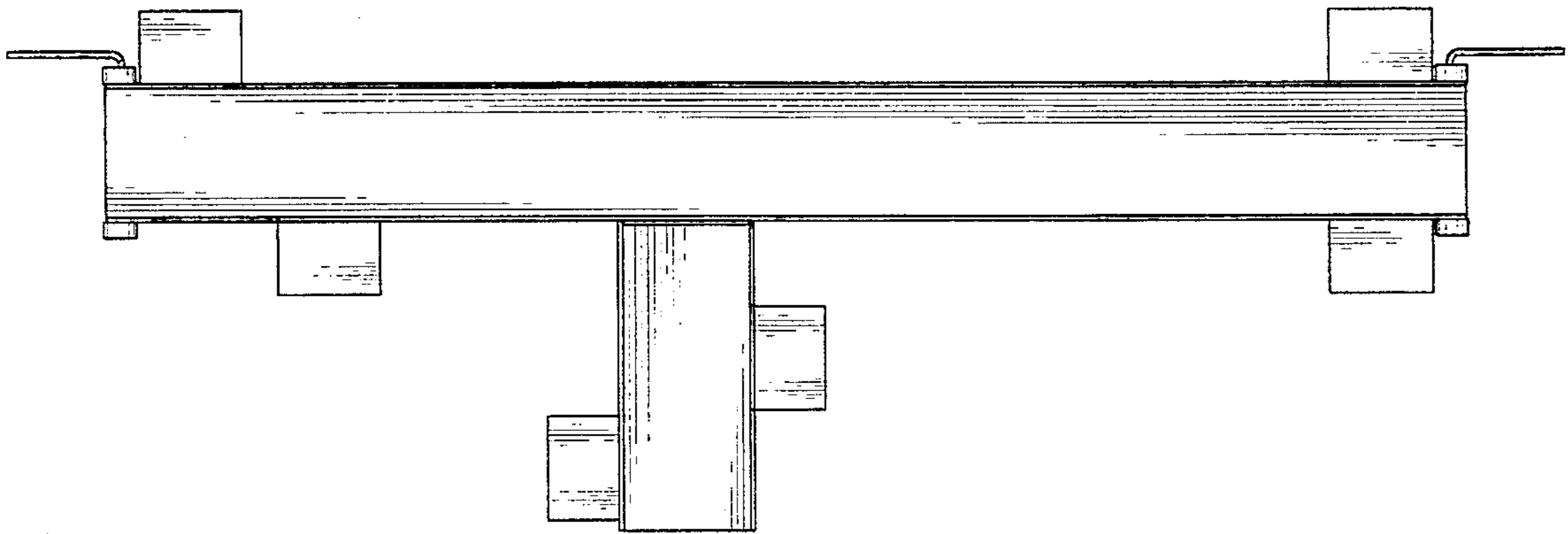

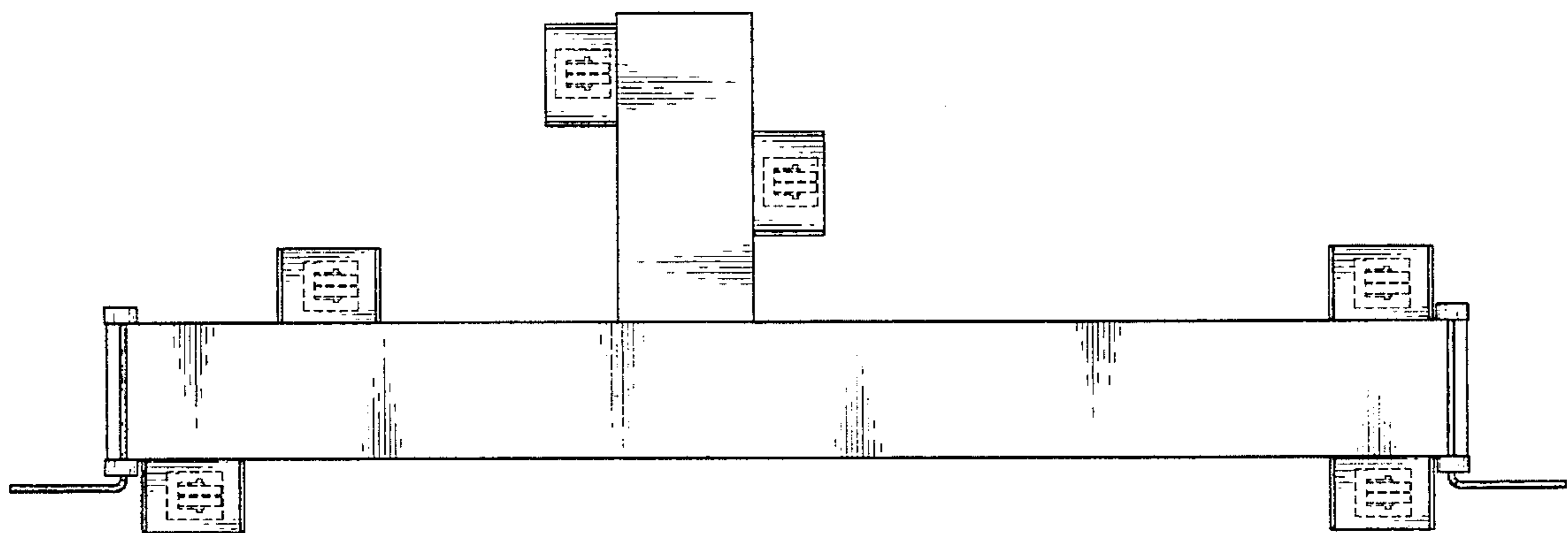
