DESCRIPTION

FIG. 1 is a front elevational view of my new design, the broken lines showing the clip profile and indicator profile are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a rear elevational view of FIG. 1, the broken lines showing the clip profile and indicator profile are for illustrative purposes only and form no part of the claimed design;

FIG. 3 is a right end elevational view of FIG. 1;

FIG. 4 is a left end elevational view of FIG. 1;

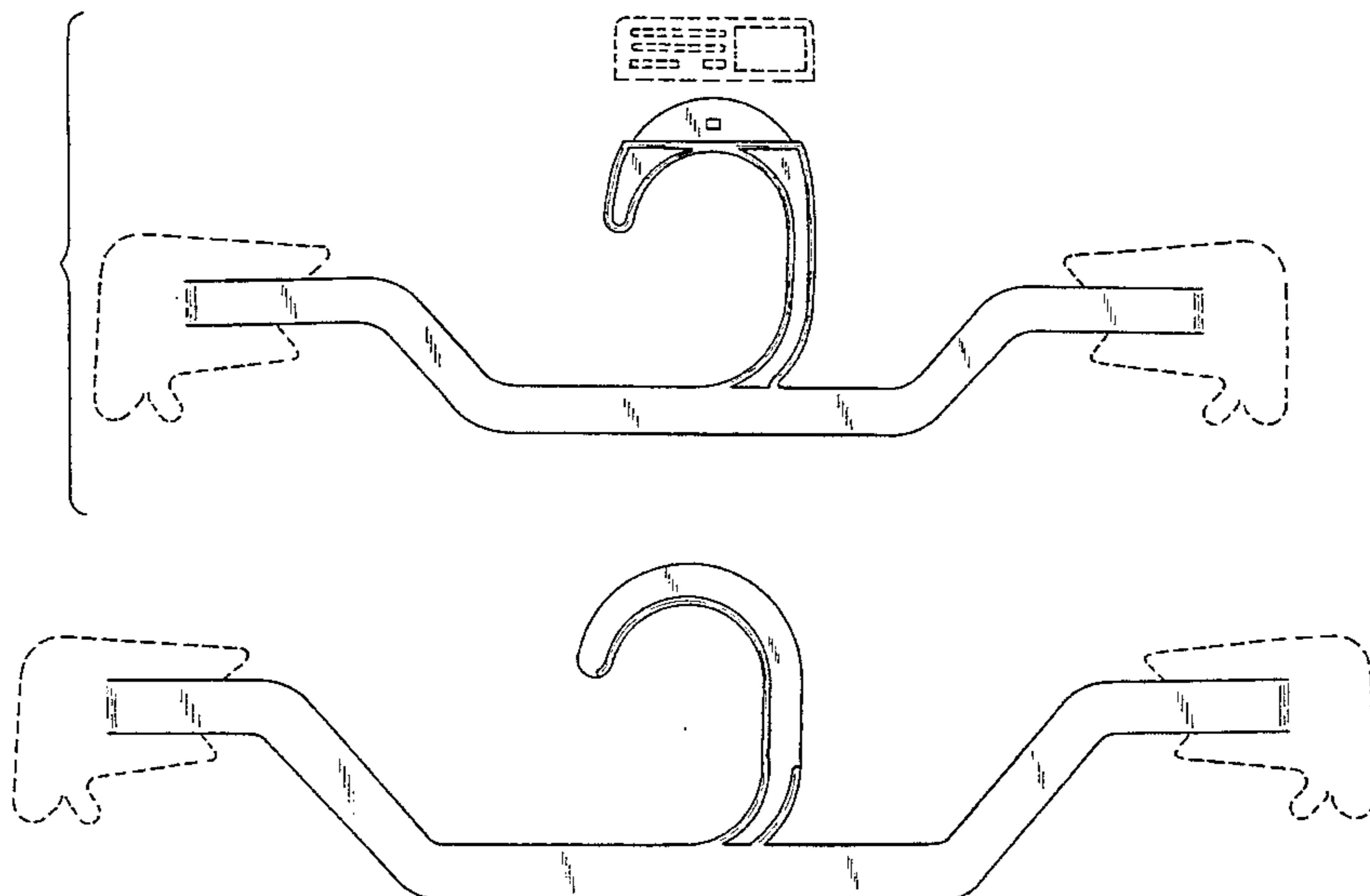
FIG. 5 is a top plan view of FIG. 1;

FIG. 6 is a bottom plan view of FIG. 1;

FIG. 7 is an exploded front elevational view of FIG. 1; and, FIG. 8 is a front elevational view of a second embodiment of the design of FIG. 1, the only difference being the configuration of the hook.

The indicator device affixed to the top of the garment hanger and clip ends of the garment hanger form no part of the claimed design.

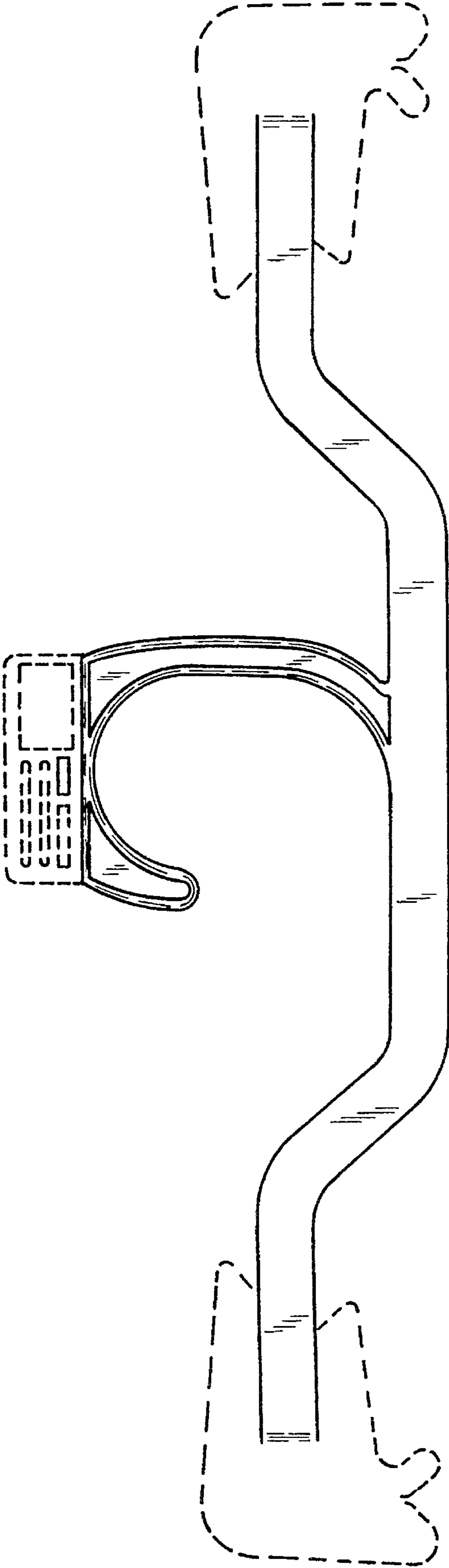

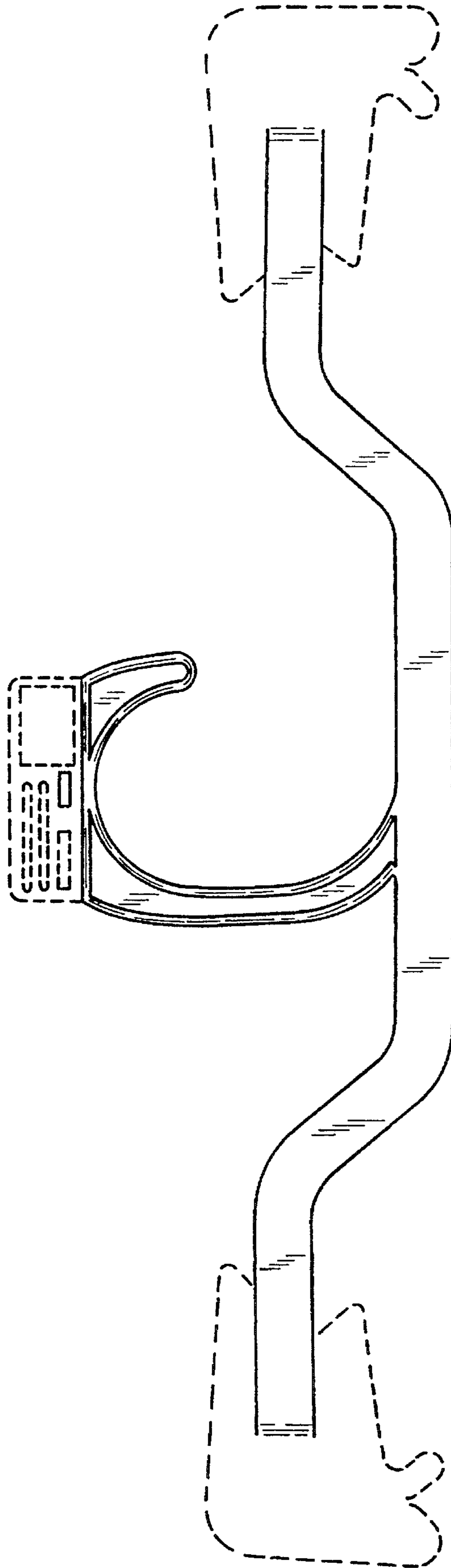

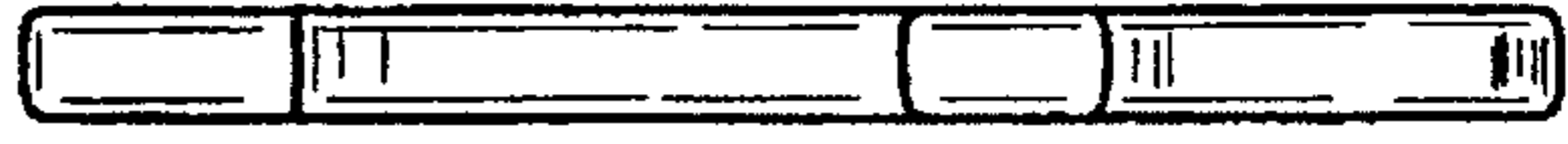

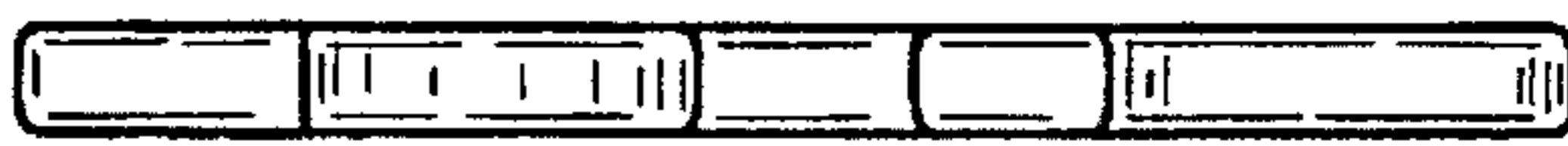

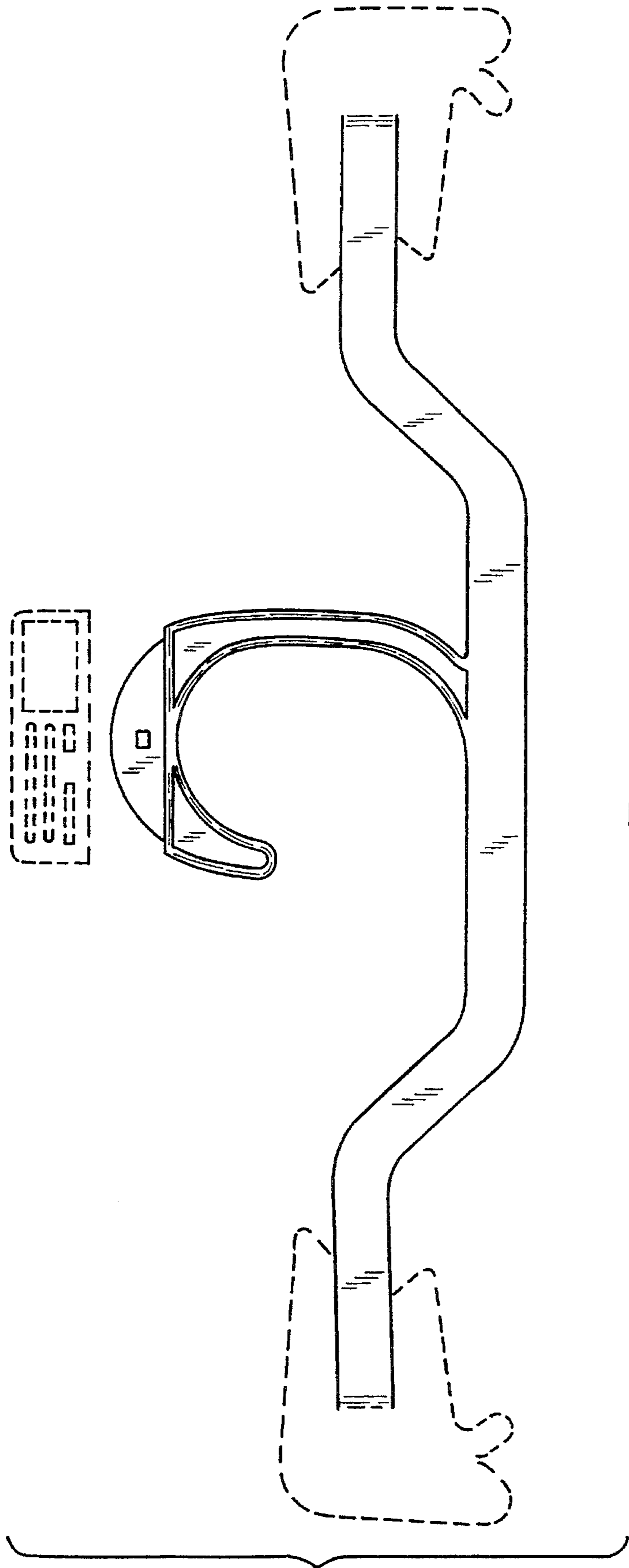

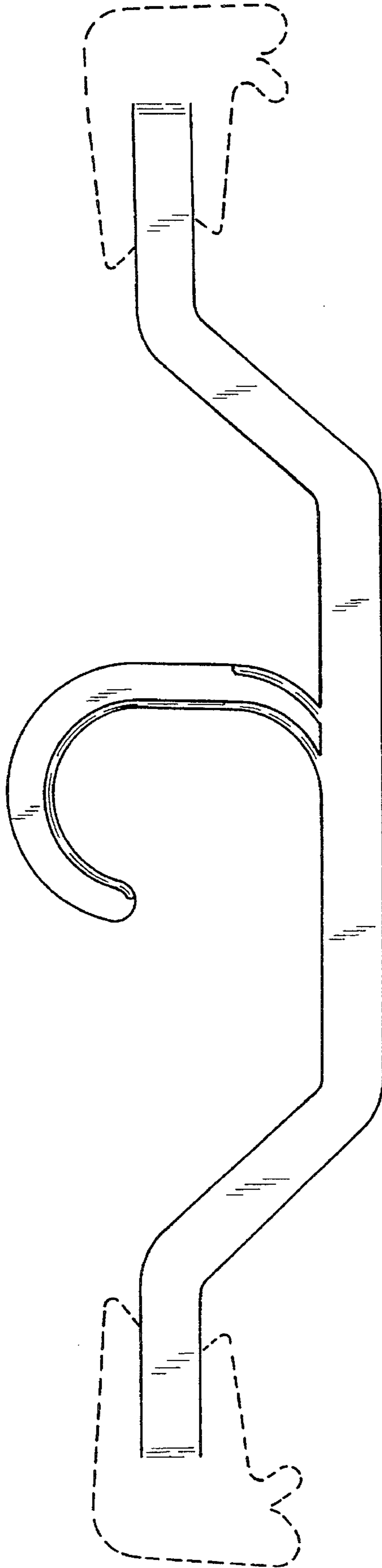
