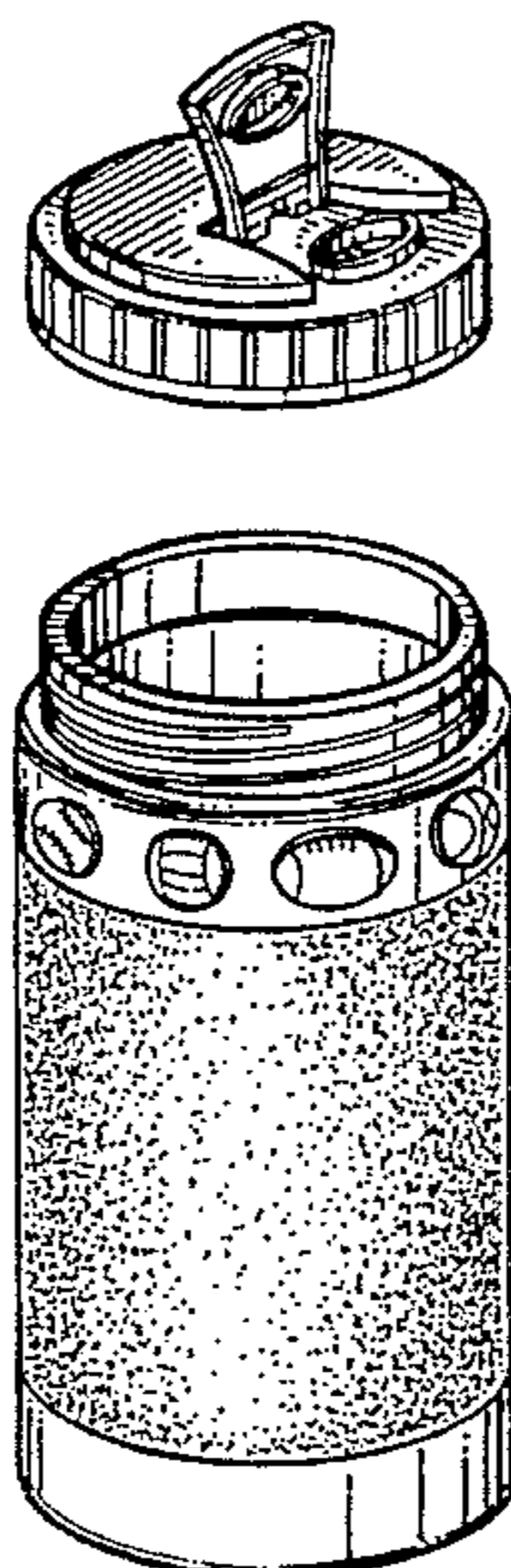

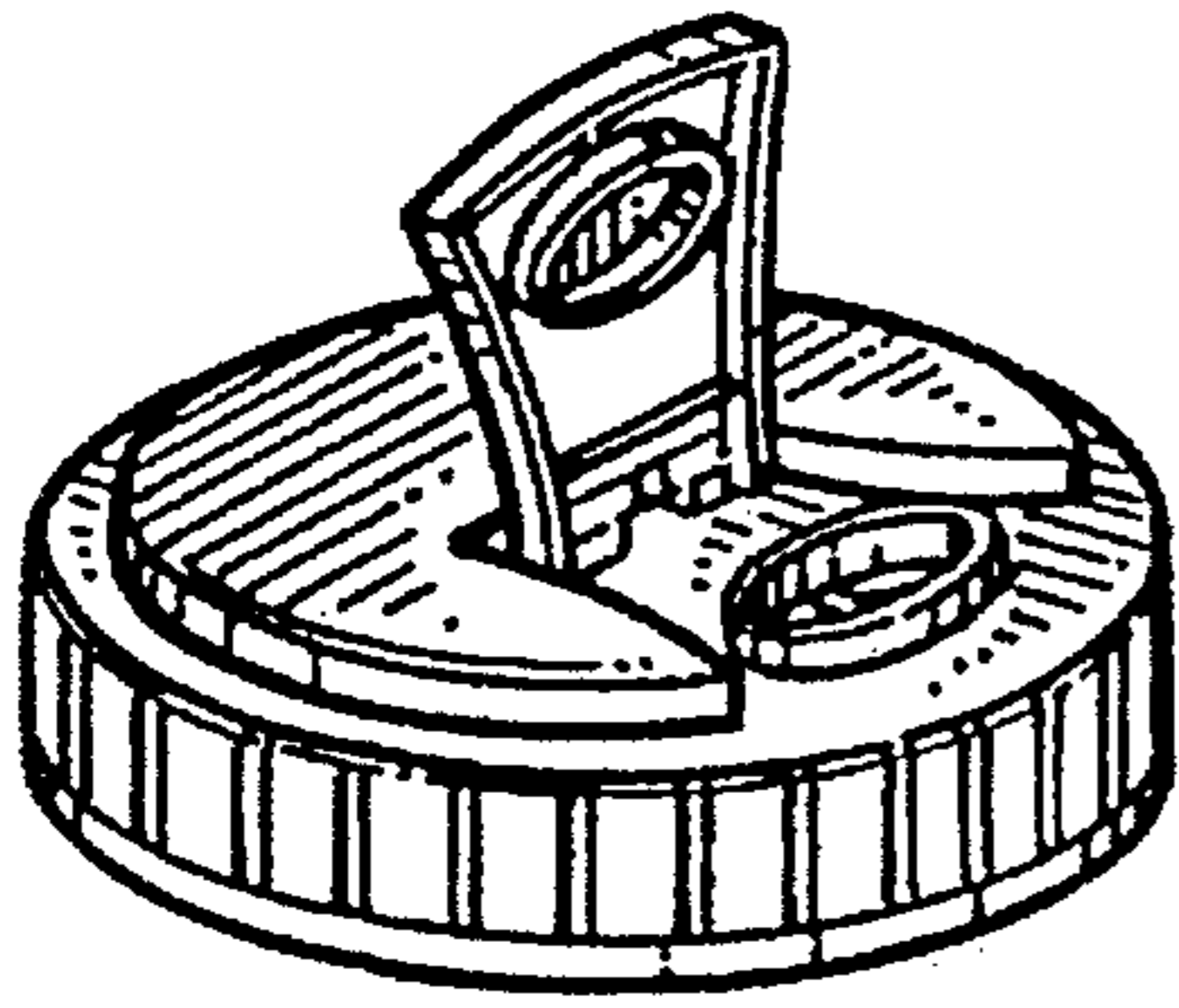
The ornamental design for a sport/squeeze bottle, as shown and described.

**DESCRIPTION**

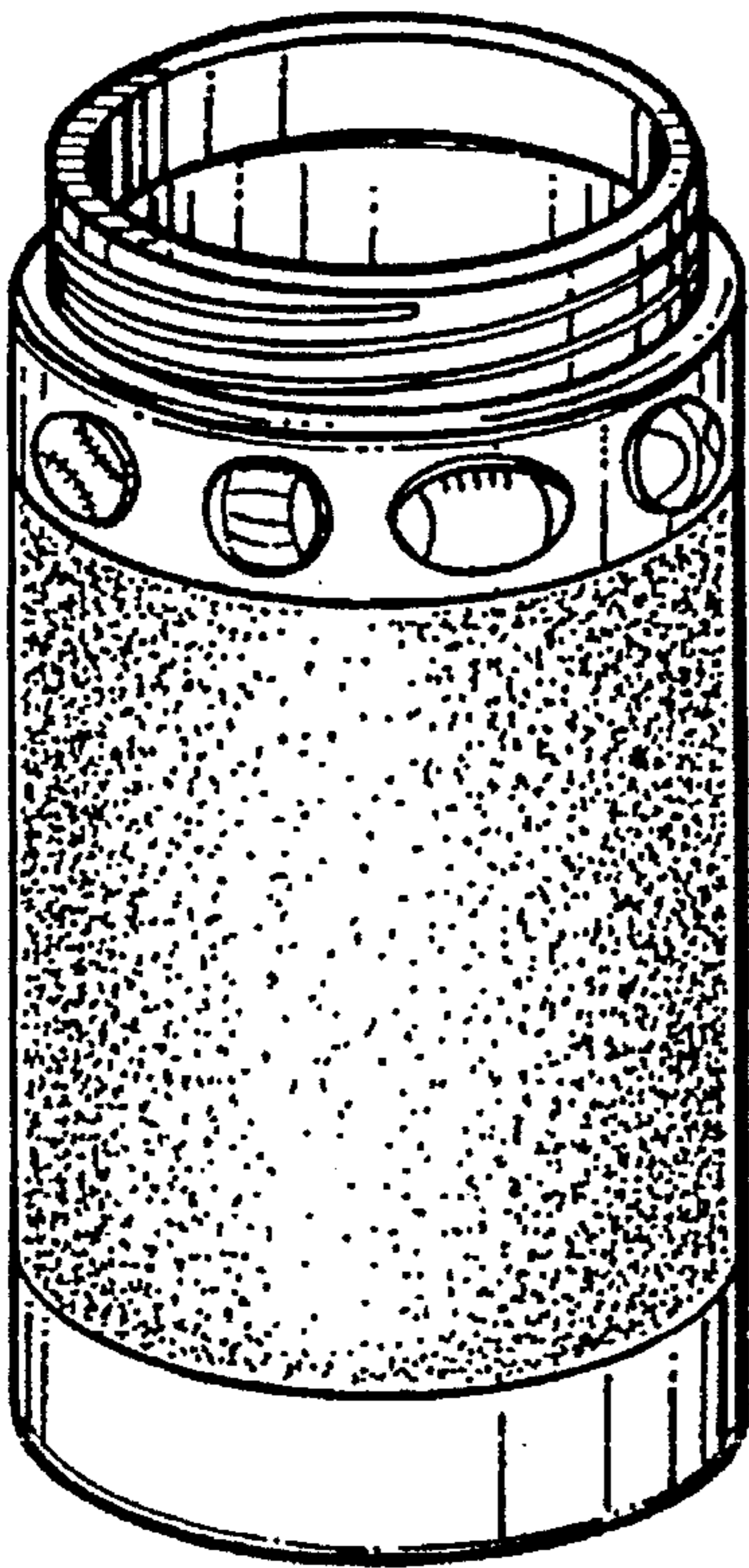
FIG. 1 is an exploded perspective view of a sport/squeeze bottle showing my new design;  
 FIG. 2 is a right side elevational view thereof;  
 FIG. 3 is a top plan view thereof, with the cap in closed position;  
 FIG. 4 is a bottom plan view of both embodiments;  
 FIG. 5 is a left side elevational view of the first embodiment thereof;  
 FIG. 6 is a rear elevational view of the first embodiment thereof;  
 FIG. 7 is a top plan view thereof with the cap in open position;  
 FIG. 8 is a top plan view of a sport/squeeze bottle showing a second embodiment of my new design with the cap in closed position, wherein the sole difference resides in the appearance of the cap;  
 FIG. 9 is a front elevational view thereof;  
 FIG. 10 is a top perspective view thereof; and,  
 FIG. 11 is a left side elevational view thereof.

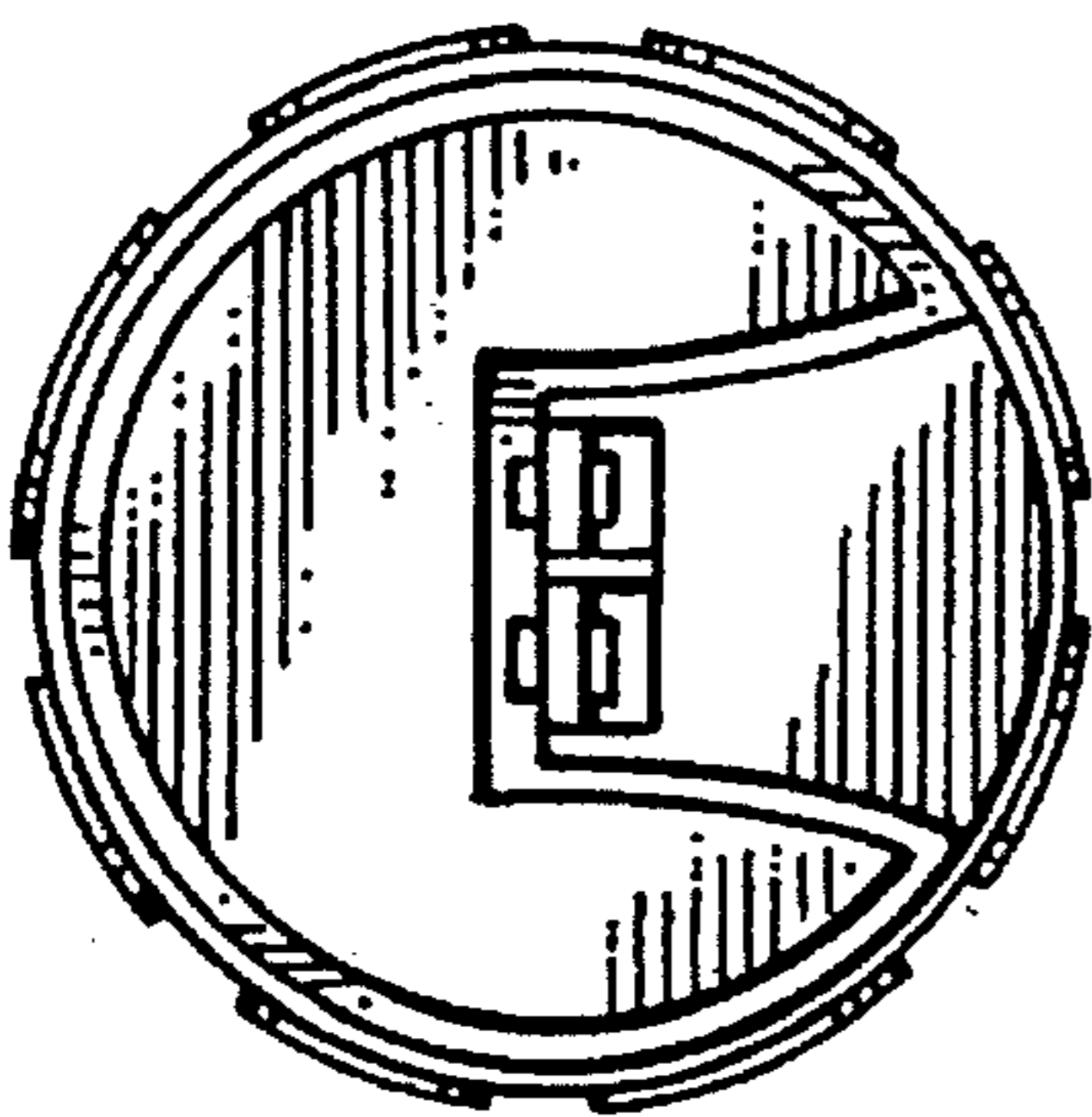
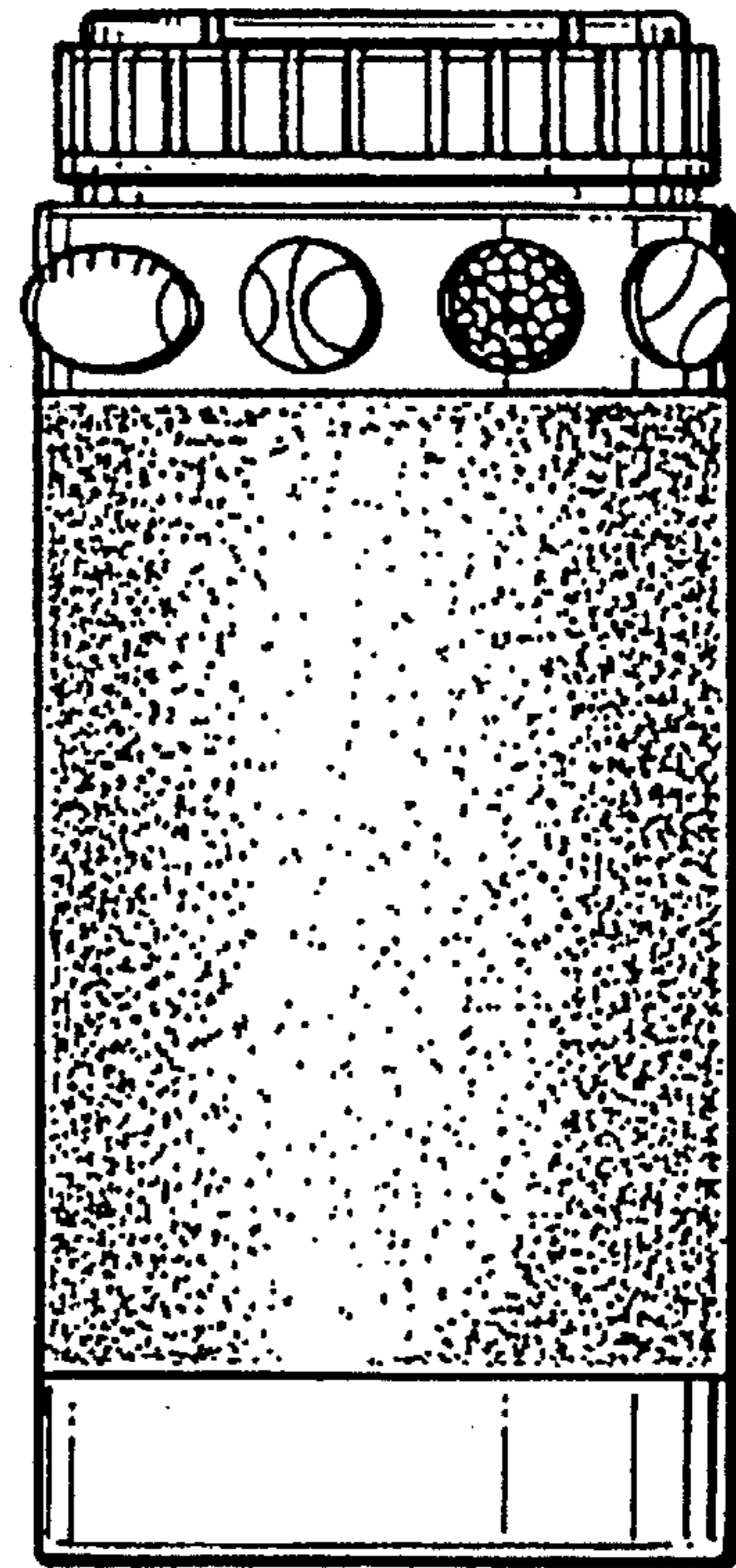

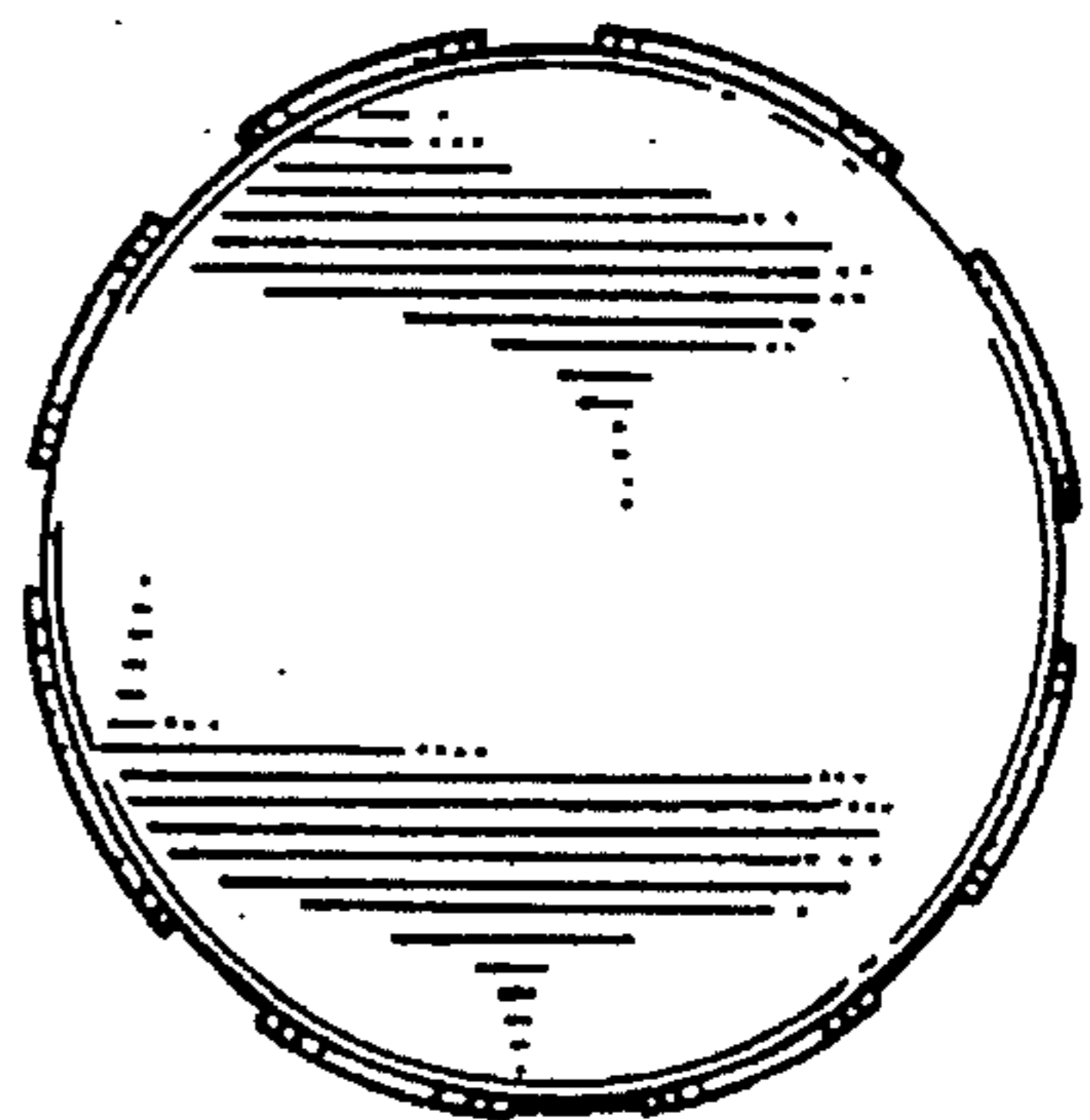

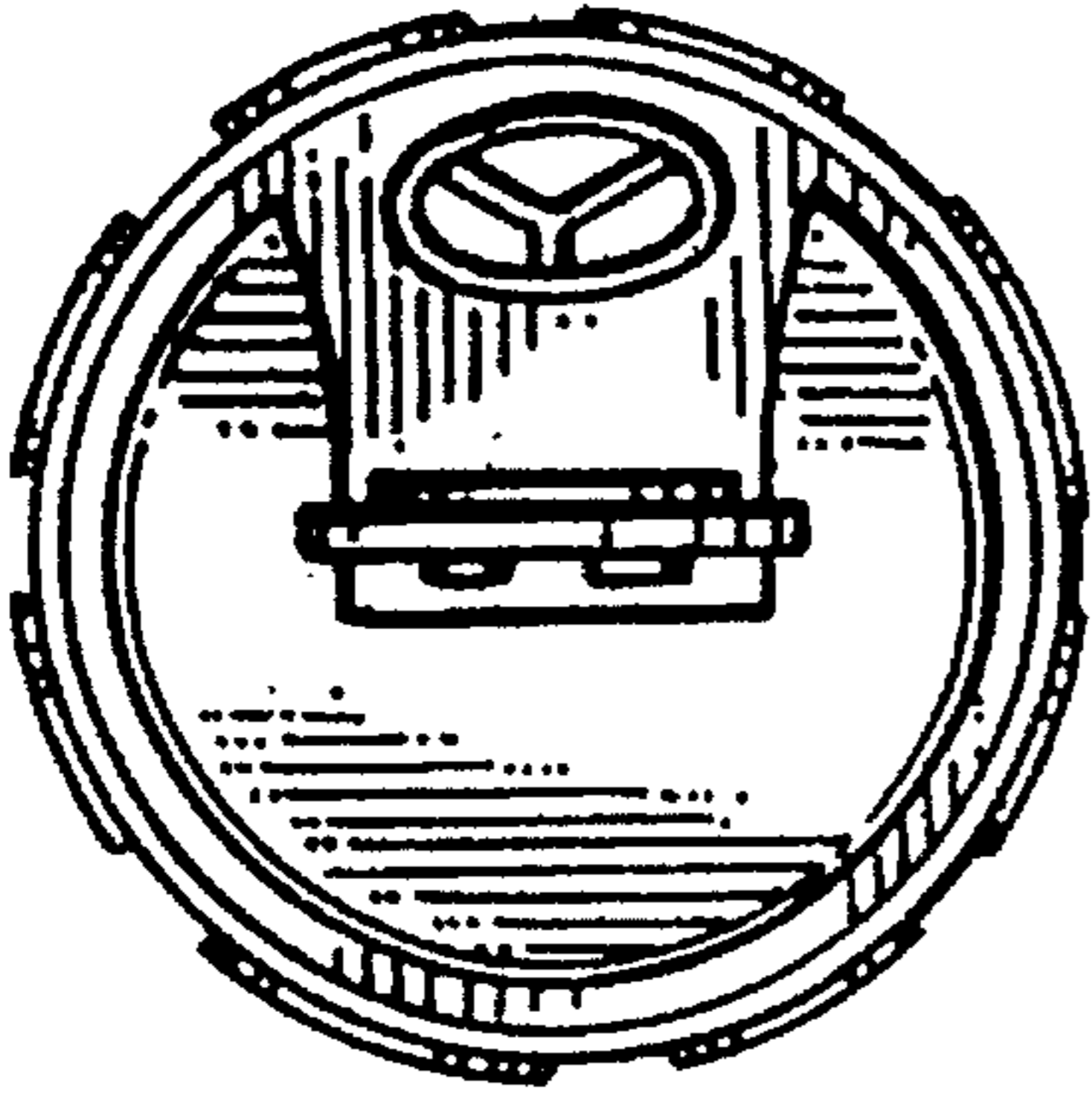

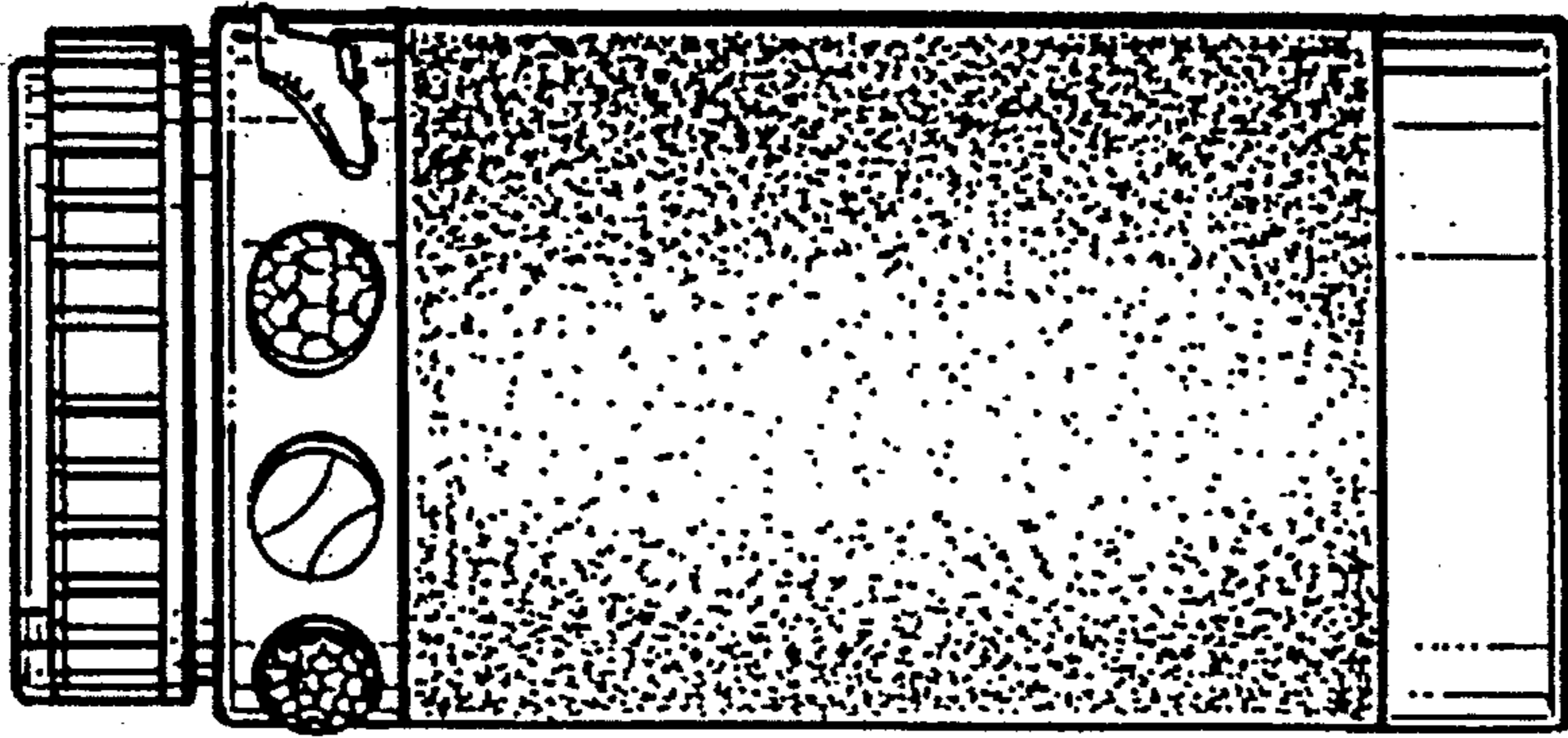
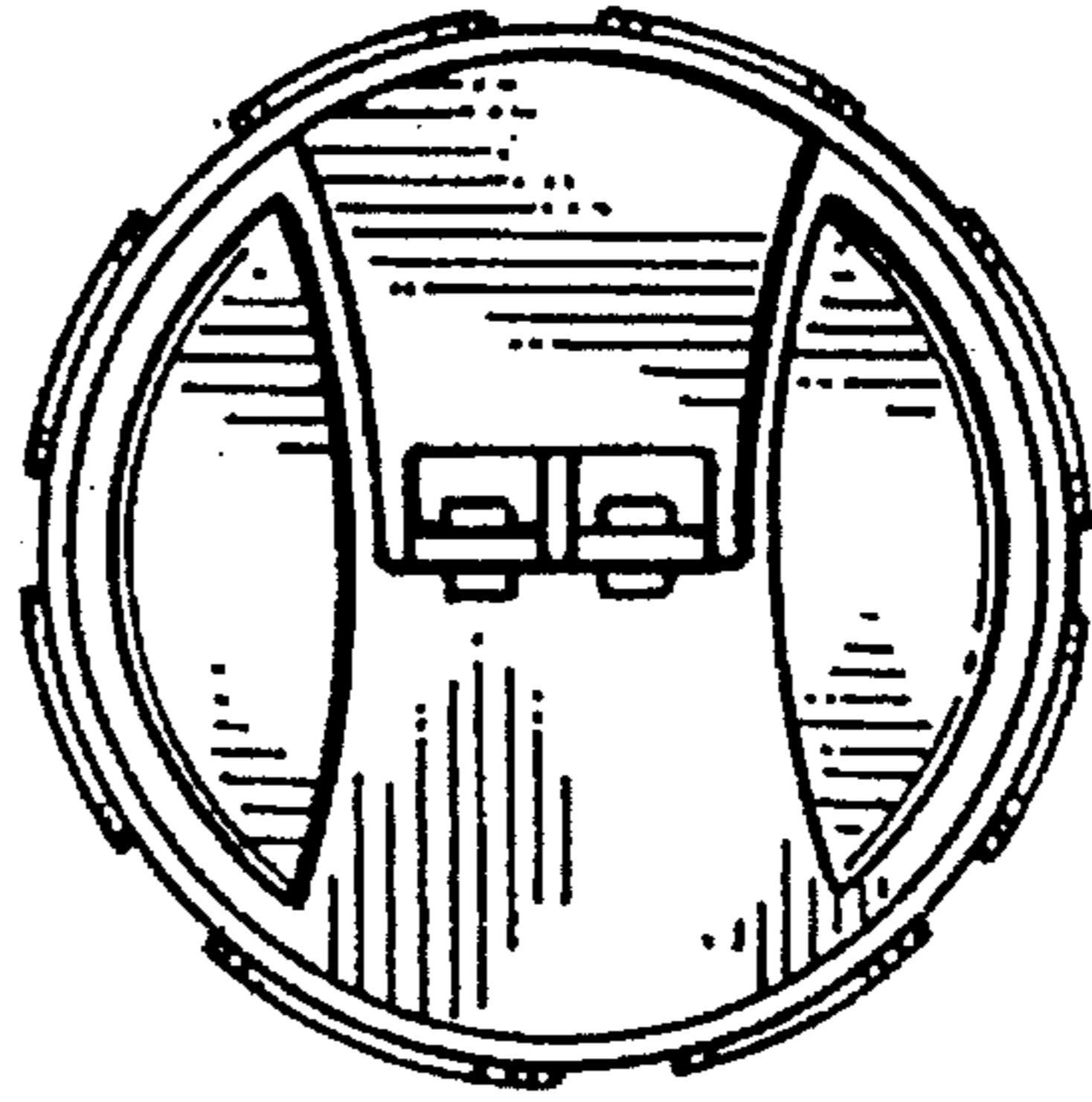

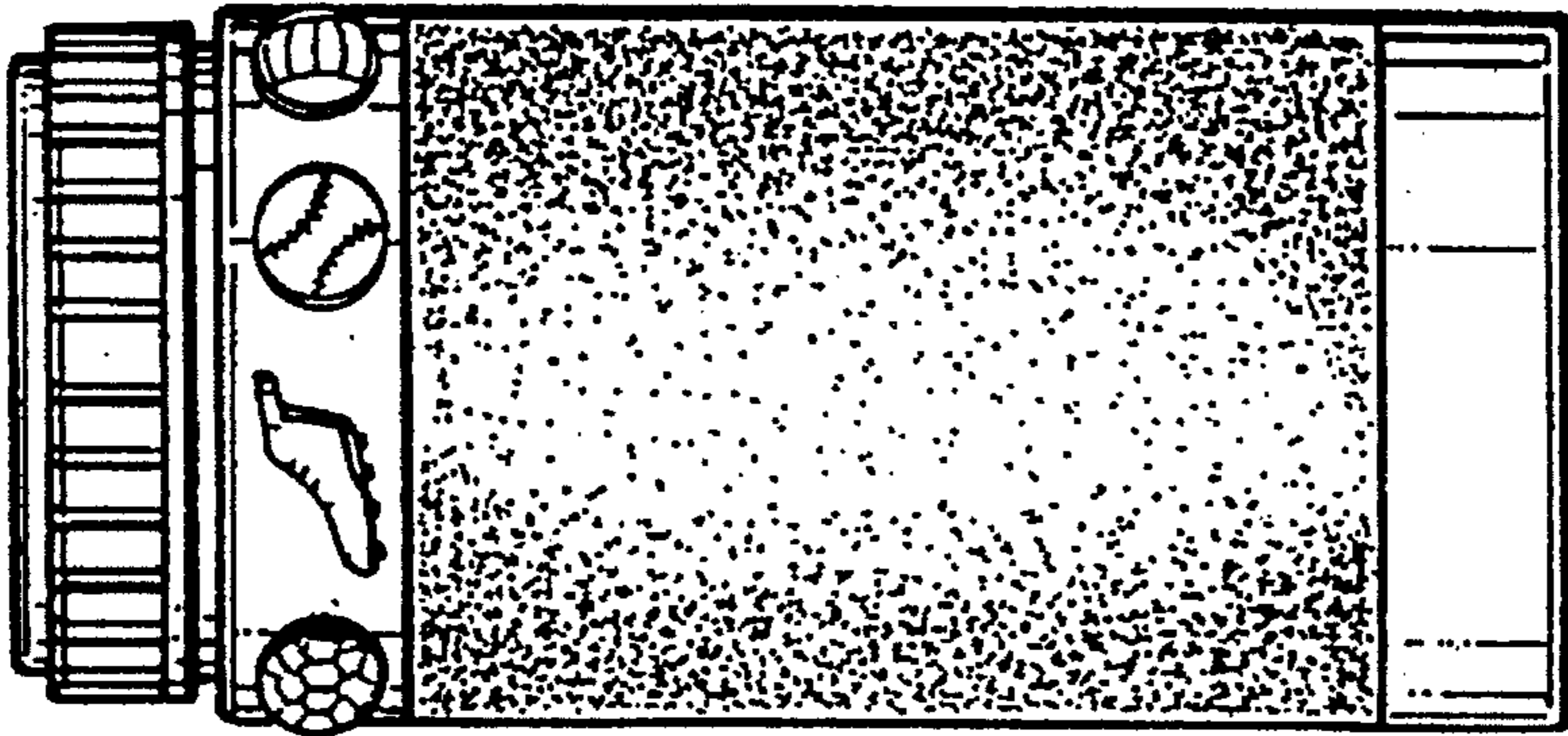

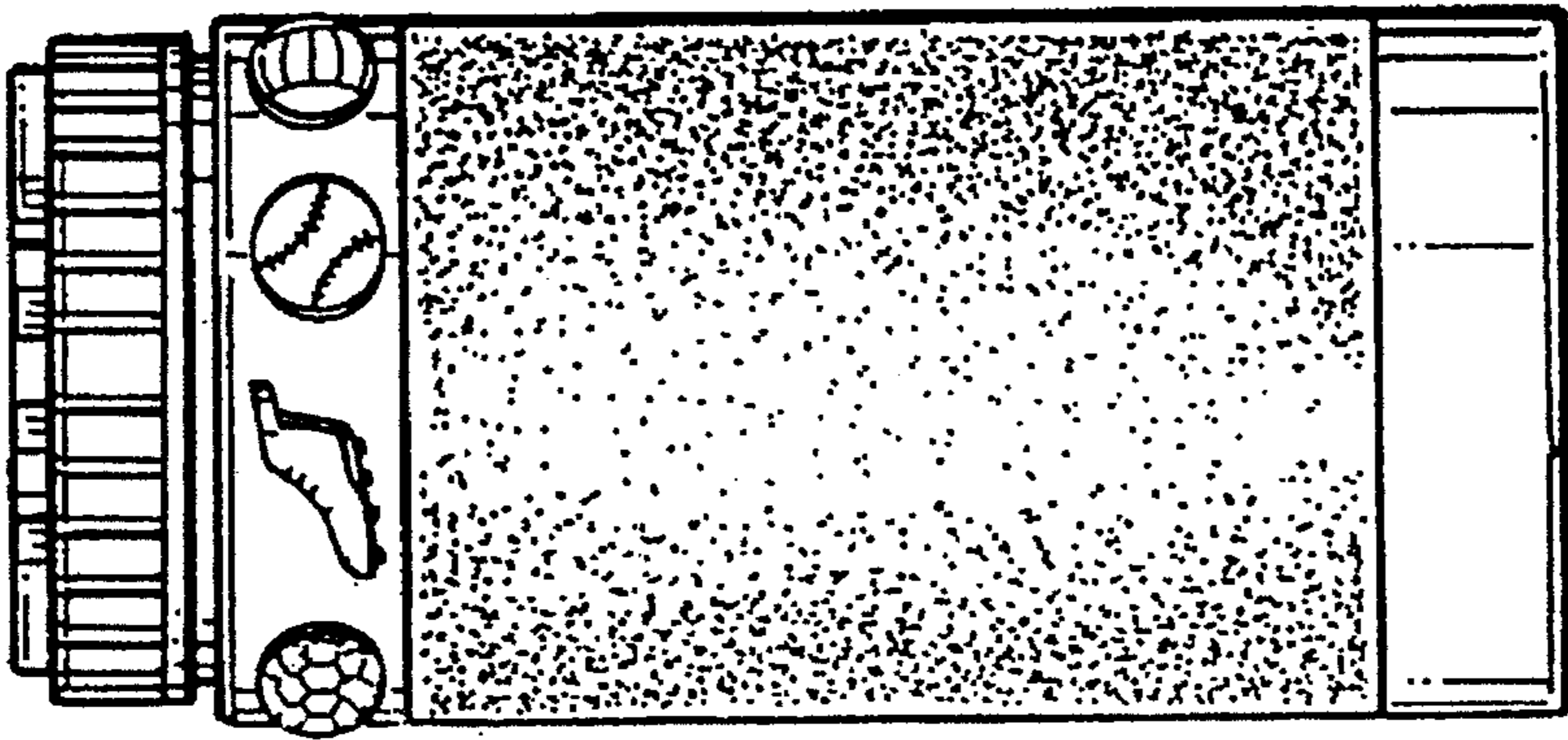

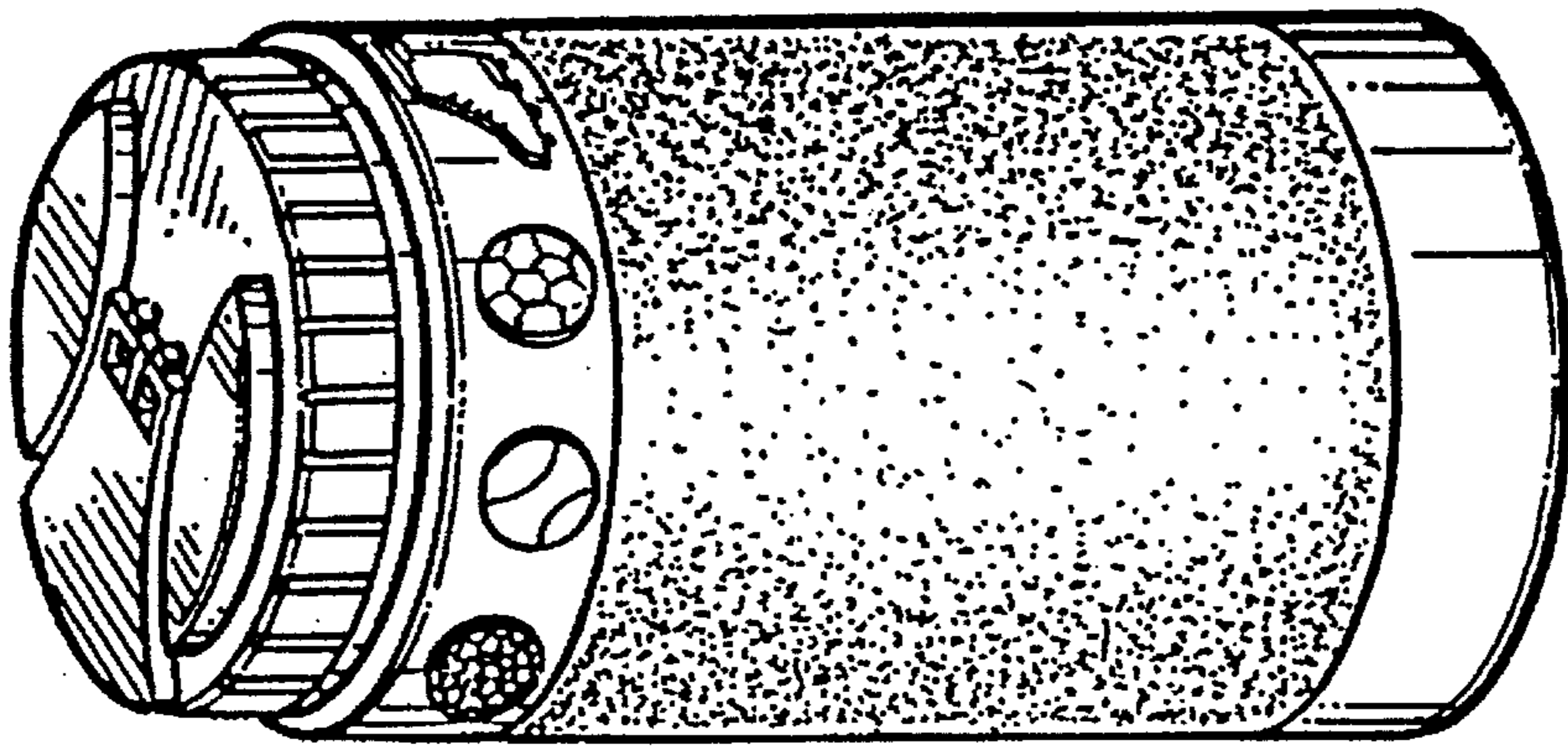

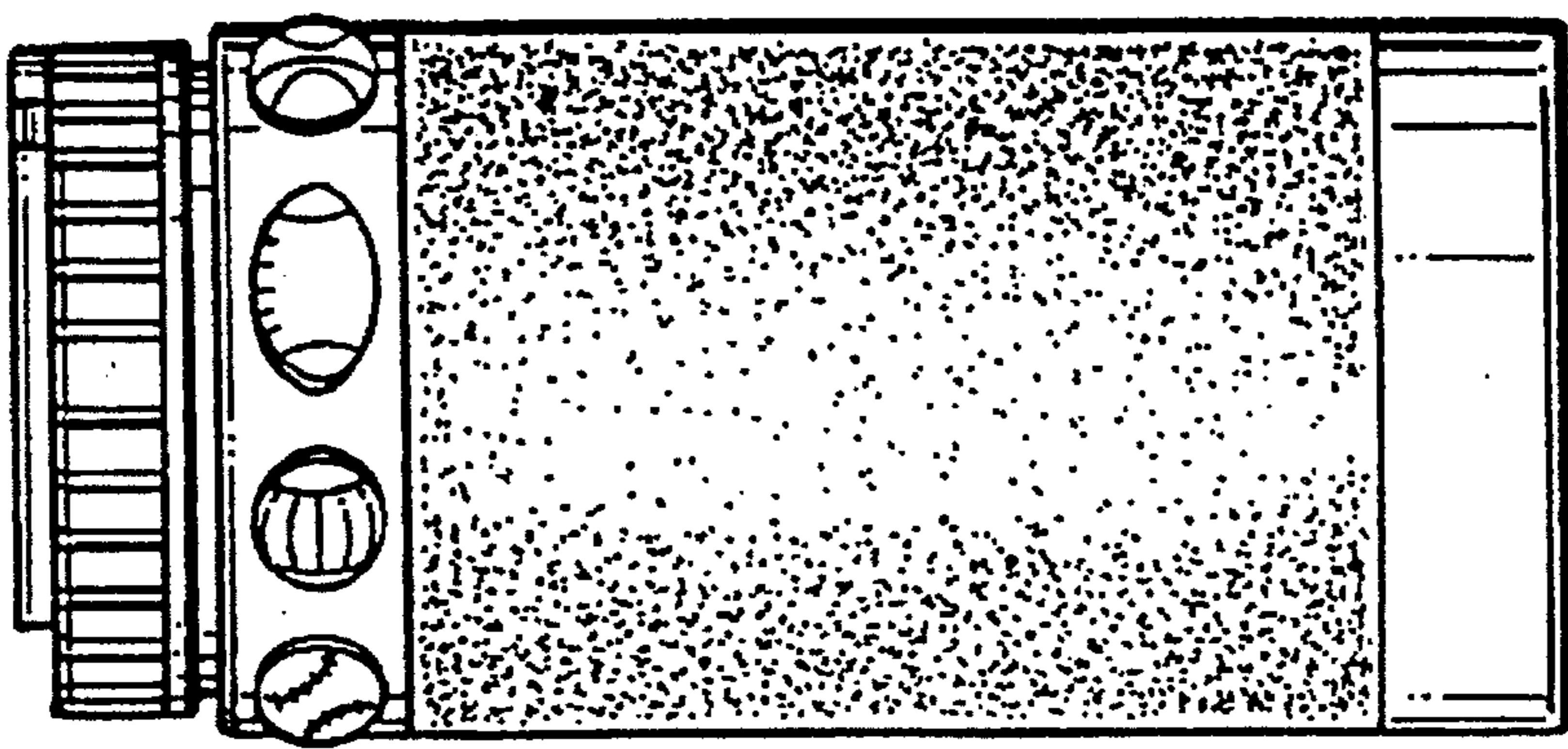
