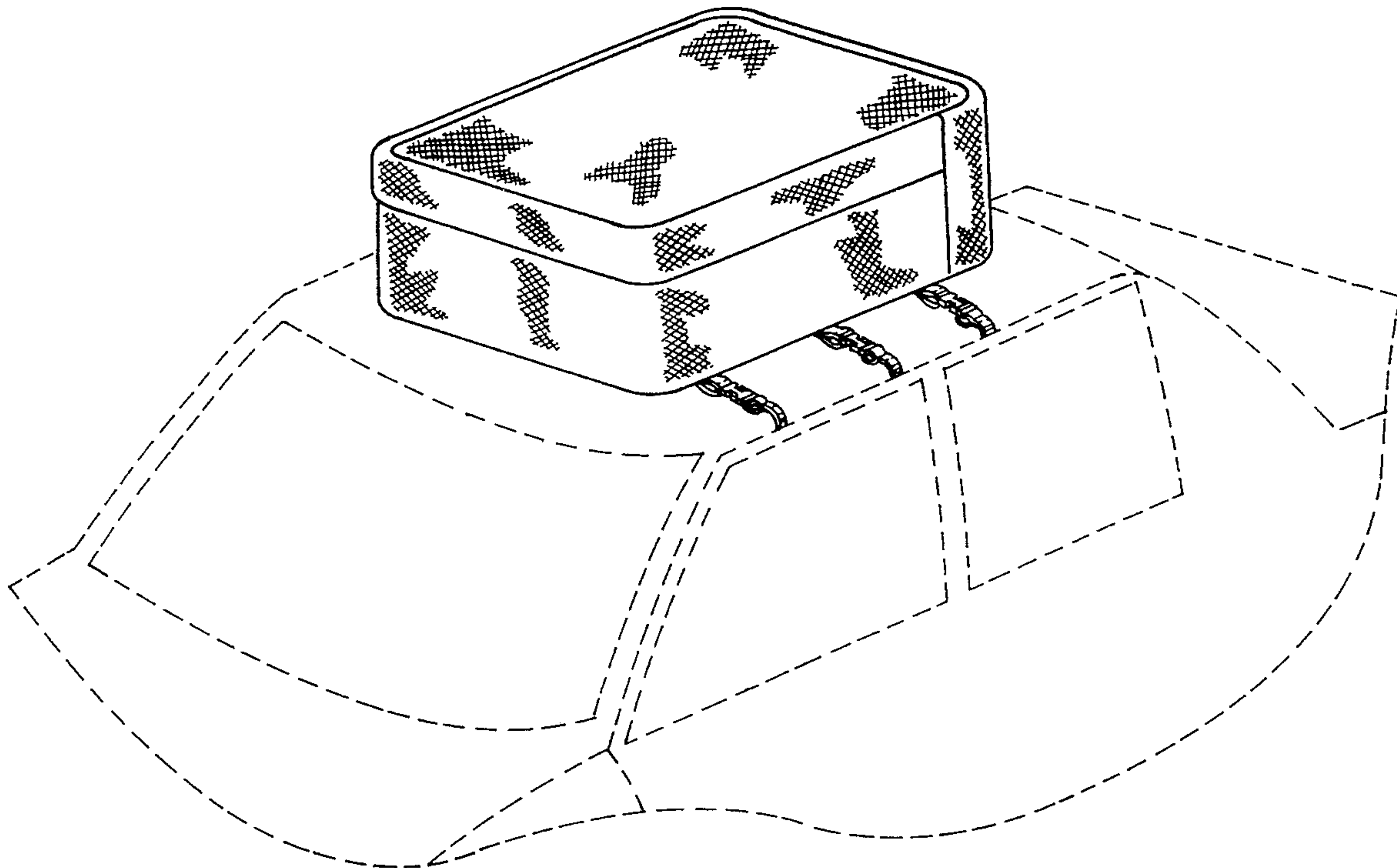
[57] **CLAIM**

The ornamental design for a vehicle-mountable luggage carrier, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and side perspective view of the vehicle-mountable luggage carrier showing my new design; FIG. 2 is a front end elevational view thereof; FIG. 3 is a rear end elevational view thereof; FIG. 4 is a side elevational view thereof, the side opposite being a mirror image of the side shown in FIG. 4; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a perspective view thereof shown on a vehicle with the vehicle being shown in broken lines for illustrative purposes only and forming no part of the claimed design.

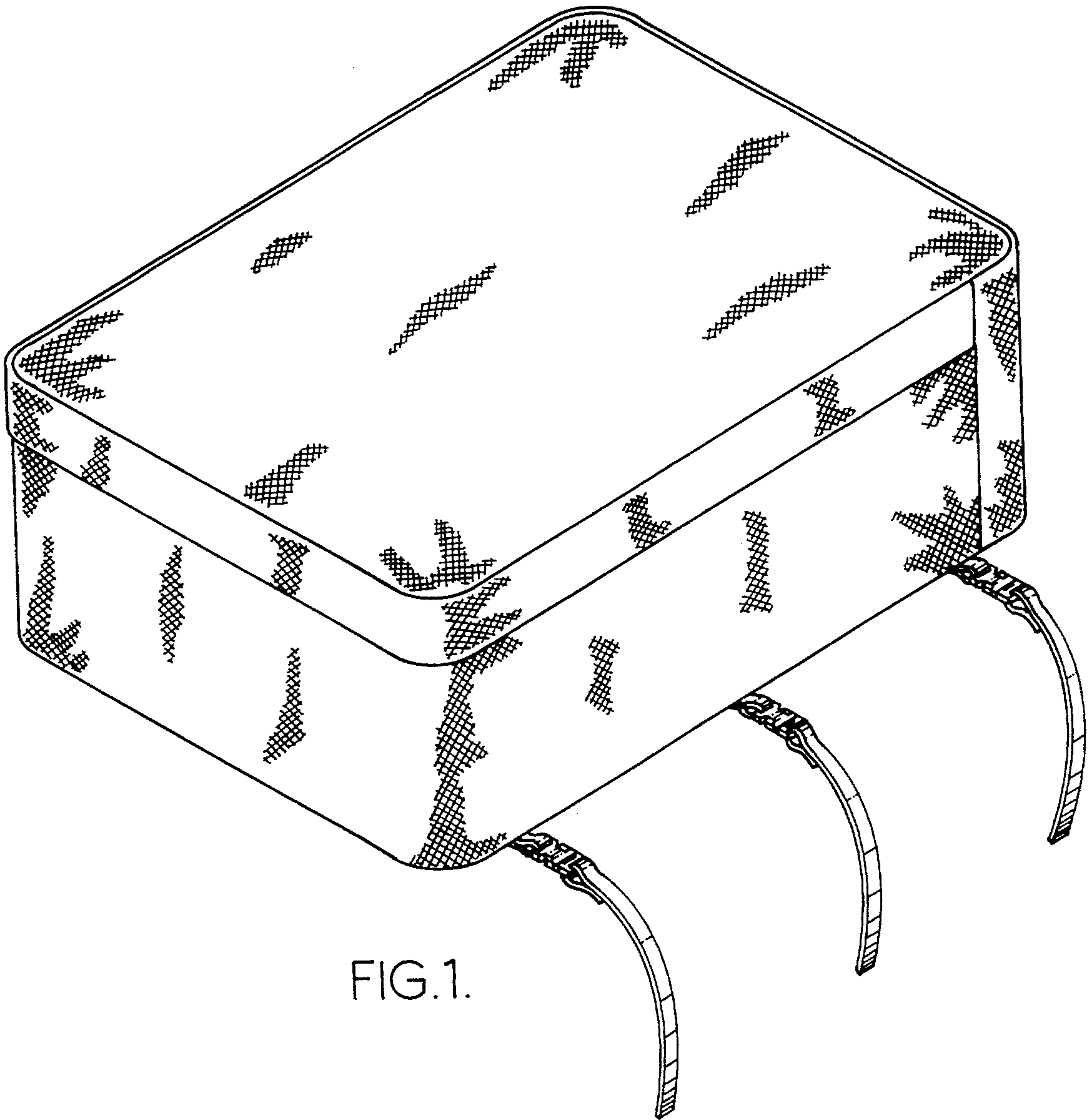

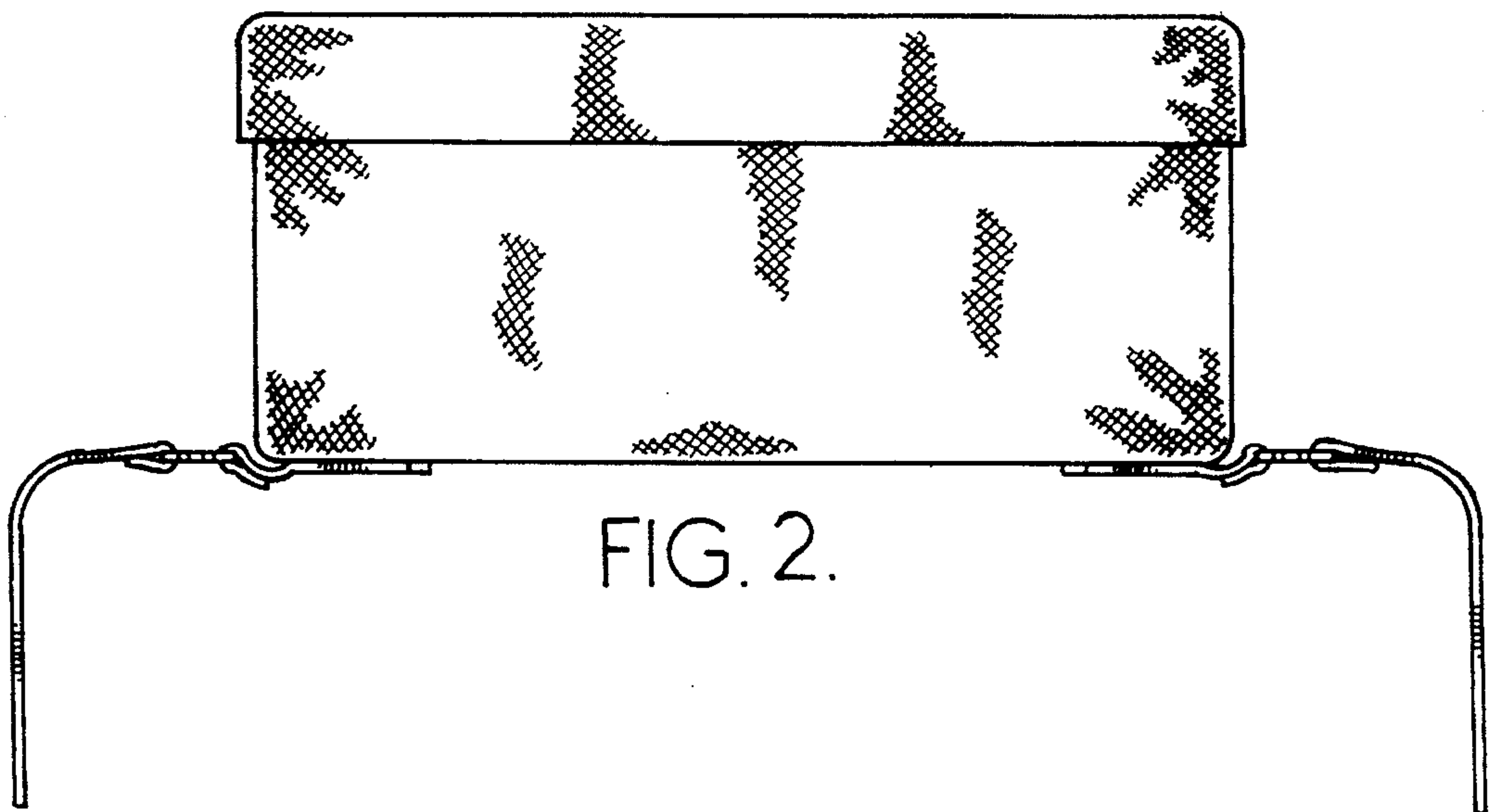
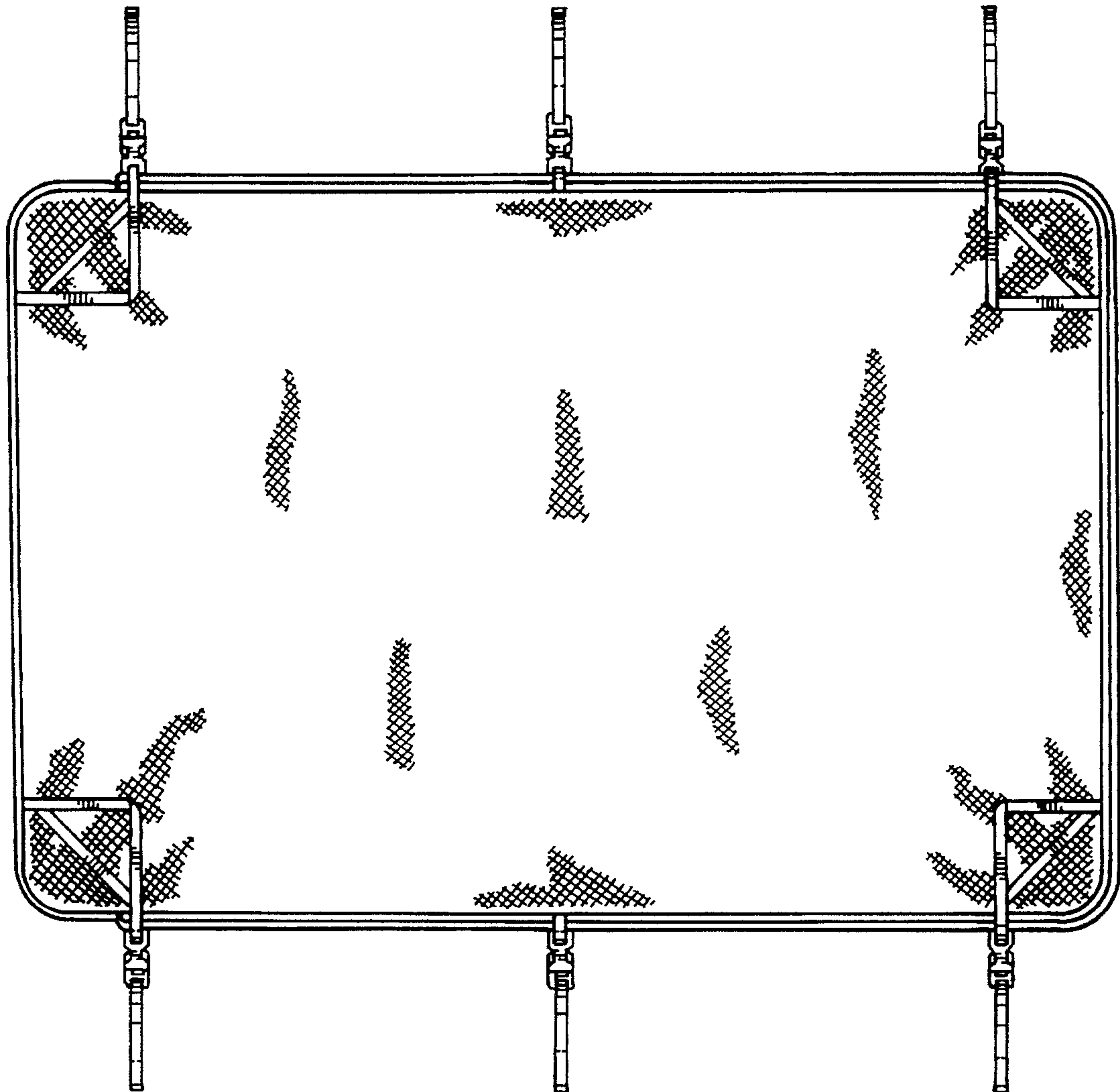

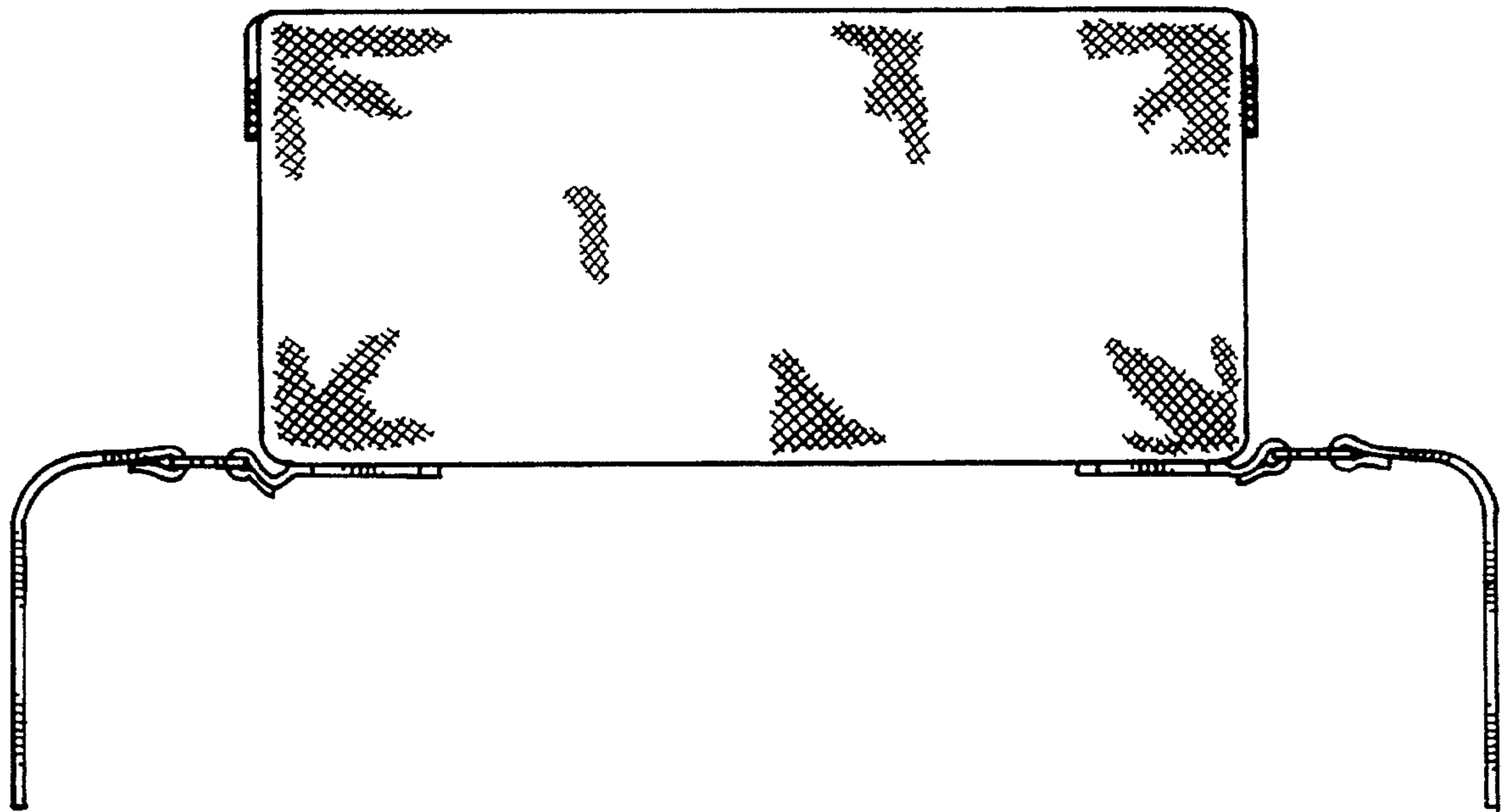

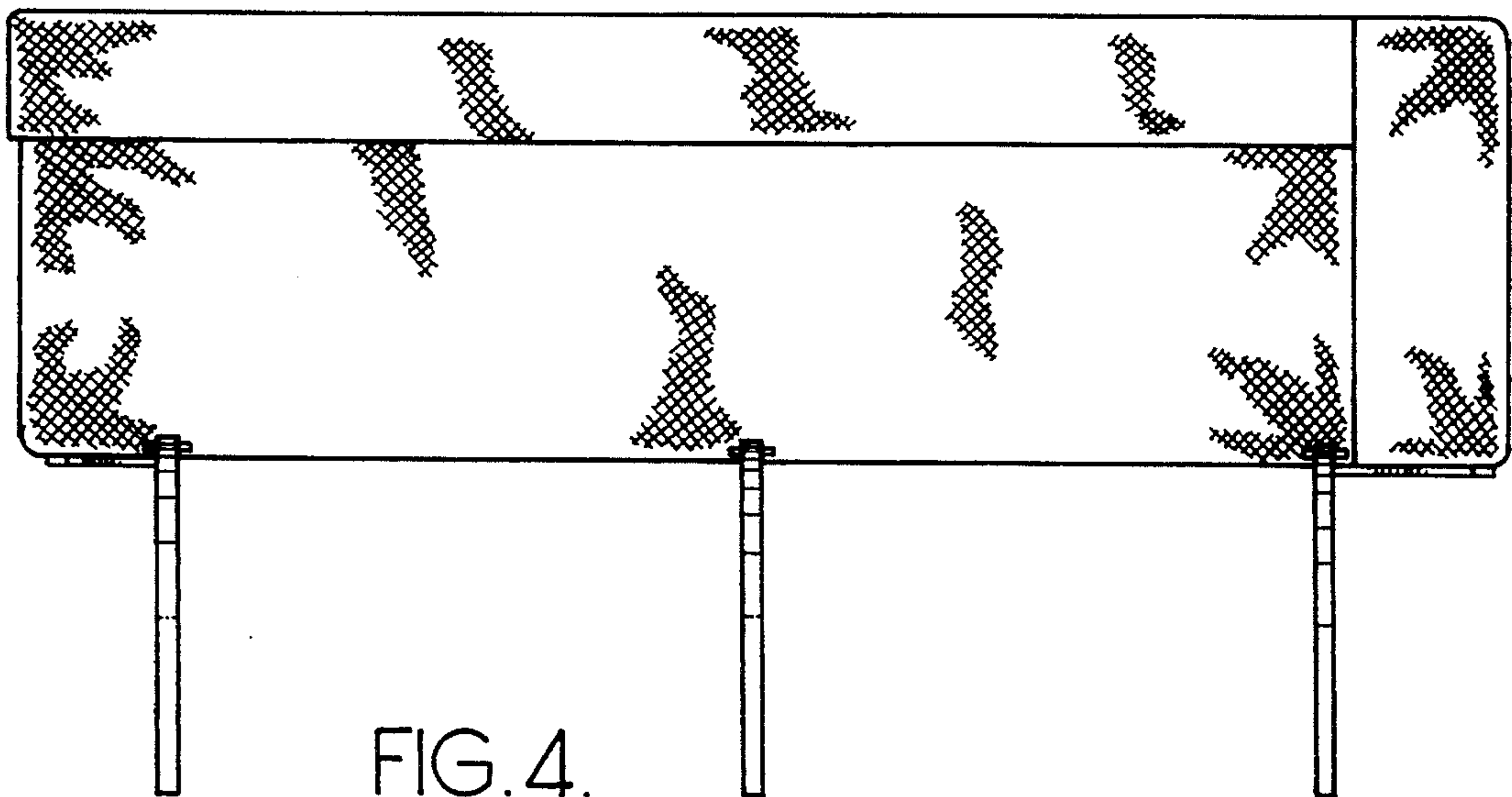
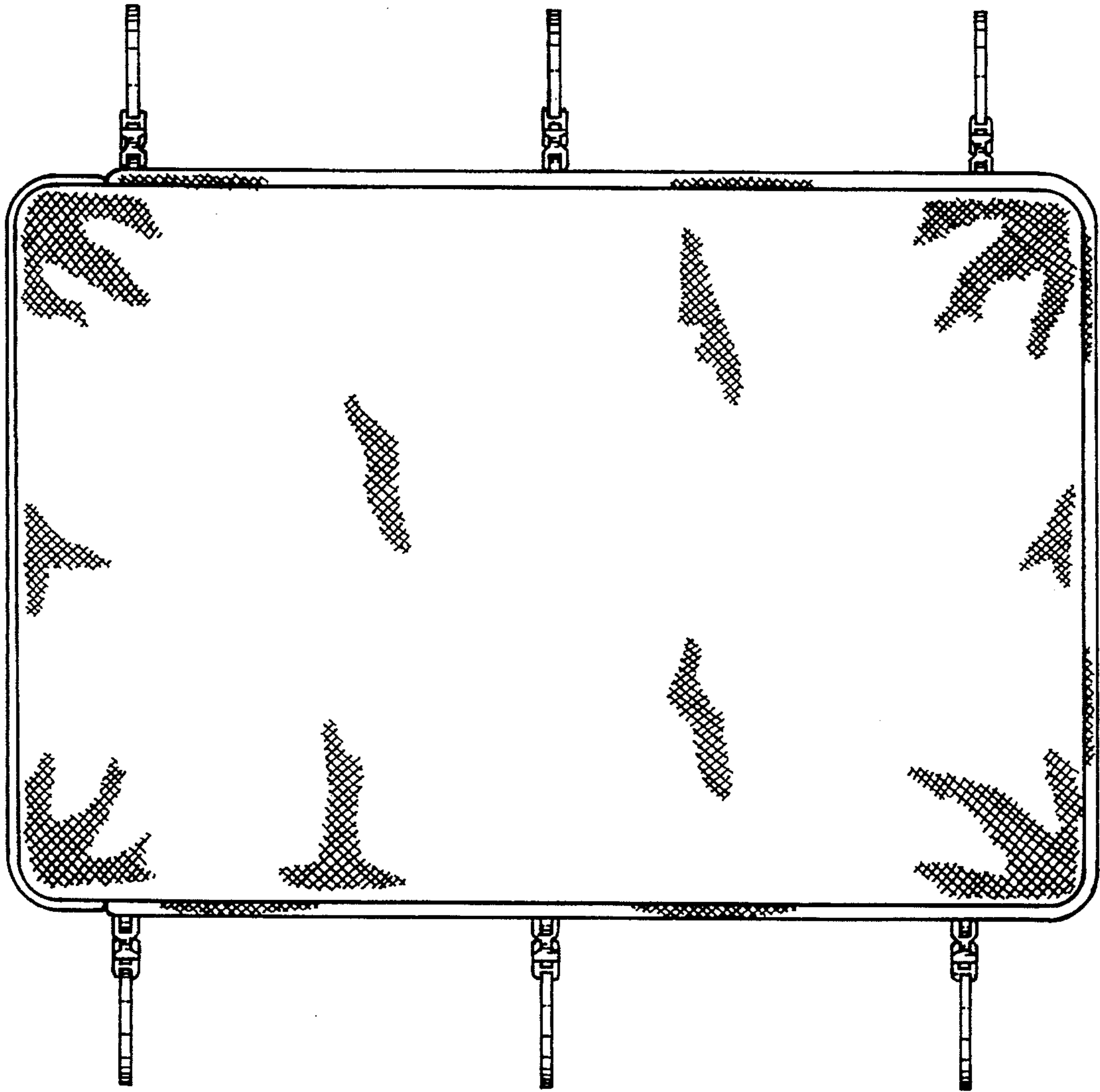

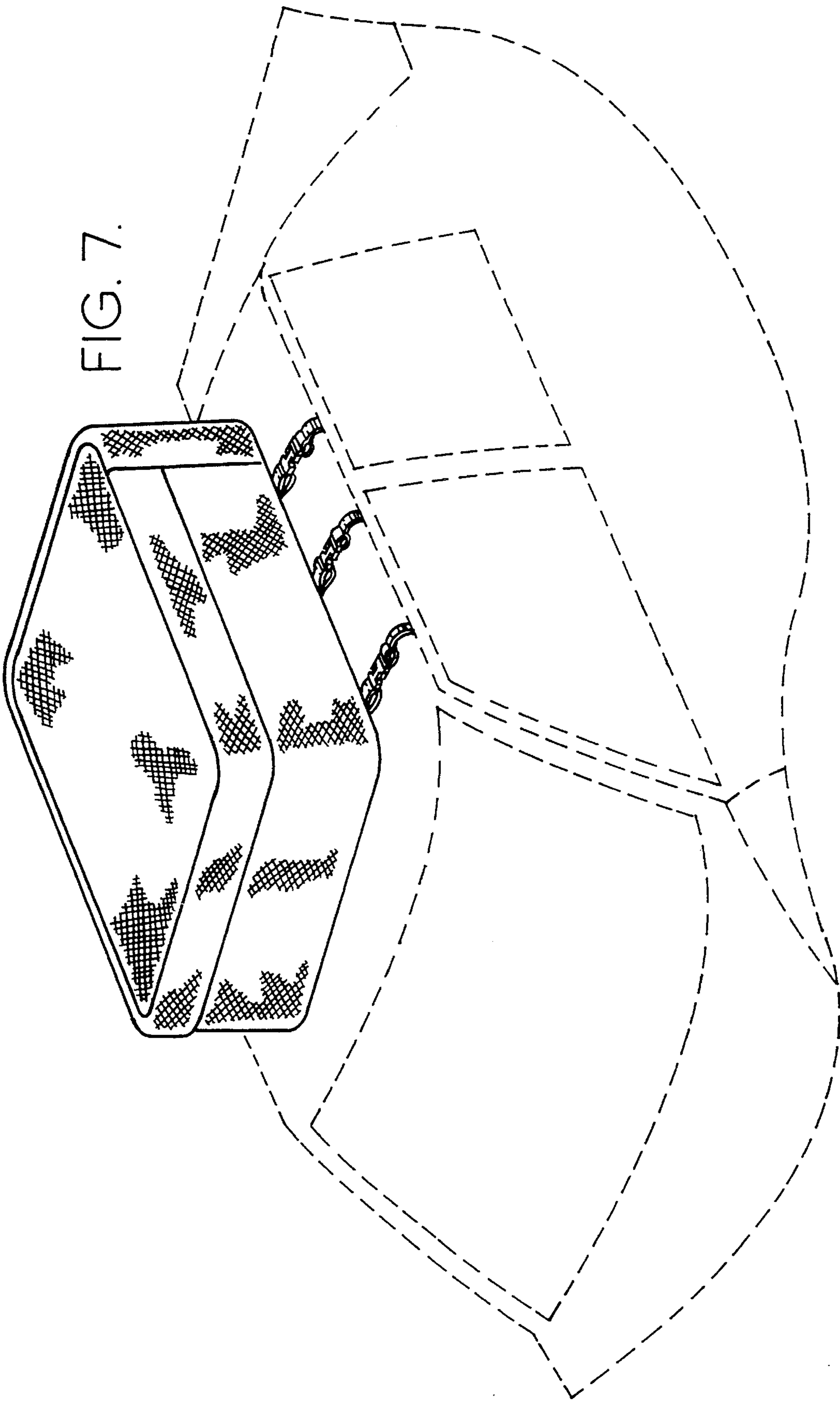
