### [57] CLAIM

The ornamental design for a transformer electrical connector, as shown and described.

### DESCRIPTION

FIG. 1 is a top plan view of one embodiment illustrating my new transformer electrical connector;

FIG. 2 is a front elevational view thereof as seen from the bottom of FIG. 1;

FIG. 3 is a bottom plan view as seen from the bottom of FIG. 2;

FIG. 4 is an end elevation view as seen from the right hand side of FIG. 2;

FIG. 5 is a rear elevation view as seen from the right hand side of FIG. 4;

FIG. 6 is an end elevation view as seen from the left hand side of FIG. 2;

FIG. 7 is a top plan view of a second embodiment of the design shown in FIG. 1;

FIG. 8 is a front elevation view of FIG. 7 as seen from the bottom thereof;

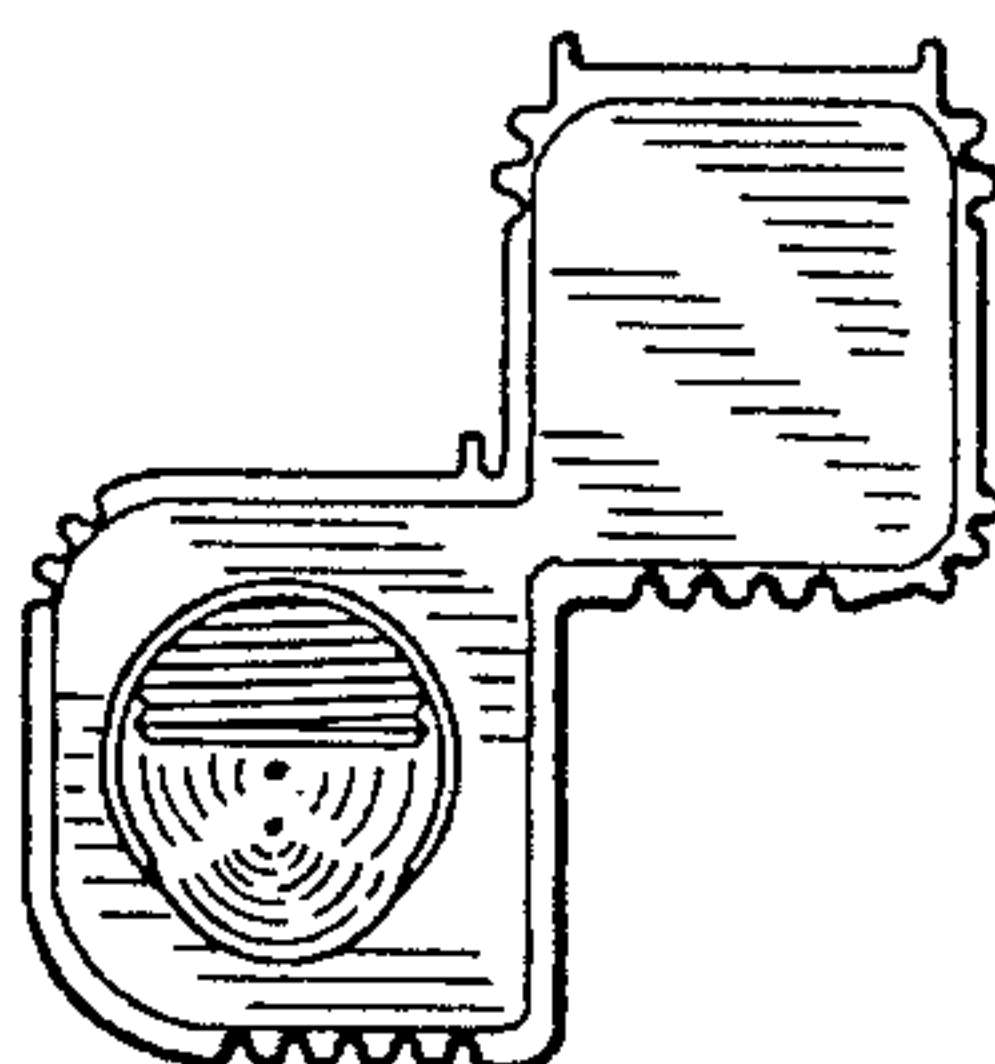
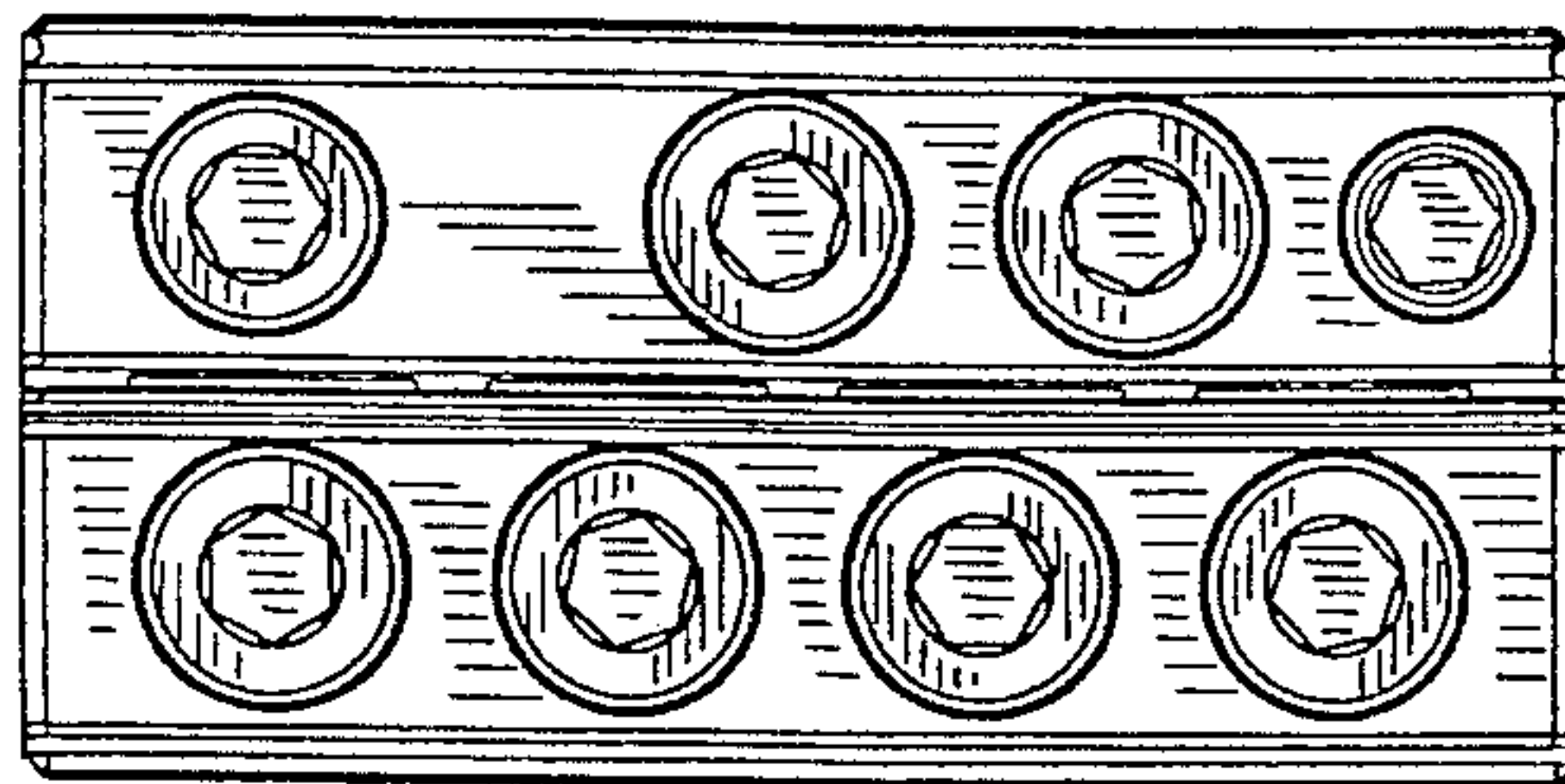
FIG. 9 is a bottom plan view as seen from the bottom of FIG. 8;

FIG. 10 is an end elevation view as seen from the right hand side of FIG. 8;

FIG. 11 is a rear elevation view as seen from the right hand side of FIG. 10; and,

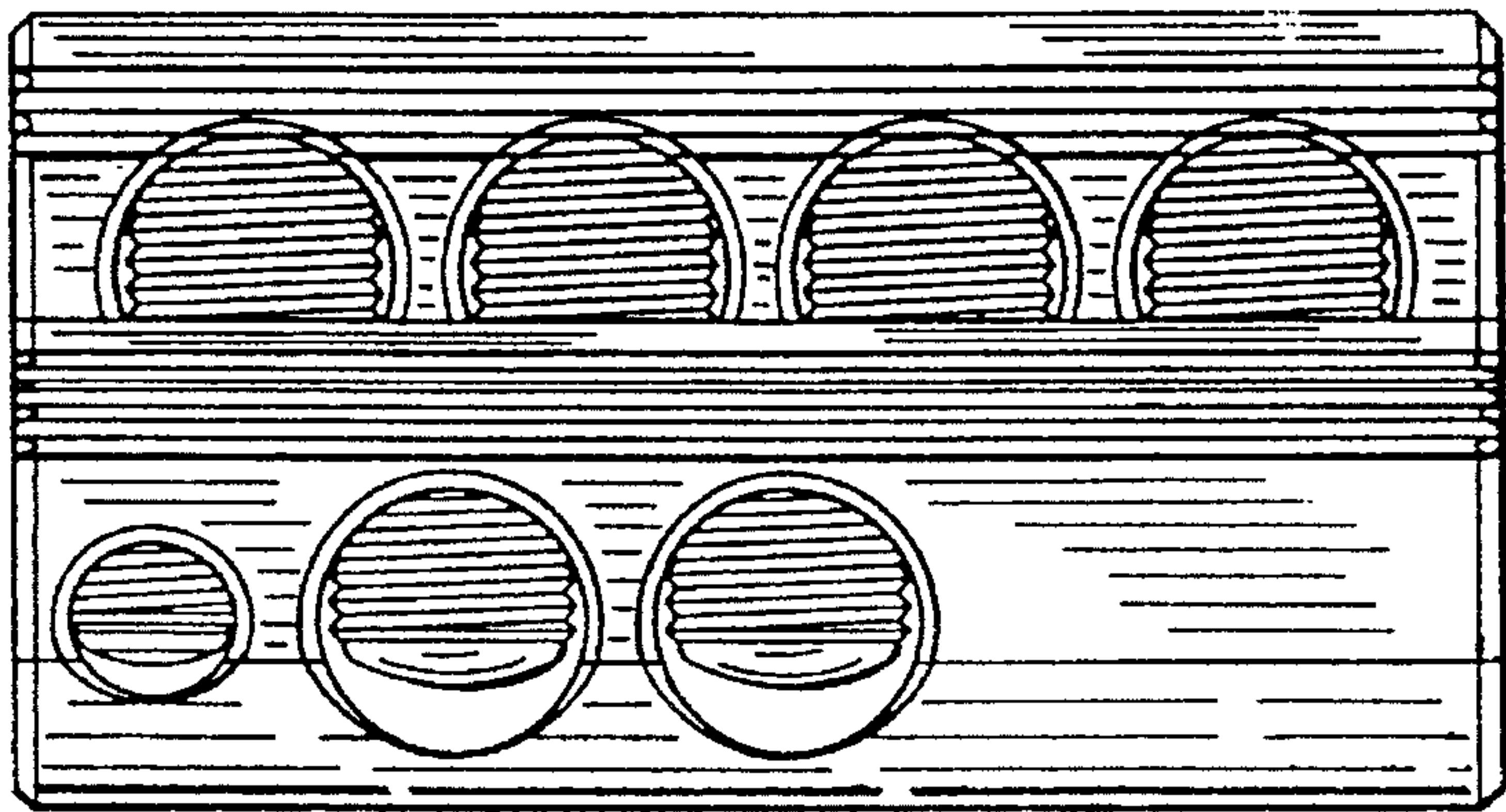

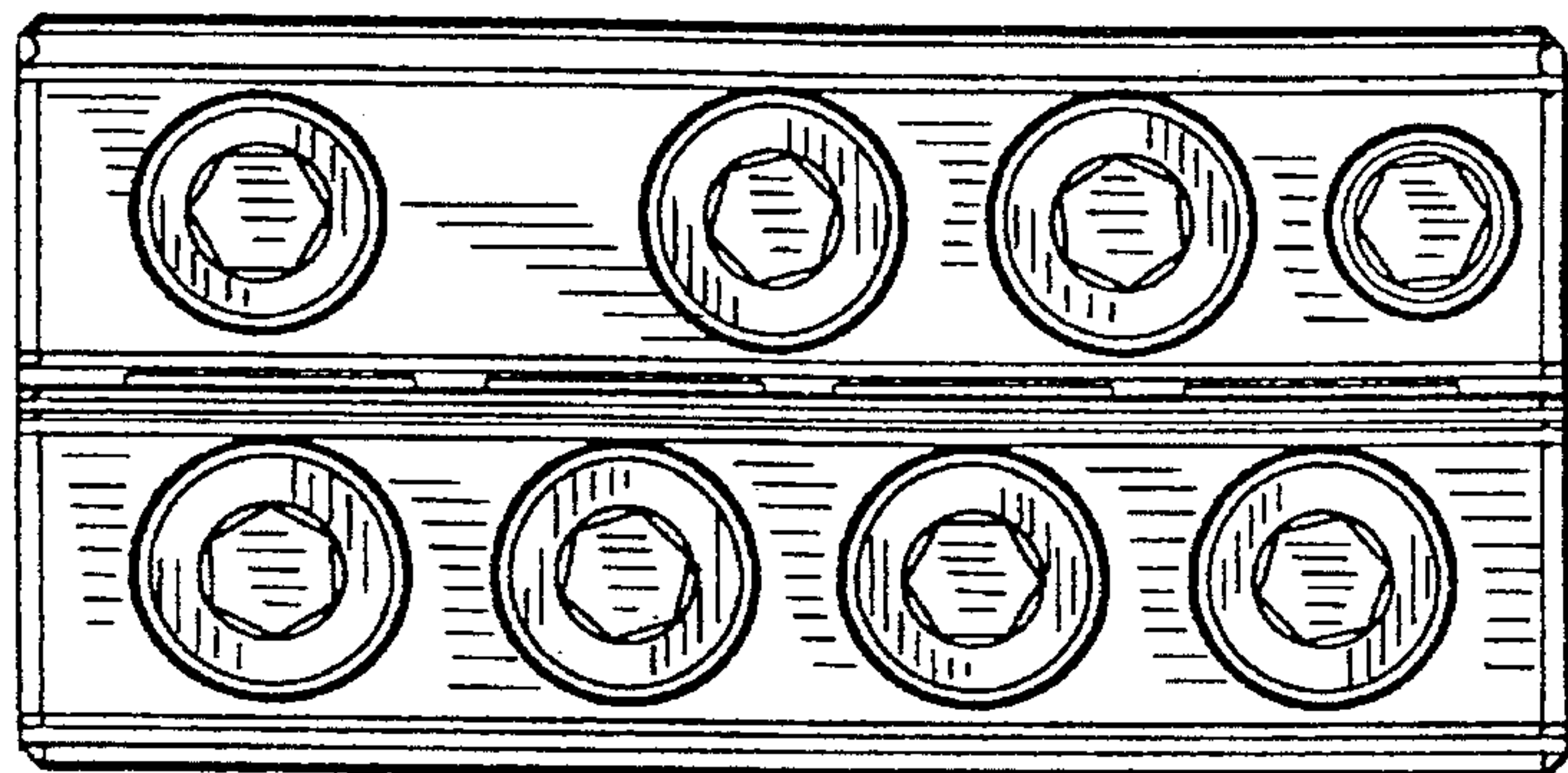

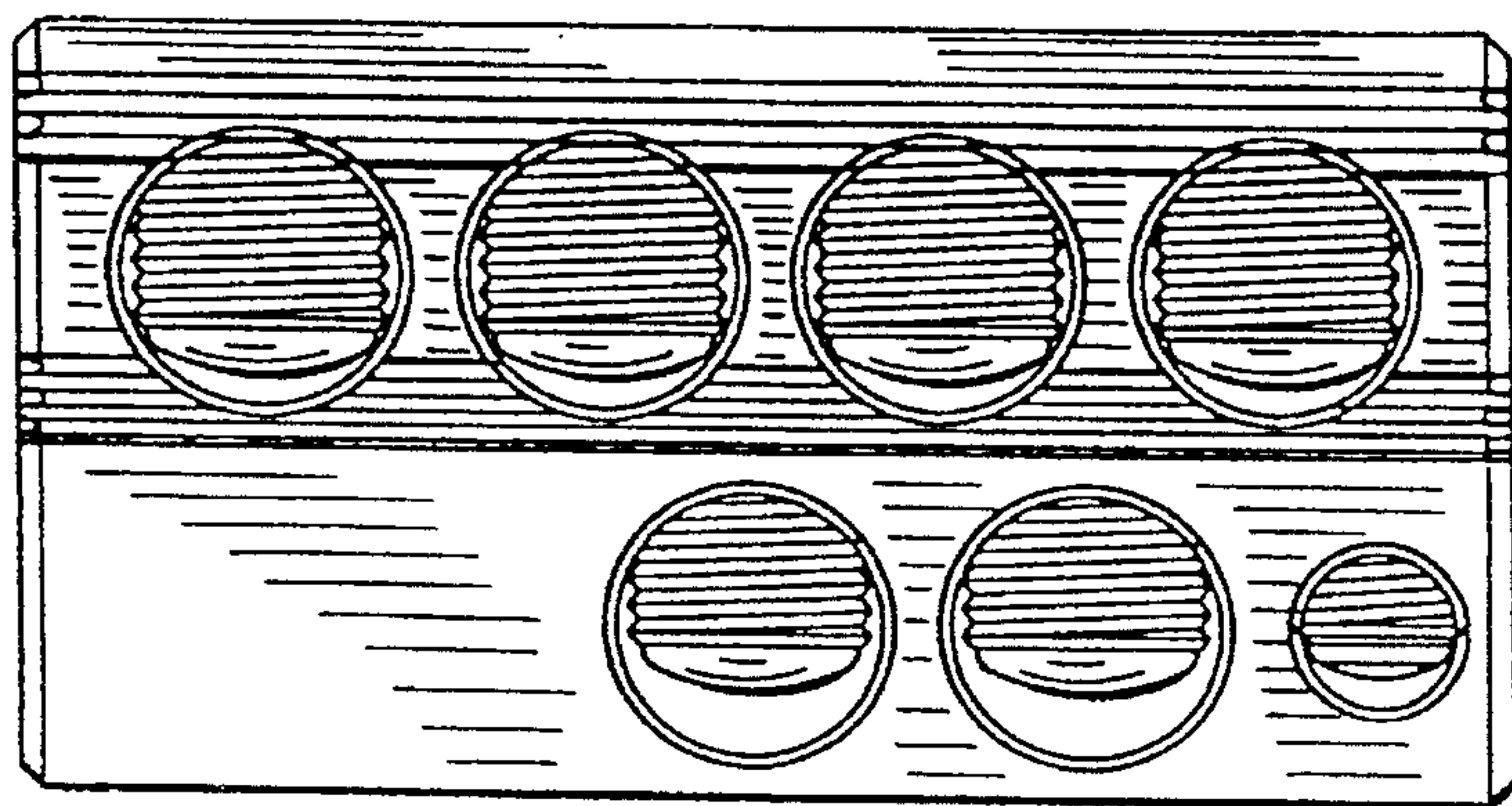

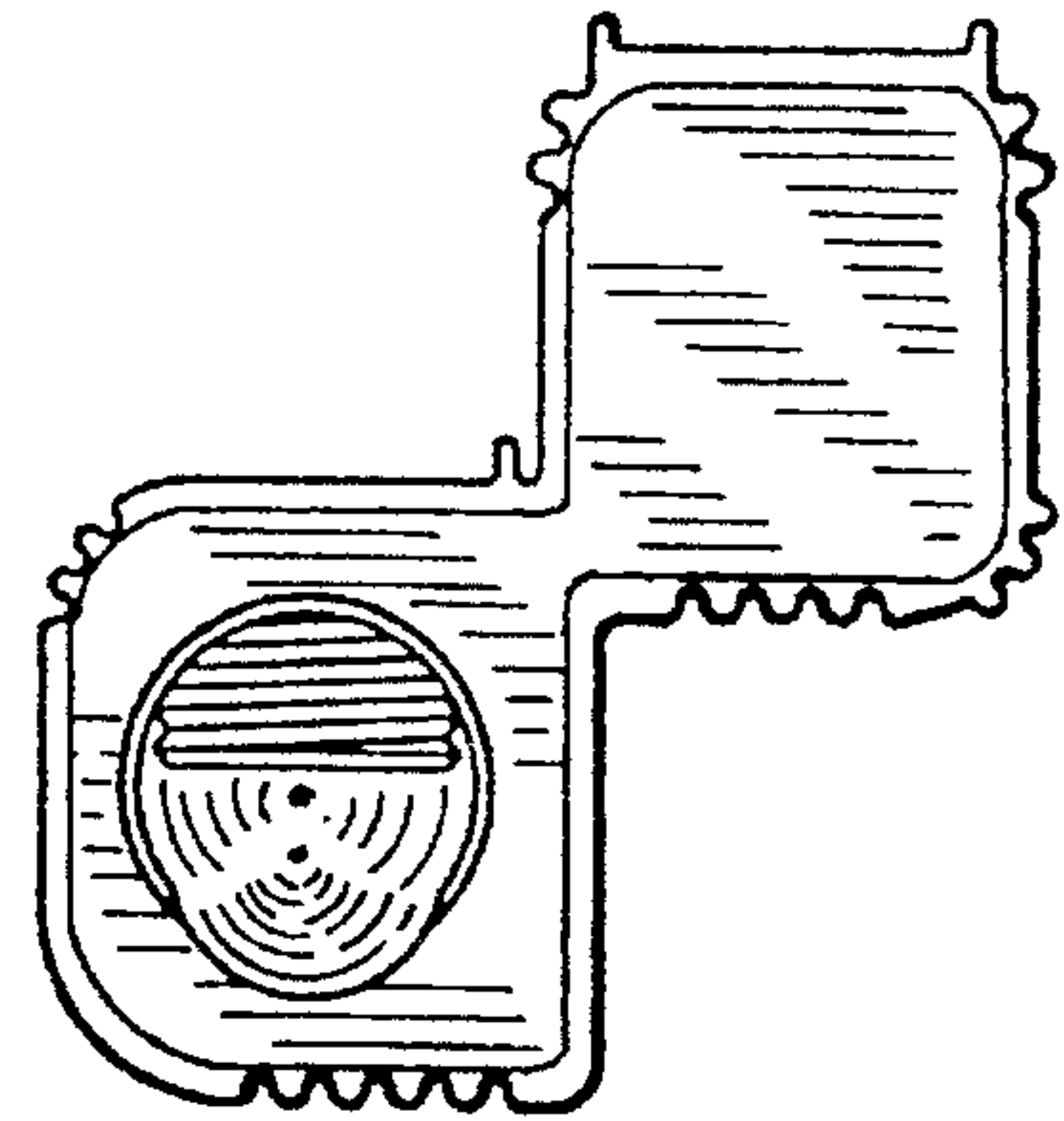

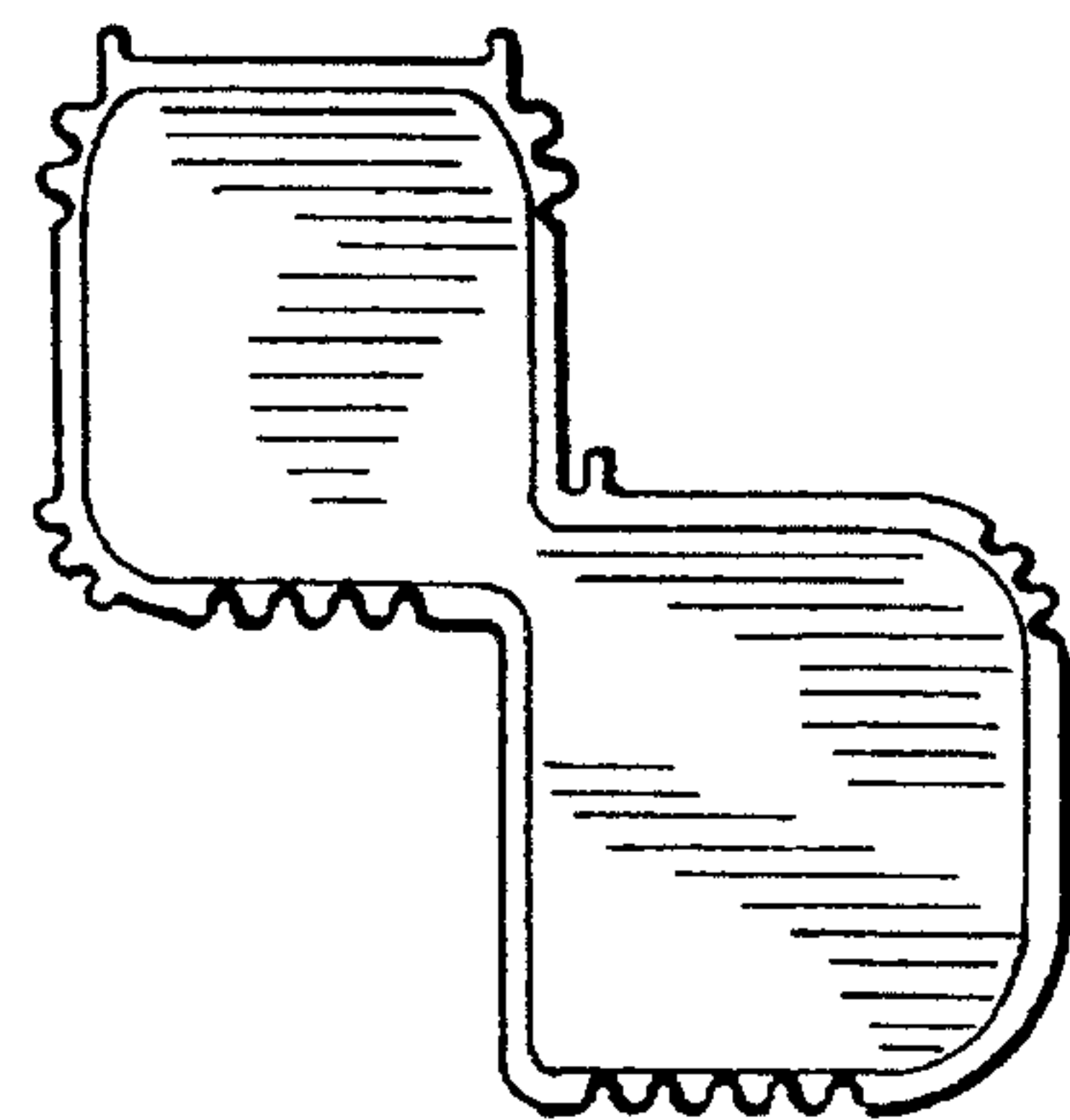

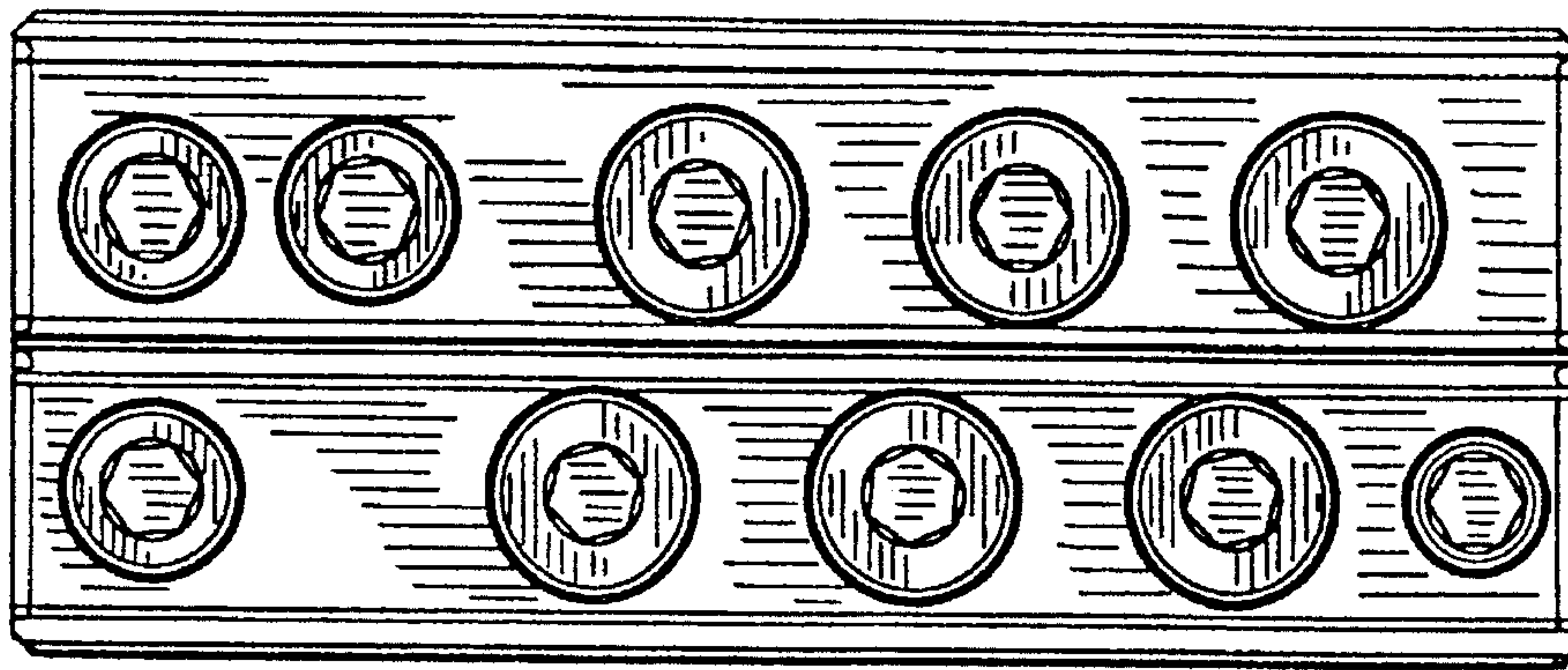

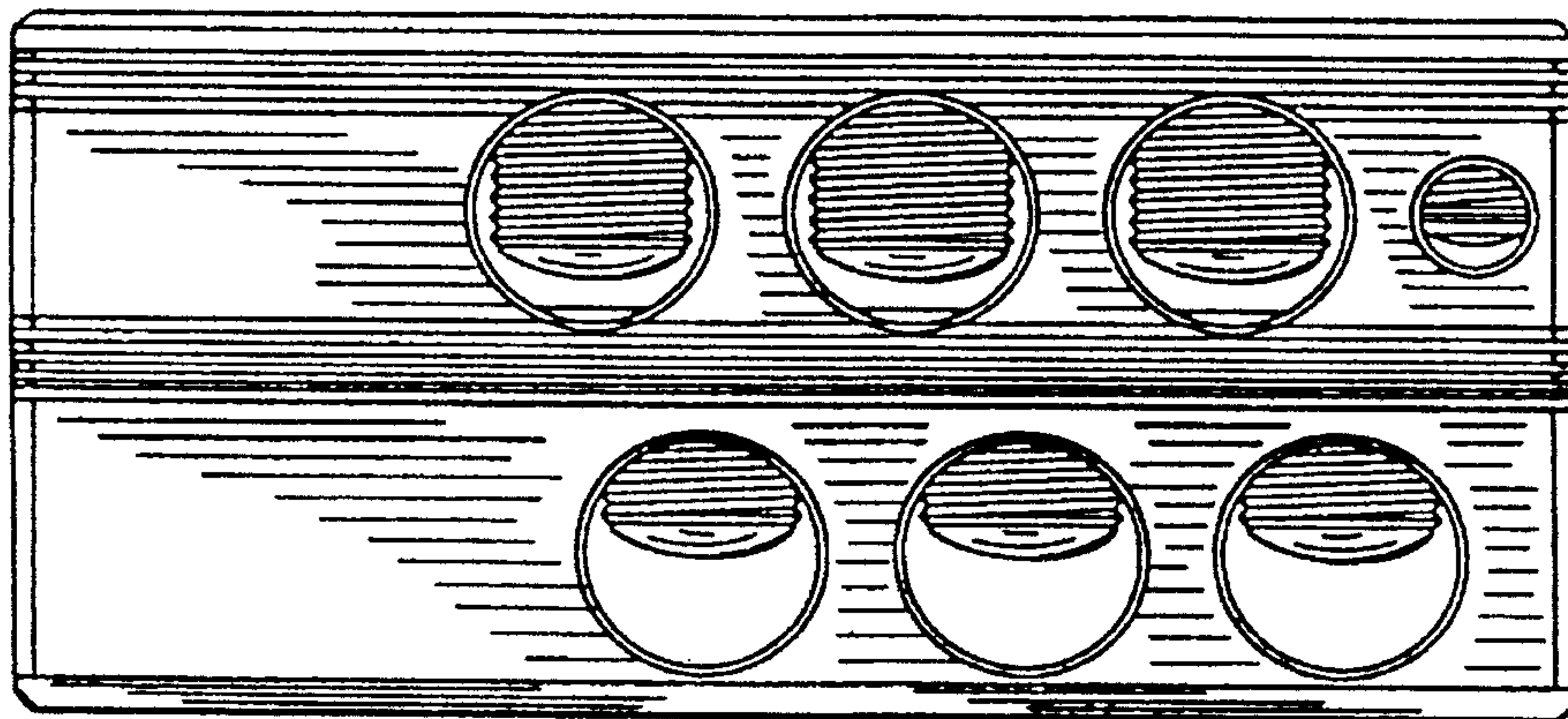

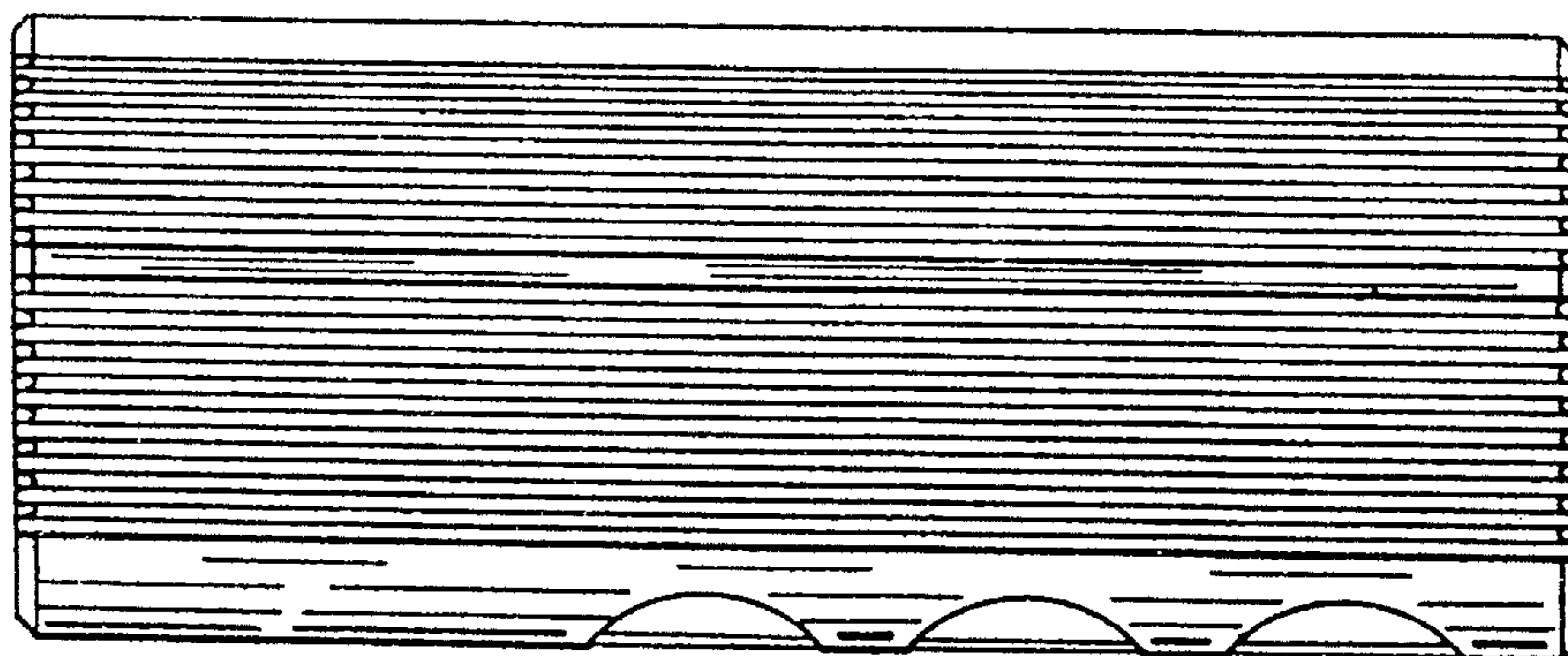

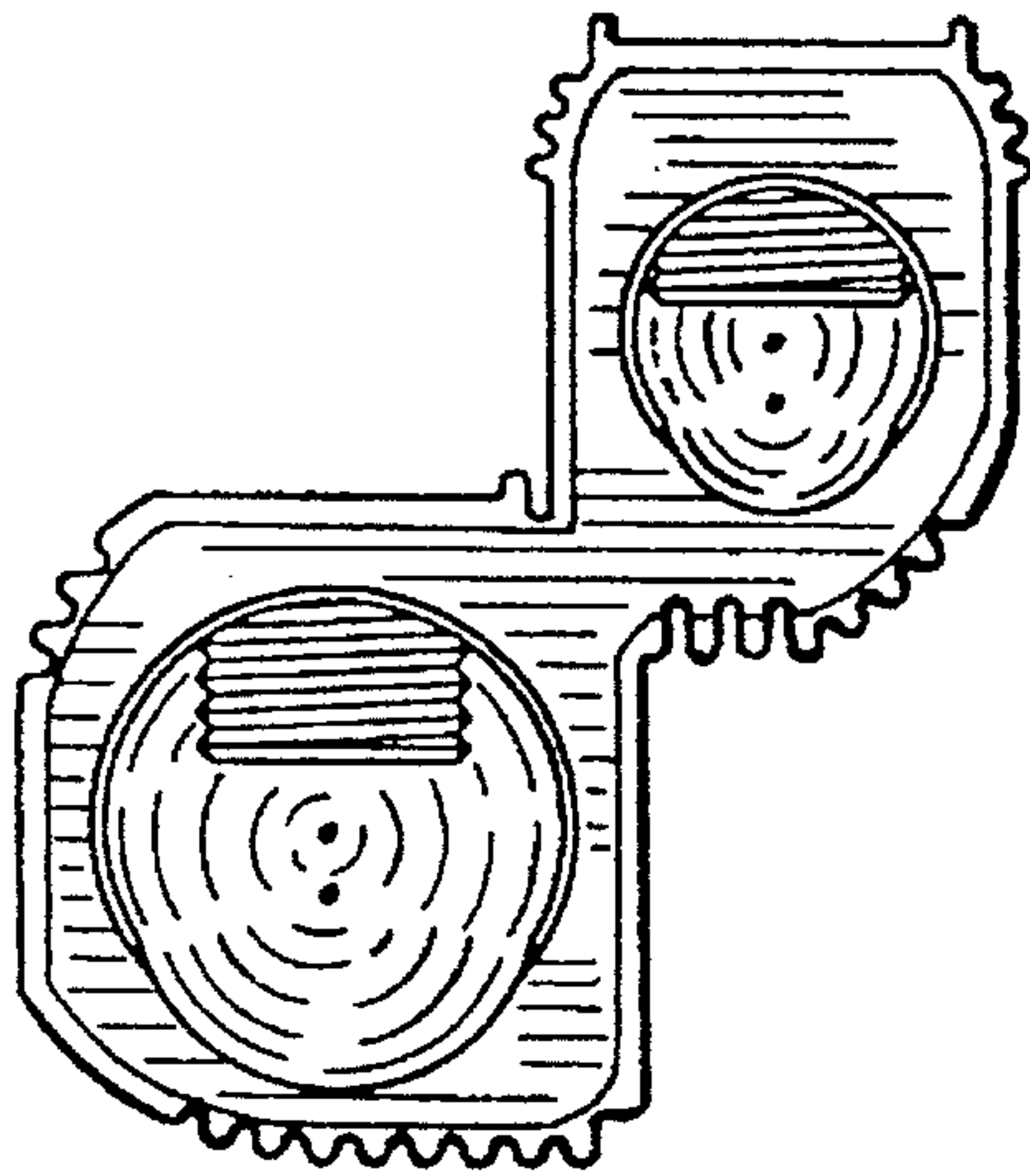

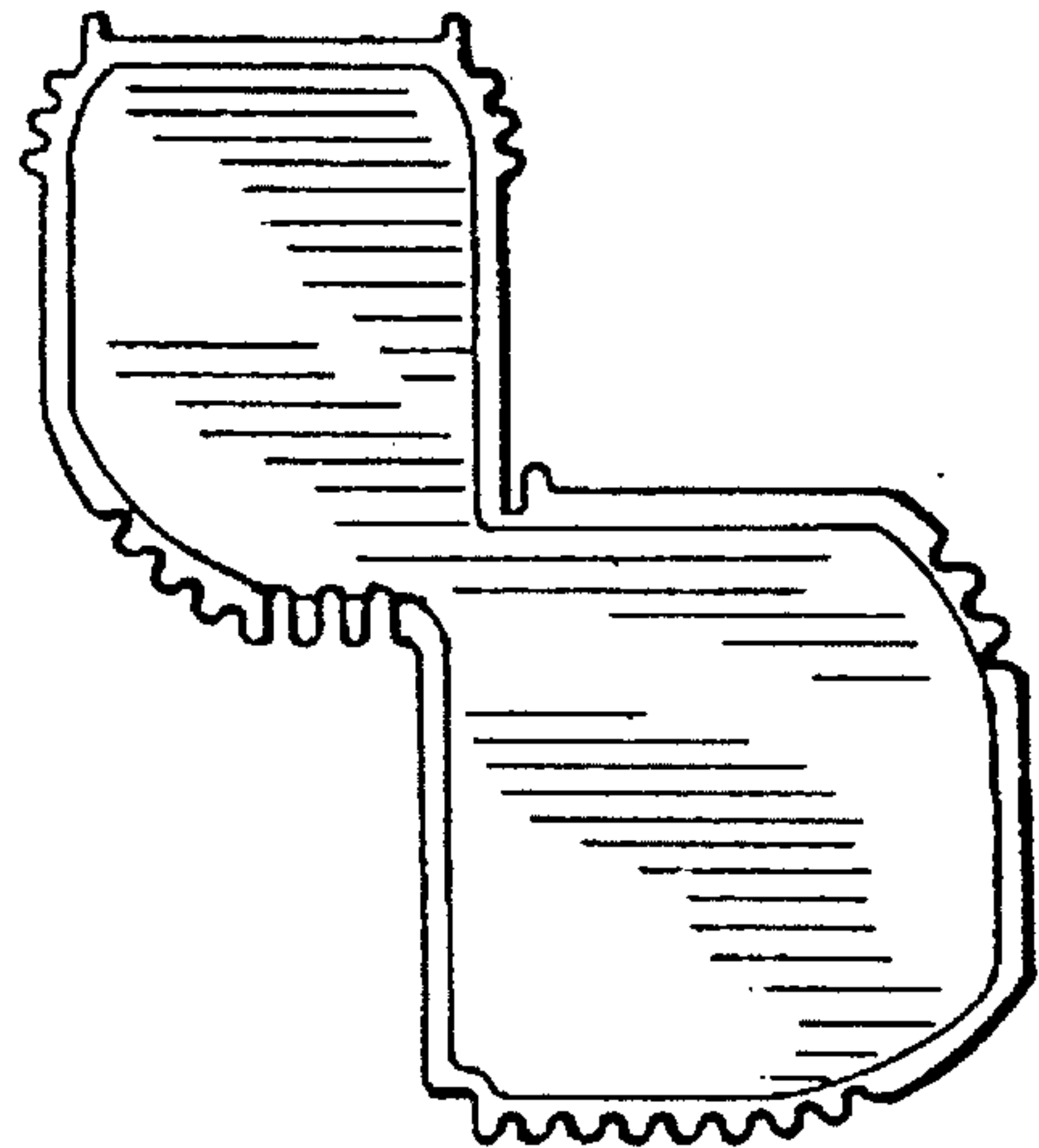

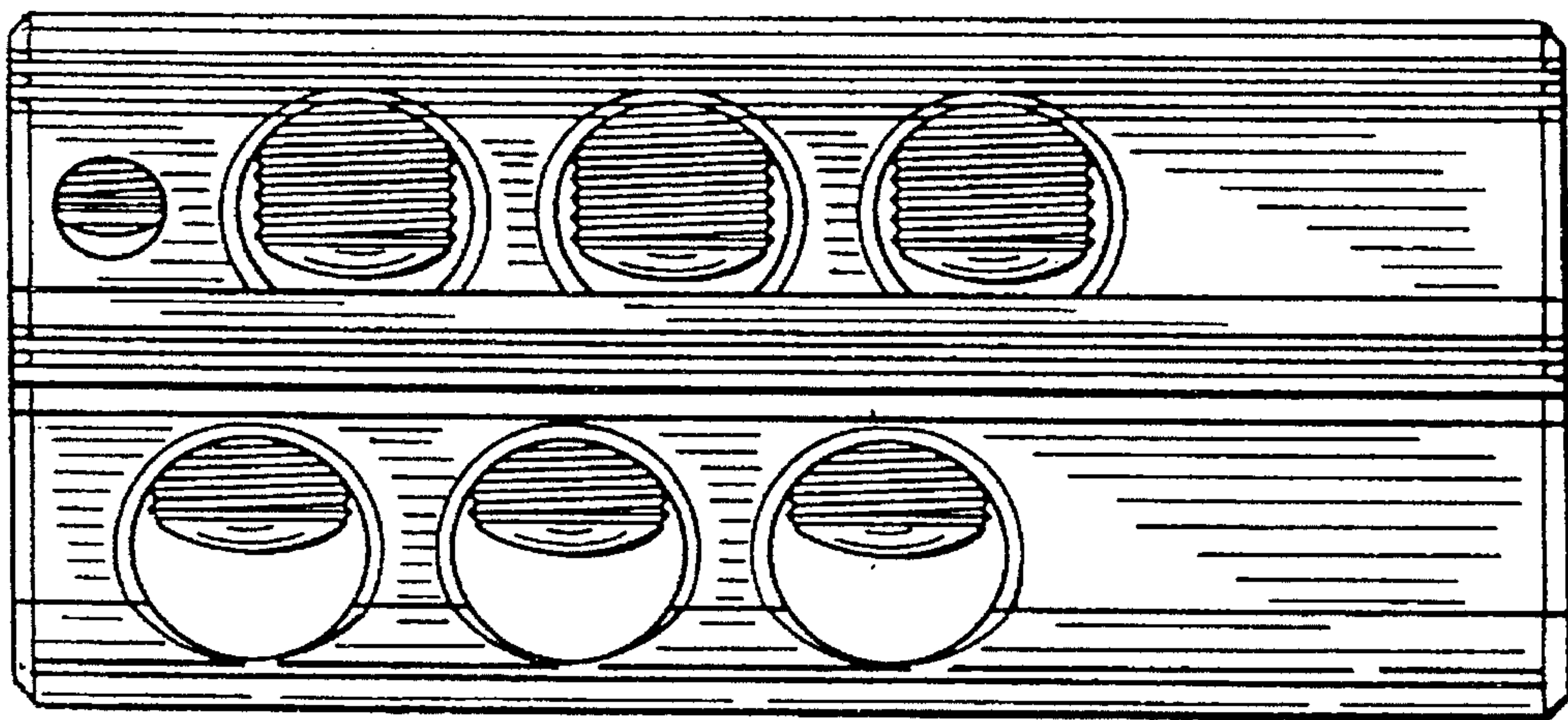
