[57] CLAIM

The ornamental design for a central processing unit cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the central processing unit cover of my new design;

FIG. 18 is a rear elevational view of FIG. 15;


FIG. 19 is a top plan view of FIG. 15;








































