The ornamental design for a Christmas tree light holder, as shown and described.

DESCRIPTION

FIG. 1 is a diagrammatic perspective view of a Christmas tree light holder showing my new design in use holding

lights on a Christmas tree

FIG. 2 is an enlarged perspective view of a Christmas tree light holder;

FIG. 3 is a reduced top plan view of FIG. 2;

FIG. 4 is a bottom plan view of FIG. 3;

FIG. 5 is a front elevational view of FIG. 3;

FIG. 6 is a rear elevational view of FIG. 3;

FIG. 7 is a right side elevational view of FIG. 3;

FIG. 8 is a left side elevational view of FIG. 3;

FIG. 9 is a top plan view of a second embodiment of a Christmas tree light holder showing my new design;

FIG. 10 is a bottom plan view of FIG. 9;

FIG. 11 is a front elevational view of FIG. 9;

FIG. 12 is a rear elevational view of FIG. 9;

FIG. 13 is a right side elevational view of FIG. 9;

FIG. 14 is a left side elevational view of FIG. 9;

FIG. 15 is a top plan view of a third embodiment of a Christmas tree light holder showing my new design;

FIG. 16 is a bottom plan view of FIG. 15;

FIG. 17 is a front elevational view of FIG. 15;

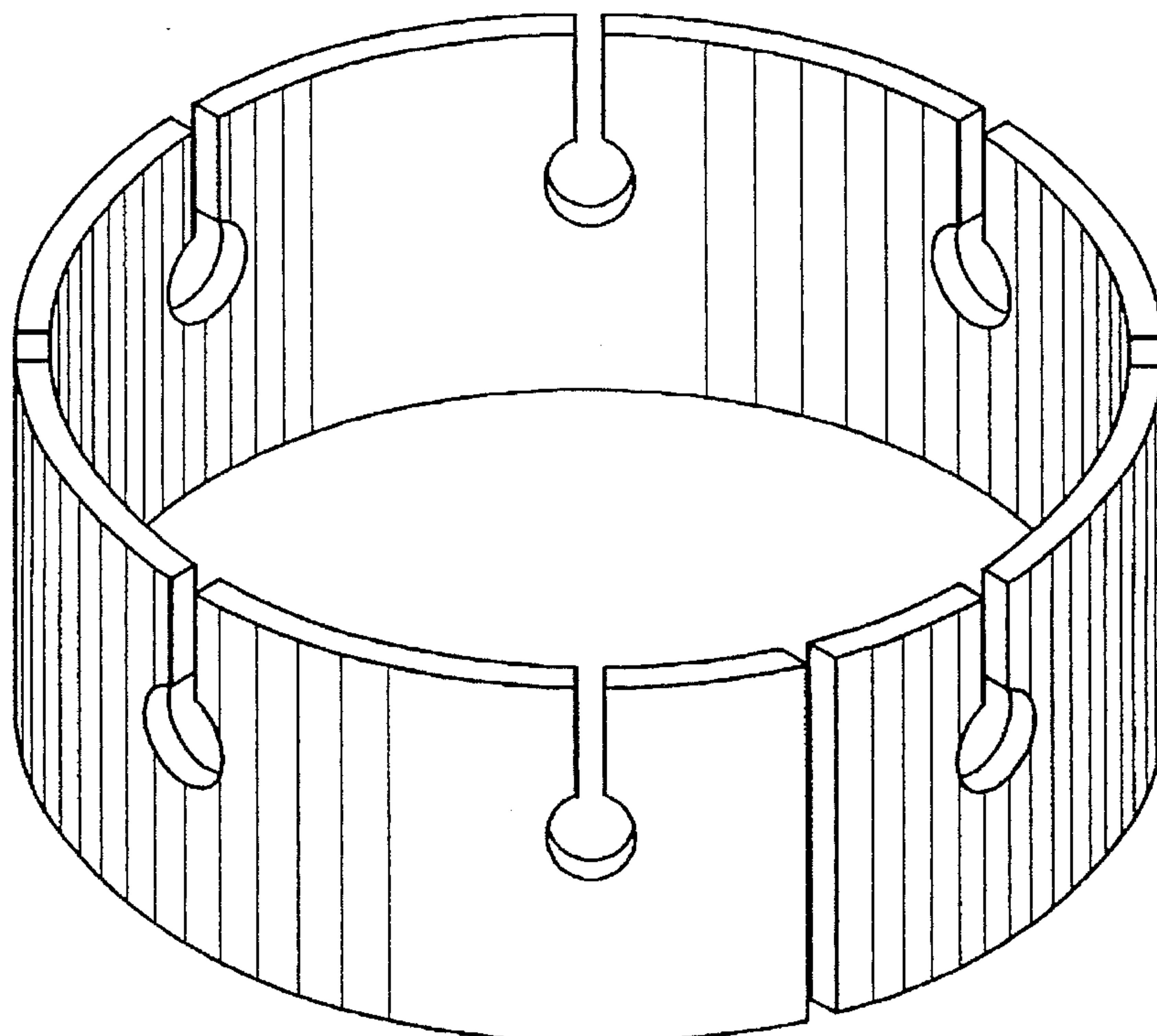
FIG. 18 is a rear elevational view of FIG. 15;

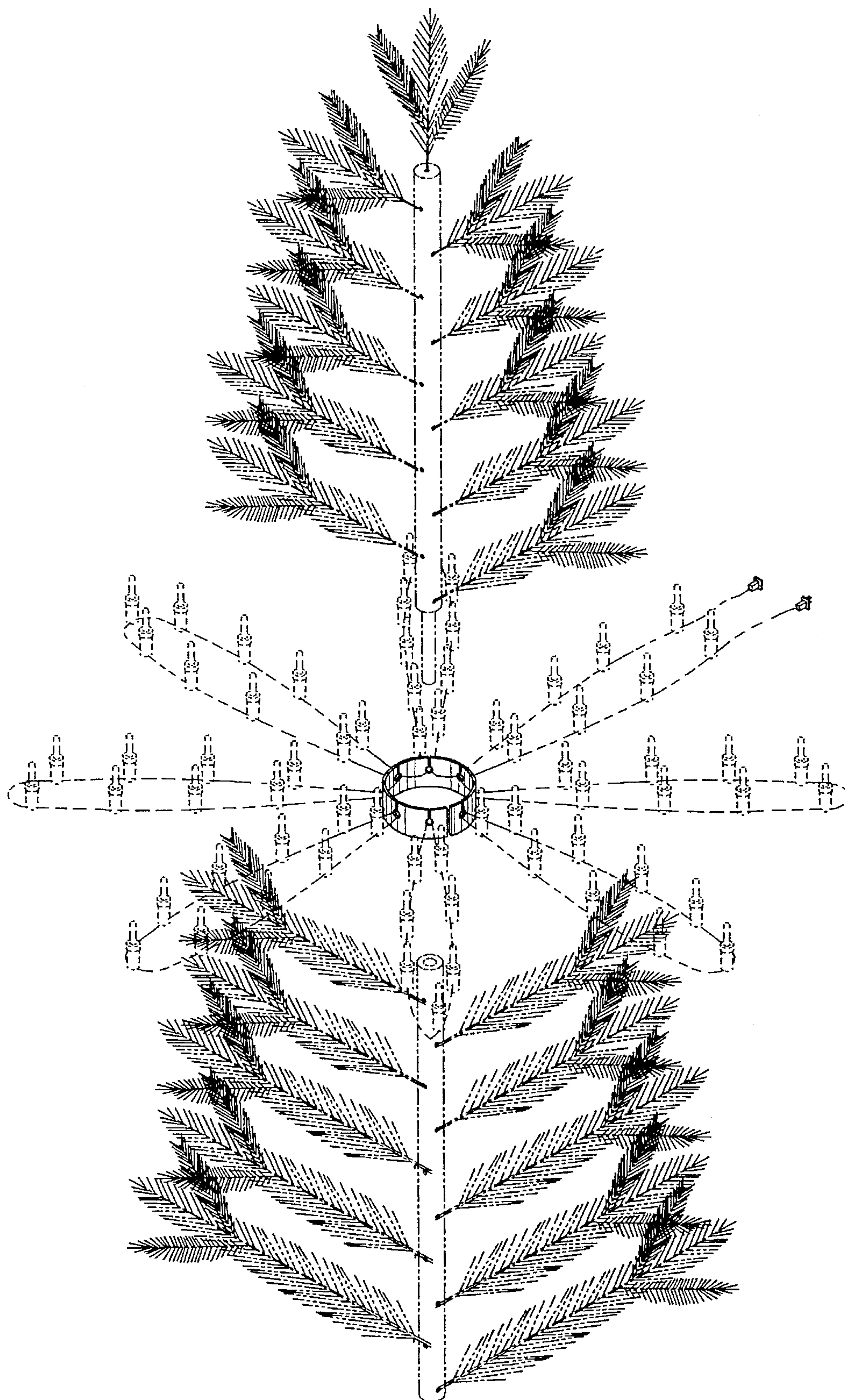

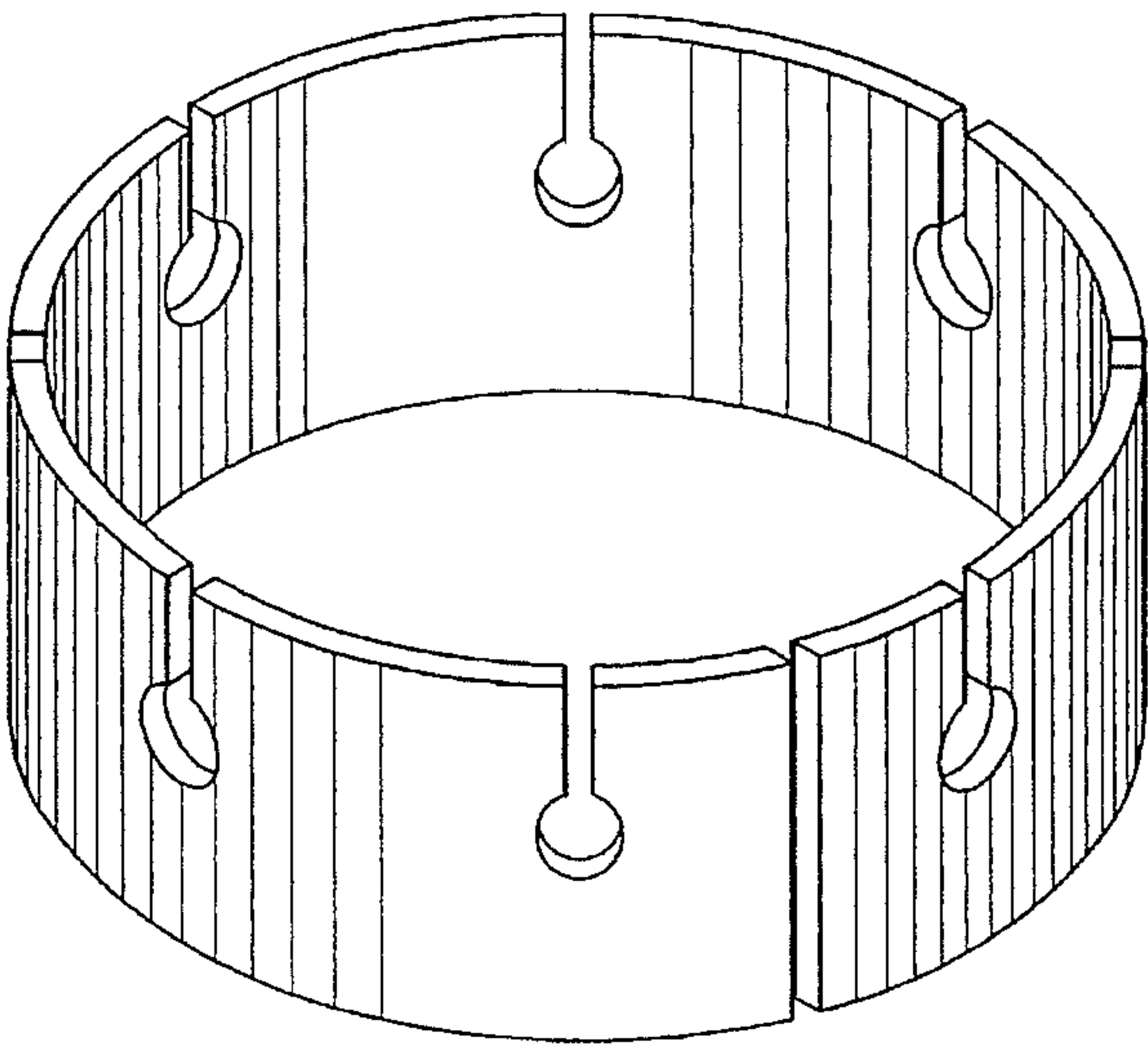

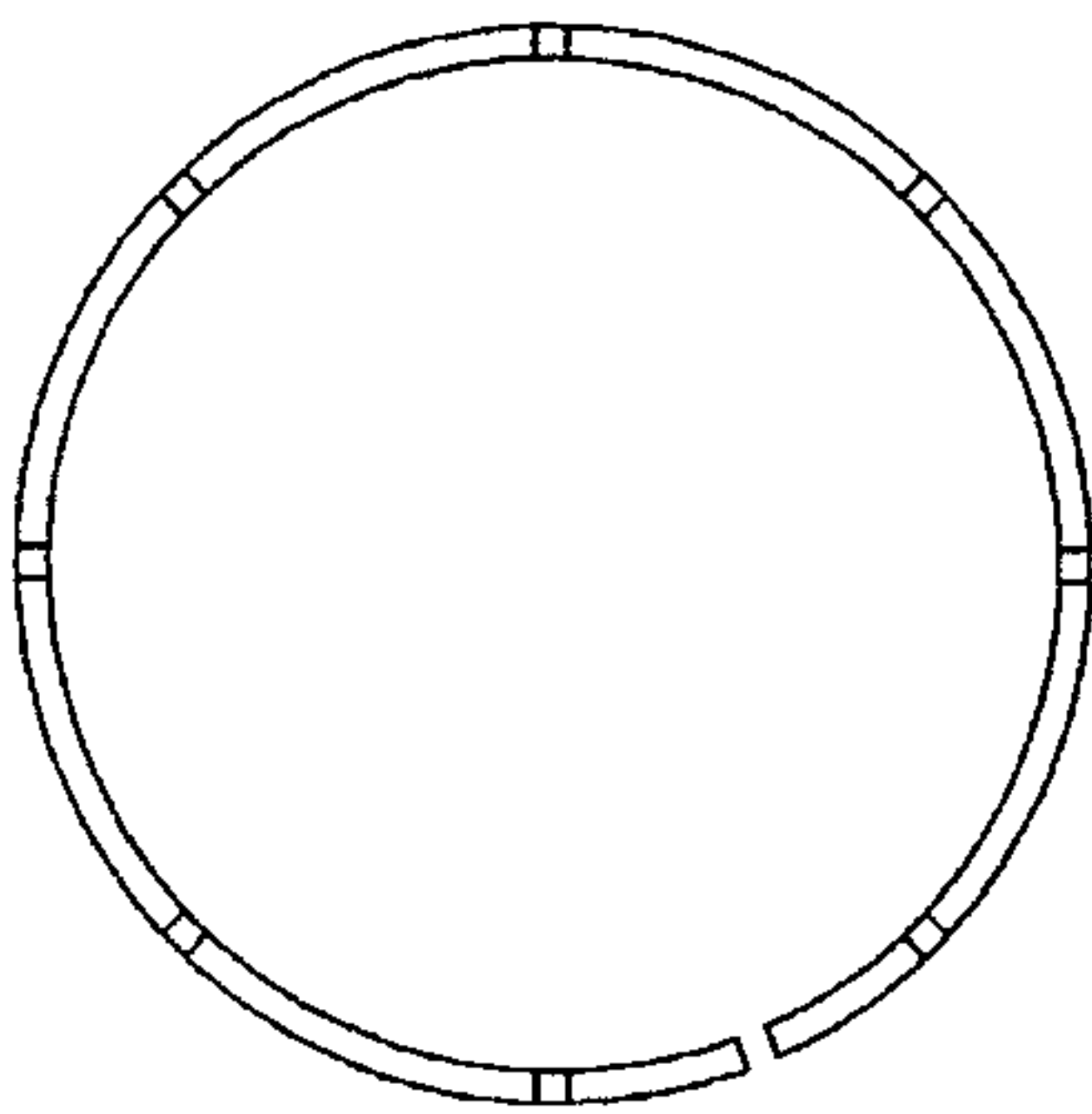

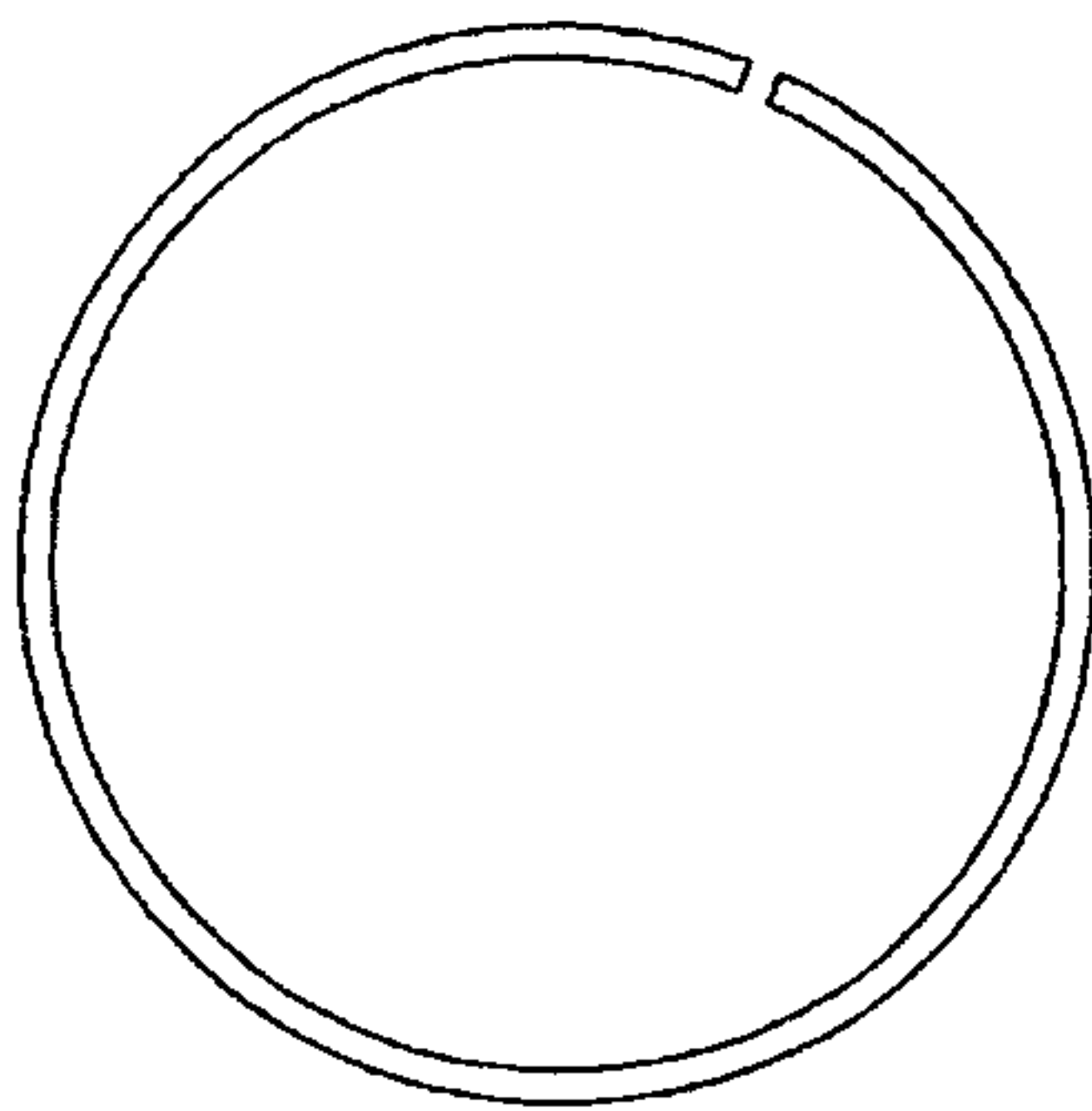

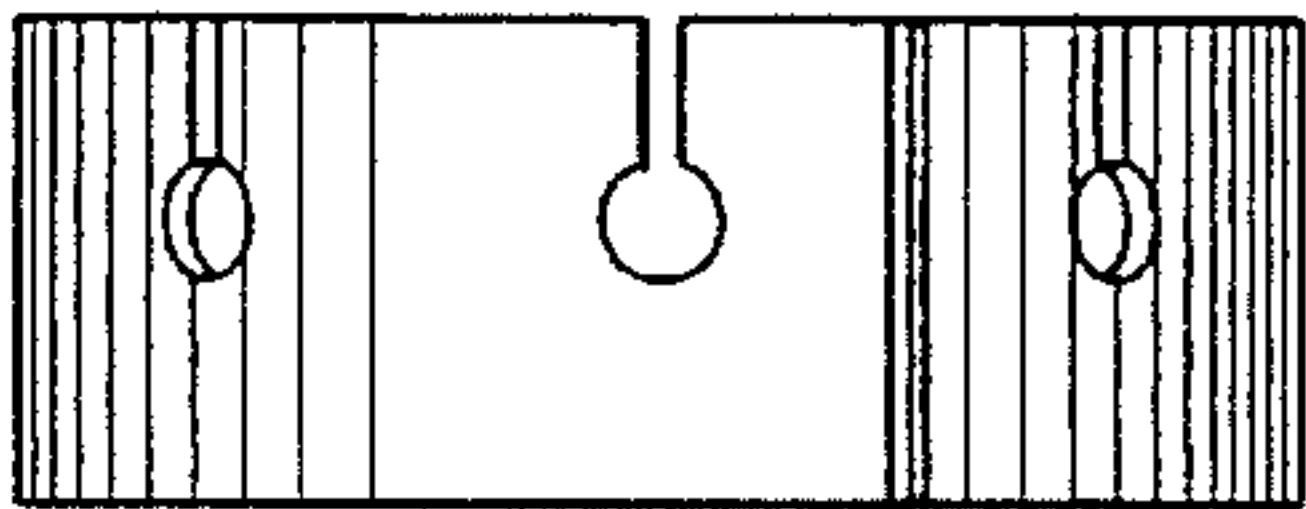

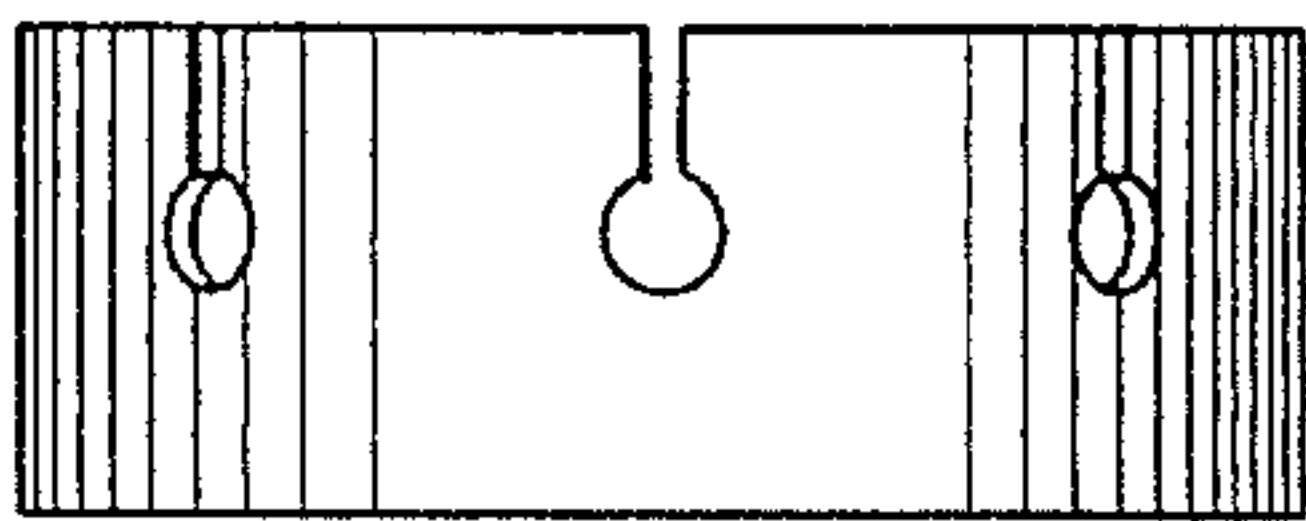

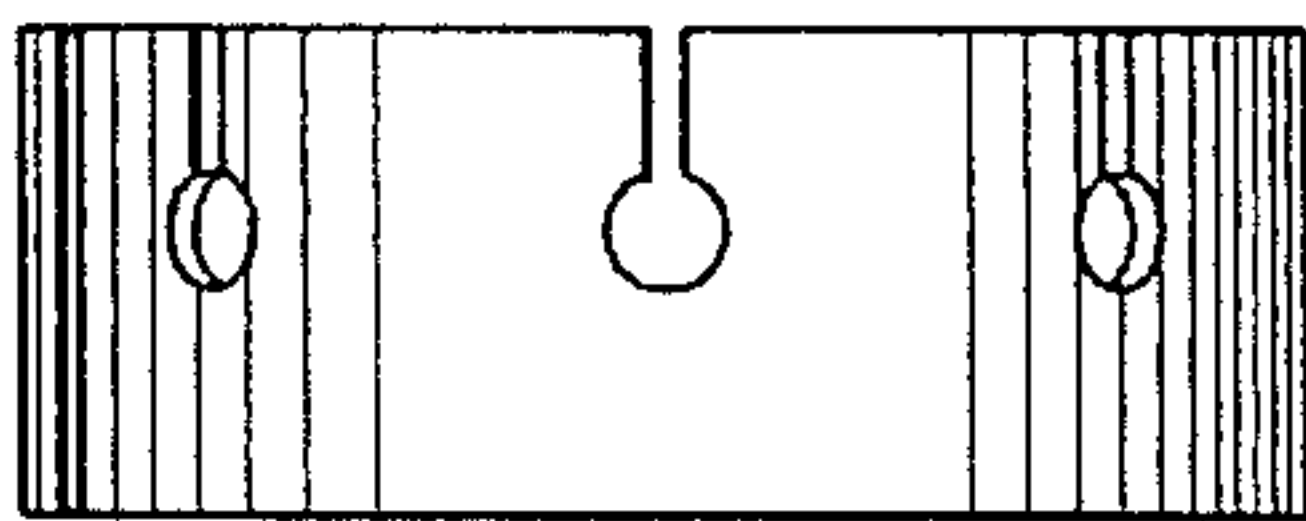

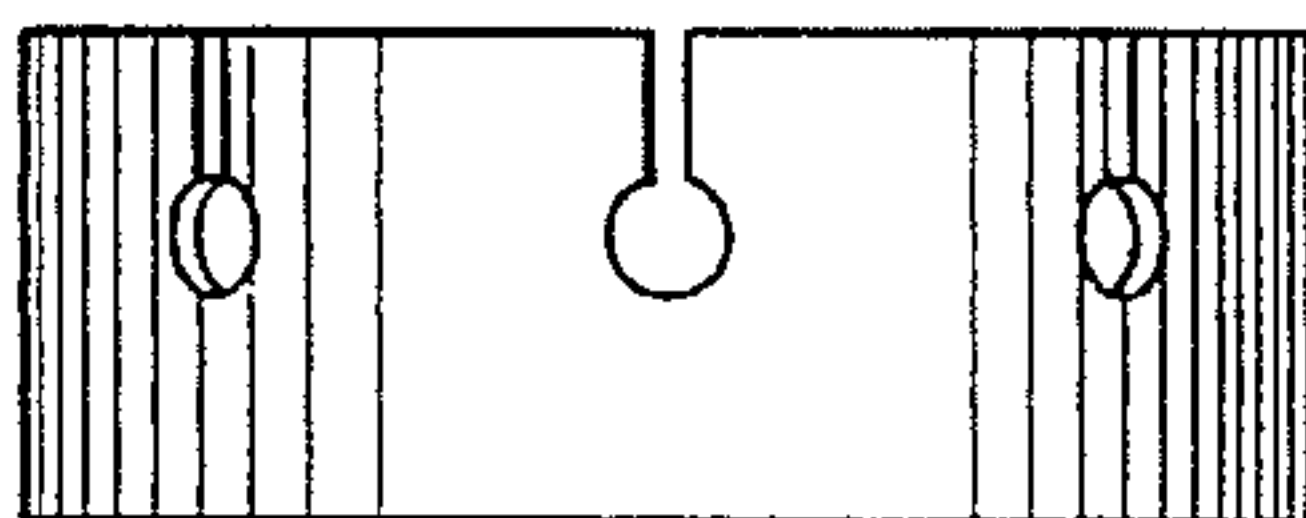

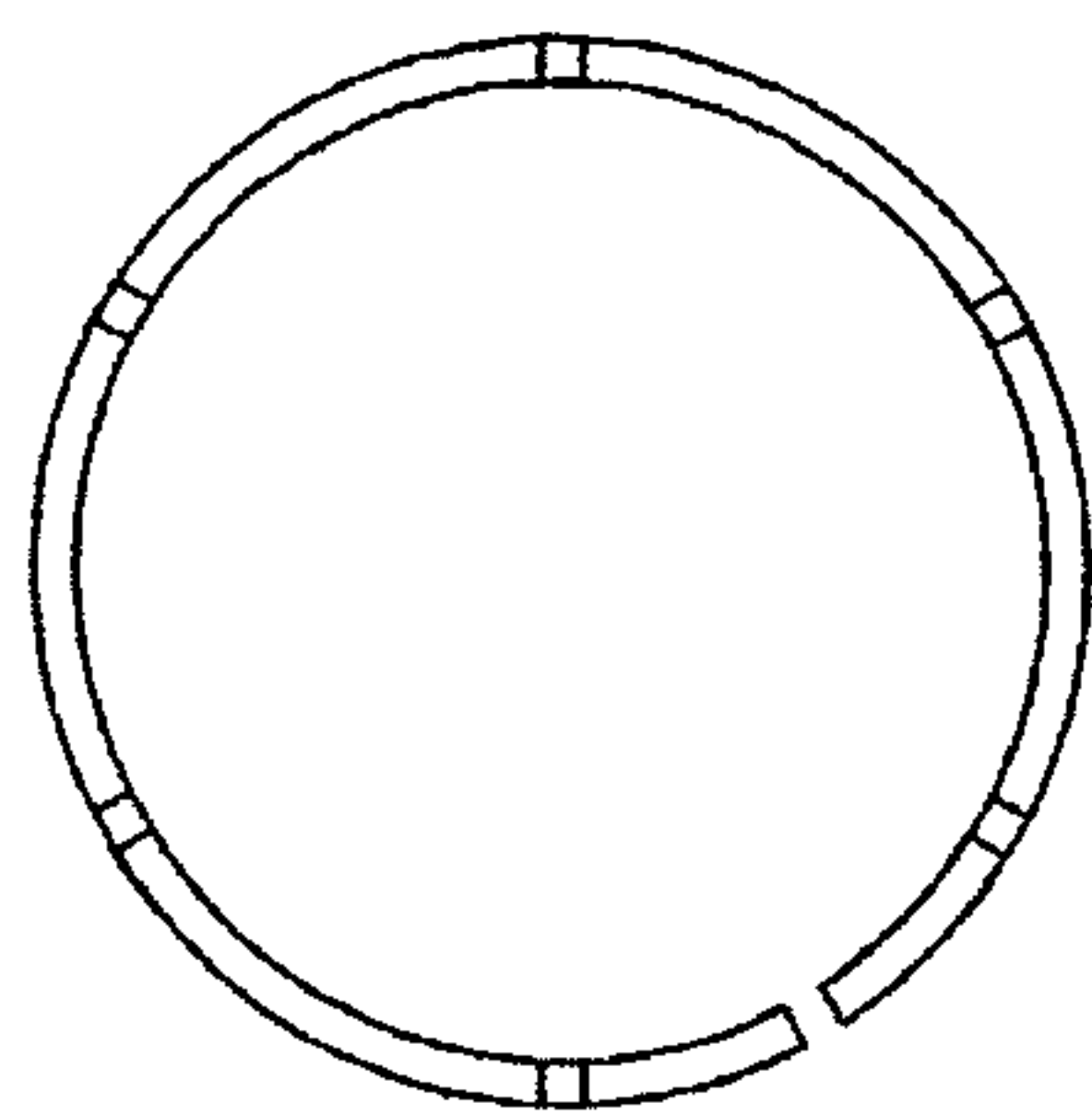

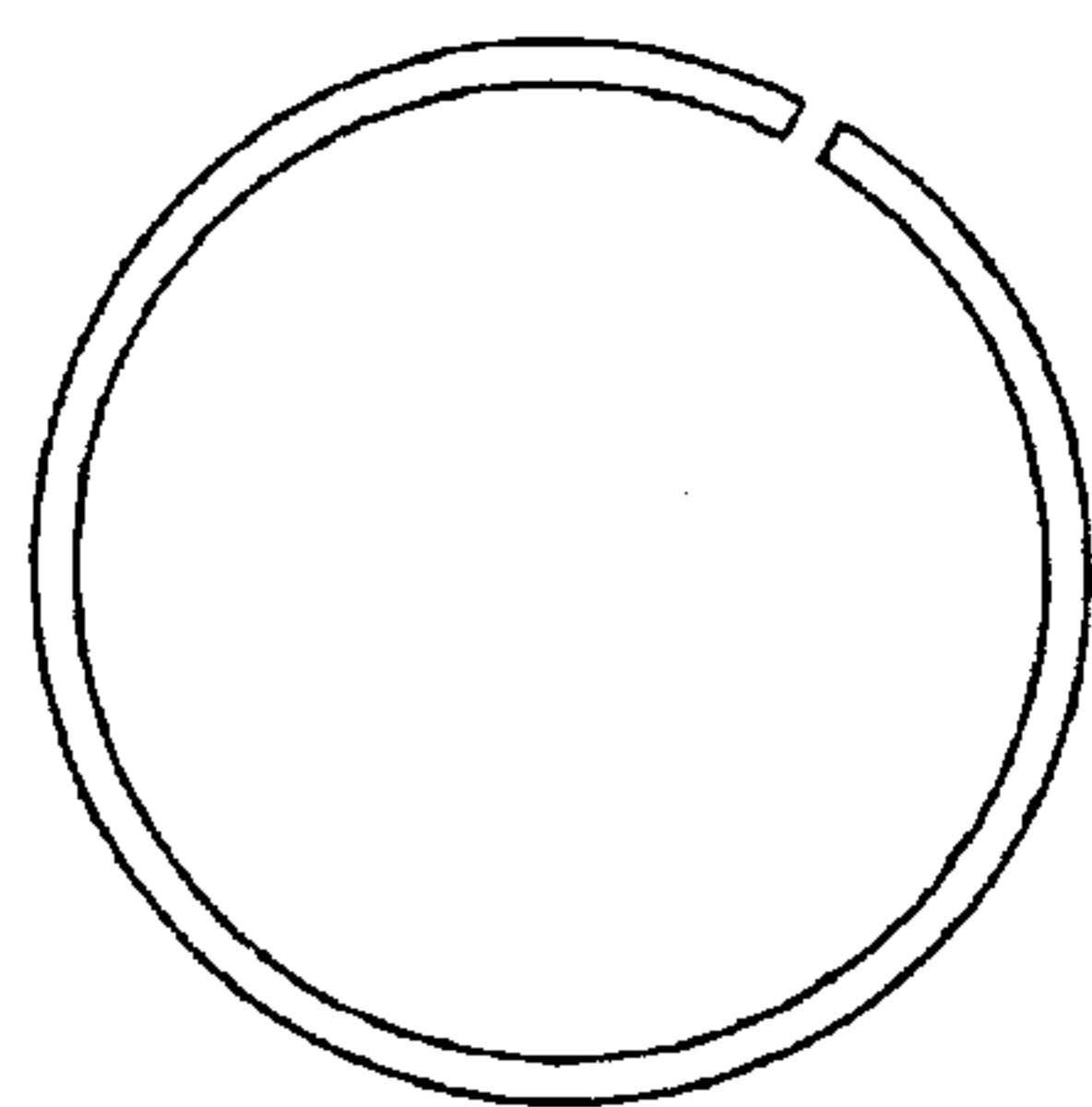

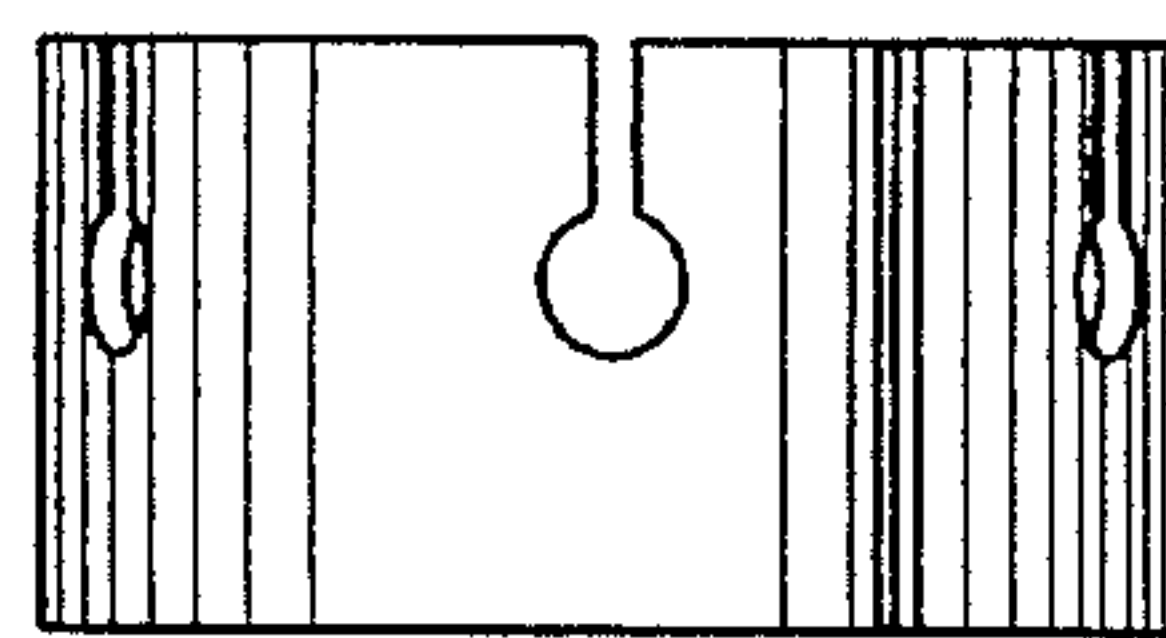

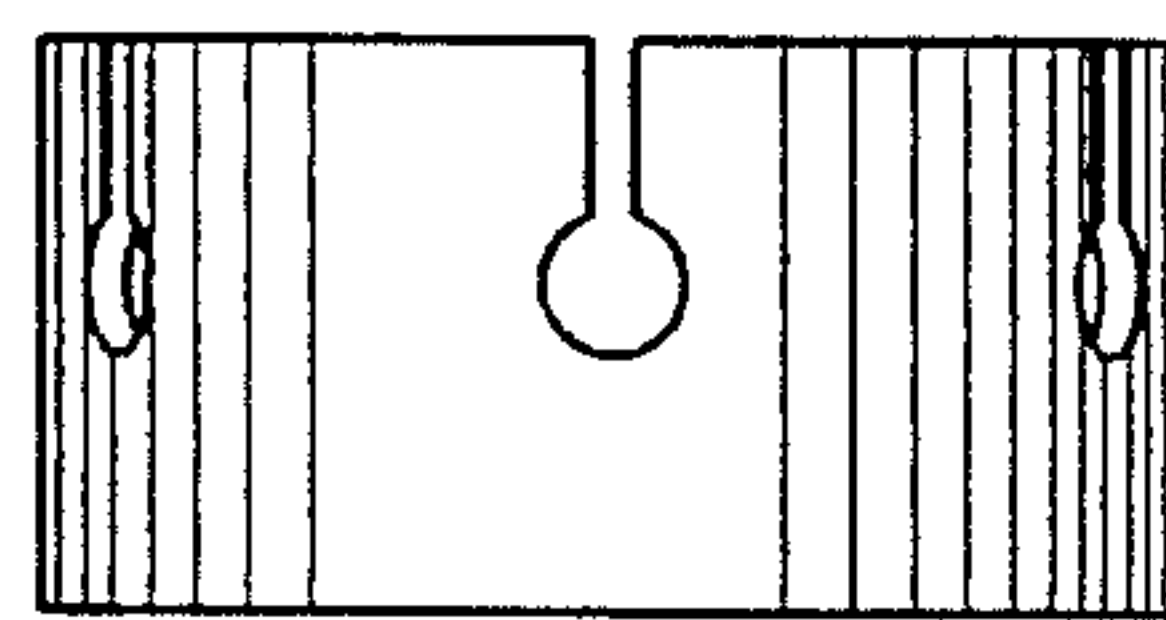

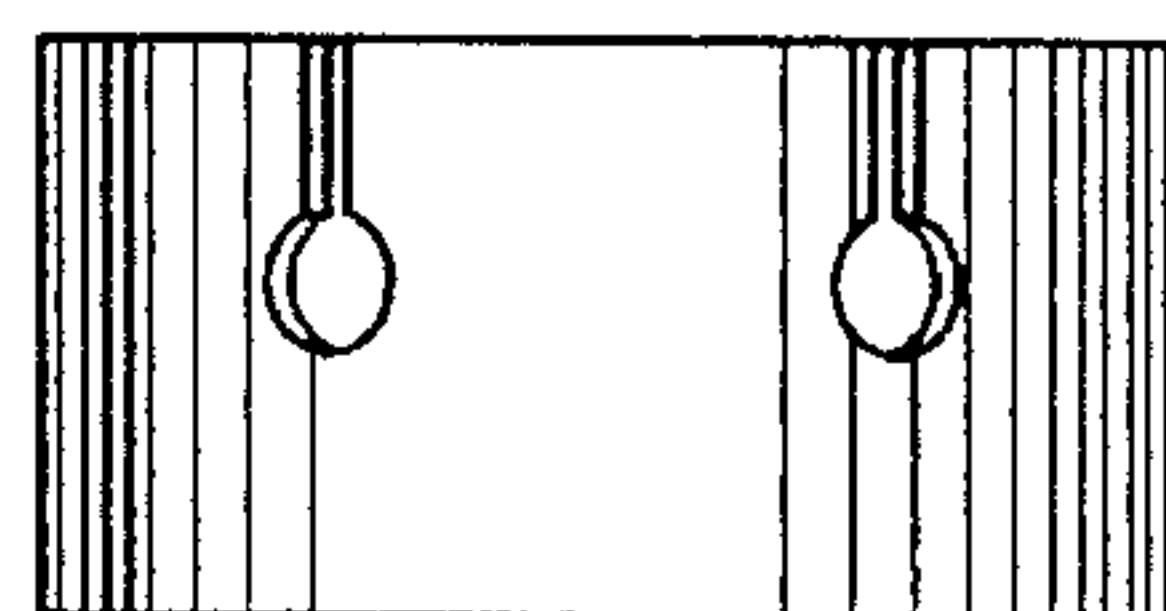

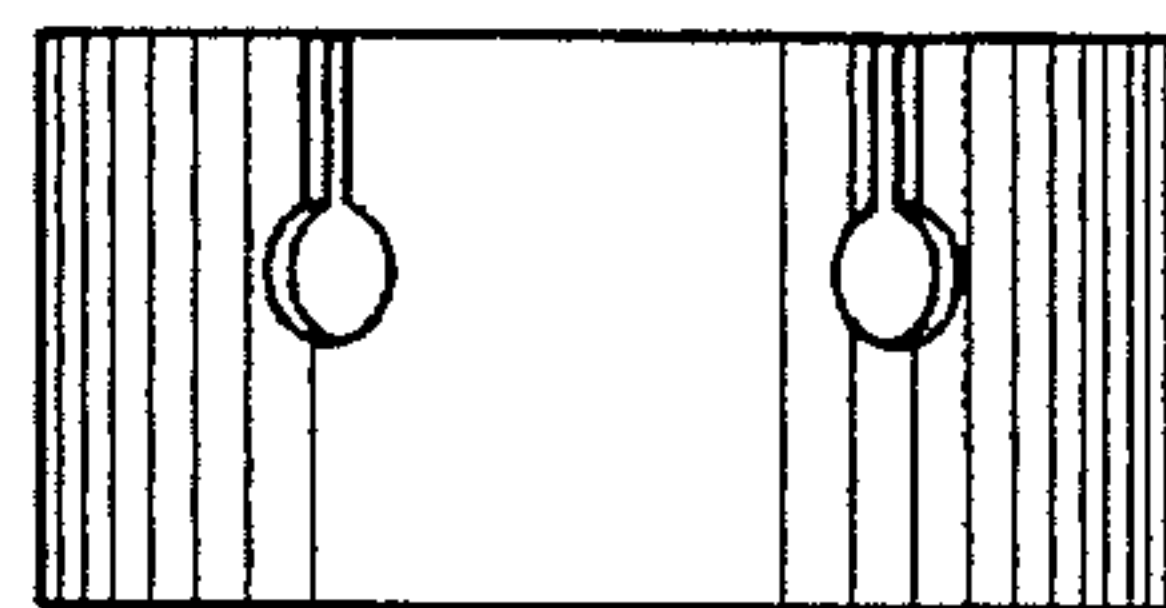

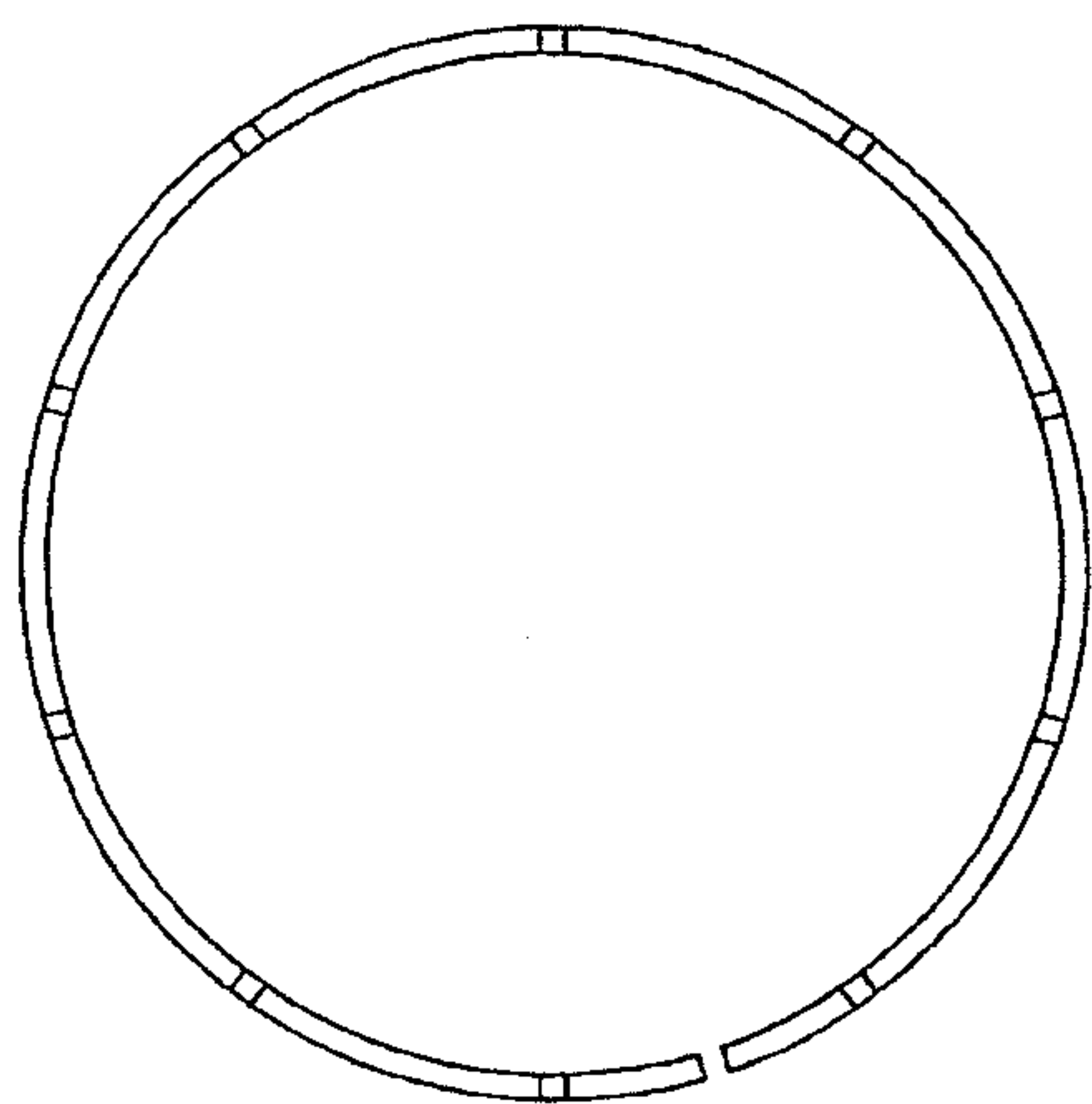

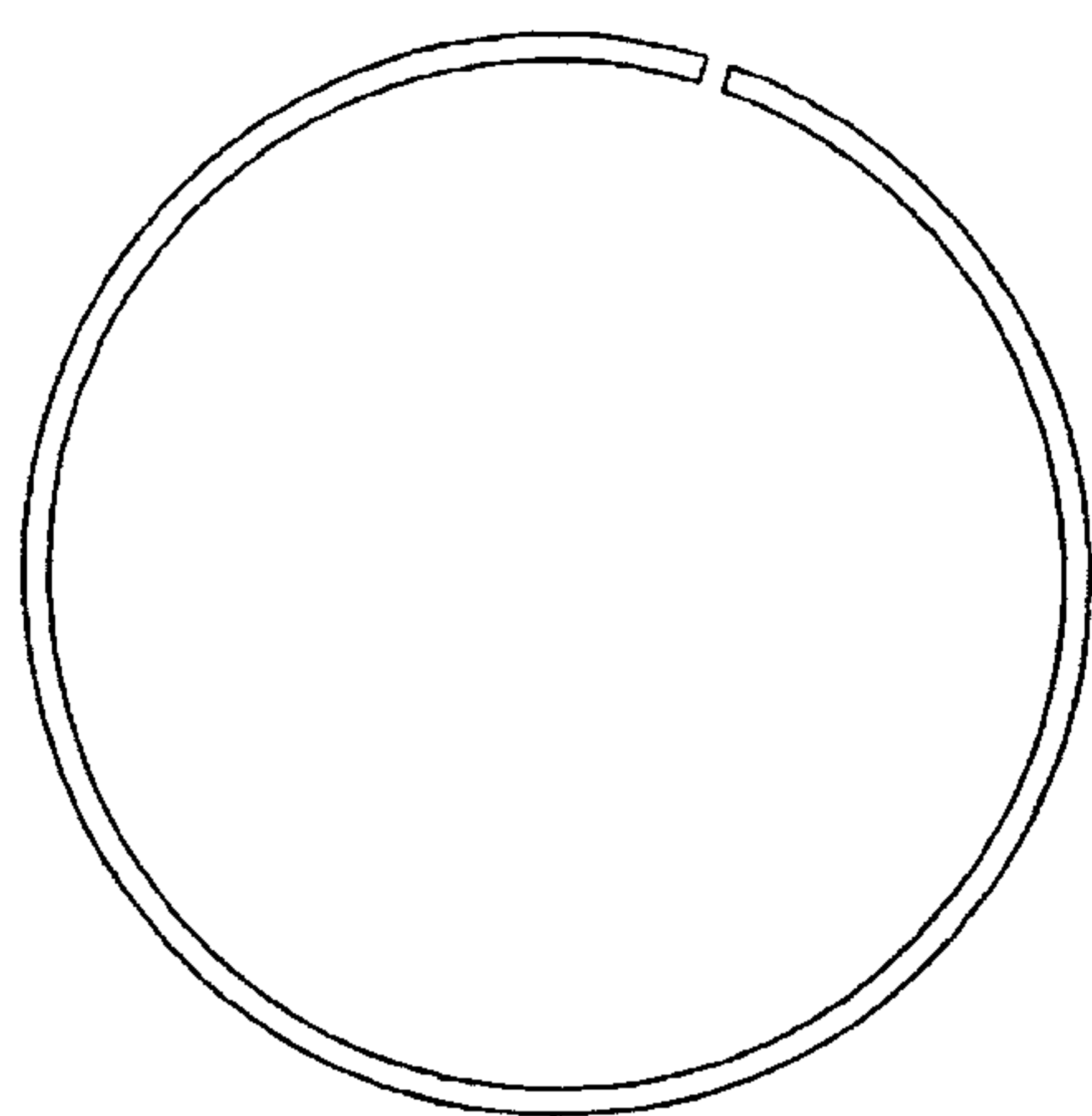

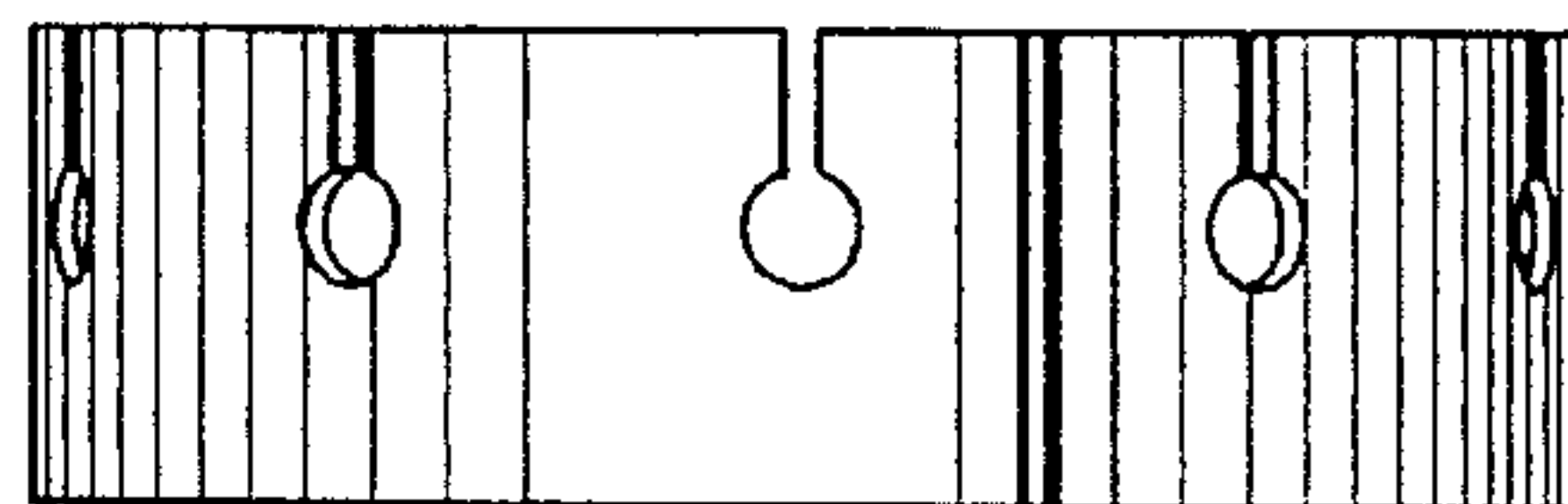

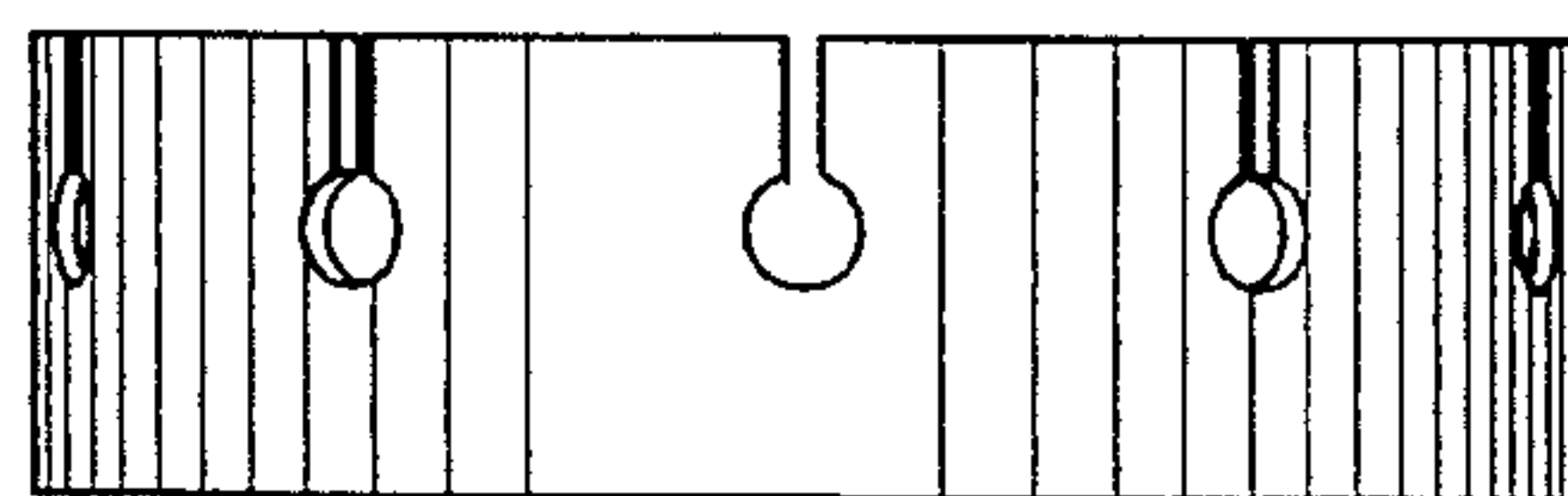

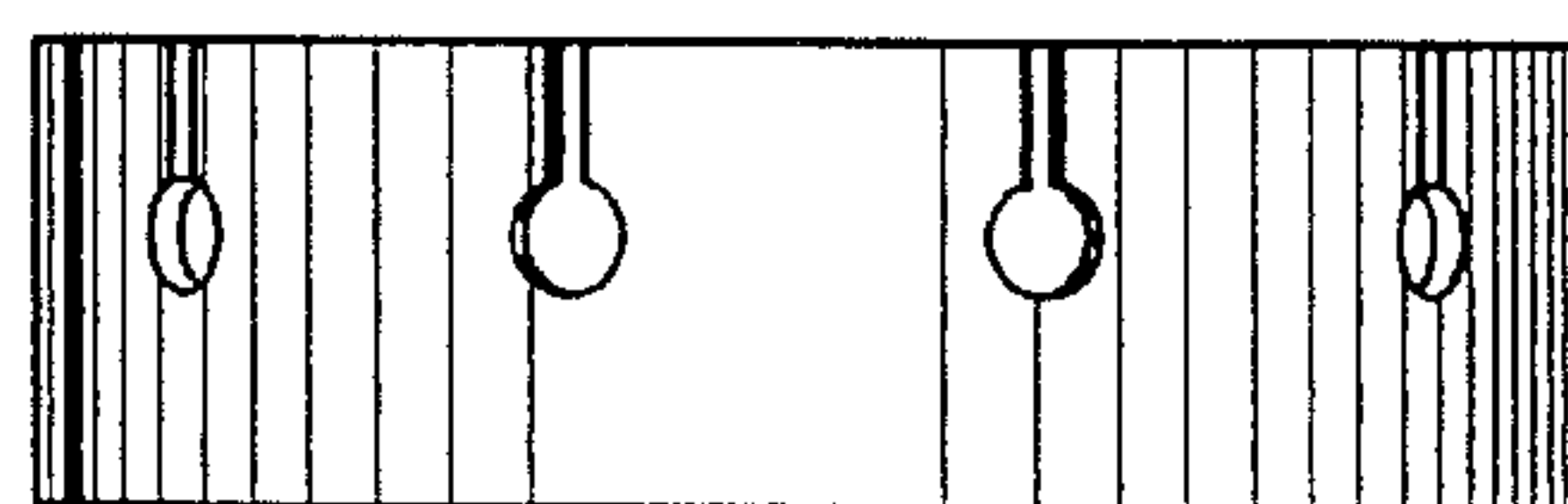

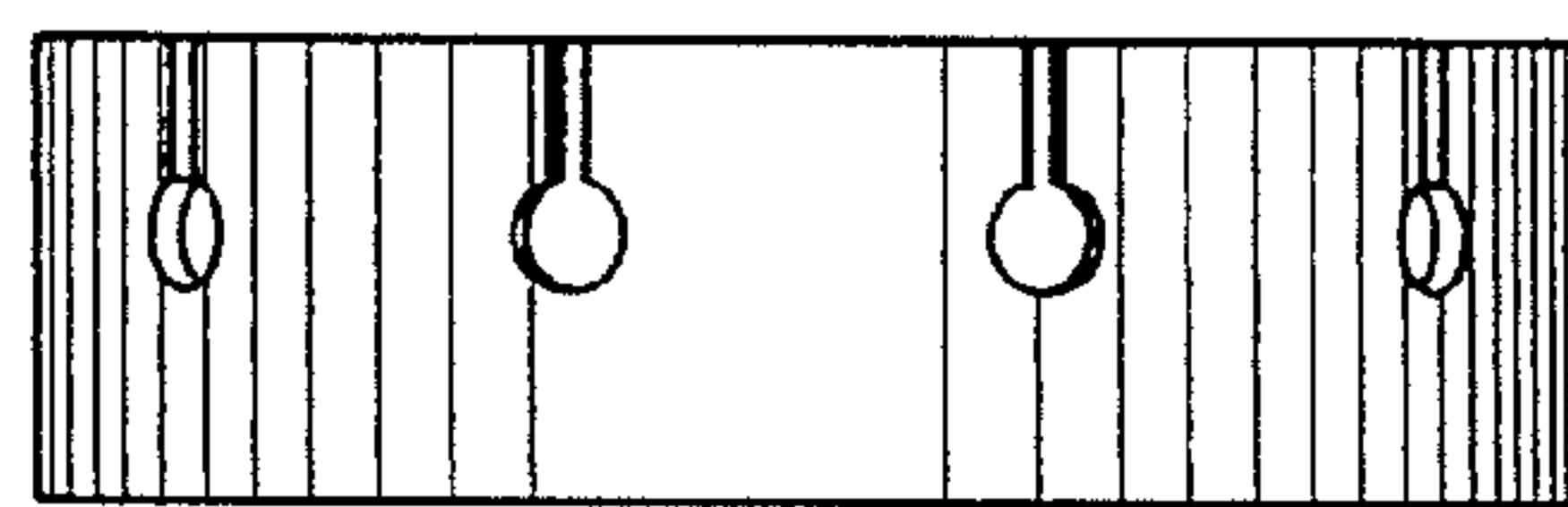
