FIG. 1 is a top right front perspective view of a portable commode showing our new design;

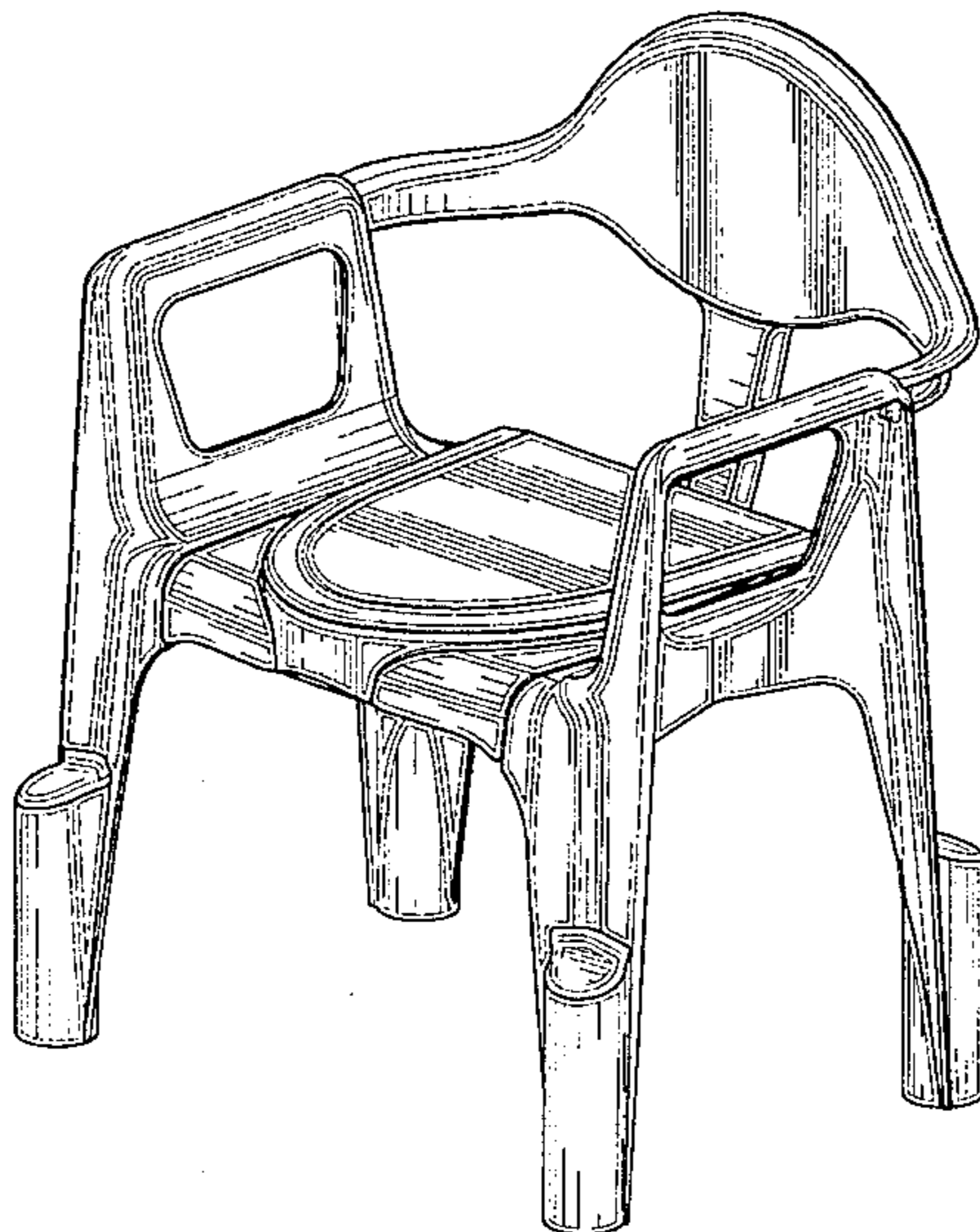
FIG. 2 is a top plan view thereof;

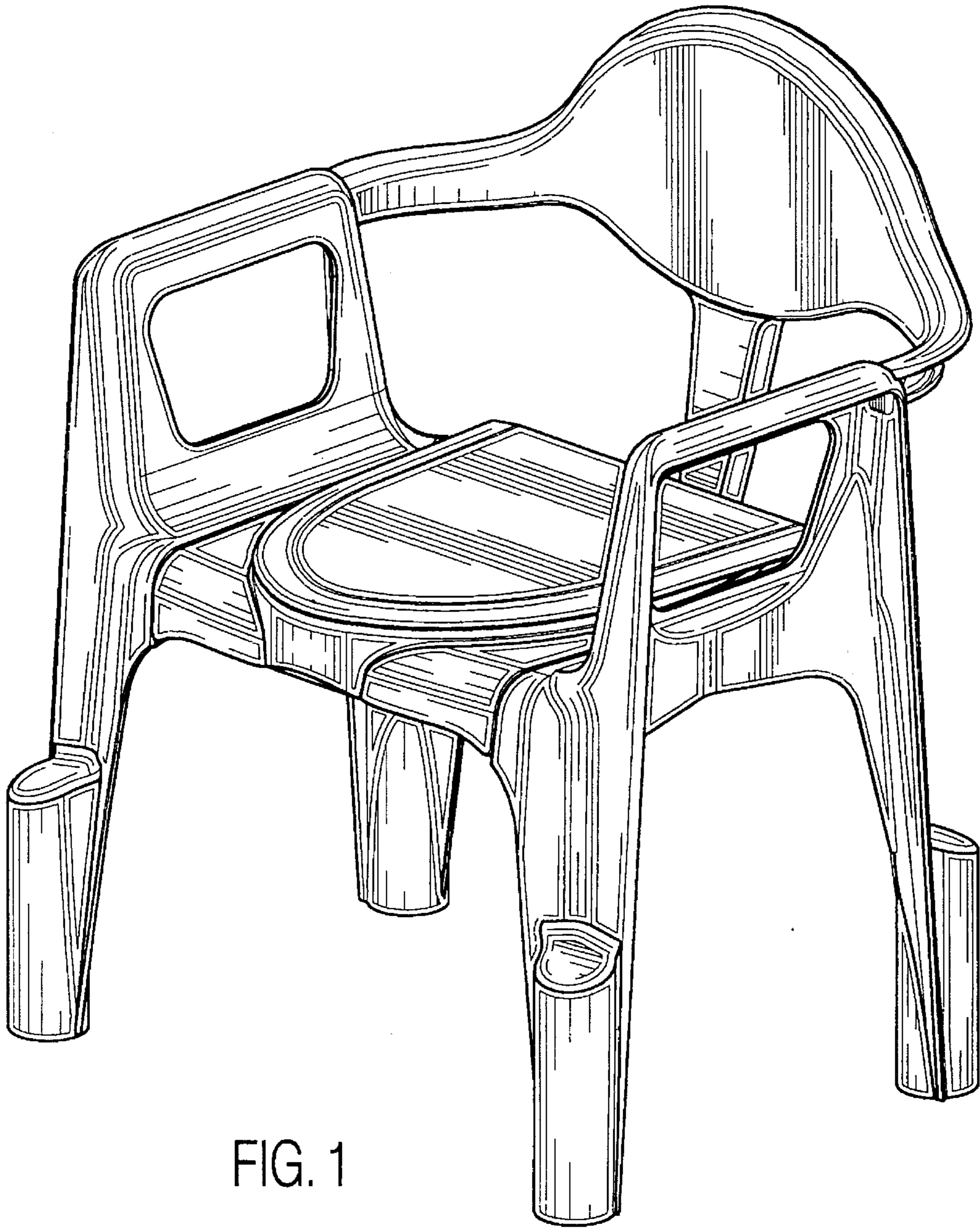

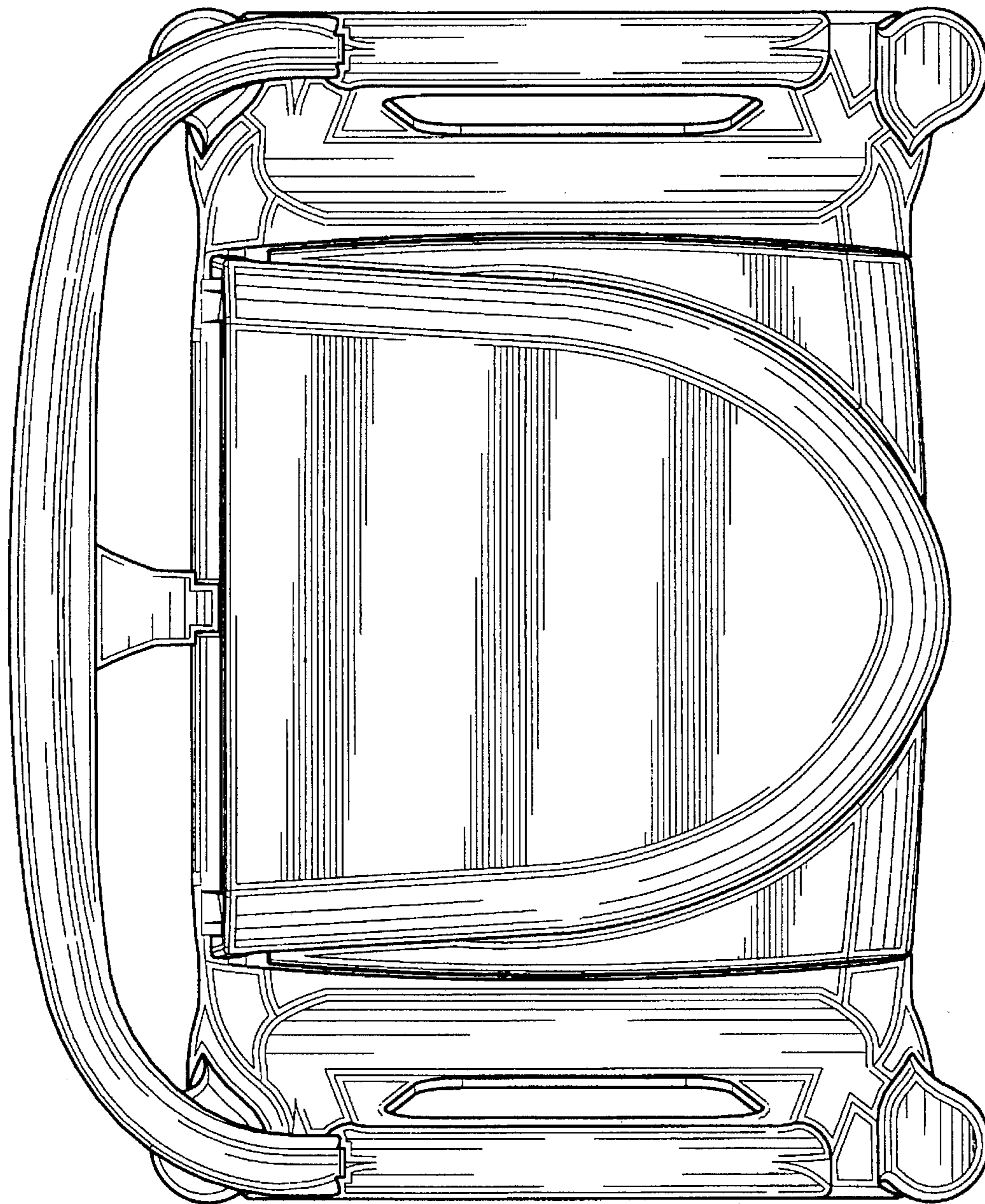

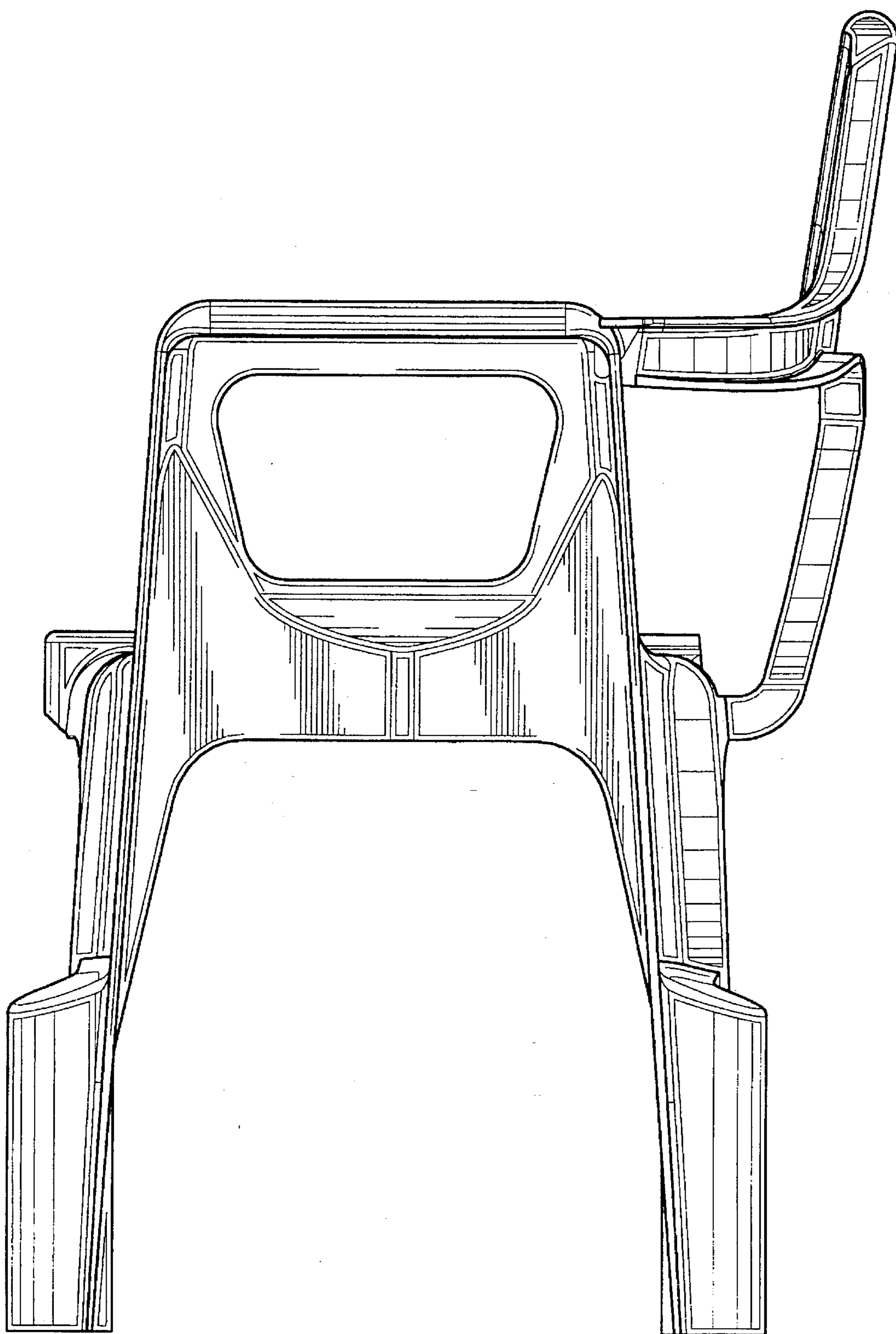

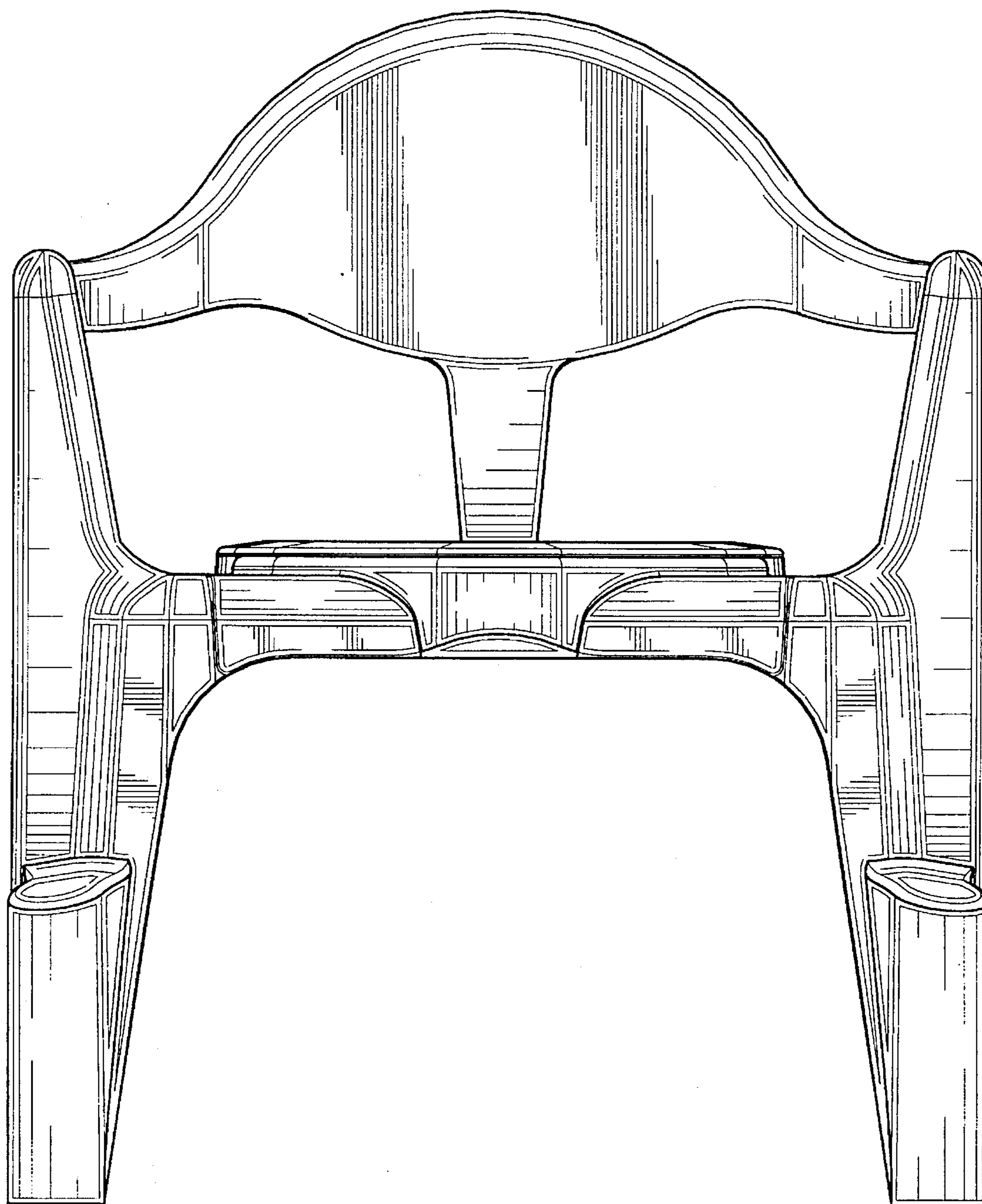

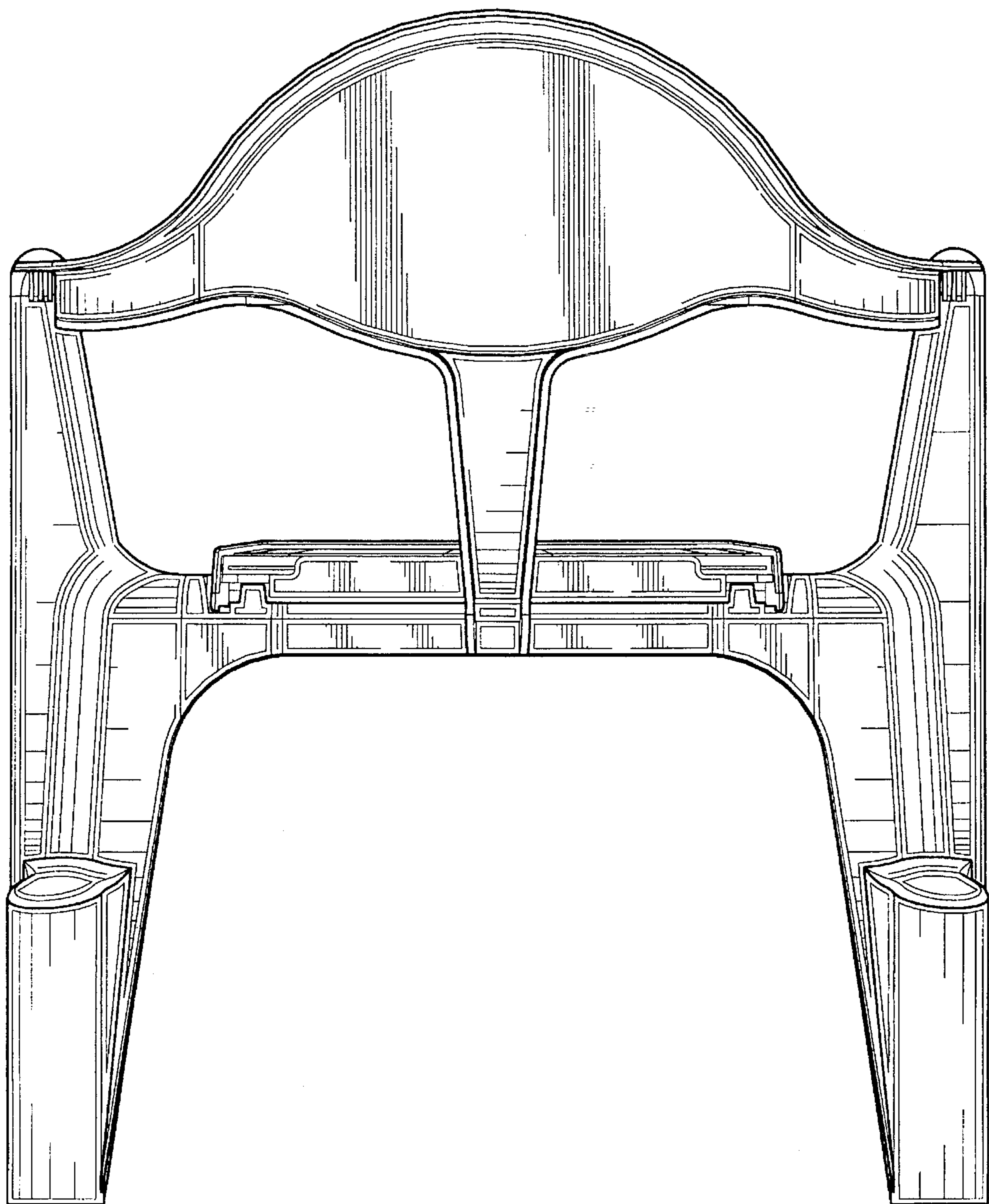
