FIG. 12 is a cross-section view taken on line 12-12 in FIG. 11.

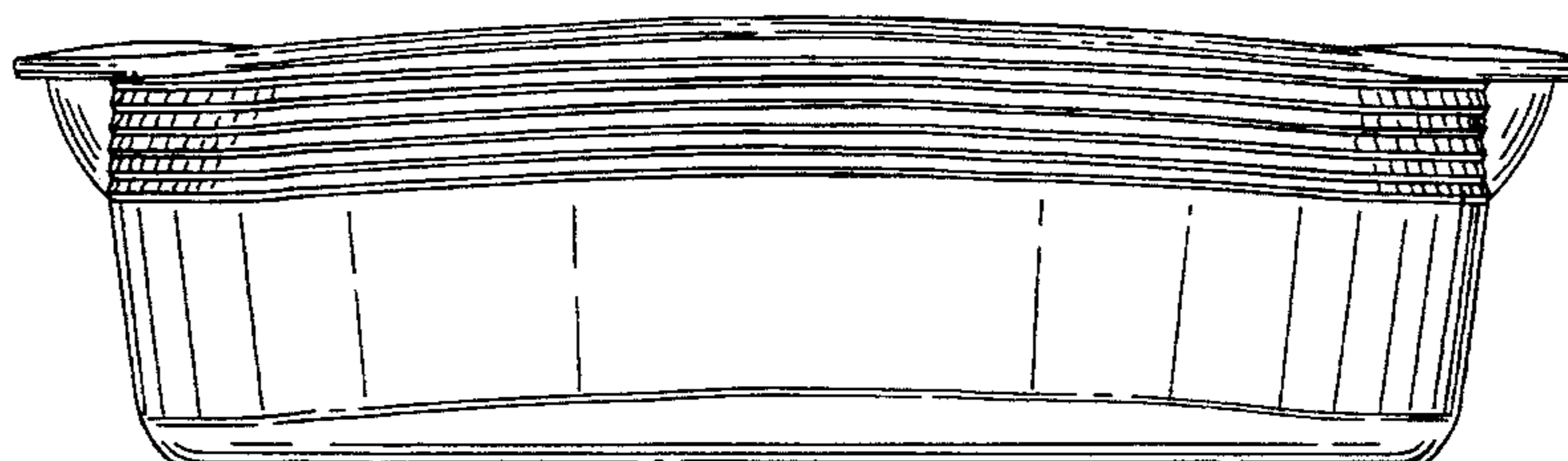
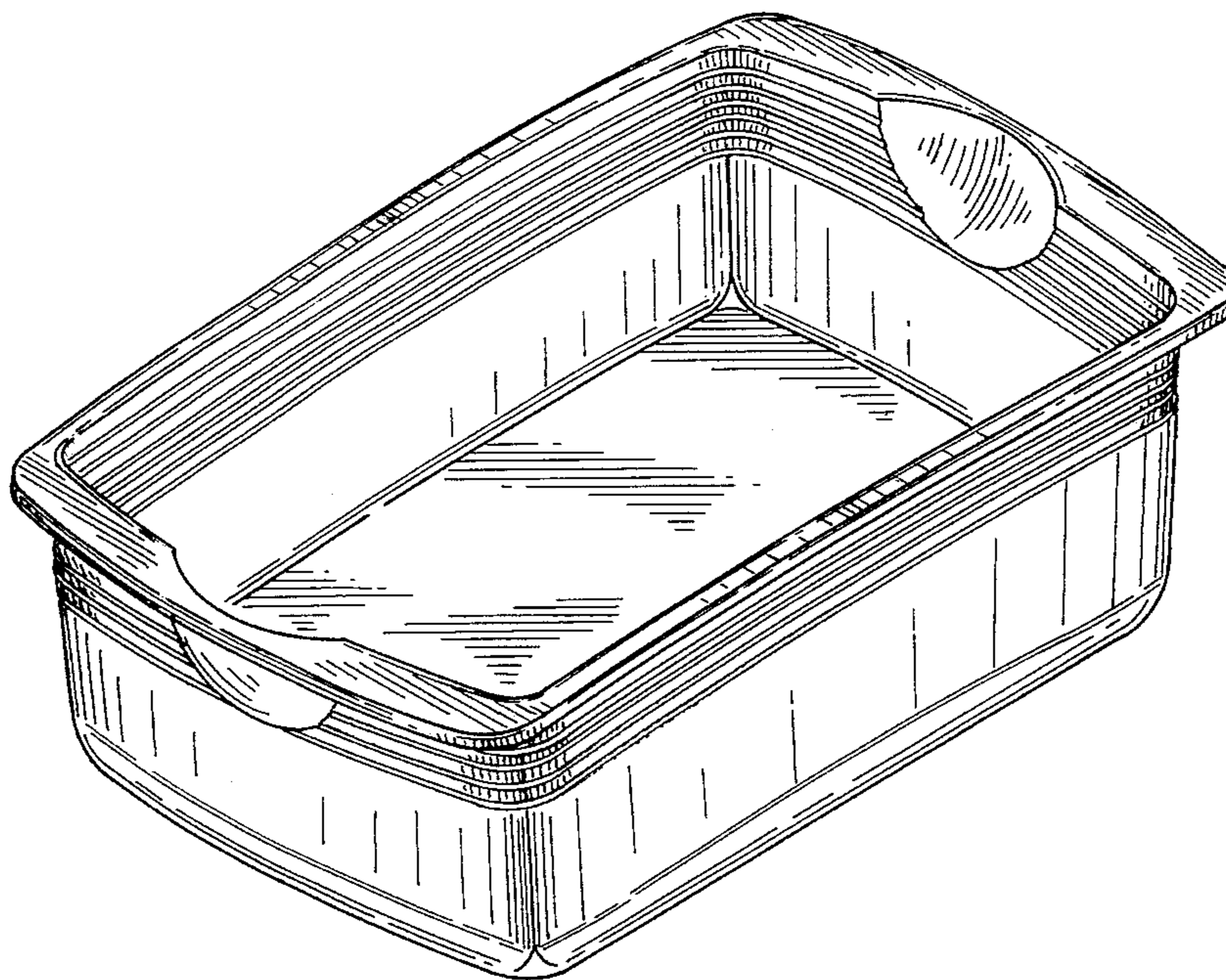

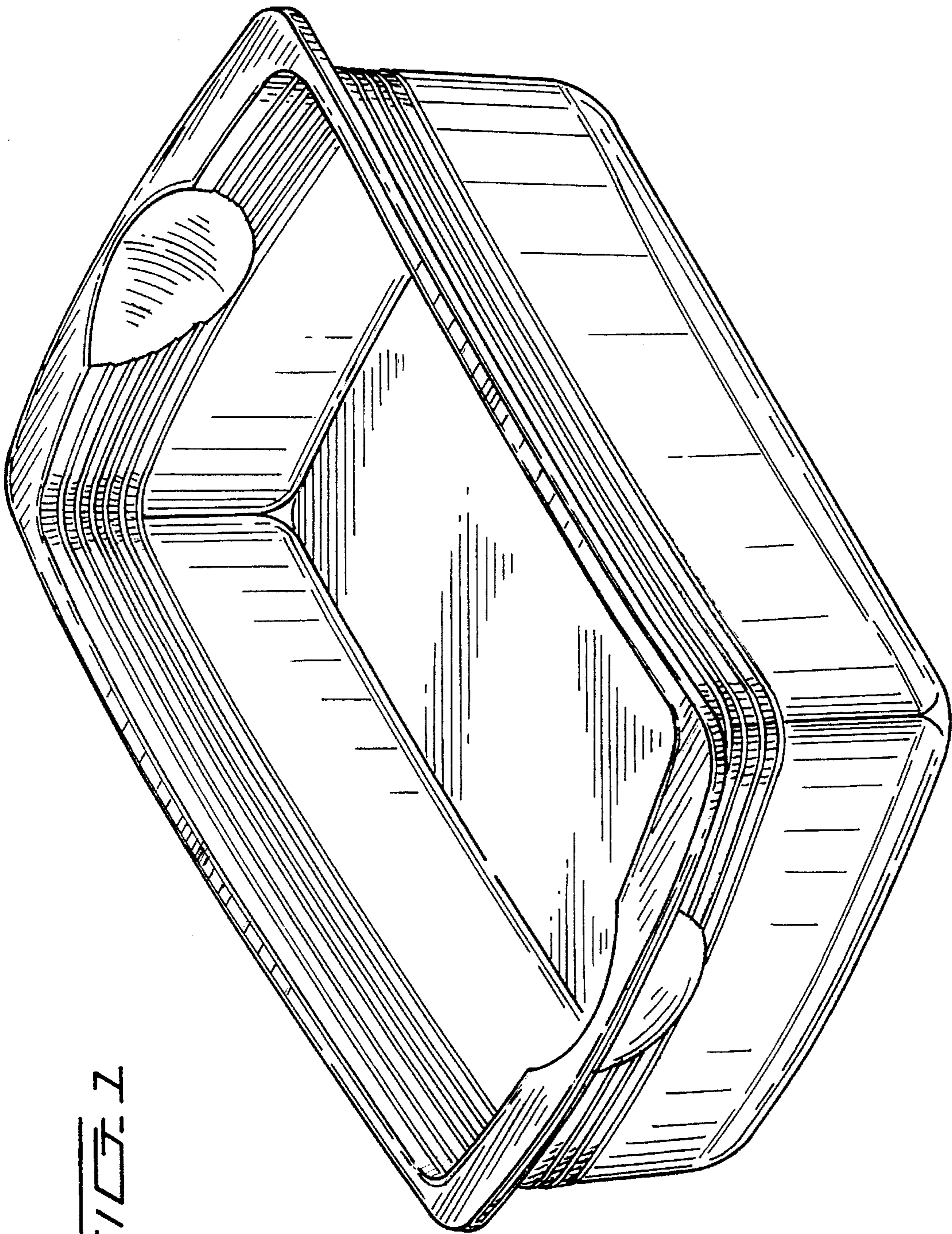

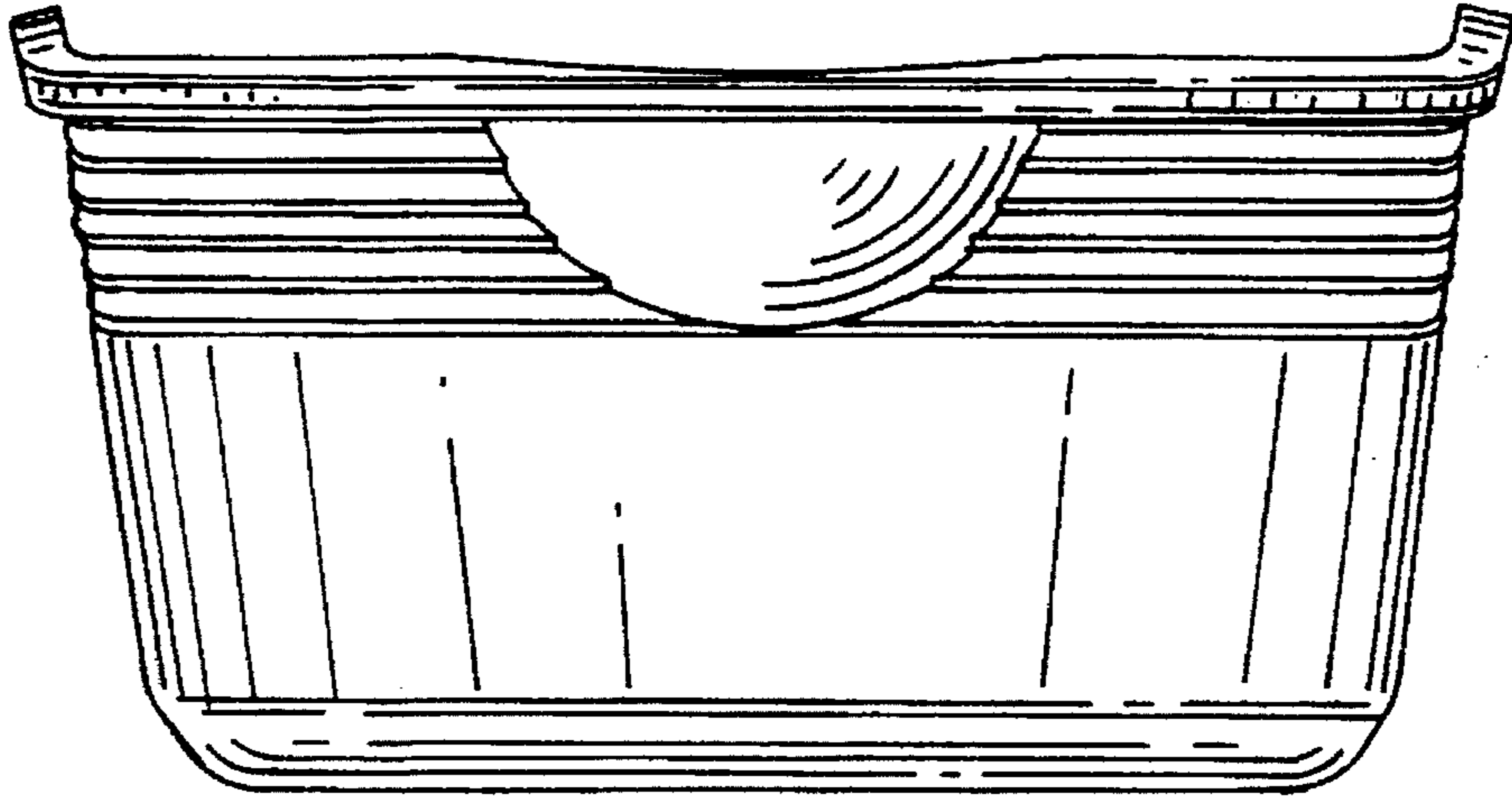

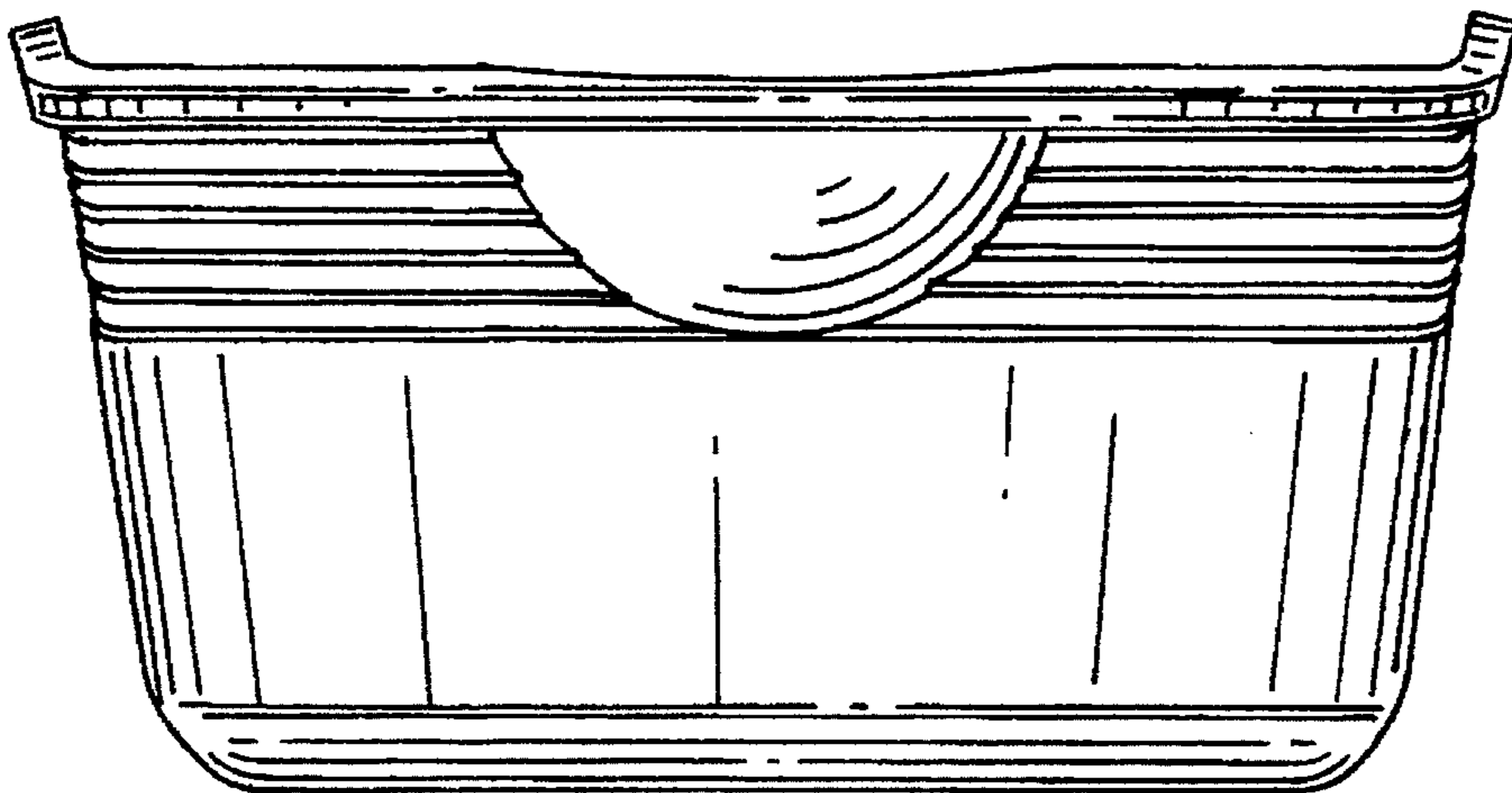

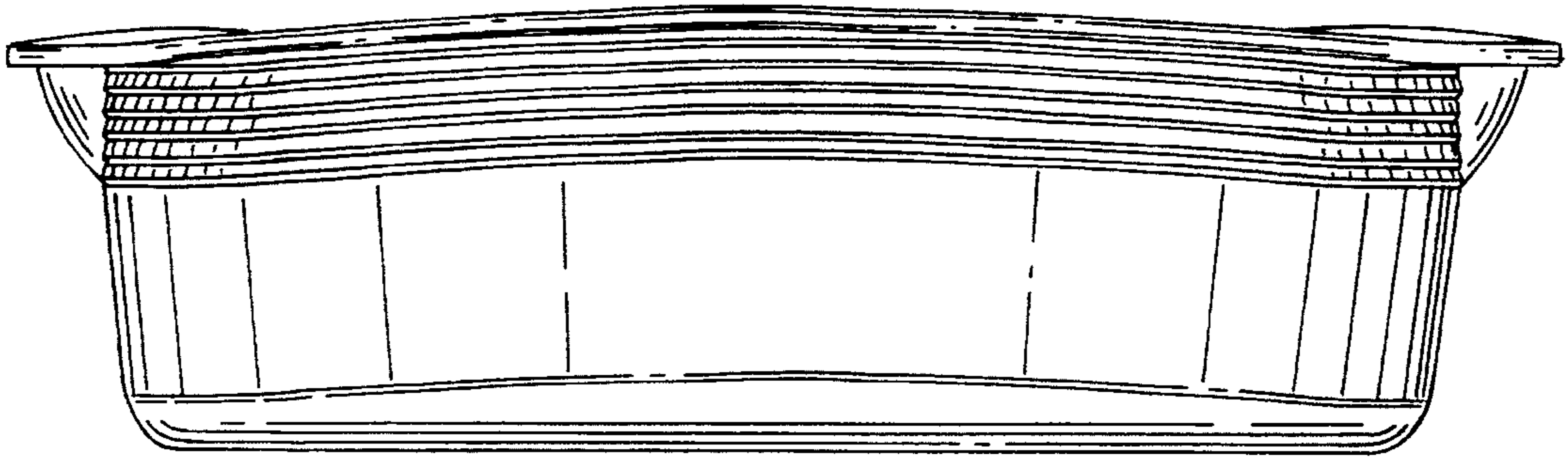

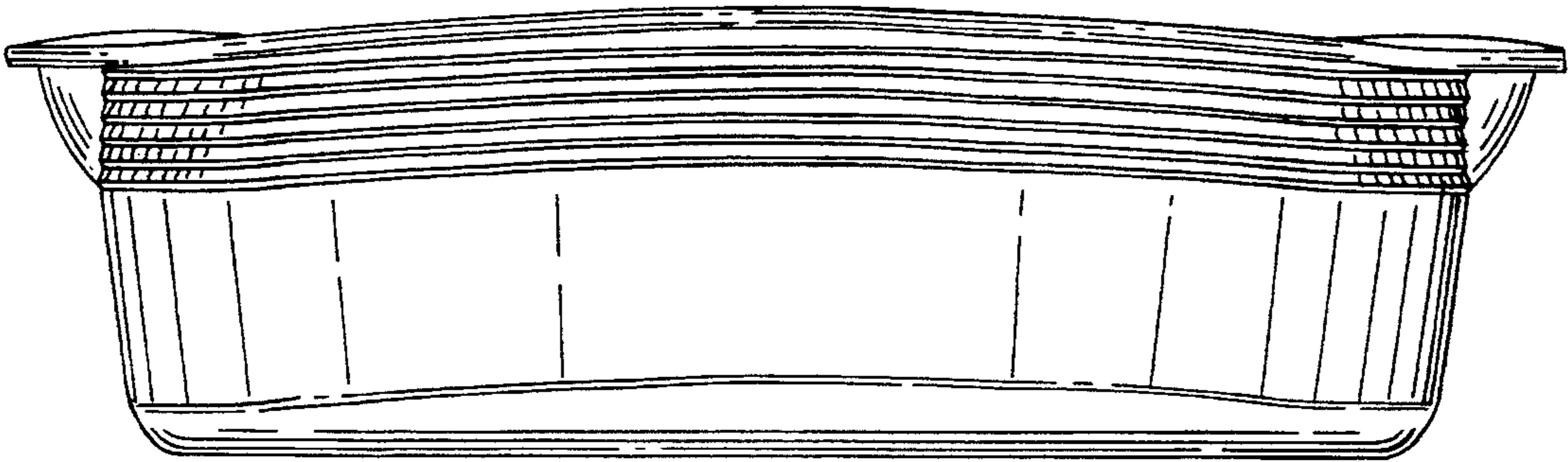

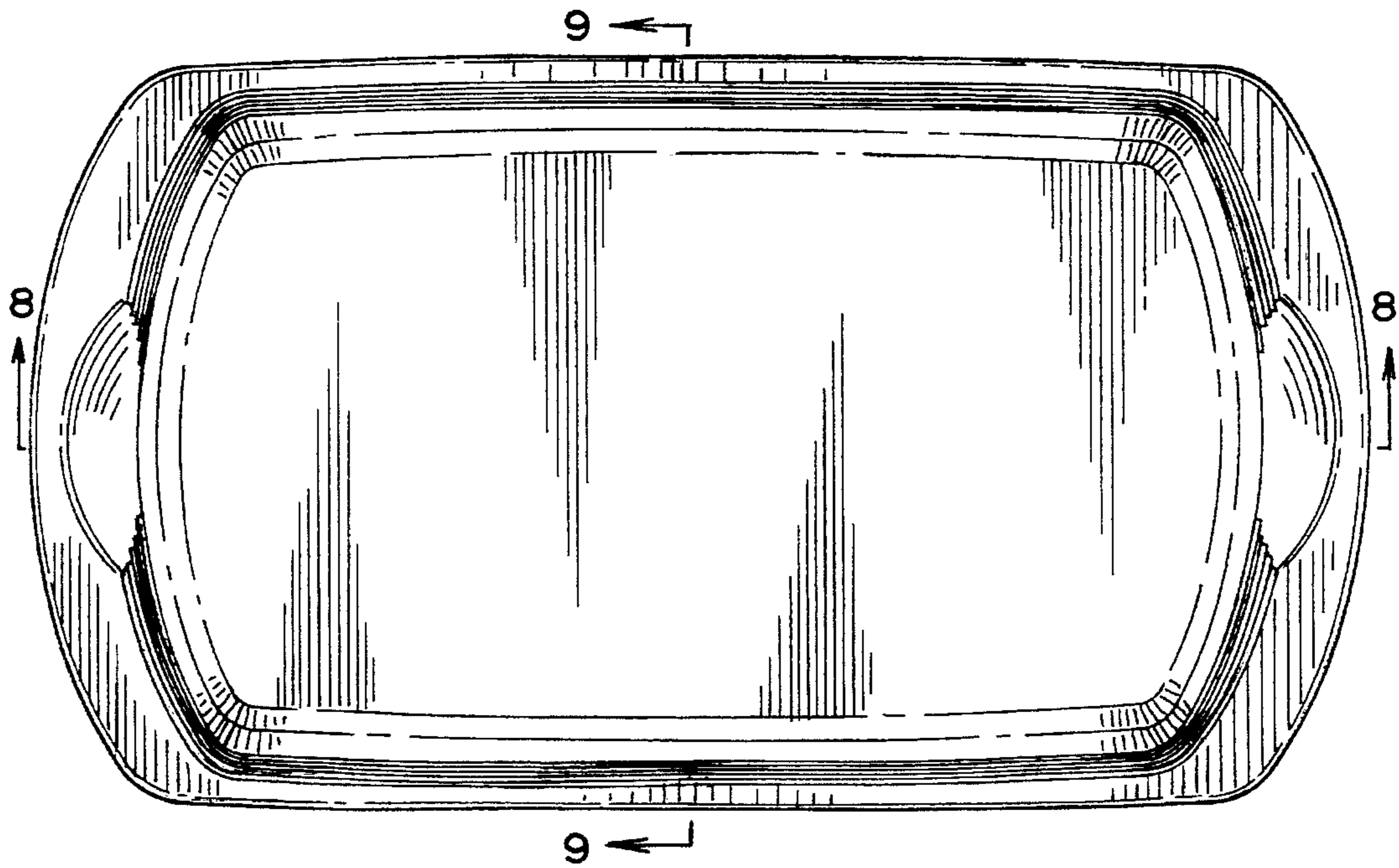

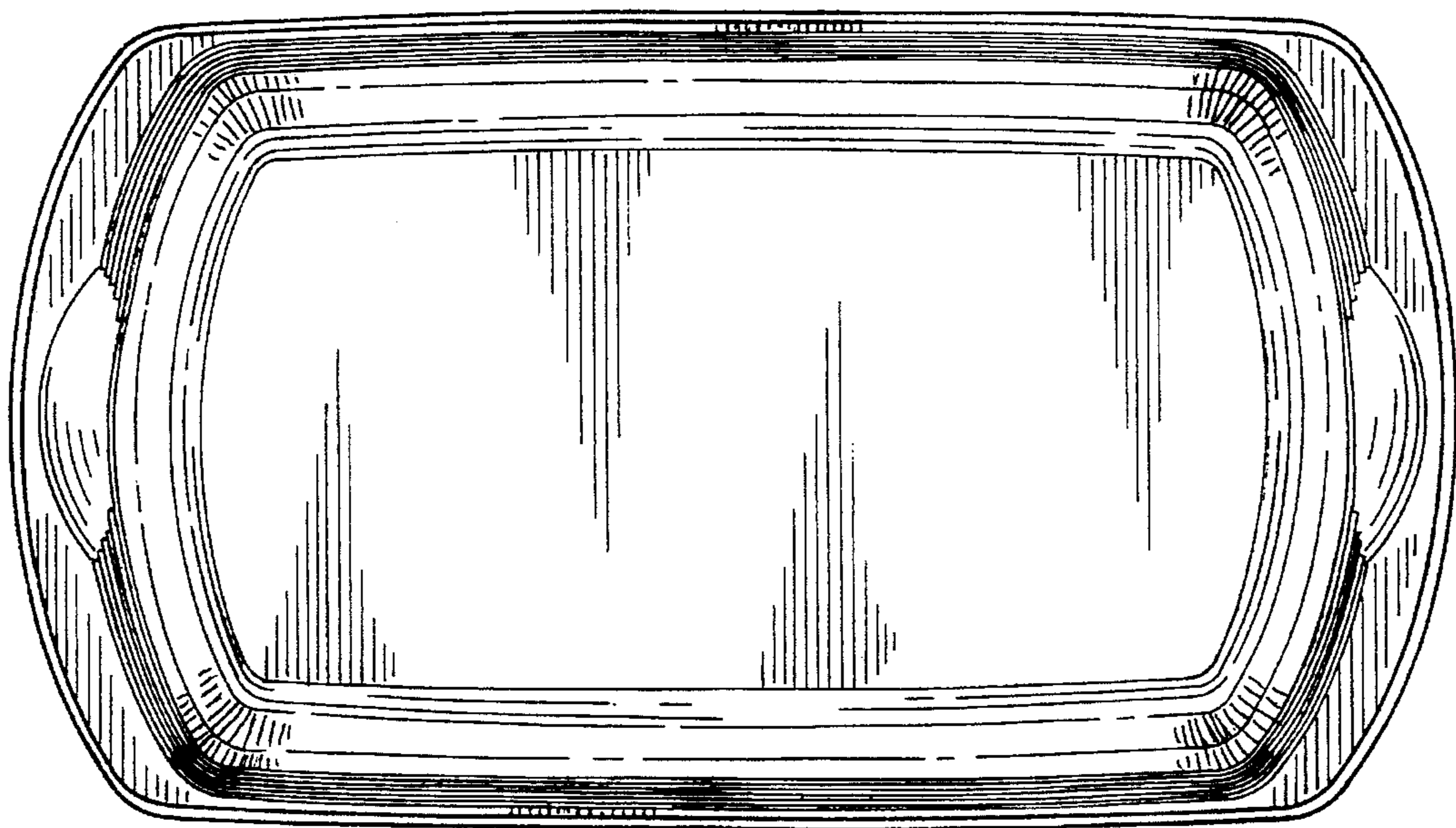

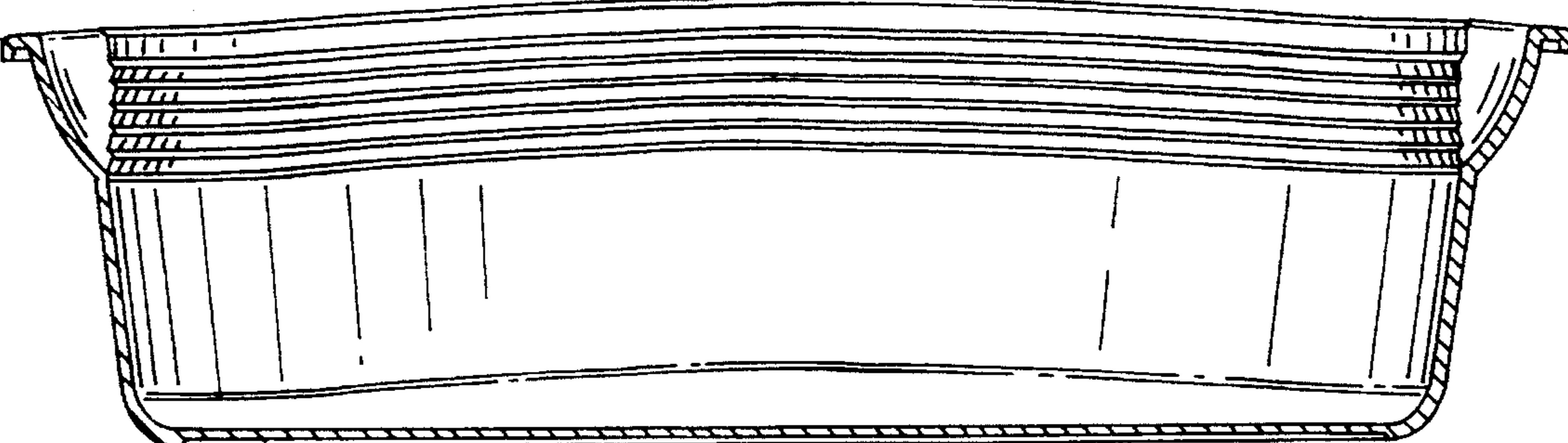

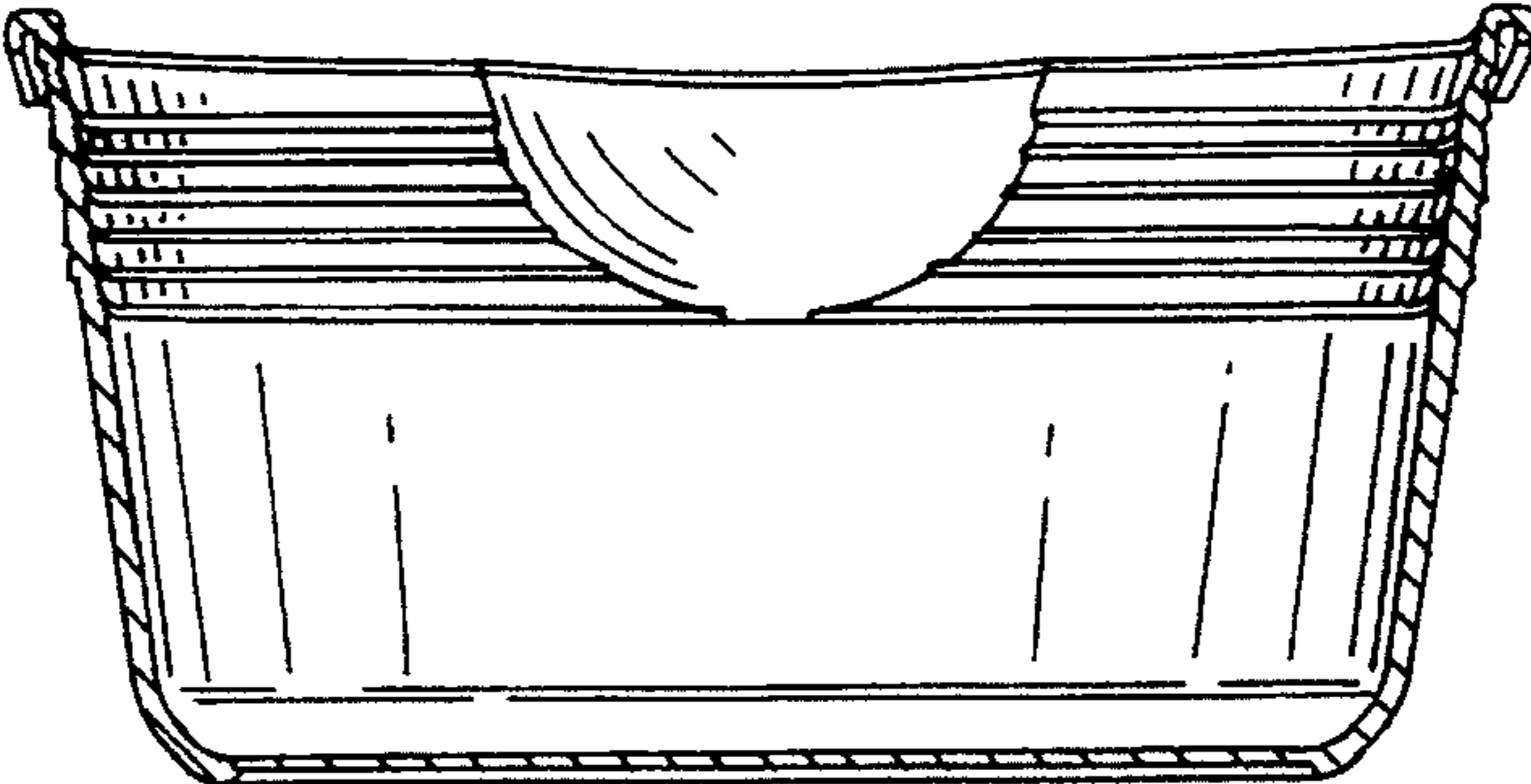
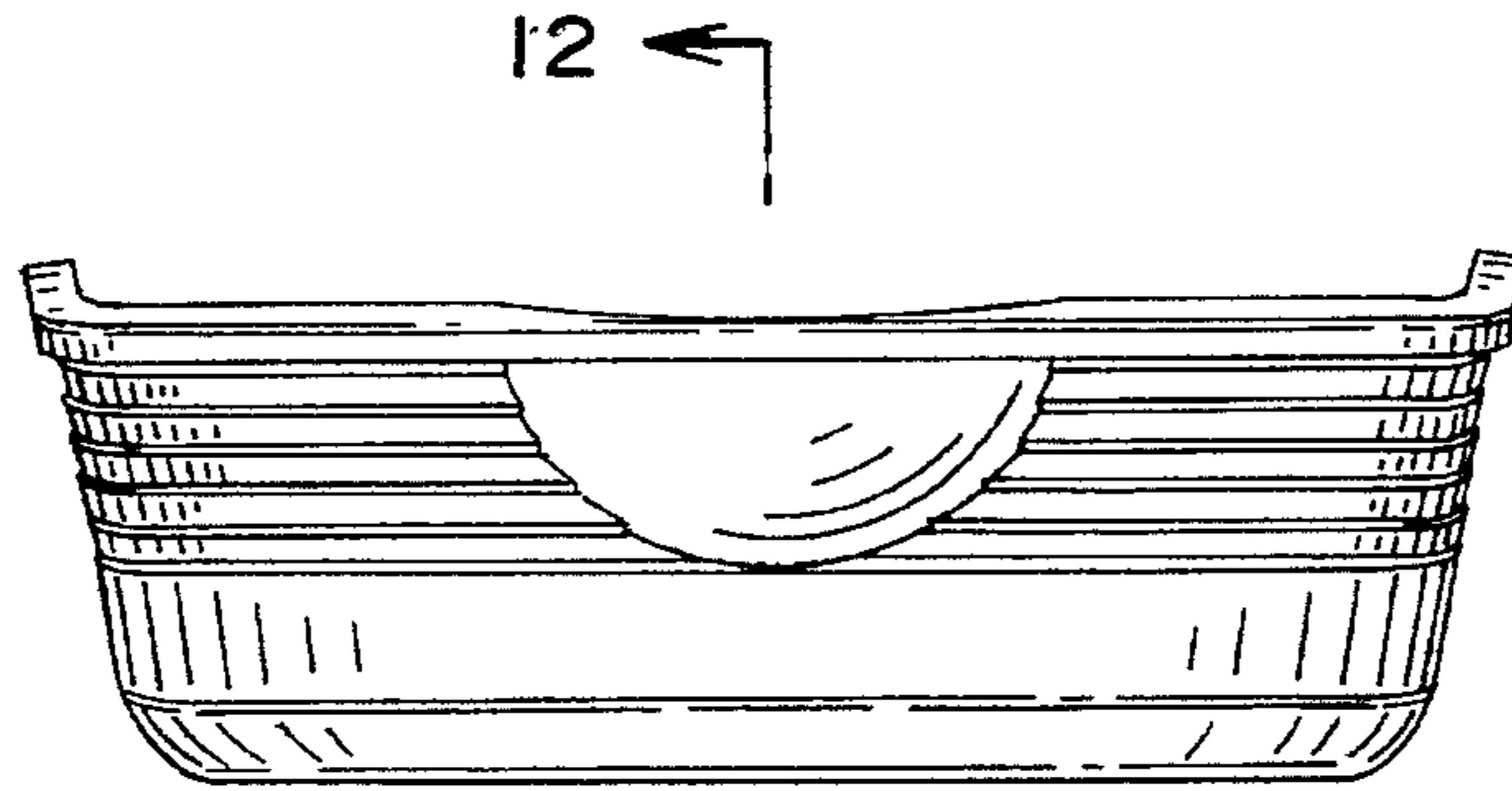

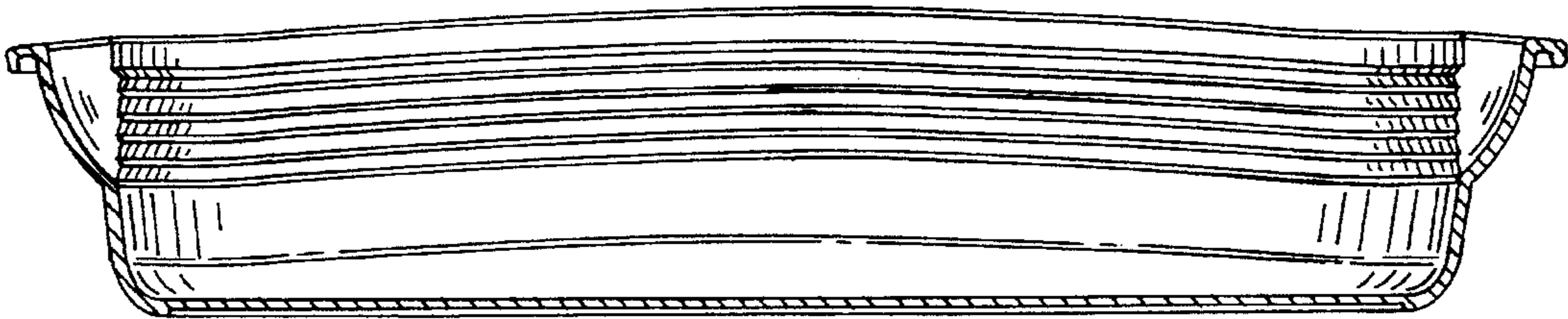
