FIG. 4 is a bottom plan view thereof;

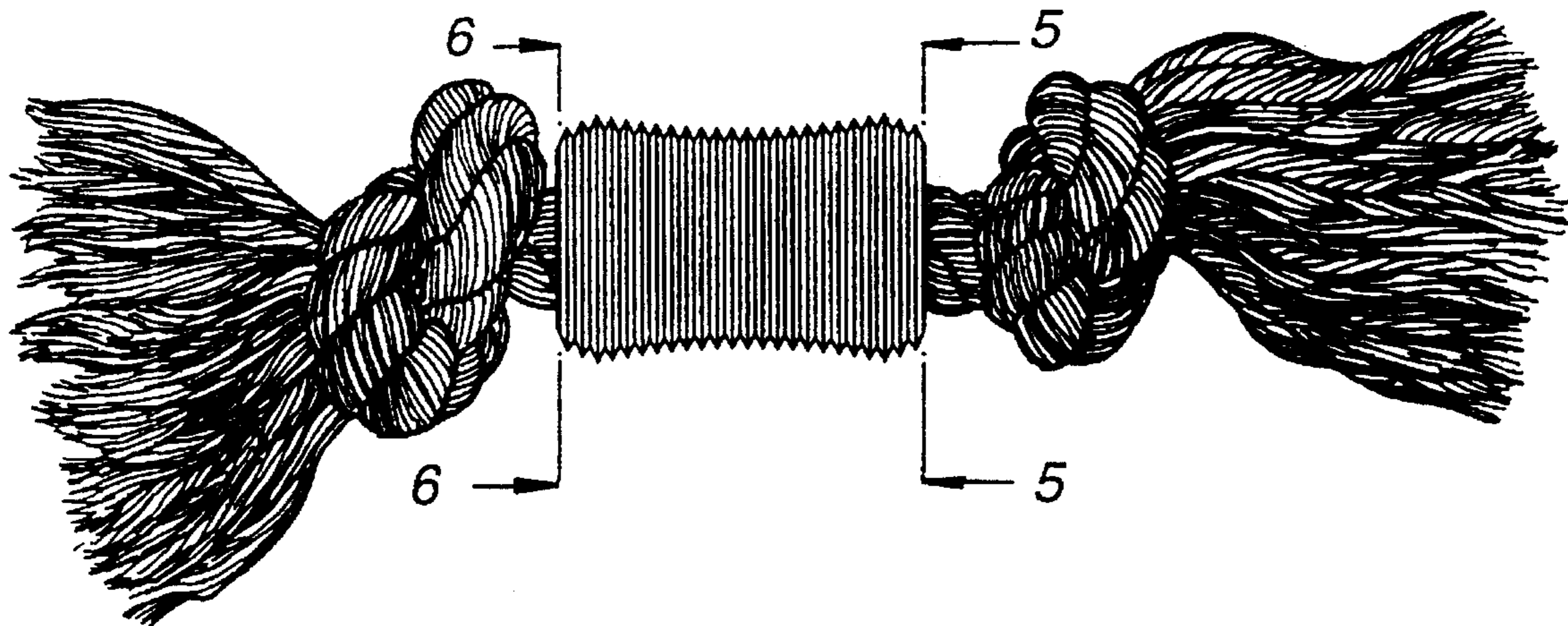
FIG. 5 is a sectional view taken along line 5-5 in FIG. 1;

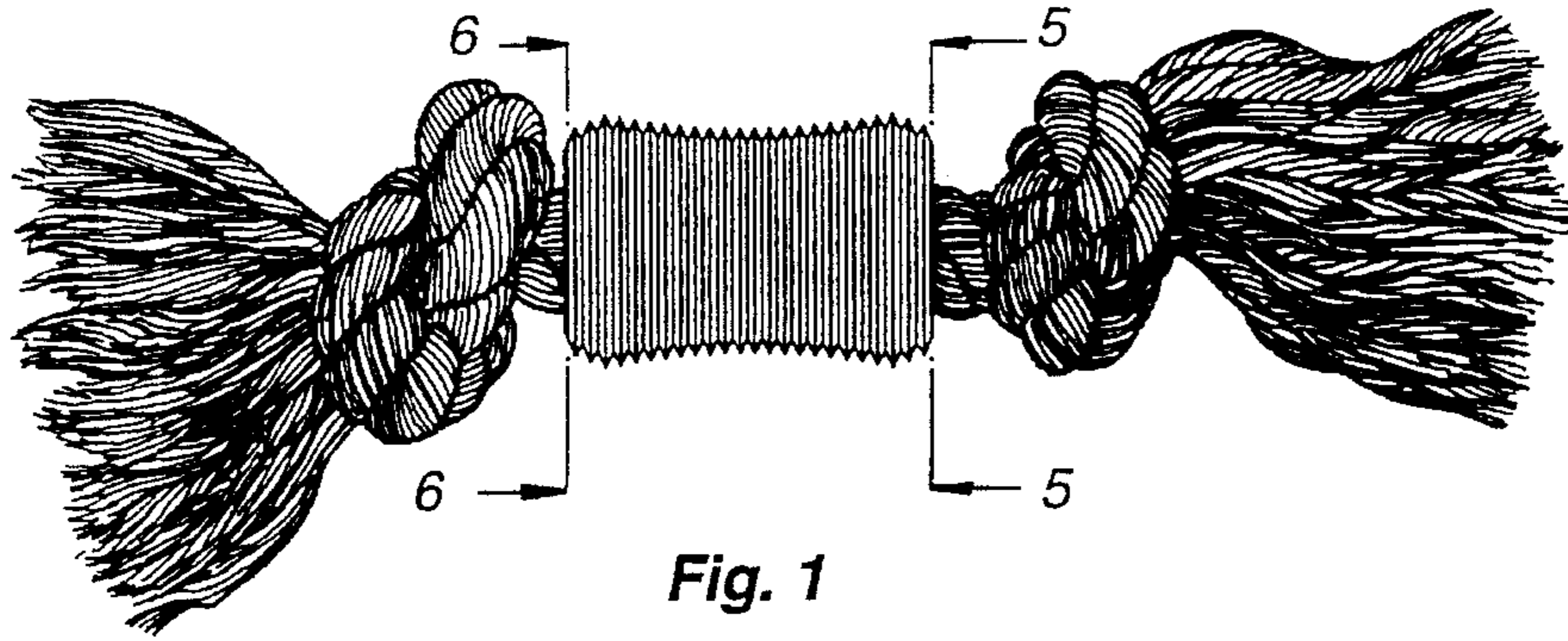

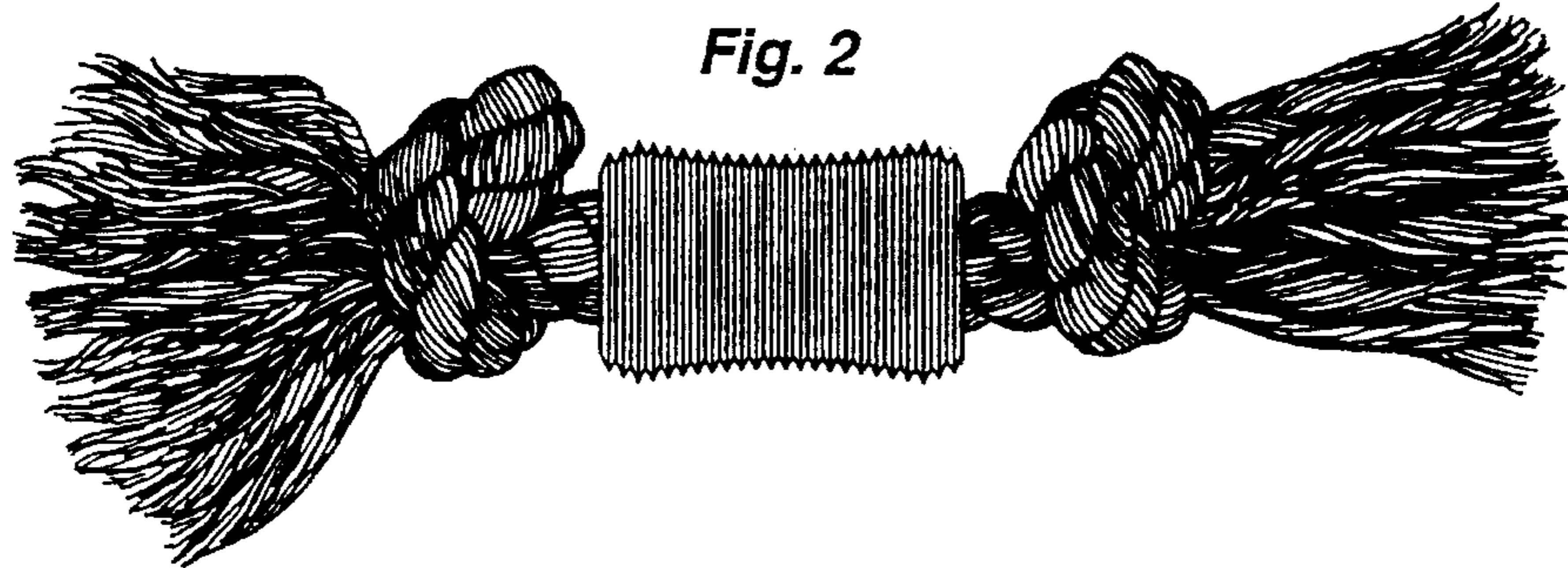

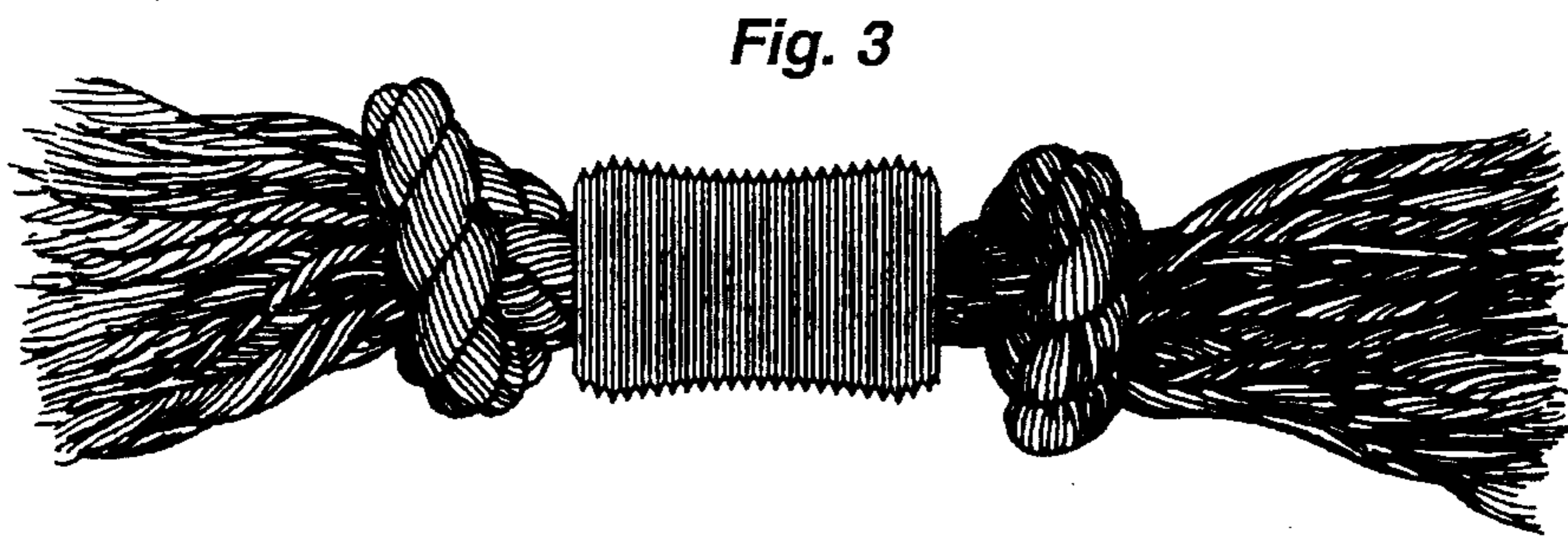

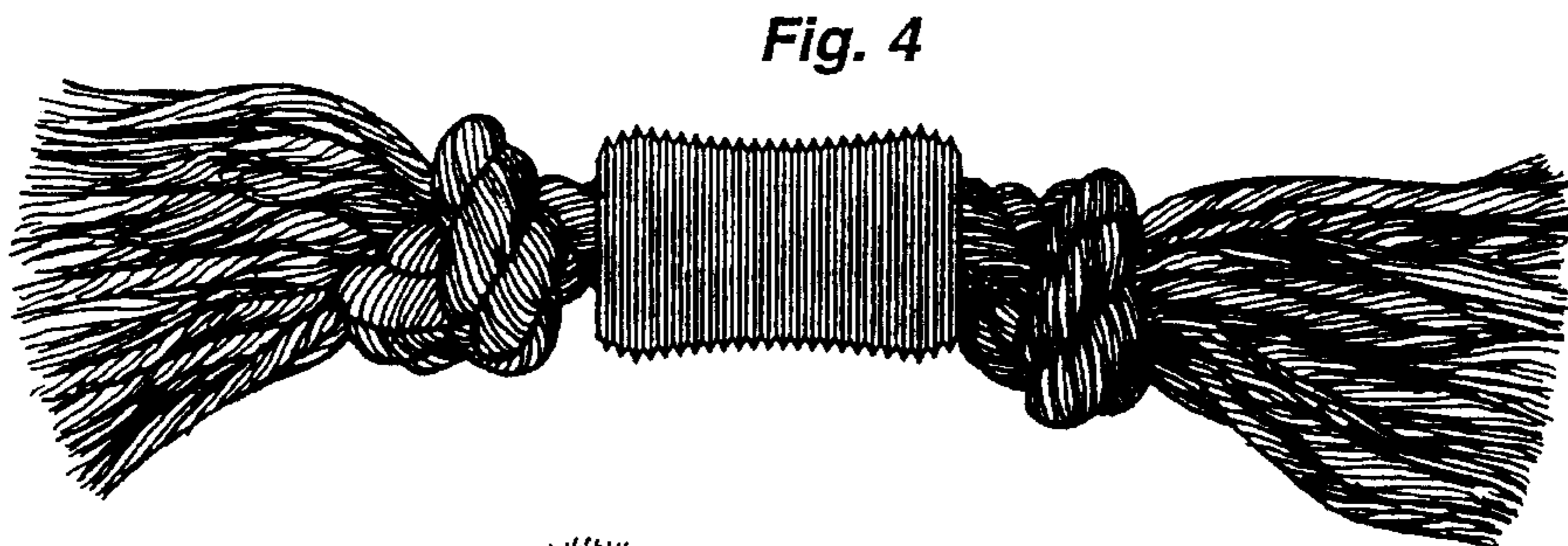

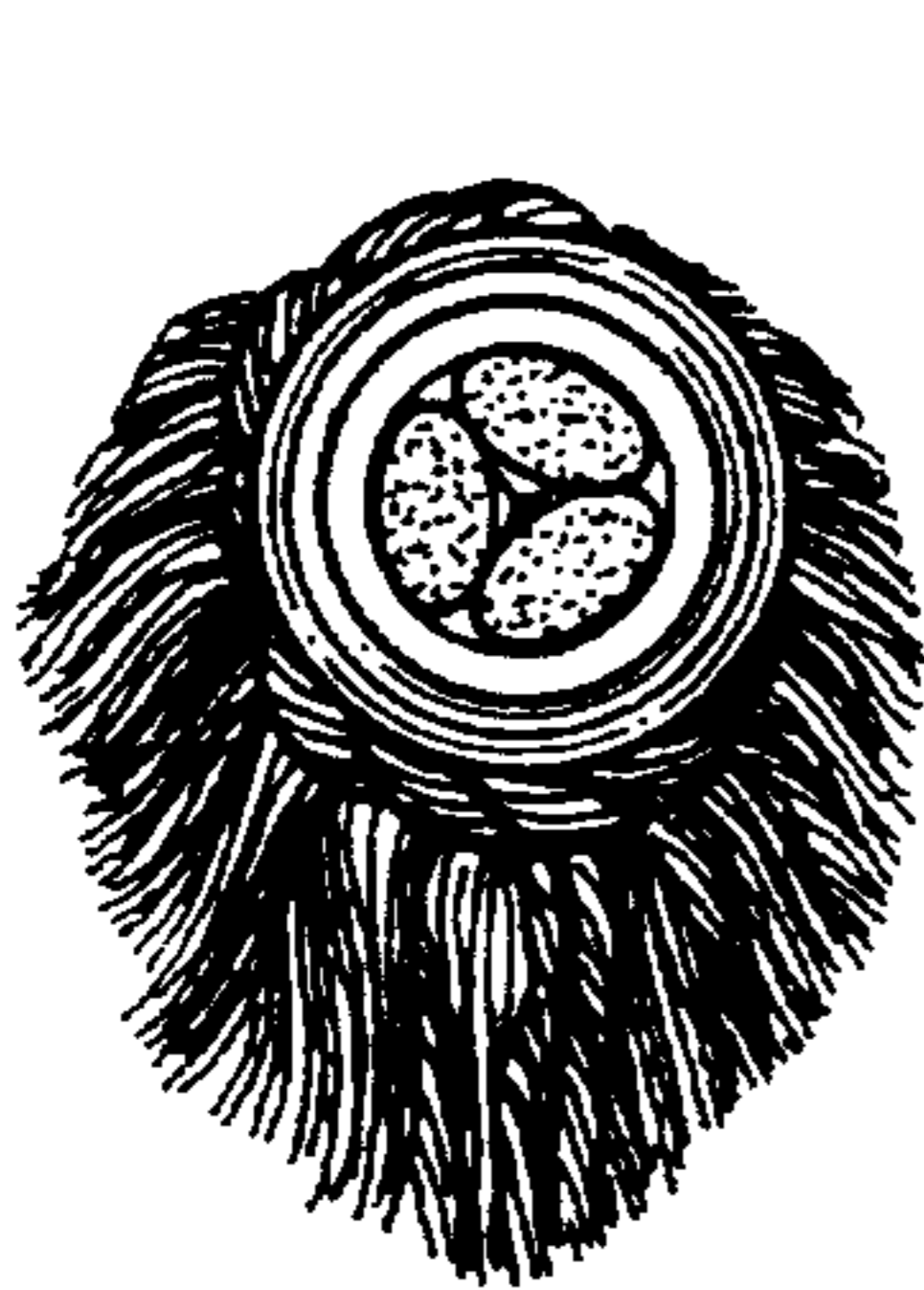

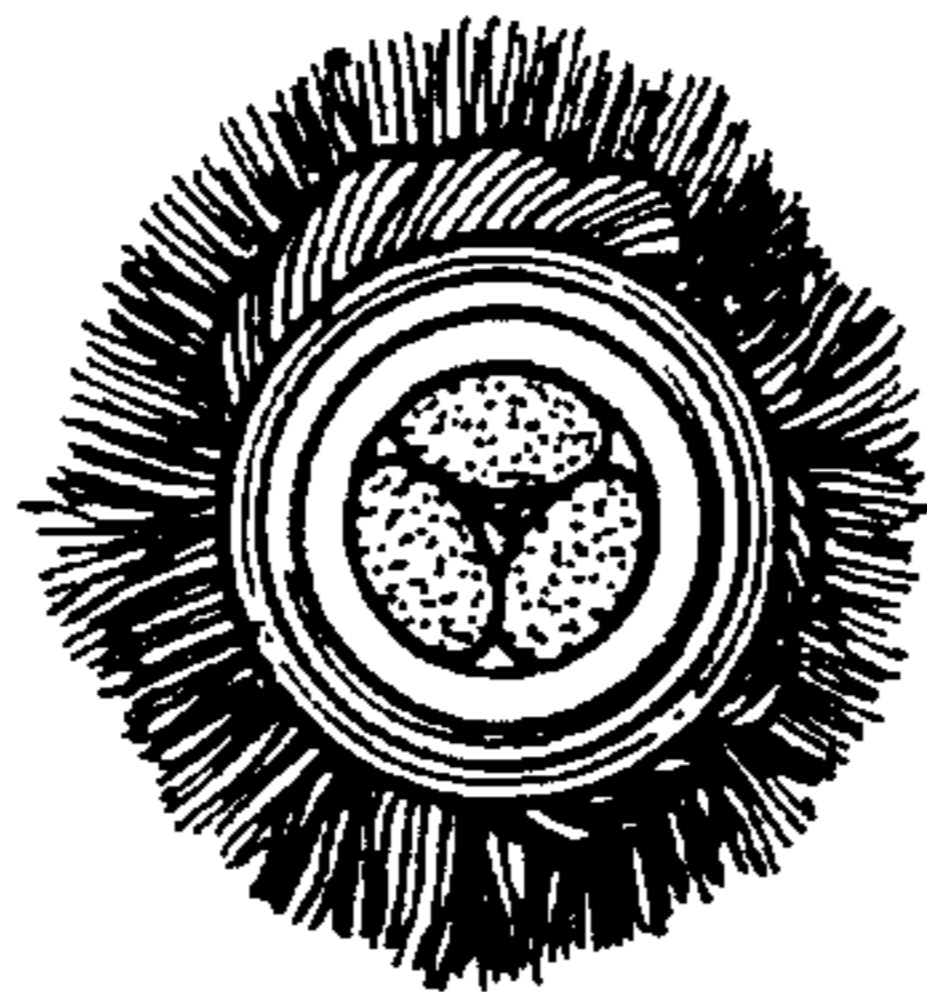

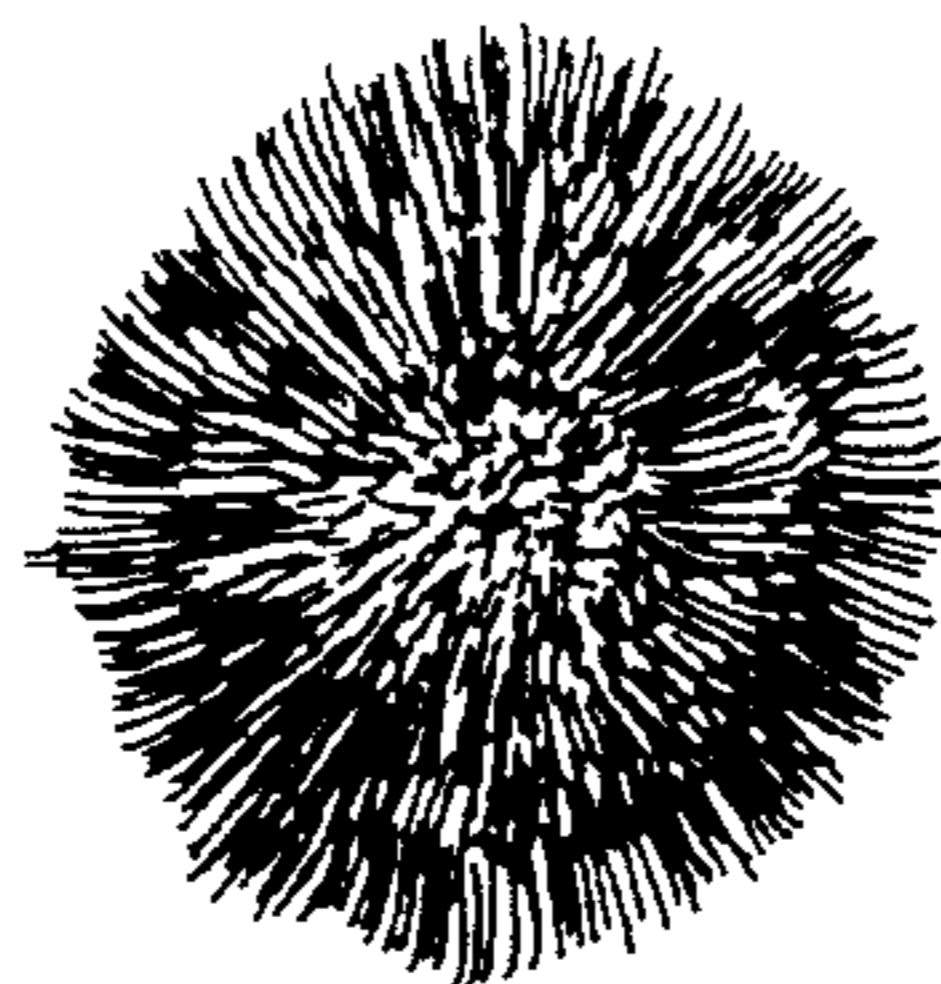
