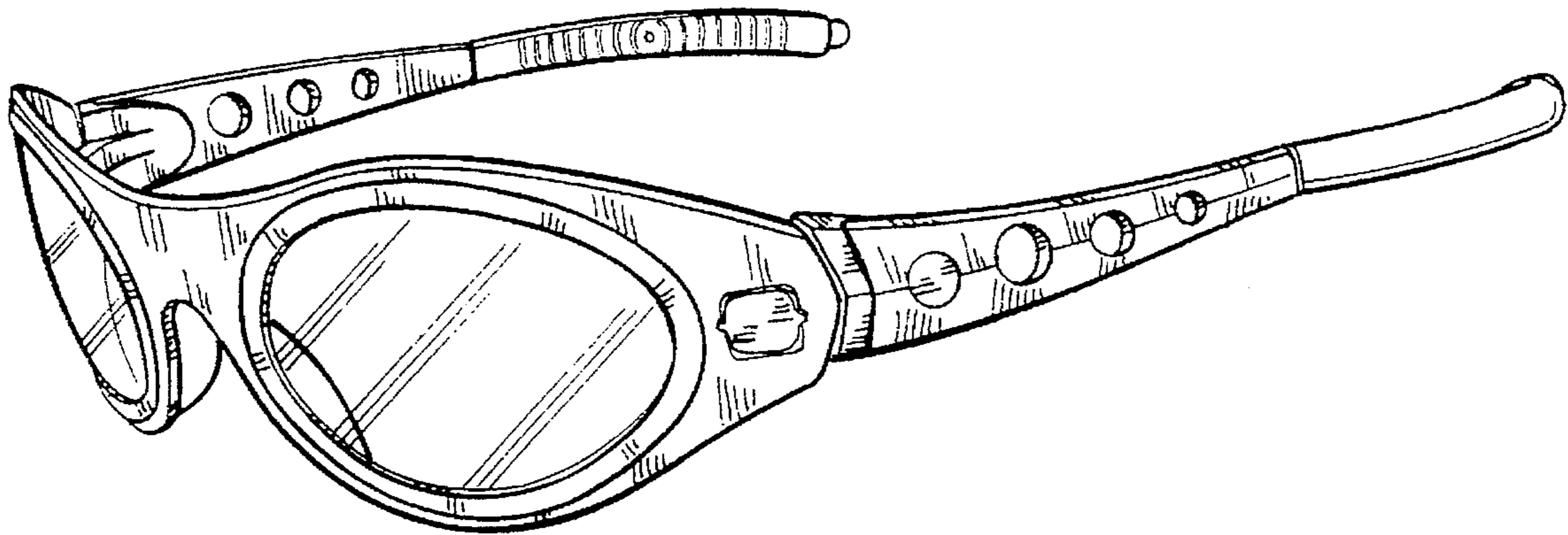

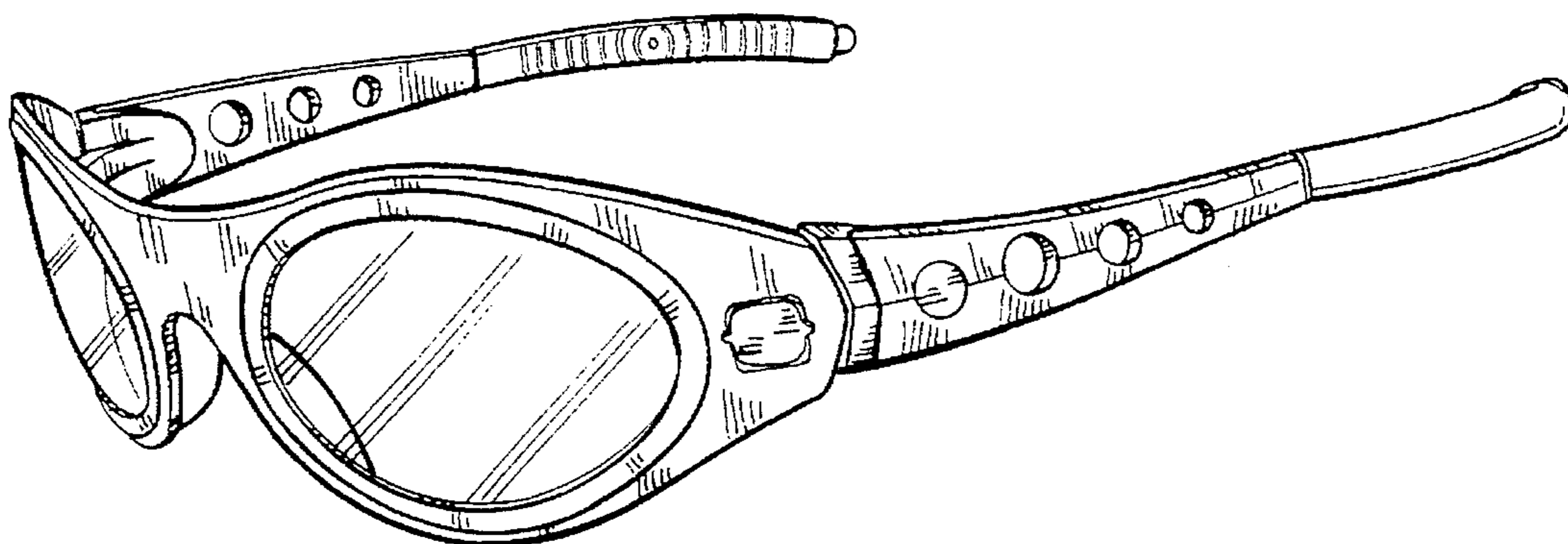
The ornamental design for the sunglasses, as shown and described.

**DESCRIPTION**

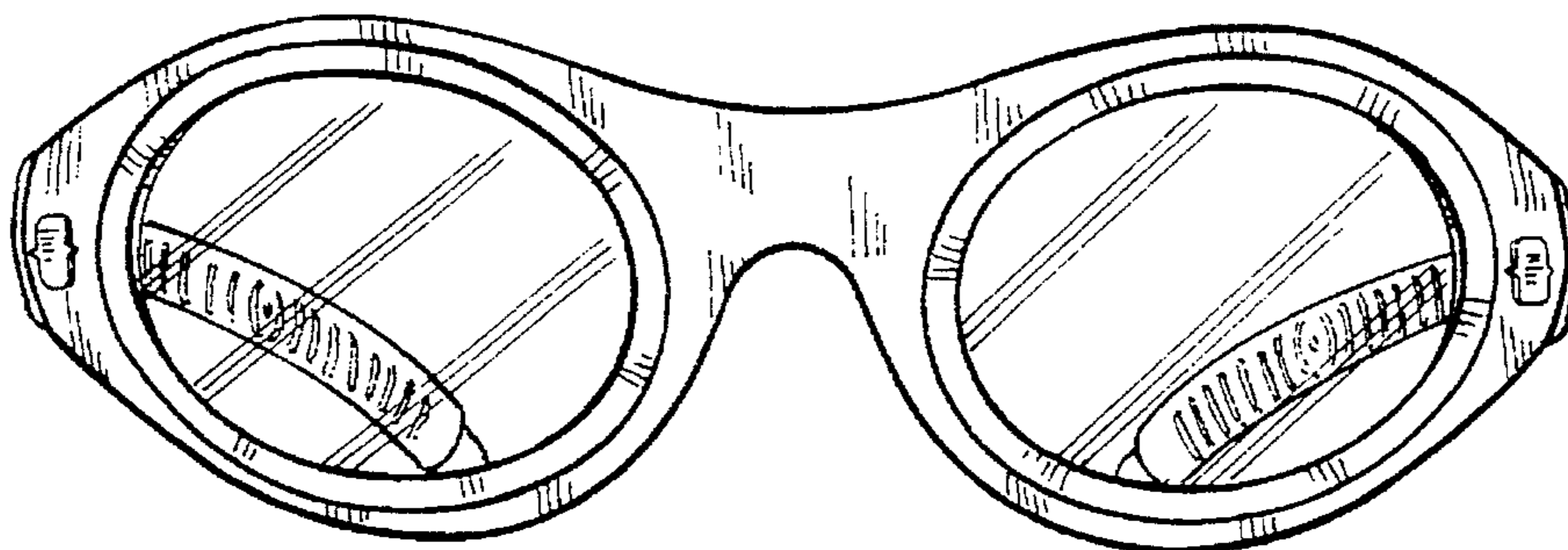
FIG. 1 is a perspective view of the sunglasses, showing my new design;

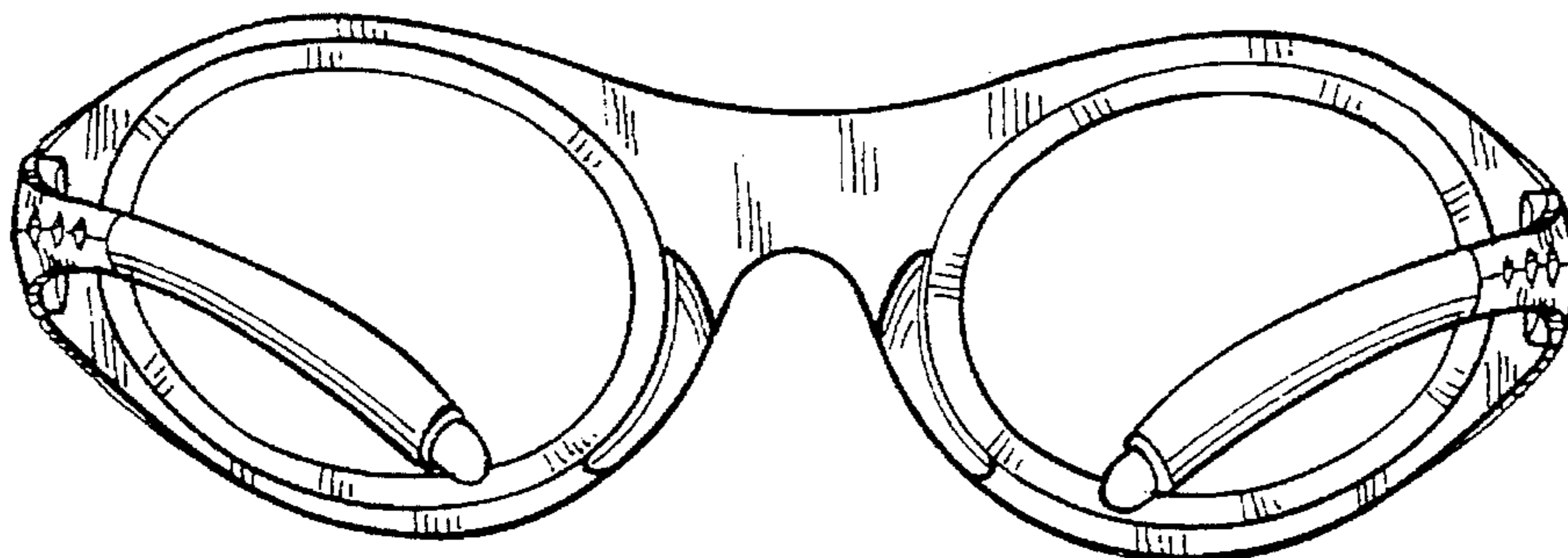

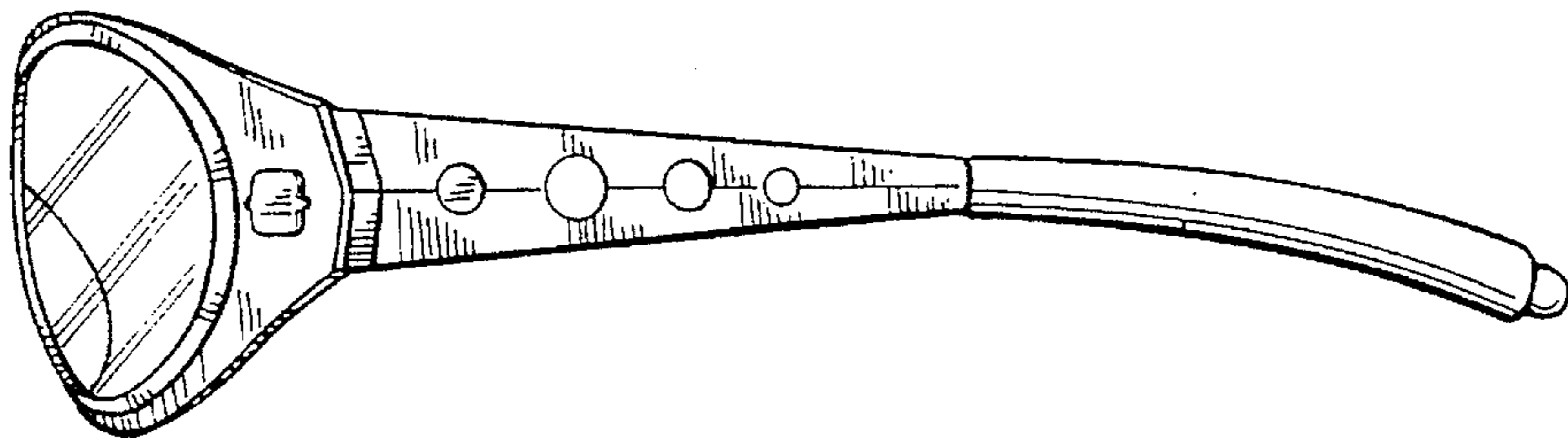

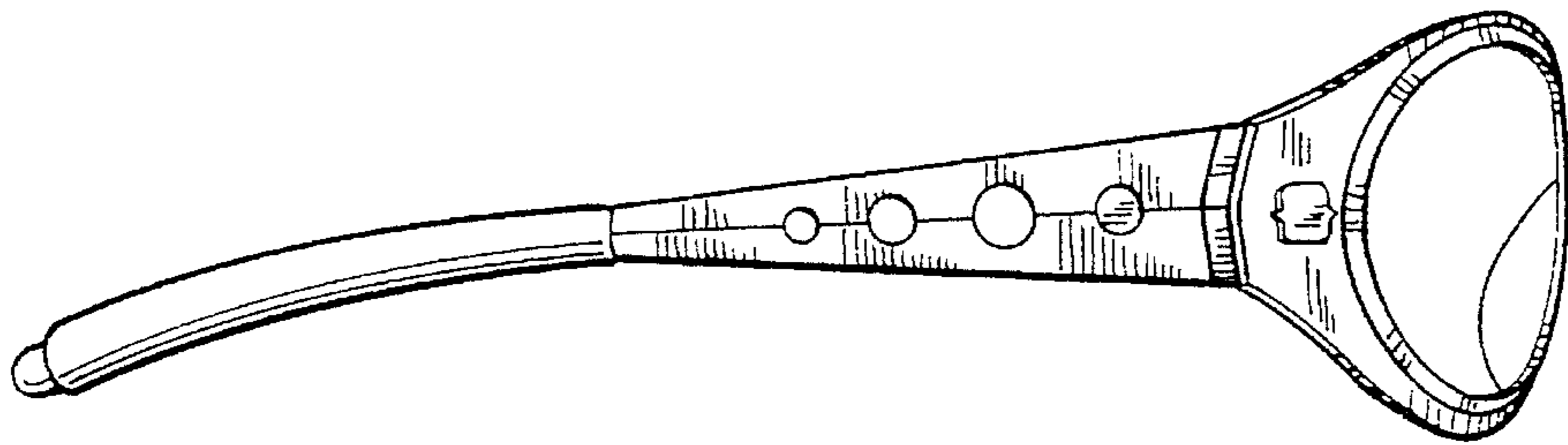
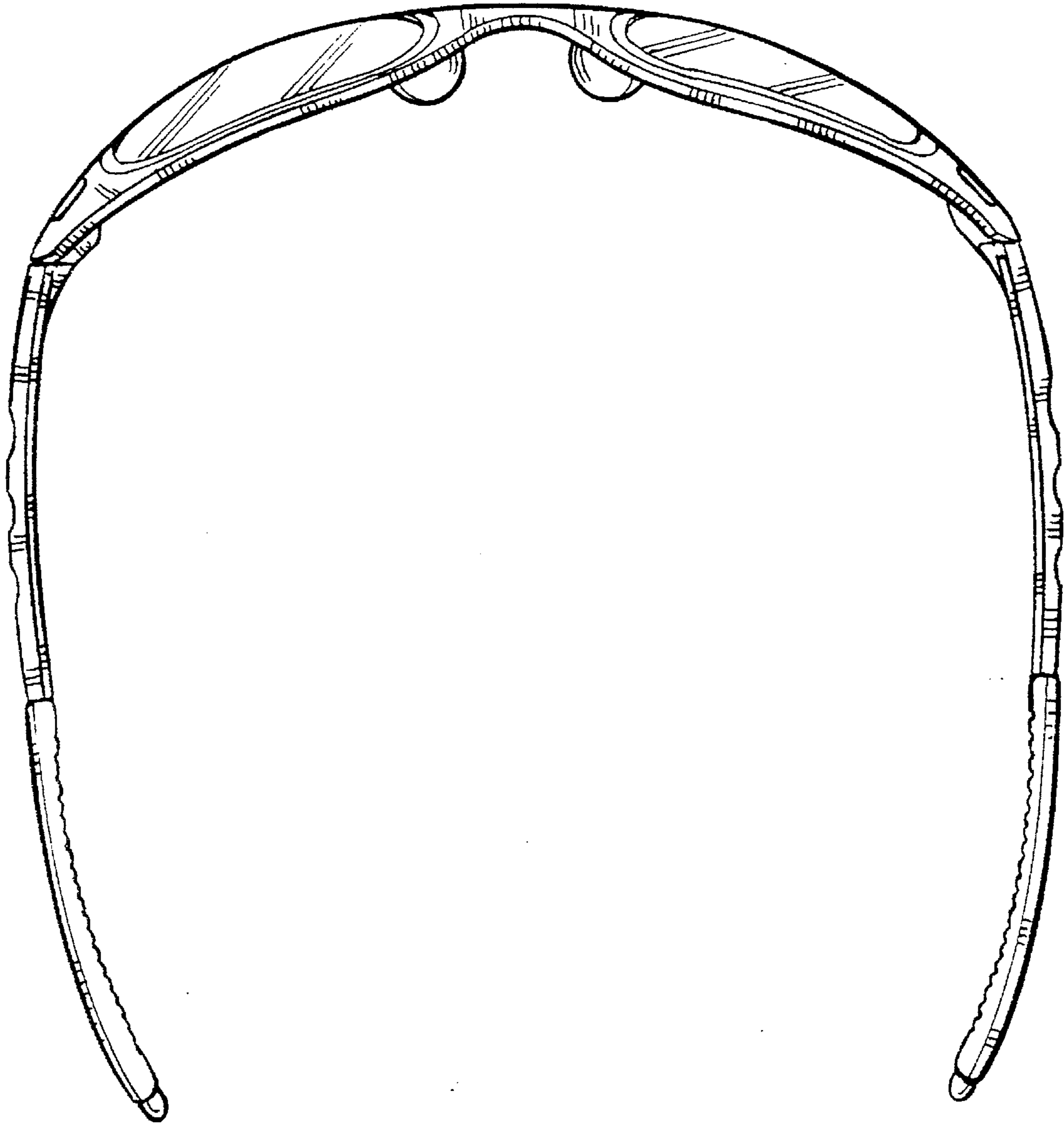
