[57] **CLAIM**

The ornamental design for a combined tempered glass door and its main fittings, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined tempered glass door and its main fittings, the broken lines showing a wall

is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is an enlarged front elevational view of a locking fitting of the tempered glass door as in FIG. 1;

FIG. 3 is an enlarged bottom view of the locking fitting as in FIG. 2;

FIG. 4 is an enlarged top plan view thereof;

FIG. 5 is an enlarged left side elevational view thereof;

FIG. 6 is an enlarged right side elevational view thereof;

FIG. 7 an enlarged rear view thereof;

FIG. 8 is an enlarged perspective view thereof;

FIG. 9 is an enlarged front elevational view of a non-locking hinged fitting of the combined tempered glass door, and its main fittings as in FIG. 1;

FIG. 10 is an enlarged bottom view of the non-locking hinged fitting of the combined tempered glass door and its main fittings as in FIG. 1;

FIG. 11 is an enlarged top plan view thereof;

FIG. 12 is an enlarged left side elevational view thereof;

FIG. 13 is an enlarged right side elevational view thereof;

FIG. 14 is an enlarged rear view thereof;

FIG. 15 is an enlarged perspective view thereof; and,

FIG. 16 is a perspective view of a second embodiment of a combined tempered glass door and its main fittings, the broken lines showing a wall is for illustrative purposes only, and forms no part of the claimed design.

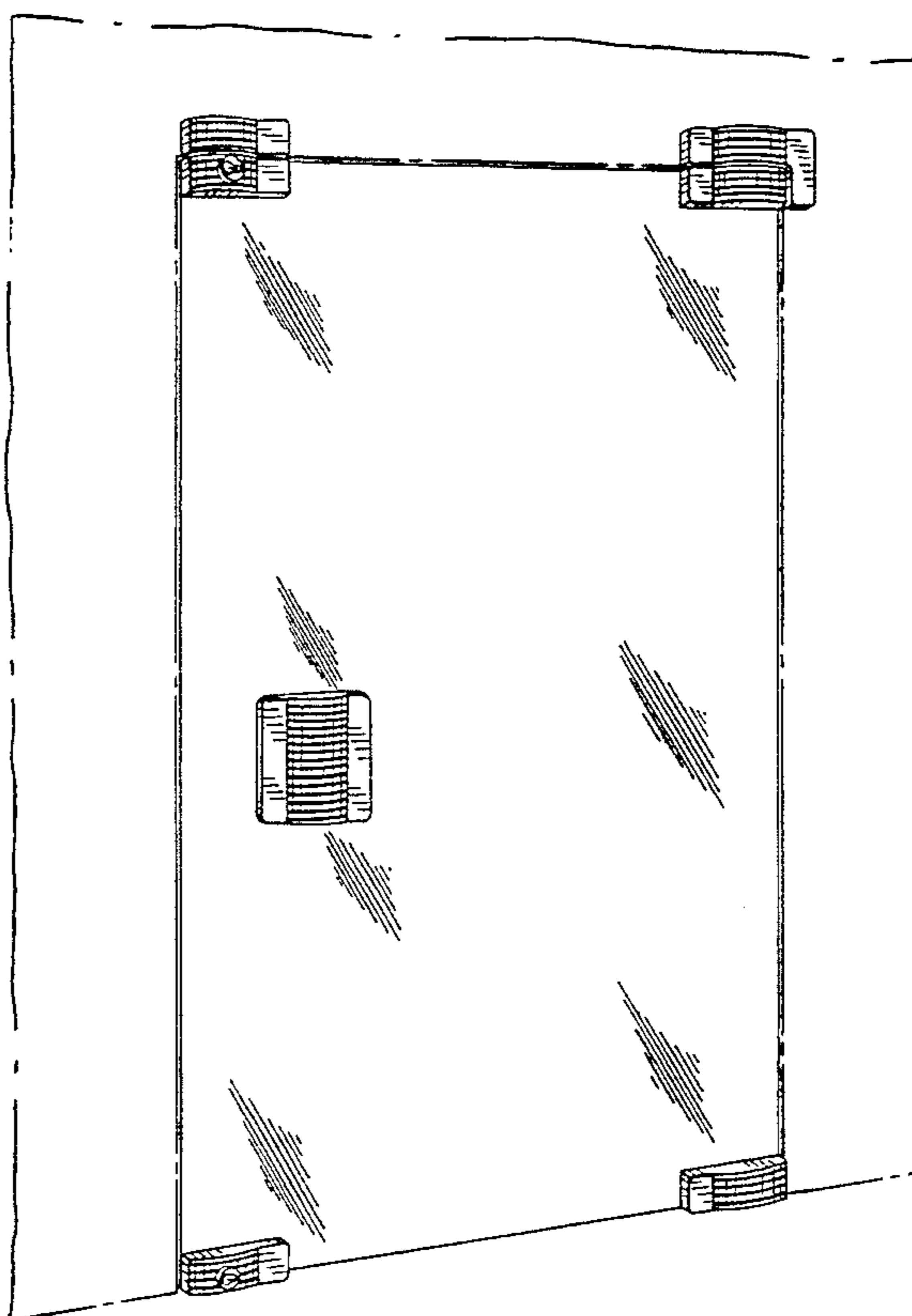

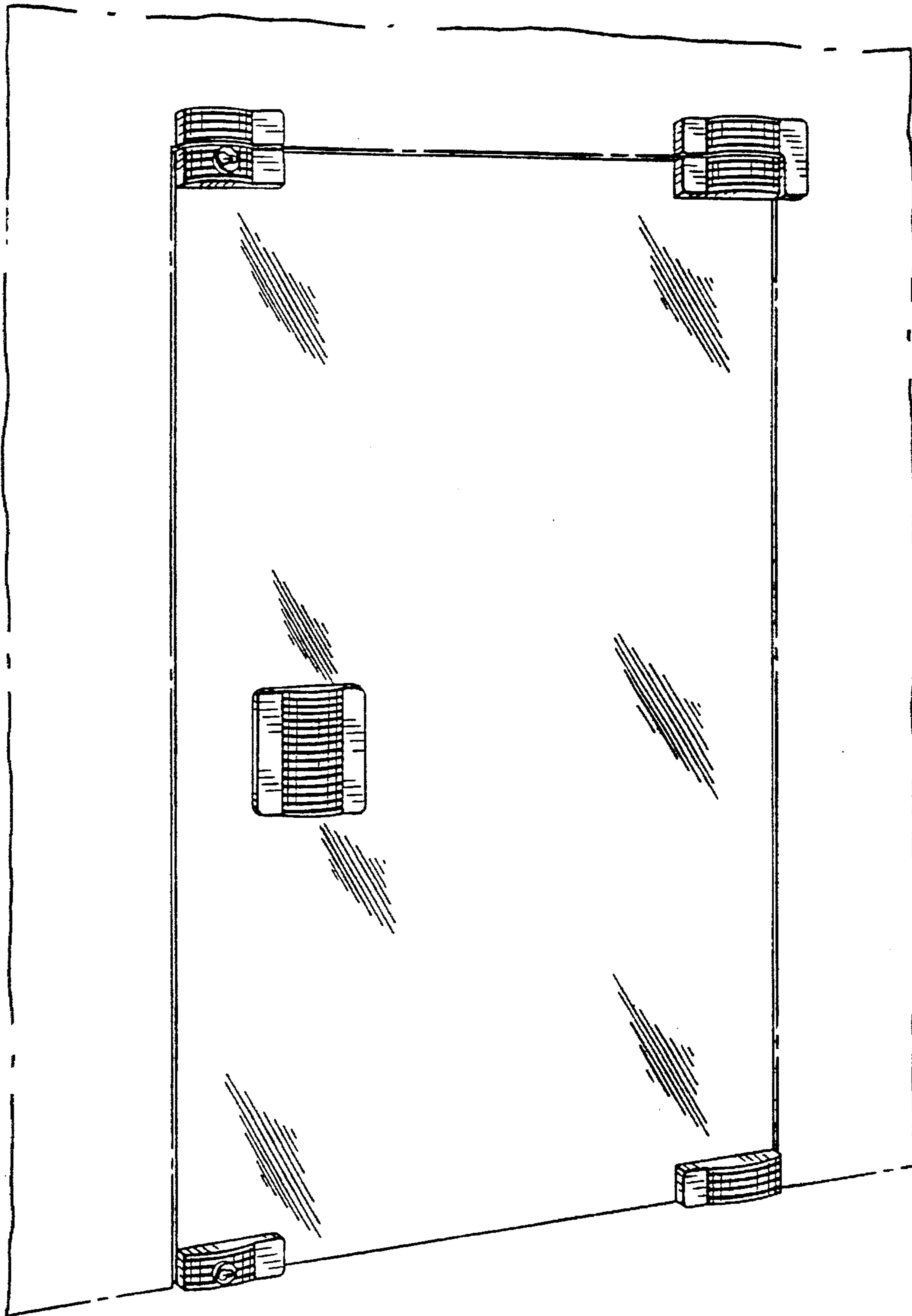

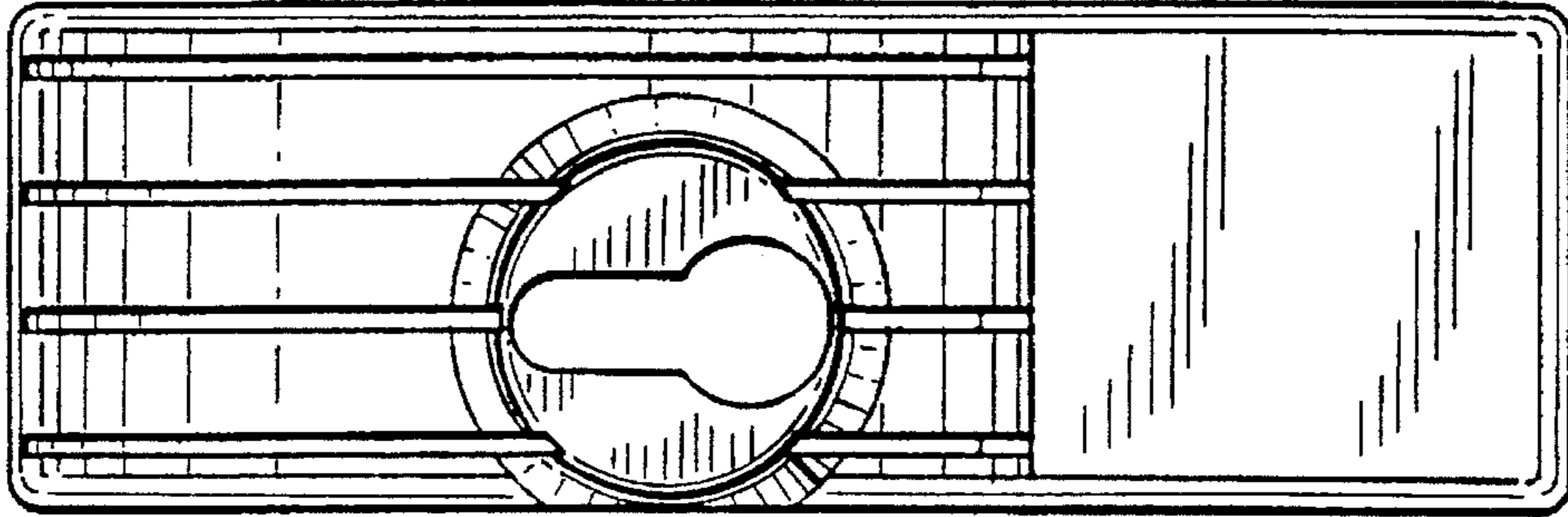

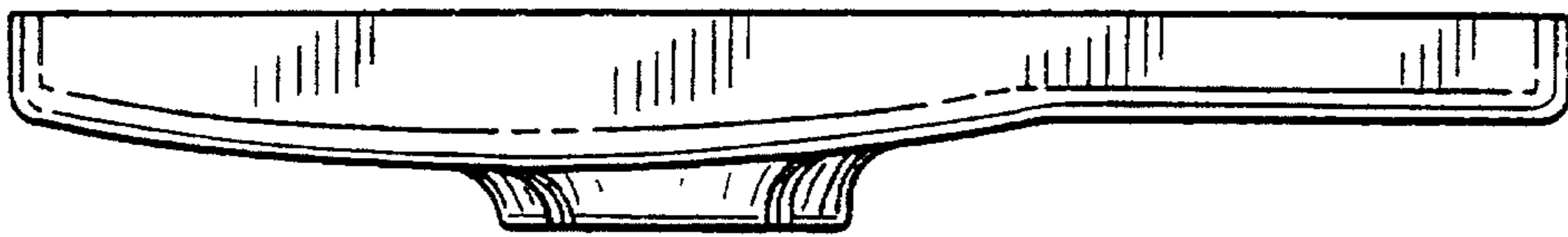

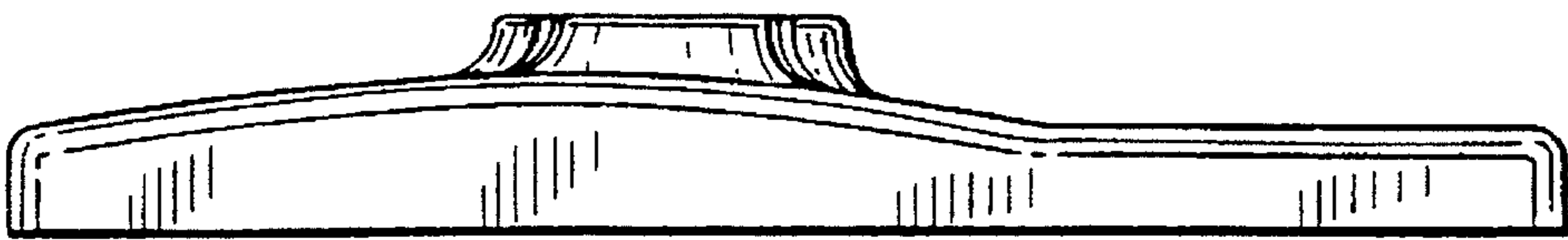

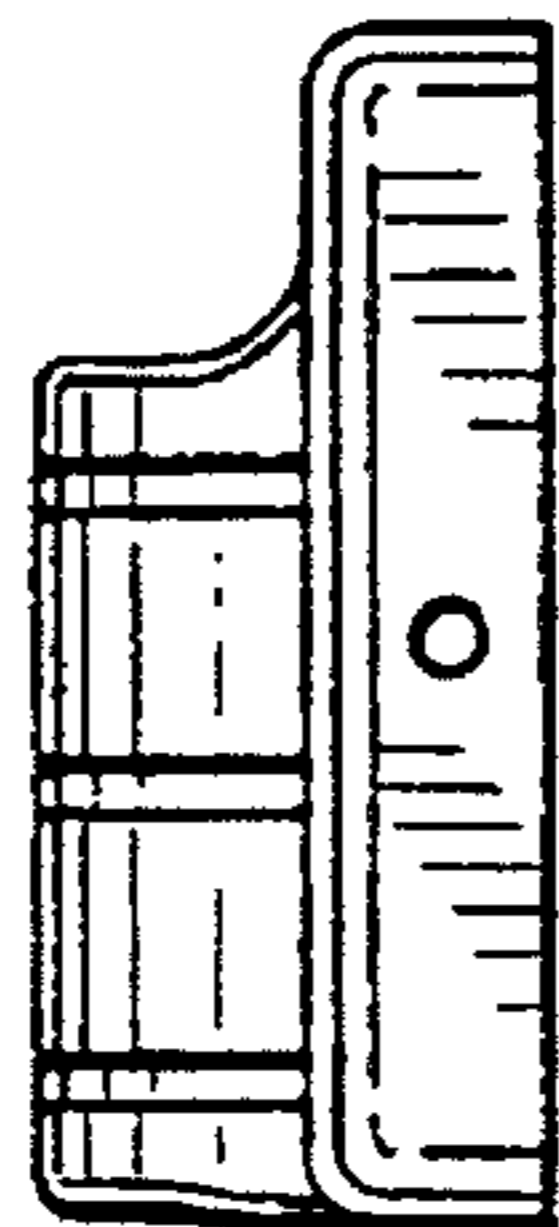

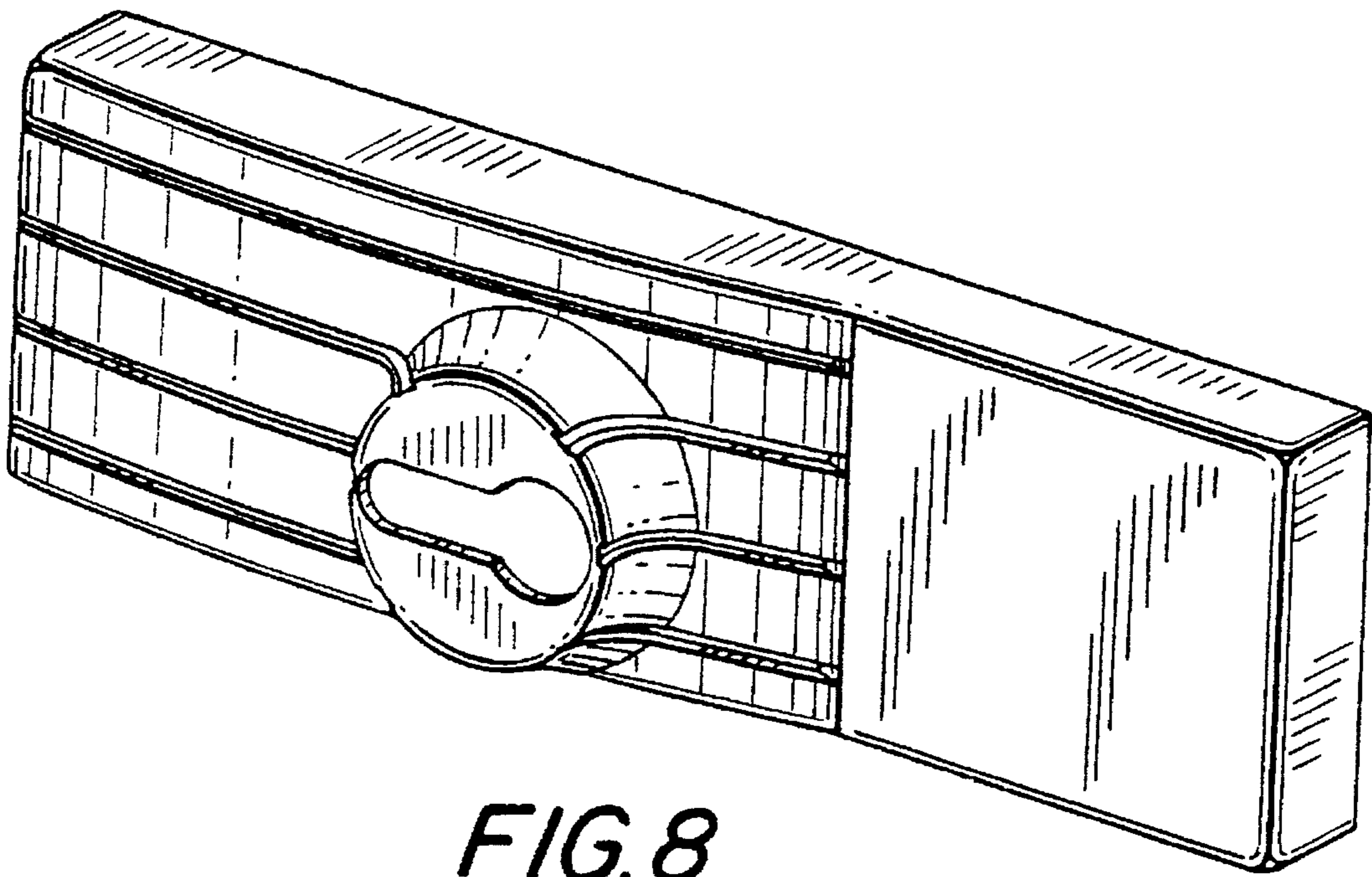
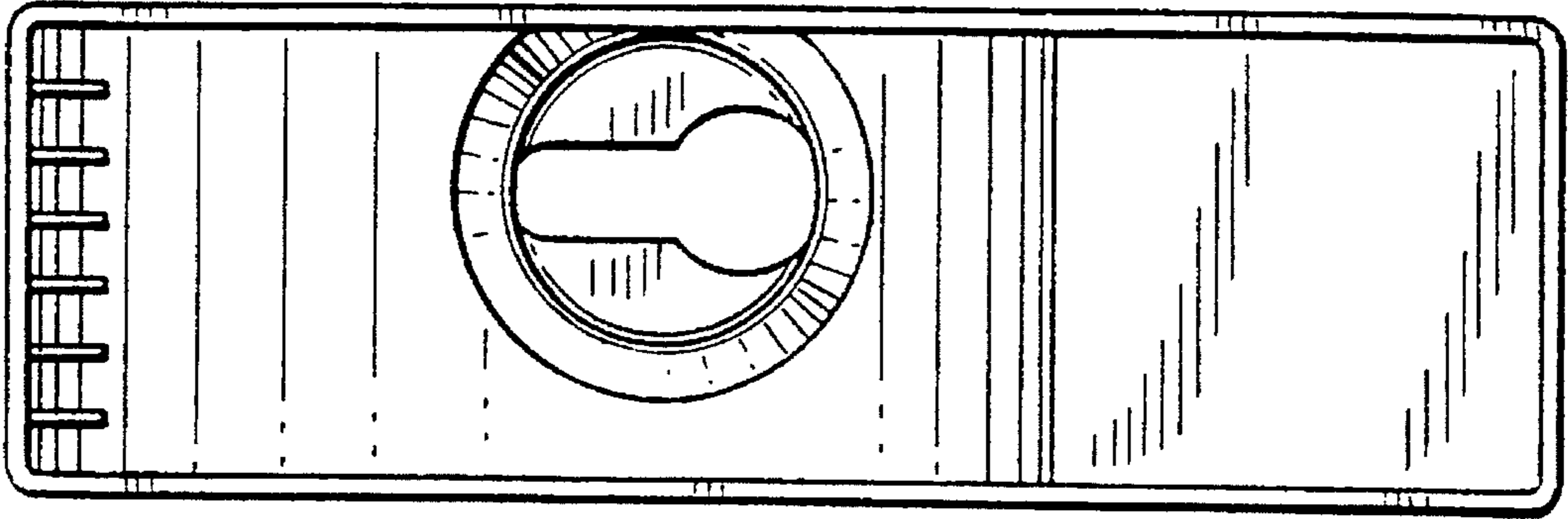

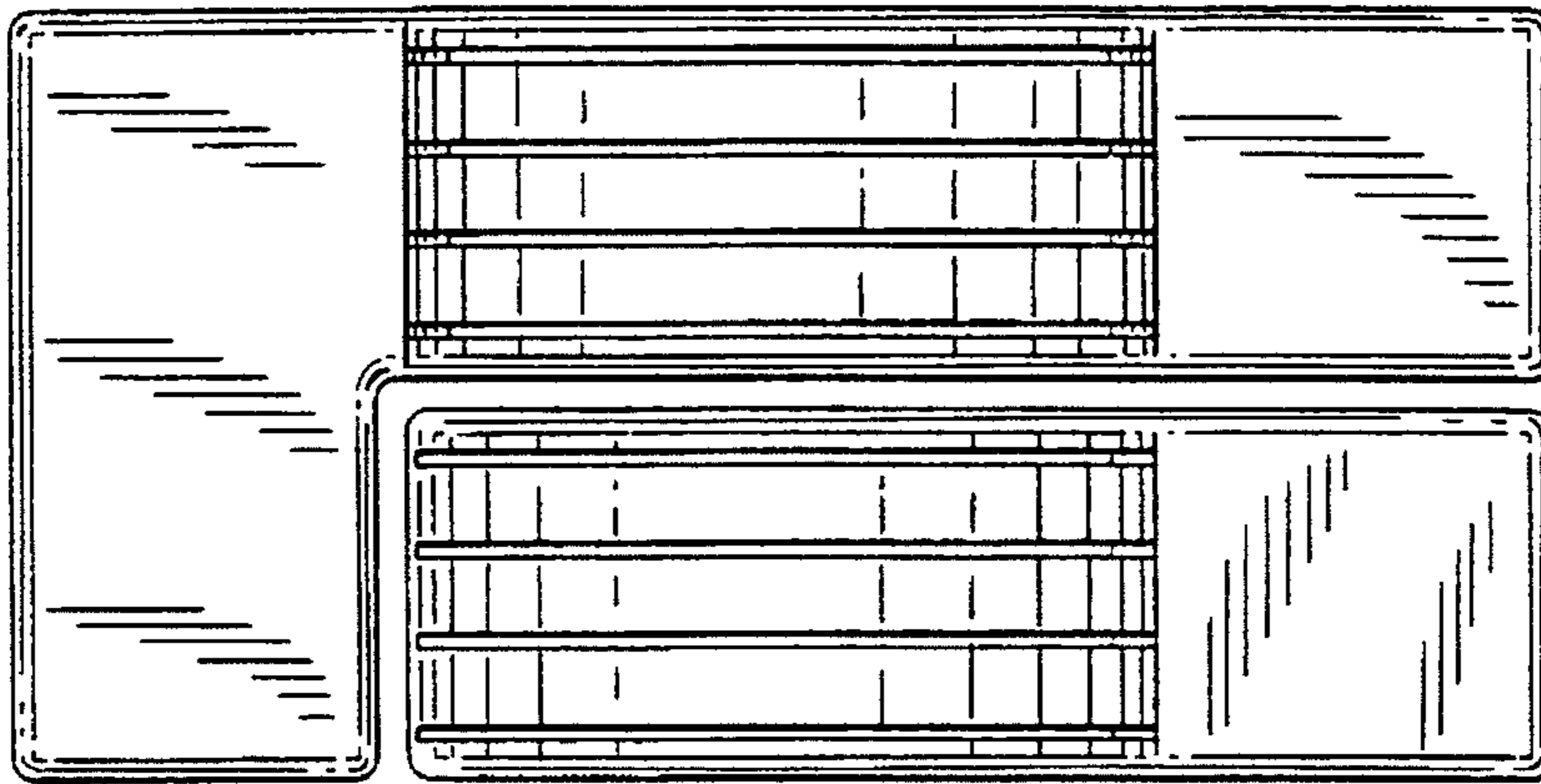

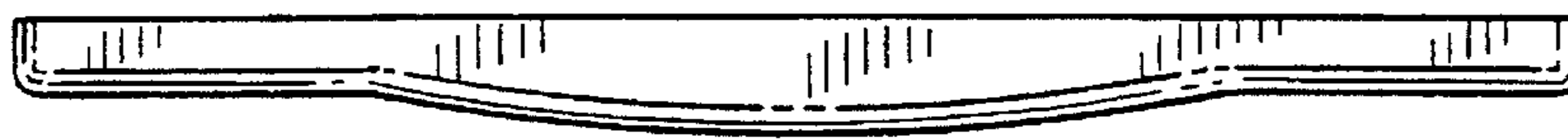

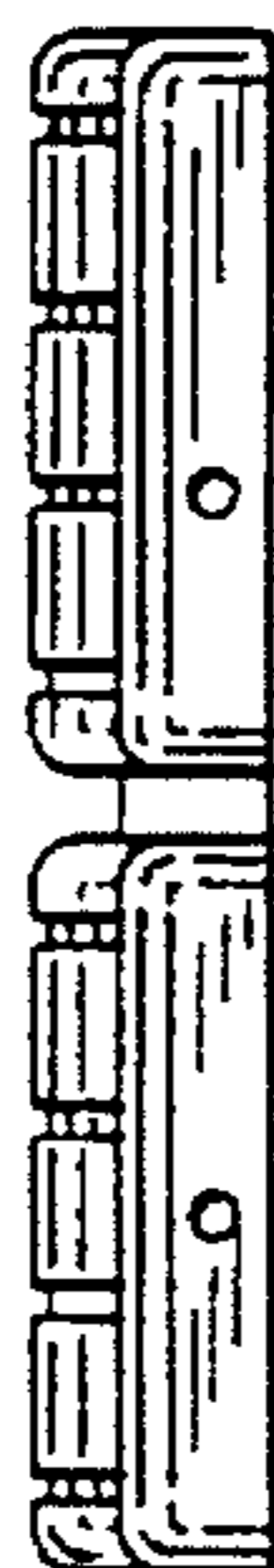

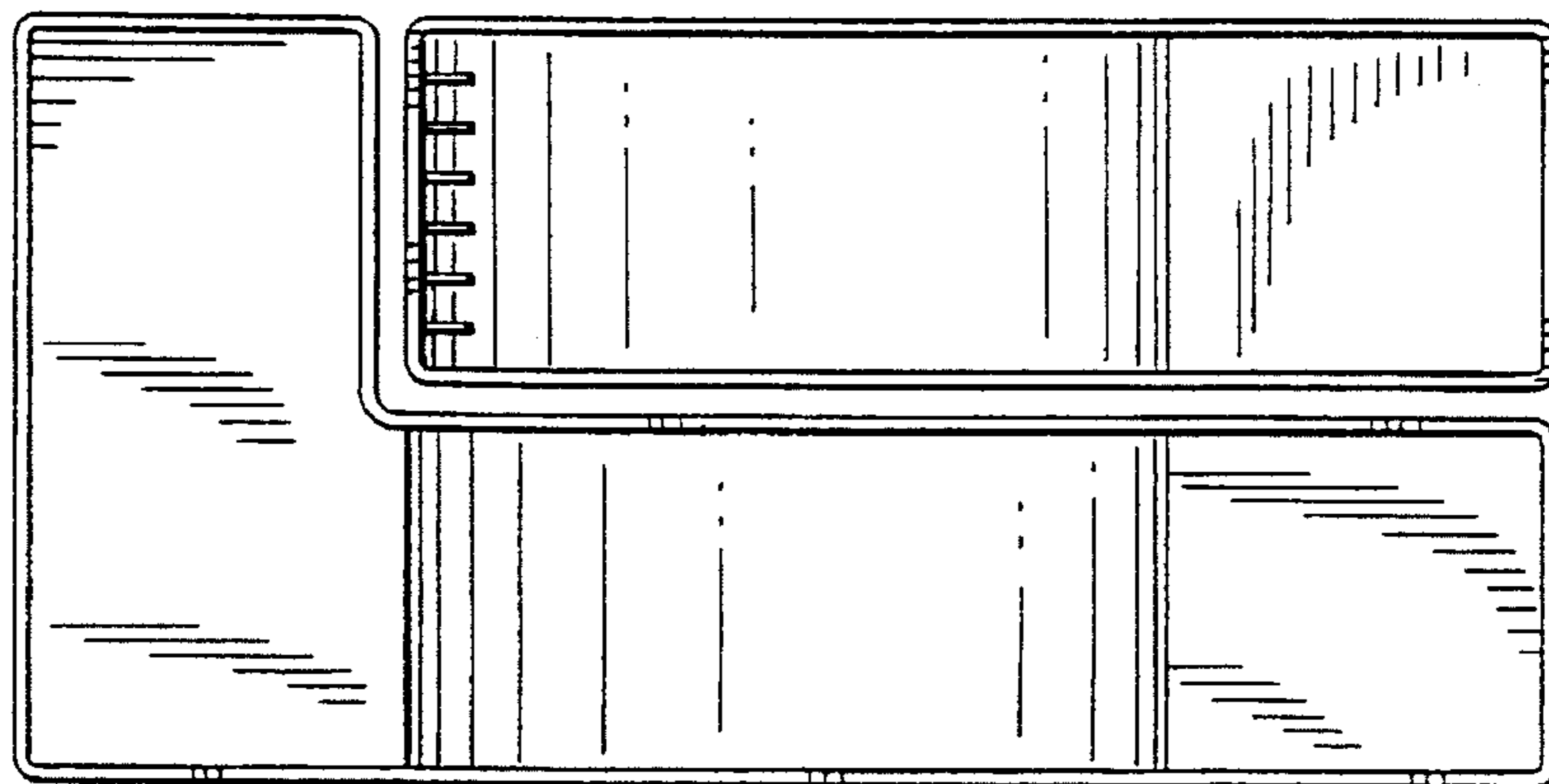

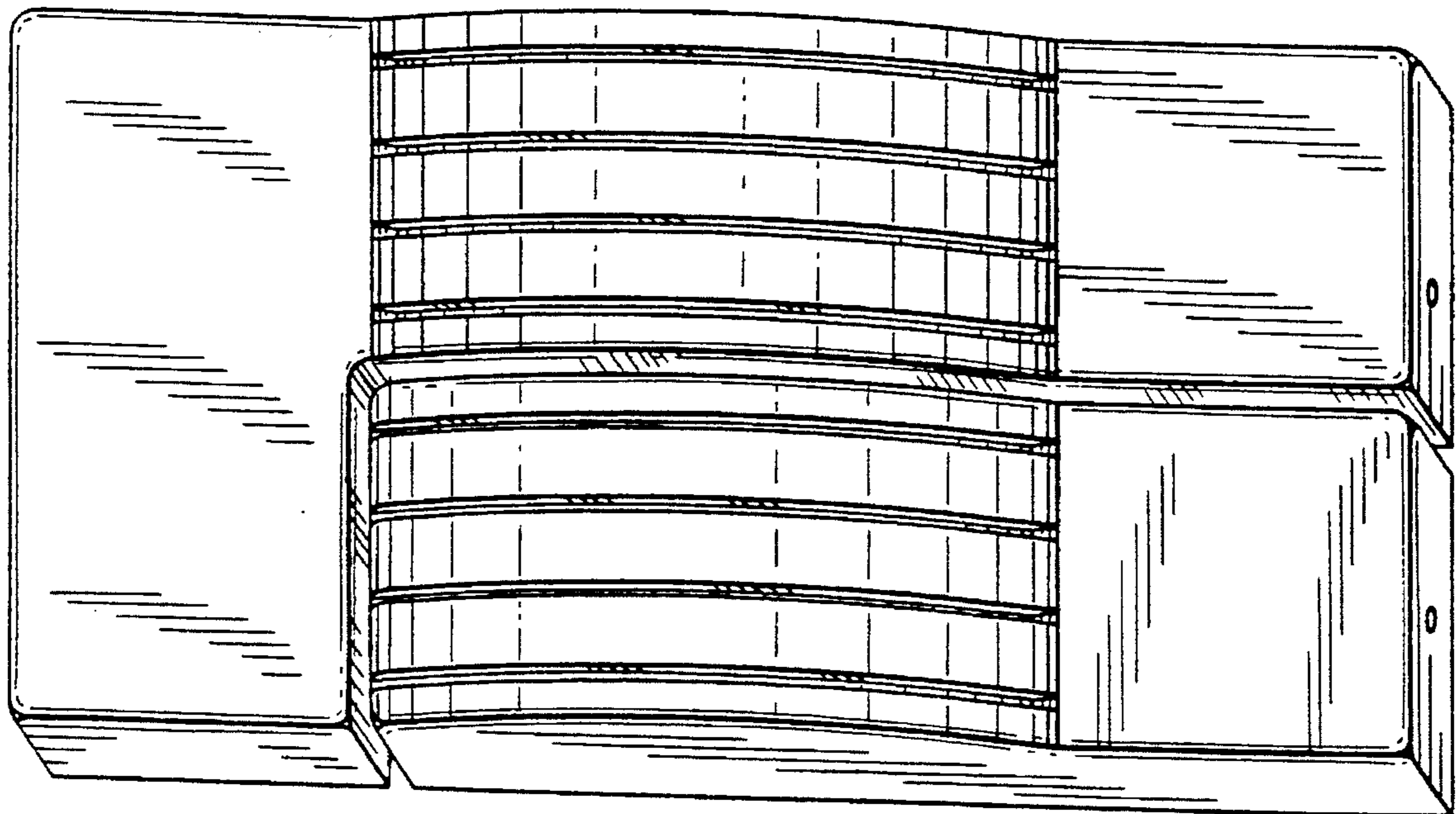
