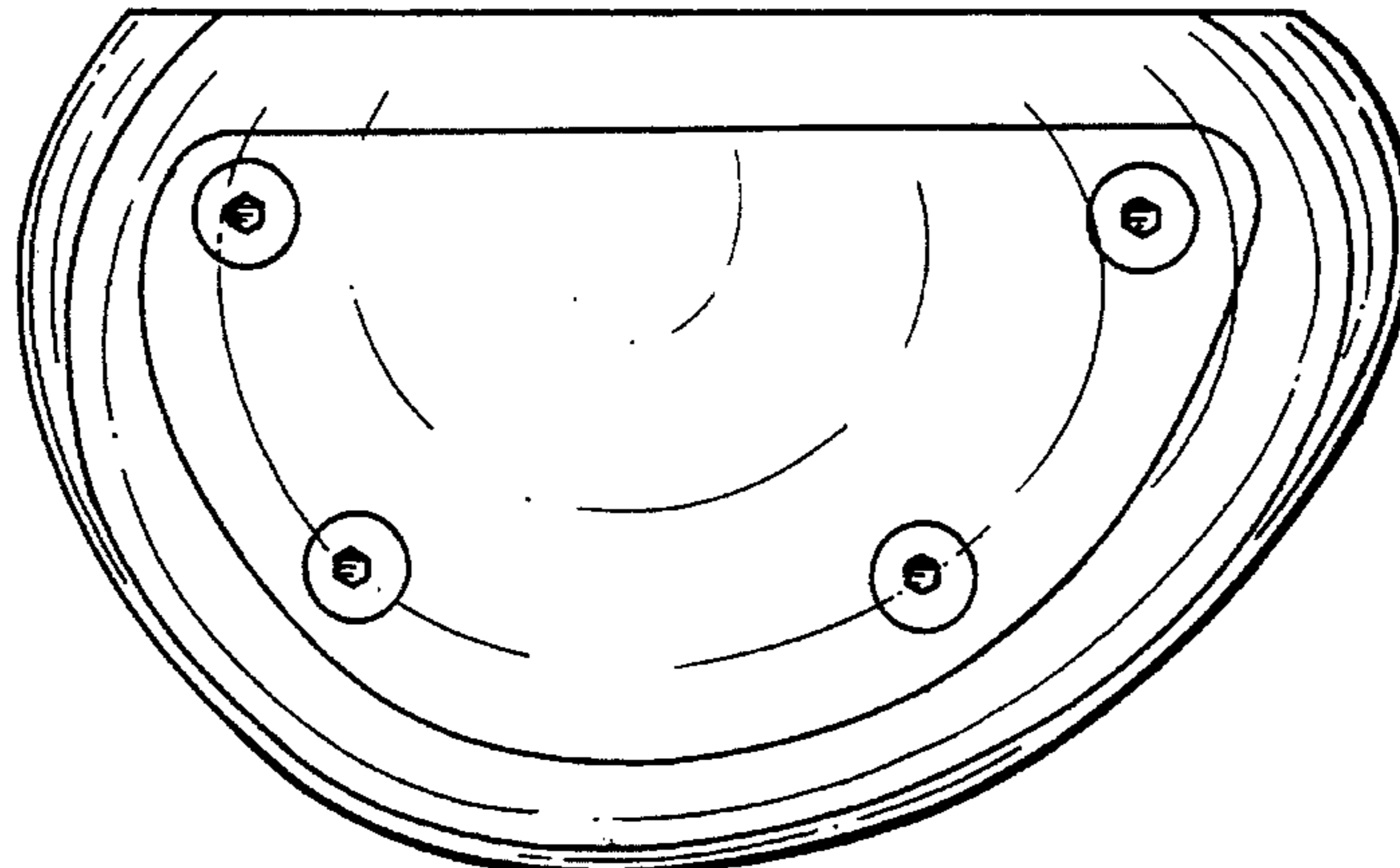
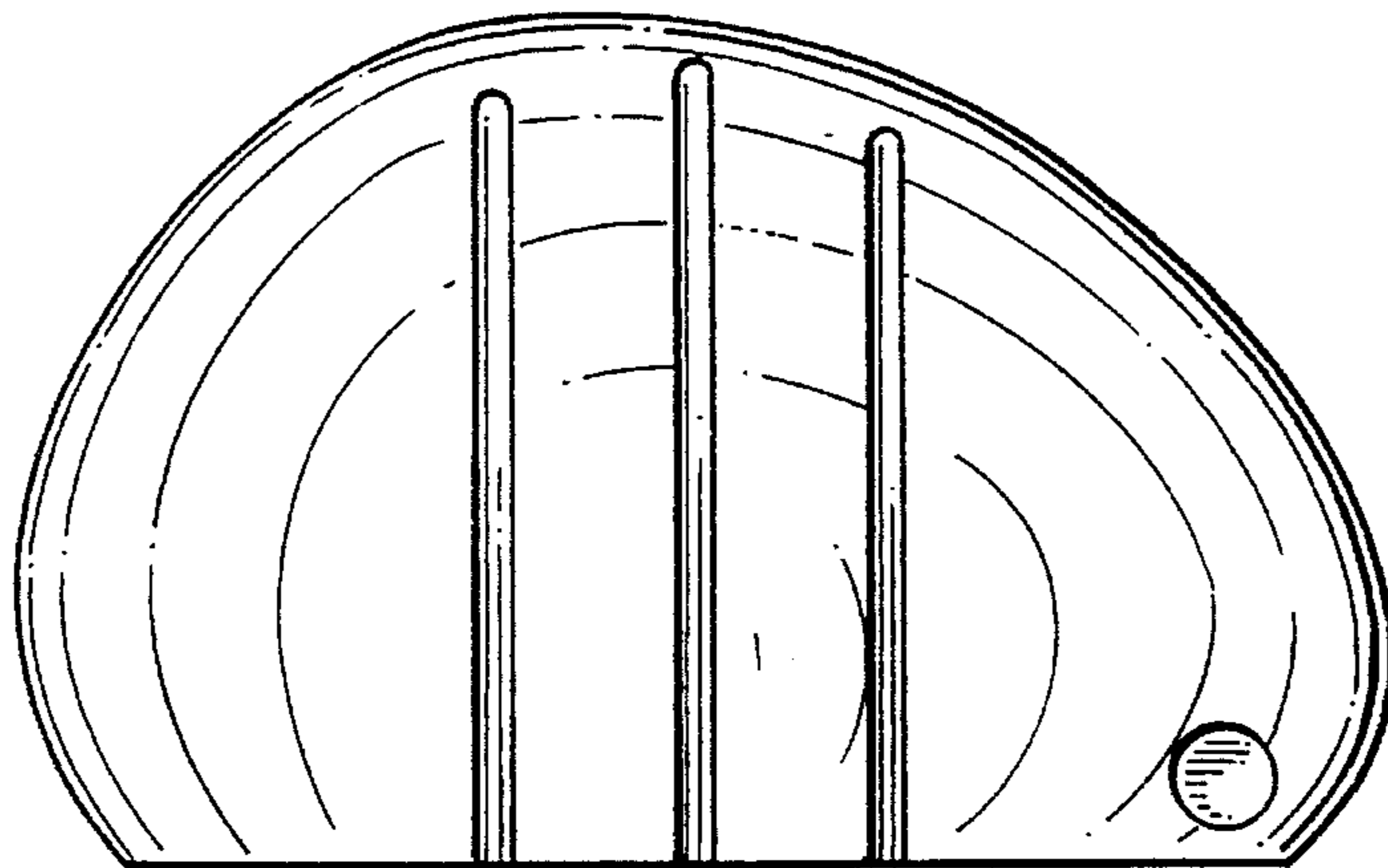

FIG. 2 is a bottom view thereof;

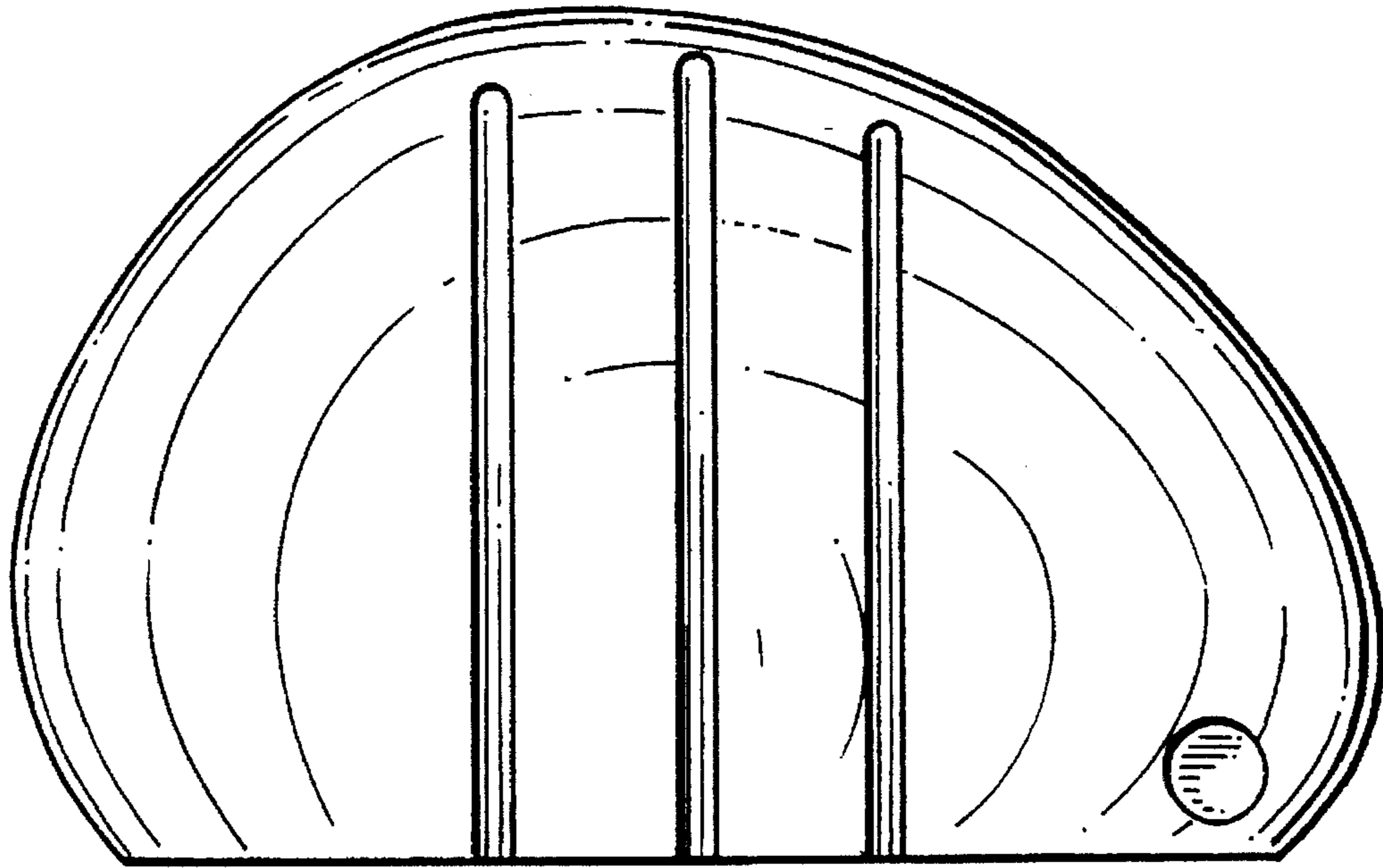

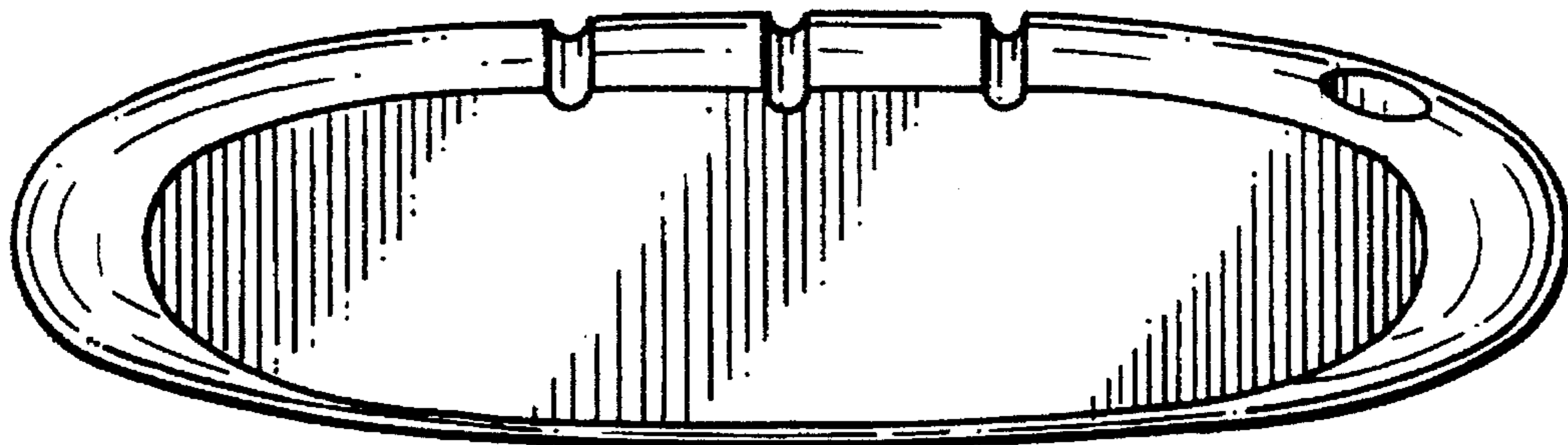

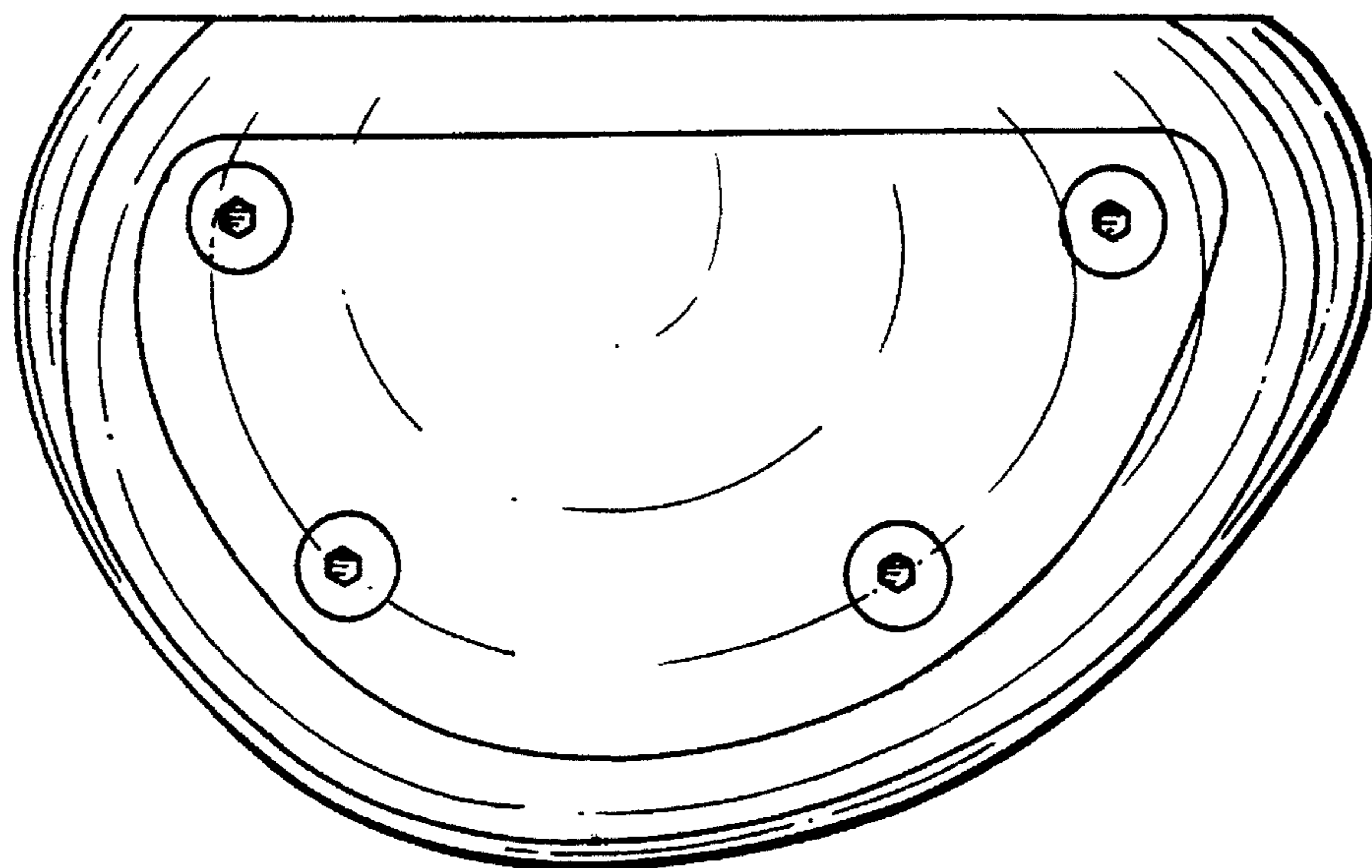

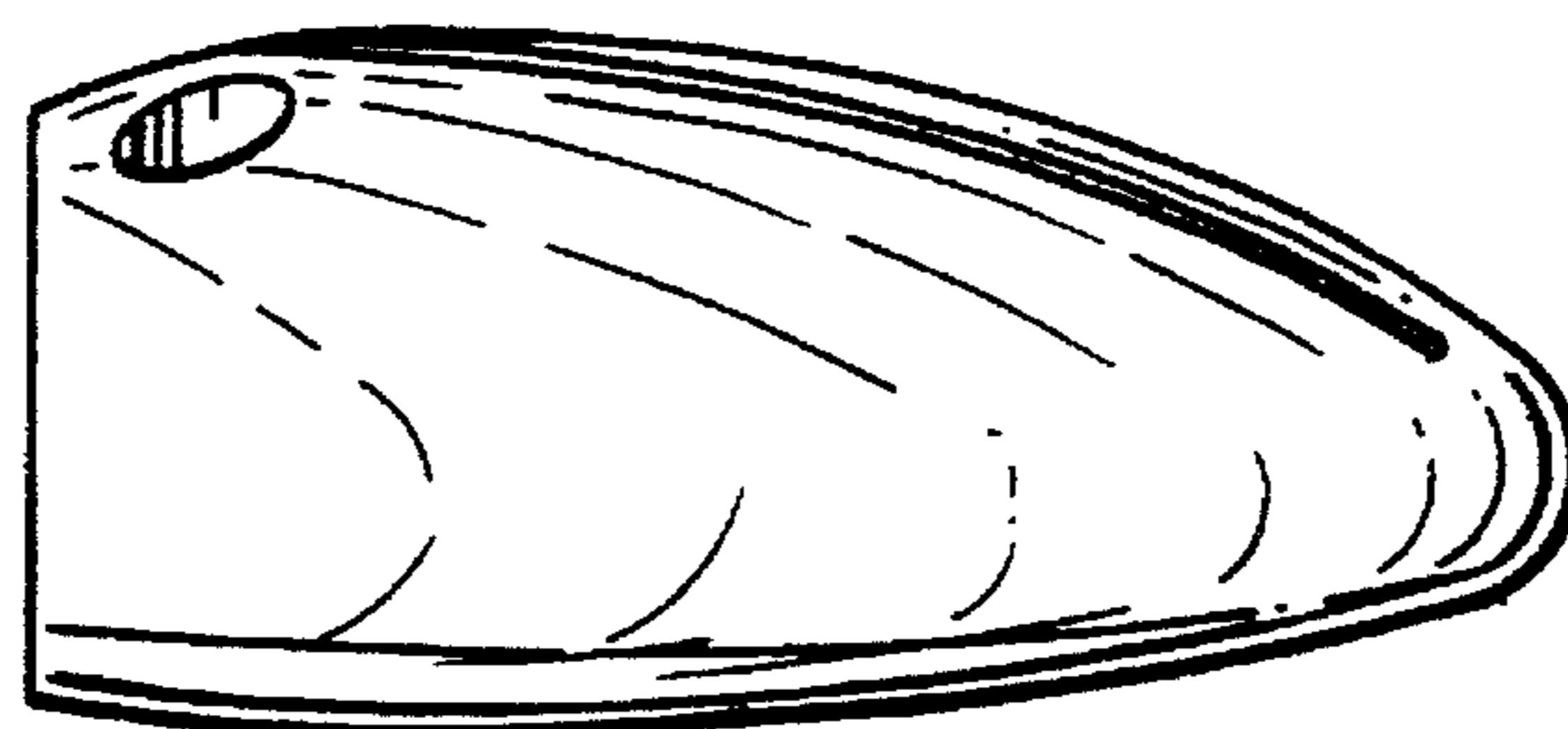

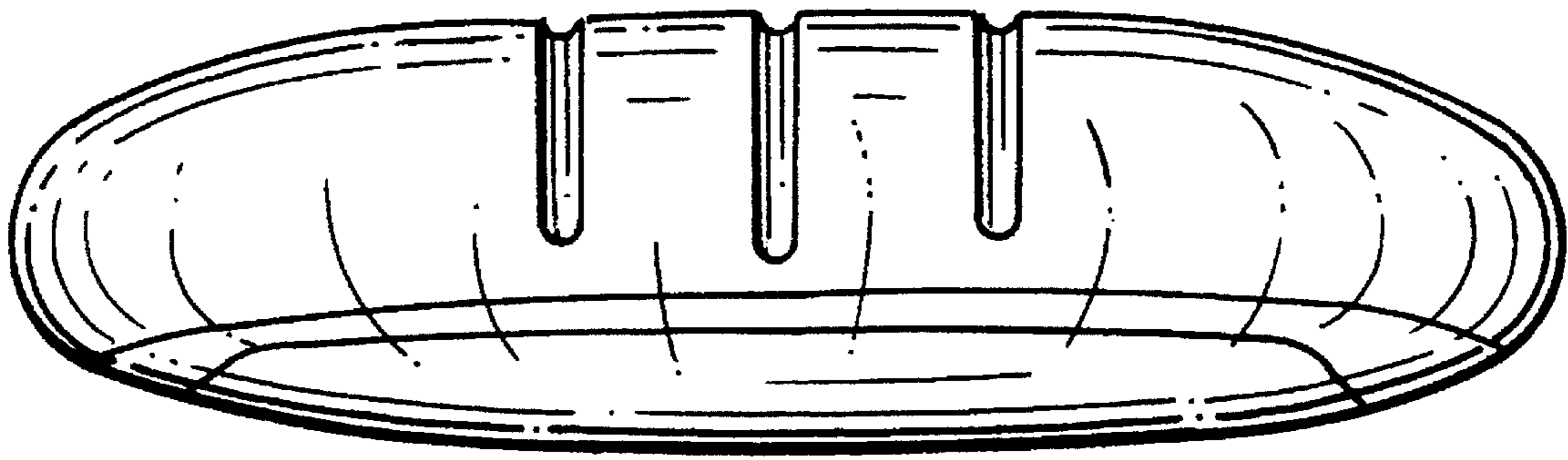

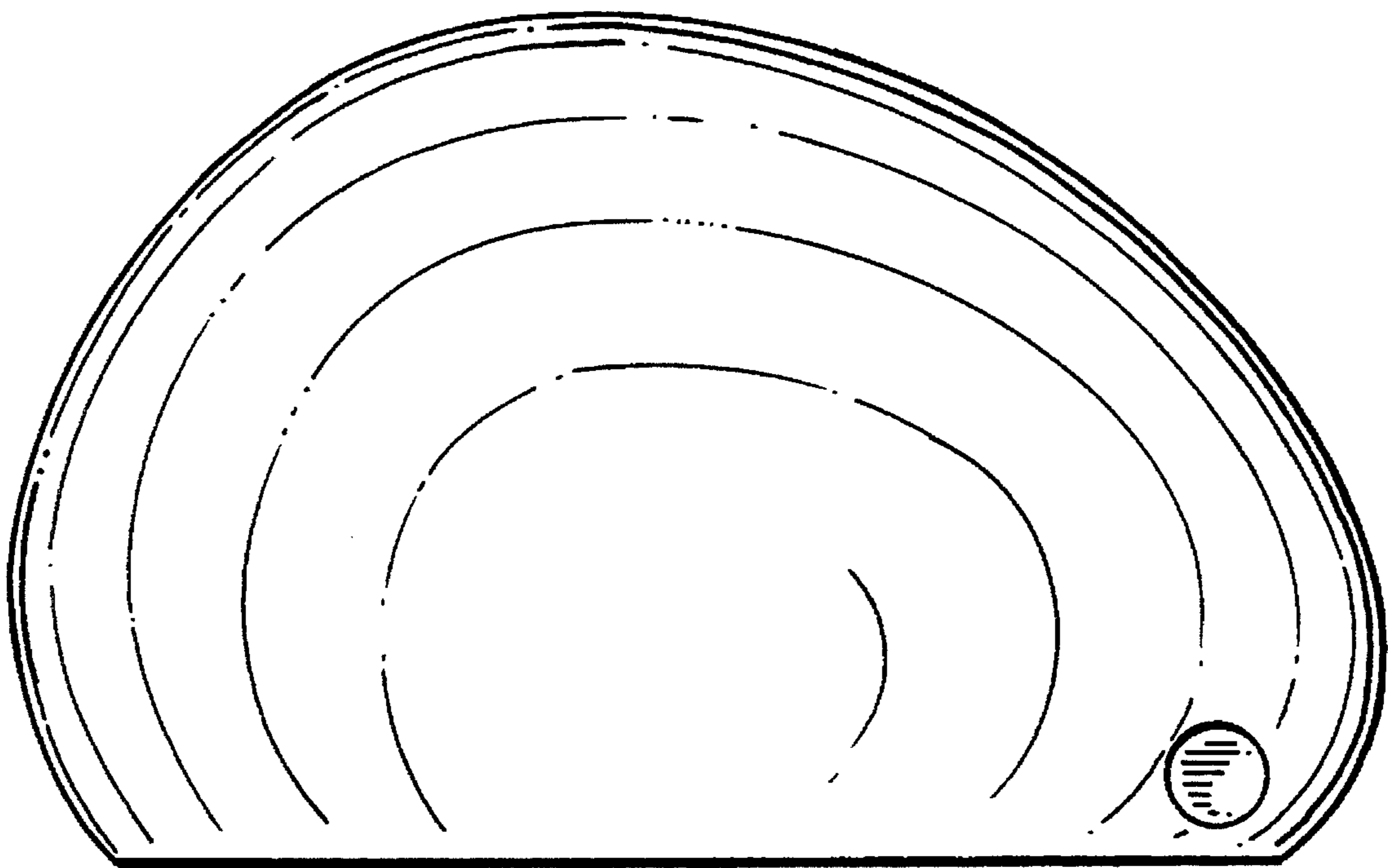
