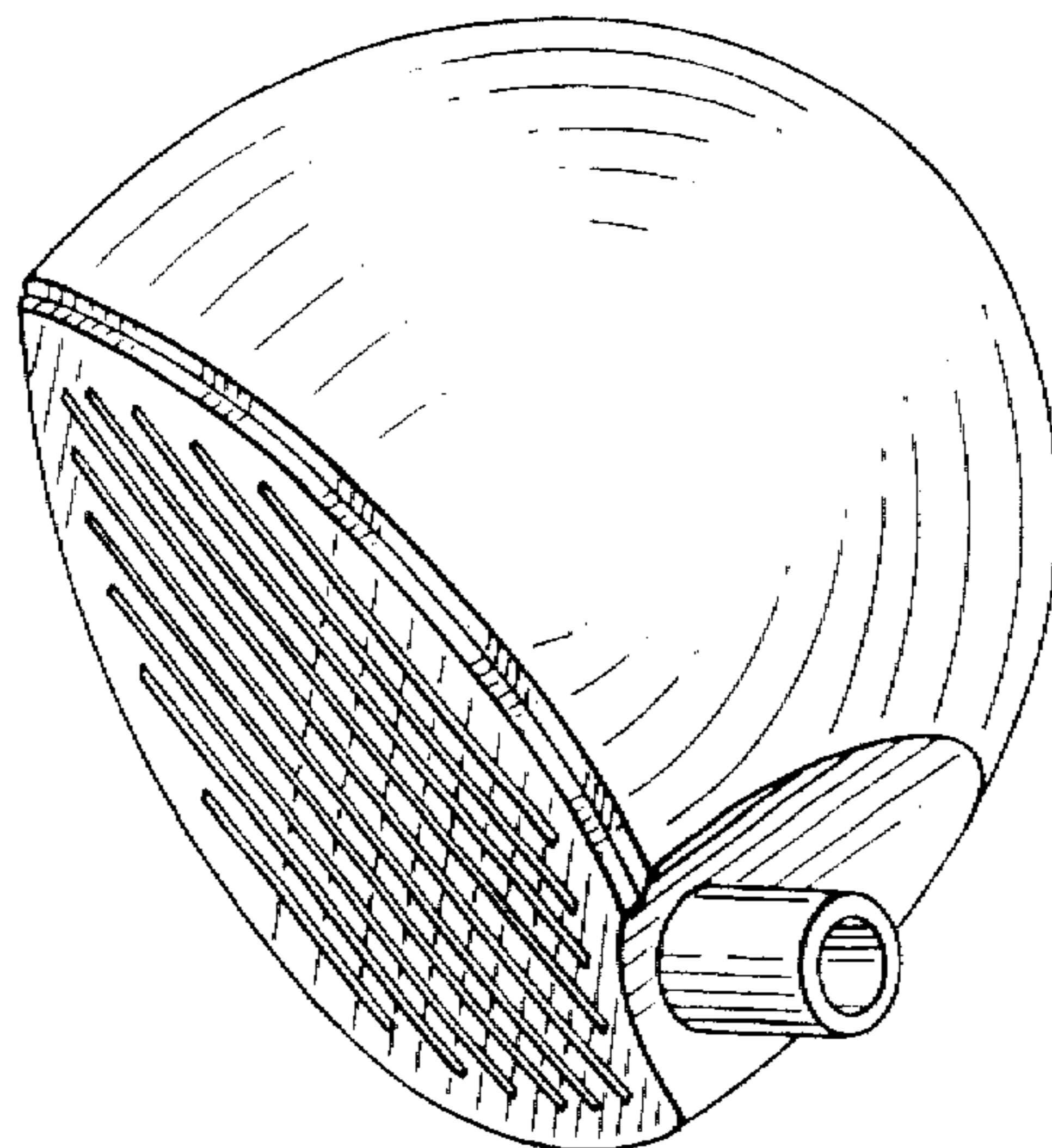
[57] **CLAIM**

The ornamental design for a clubhead, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a clubhead showing our new design;
FIG. 2 is a bottom perspective view of the clubhead;
FIG. 3 is a top plan view of the clubhead;
FIG. 4 is a front elevational view of the clubhead;
FIG. 5 is a left end view of the clubhead;
FIG. 6 is a right end view of the clubhead;
FIG. 7 is a bottom plan view of the clubhead; and,
FIG. 8 is a rear elevational view of the clubhead.

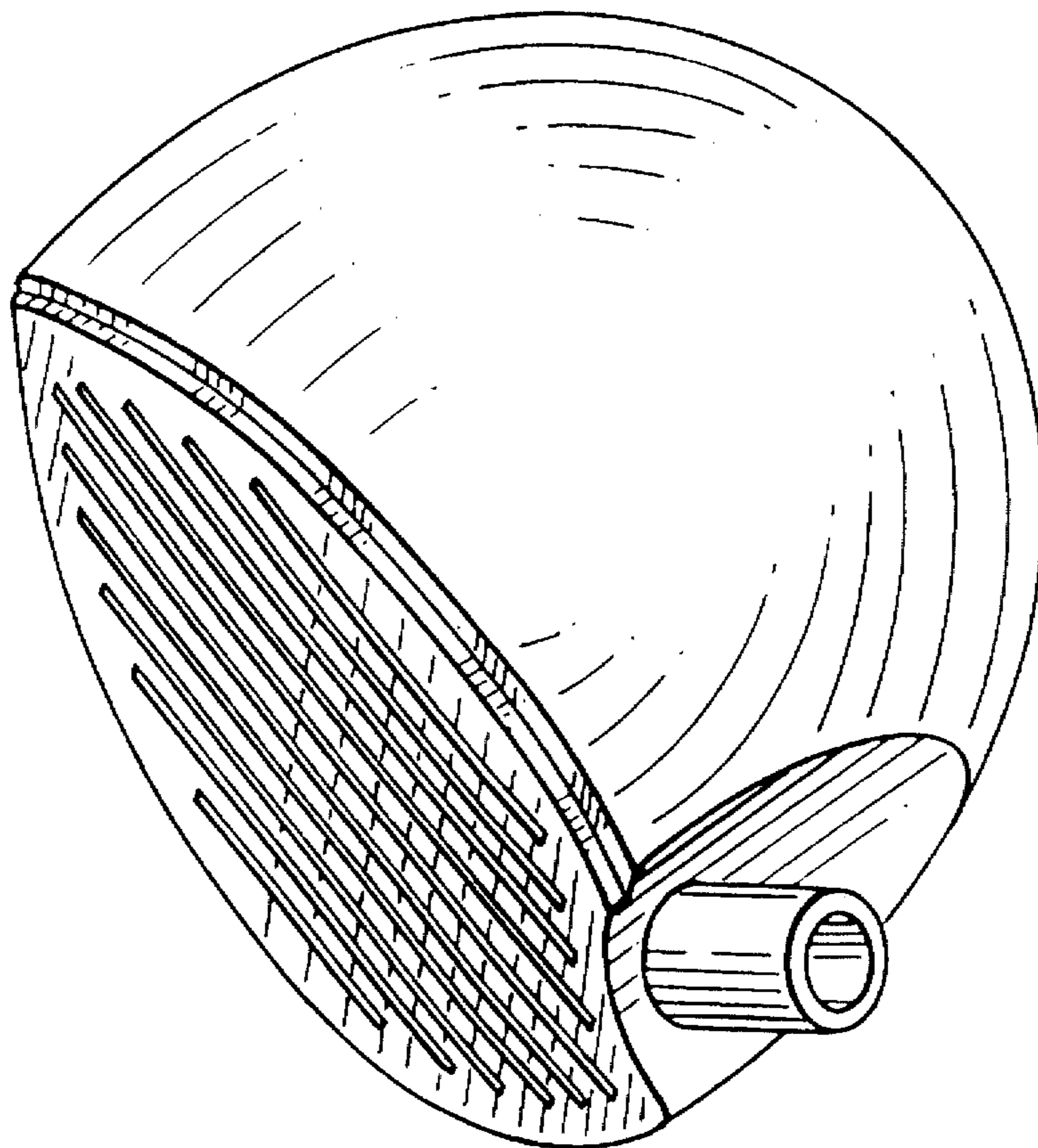

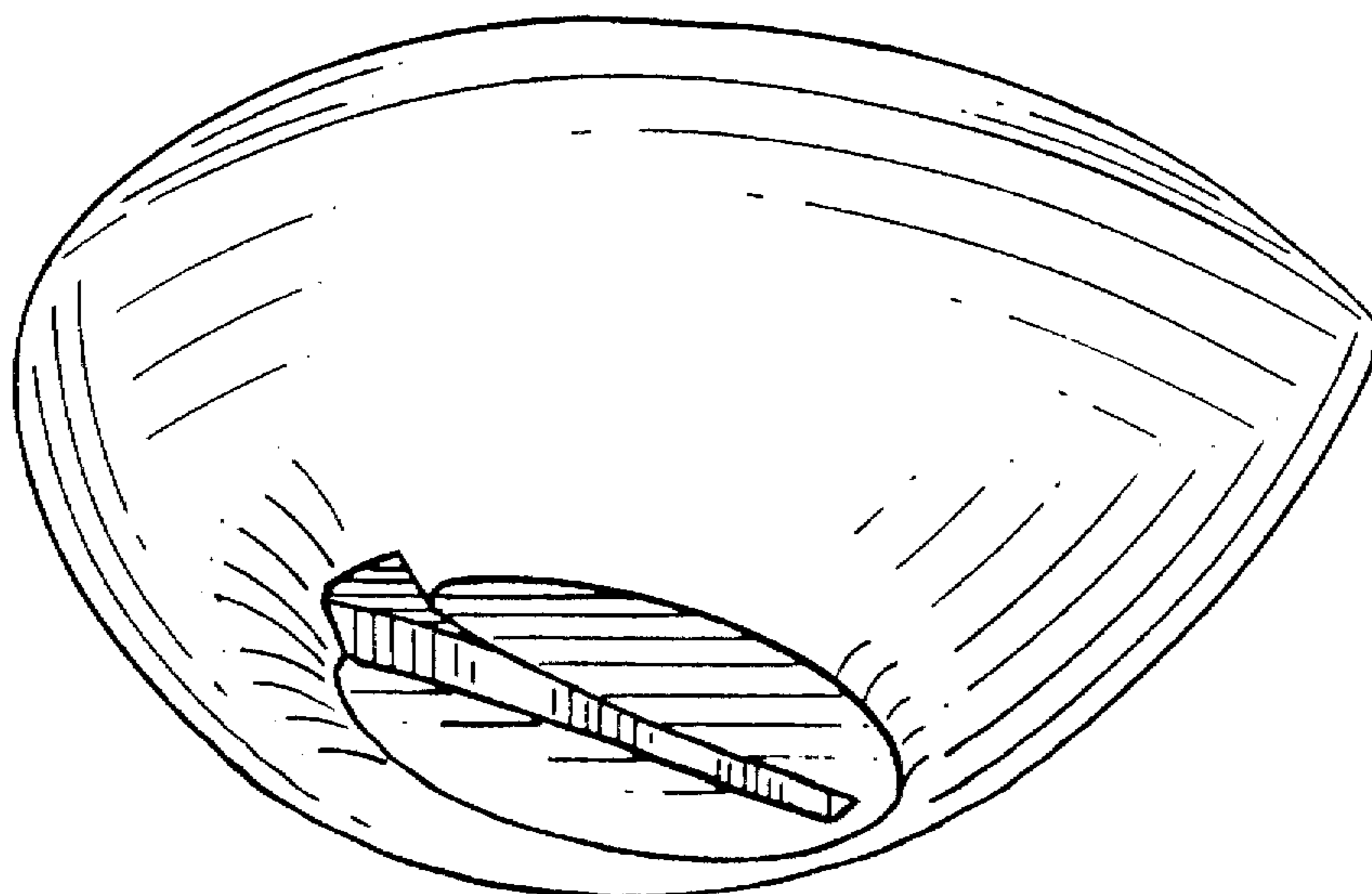

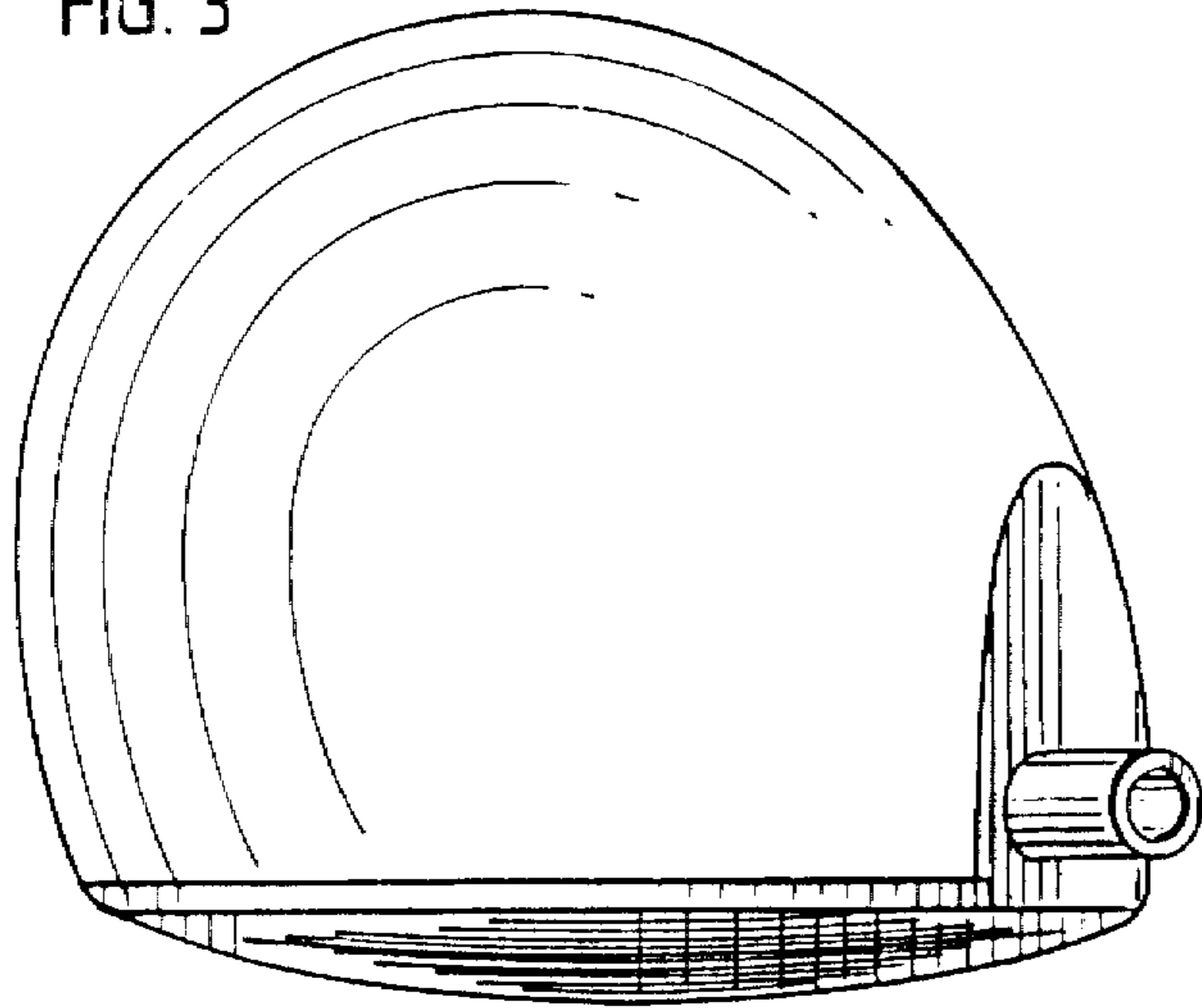

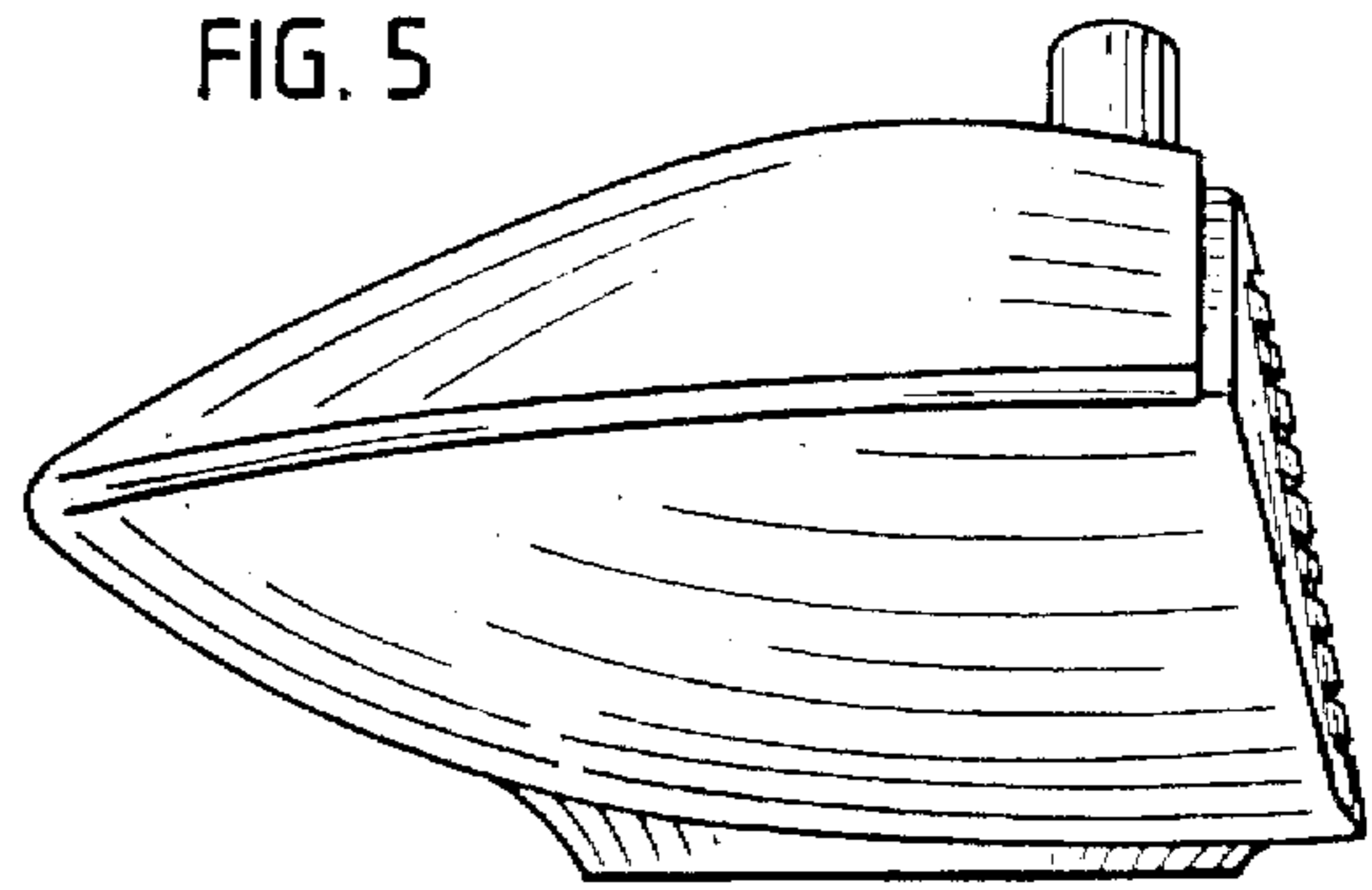

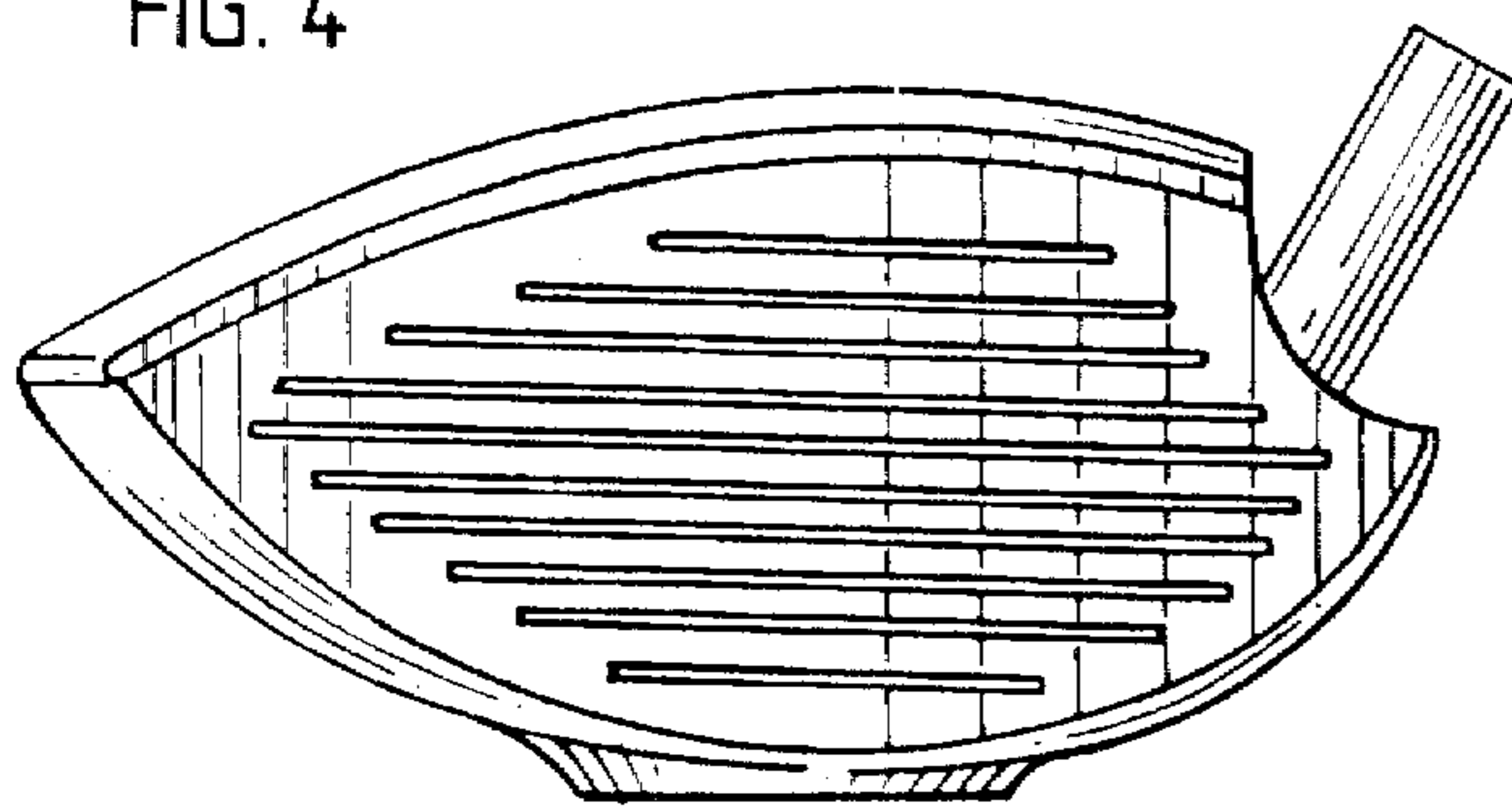

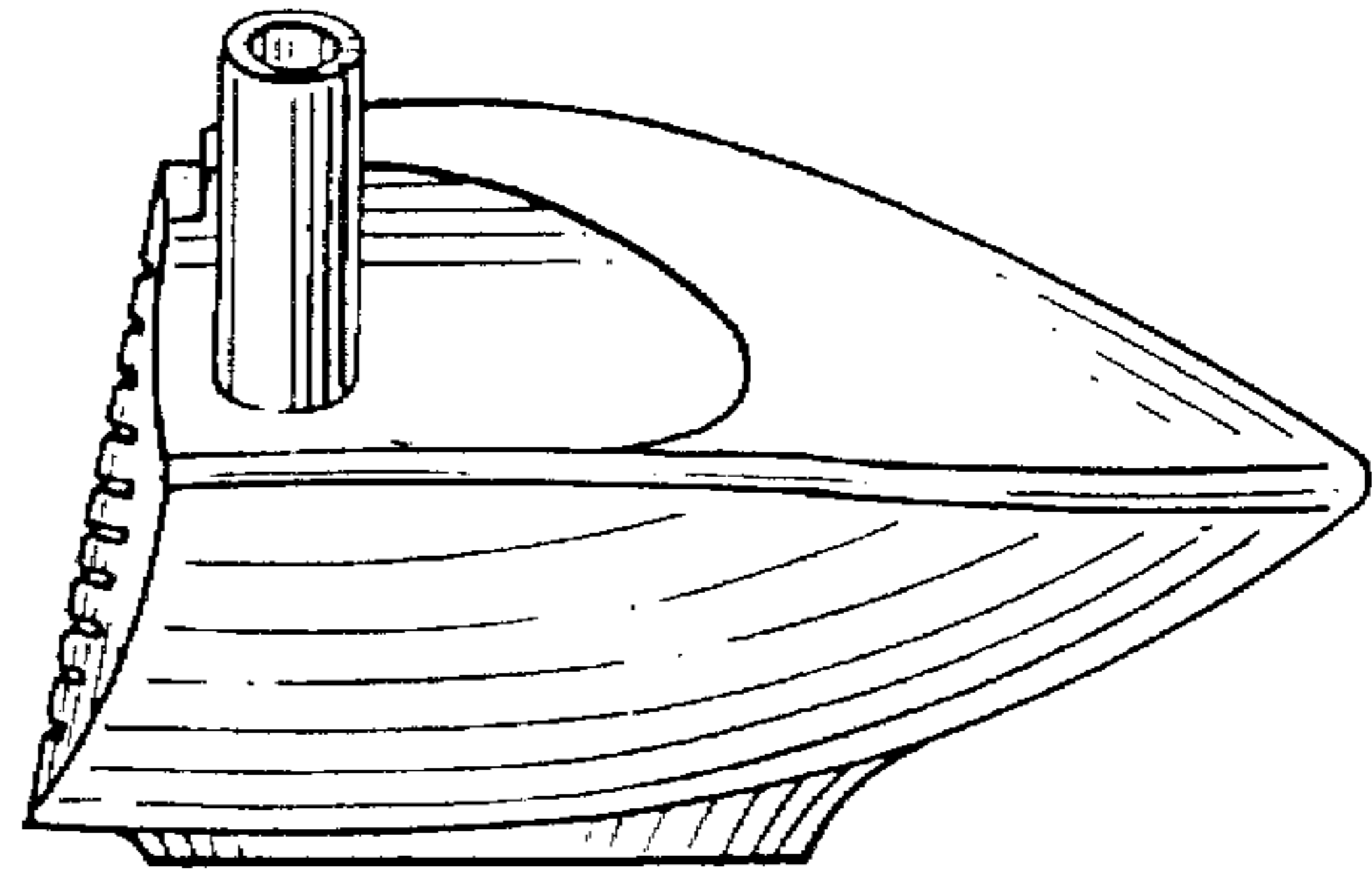

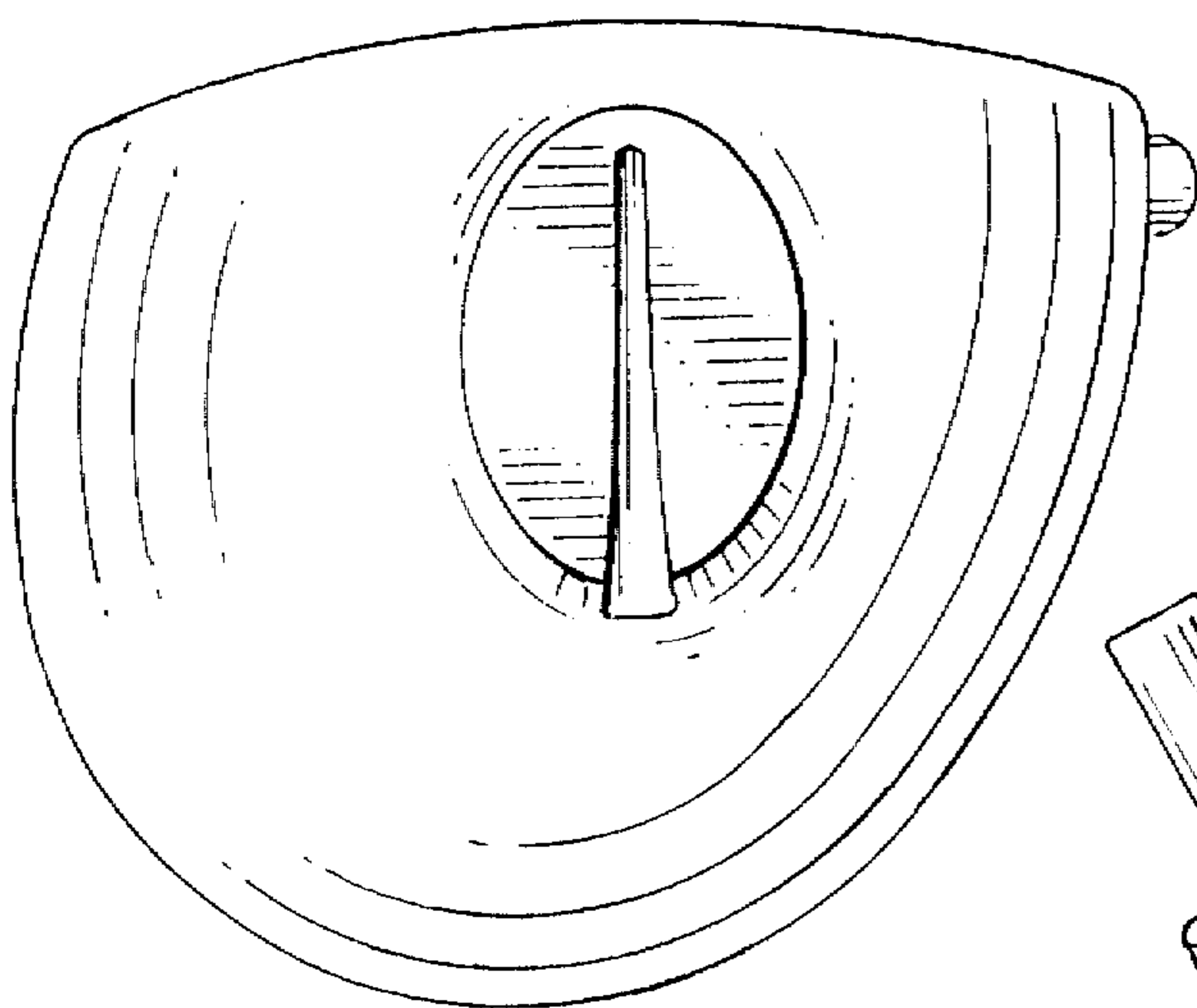
