[57] **CLAIM**

The ornamental design for a linen cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a linen cabinet showing my new design;

FIG. 2 is a front elevational view of a linen cabinet showing my new design;

FIG. 3 is a right side elevational view, the left side elevational view is a mirror image thereof;

FIG. 4 is a top plan view;

FIG. 5 is an enlarged fragmentary cross-sectional view taken along line 5—5 of FIG. 2 to better illustrate the contour;

FIG. 6 is an enlarged fragmentary cross-sectional view taken along line 6—6 of FIG. 2 to better illustrate the contour;

FIG. 7 is an enlarged fragmentary cross-sectional view taken along line 7—7 of FIG. 2 to better illustrate the contour;

FIG. 8 is an enlarged fragmentary cross-sectional view taken along line 8—8 of FIG. 2 to better illustrate the contour;

FIG. 9 is an enlarged fragmentary cross-sectional view taken along line 9—9 of FIG. 2 to better illustrate the contour;

FIG. 10 is an enlarged fragmentary cross-sectional view taken along line 10—10 of FIG. 2 to better illustrate the contour;

FIG. 11 is an enlarged fragmentary view of a portion of the cabinet header taken in the direction of lines 11—11 of FIG. 5 to illustrate the appearance thereof;

FIG. 12 is an enlarged broken profile view of a cabinet door to better illustrate the contour thereof;

FIG. 13 is a cross-sectional view of FIG. 12 taken along lines 13—13 to better illustrate the contour thereof;

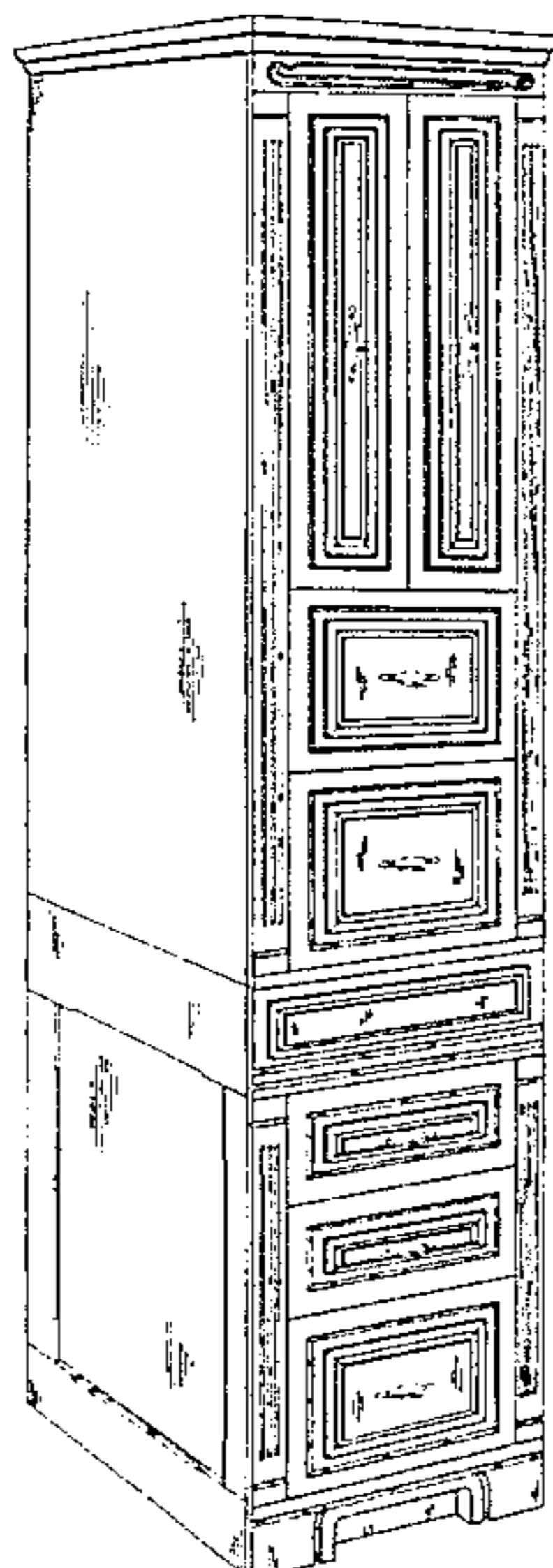
FIG. 14 is an enlarged side profile view of a drawer panel to better illustrate the contour thereof;

FIG. 15 is an enlarged profile view of a drawer panel taken in the direction of lines 15—15 of FIG. 14 to better illustrate the contour thereof; and,

FIG. 16 is an enlarged fragmentary view of a portion of the pilasters of the cabinet to better illustrate the appearance thereof.

The rear and bottom of the cabinet are flat and unornamented.

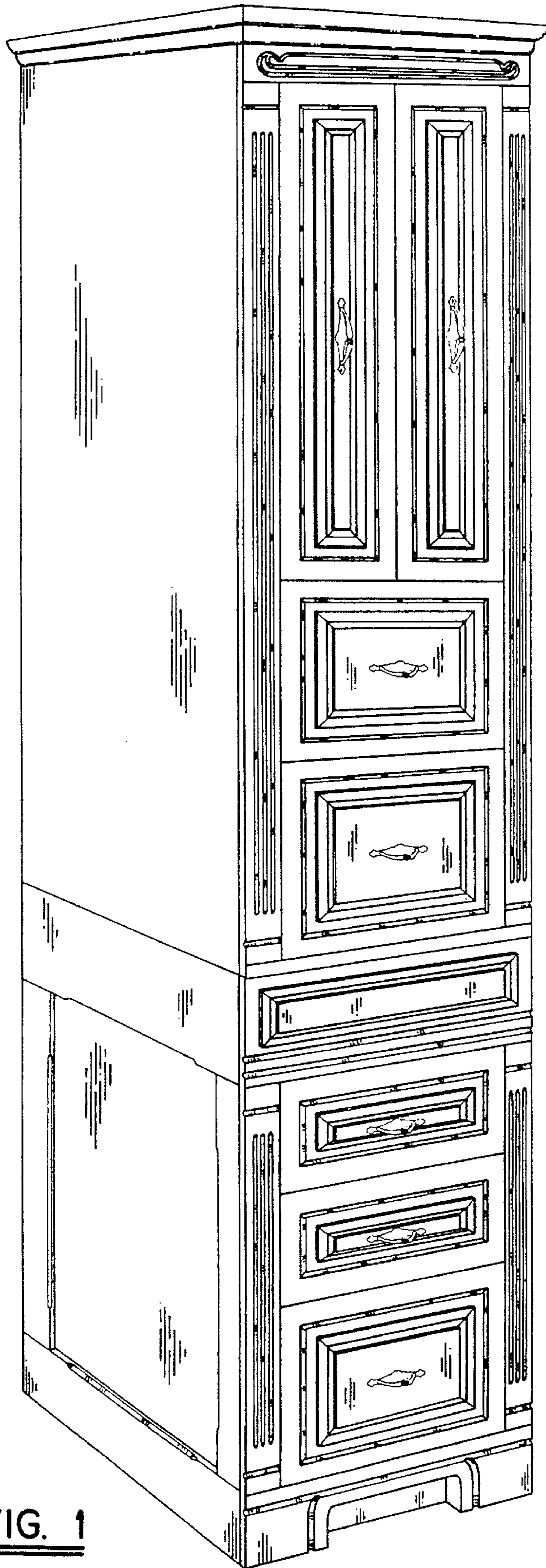

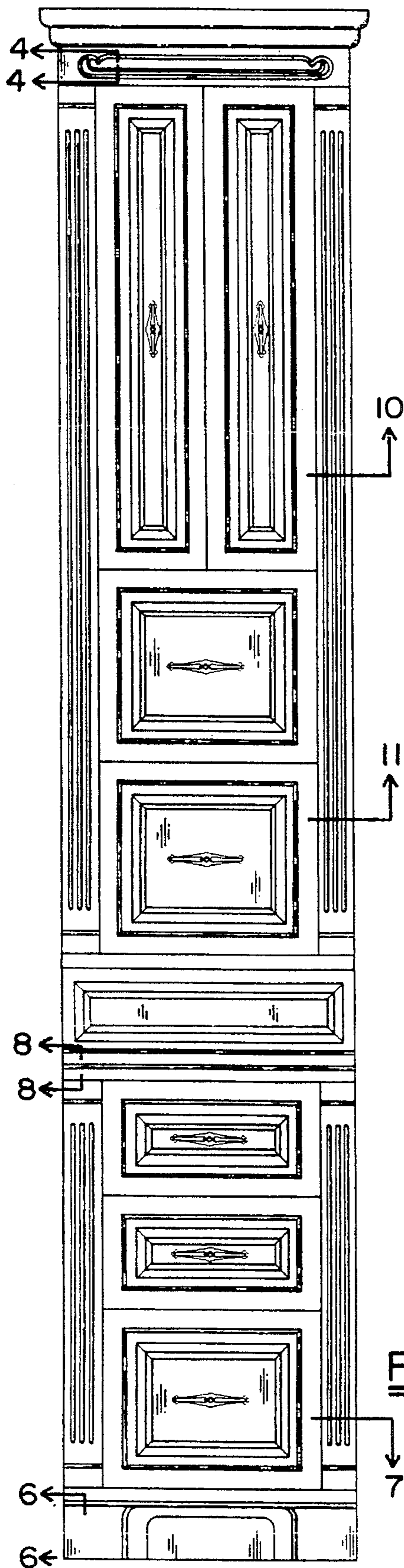

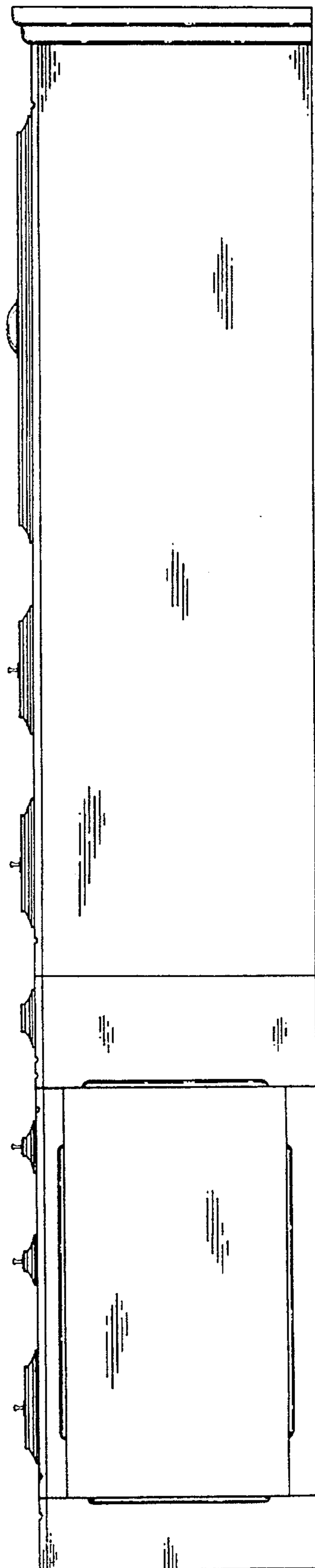

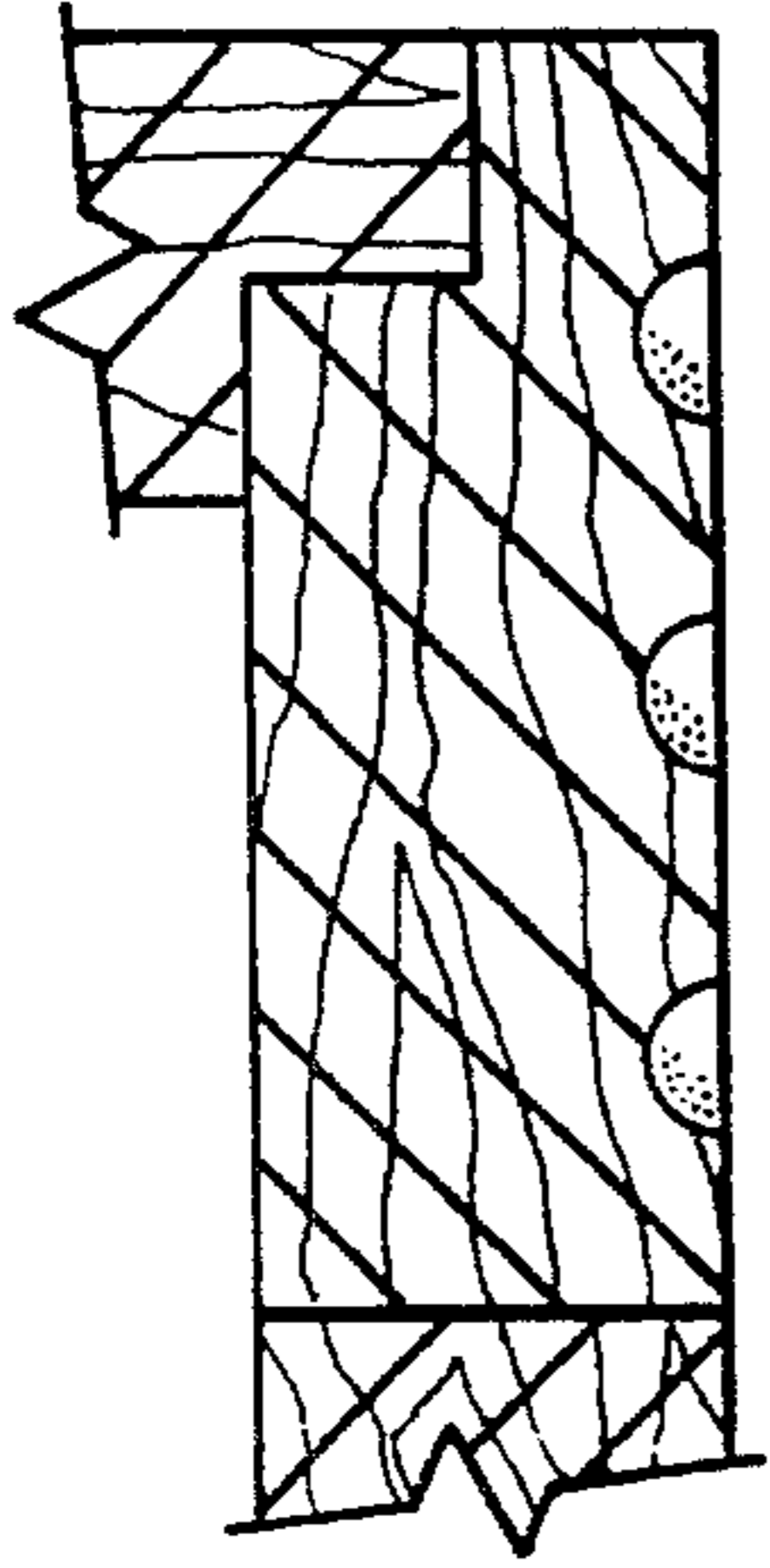

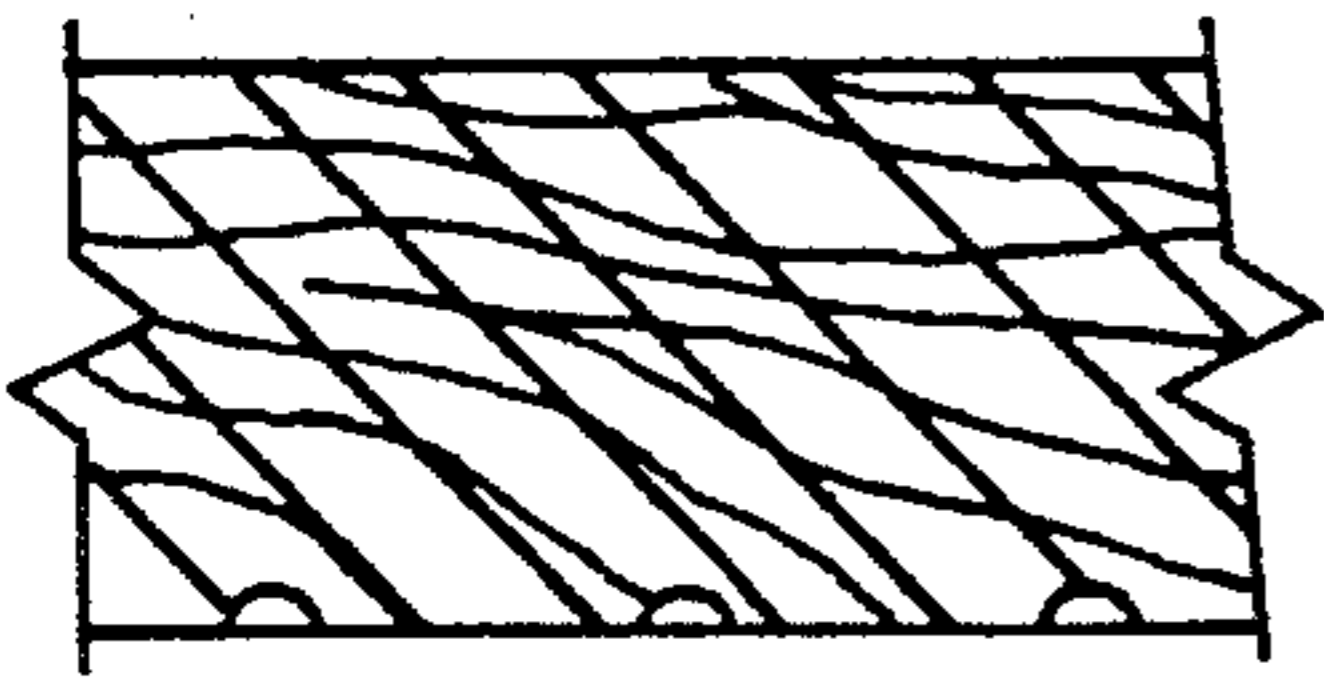

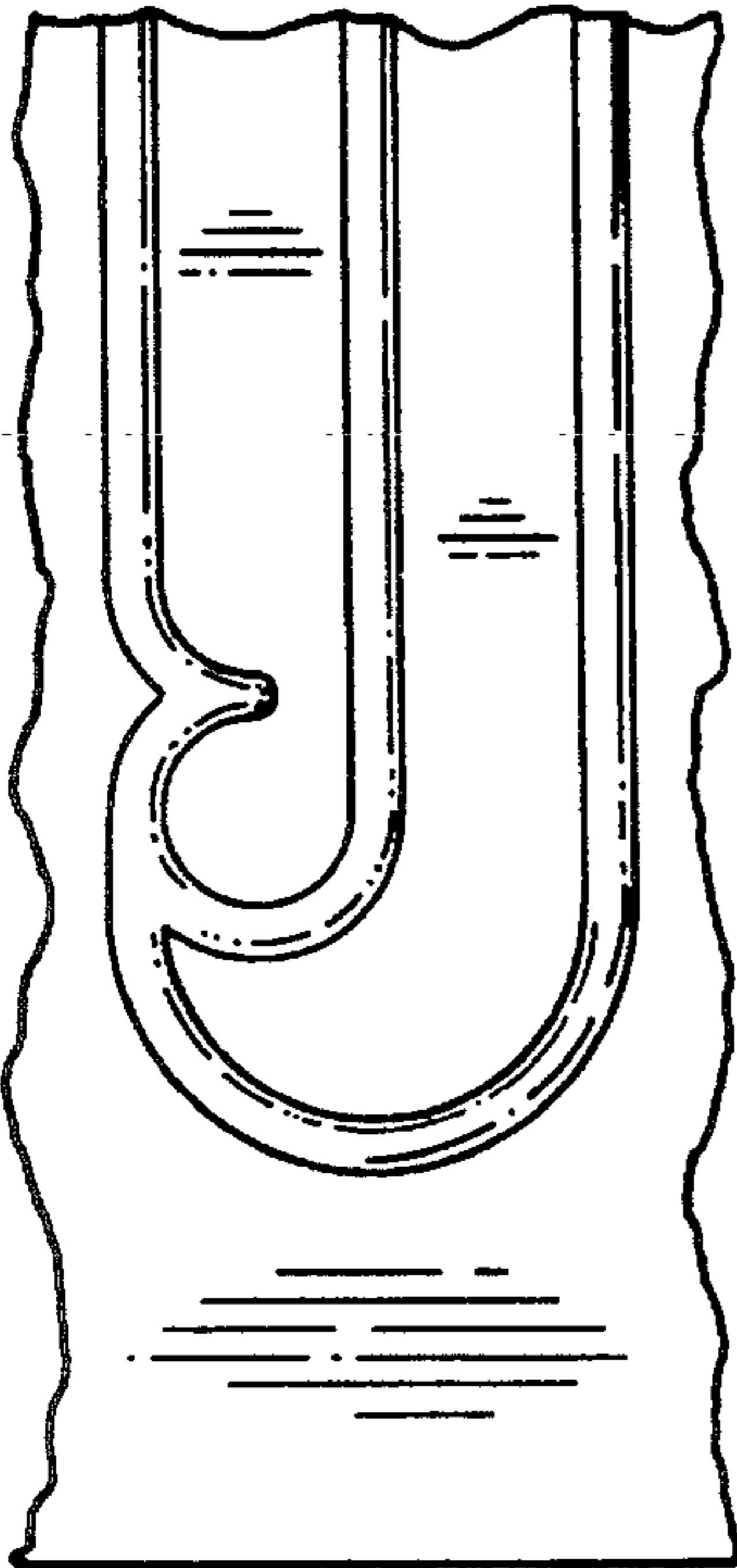

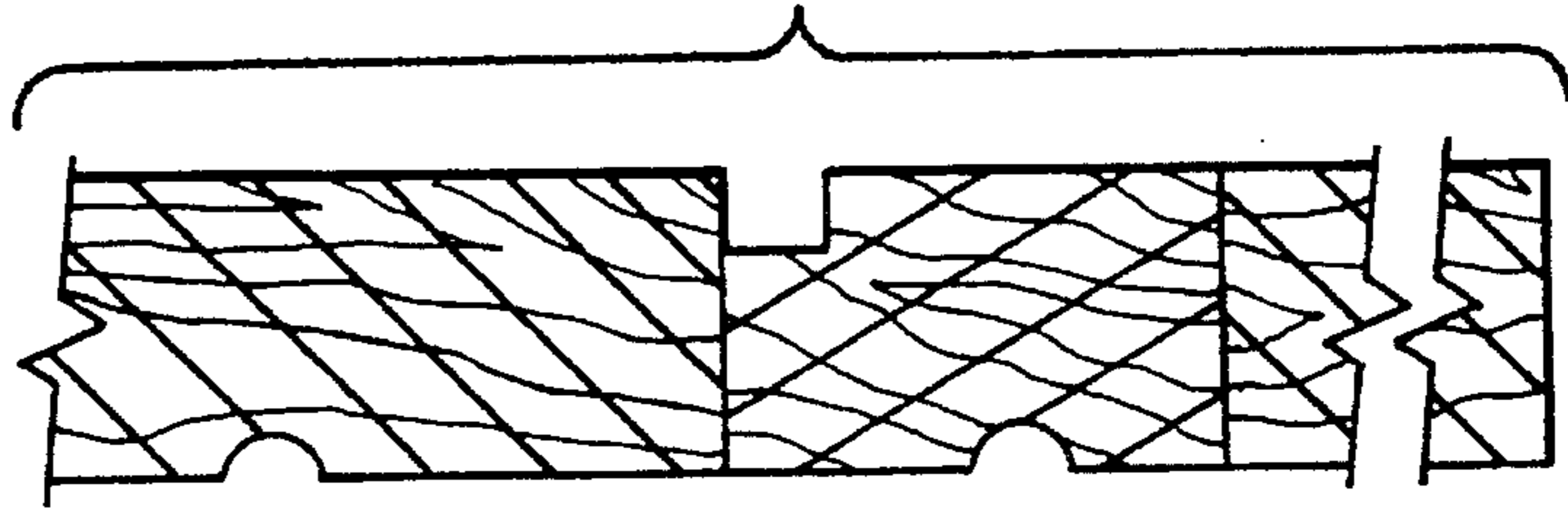

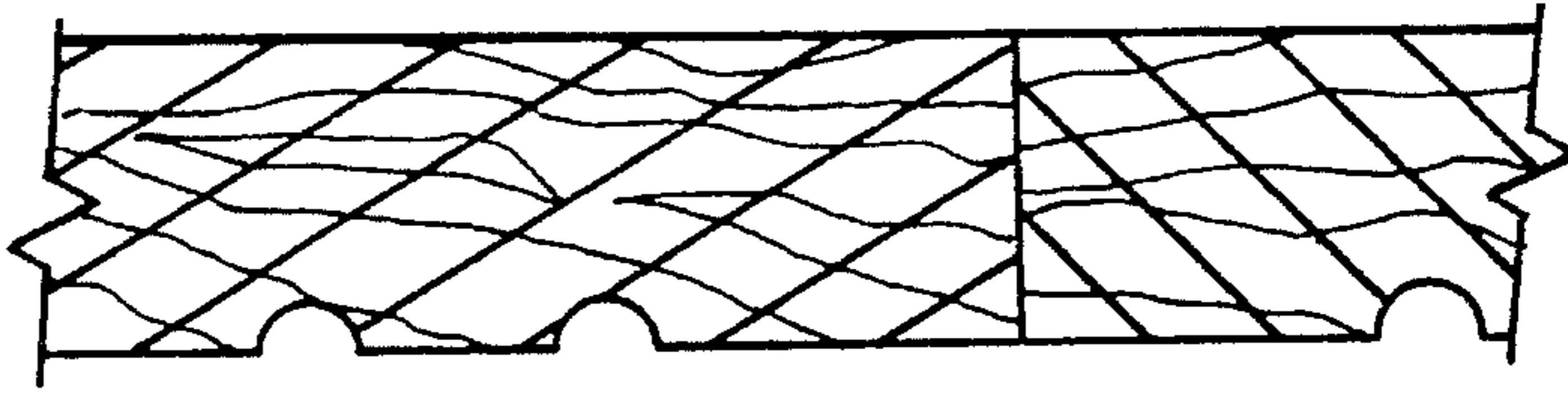

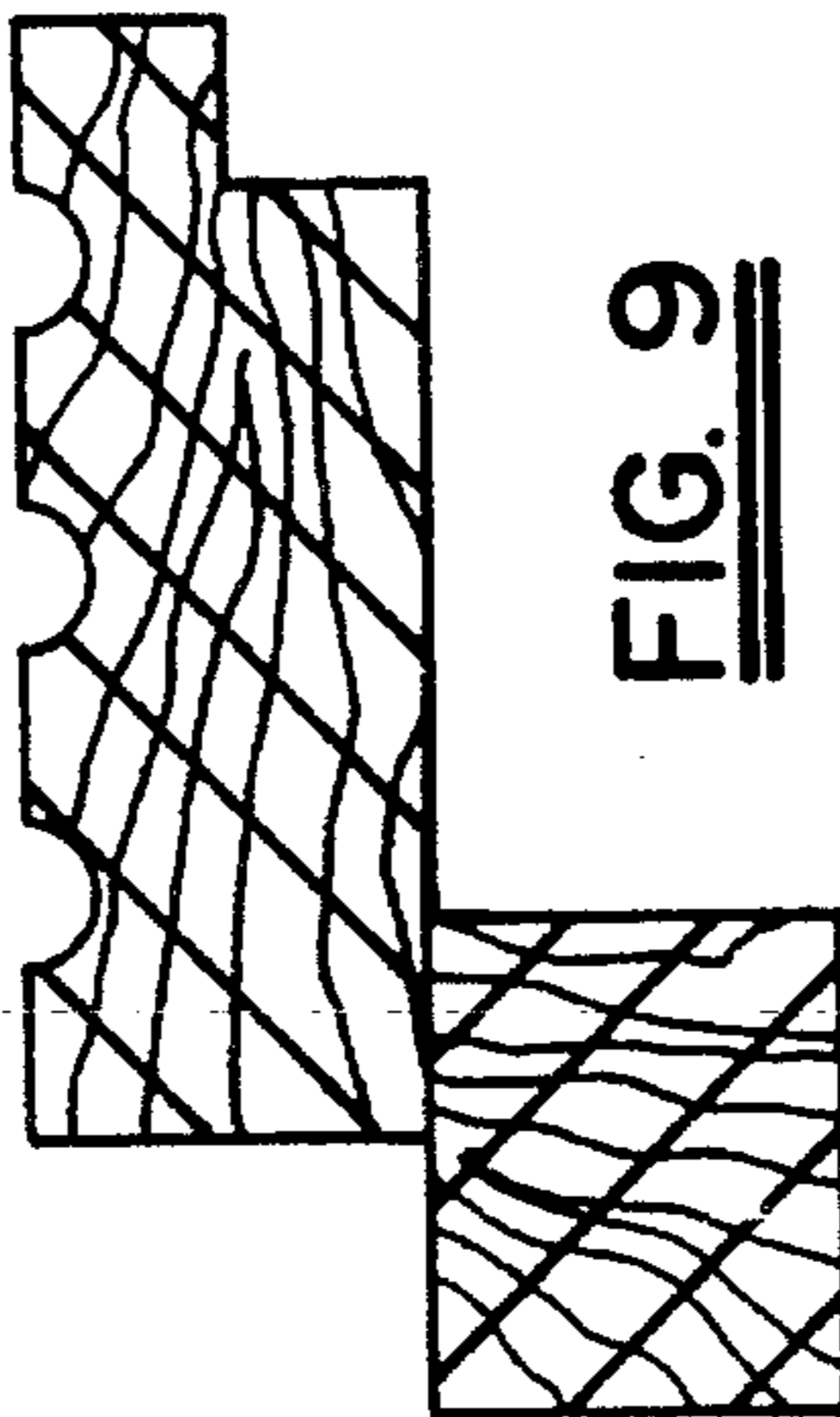

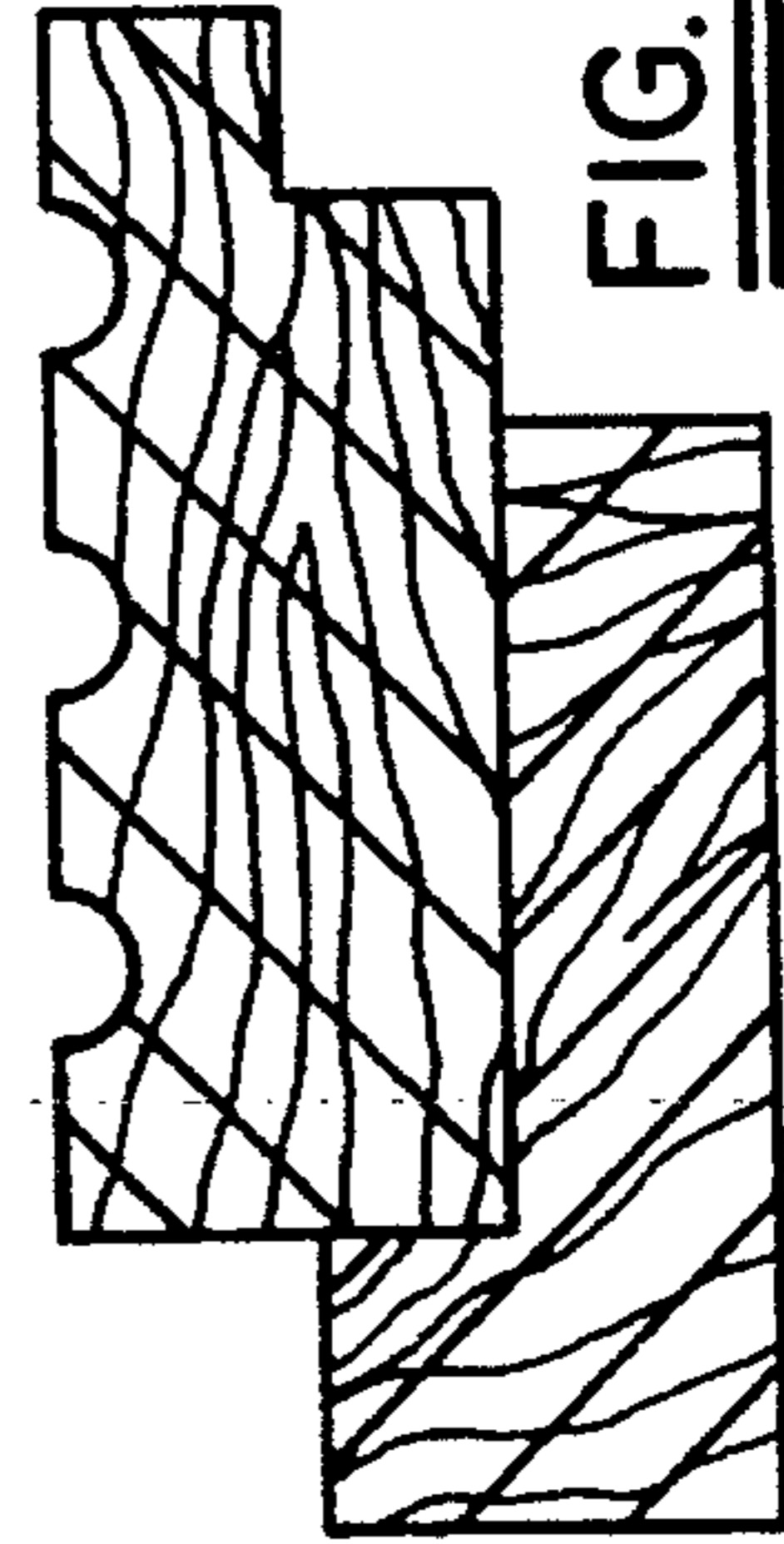

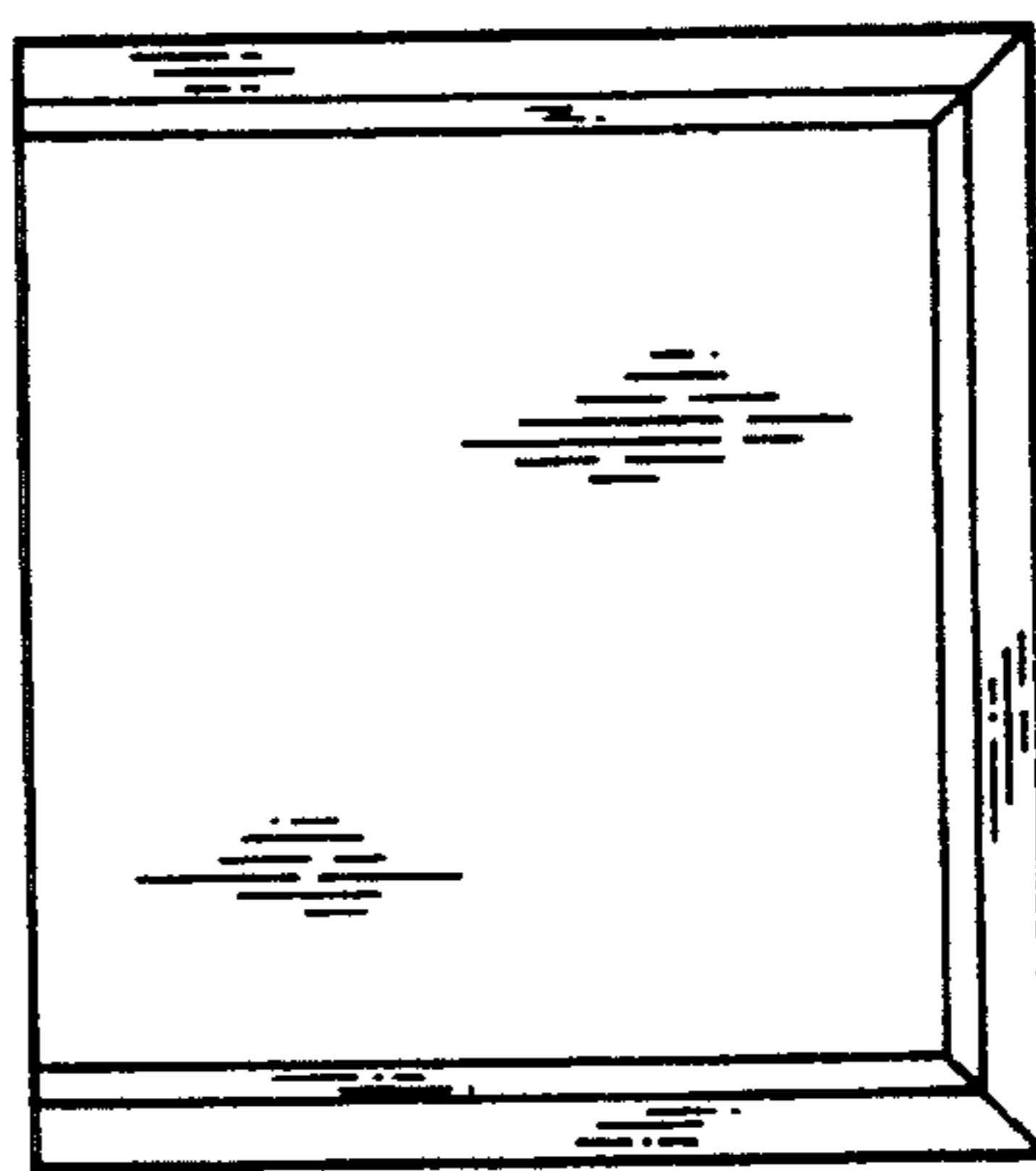

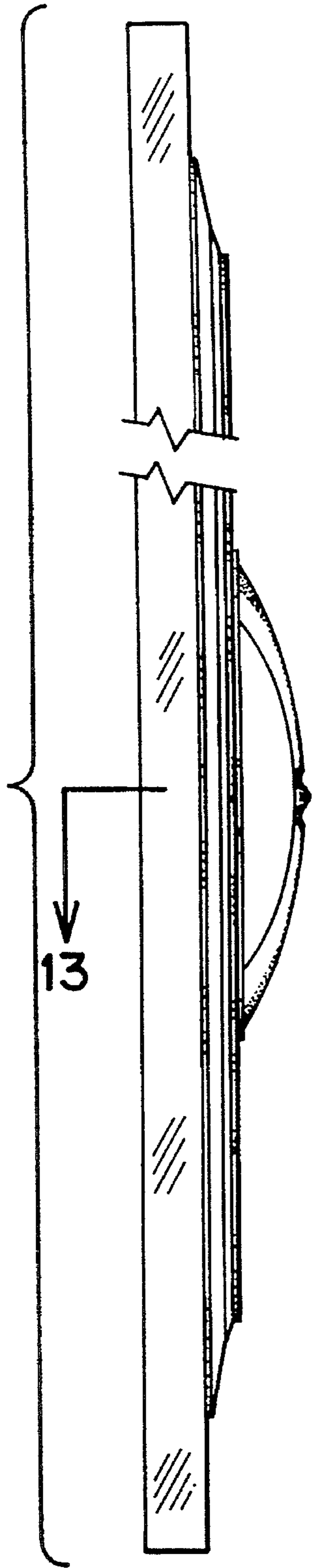

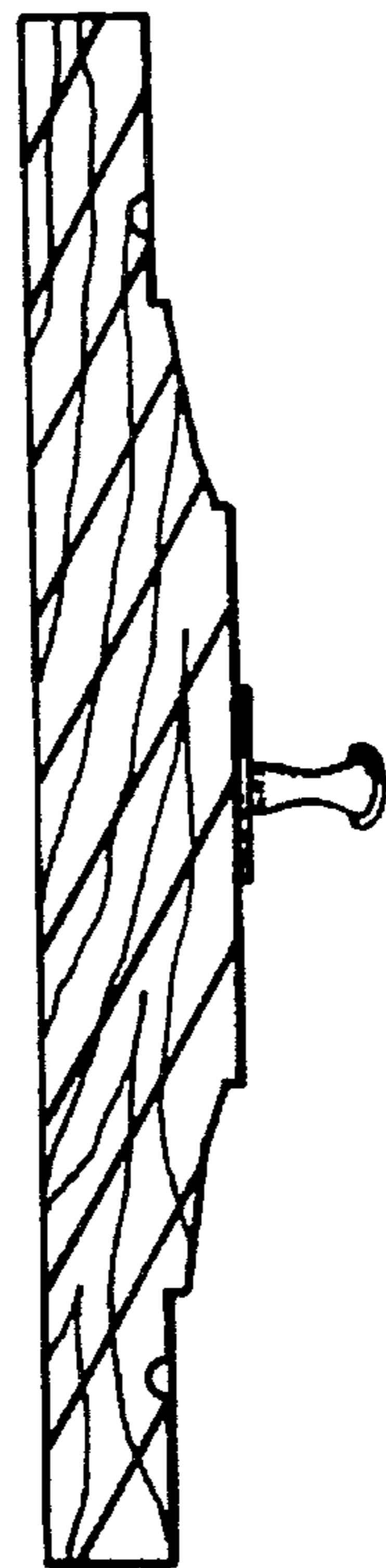

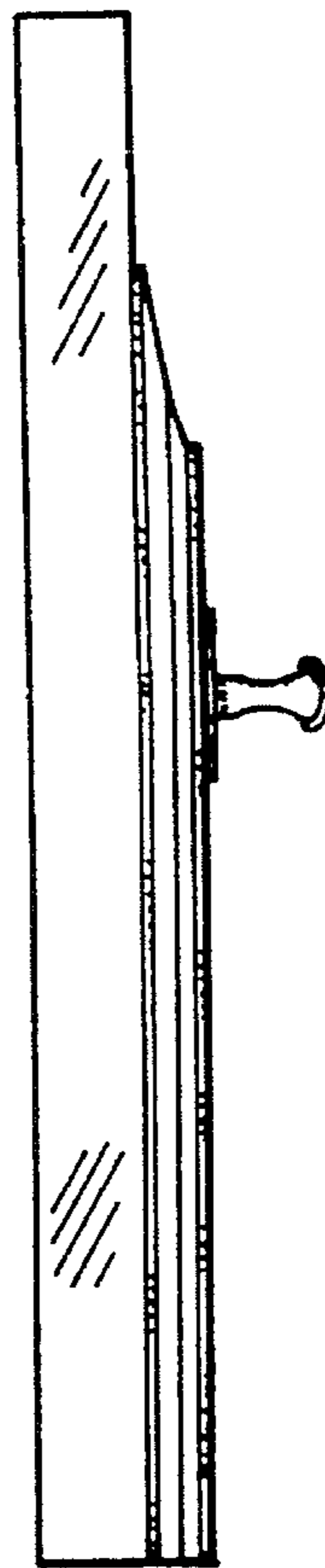

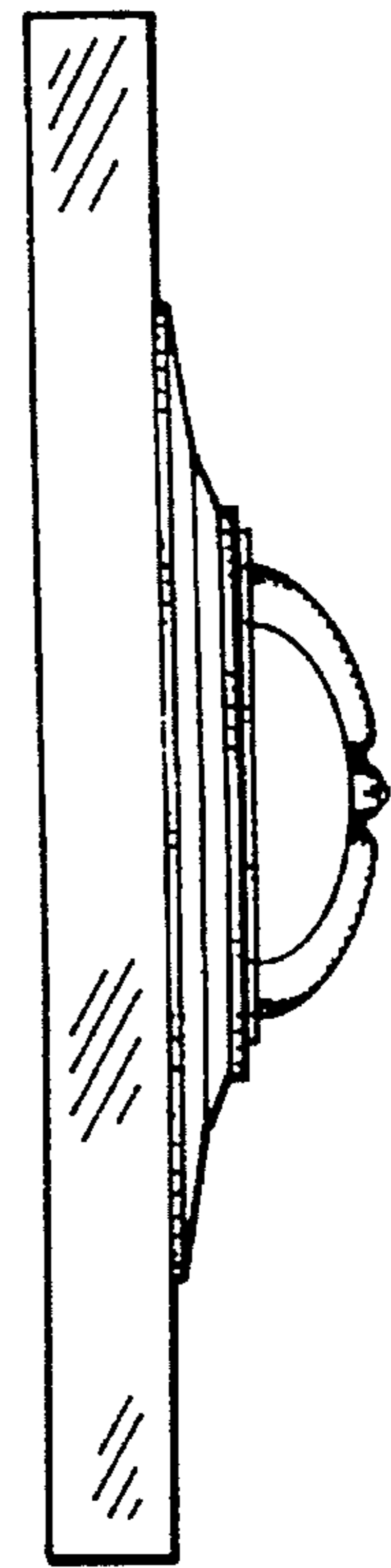

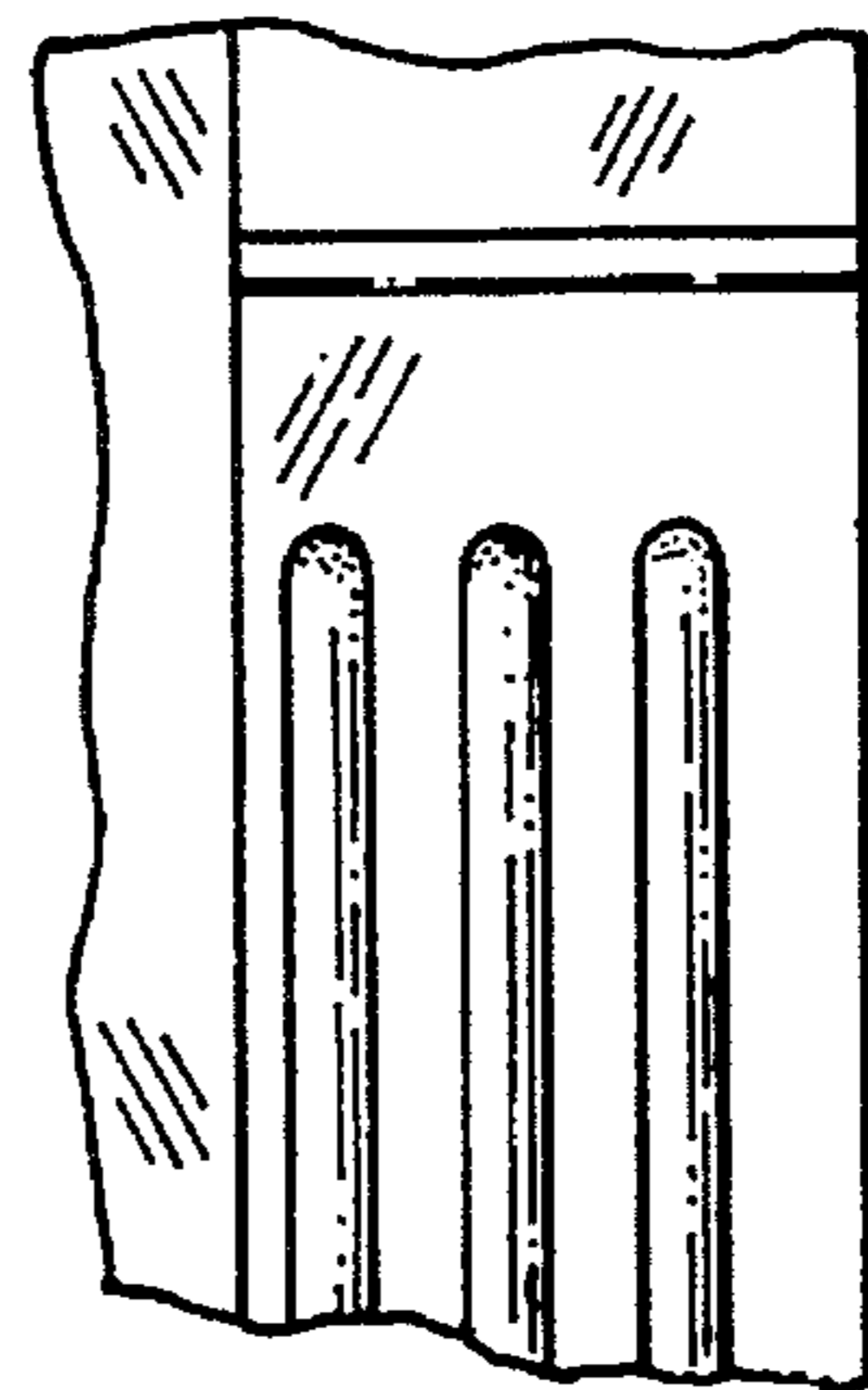
