### [57] CLAIM

The ornamental design for a lighted sign assembly for an automatic teller machine, as shown and described.

### DESCRIPTION

FIG. 1 is a front view of a lighted sign assembly for an automatic teller machine showing our new design; FIG. 2 is a right side elevational view; FIG. 3 is a front, top left side perspective of the lighted sign assembly with respect to which FIGS. 1, 2 and 4; FIG. 4 is a rear view of the lighted sign assembly of FIGS. 1, 2 and 3; FIG. 5 is a front view of another embodiment of a lighted sign assembly for an automatic teller machine showing our new design; FIG. 6 is a right side elevational view; FIG. 7 is a front, top left side perspective of the lighted sign assembly with respect to which FIGS. 5, 6 and 8 relate; and, FIG. 8 is a rear view of the lighted sign assembly of FIGS. 5-7.

The bottom surface of the lighted sign assembly shown in FIGS. 1-4 is flat and unadorned.

The bottom surface of the lighted sign assembly shown in FIGS. 5-8 is flat and unadorned.

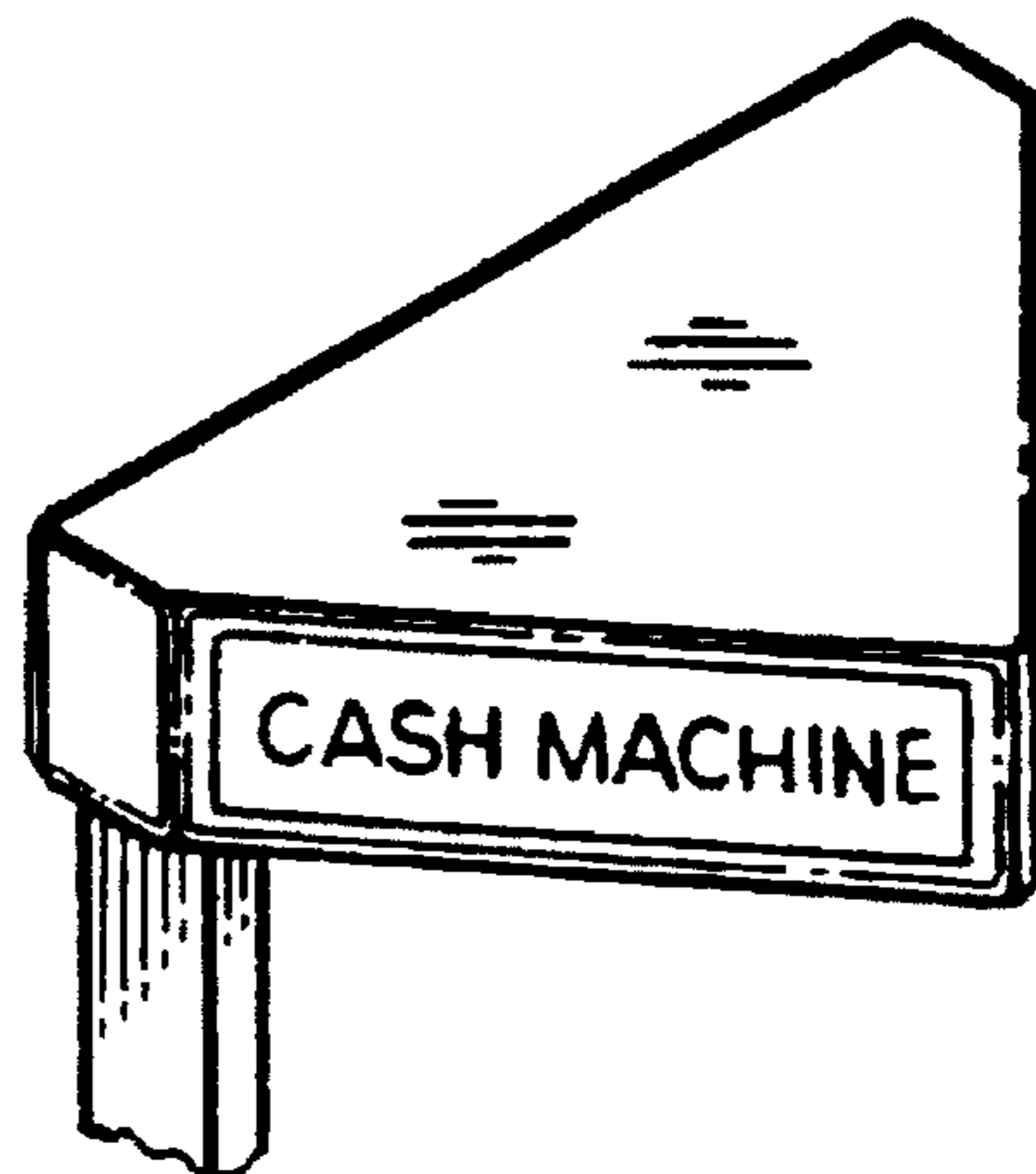
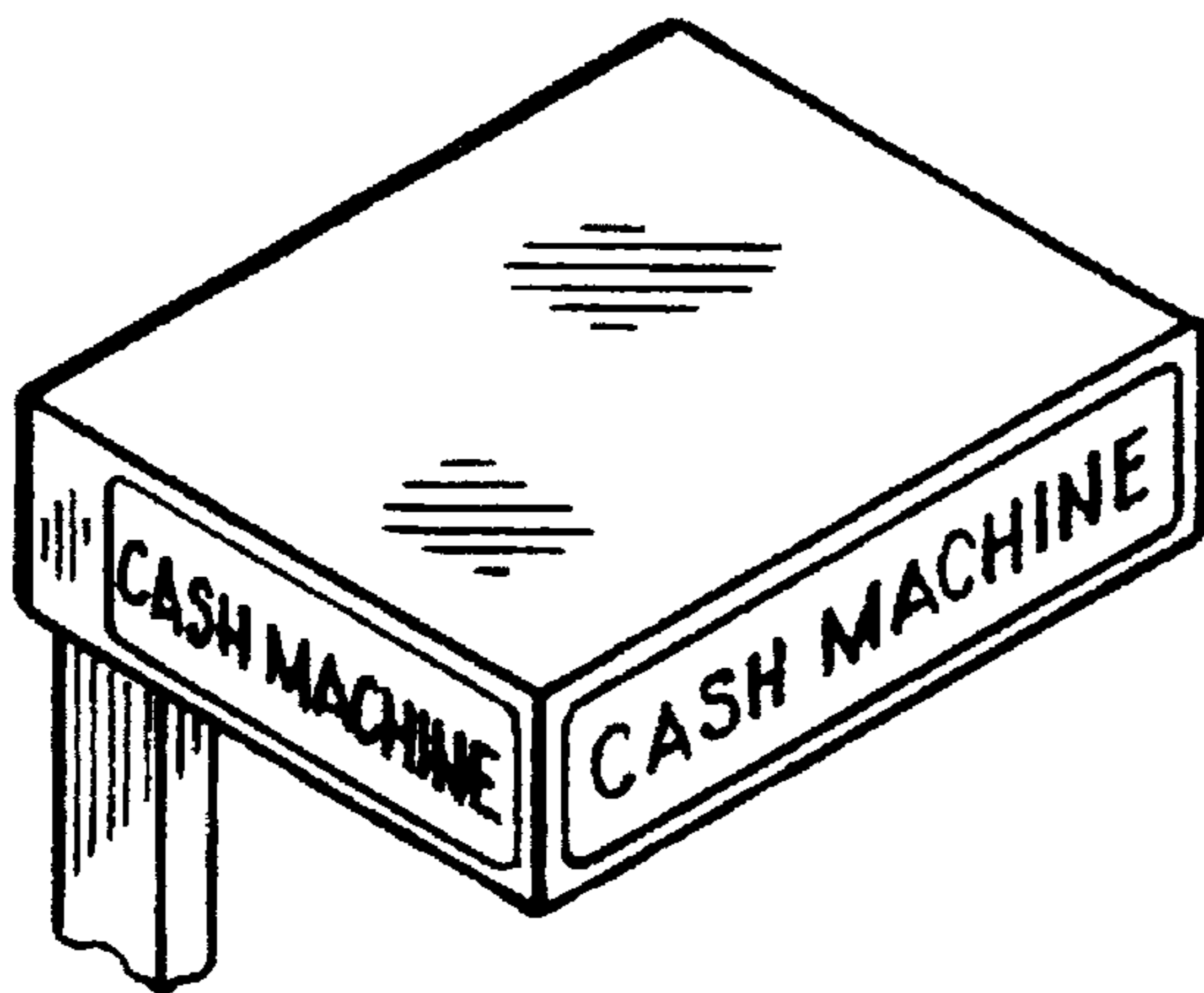

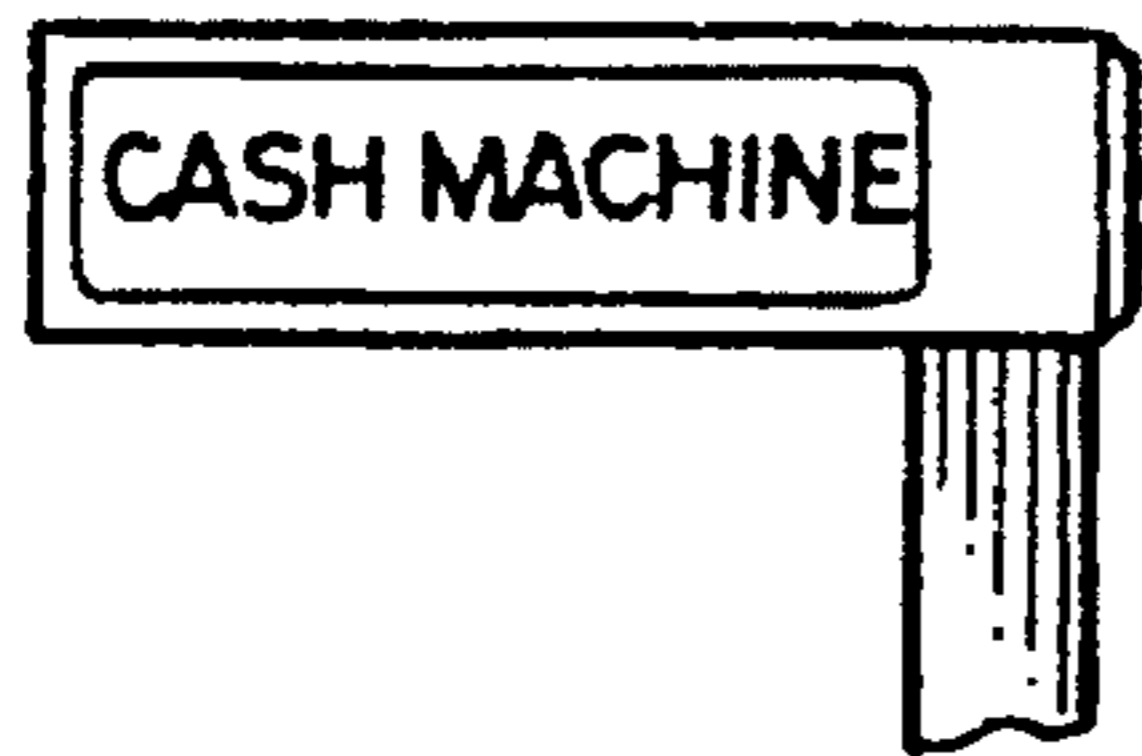

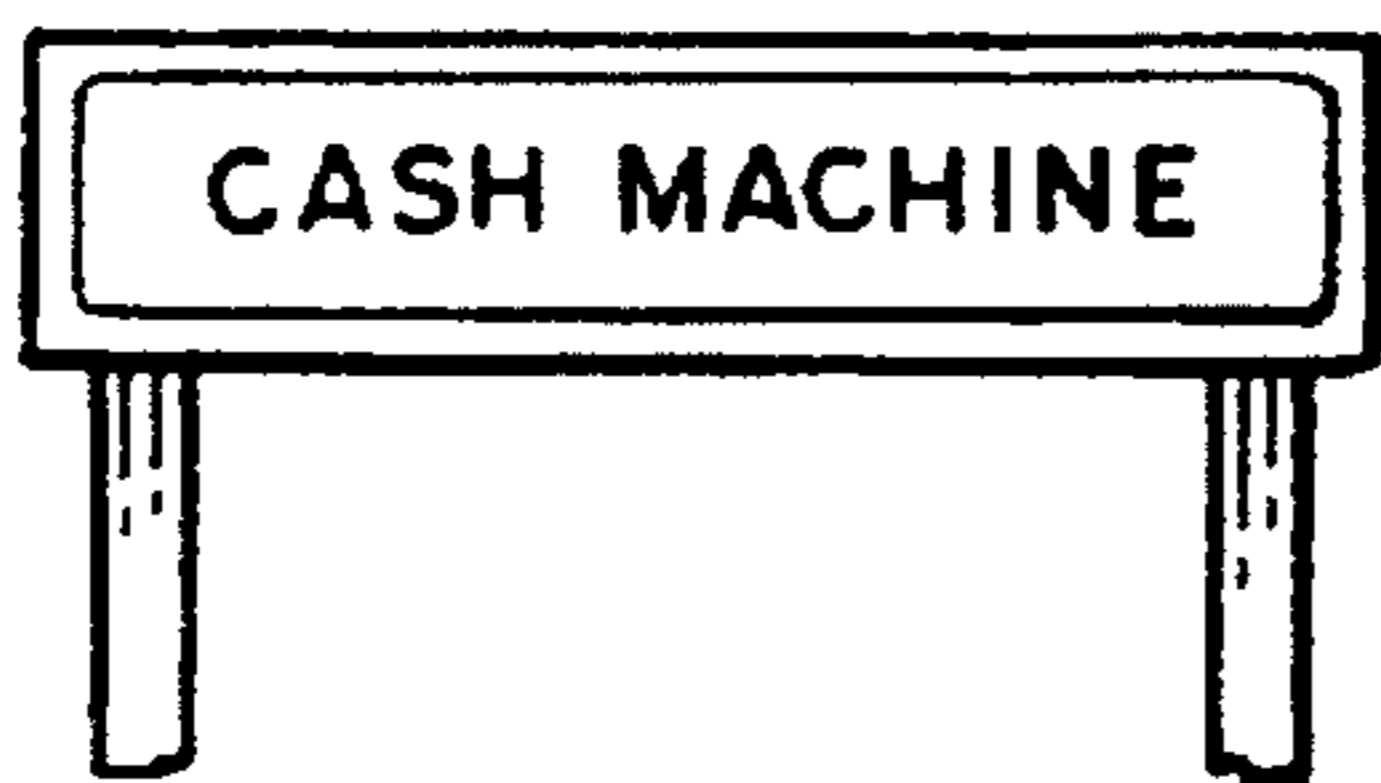

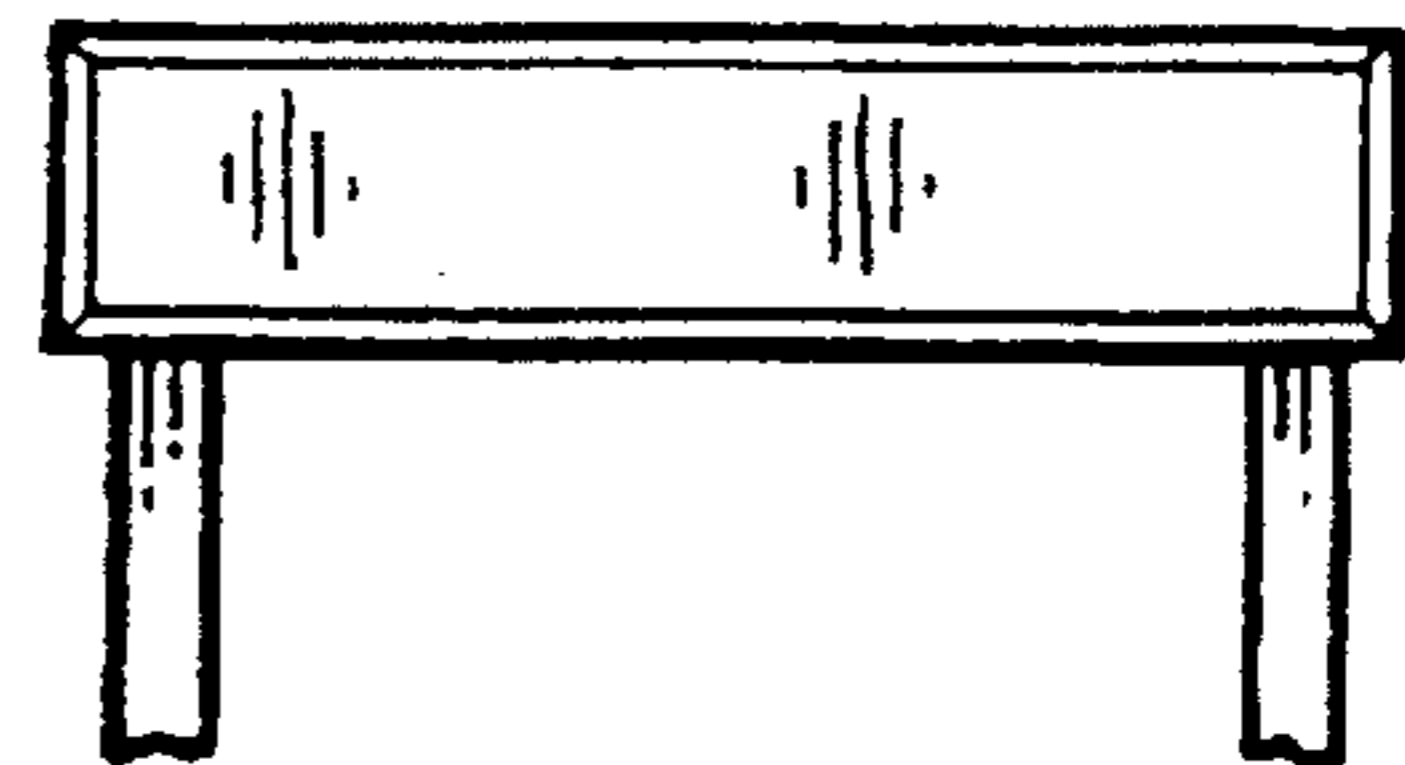

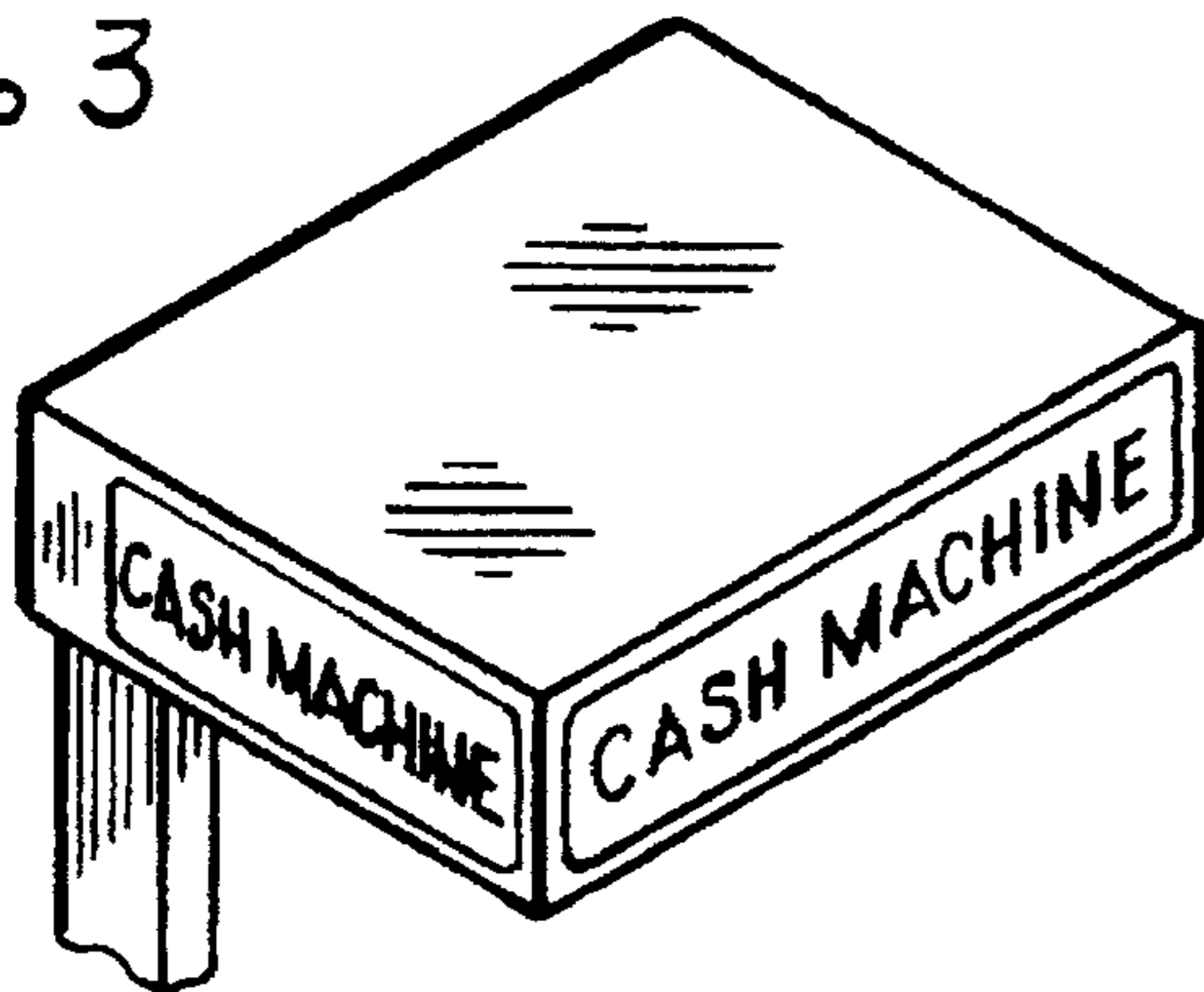

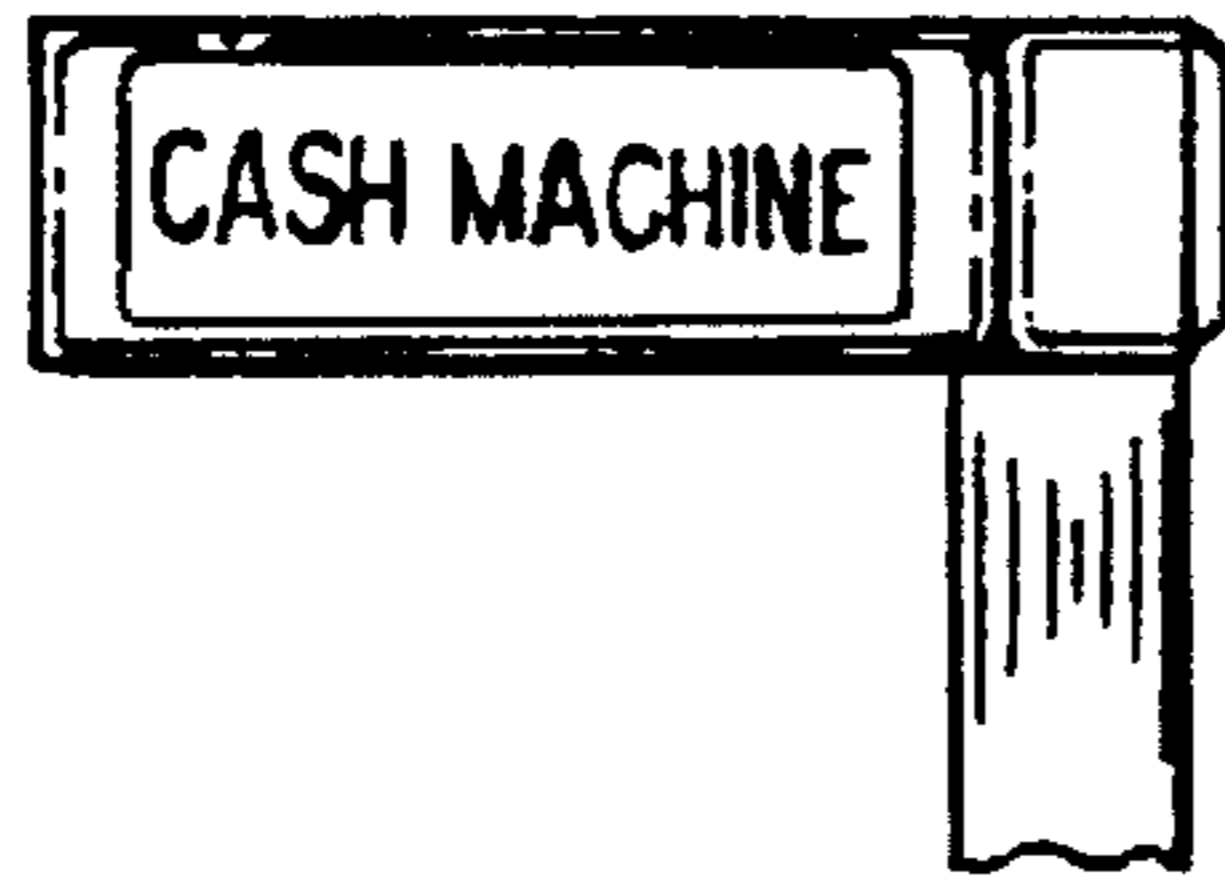

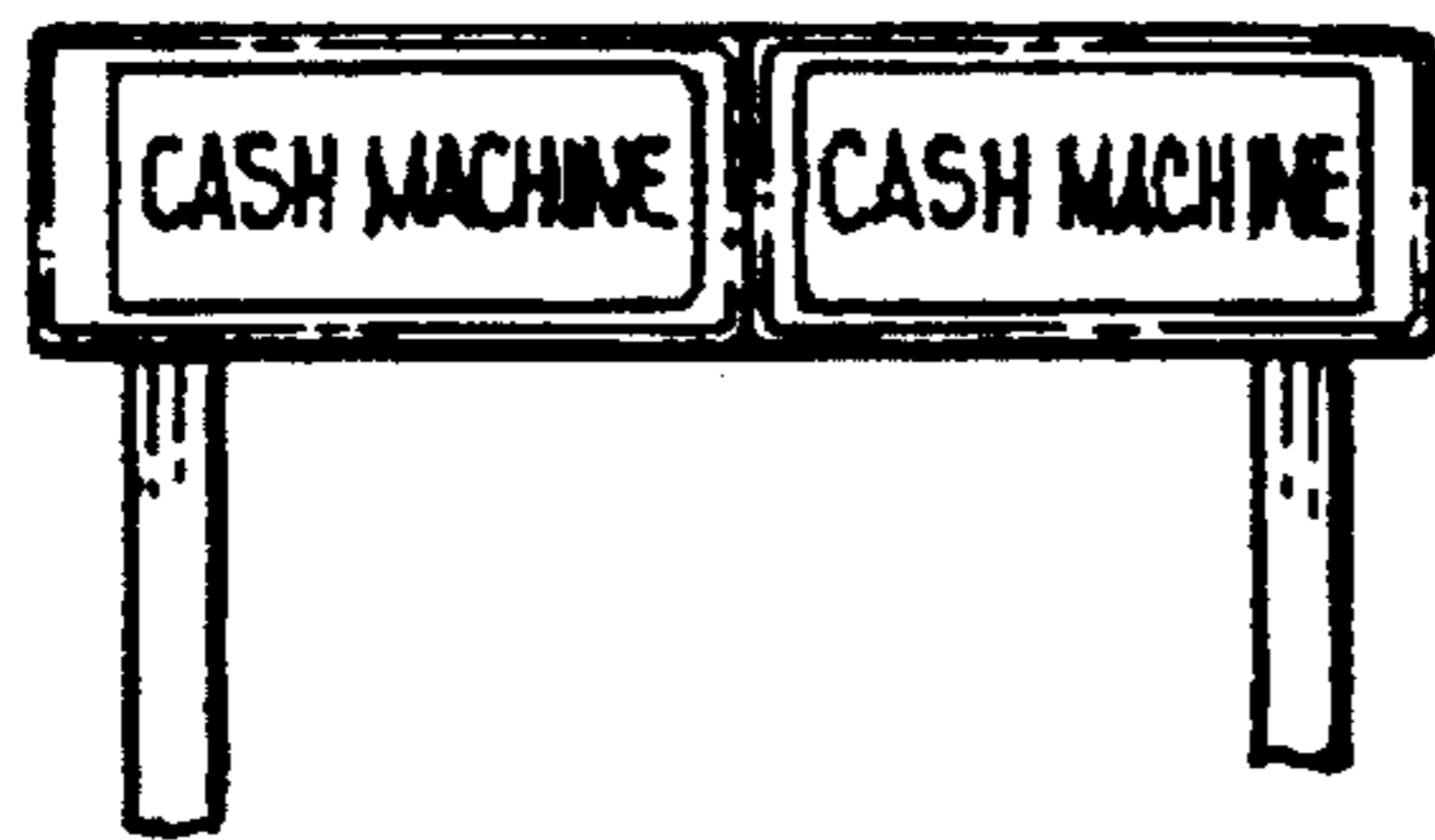

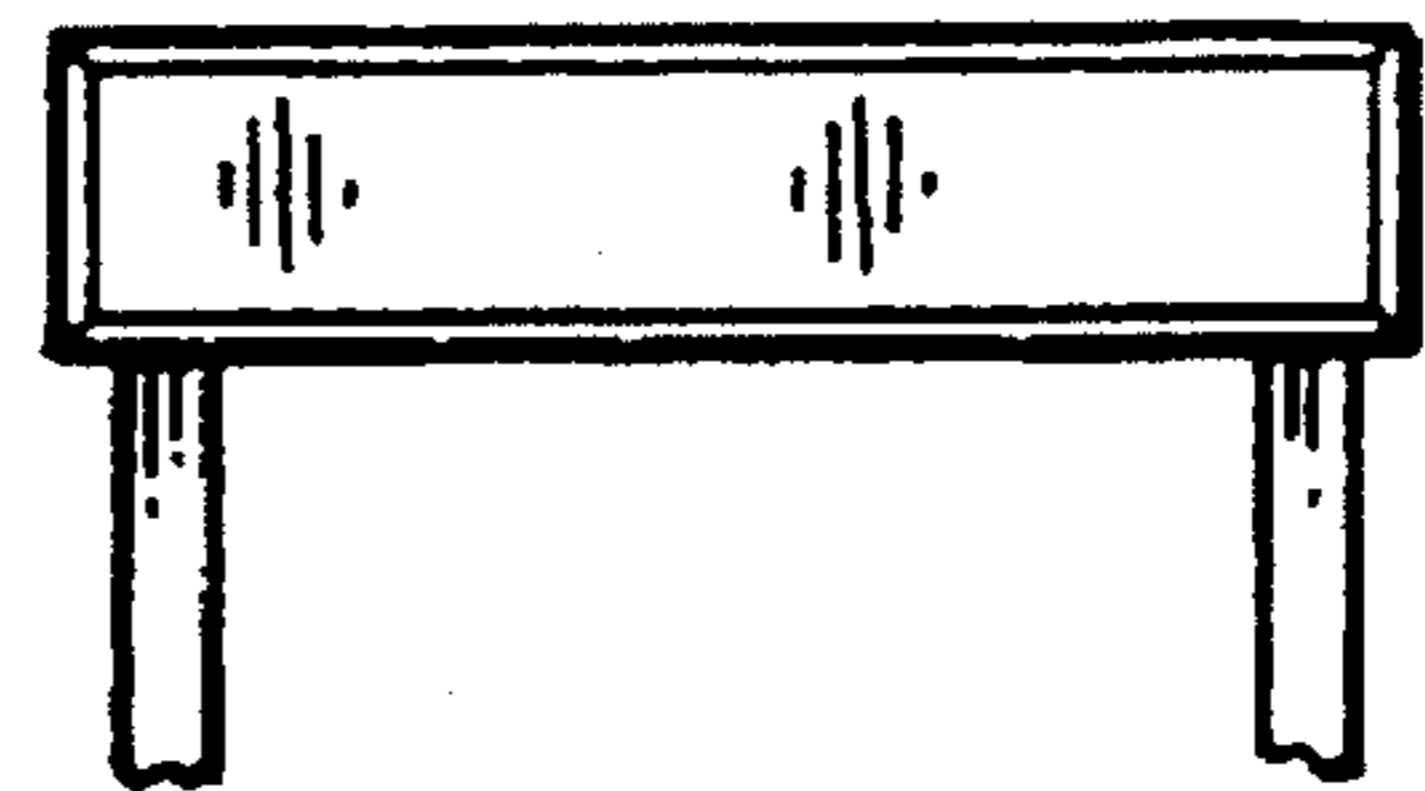
