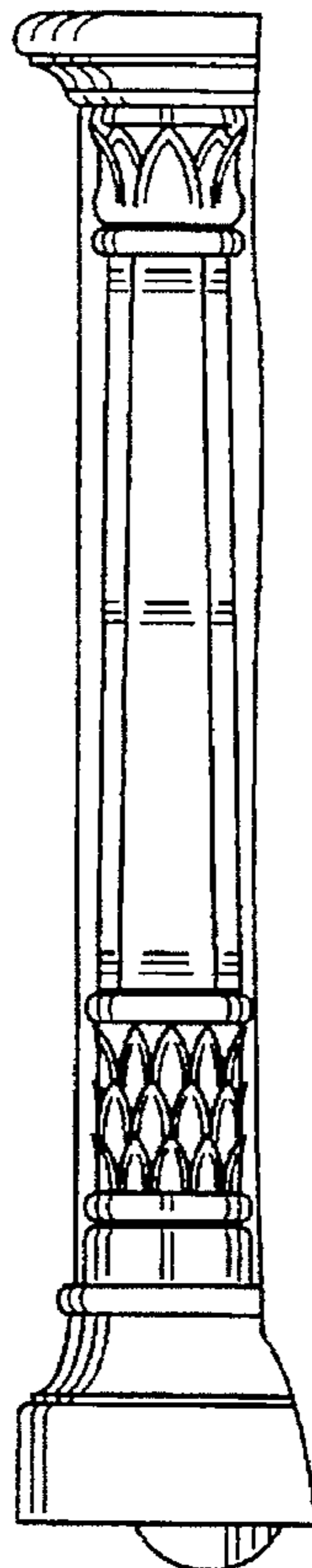

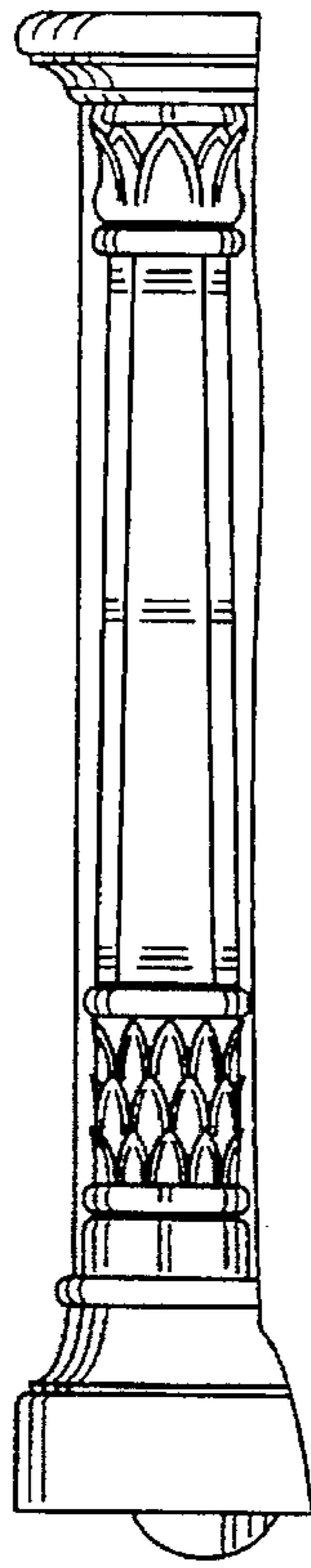
[57] **CLAIM**

The ornamental design for a trim for furniture, as shown and described.

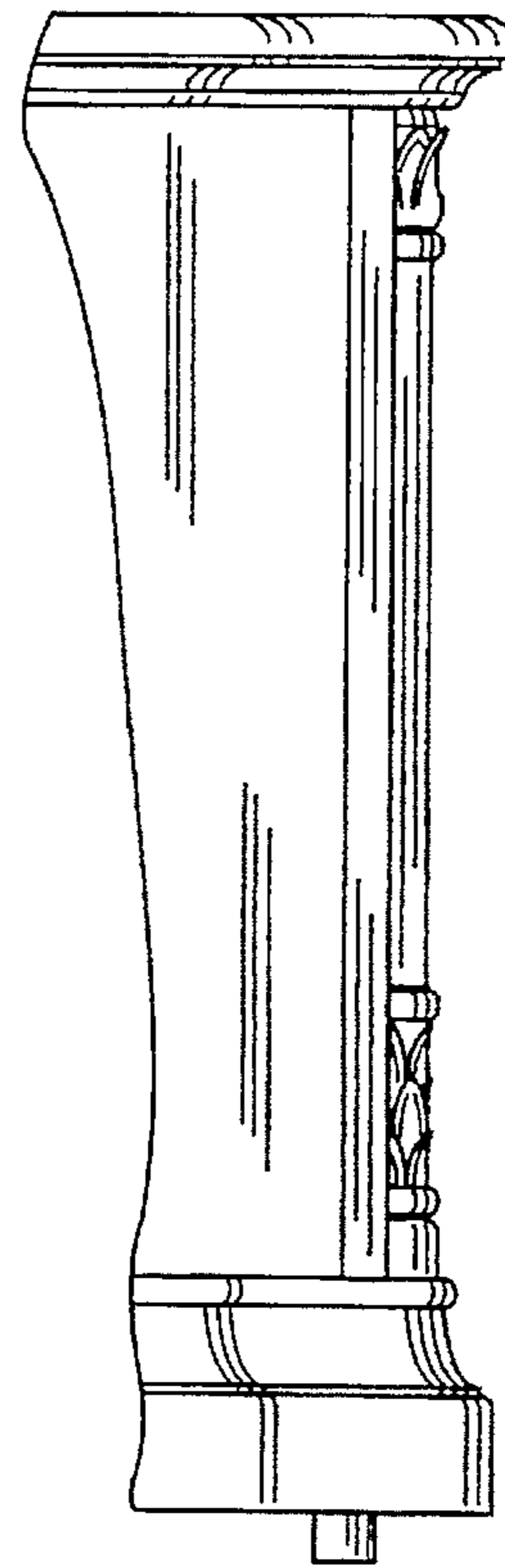
FIG. 1 is a left-front elevational view of a trim for furniture showing my new design;

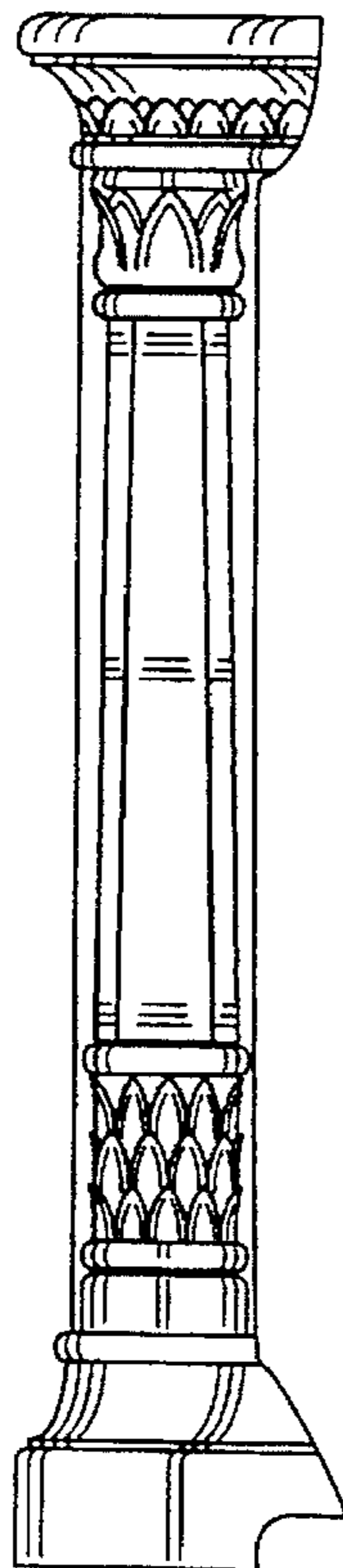




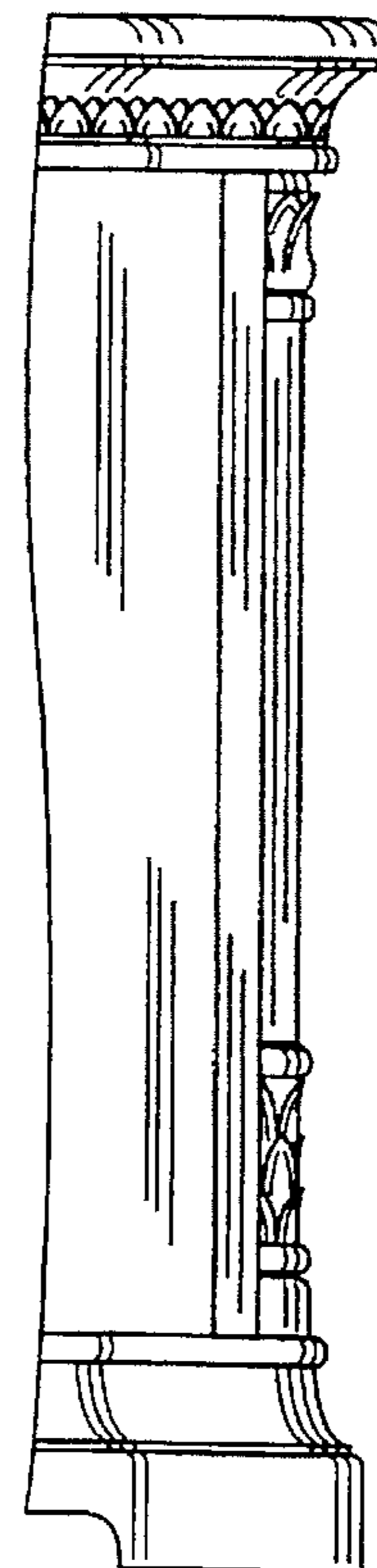

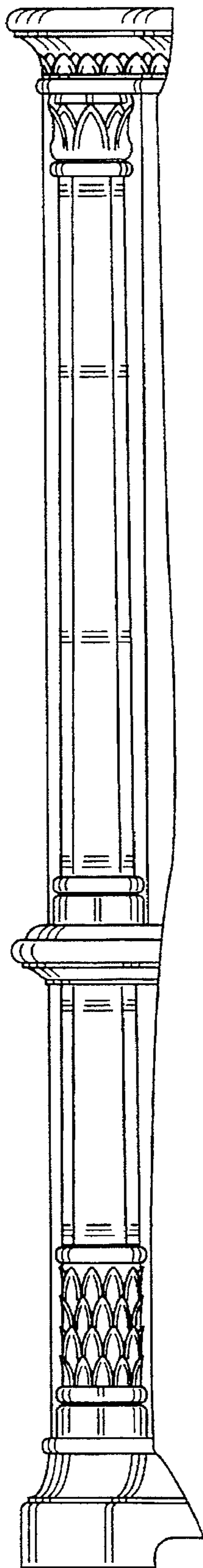

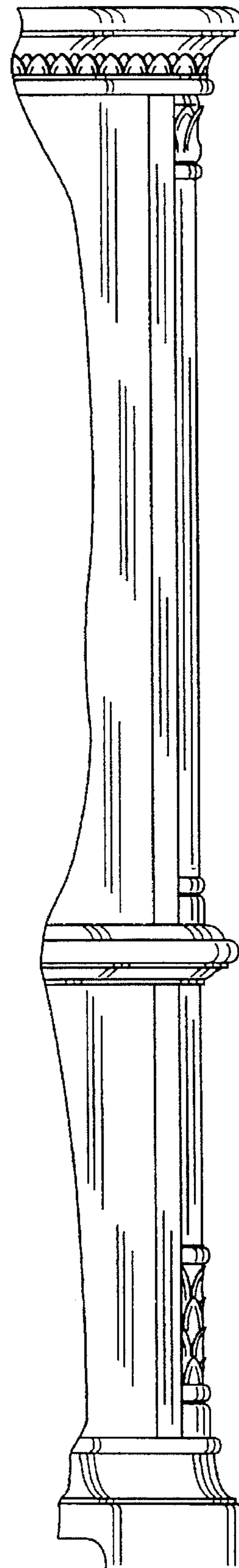

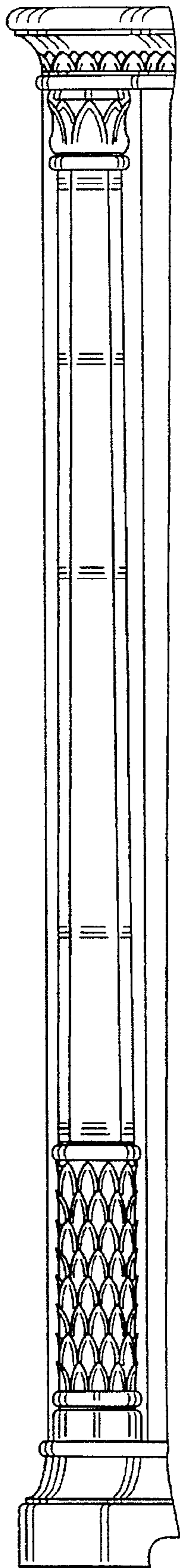

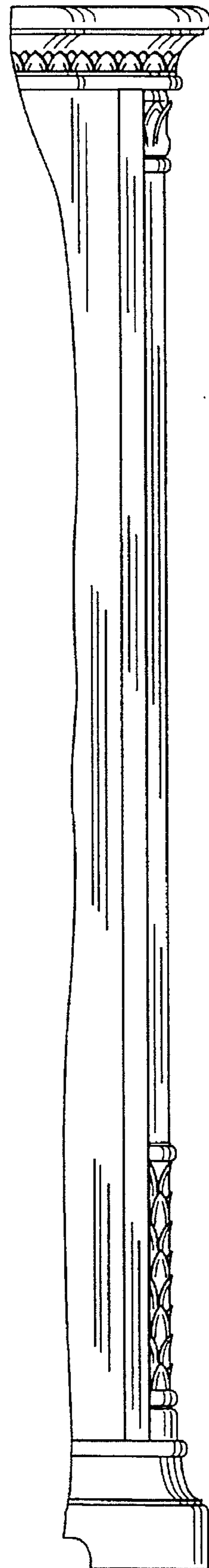
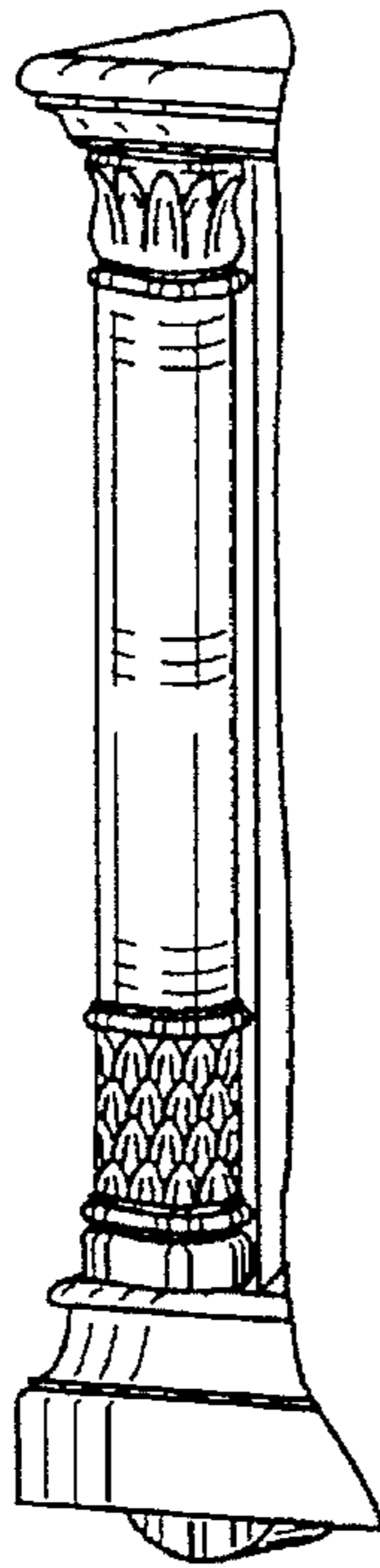
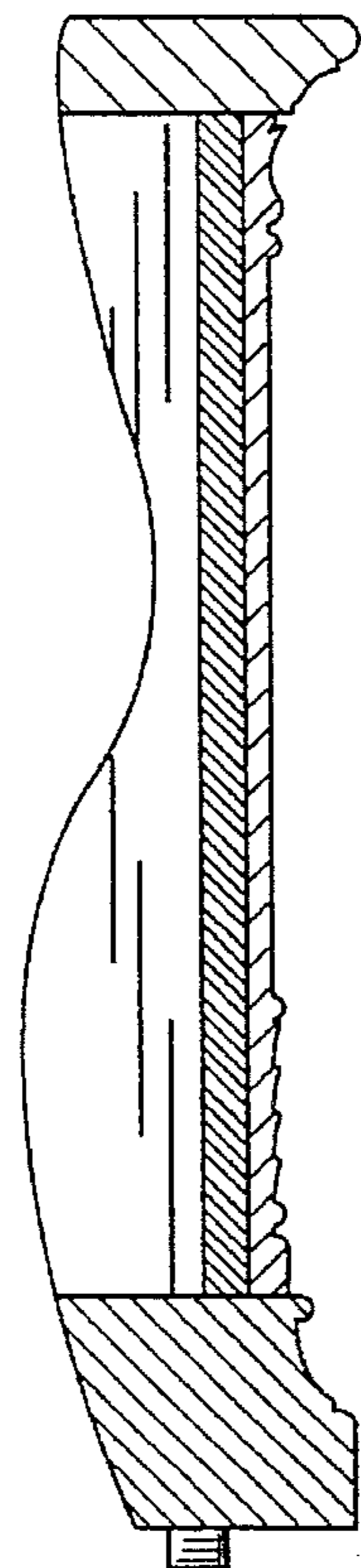

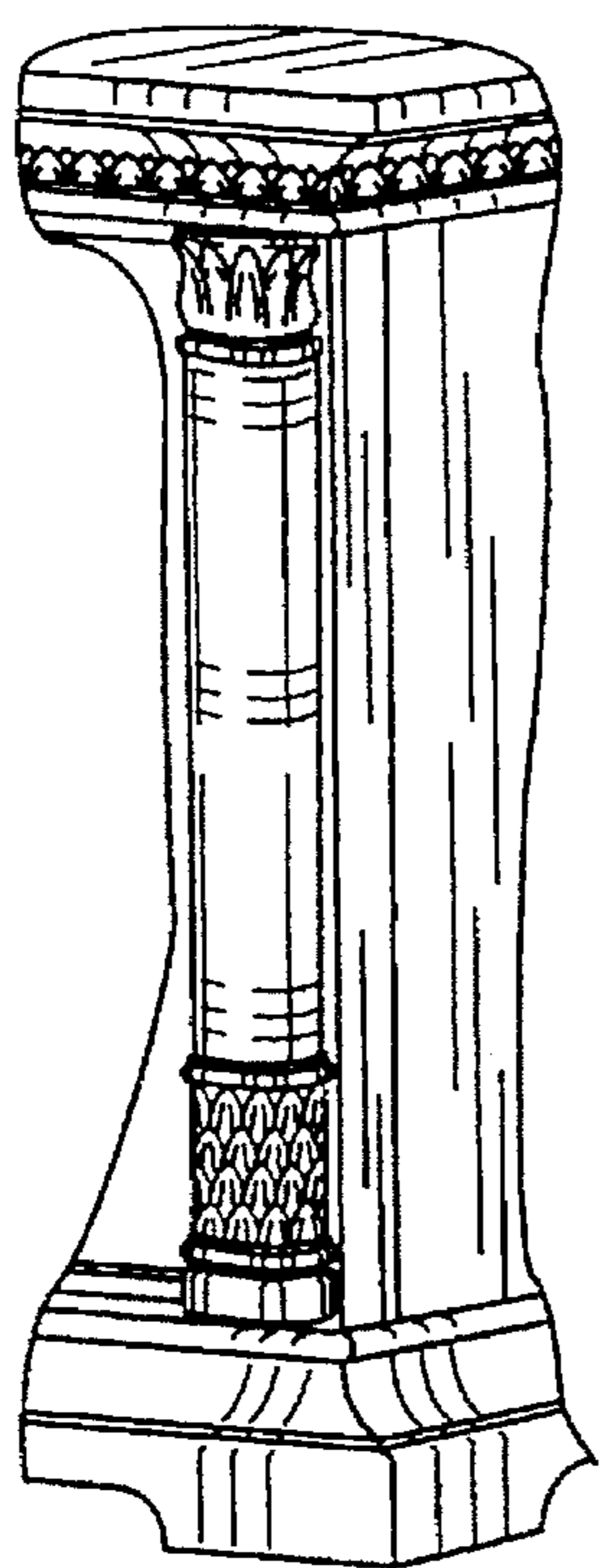

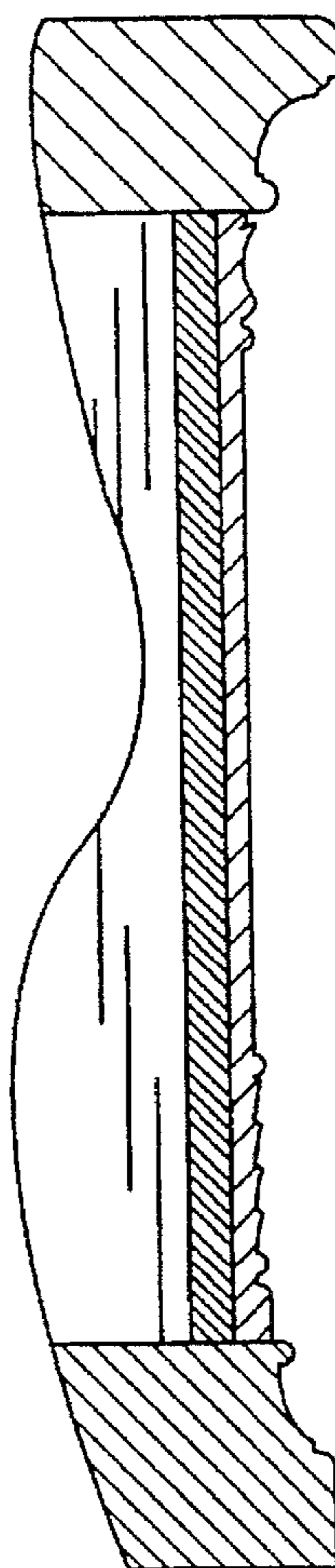

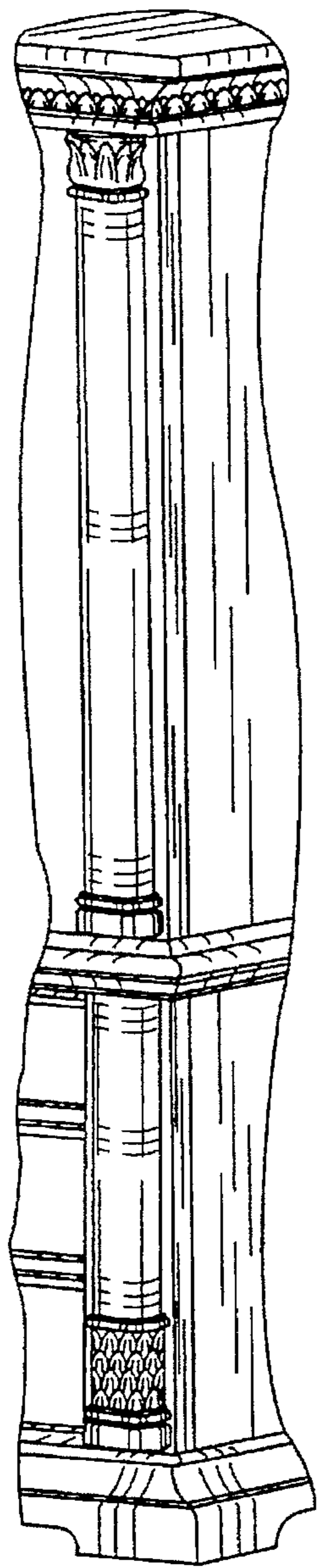




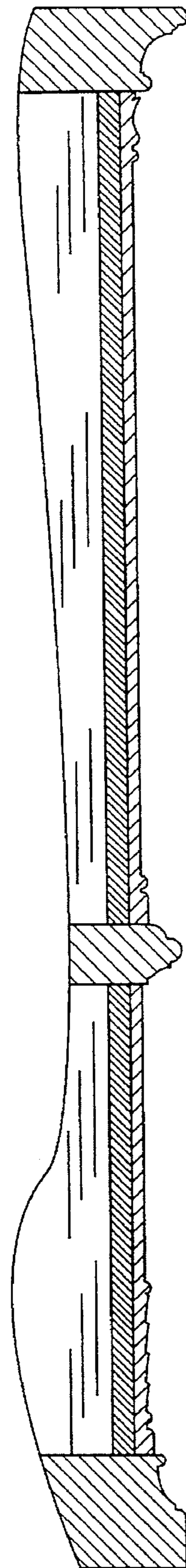

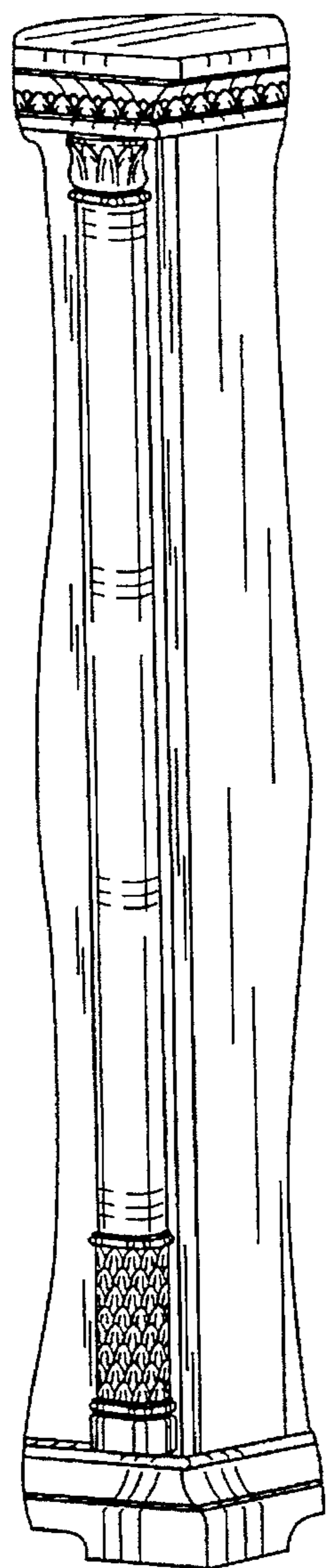

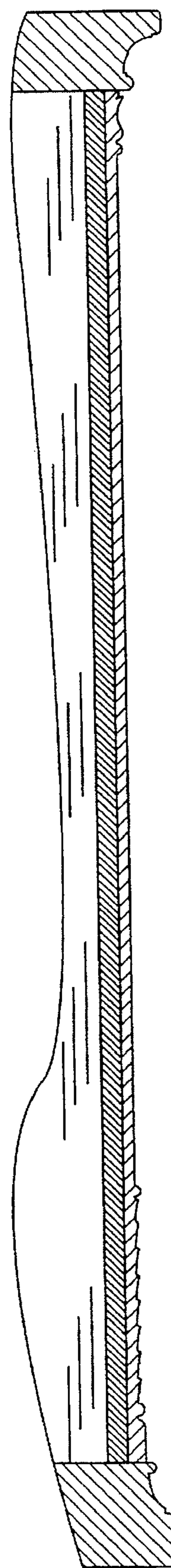
