[57] **CLAIM**

The ornamental design for a combined pager, telephone dialer and electronic calculator having the functions of telephone book, address book, calendar, schedule book and memo book, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a combined pager, telephone dialer and electronic calculator having the functions of telephone book, calendar, schedule book and memo book showing our new design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a perspective view thereof;

FIG. 8 is a front elevational view thereof with the cover closed; and,

FIG. 9 is a right side elevational view thereof with the cover closed.

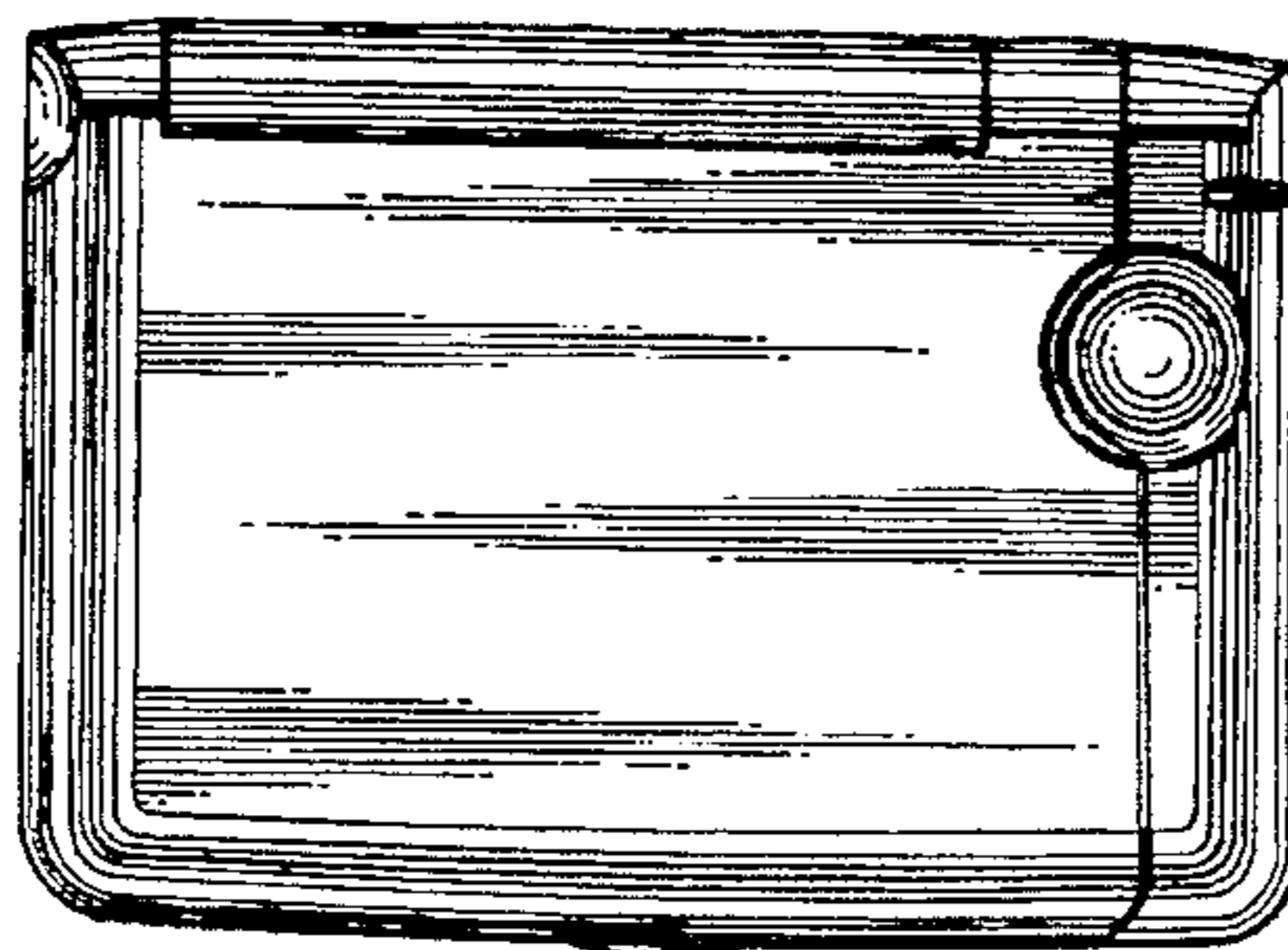
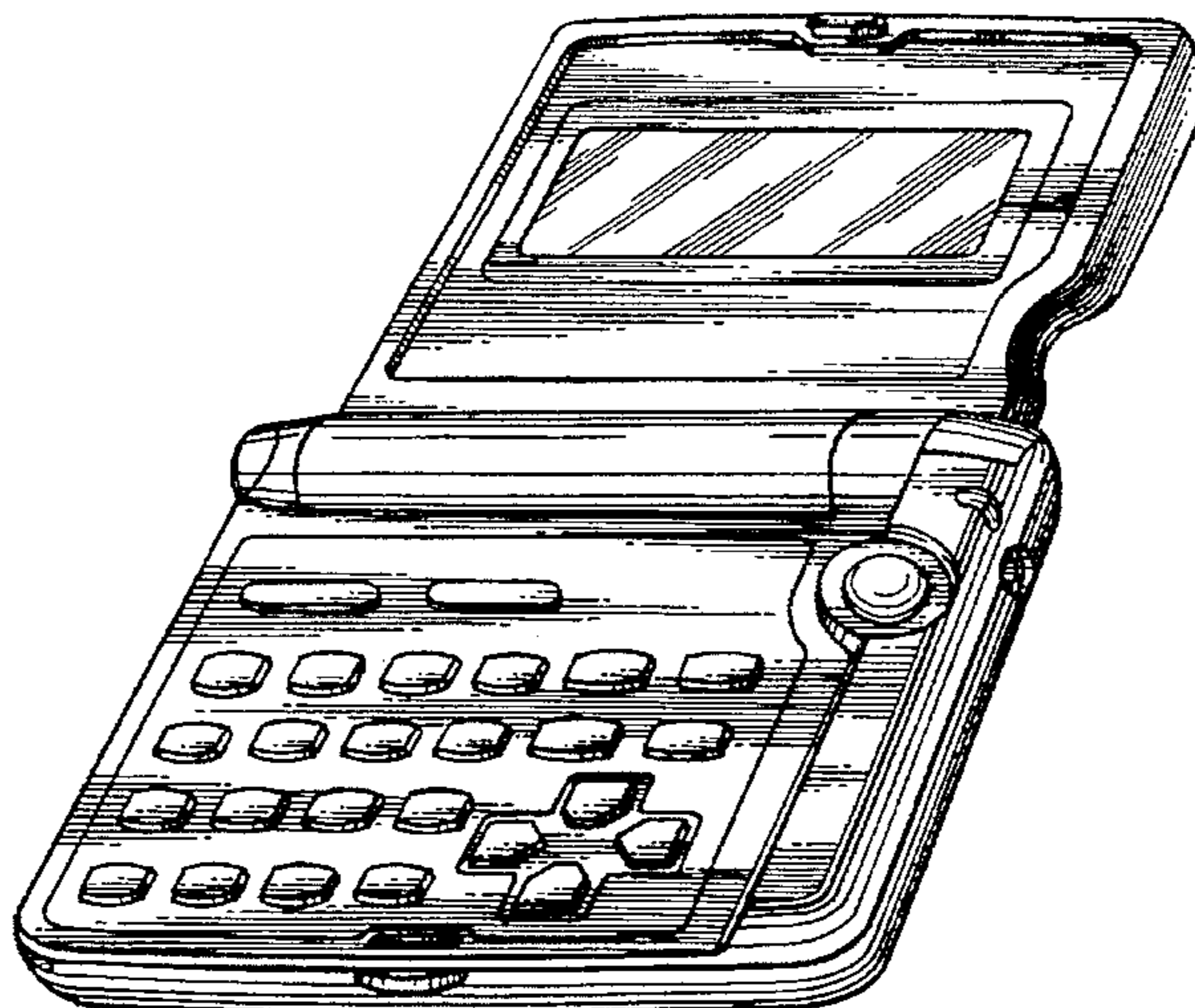

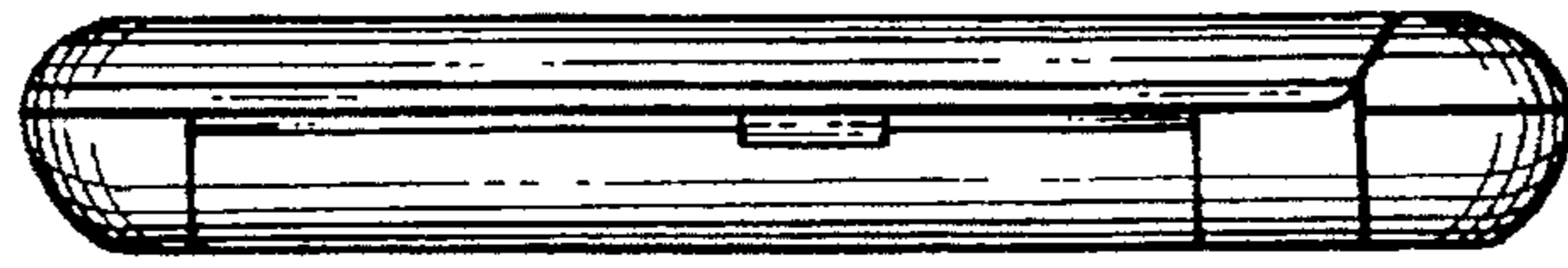

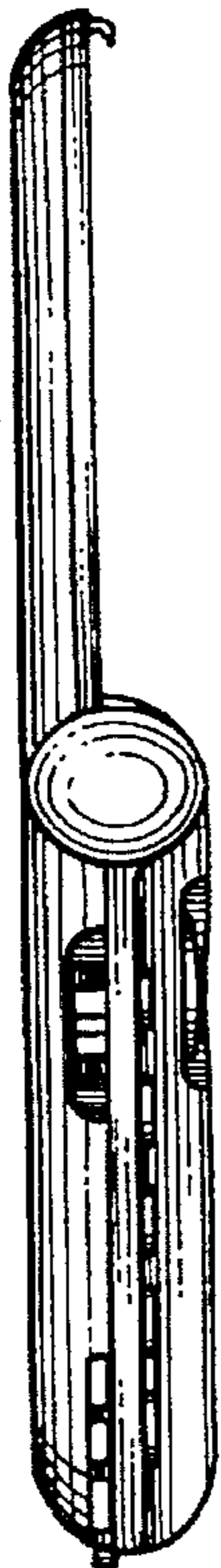

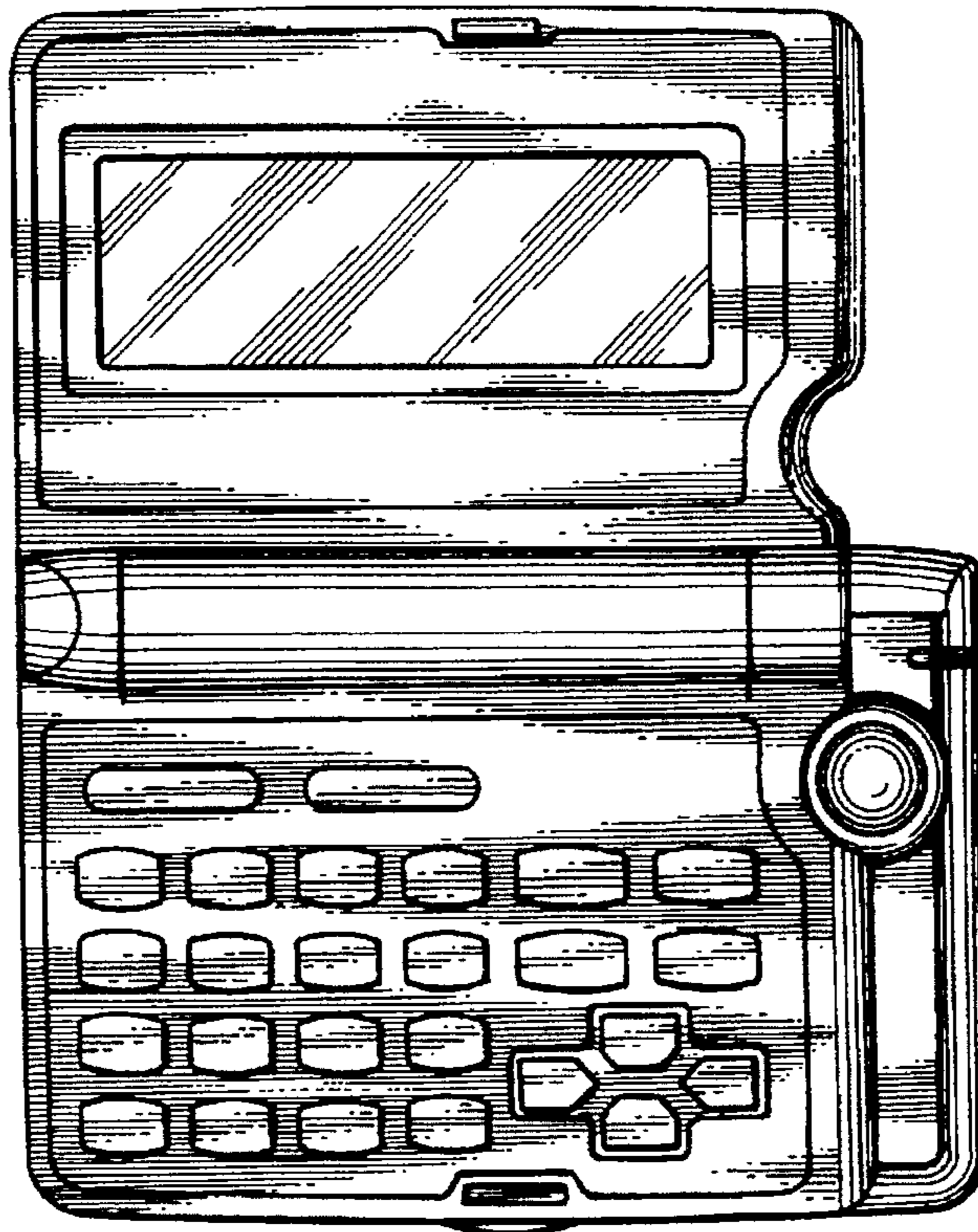
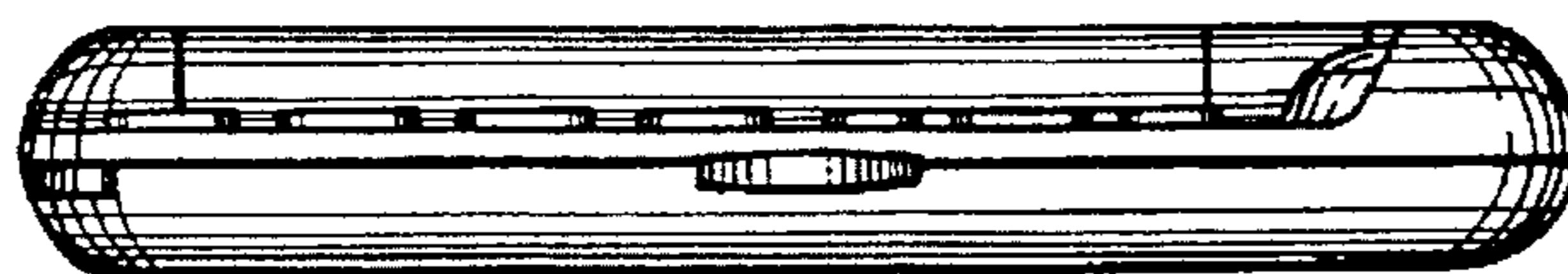

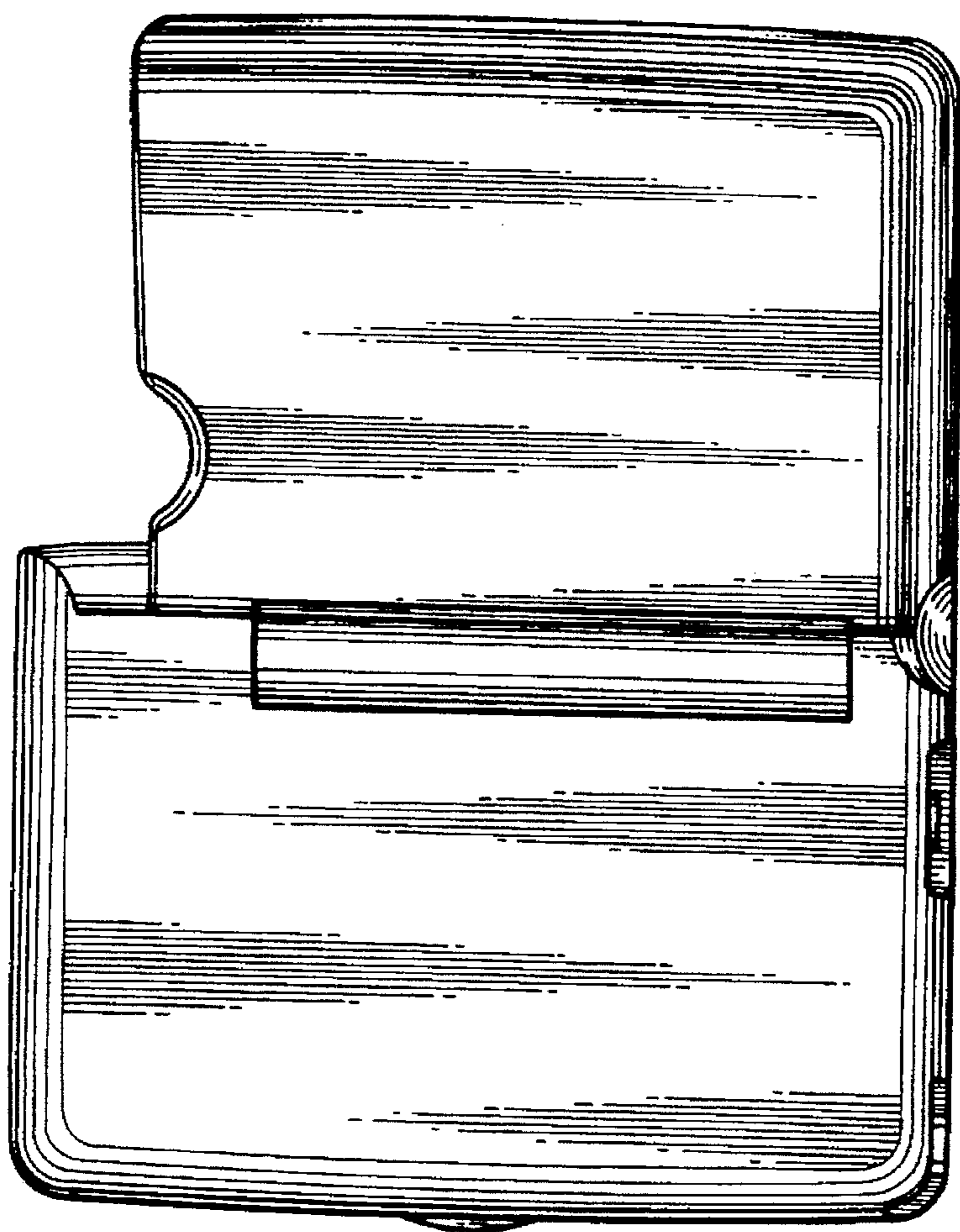

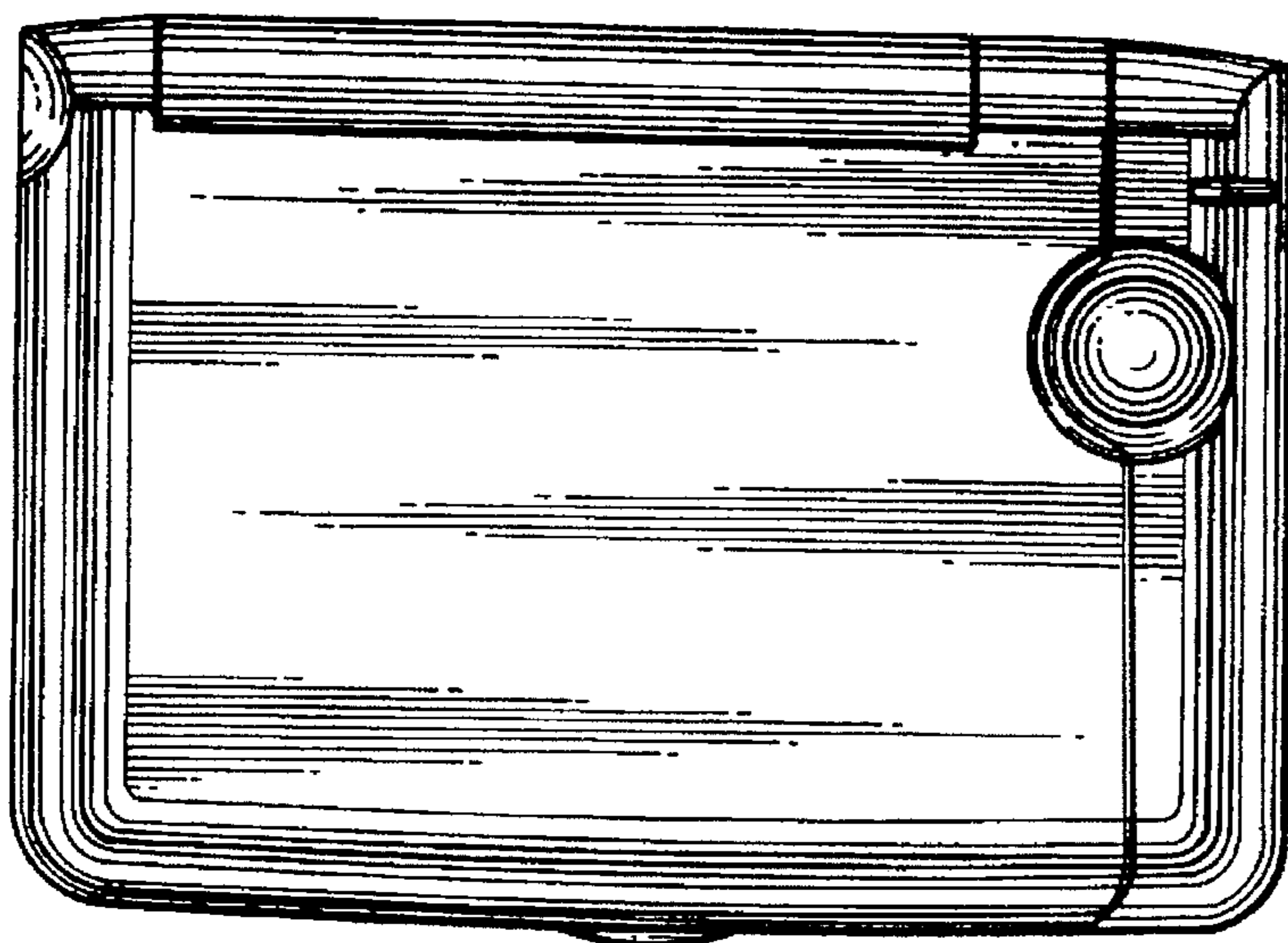
