### [57] CLAIM

The ornamental design for a wall bar for hand shower, as shown and described.

### DESCRIPTION

FIG. 1 is a side perspective view of a wall bar for hand showers showing our new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a side elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is an opposite side elevation view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

The hand shower and the mounting particulars, shown in broken lines, form no part of the claimed design.

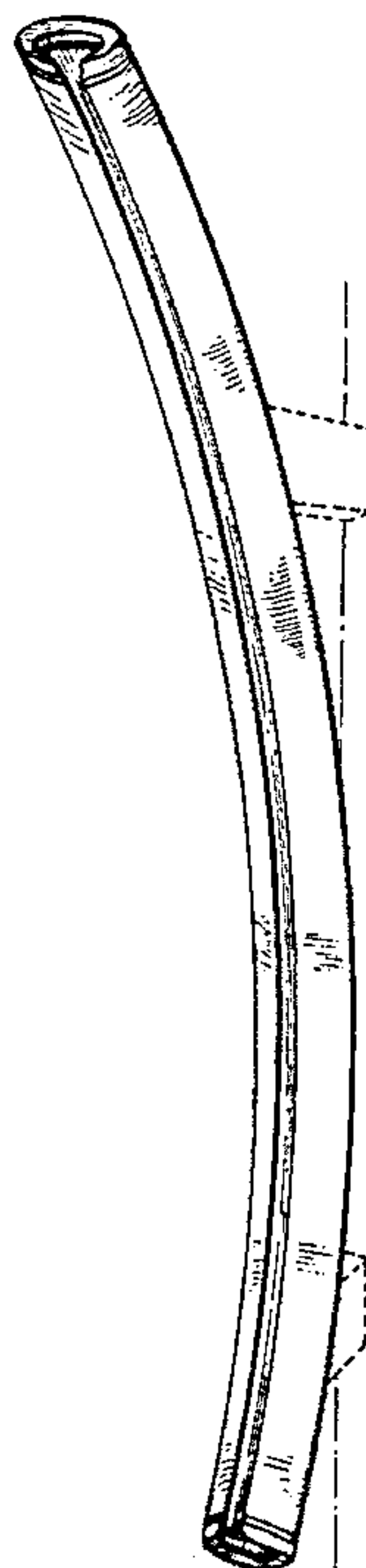

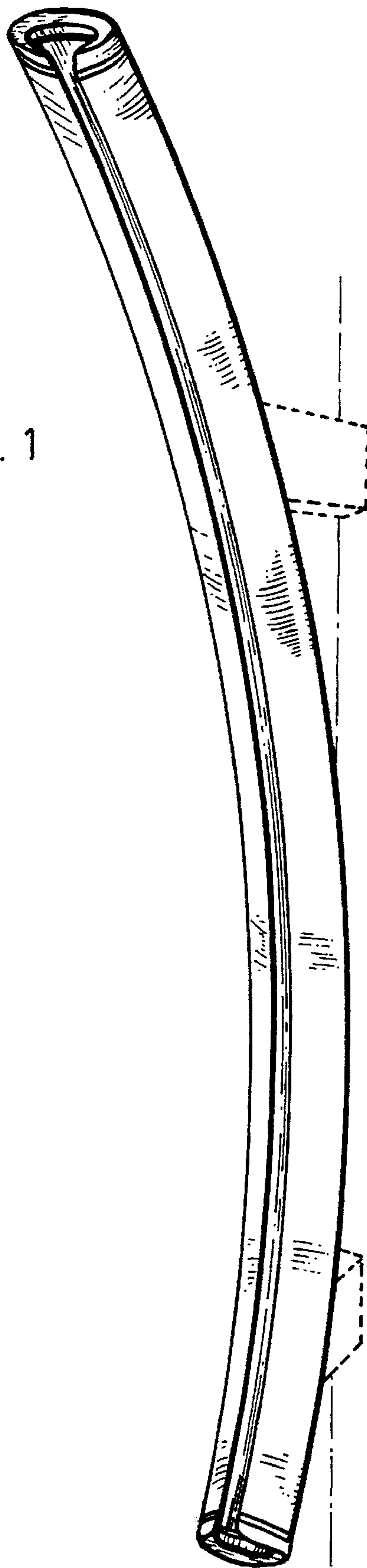

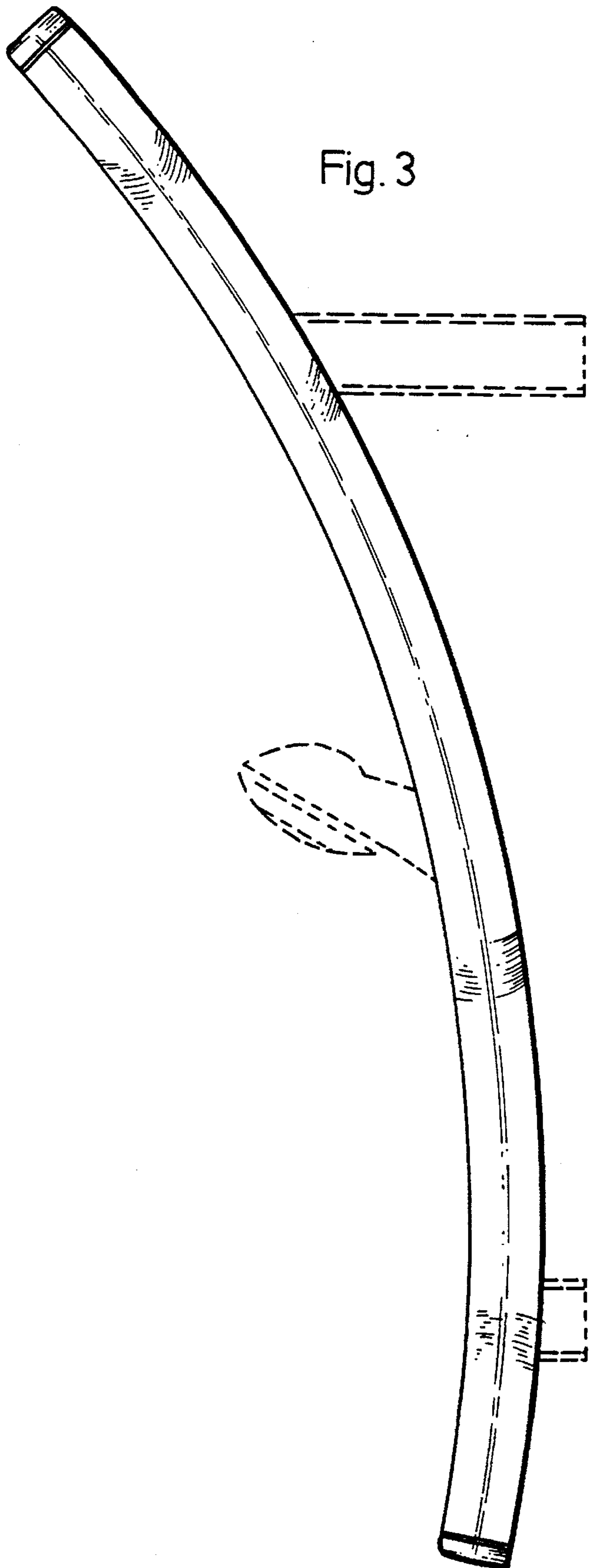

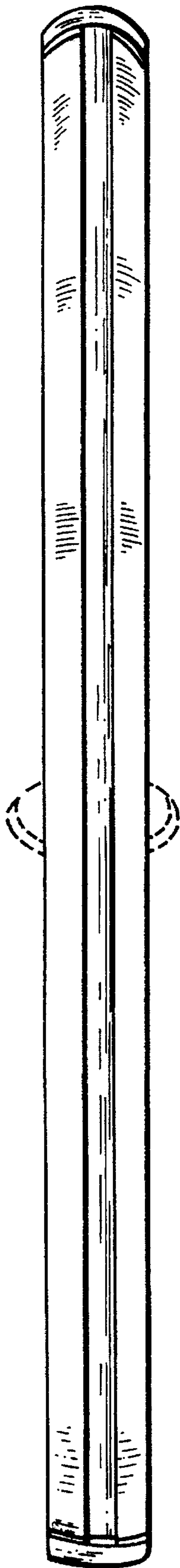

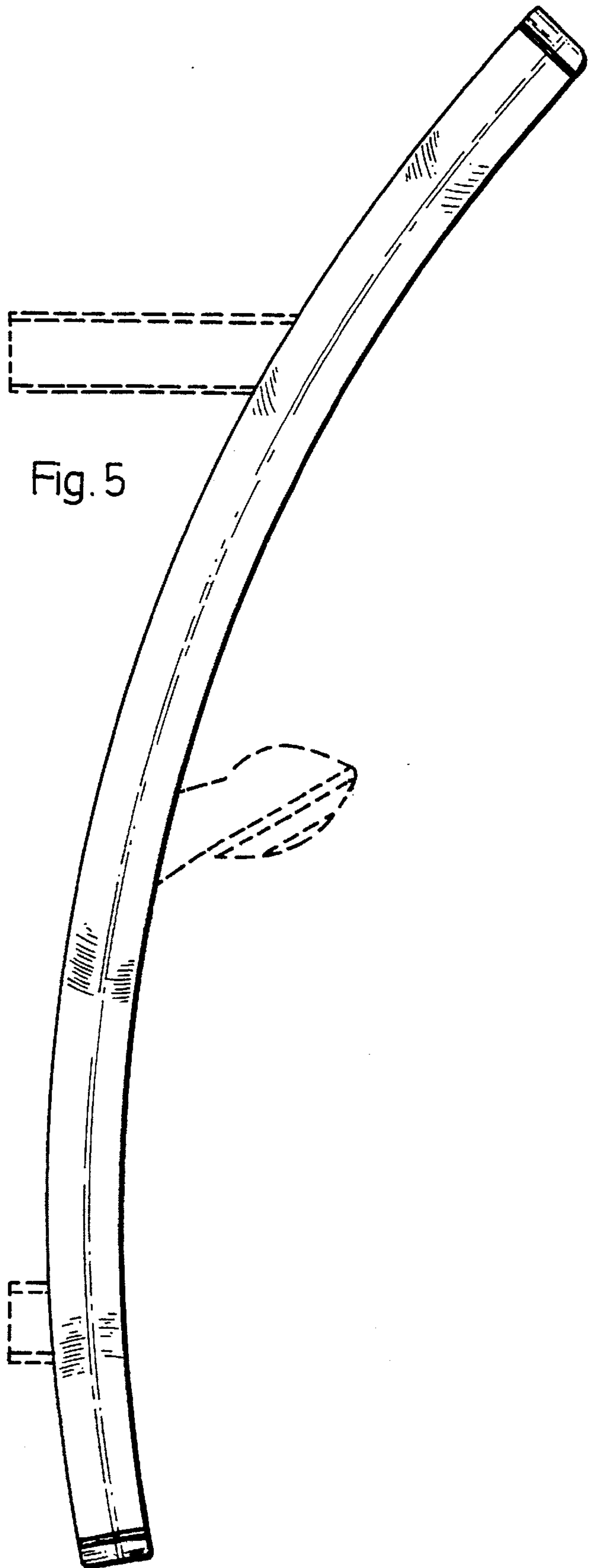

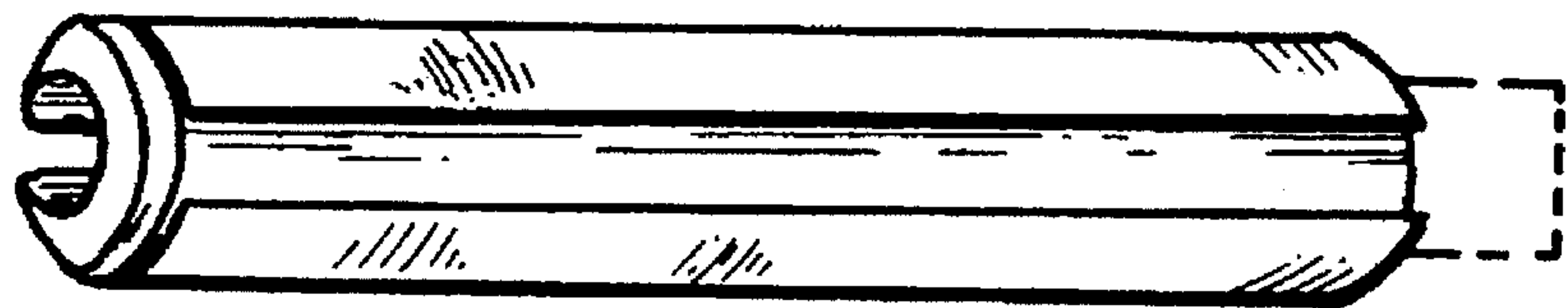
