The ornamental design for a tooth and gum cleaning implement, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tooth and gum cleaning implement, showing a first embodiment of my new design;

FIG. 2 is a top plan view thereof, the bottom plan view being identical thereto;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right end elevational view thereof;

FIG. 6 is a left end elevational view thereof;

FIG. 7 is a perspective view of a tooth and gum cleaning implement, showing a second embodiment of my new design;

FIG. 8 is a top plan view thereof, the bottom plan view being identical thereto;

FIG. 9 is a right side elevational view thereof, the left side elevational view being identical thereto;

FIG. 10 is a right end elevational view thereof, the left end elevational view being identical thereto;

FIG. 11 is a perspective view of a tooth and gum cleaning implement, showing a third embodiment of my new design;

FIG. 12 is a top plan view thereof, the bottom plan view being identical thereto;

FIG. 13 is a right side elevational view thereof;

FIG. 14 is a left side elevational view thereof;

FIG. 15 is a right end elevational view thereof;

FIG. 16 is a left end elevational view thereof;

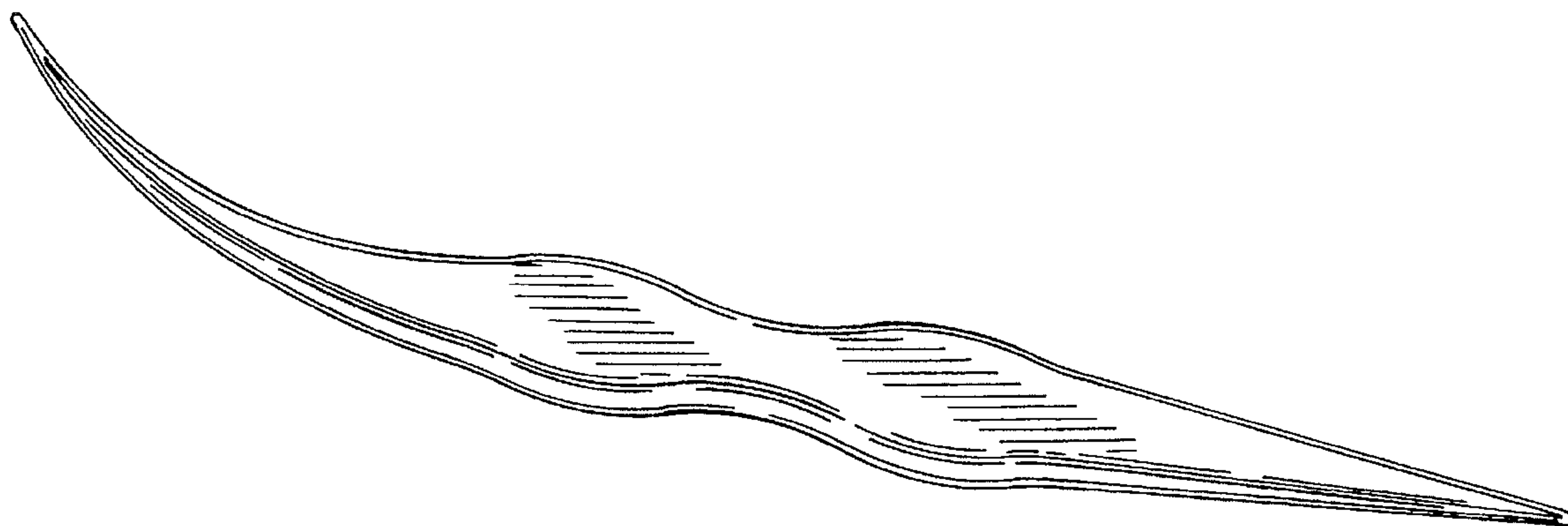
FIG. 17 is a perspective view of a tooth and gum cleaning implement, showing a fourth embodiment of my new design;

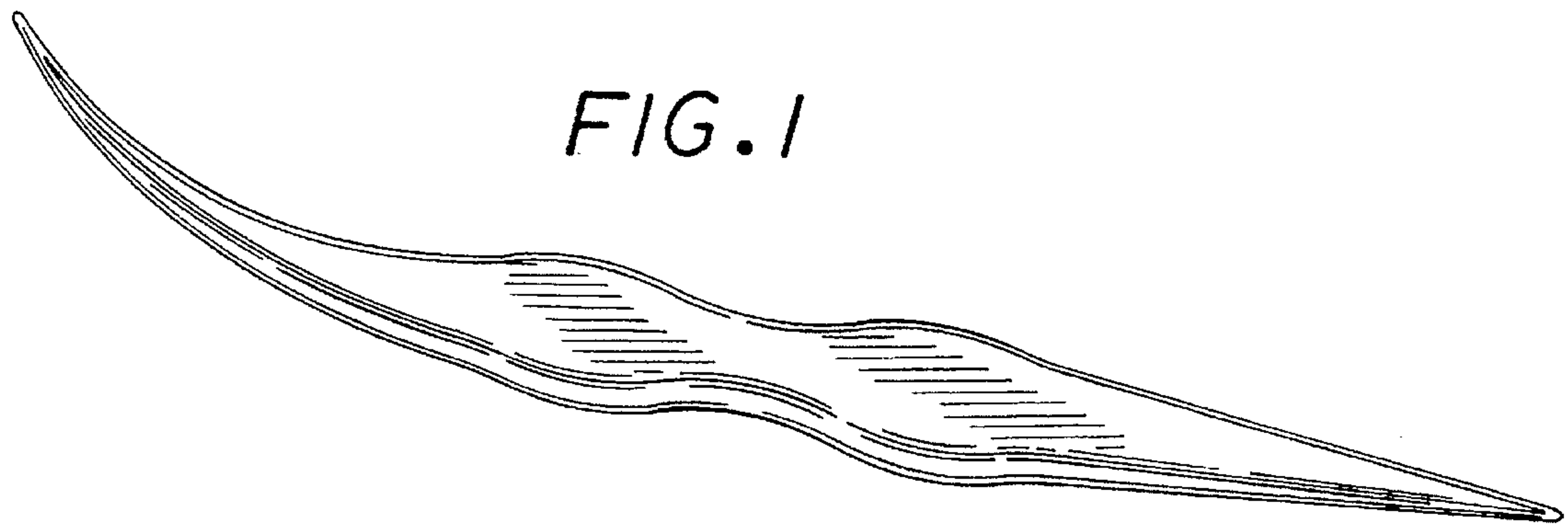

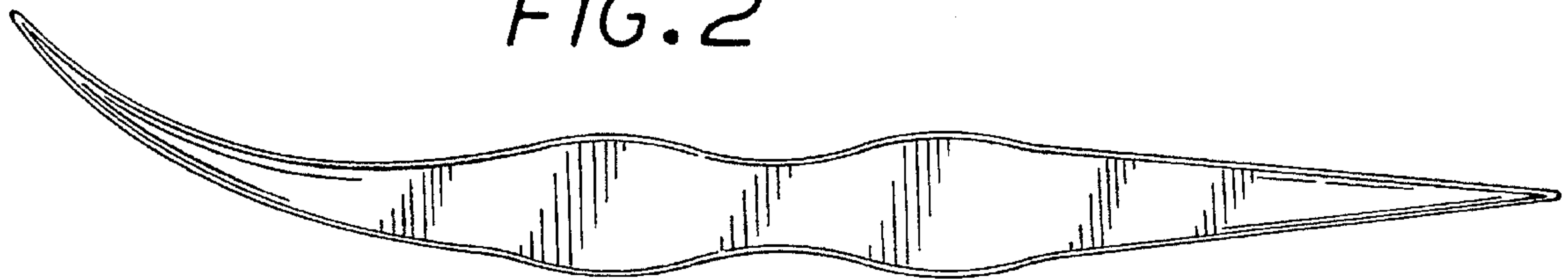

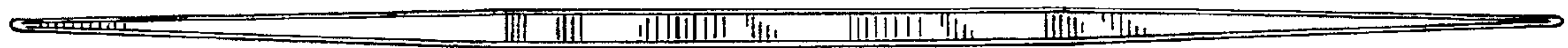

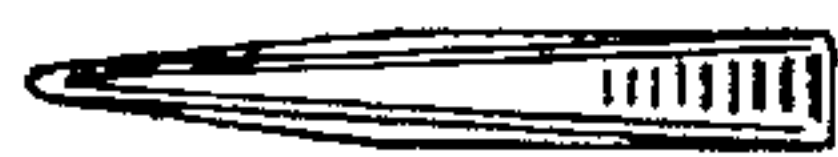

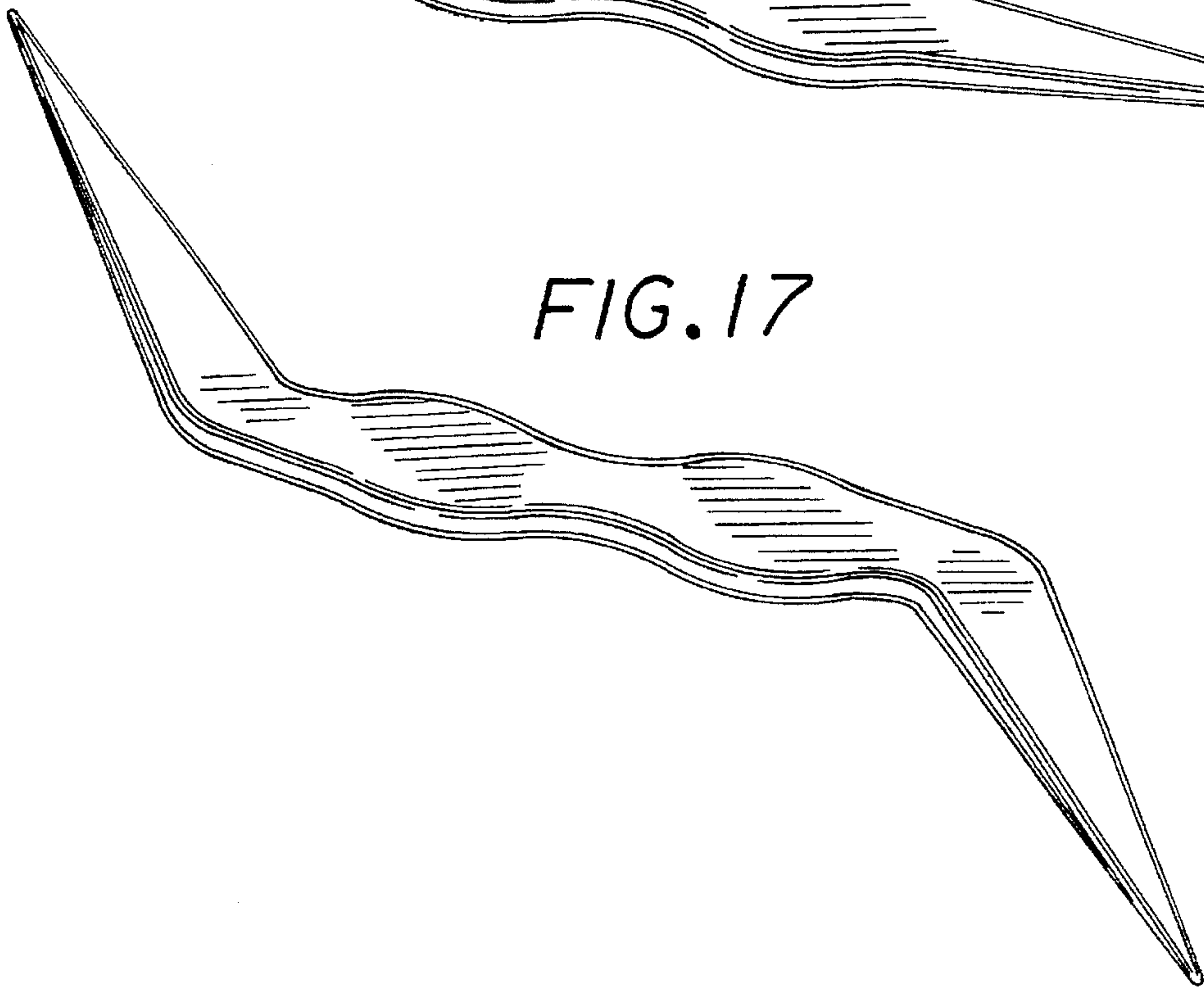
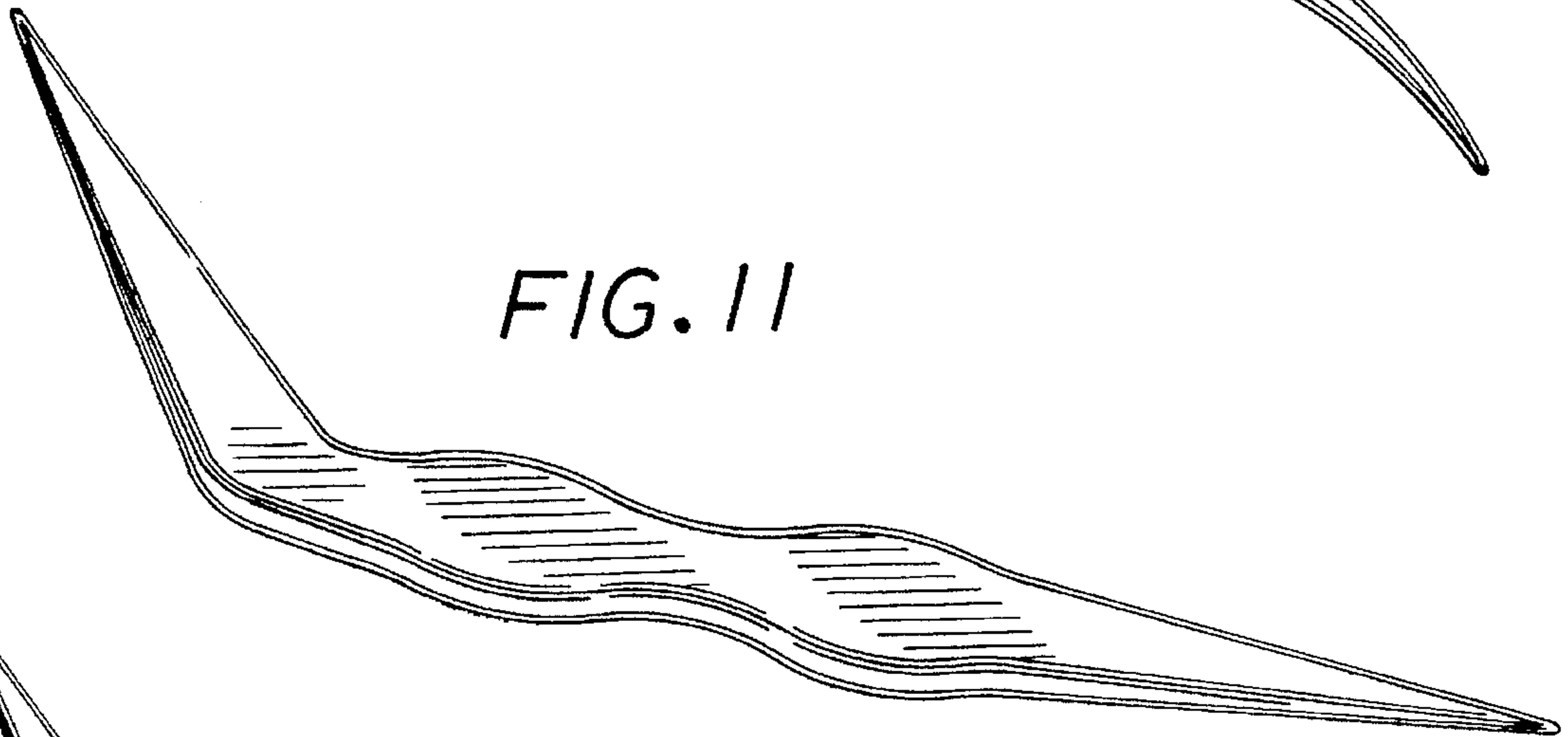
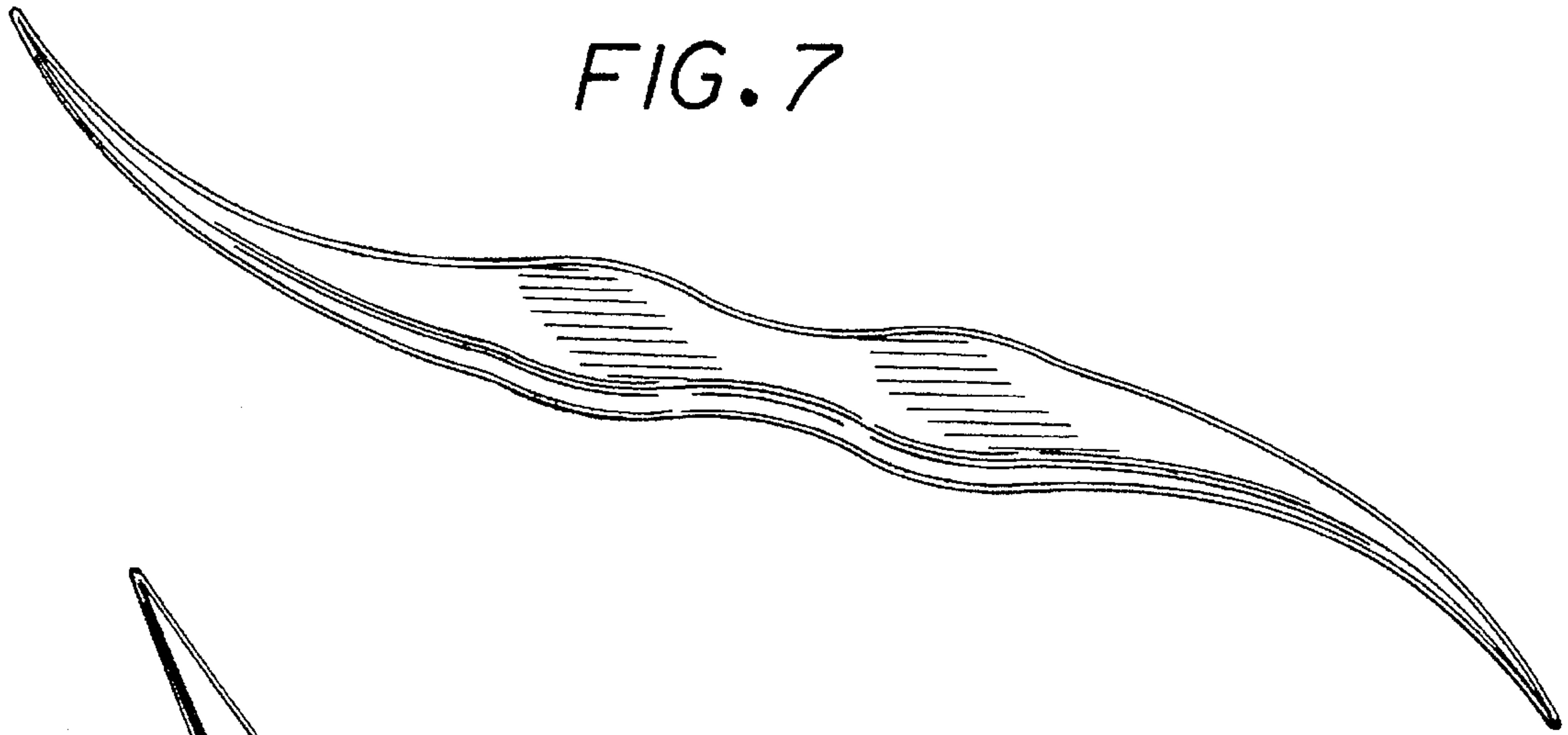

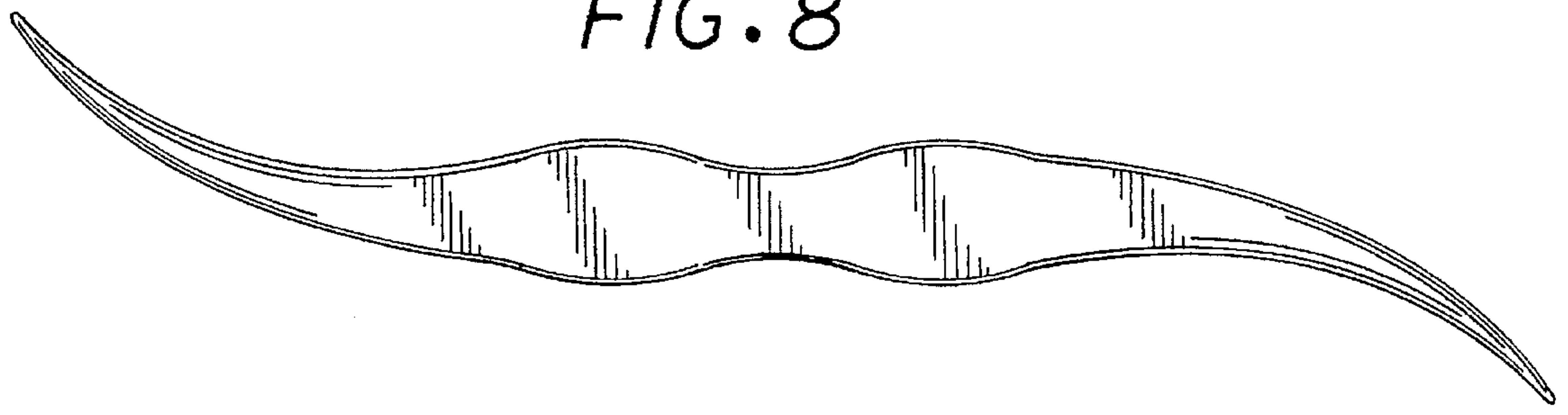

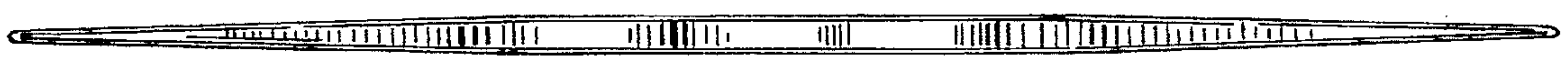

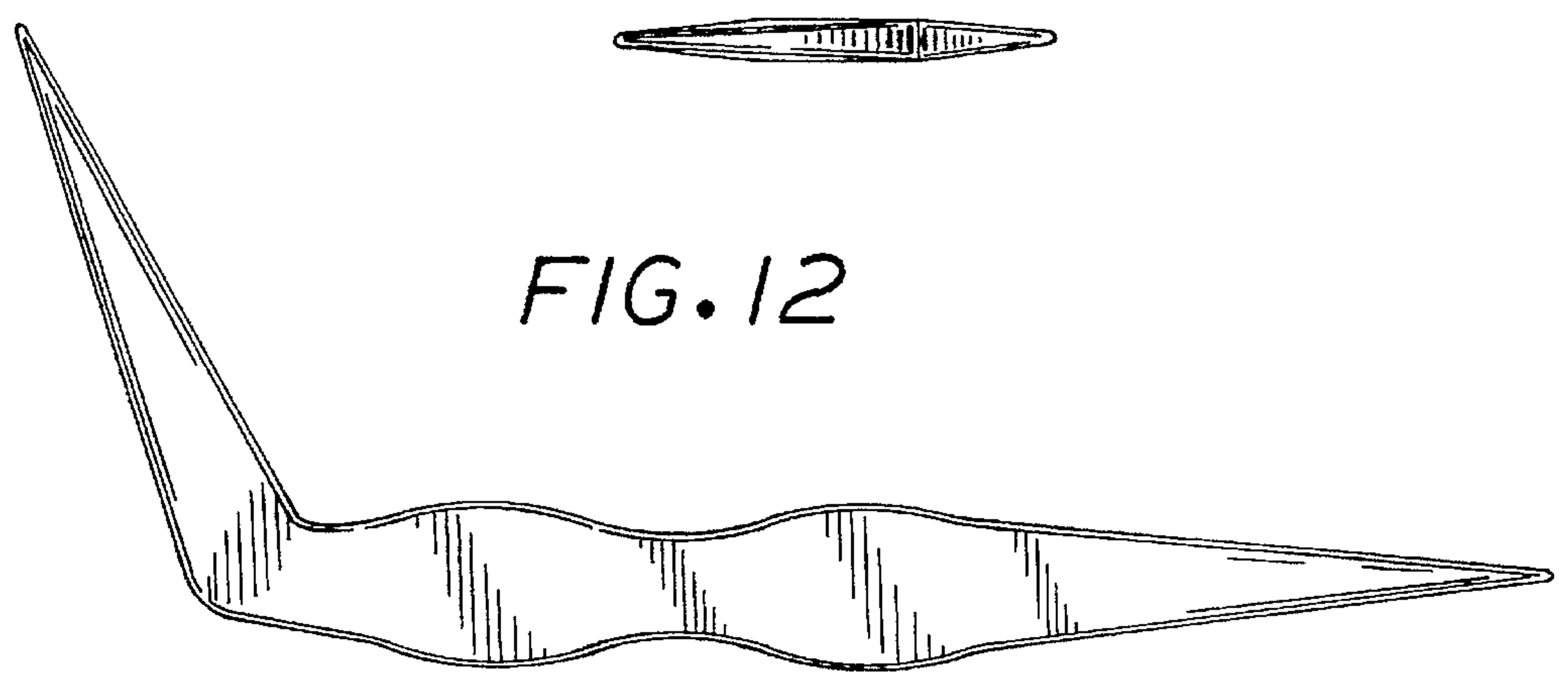

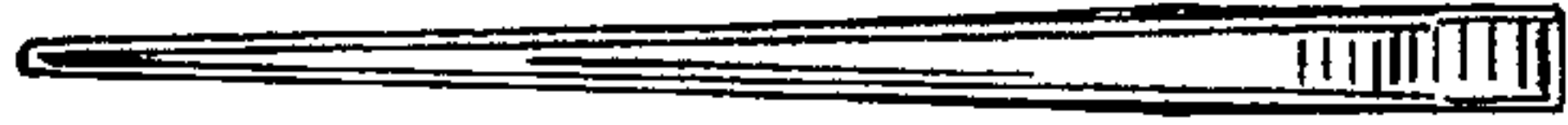

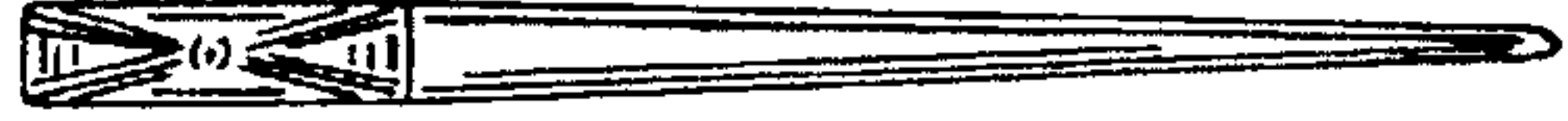

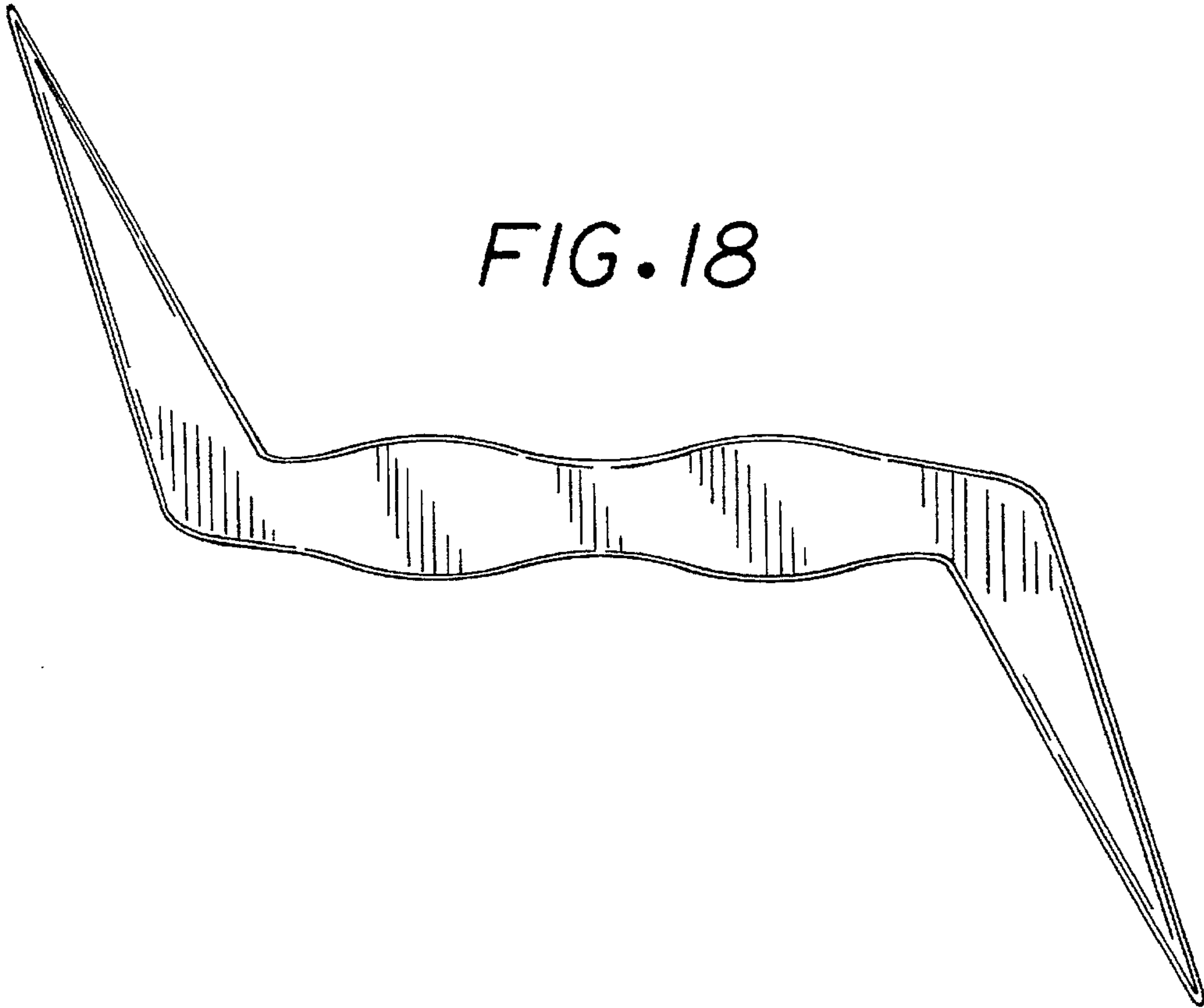
