FIG. 8 is a second end view thereof.

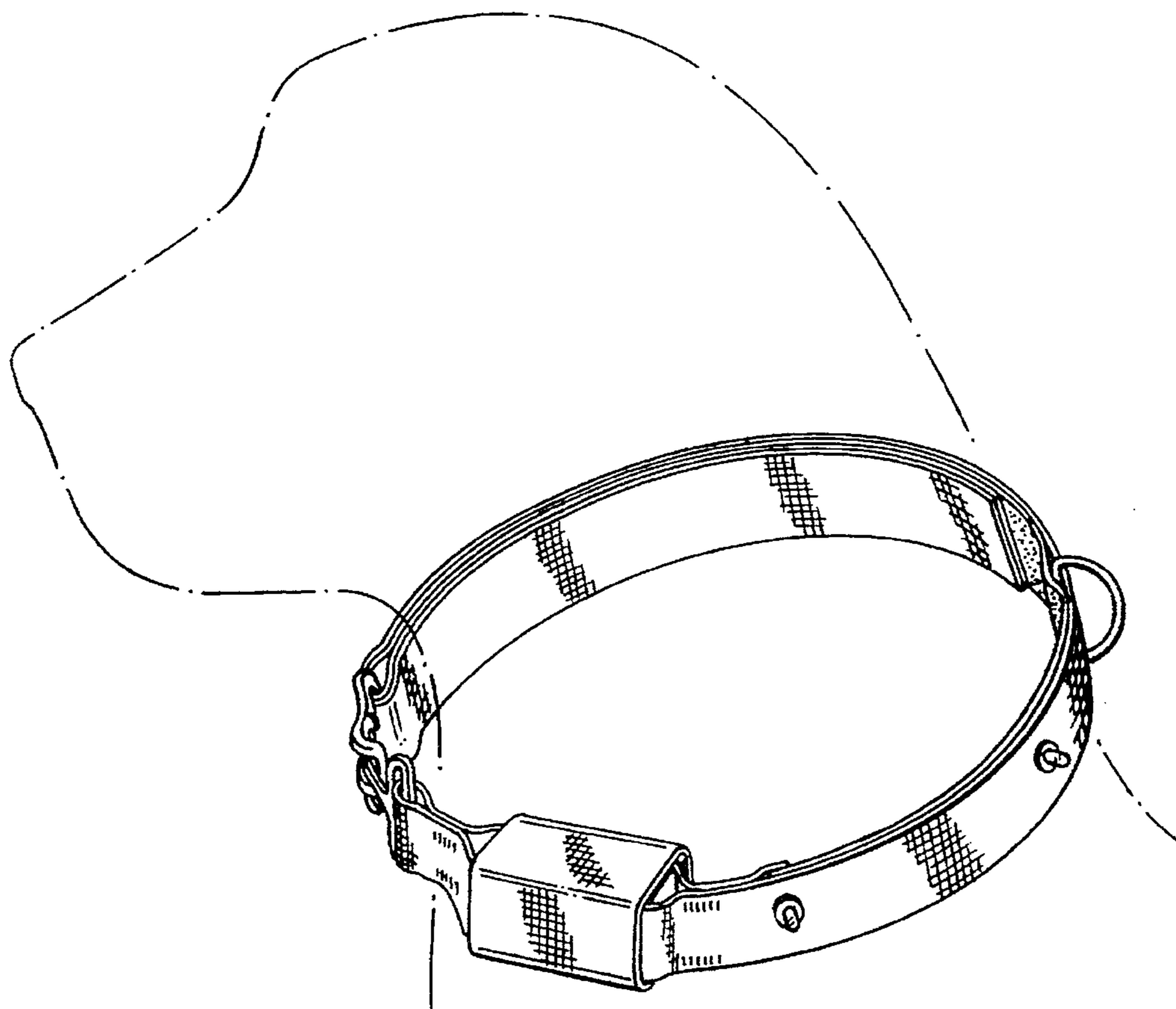

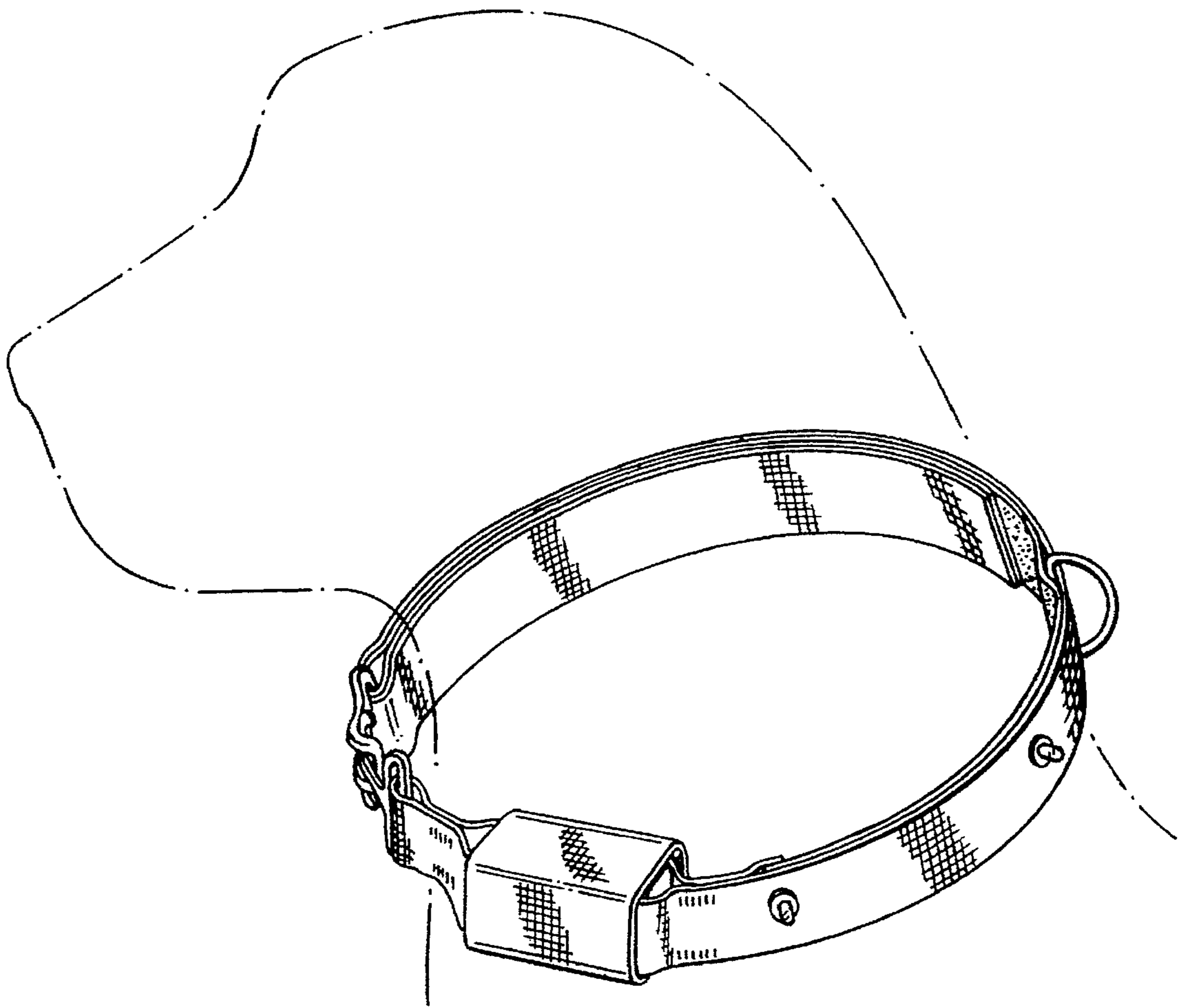

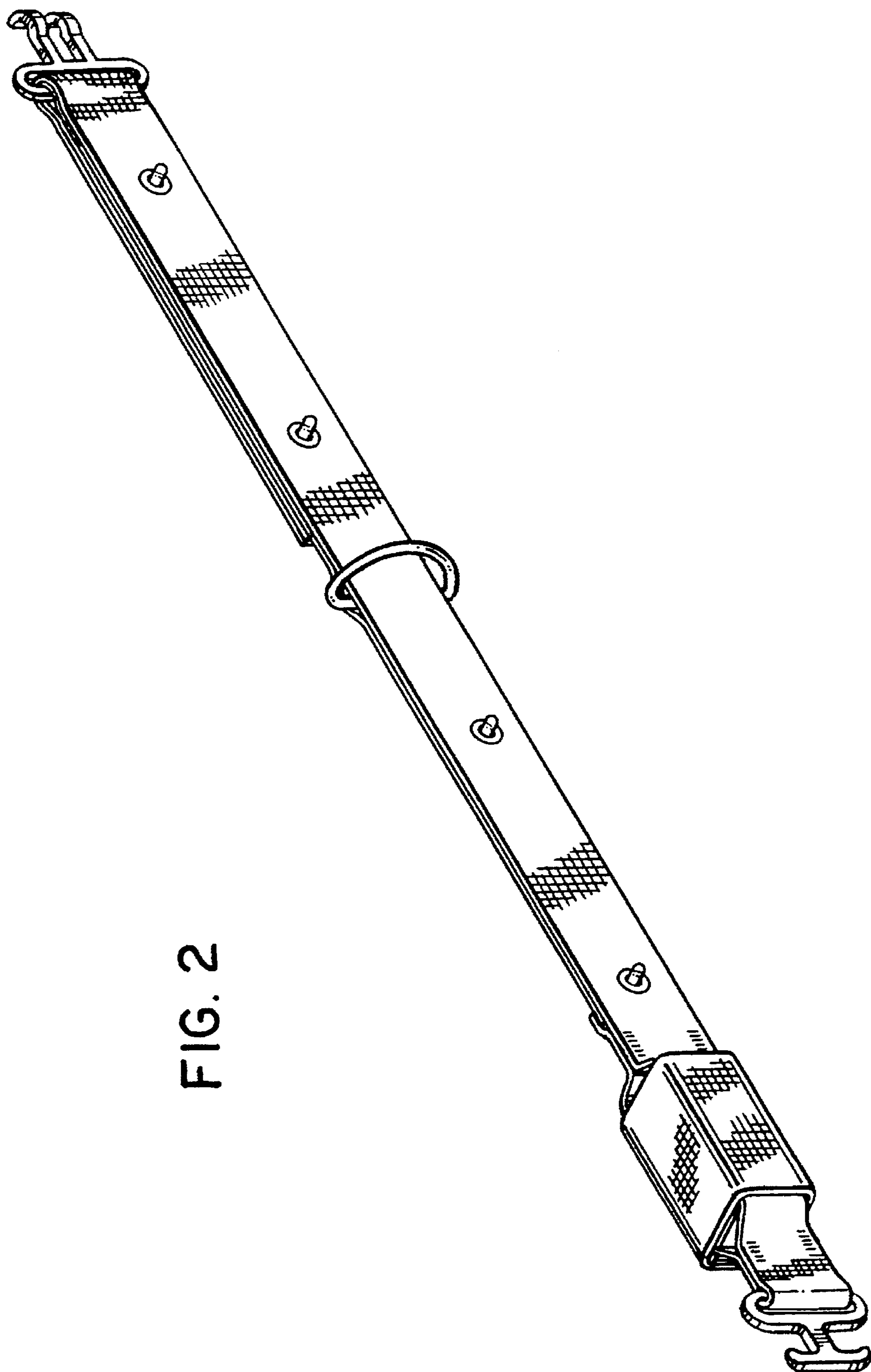

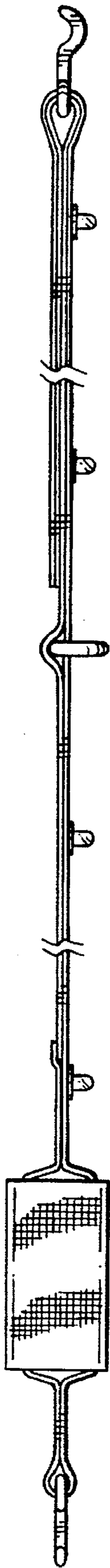

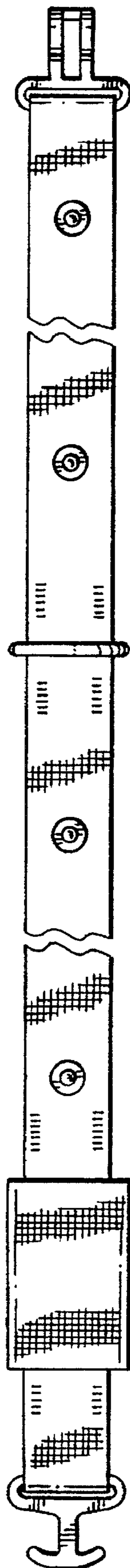

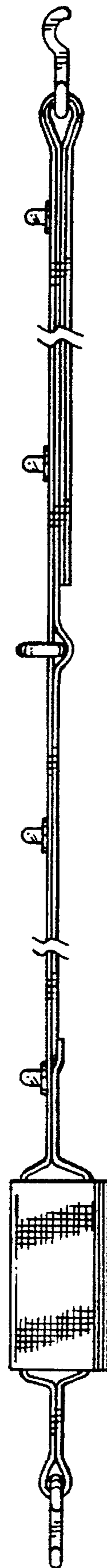

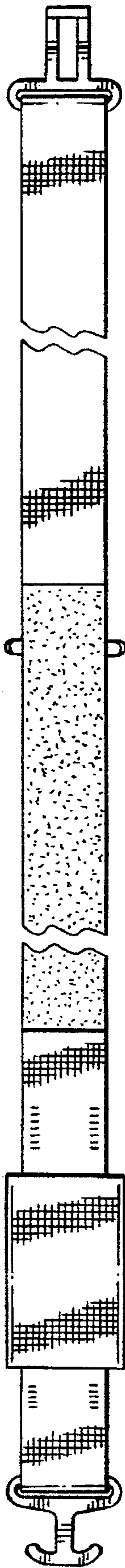

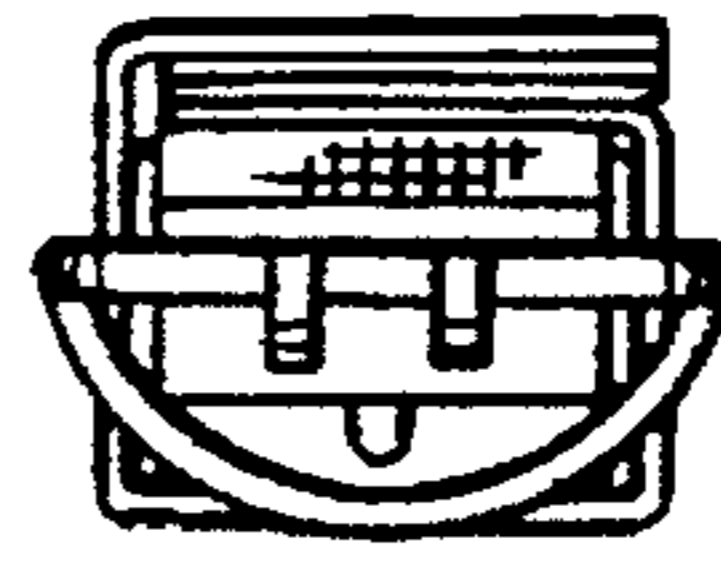

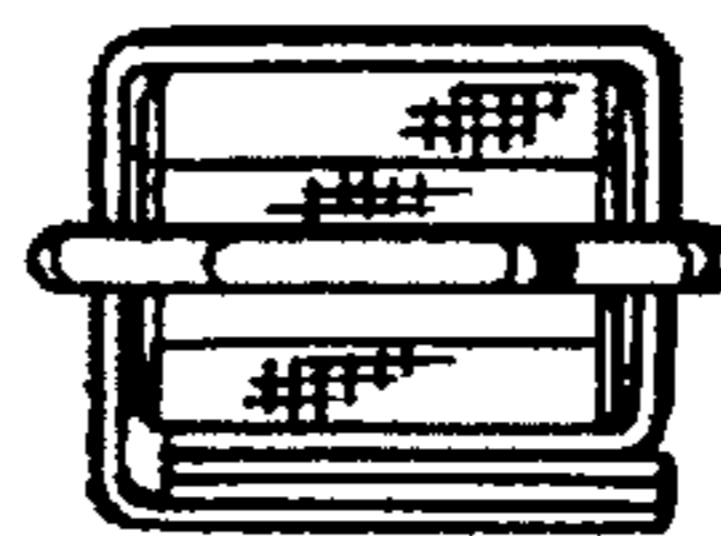
