The ornamental design for apparatus for dispensing drinks, as shown and described.

**DESCRIPTION**

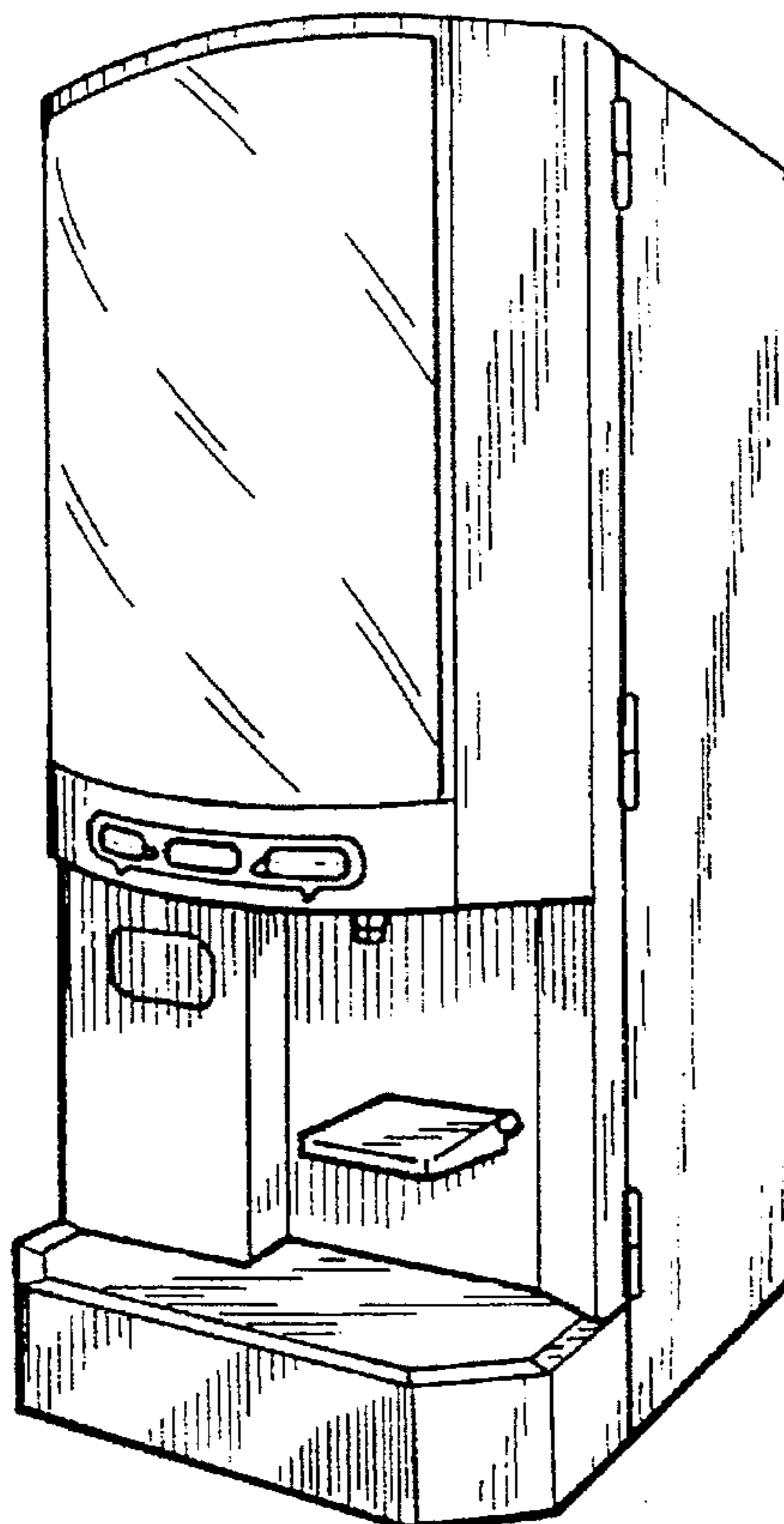

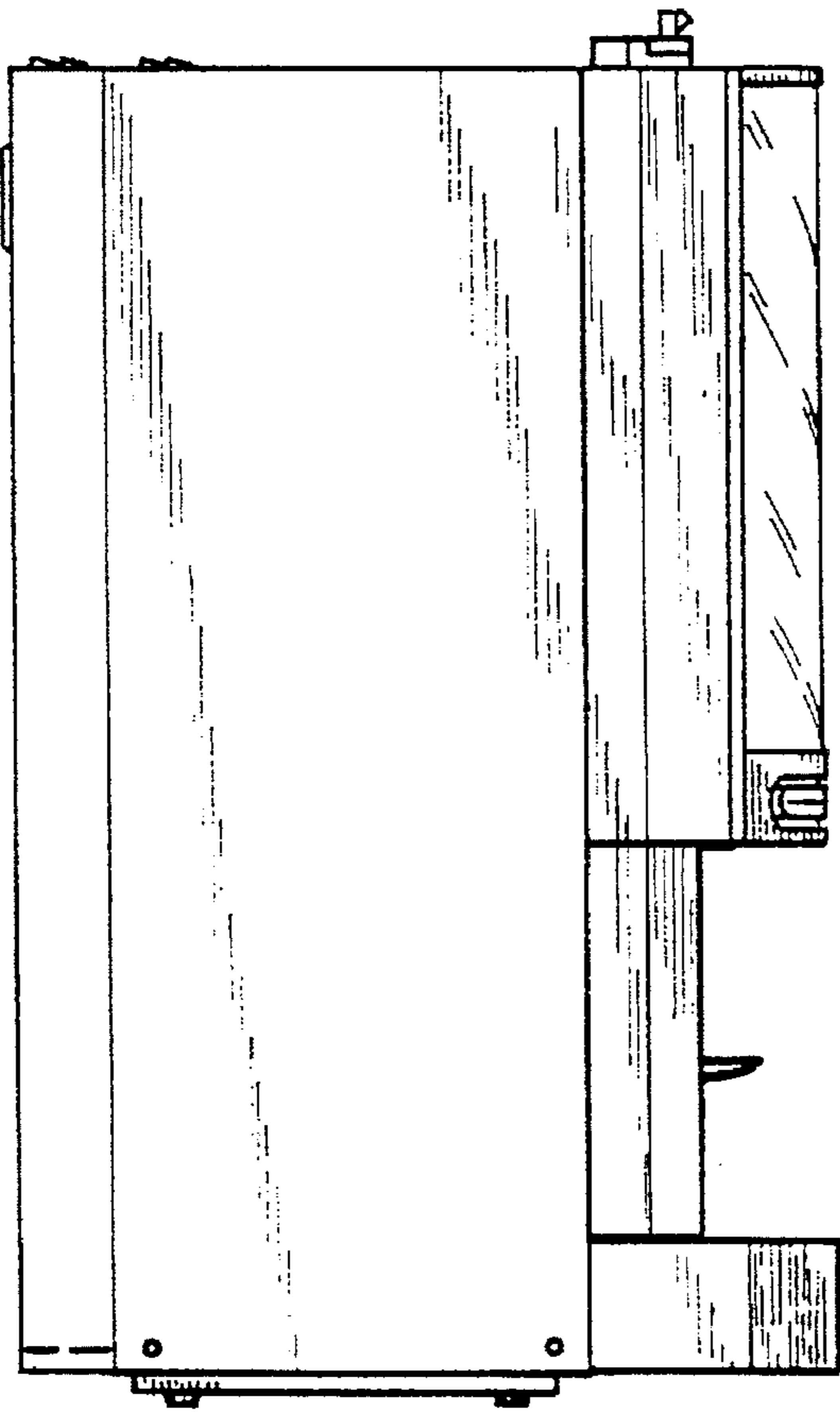
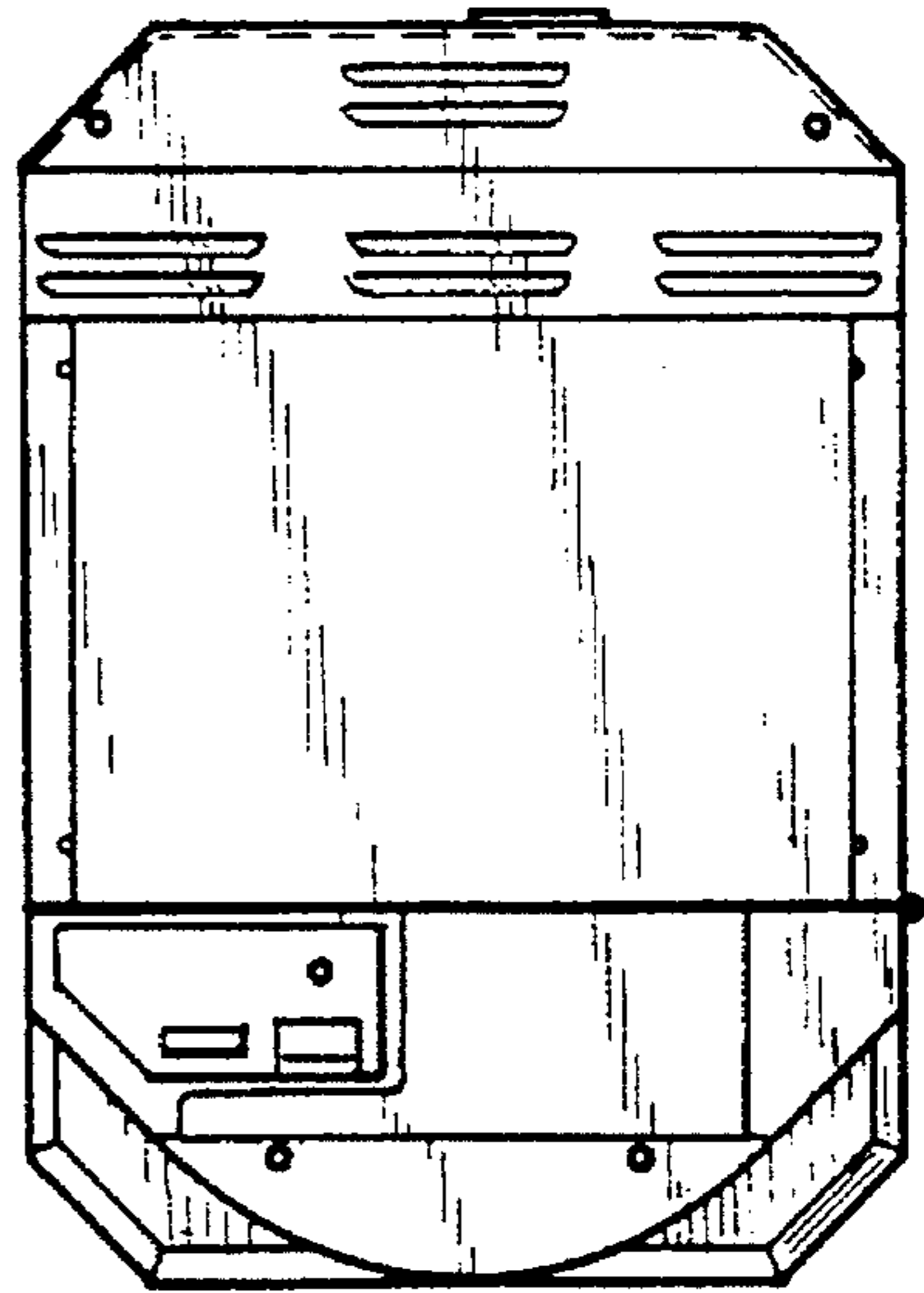

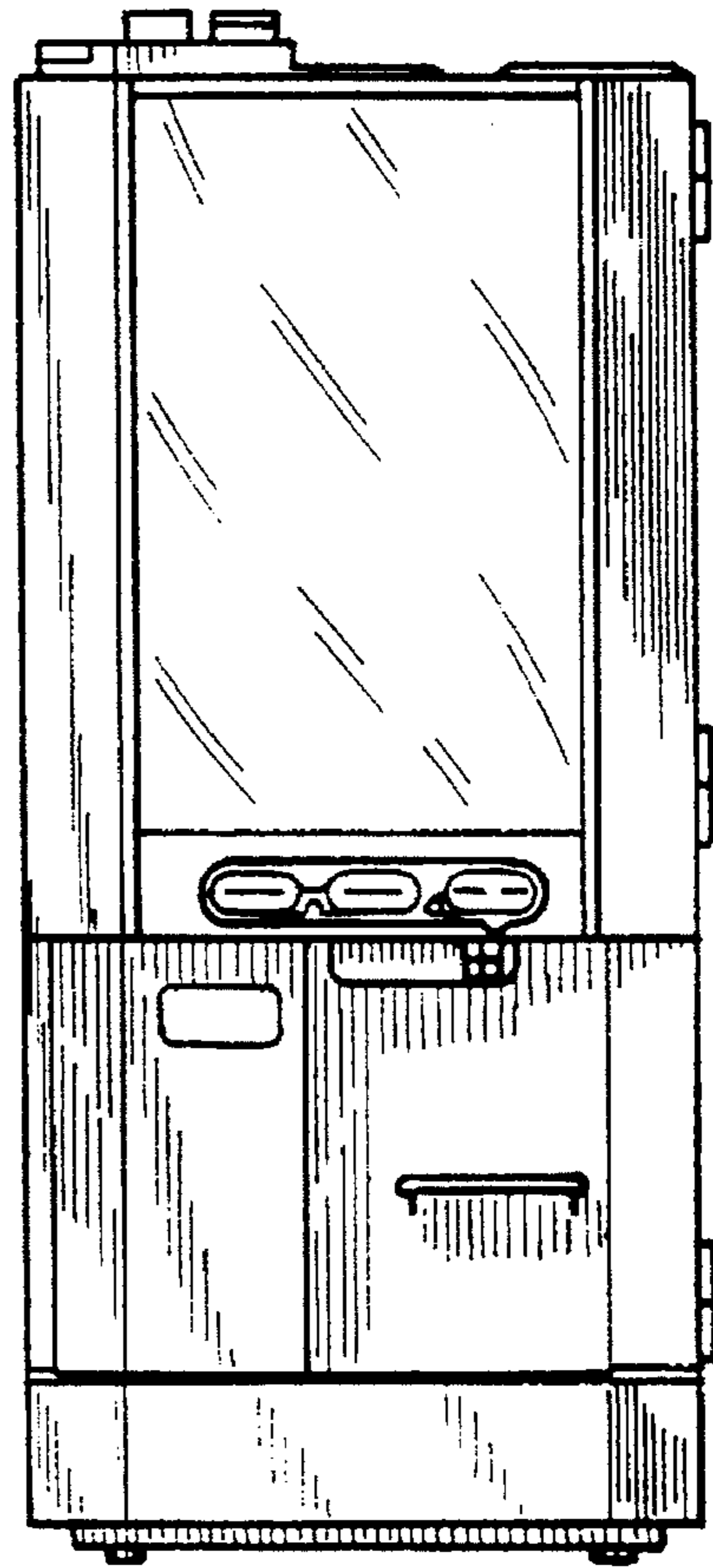

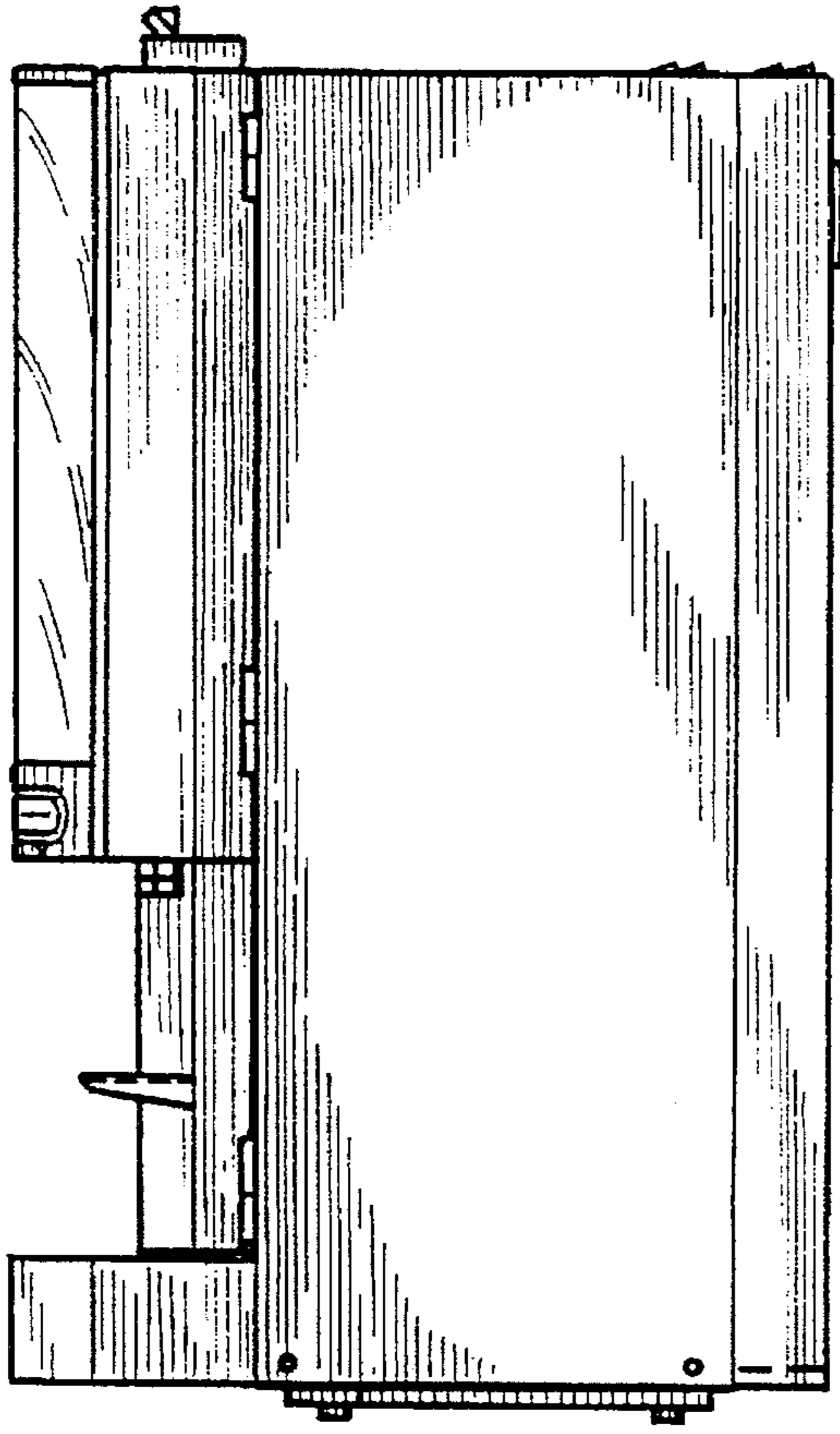

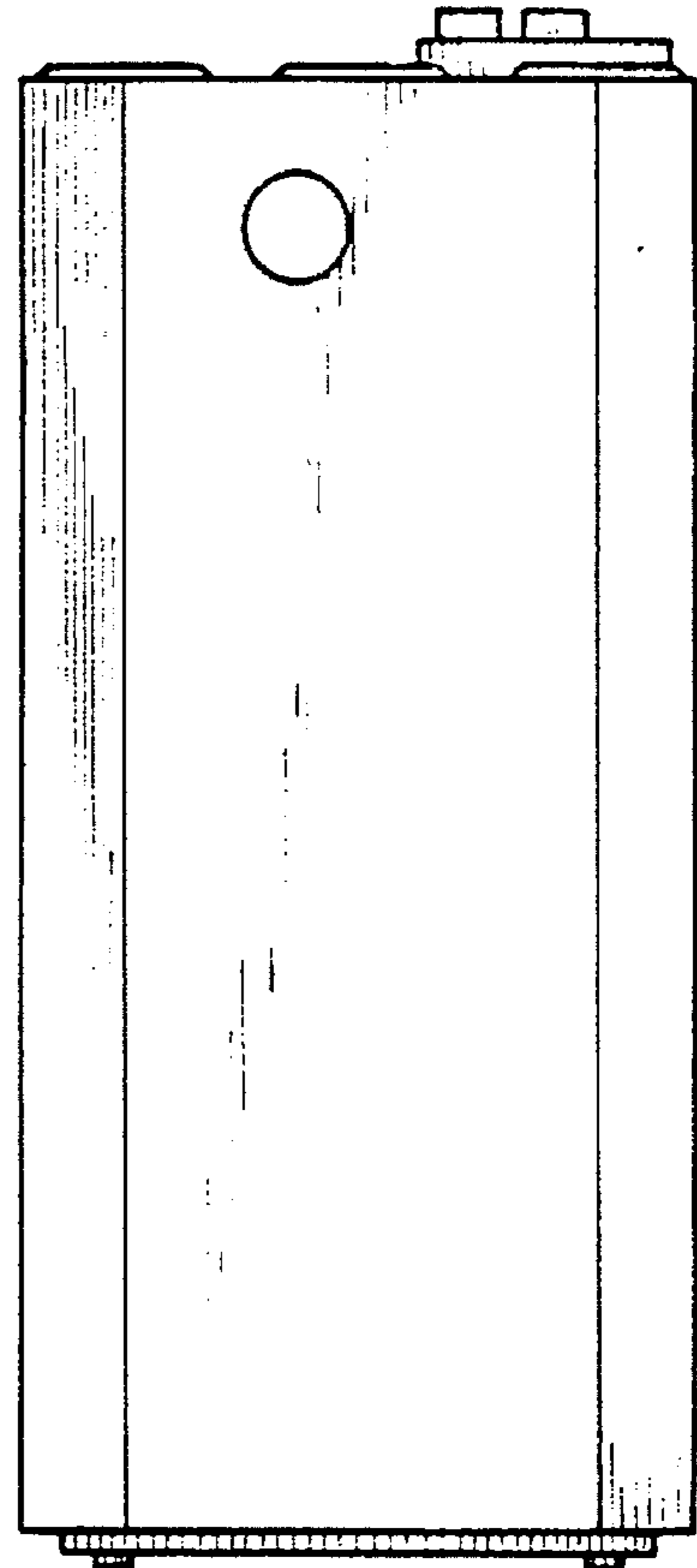

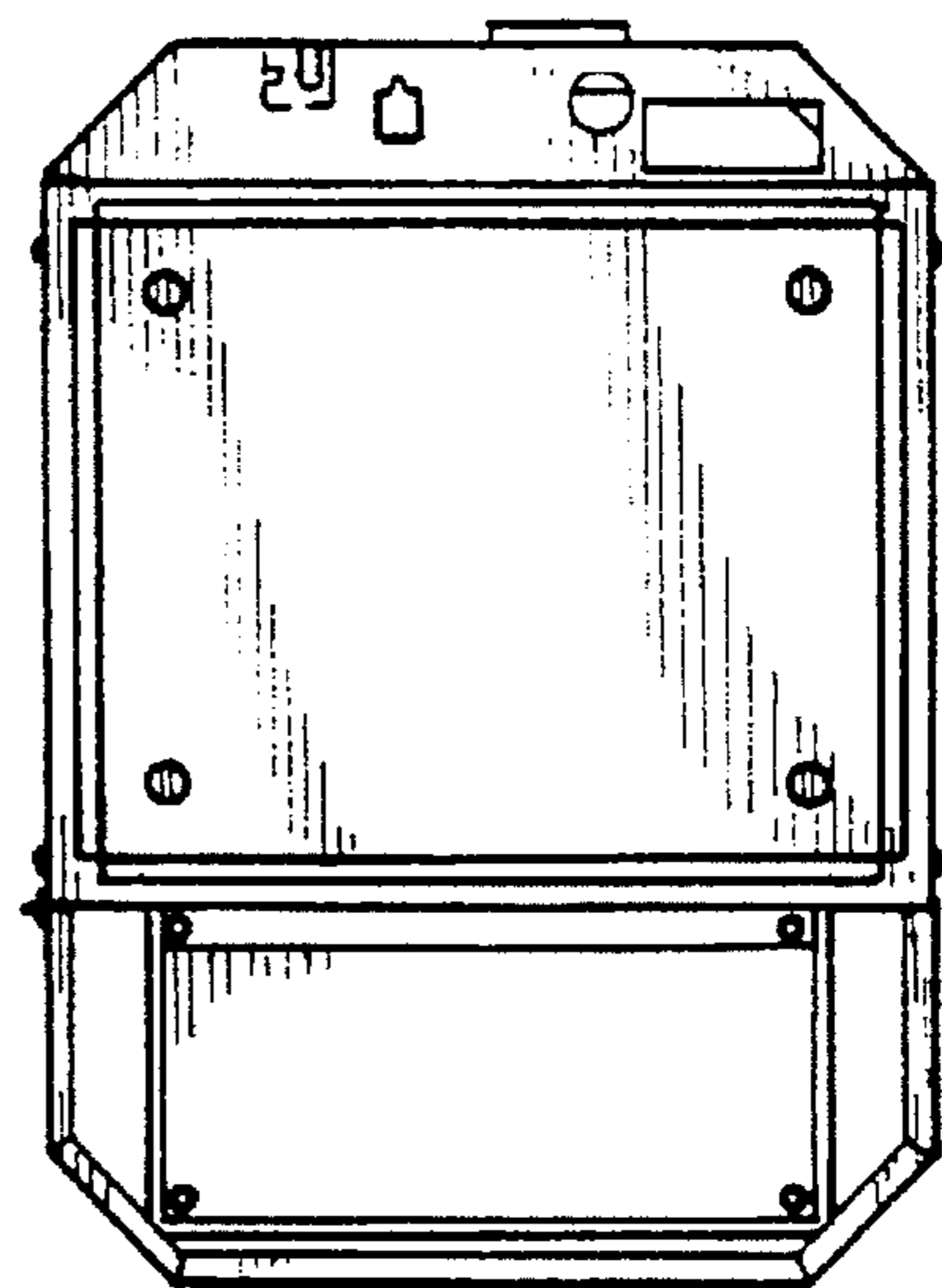

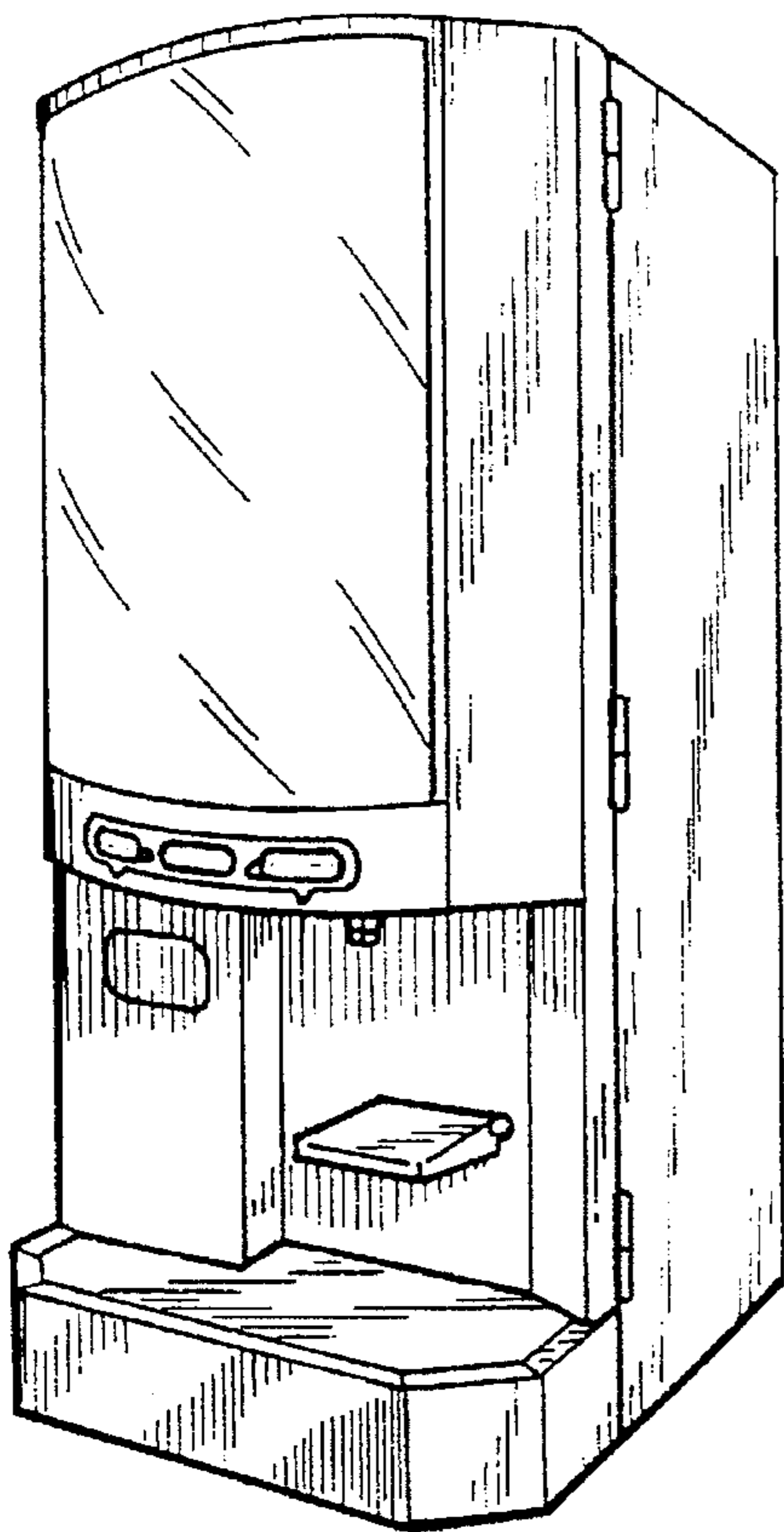

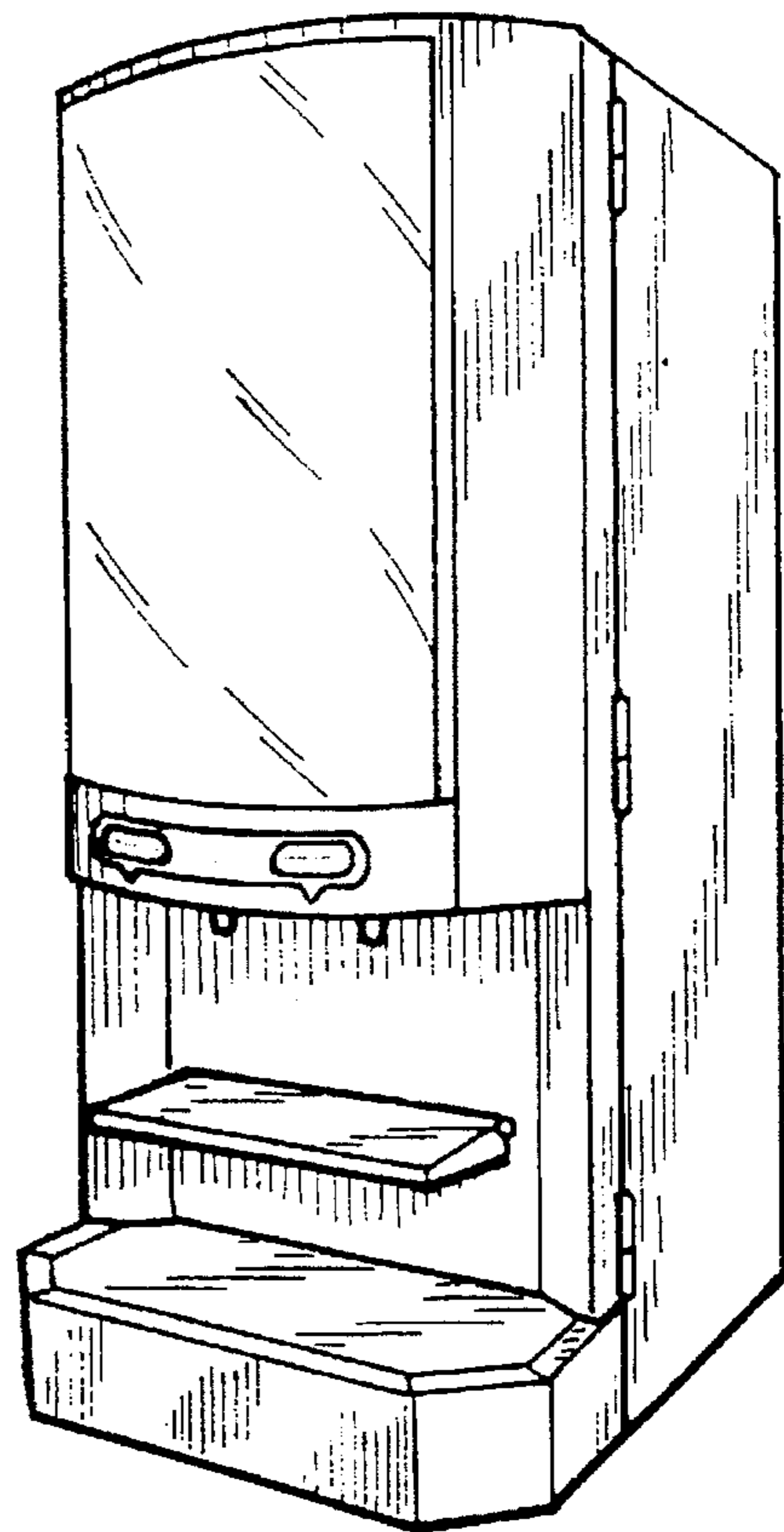

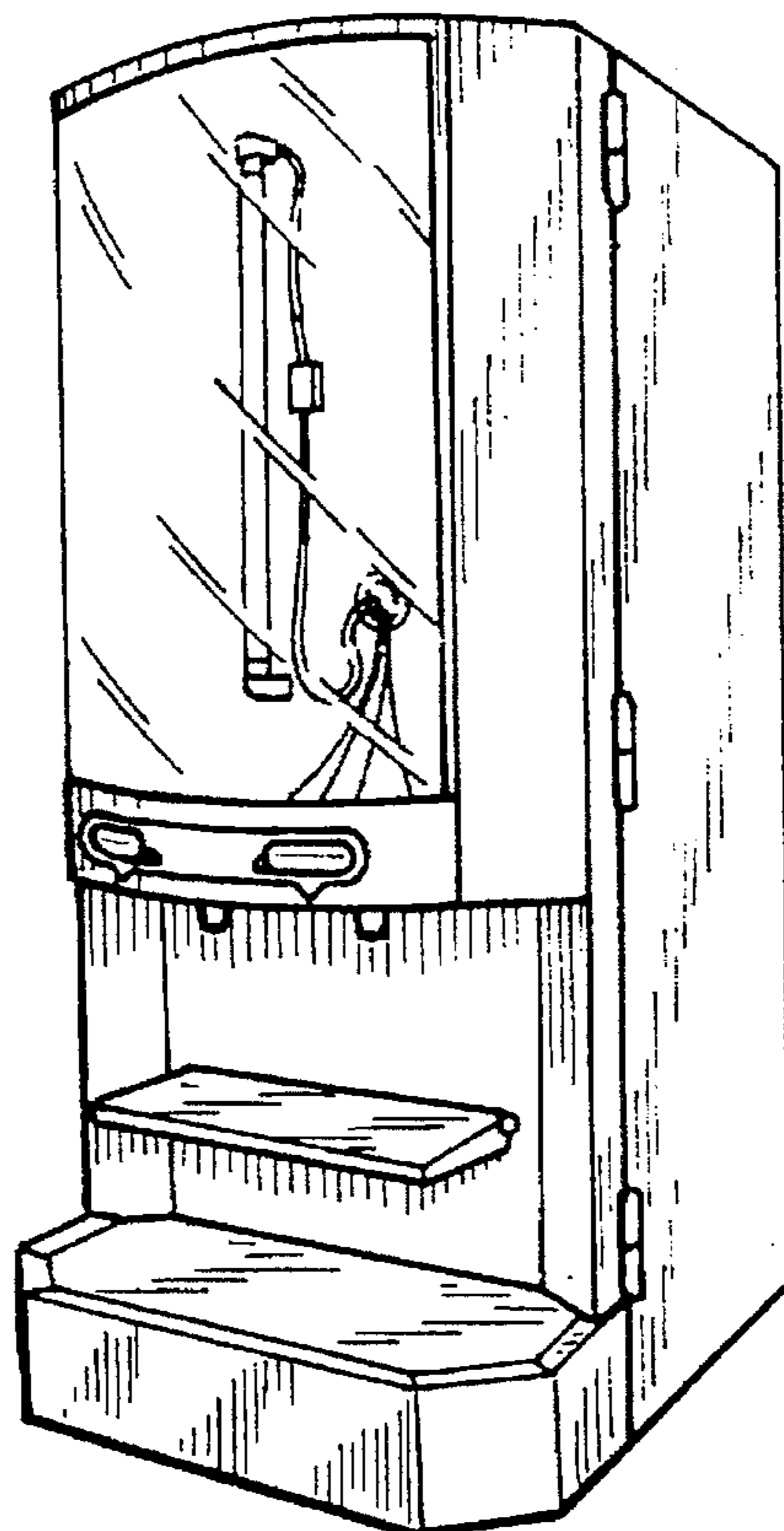

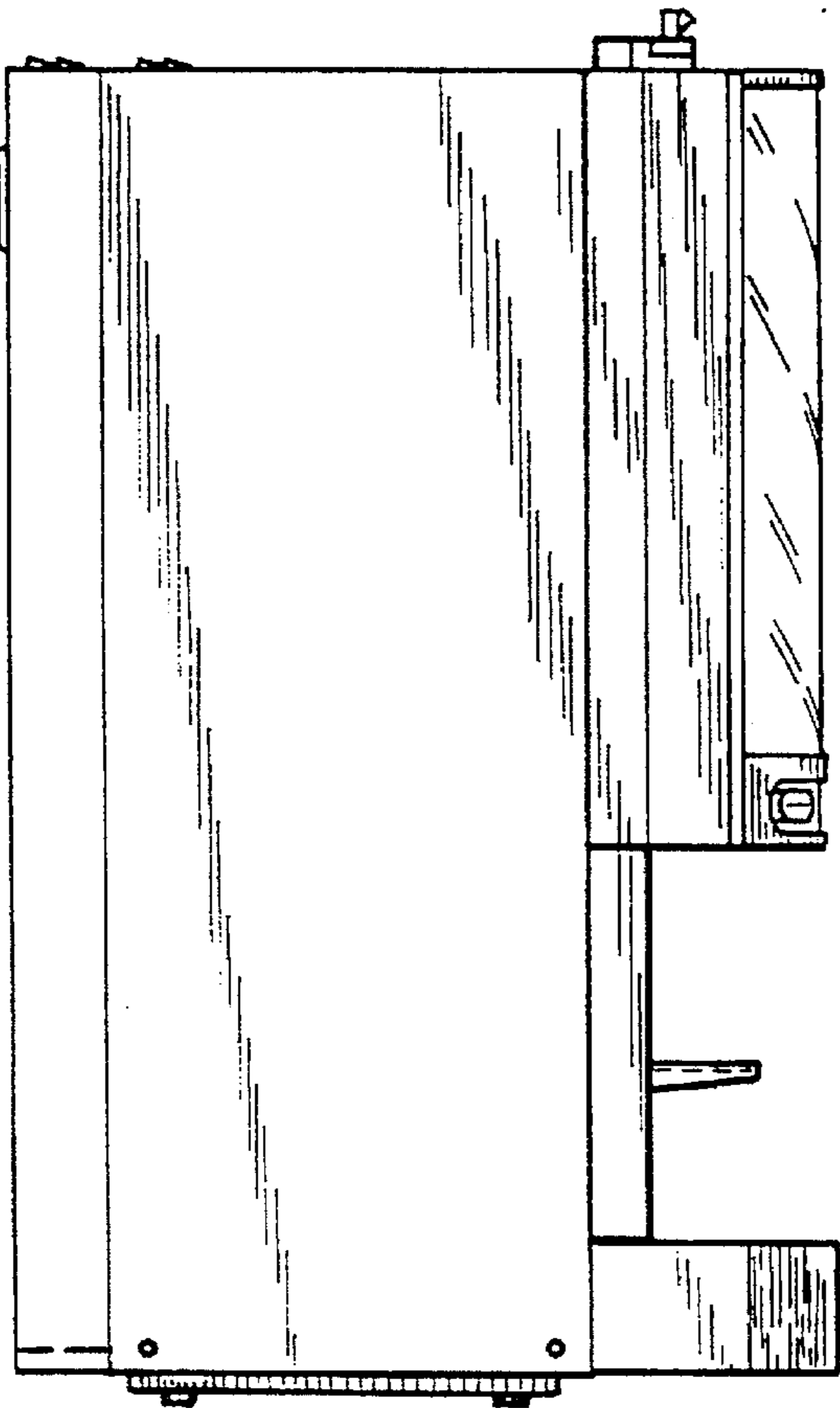
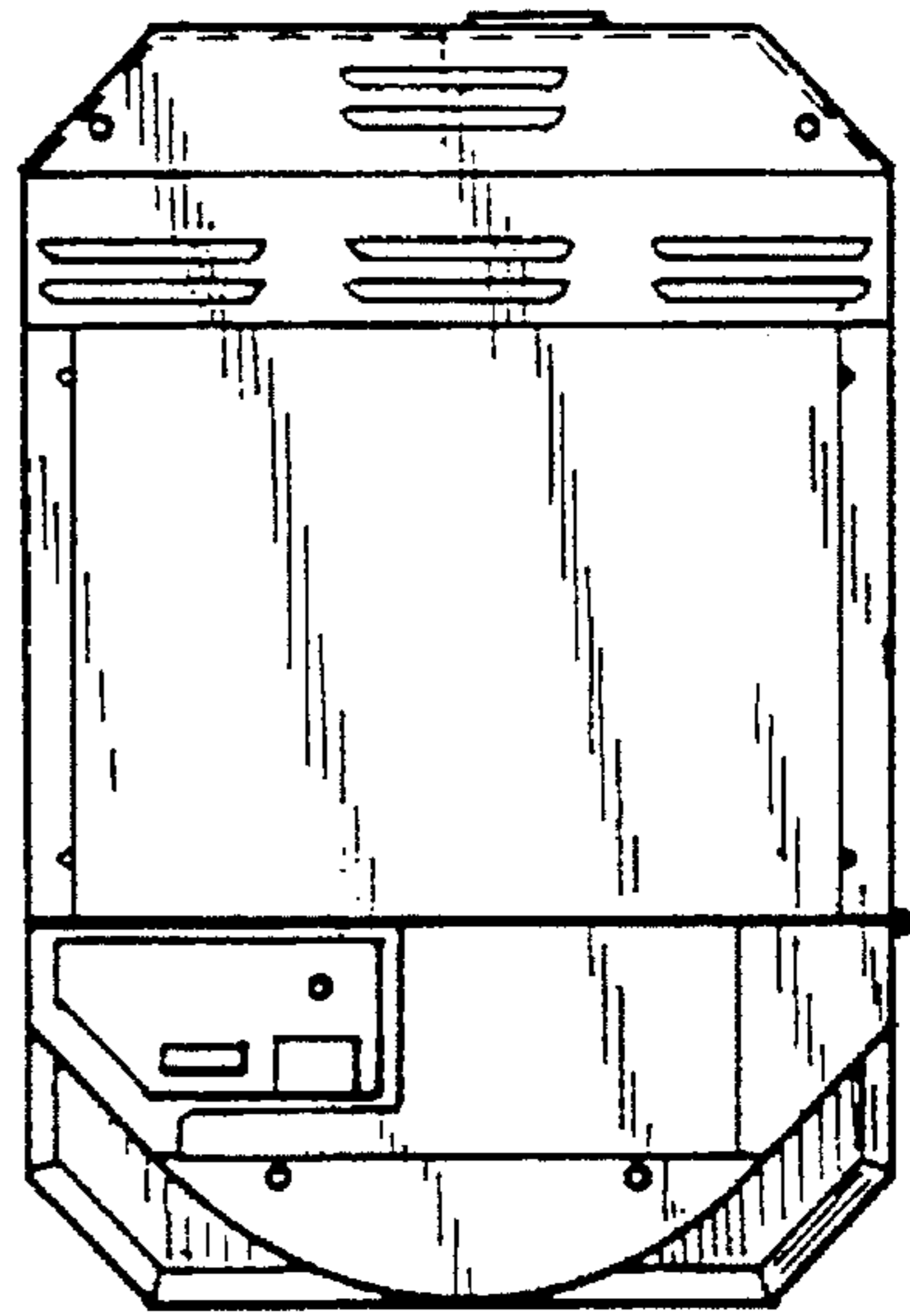

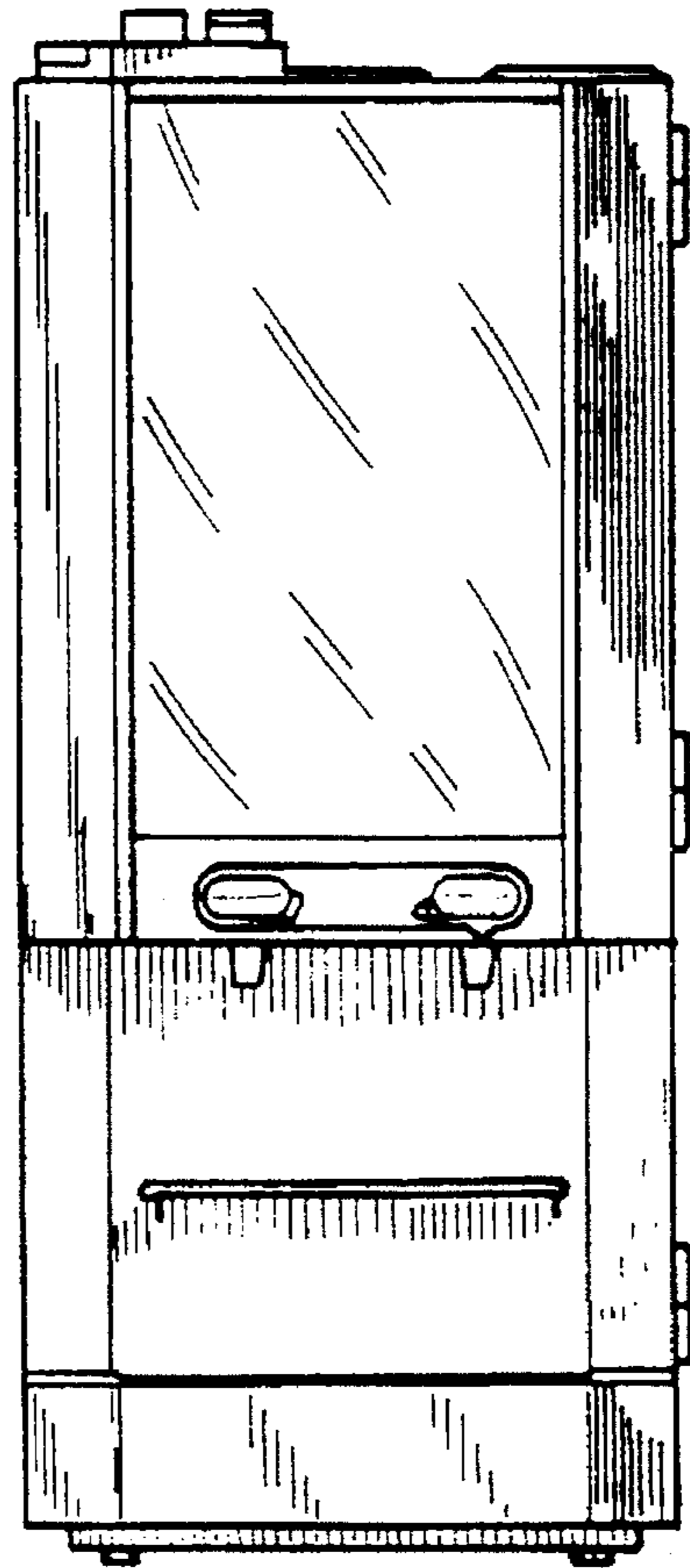

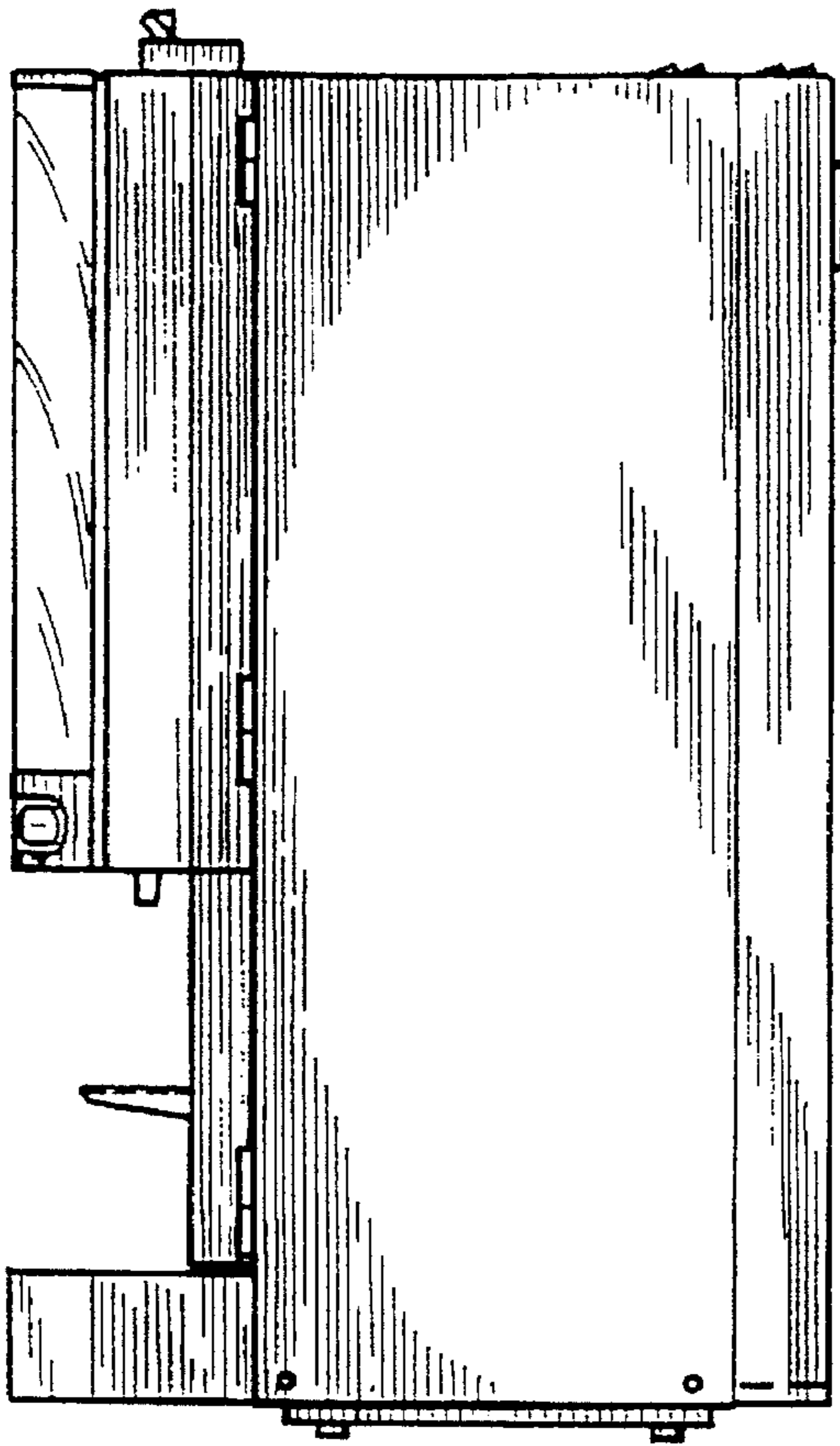

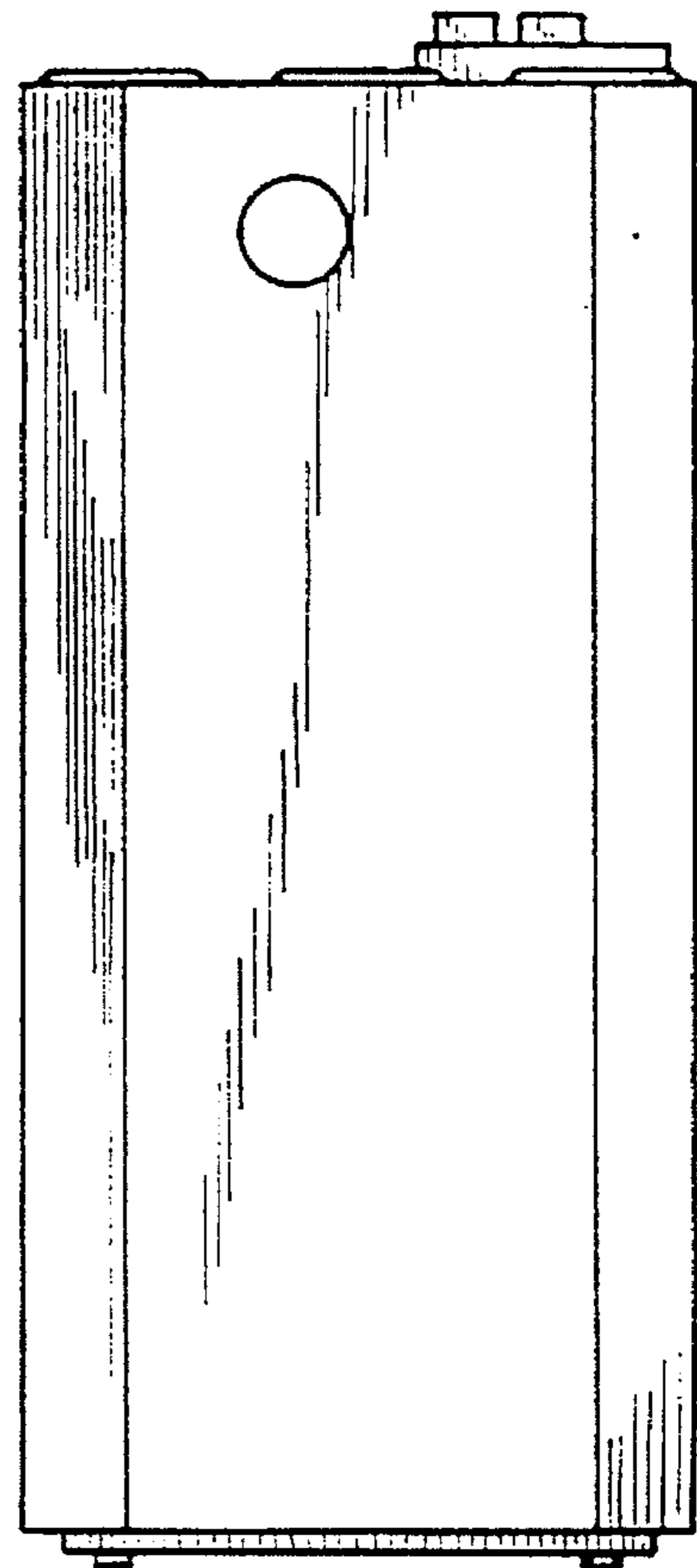

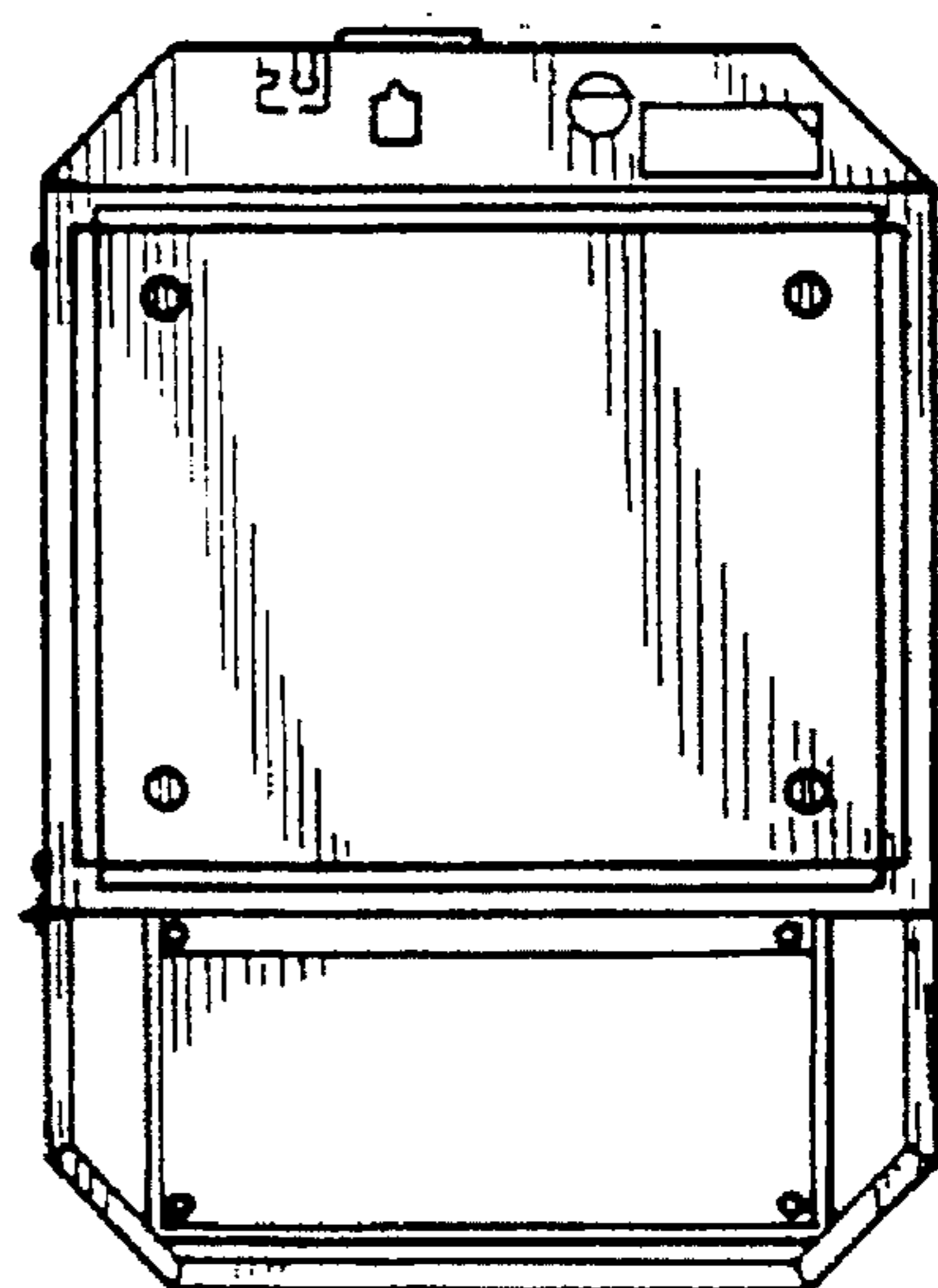

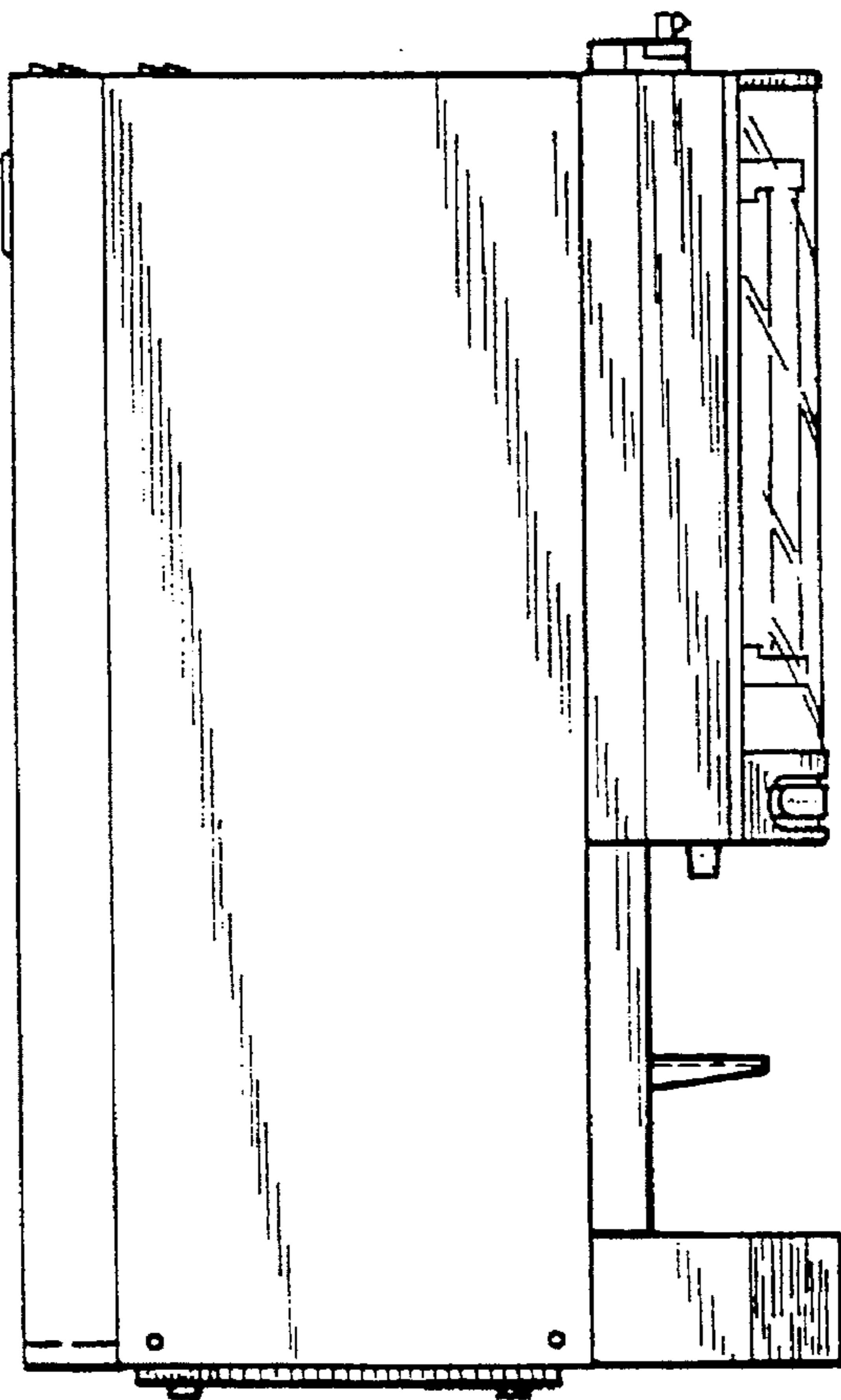
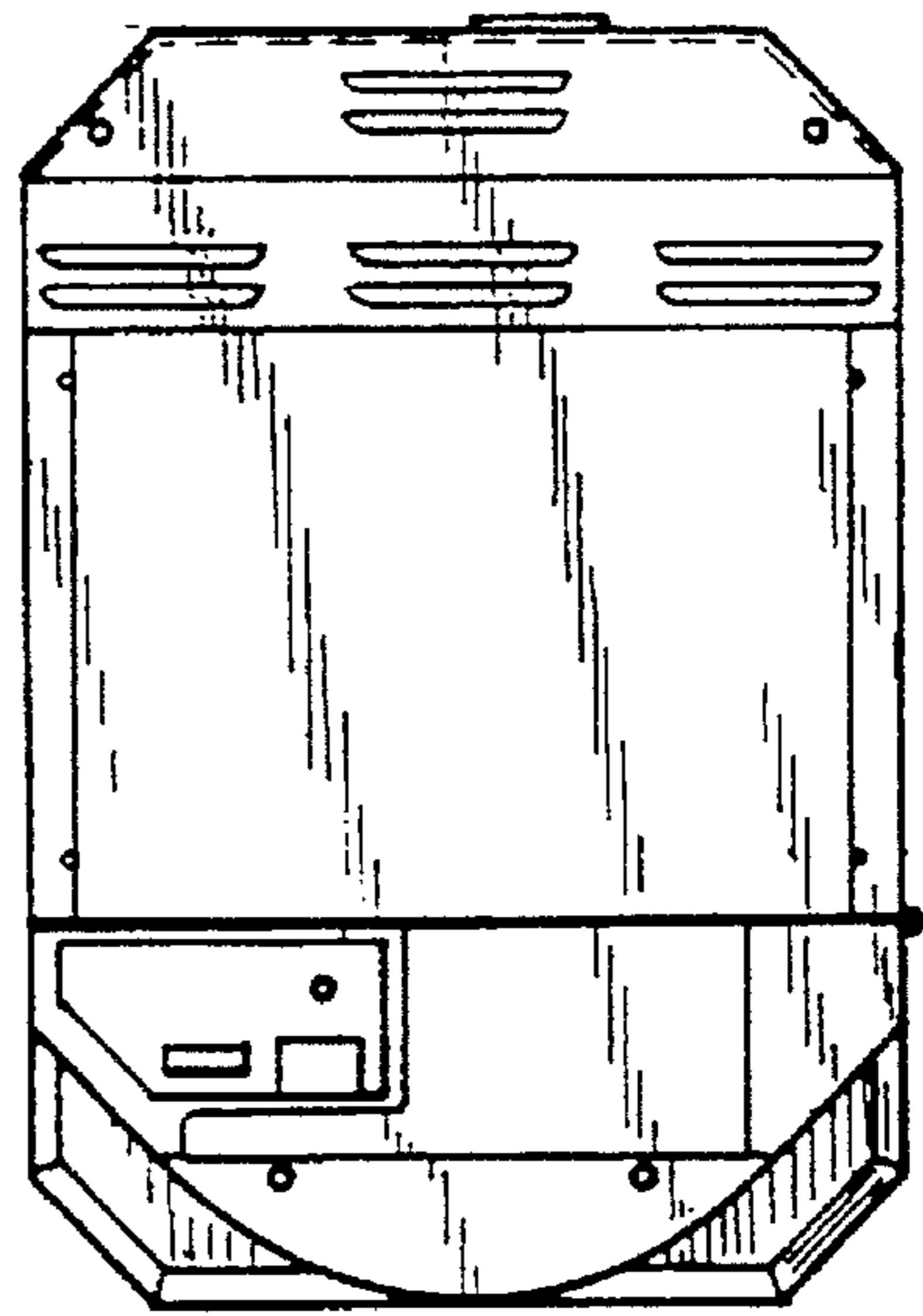

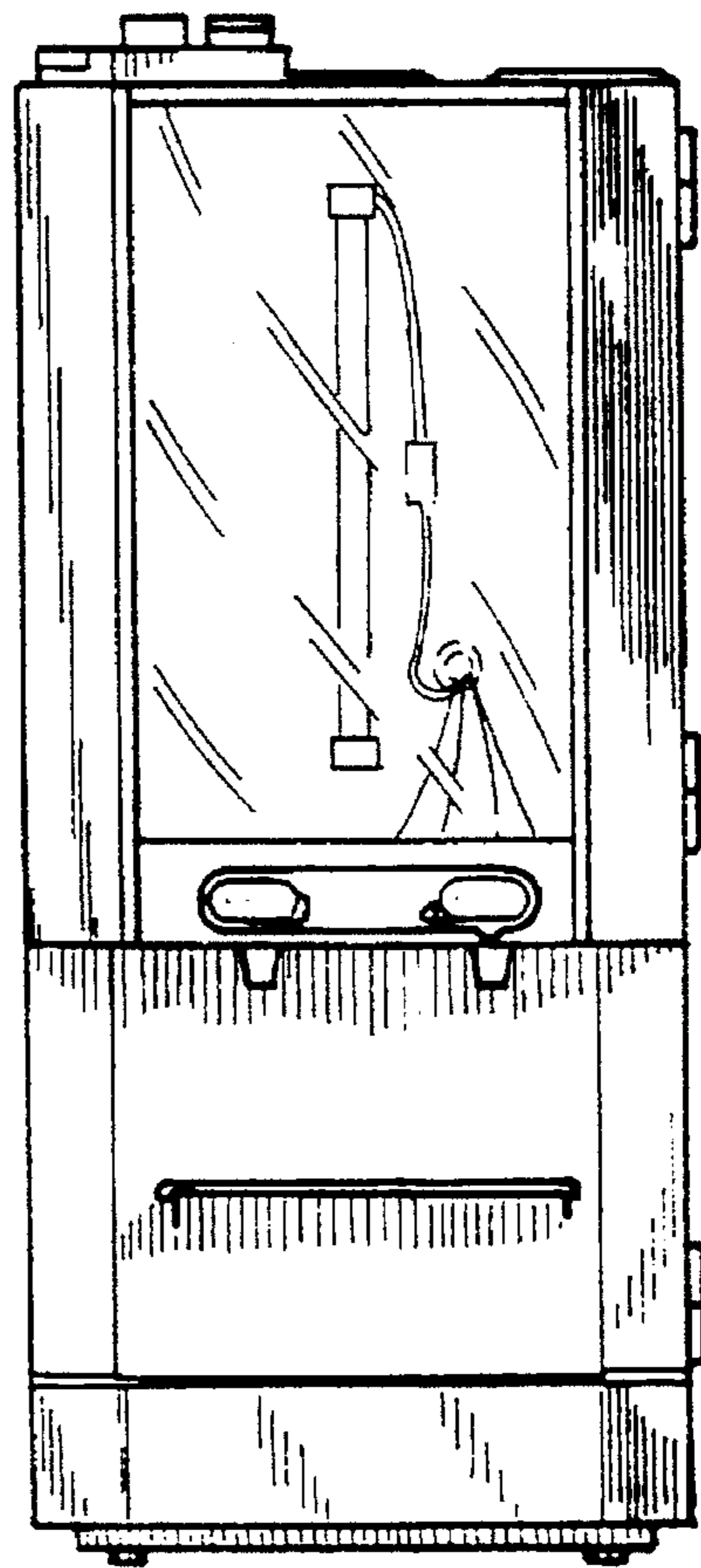

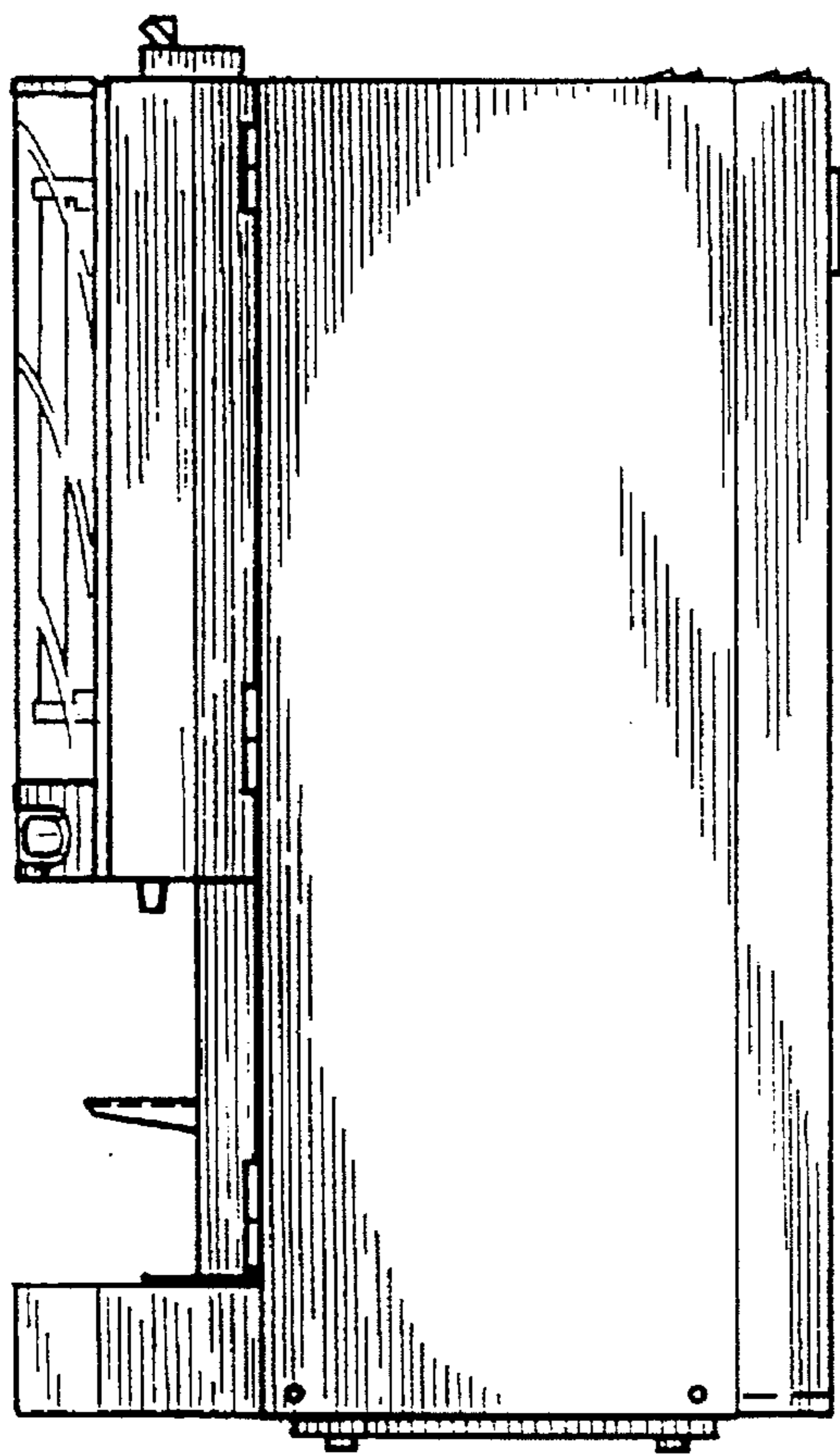

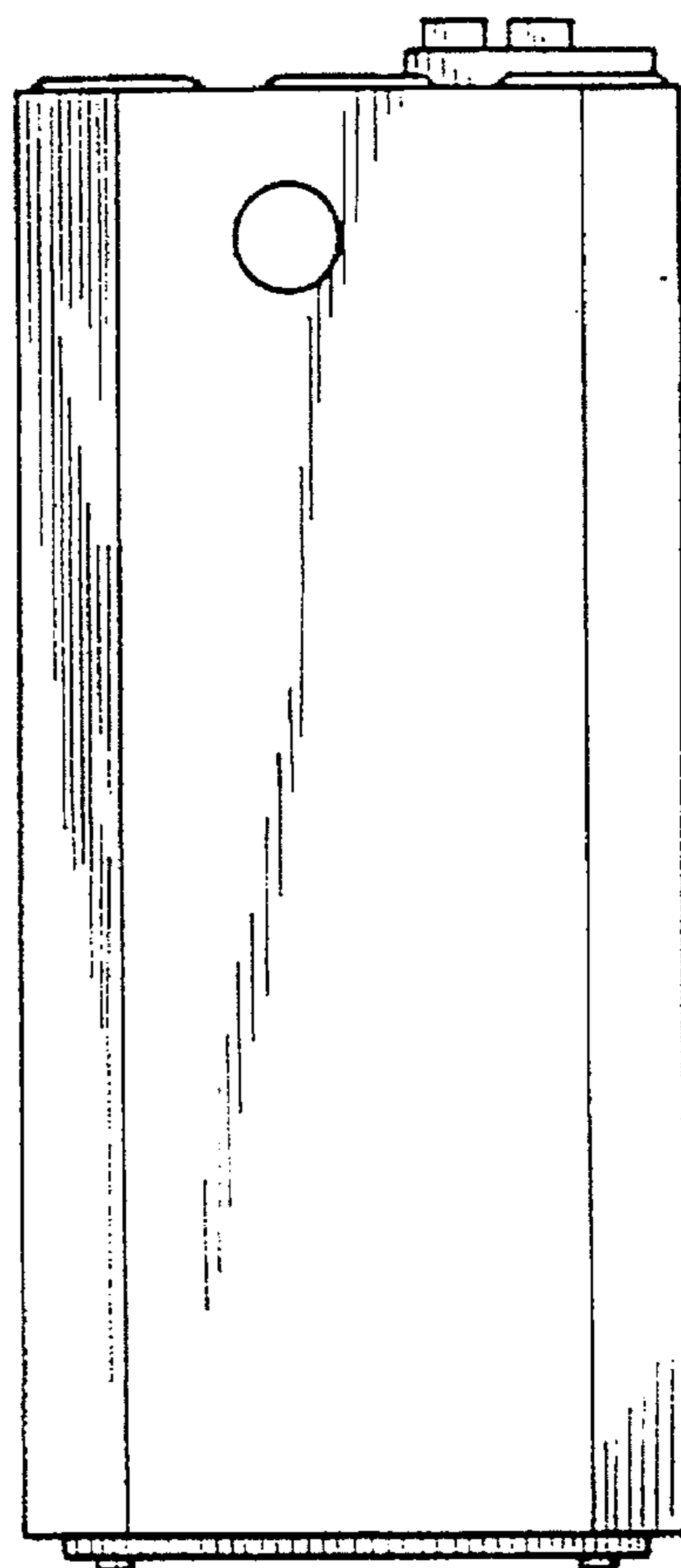

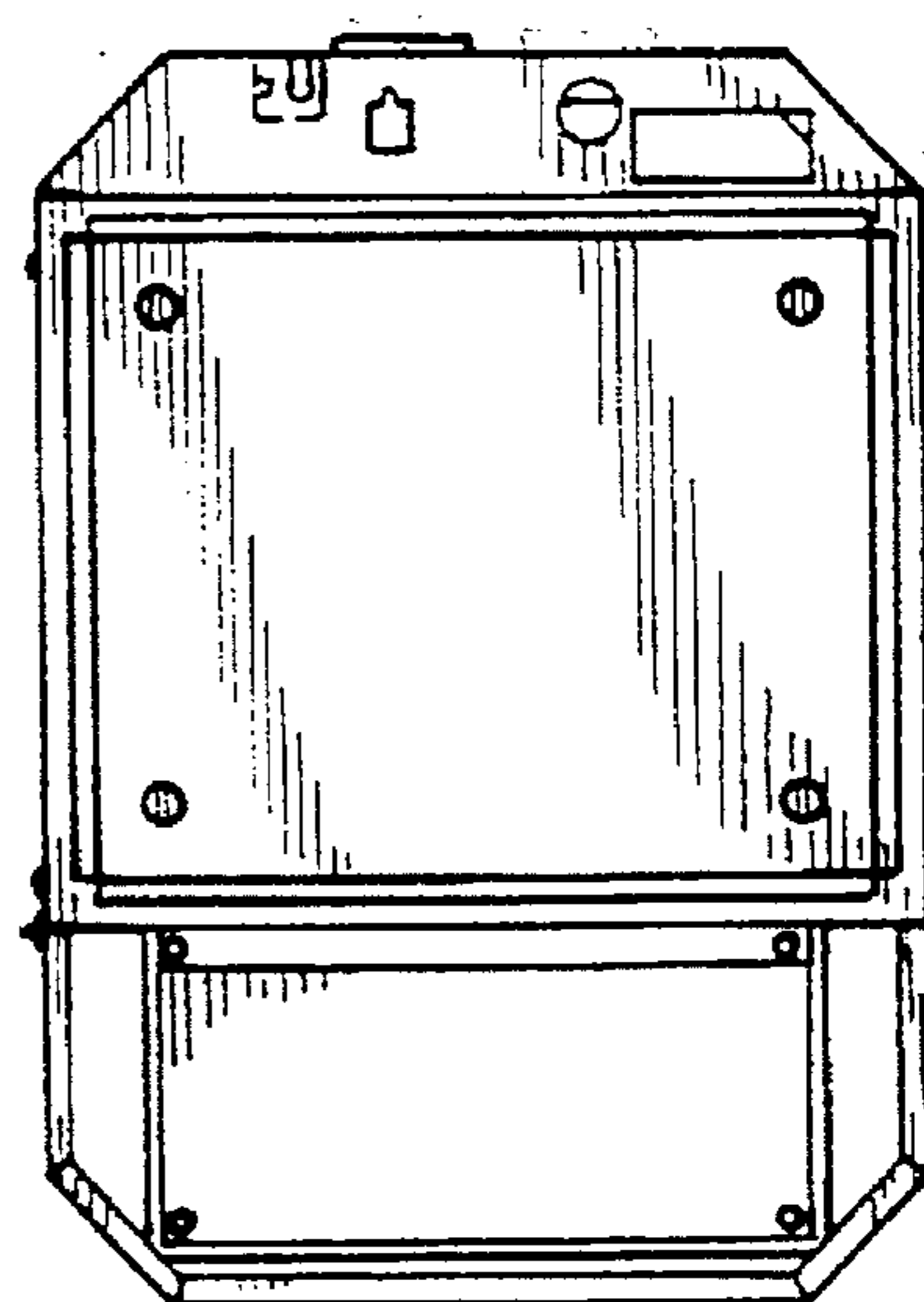
