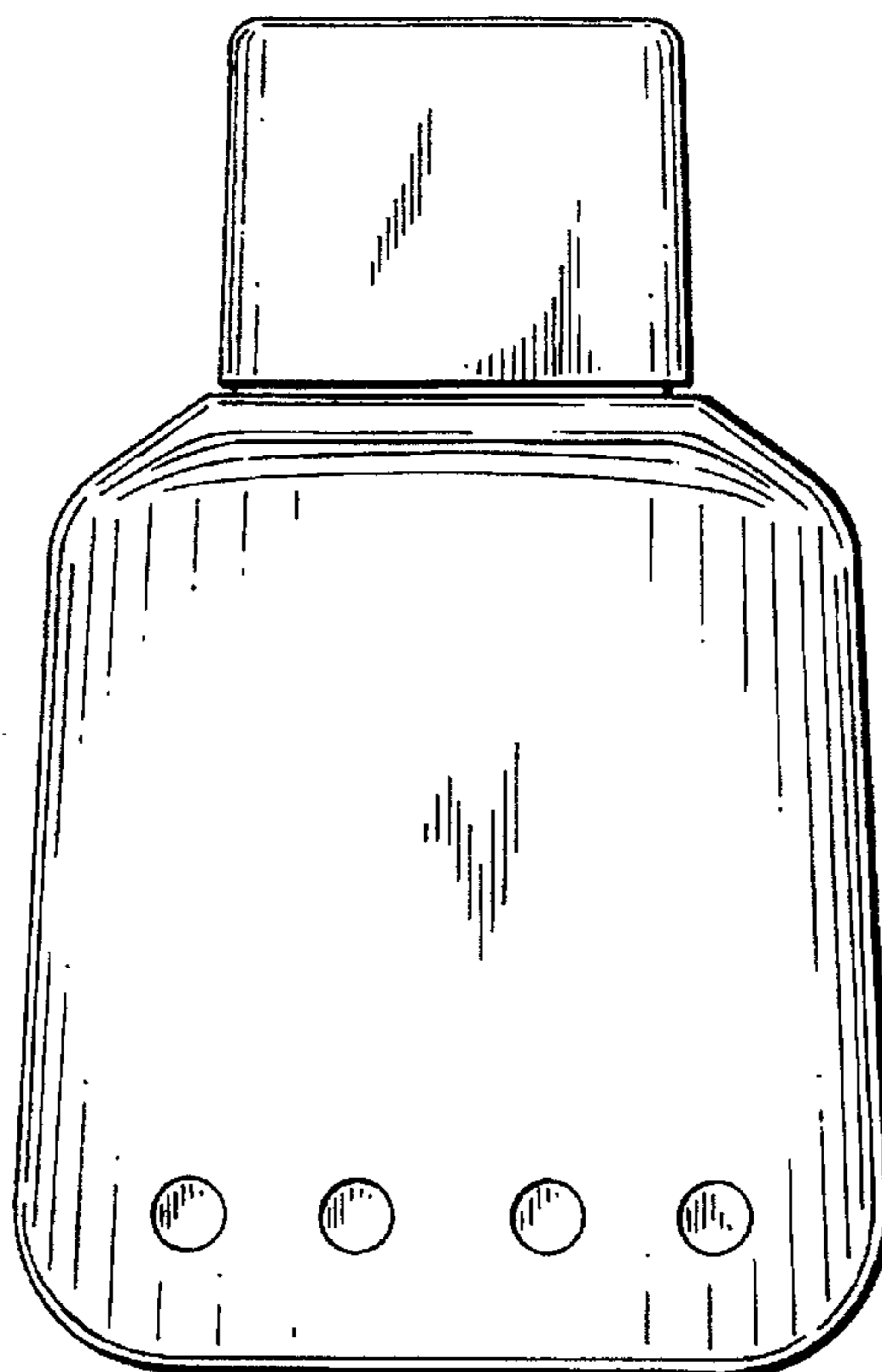
[57] CLAIM

The ornamental design for a combined bottle and cap as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined bottle and cap showing my new design;
 FIG. 2 is a front elevation thereof, the rear elevation is the same;
 FIG. 3 is a left side elevation thereof, the right side elevation is the same;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a first alternative embodiment of the combined bottle and cap of FIG. 1;
 FIG. 7 is a front elevation of FIG. 6, the rear elevation is the same;
 FIG. 8 is a left side elevation of FIG. 6, the right side elevation is the same;
 FIG. 9 is a top plan view of the combined bottle and cap of FIG. 6;
 FIG. 10 is a bottom plan view of the combined bottle and cap of FIG. 6;
 FIG. 11 is a perspective view of a second alternative embodiment of the combined bottle and cap of FIG. 1;
 FIG. 12 is a front elevation of FIG. 11, the rear elevation is the same;
 FIG. 13 is a left side elevation of FIG. 11, the right side elevation is the same;
 FIG. 14 is a top plan view of the combined bottle and cap of FIG. 11; and,

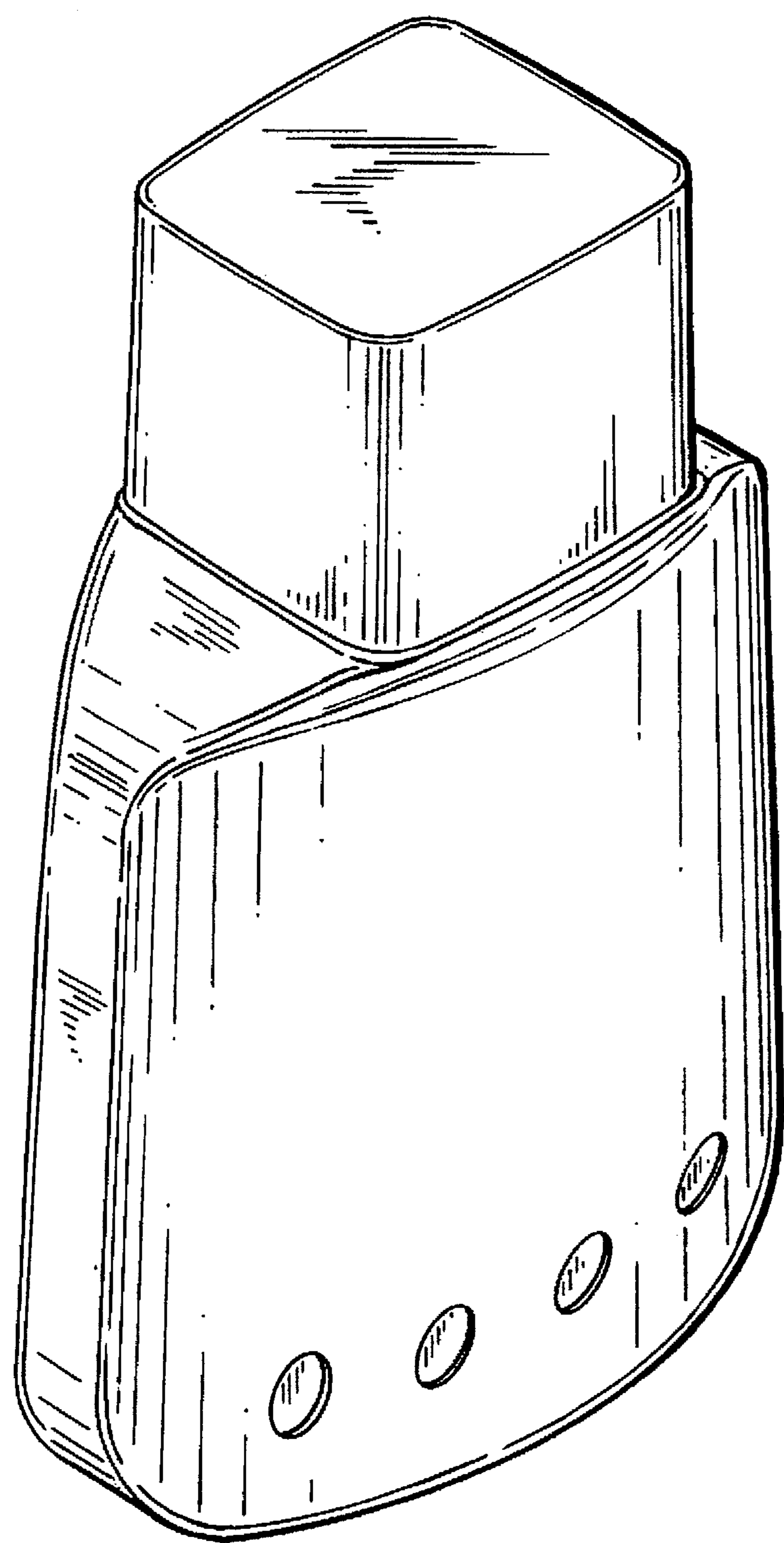

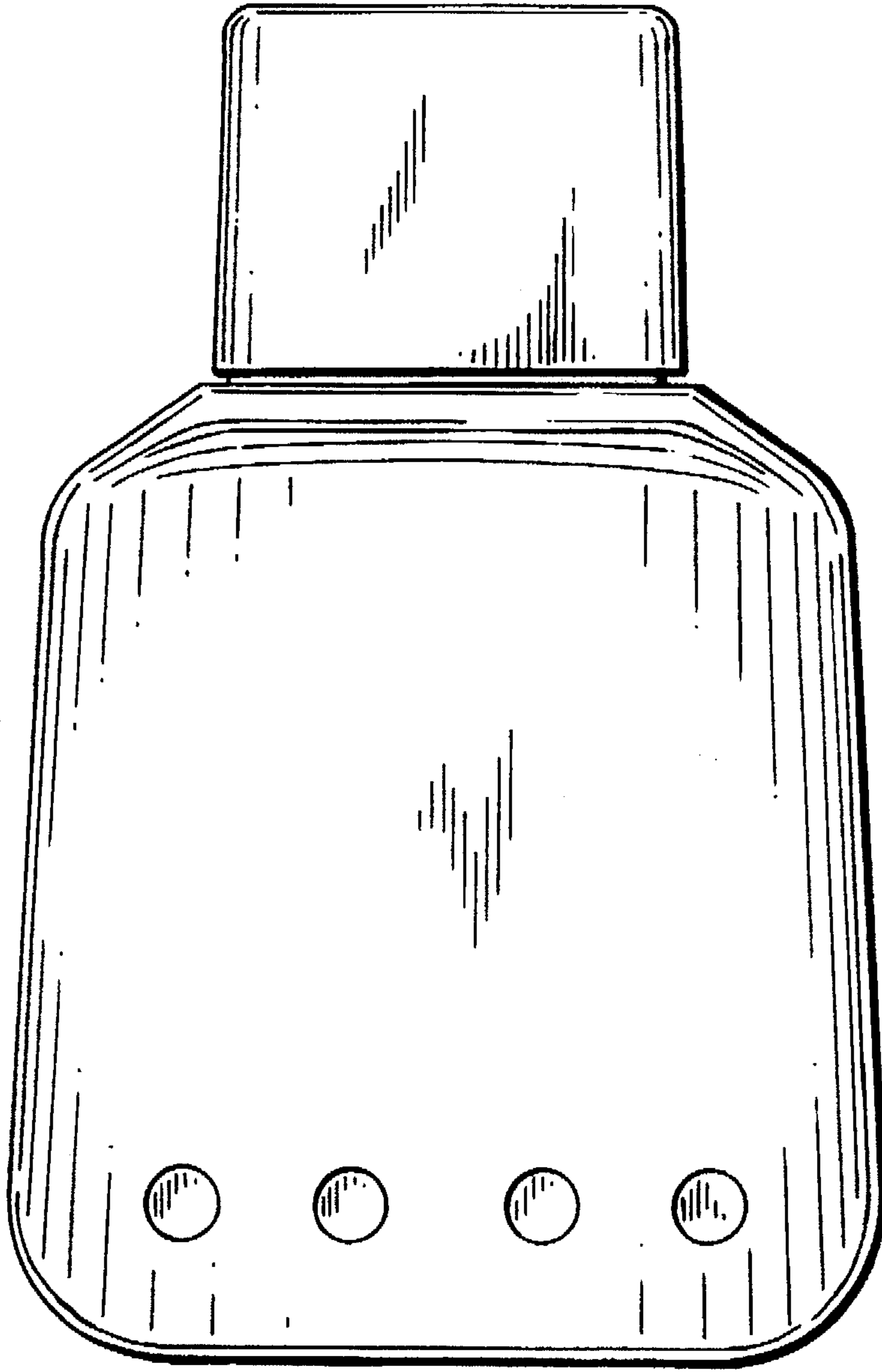

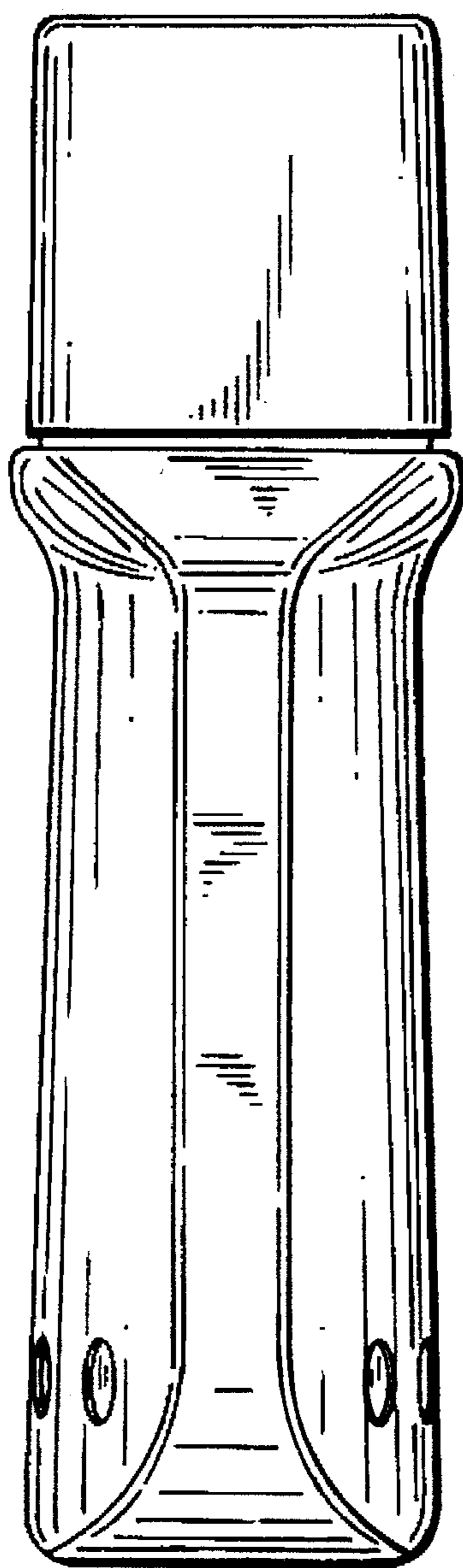

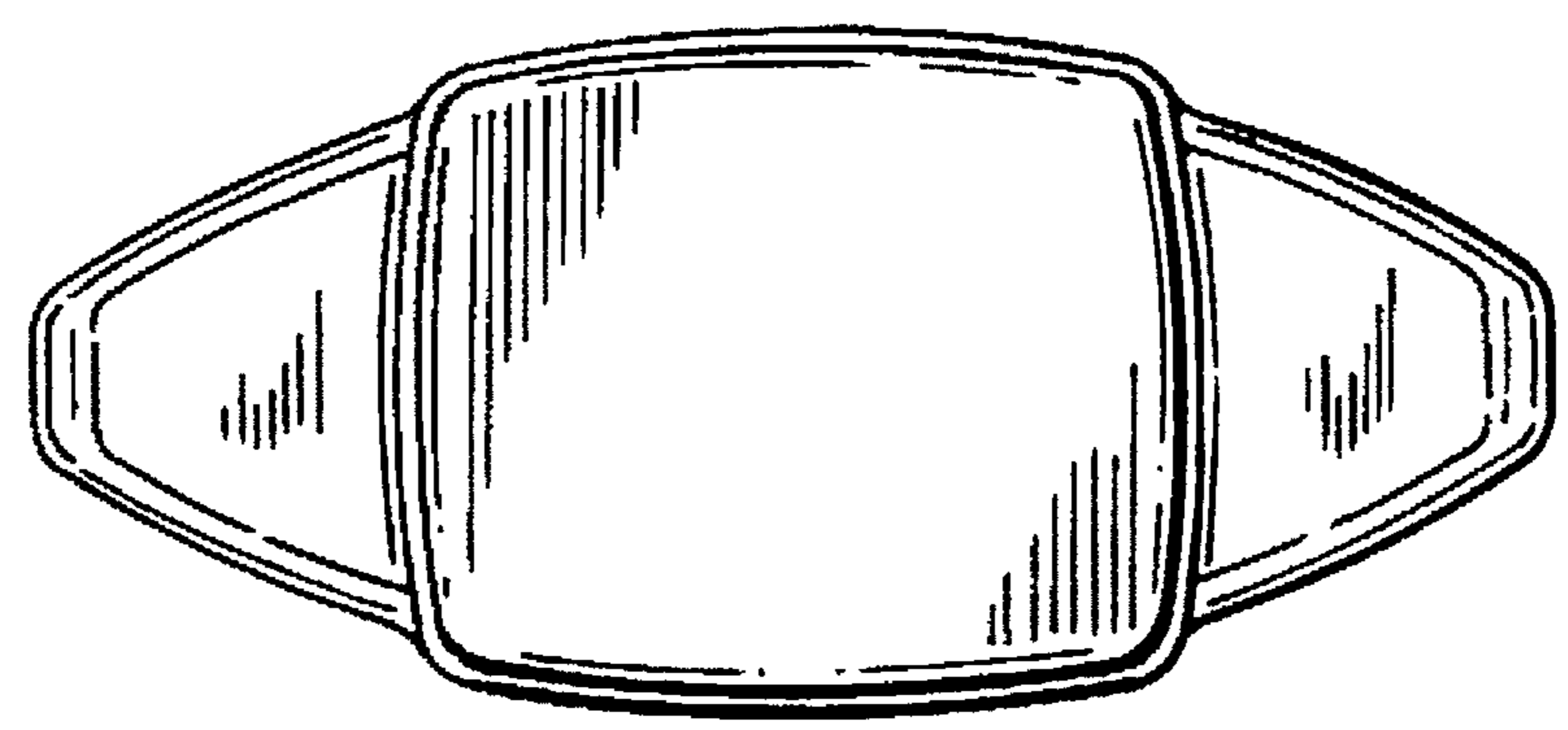

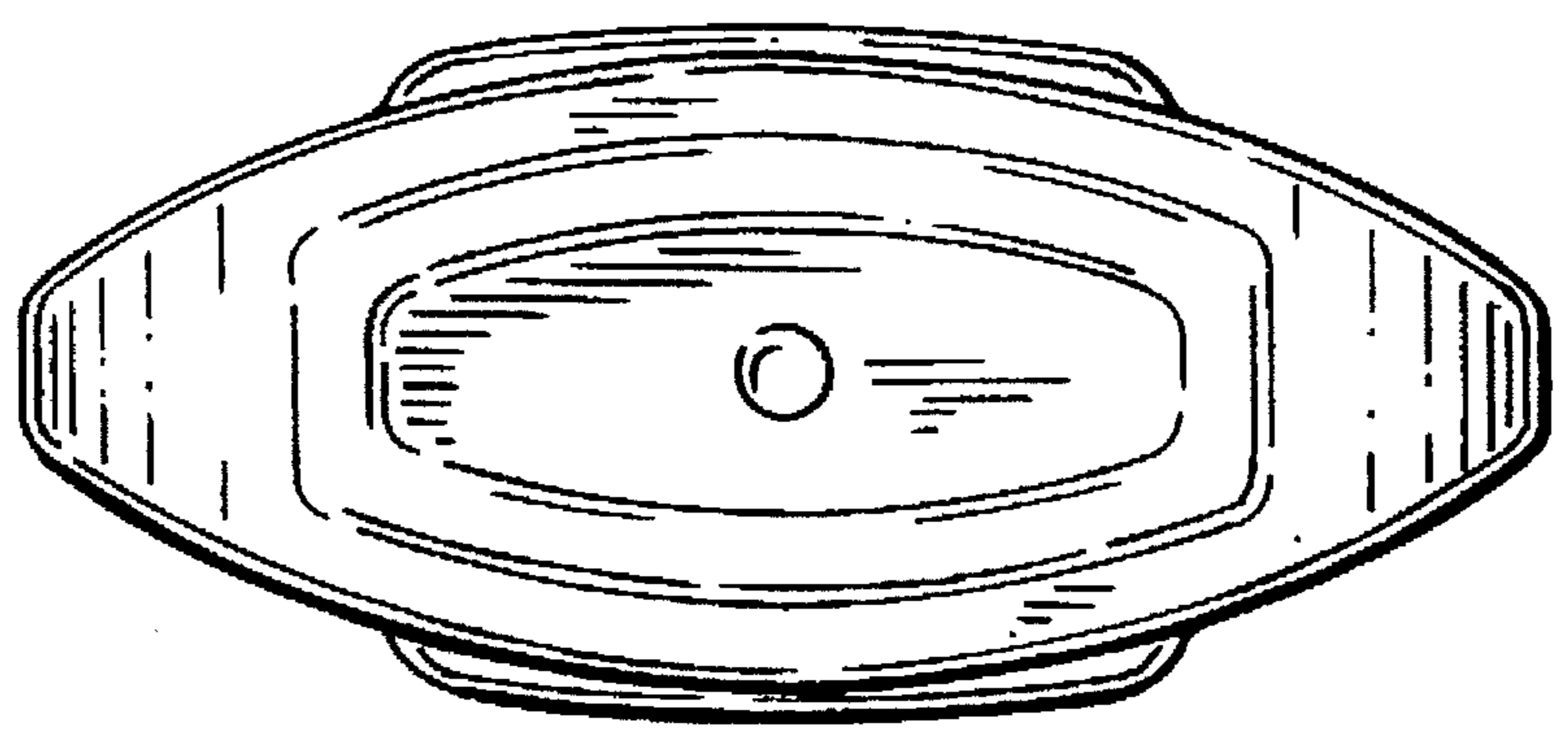

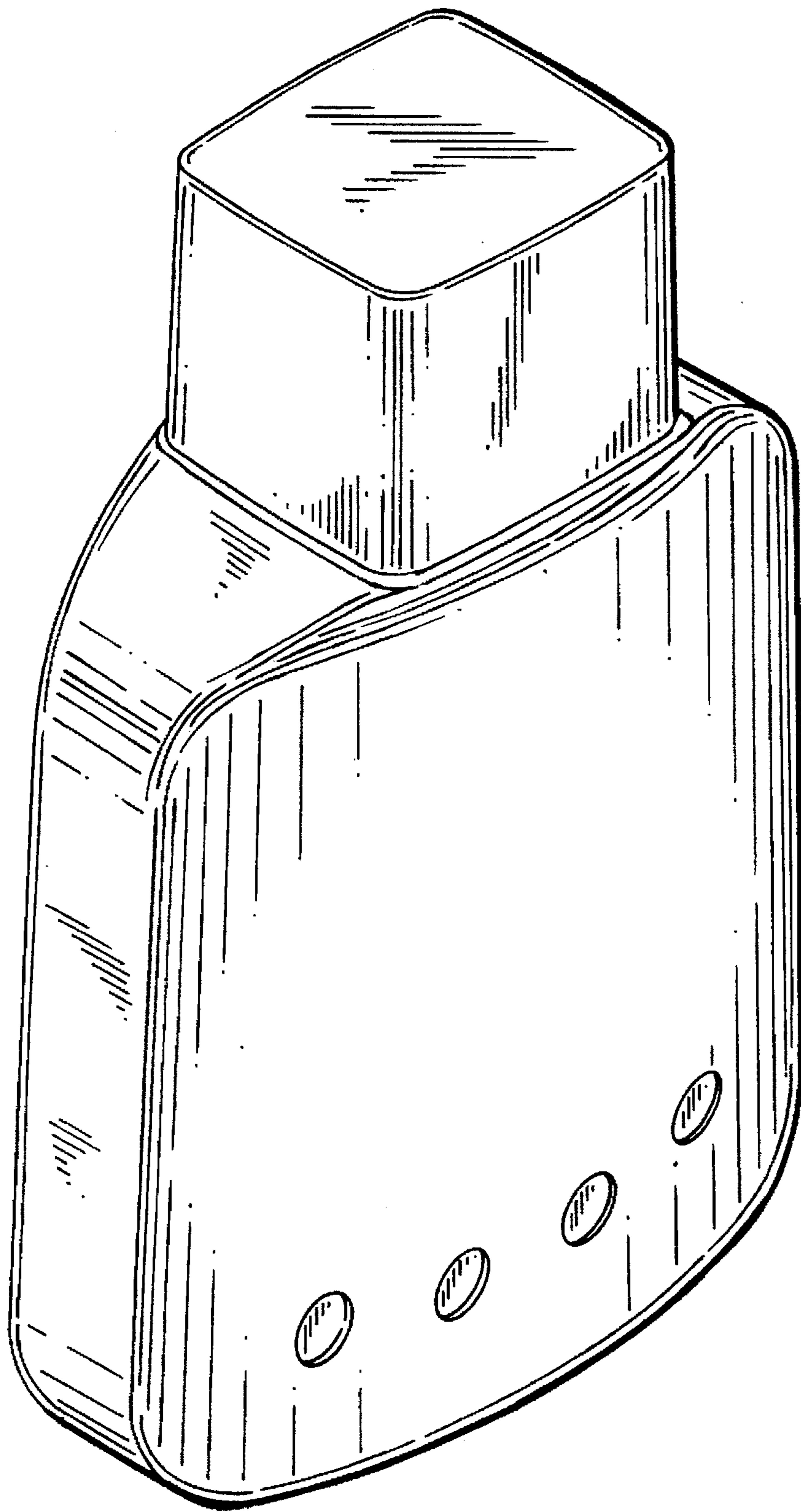

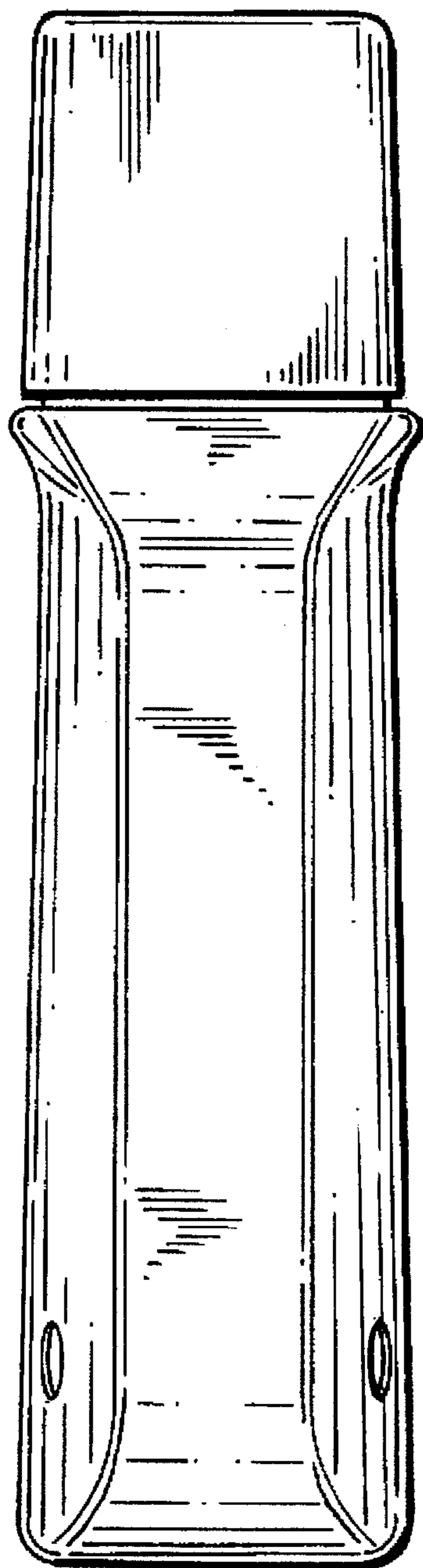

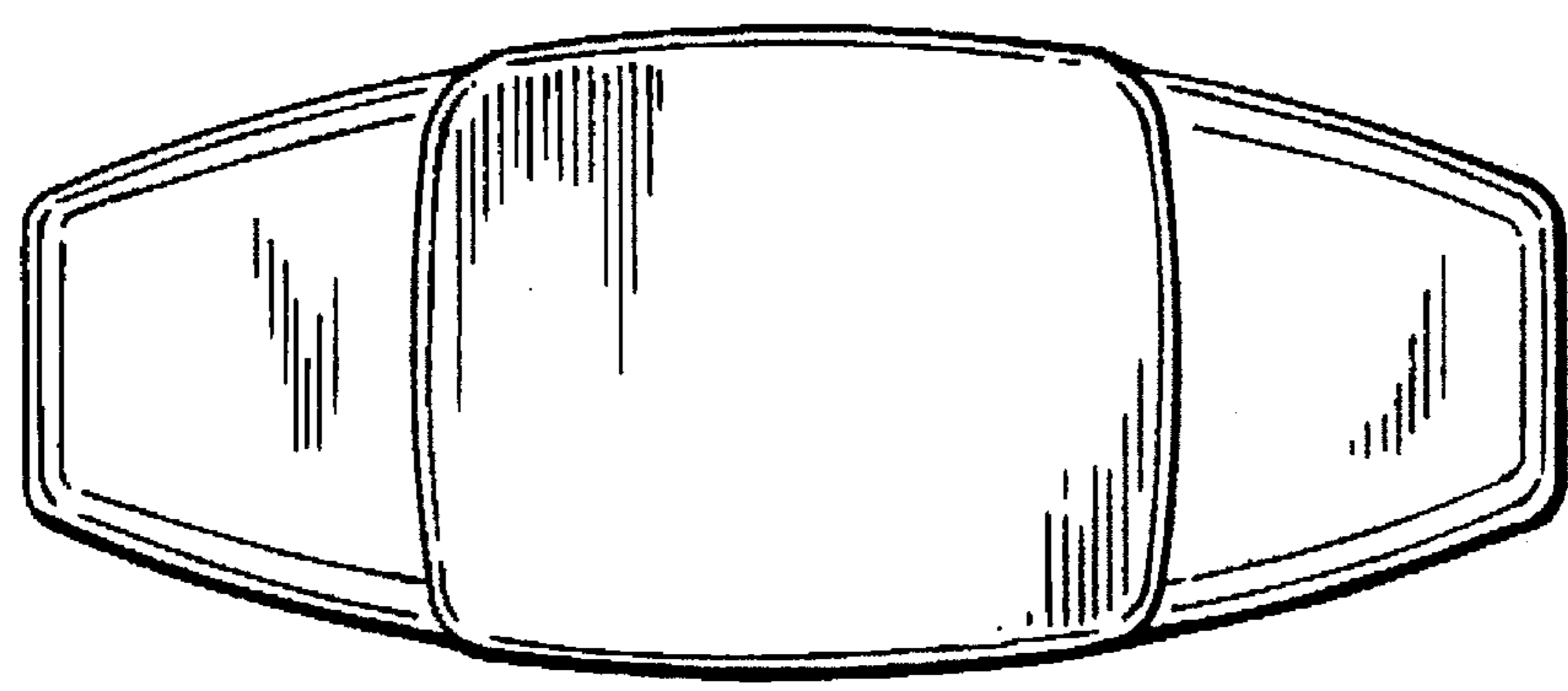

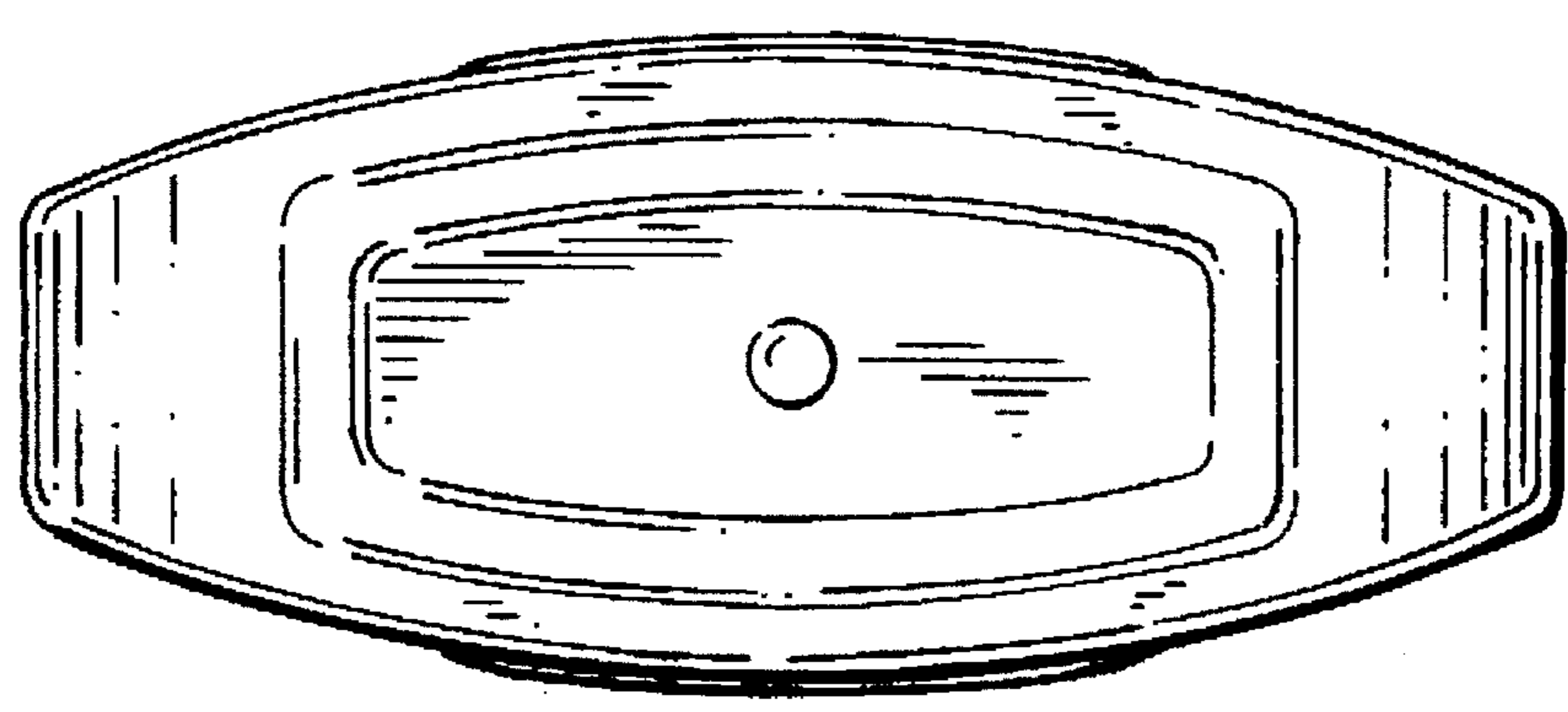

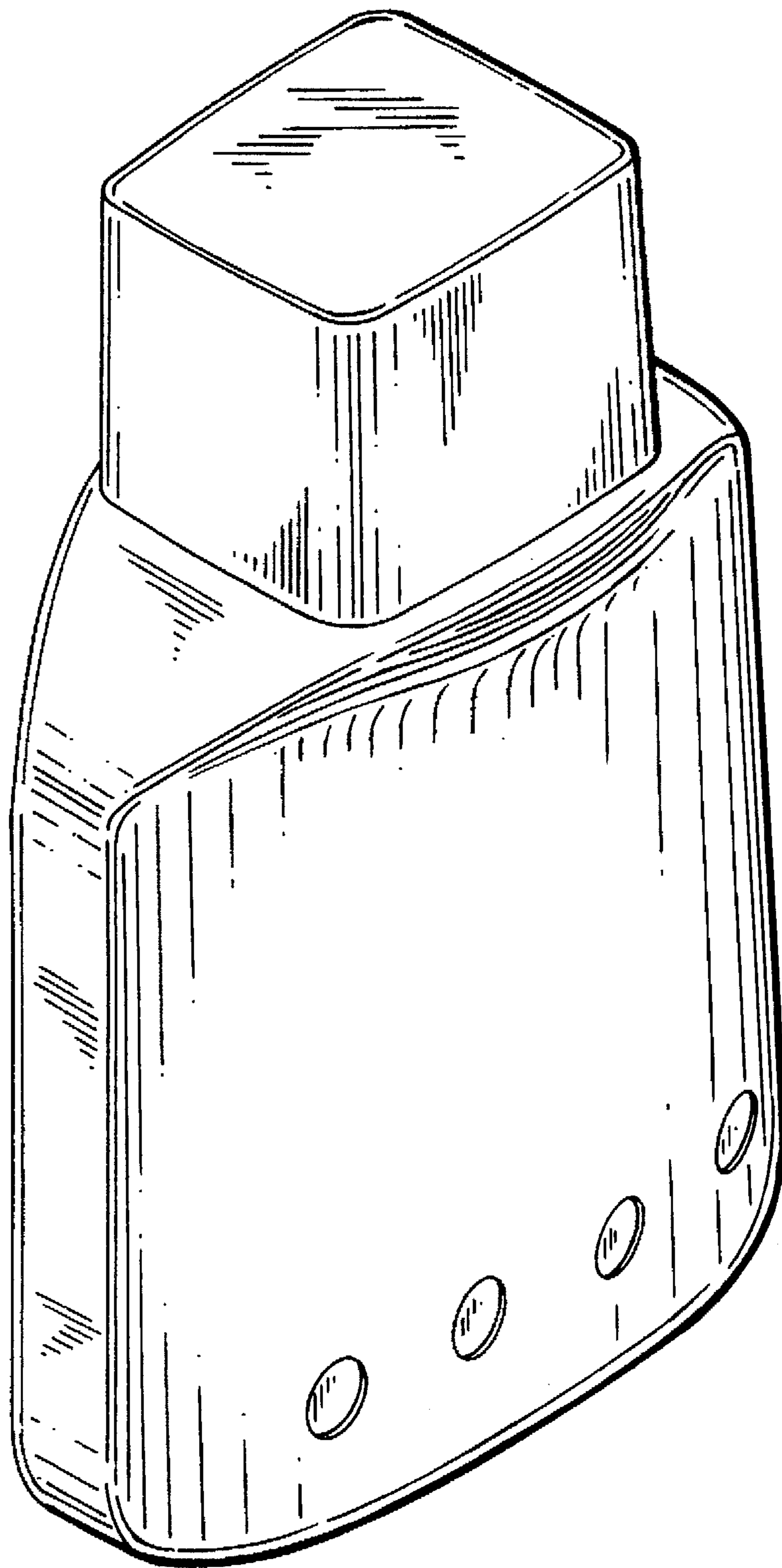

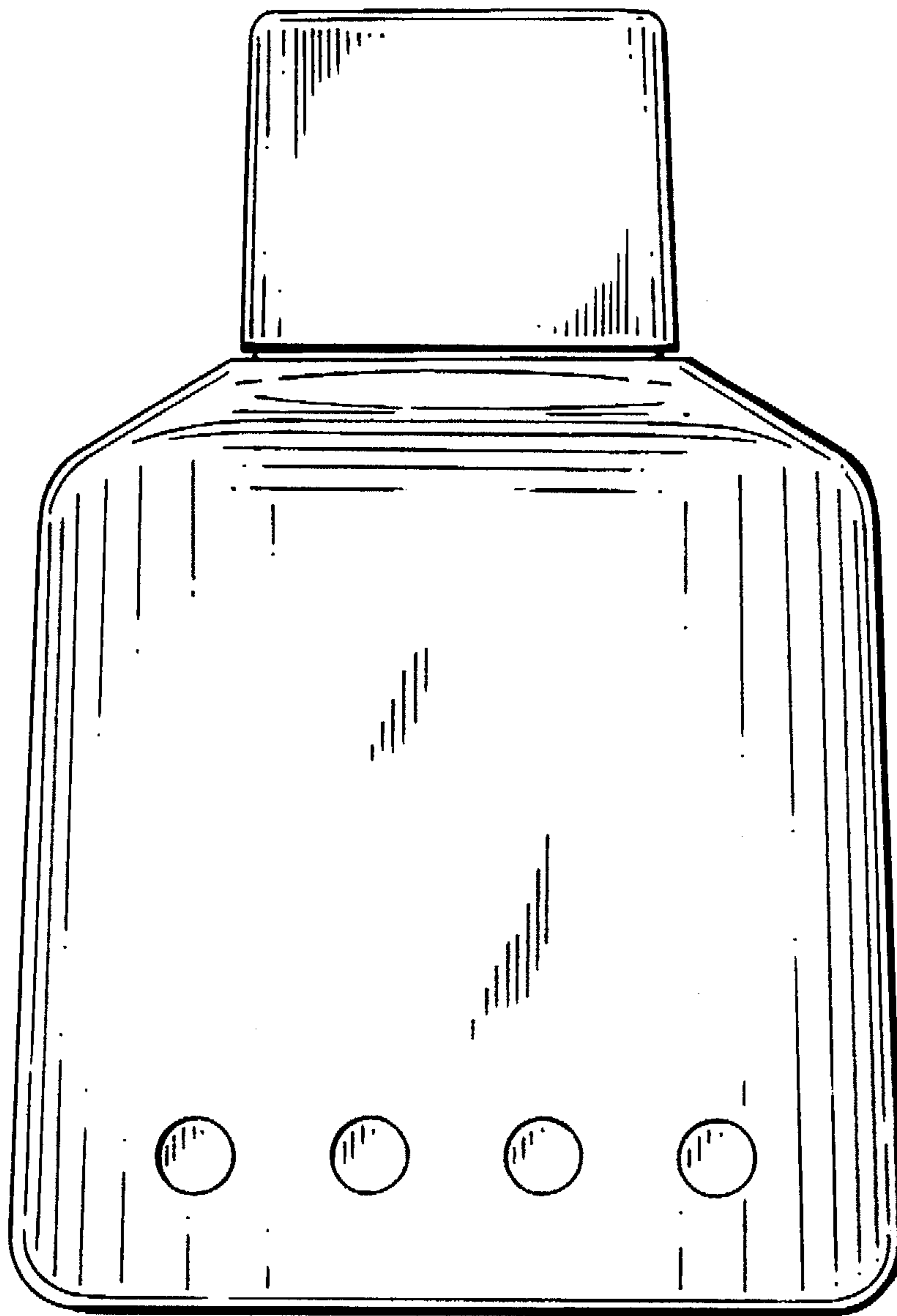

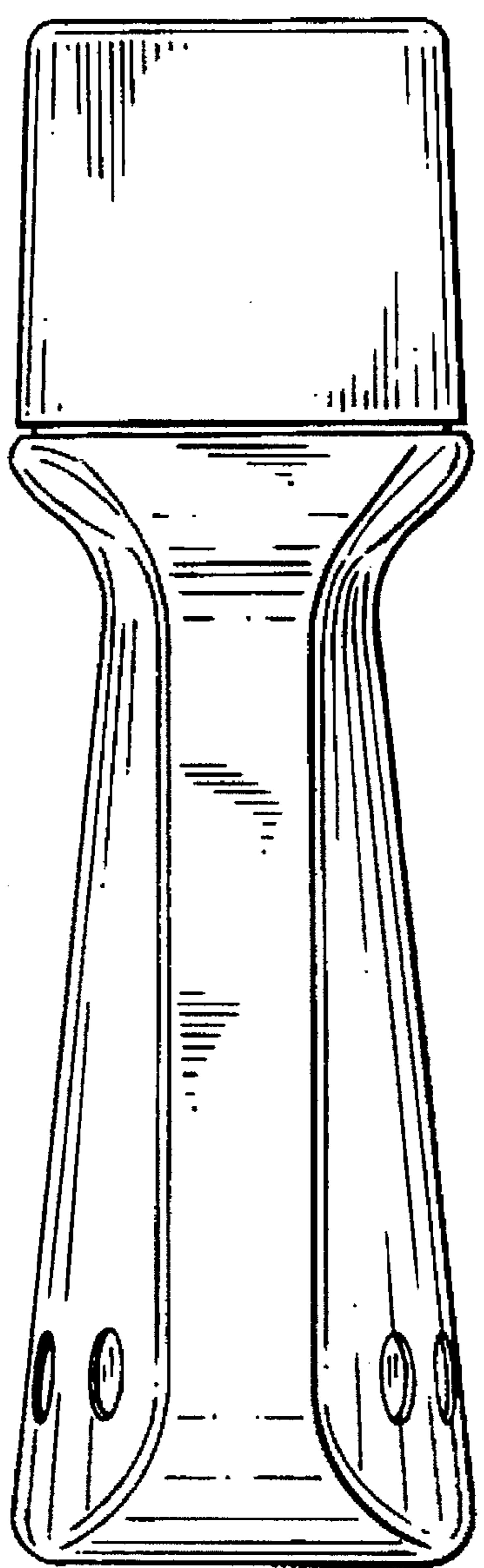

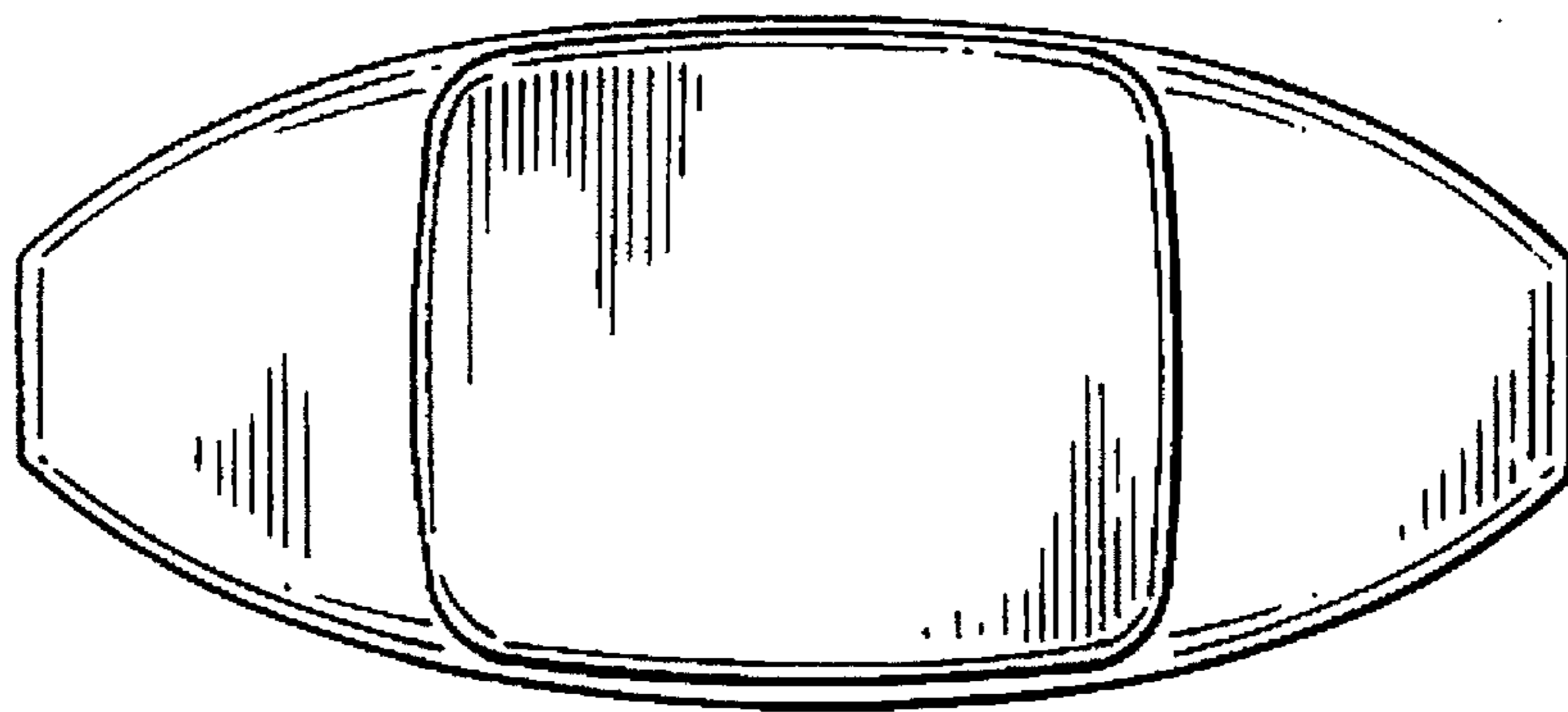

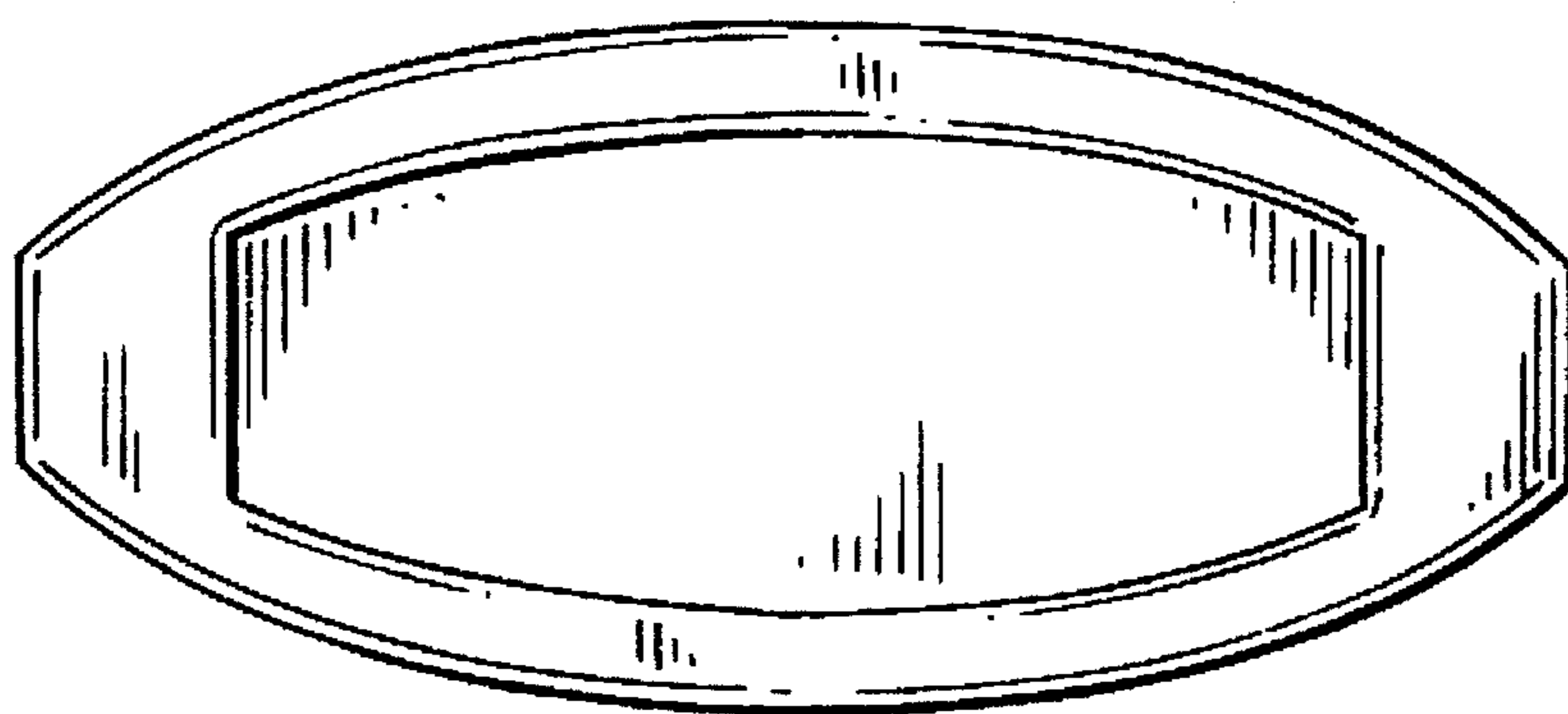
