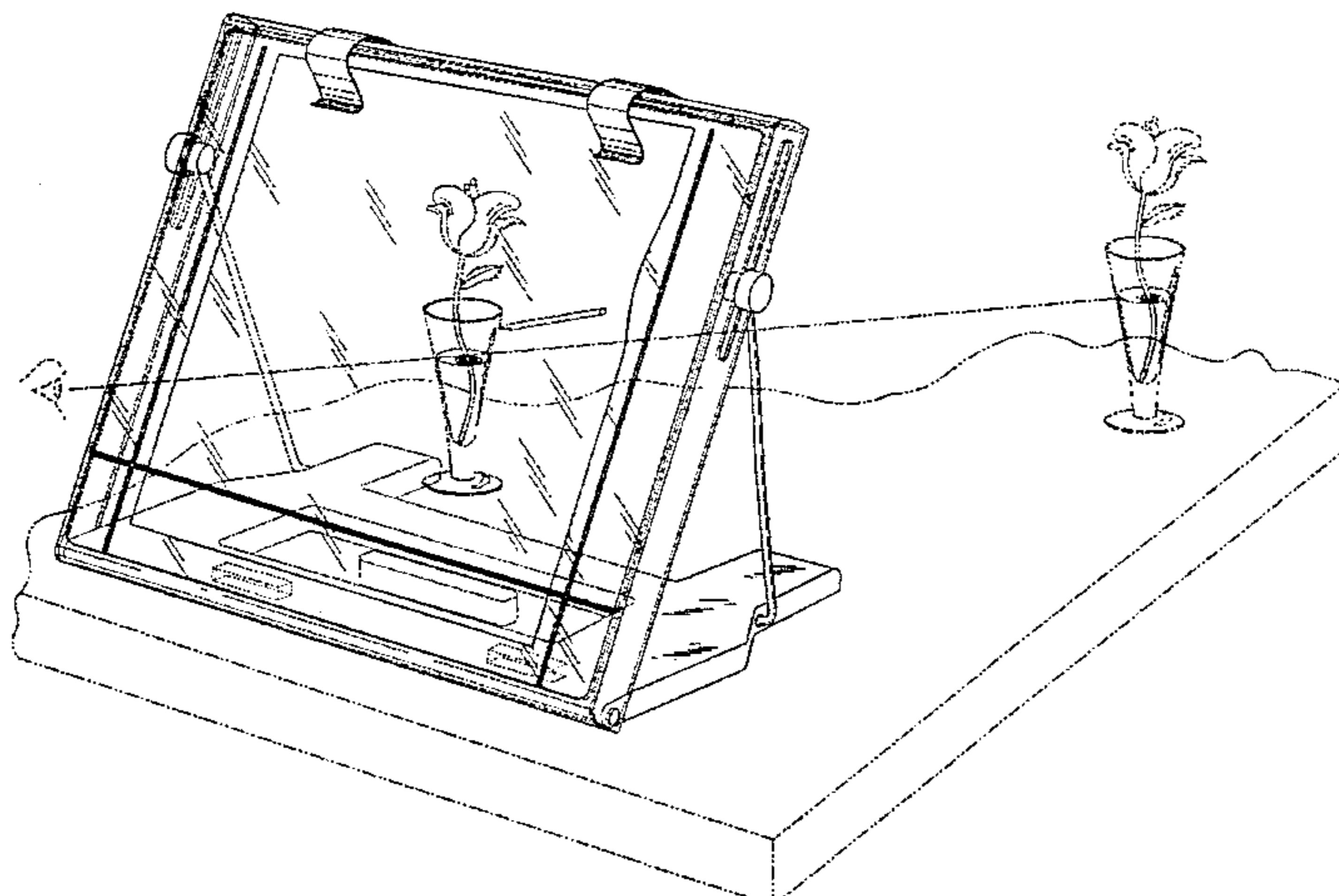
## [57] CLAIM

The ornamental design for a perspective drawing device, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of our new perspective drawing device in an open position;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a right side elevational view thereof;  
 FIG. 7 is a left side elevational view thereof;  
 FIG. 8 is a right side elevational view of our new perspective drawing device in a closed position; and,  
 FIG. 9 is a left side elevational view of the perspective drawing device in a closed position.  
 The broken line disclosure in the FIG. 1 view is provided for illustrative purposes only and forms no part of the claimed design.

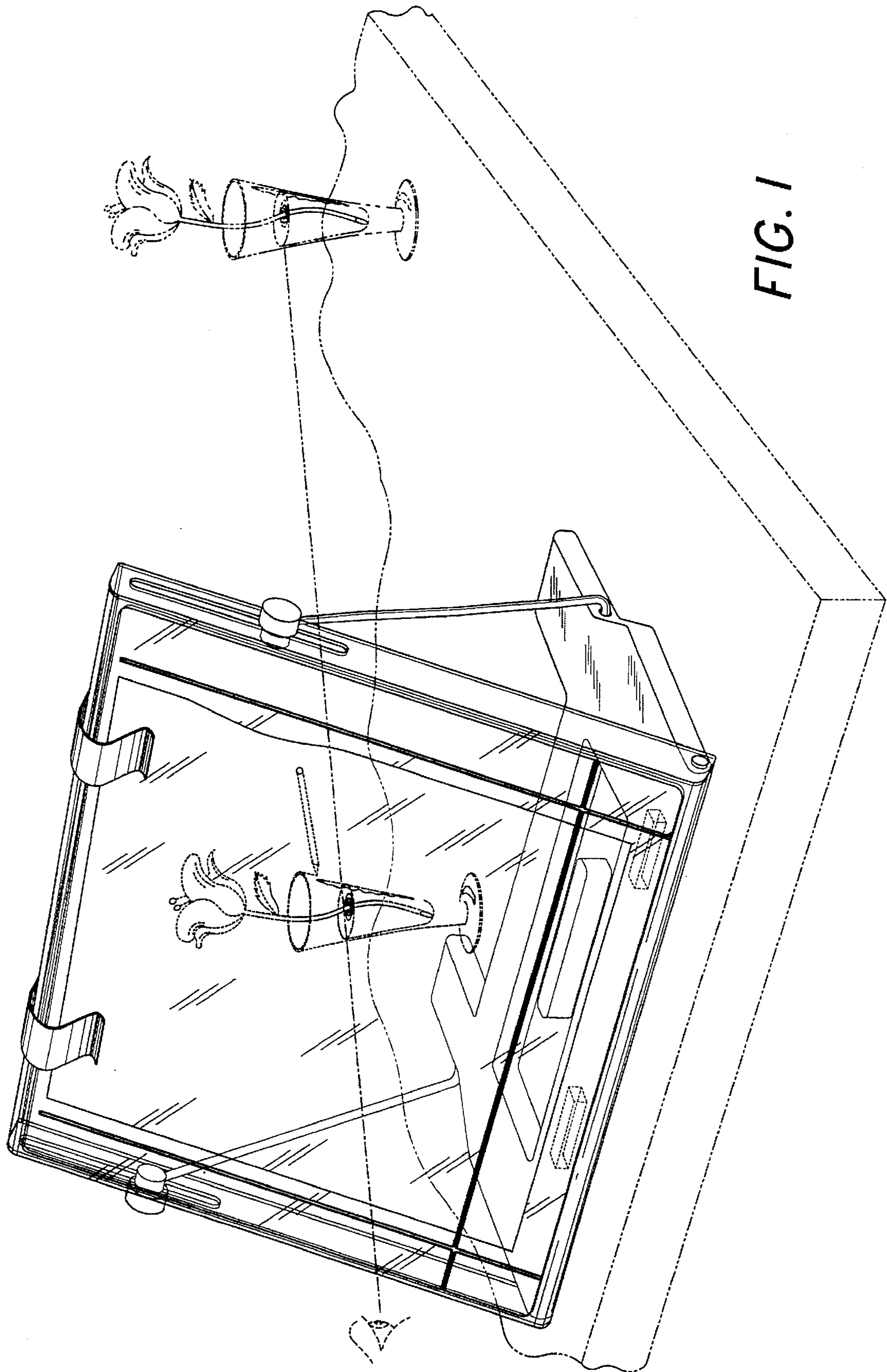
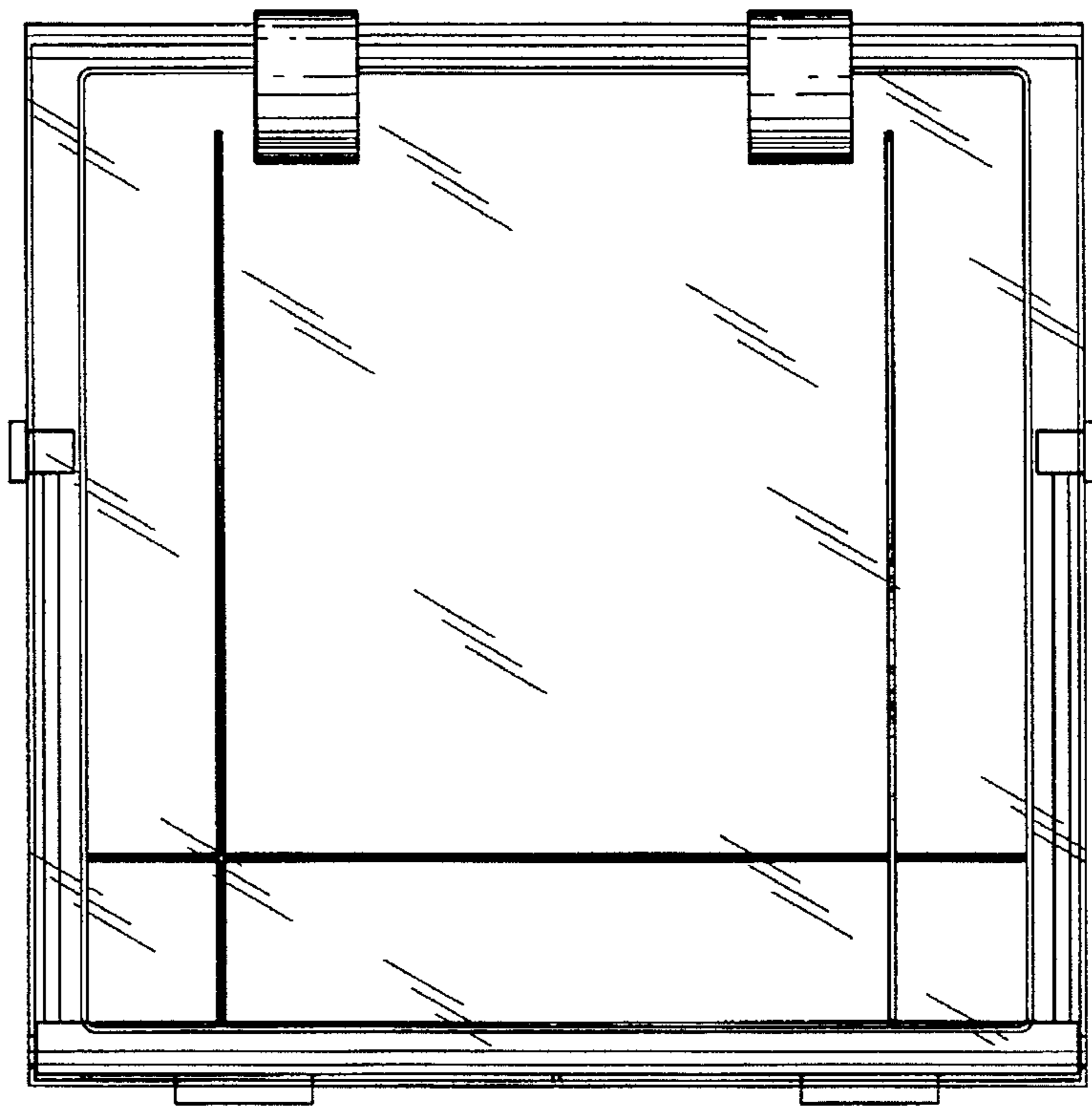
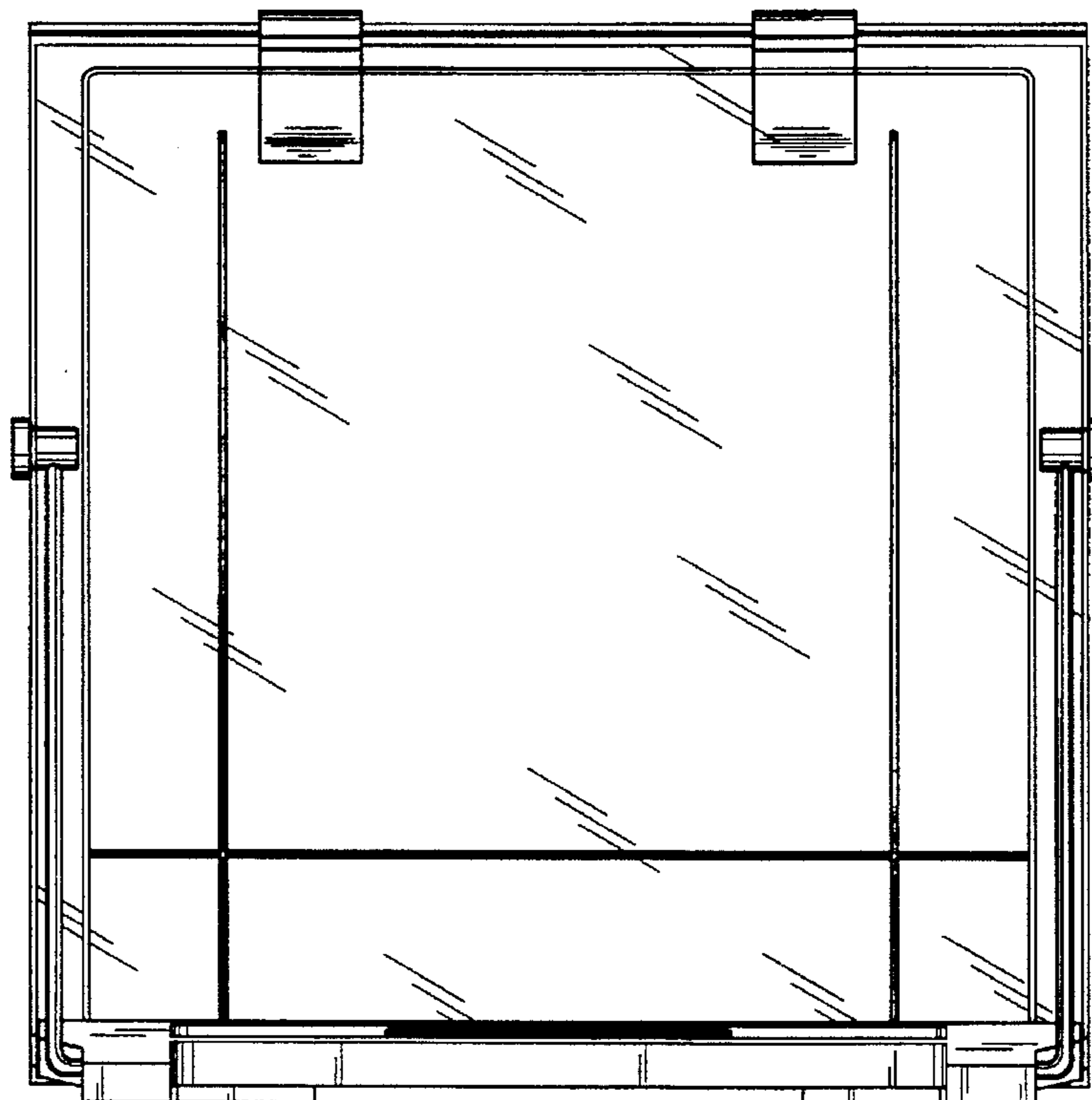


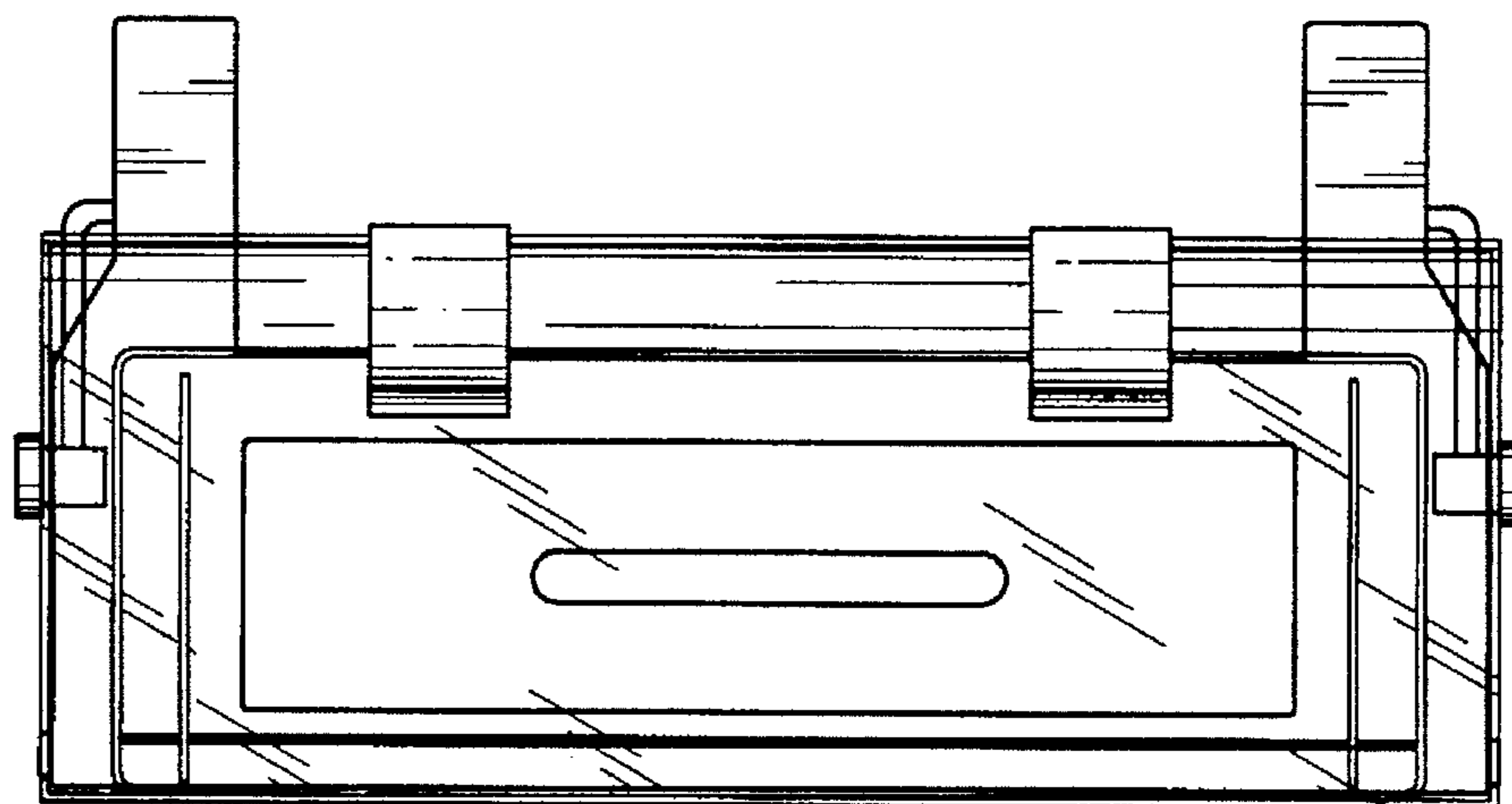

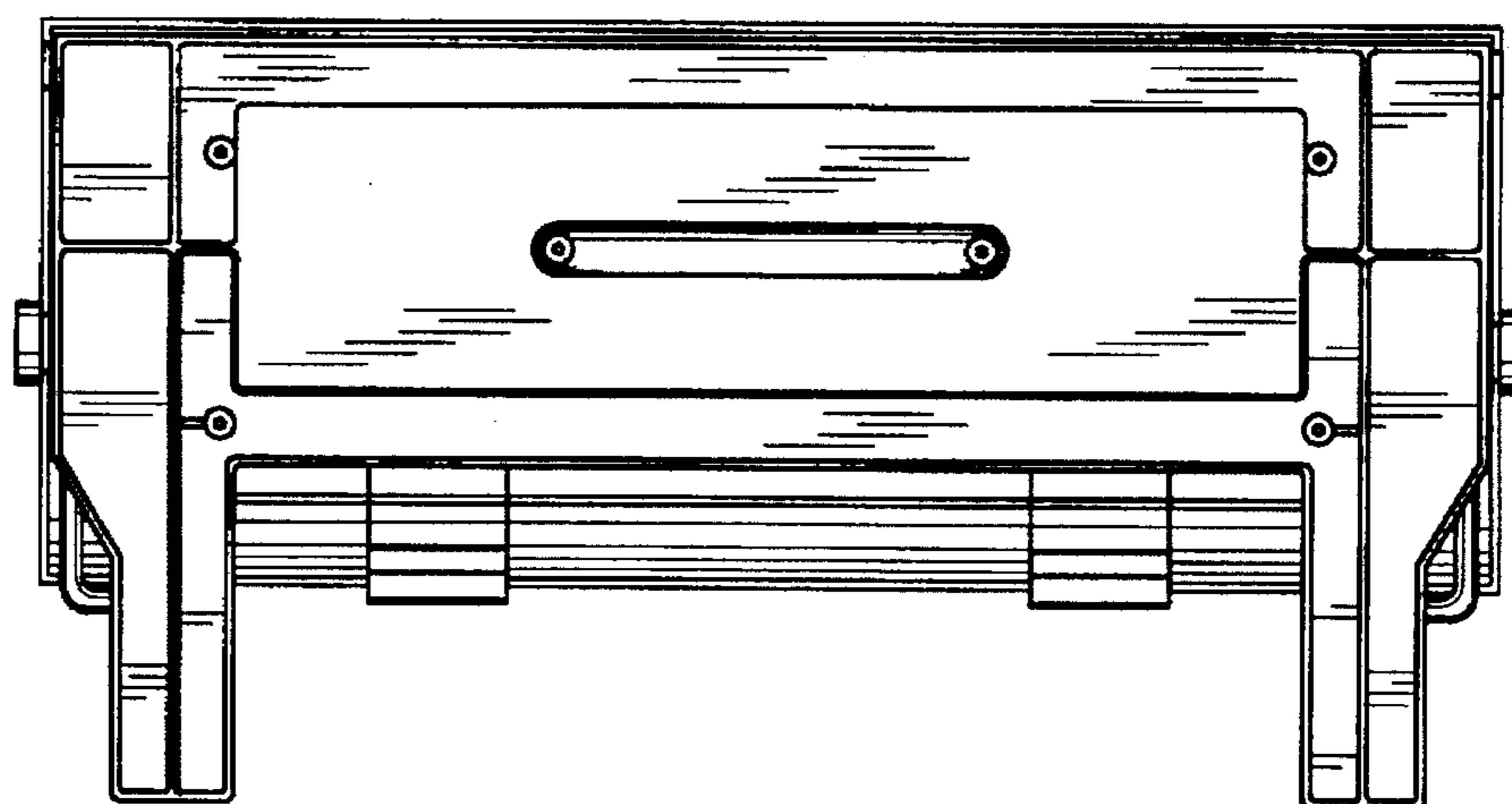

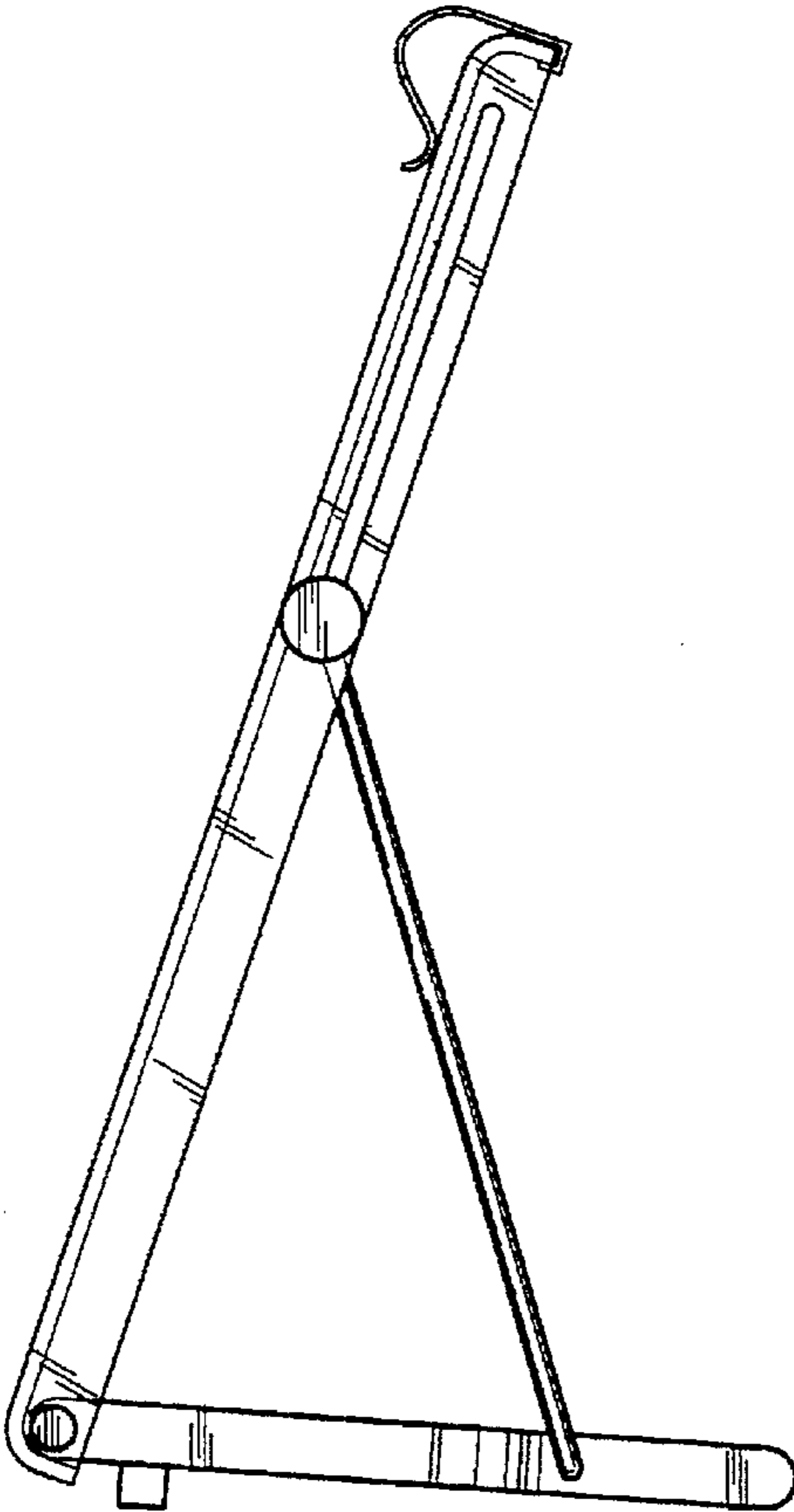

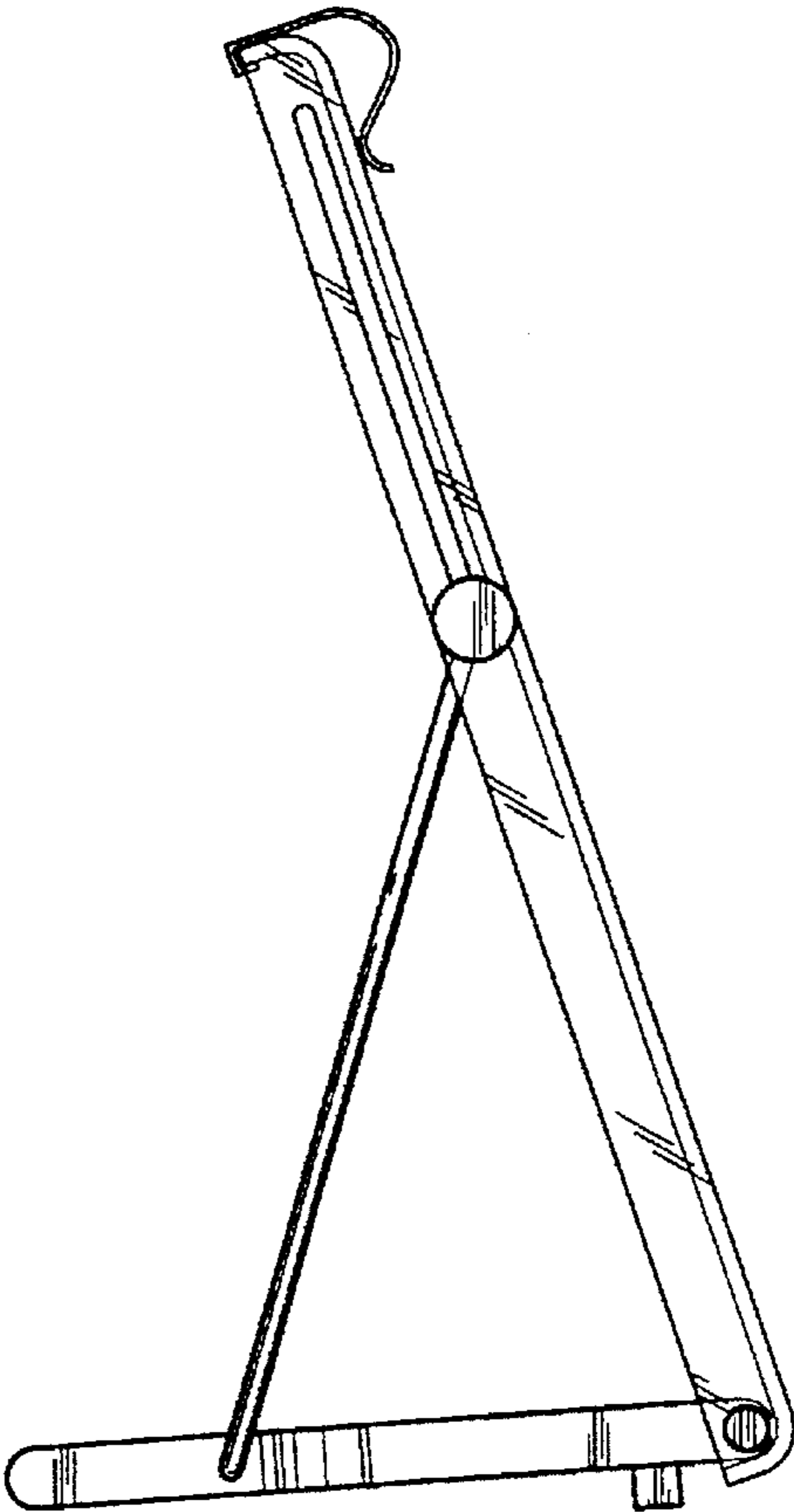

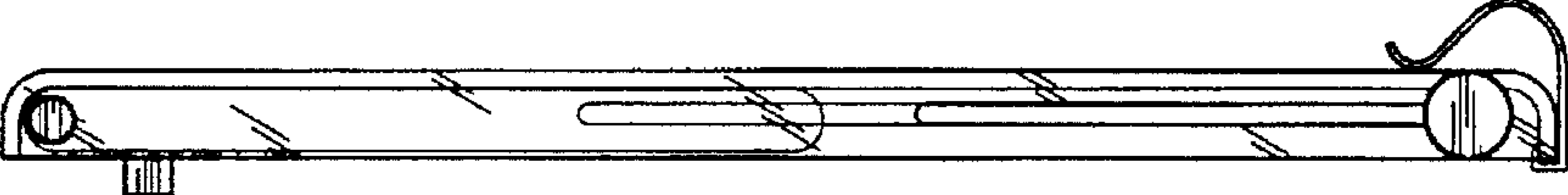
