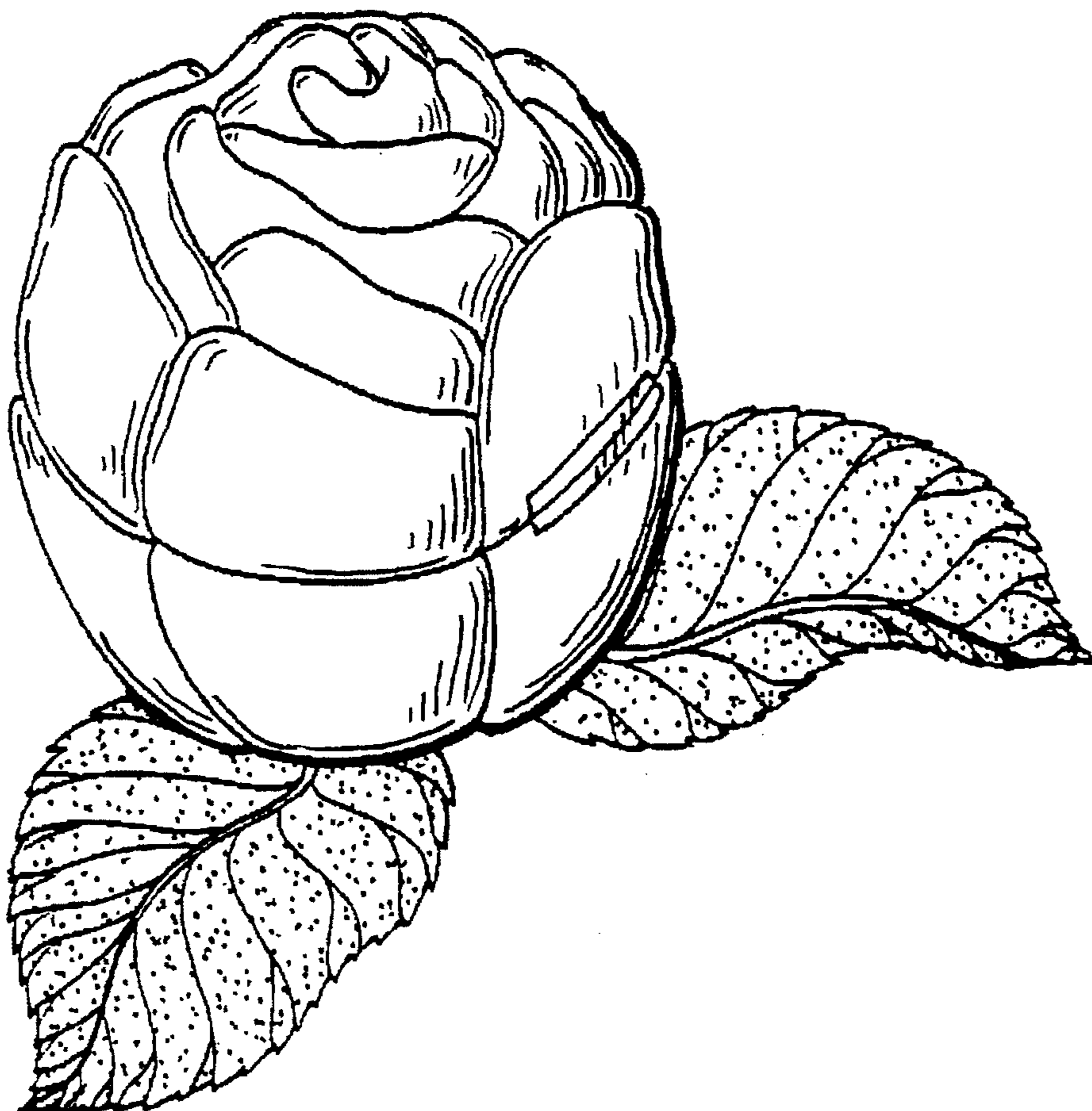

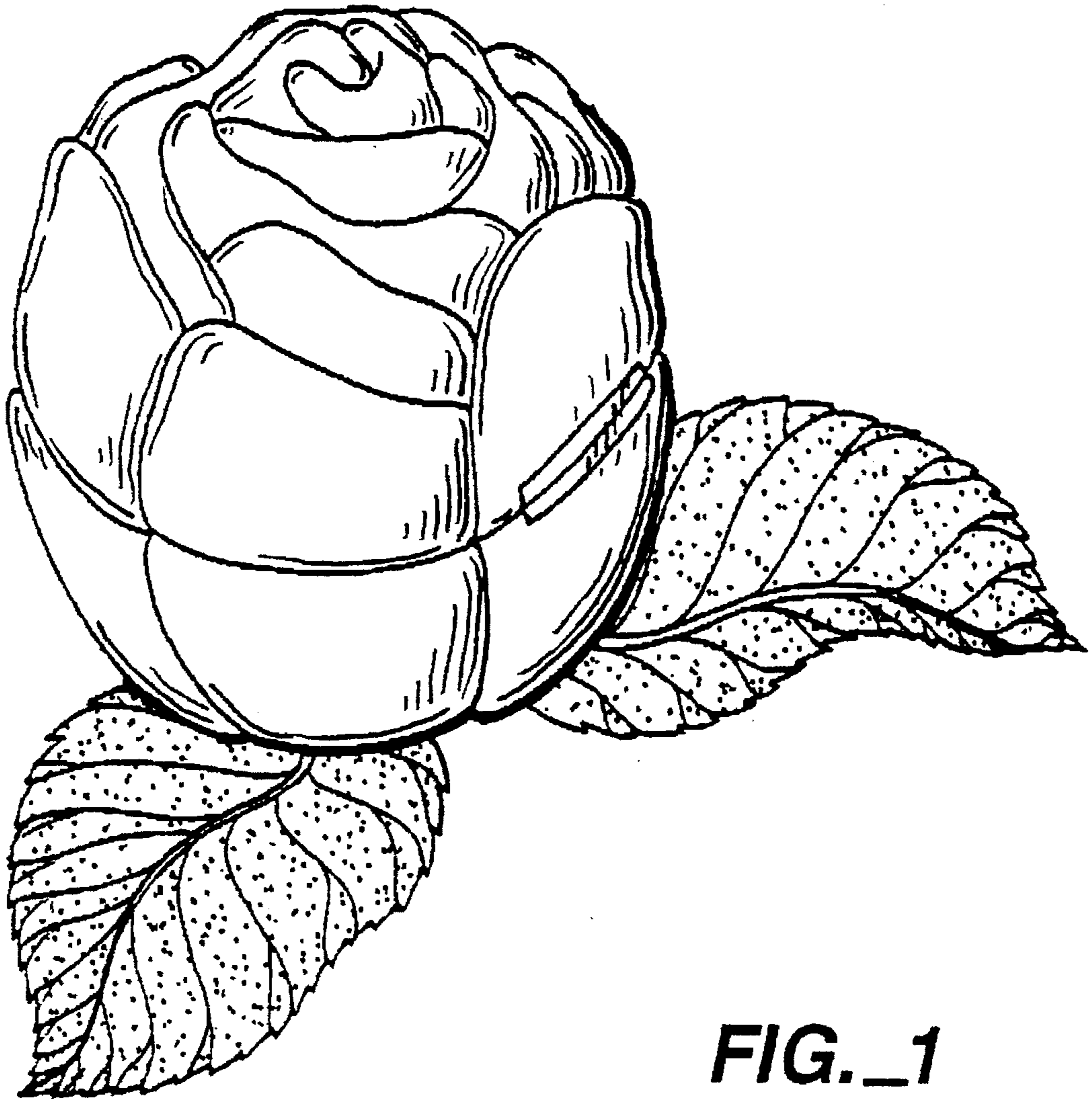
The ornamental design for a rose-shaped jewelry case, as shown and described.

**DESCRIPTION**

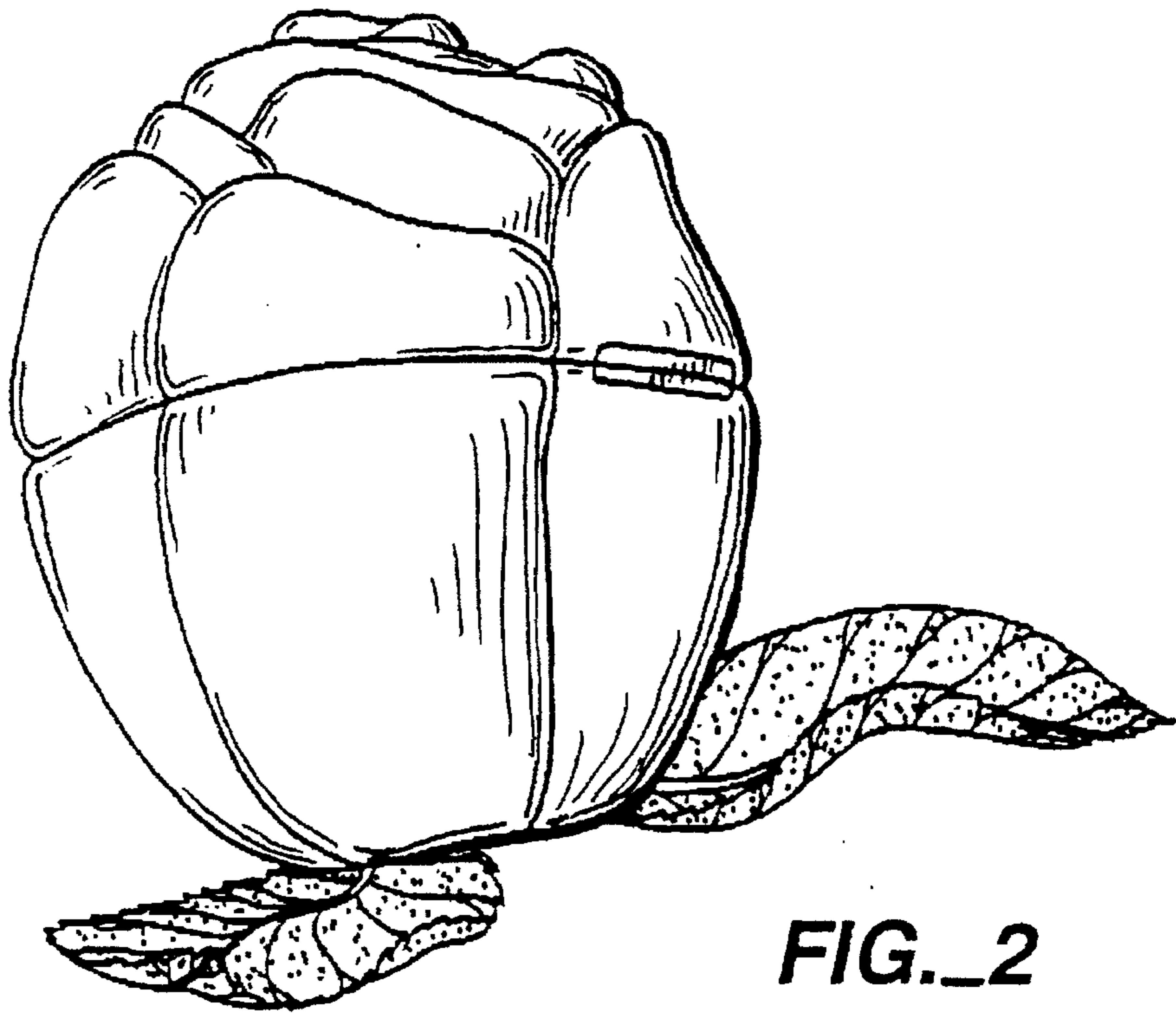

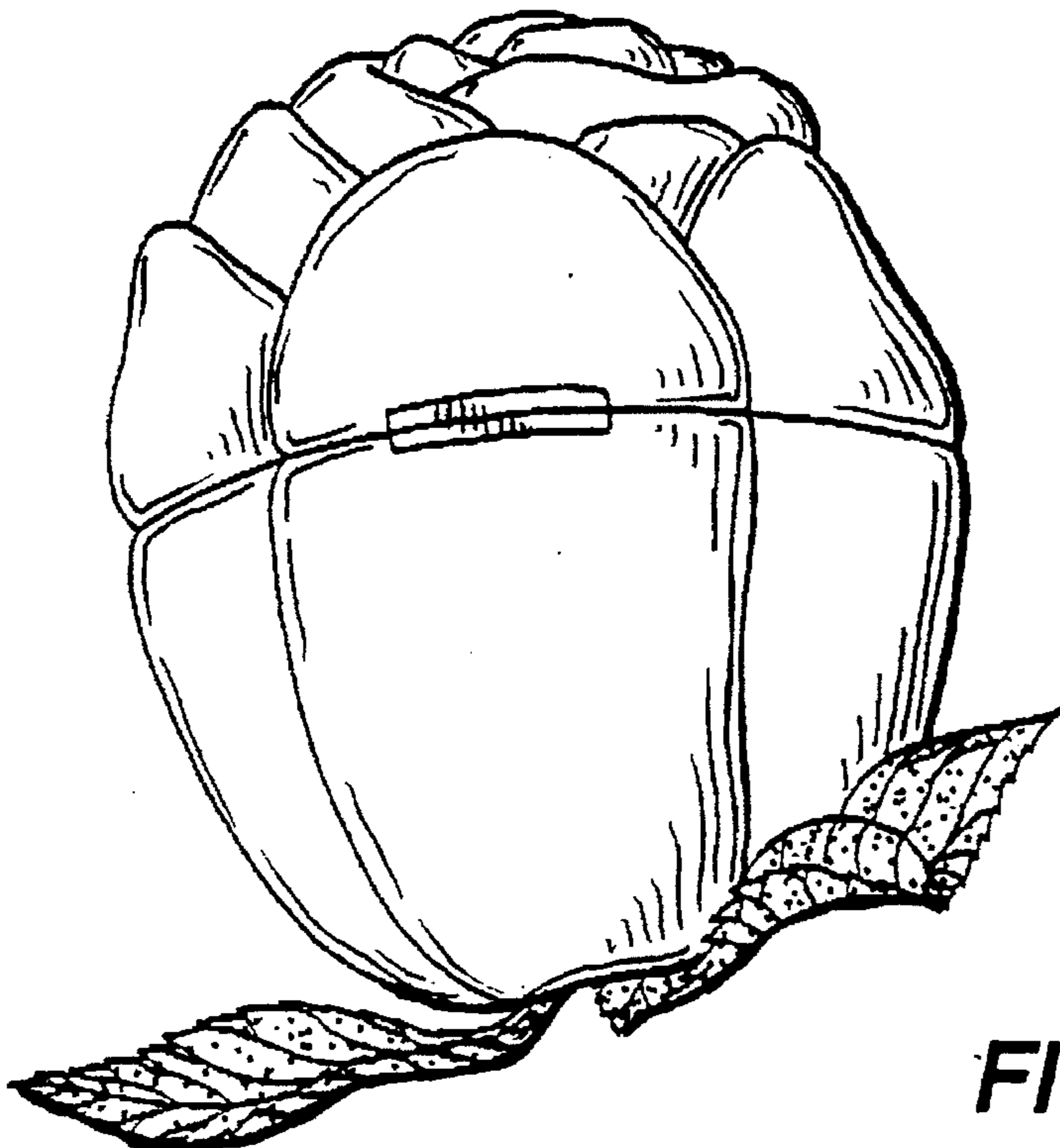




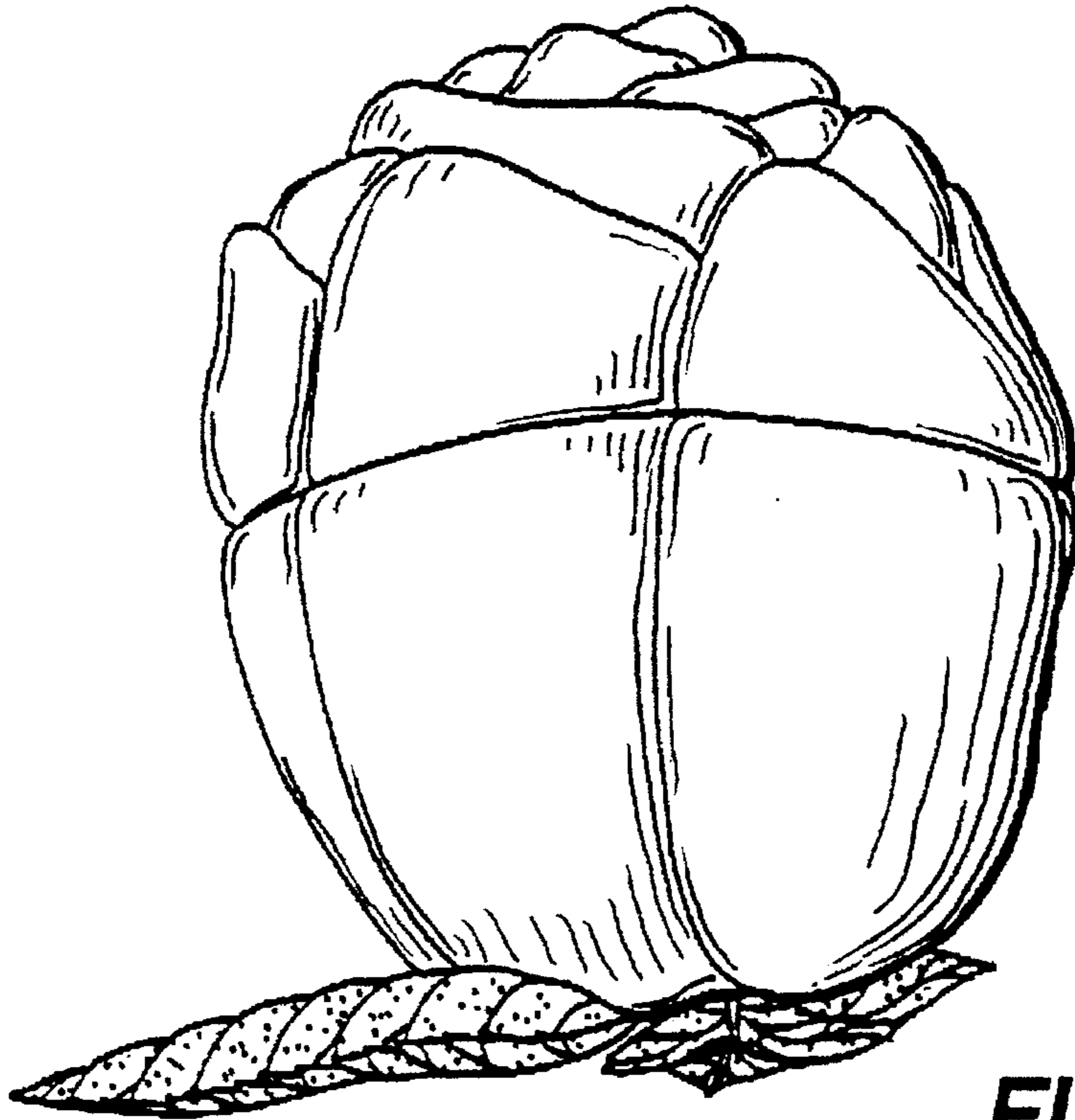

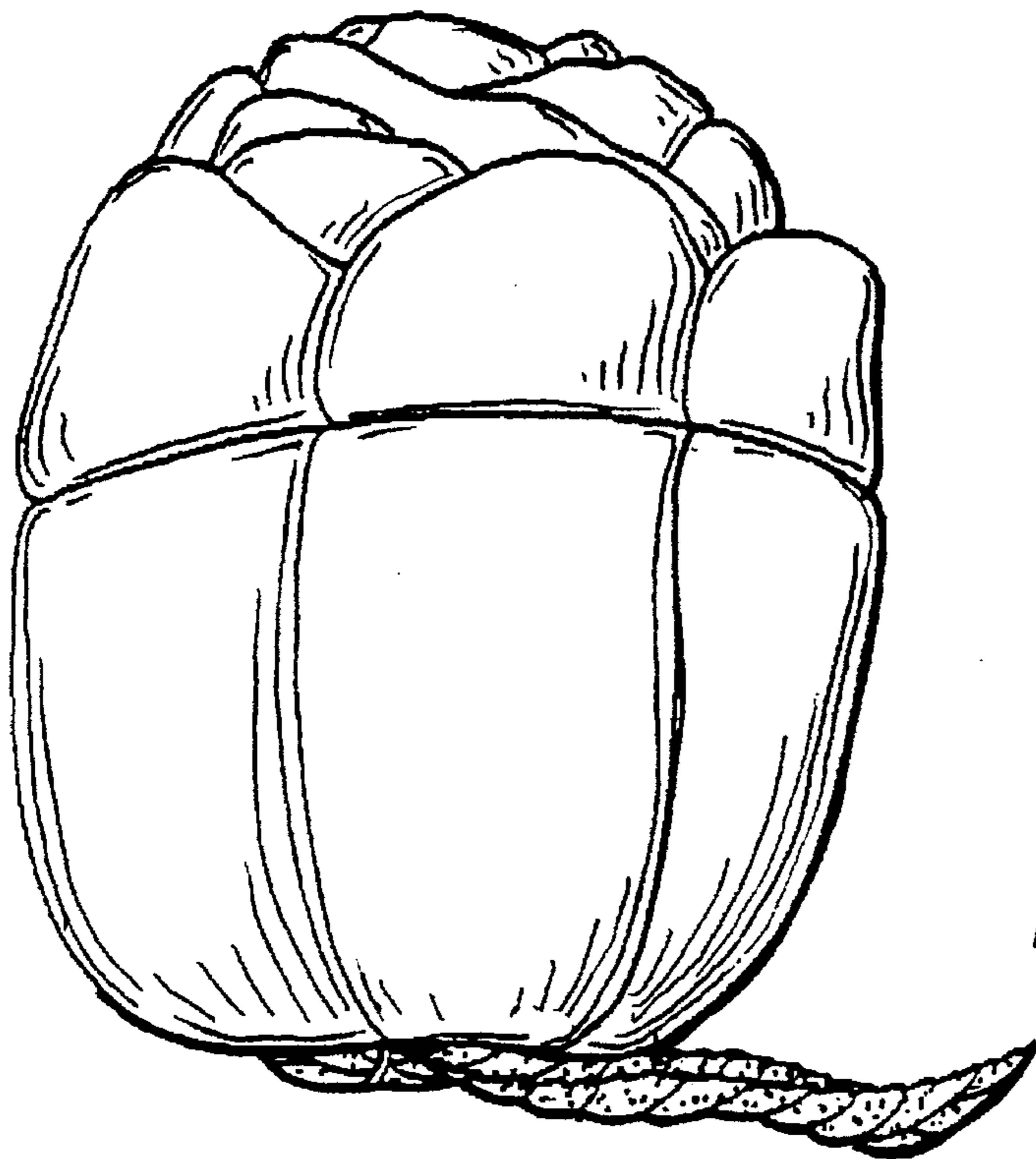

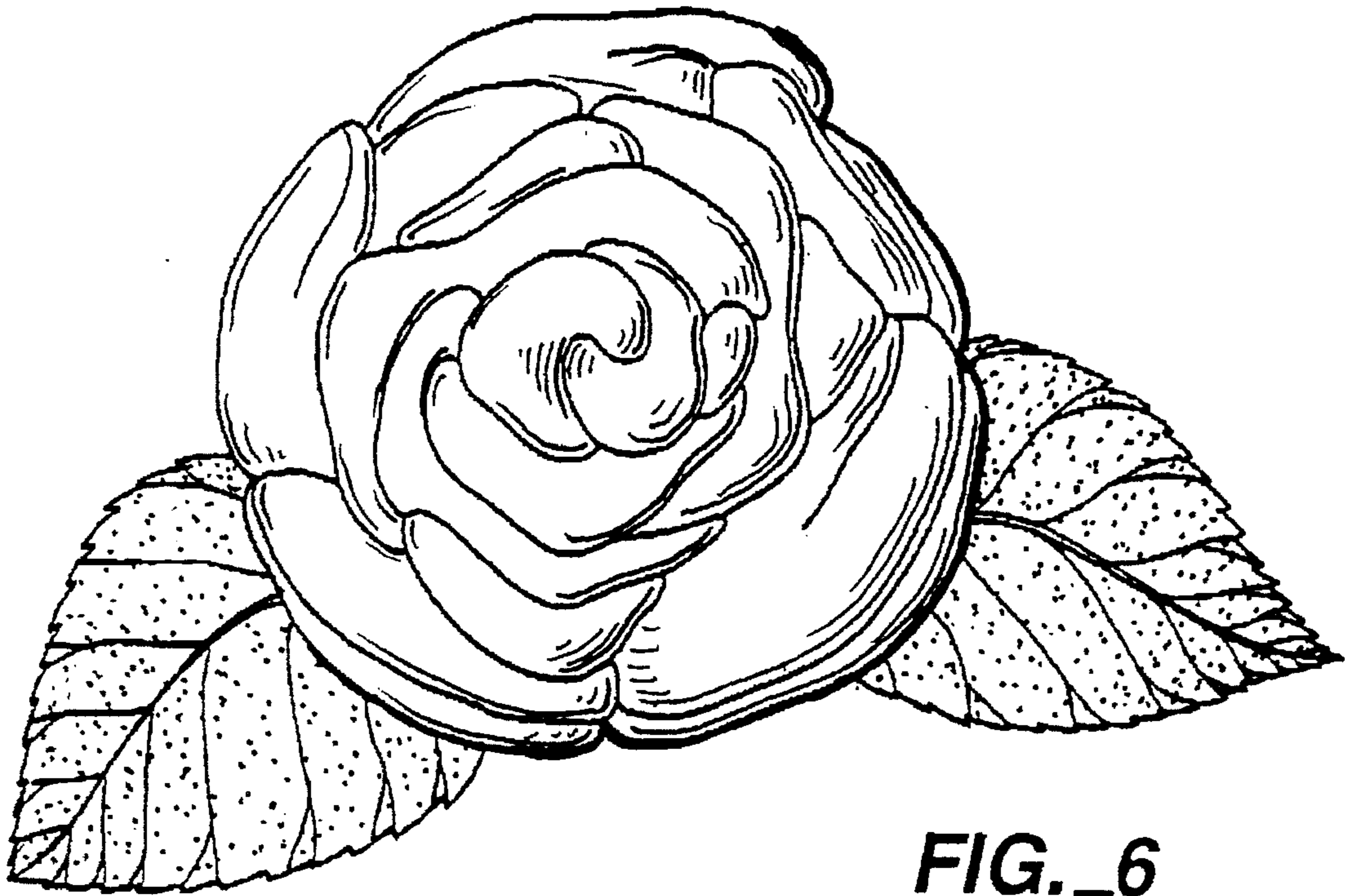

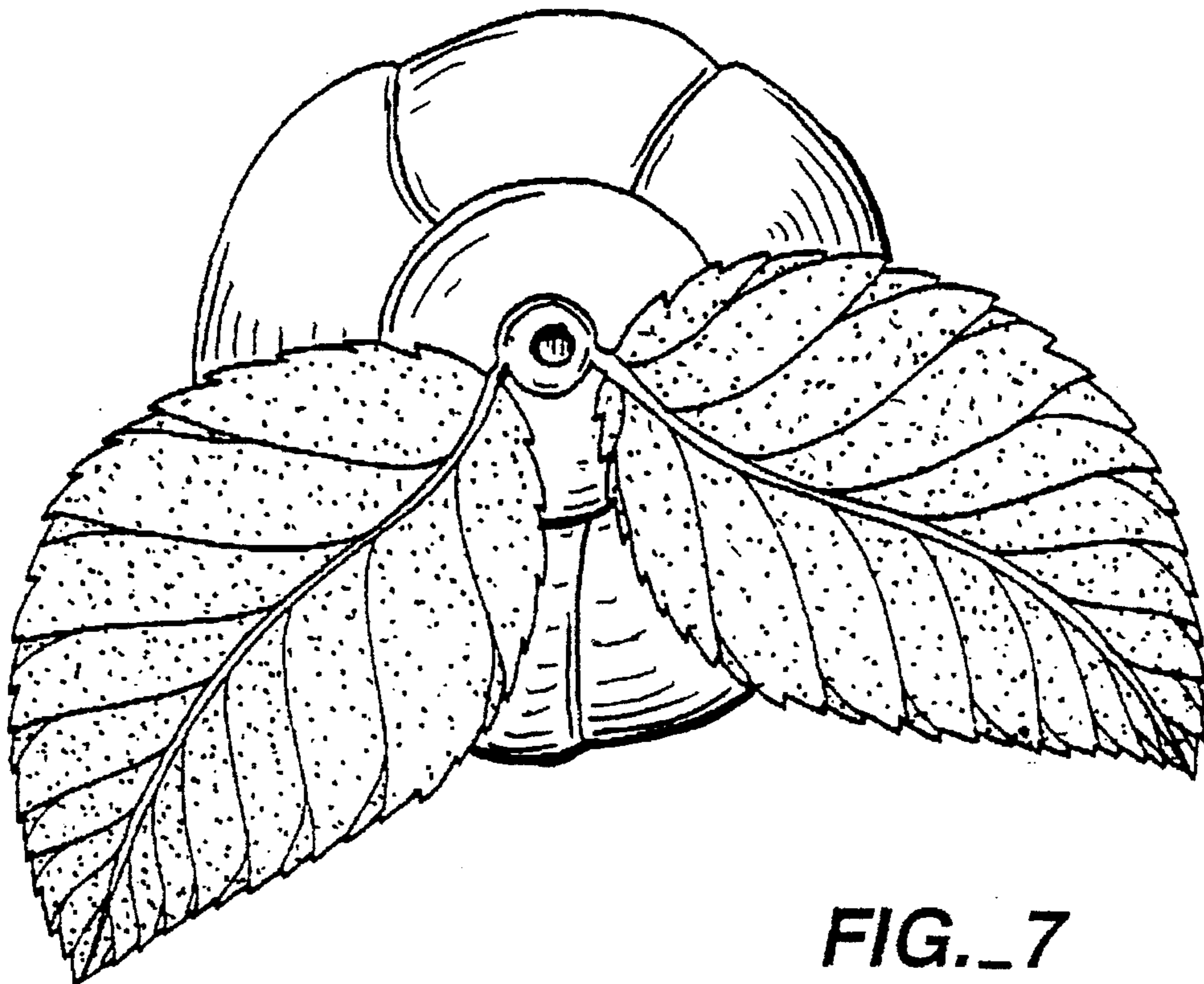
