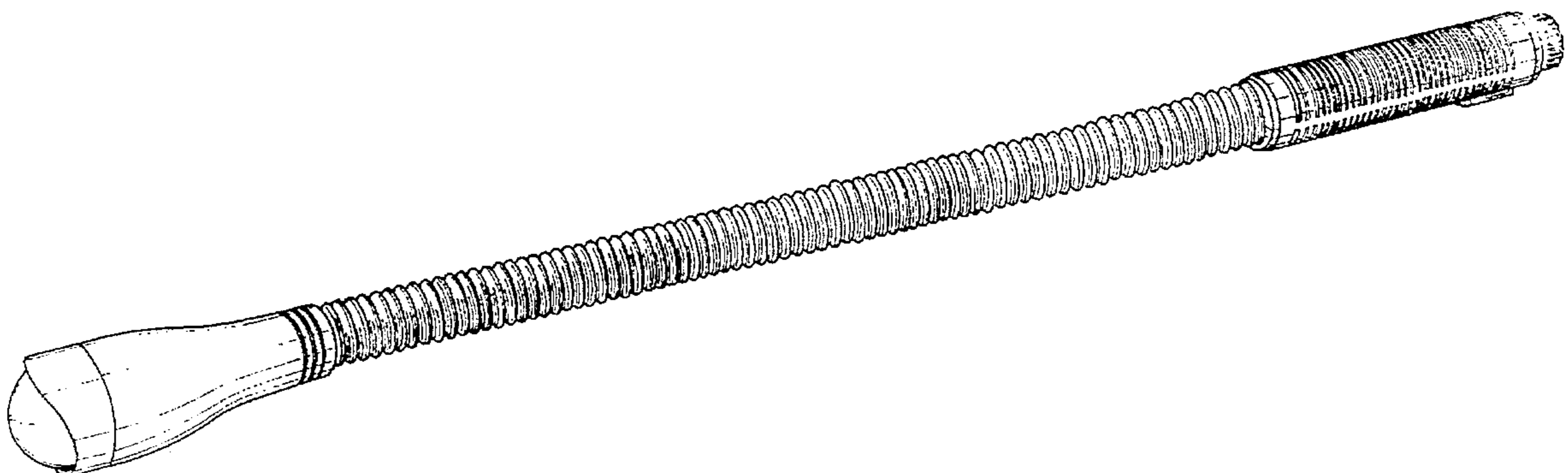
[57] **CLAIM**

The ornamental design for a flexible flashlight, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side side perspective view of our new design for a flexible flashlight;
 FIG. 2 is a top, front, and left side perspective view thereof with the flexible body of the flexible flashlight of FIG. 1 in a curved configuration;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a right side elevation view thereof;
 FIG. 6 is a left side elevation view thereof;
 FIG. 7 is a front elevation view thereof; and,
 FIG. 8 is a rear elevation view of our new design.

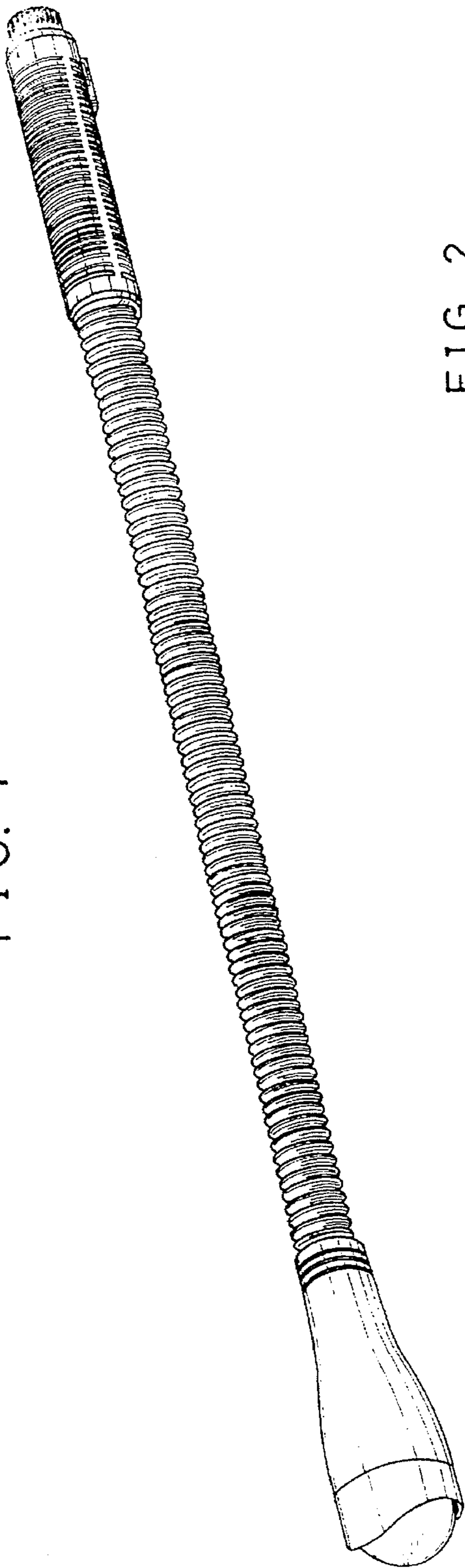

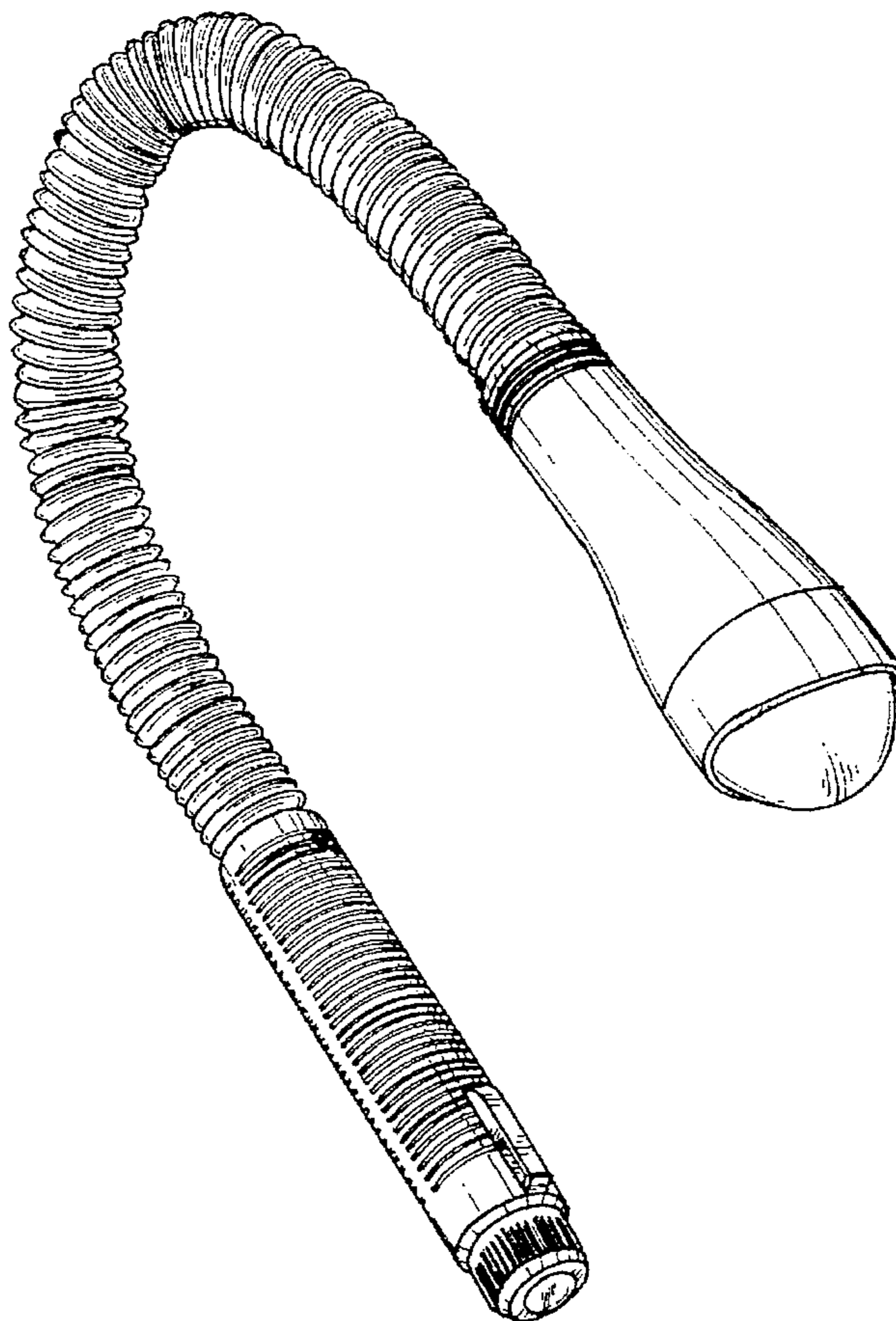

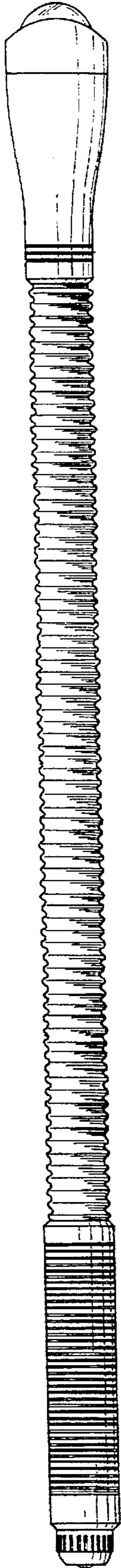

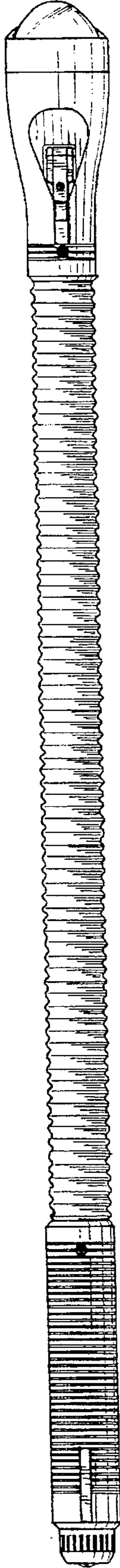

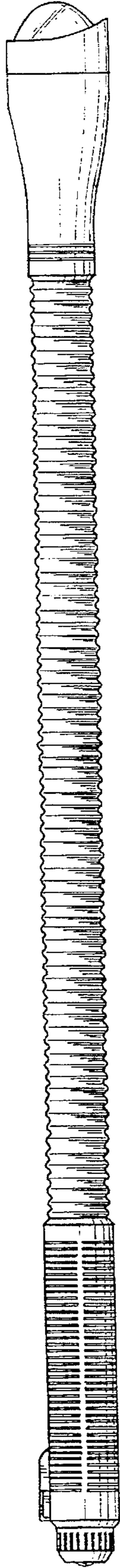

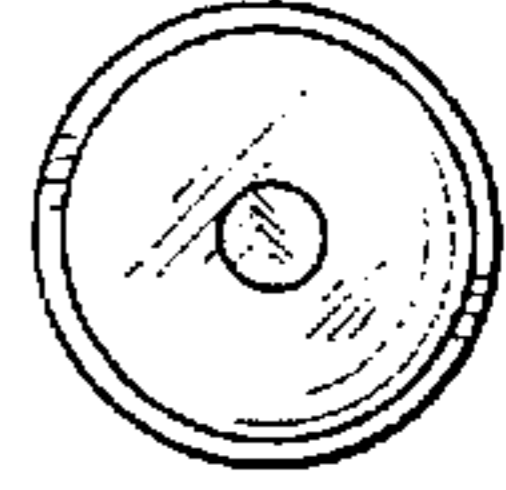
