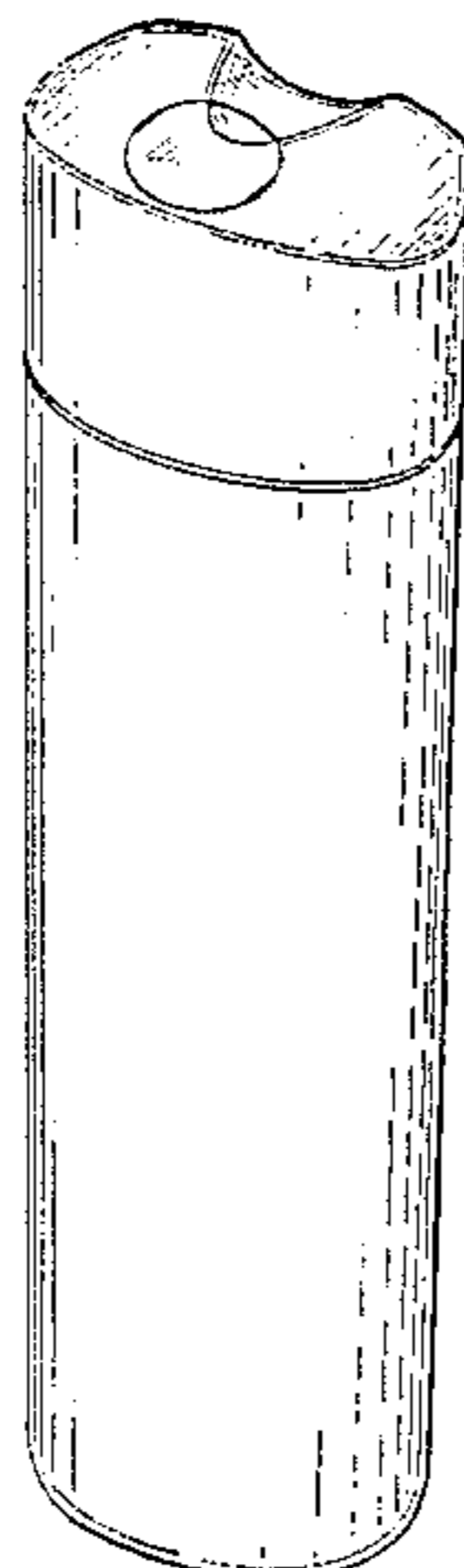
[57] **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the container of my design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevational view, the right side elevational view is a mirror image thereto; FIG. 7 is a perspective view of a first alternative embodiment of the container of FIG. 1 wherein the container is greater in lateral cross-section than the closure; FIG. 8 is a rear elevational view of the container of FIG. 7; FIG. 9 is a front elevational view of the container of FIG. 7; FIG. 10 is a top plan view of the container of FIG. 7; FIG. 11 is a bottom plan view of the container of FIG. 7; FIG. 12 is a left side elevational view of the container of FIG. 7, the right side elevational view is a mirror image thereto; FIG. 13 is a perspective view of a second alternative embodiment of the container of FIG. 1 wherein the container is dimensionally greater than the closure; FIG. 14 is a rear elevational view of the container of FIG. 13; FIG. 15 is a front elevational view of the container of FIG. 13; FIG. 16 is a top plan view of the container of FIG. 13; FIG. 17 is a bottom plan view of the container of FIG. 13; and, FIG. 18 is a left side elevational view of the container of FIG. 13, the right side elevational view is a mirror image thereto.

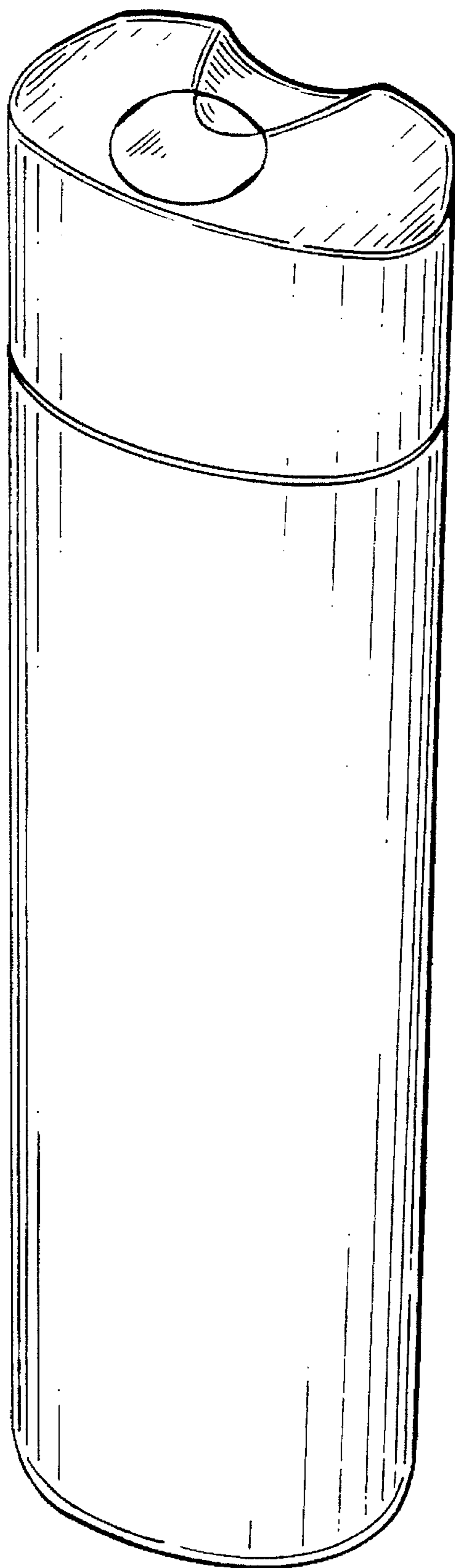

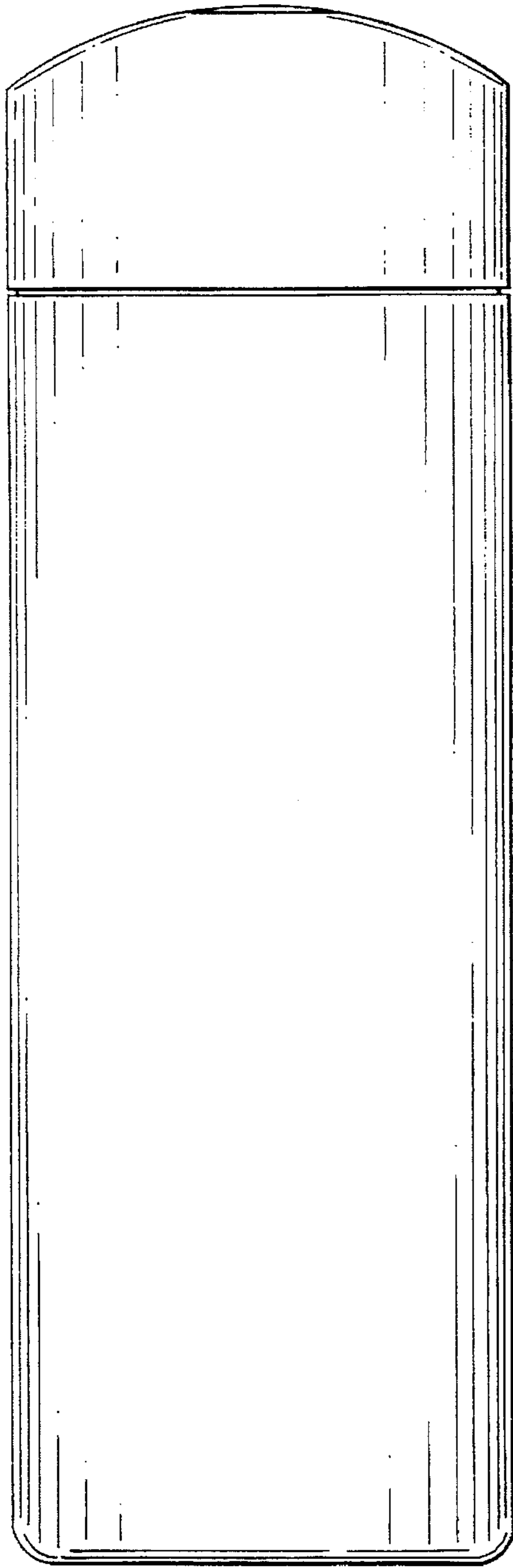

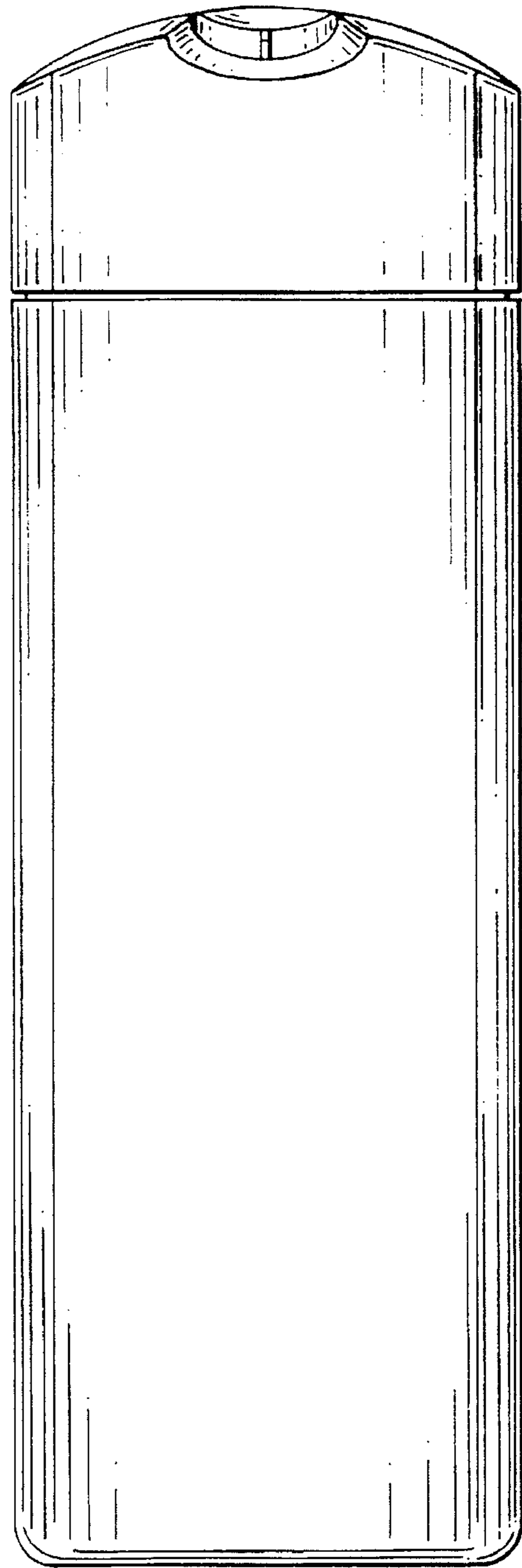

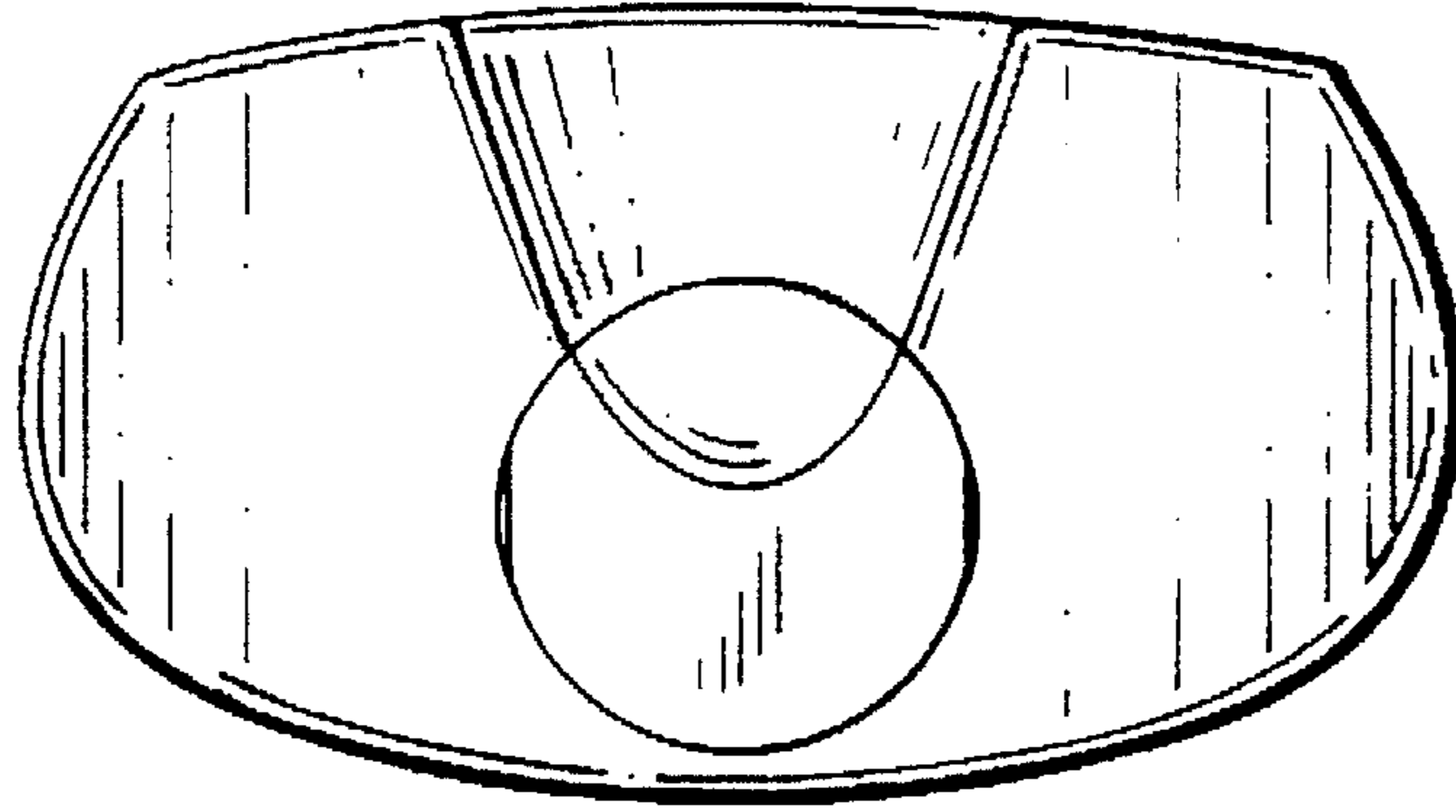

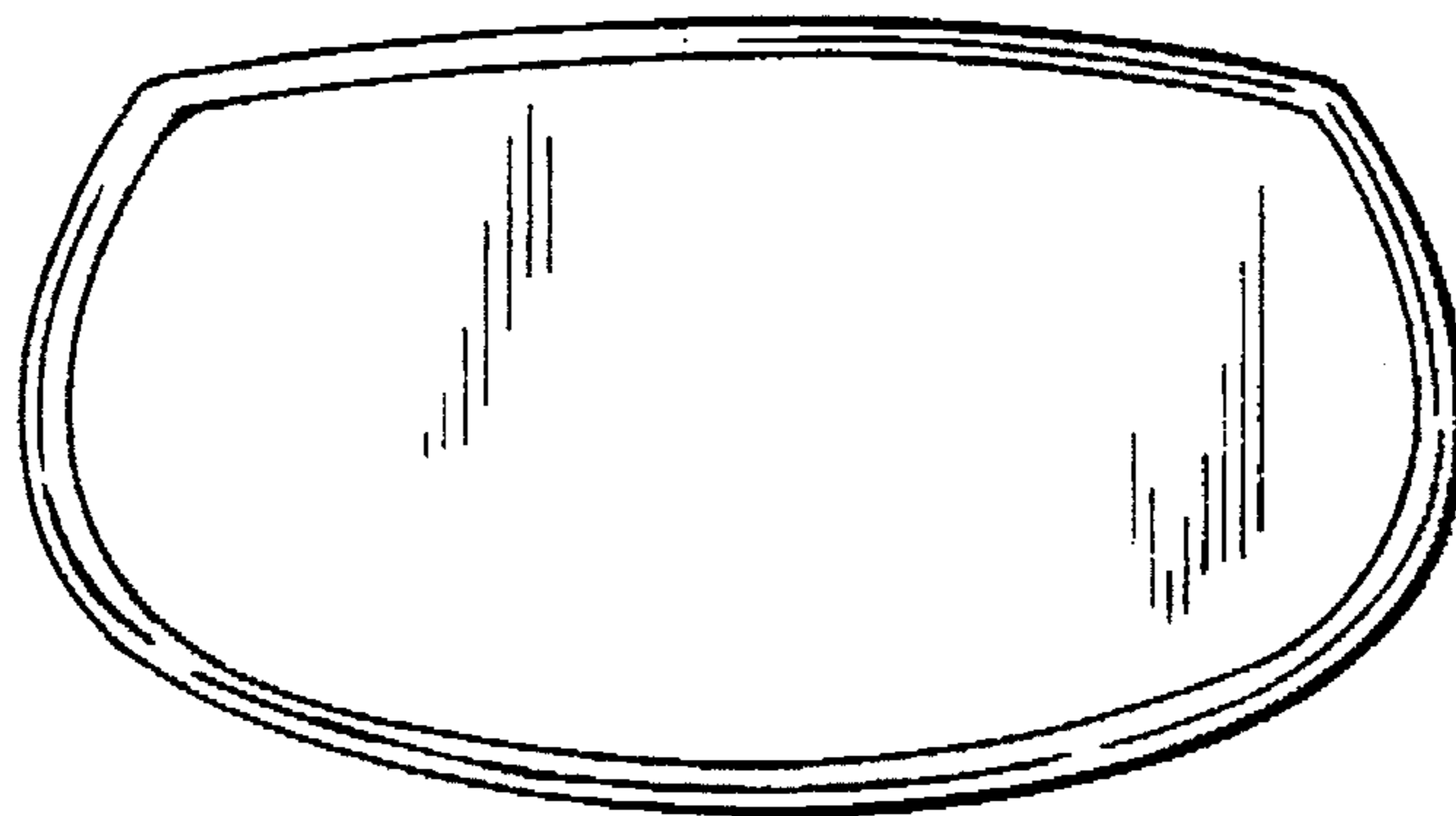

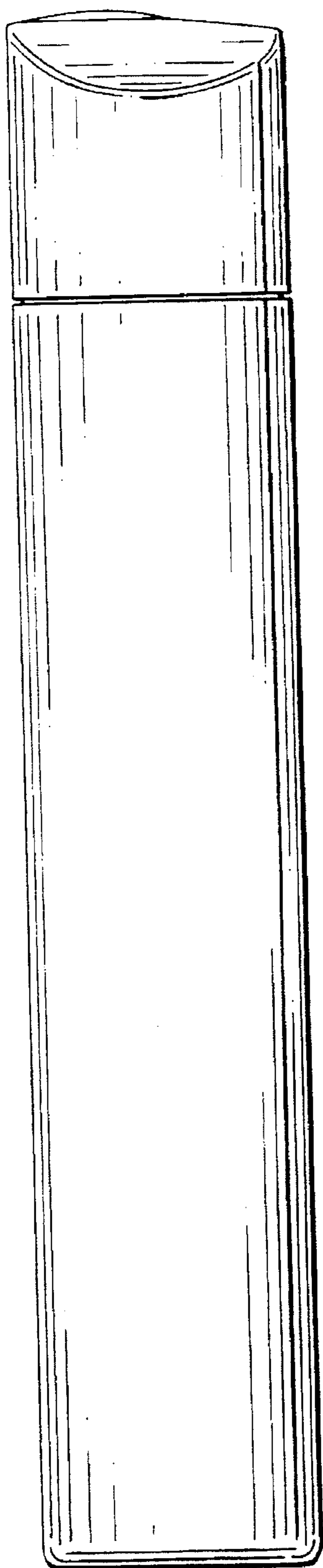

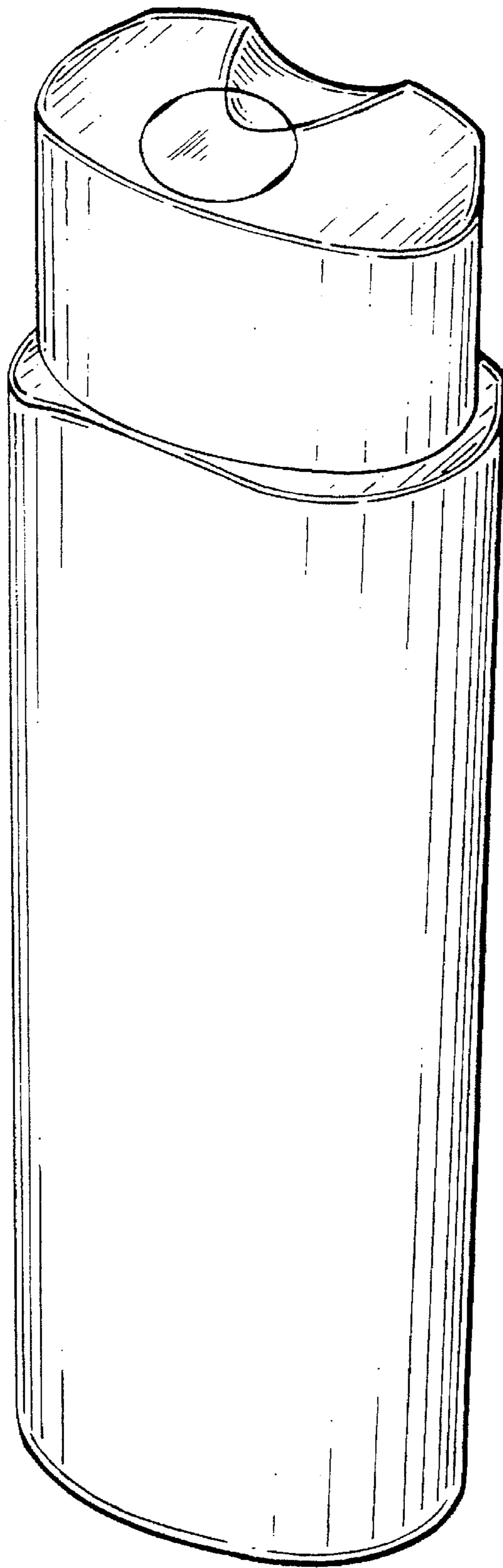

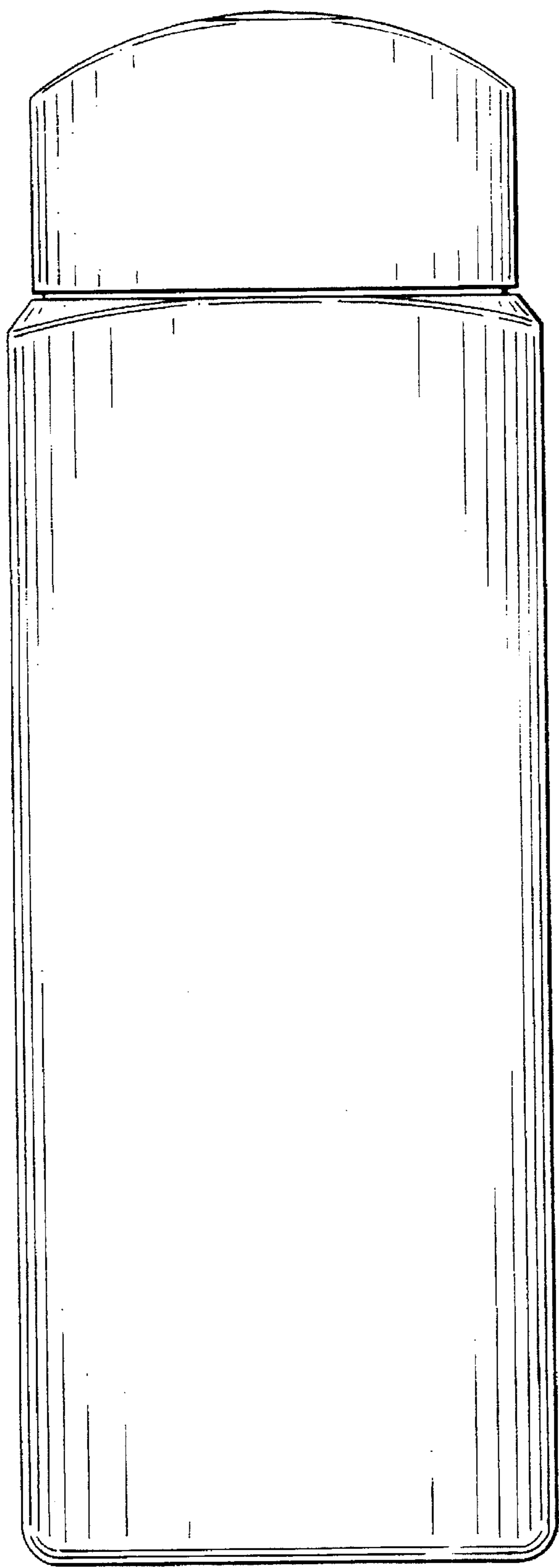

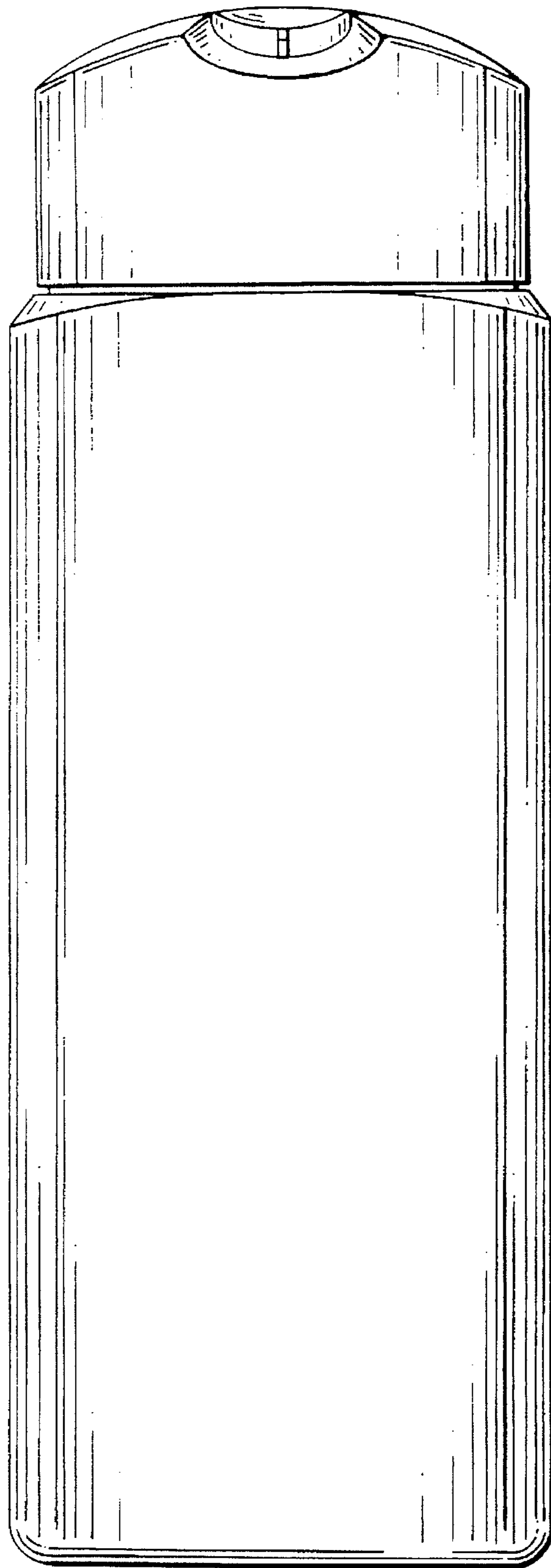

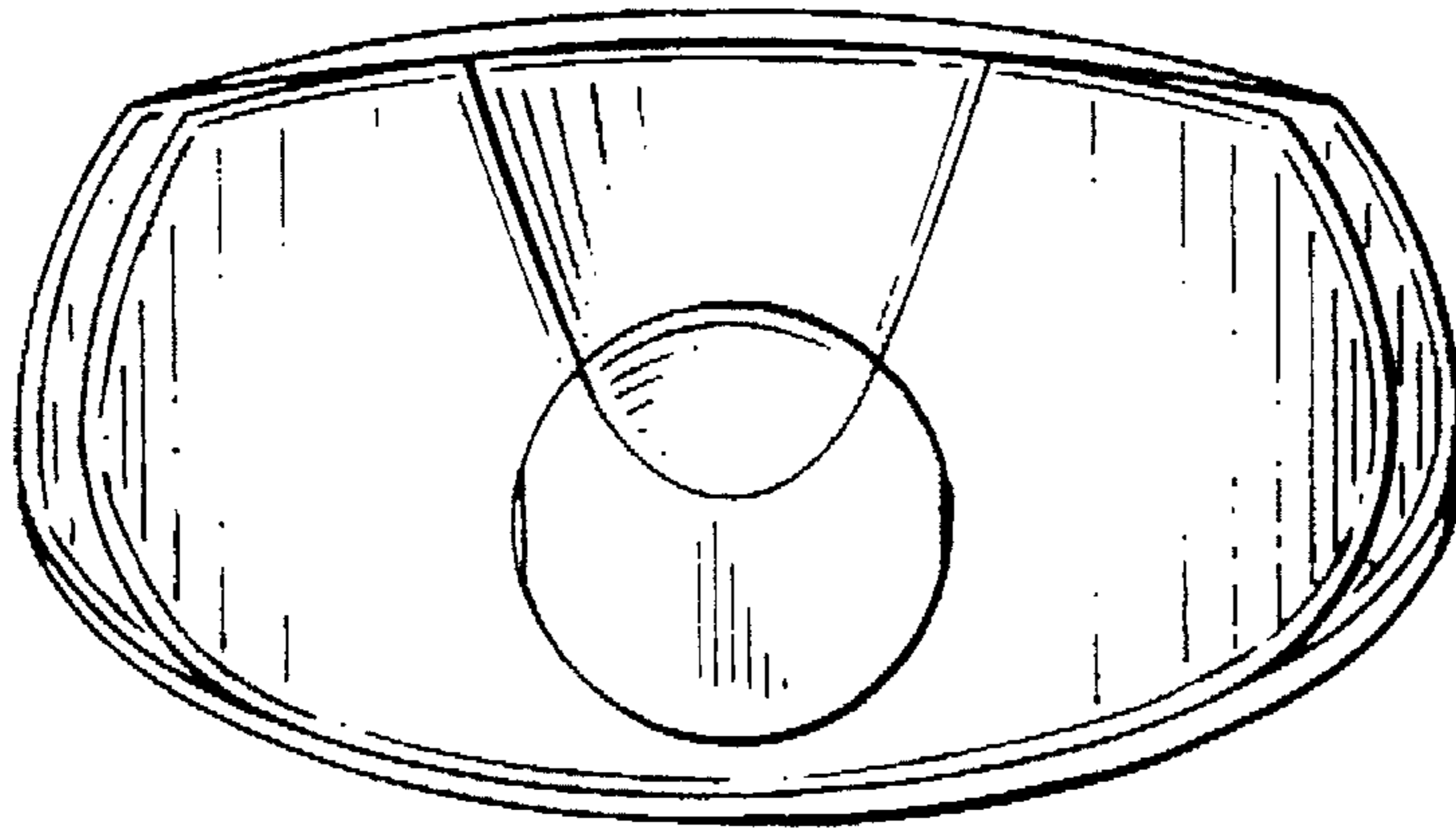

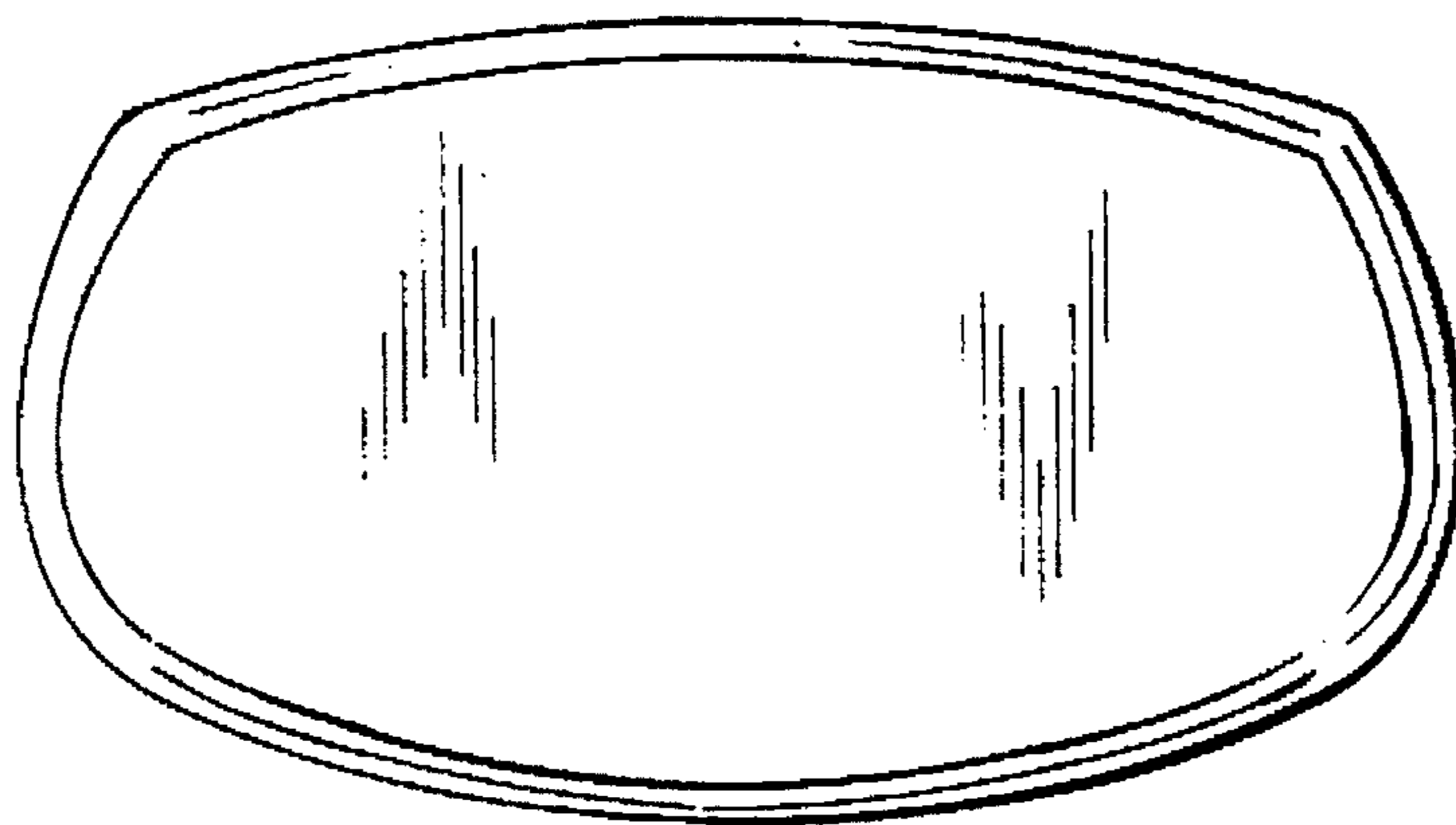

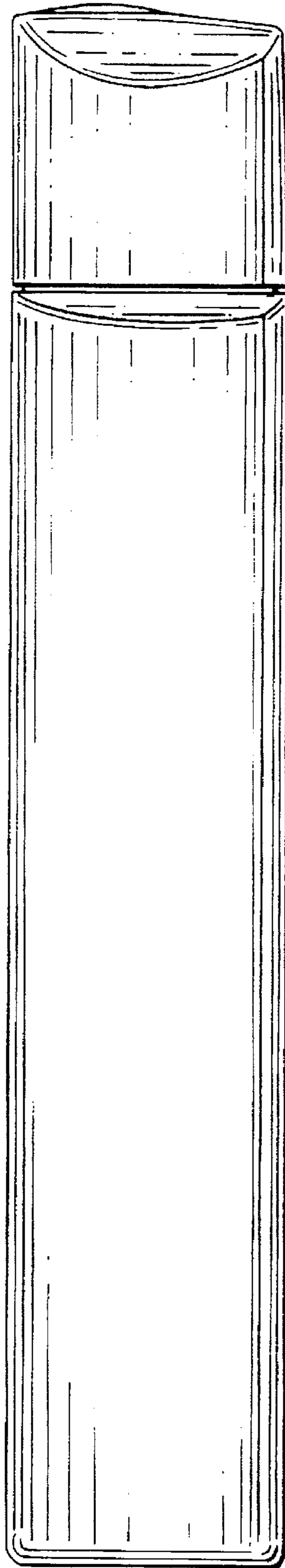

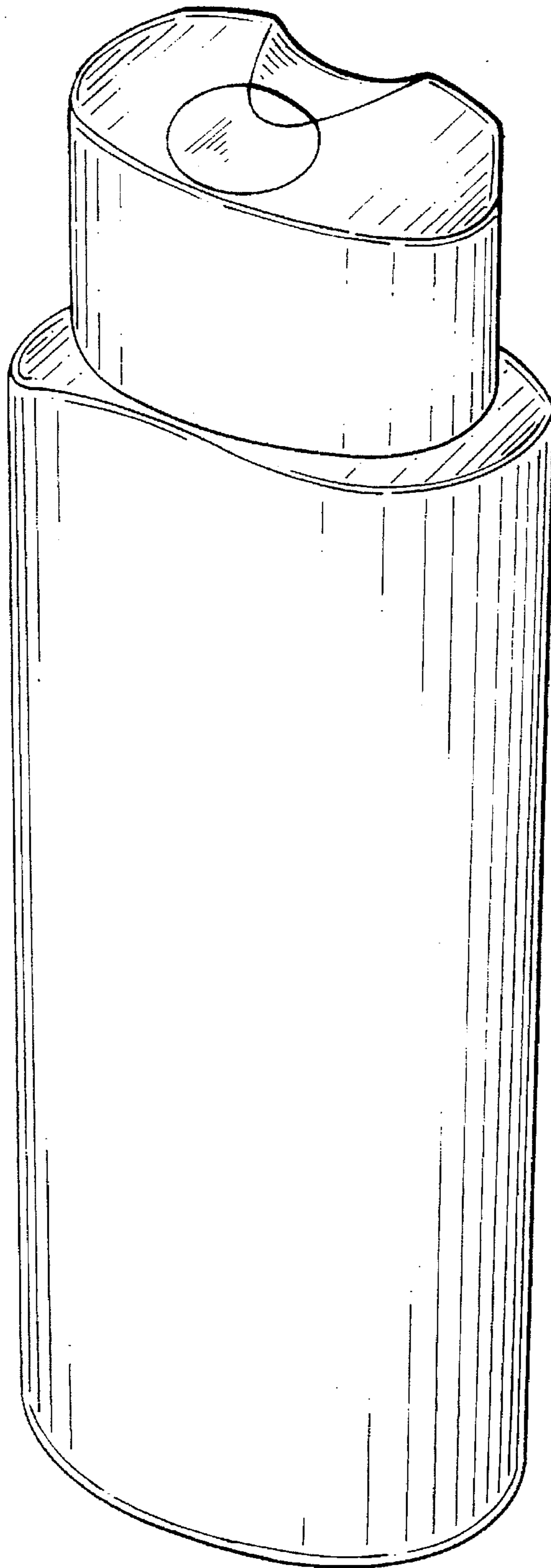

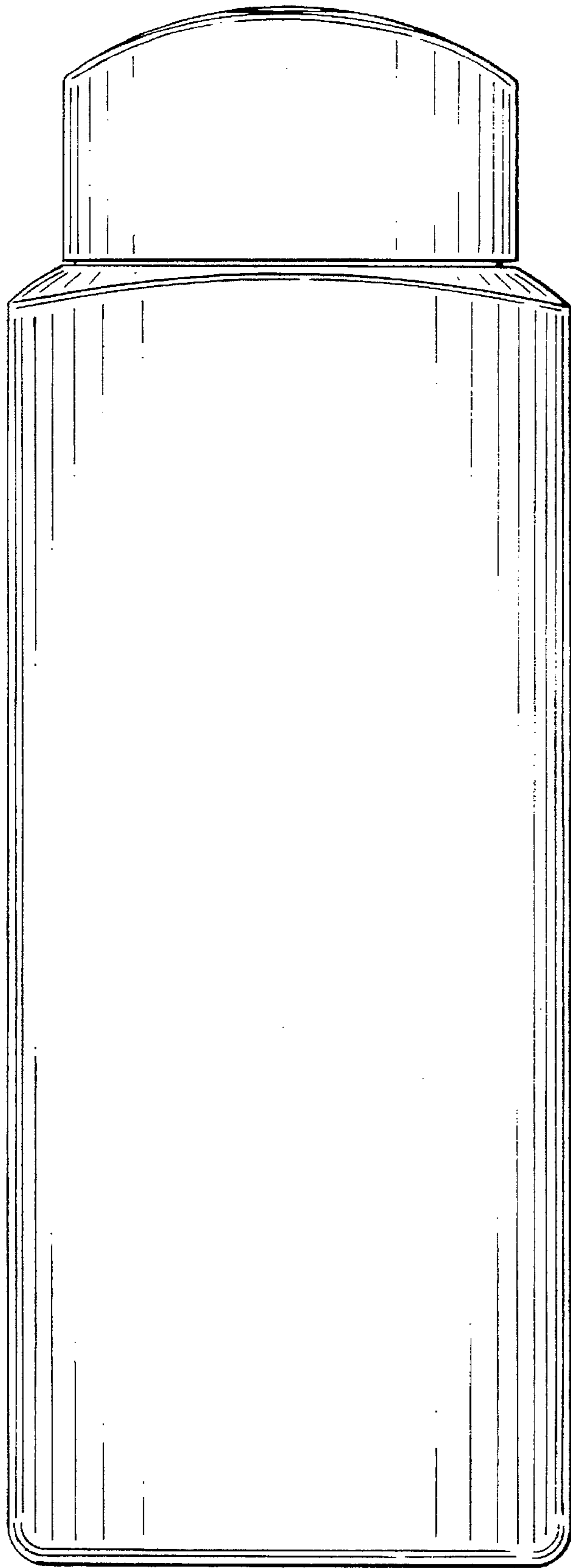

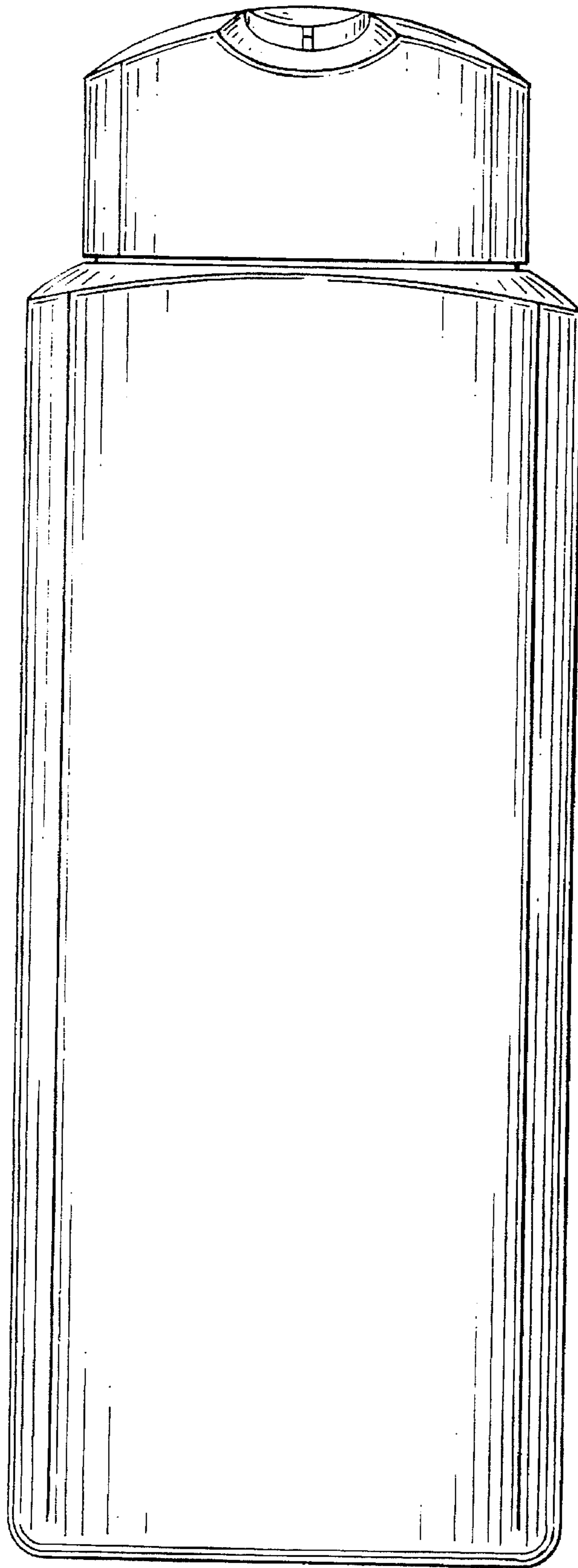

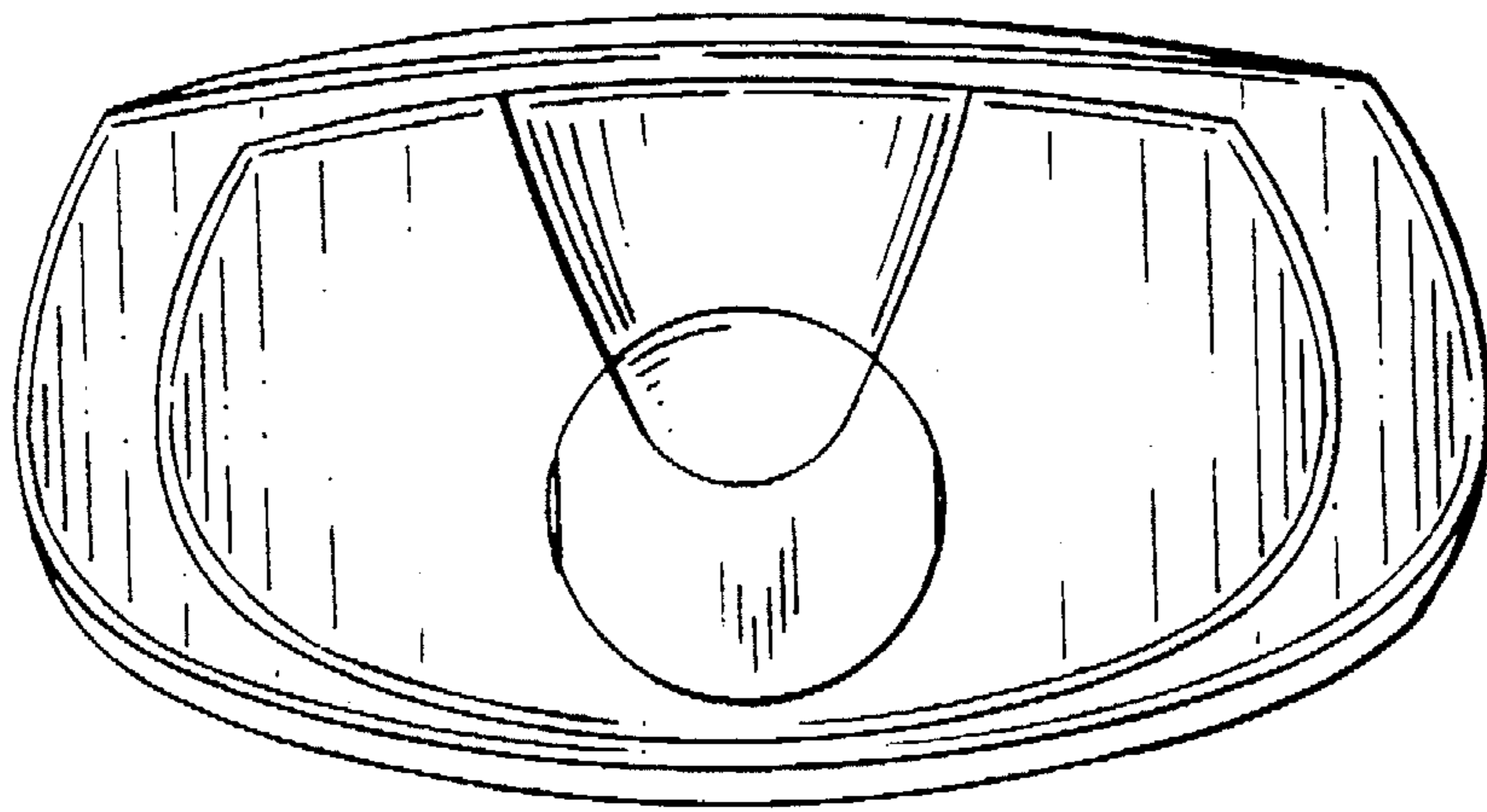

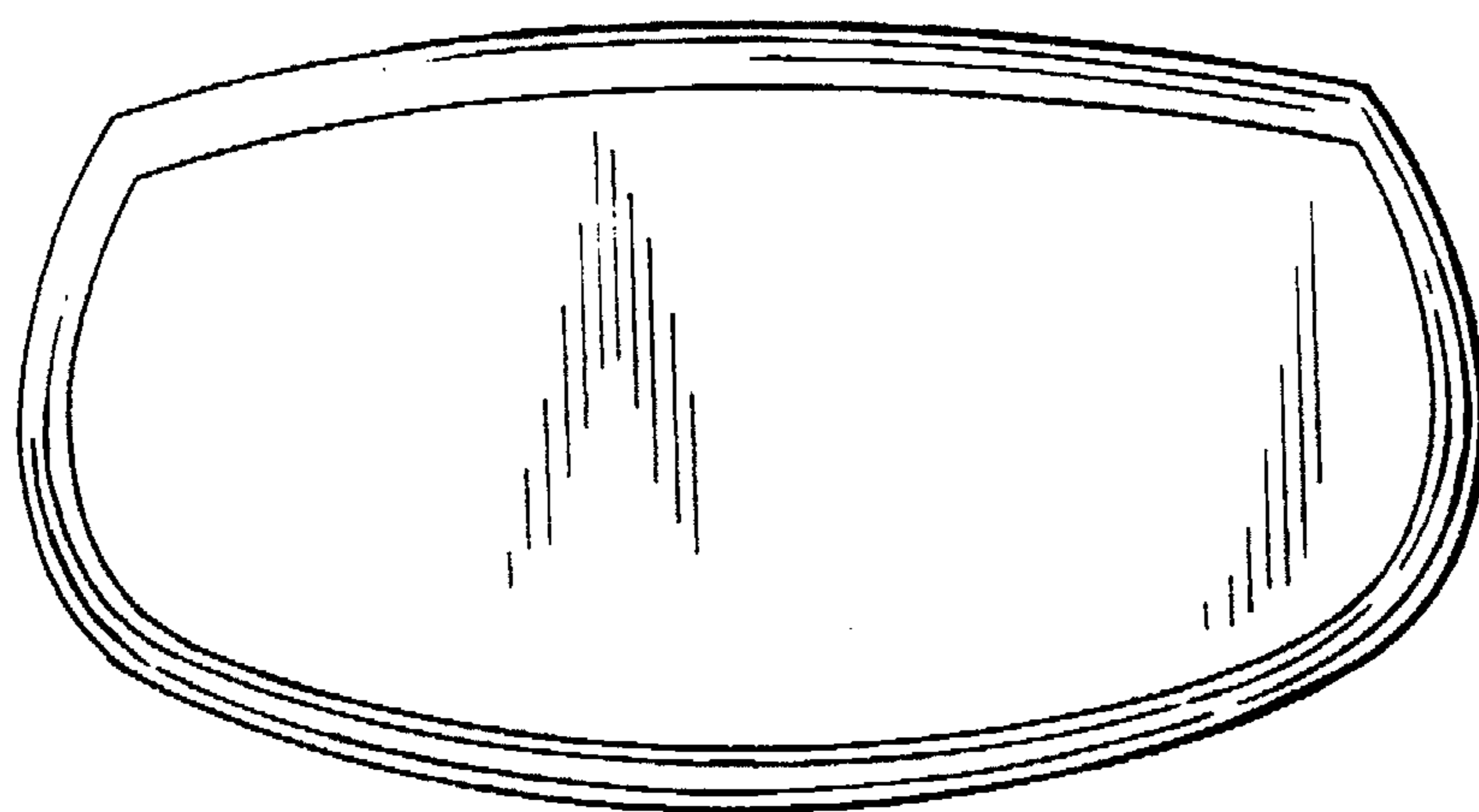

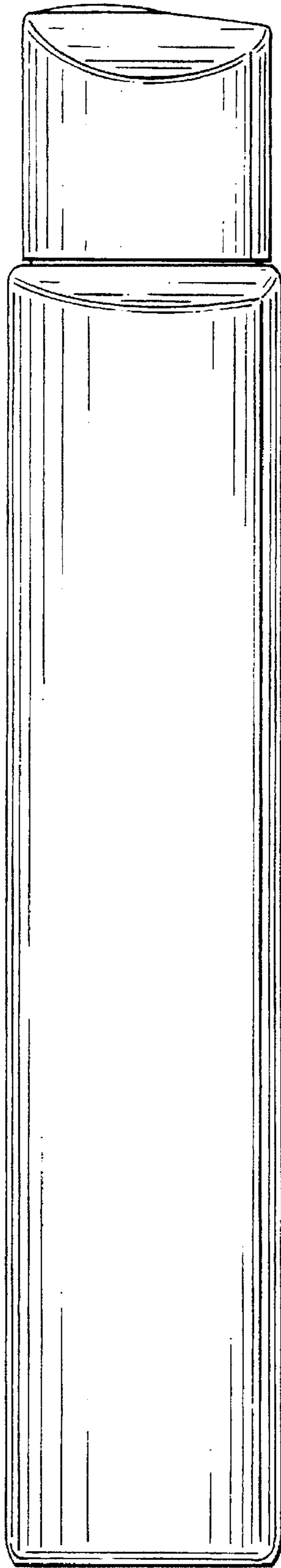
