[57] **CLAIM**

The ornamental design for a pair of ski, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of the pair of ski. The broken lines showing a skier with one ski on each foot are for illustrative purposes only and form no part of the claimed design. The ski shown in broken lines is identical to the ski shown in solid lines;

FIG. 2 is a top perspective view of one of the skis;

FIG. 3 is a front view thereof, the rear view being identical;

FIG. 4 is a top plan view thereof;

FIG. 5 is a side view thereof; and,

FIG. 6 is a bottom plan view thereof.

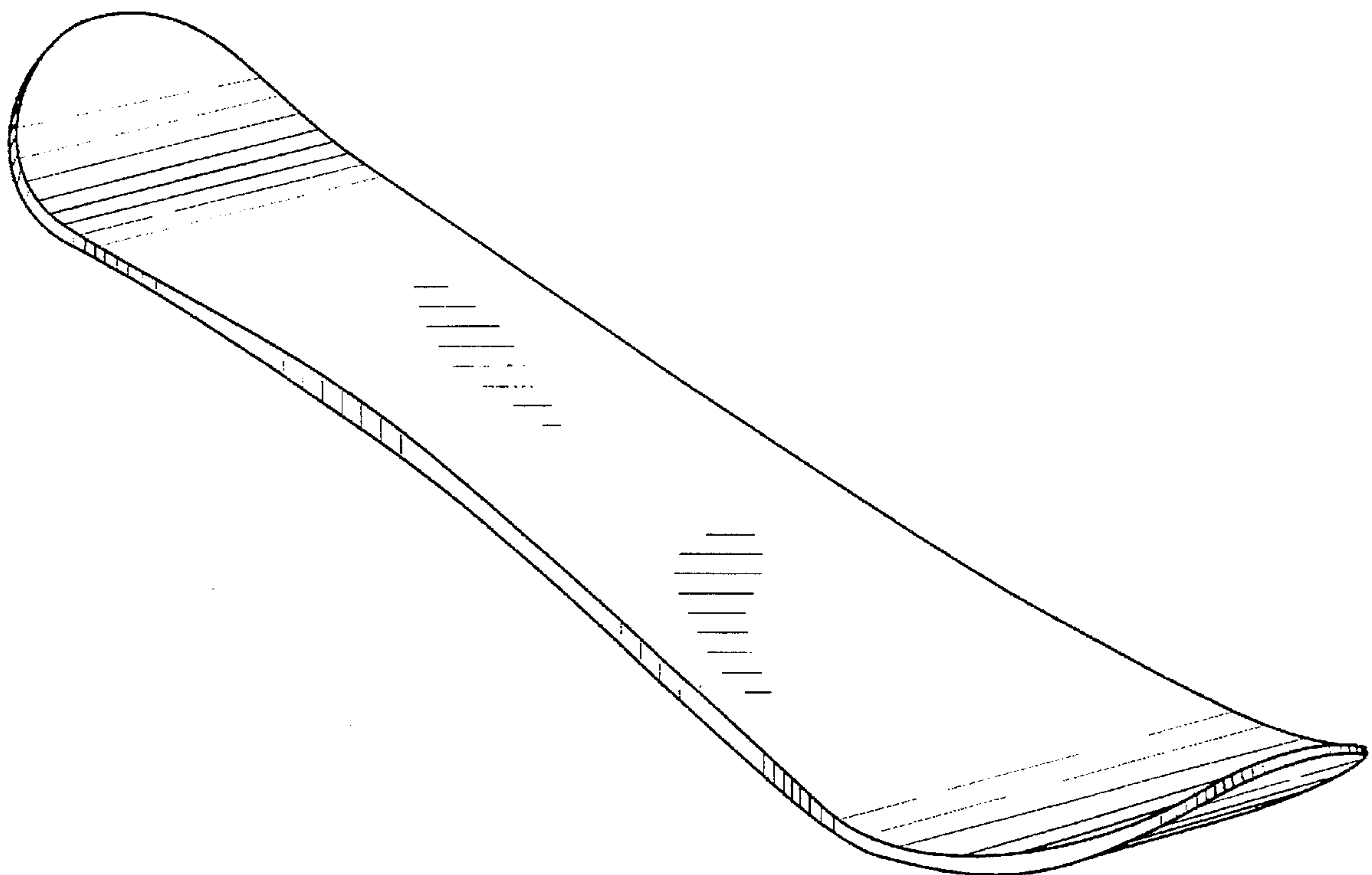

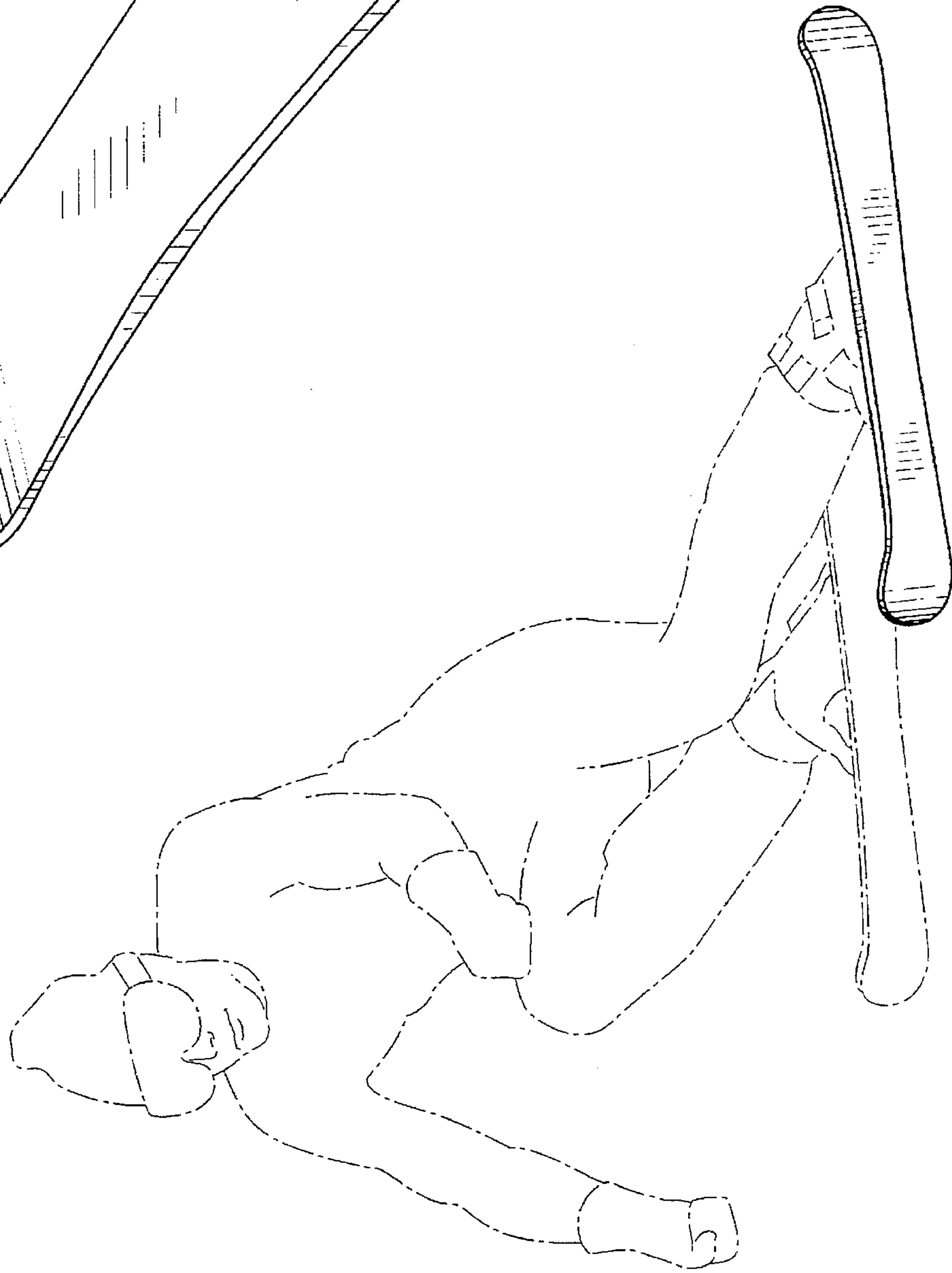

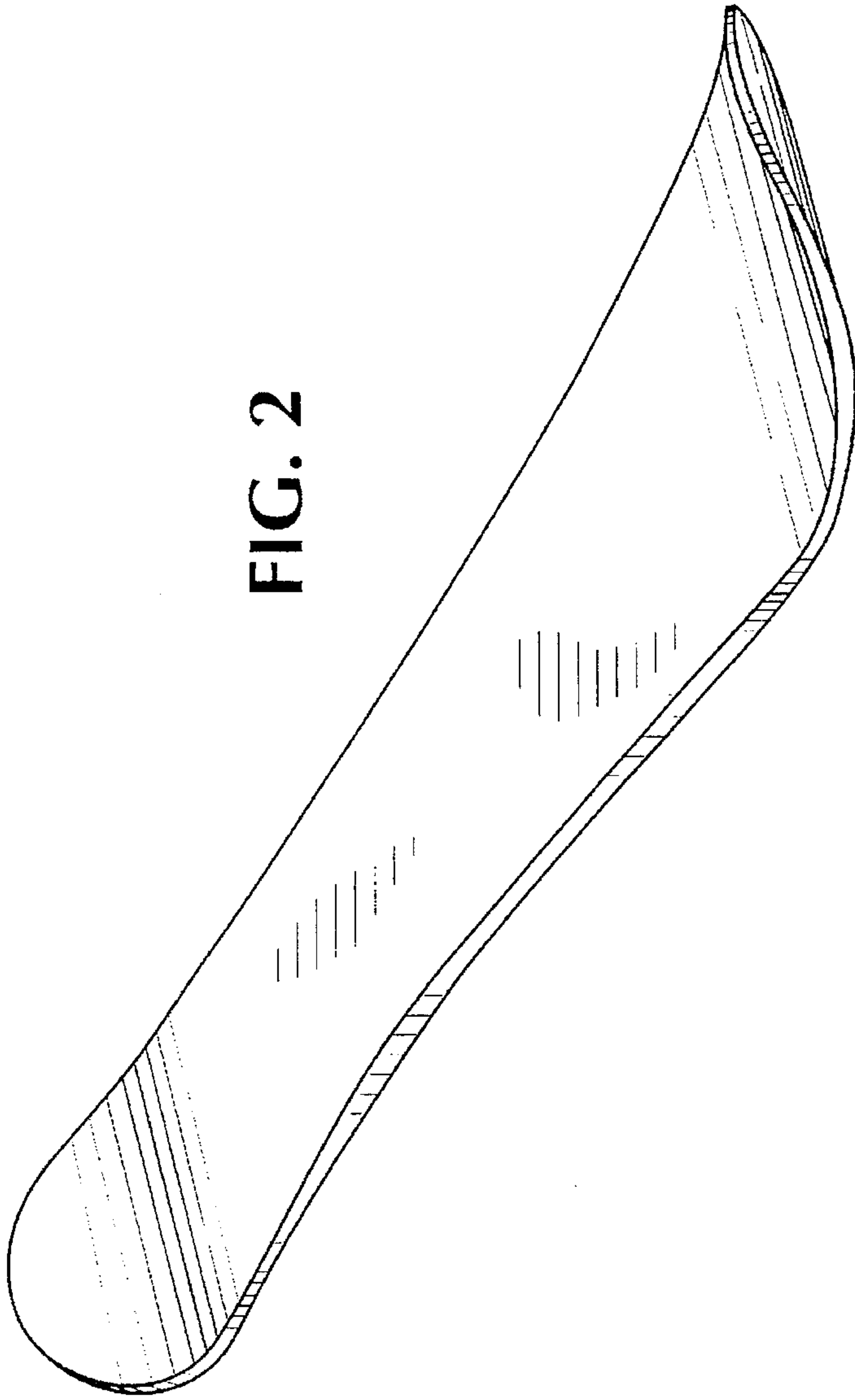
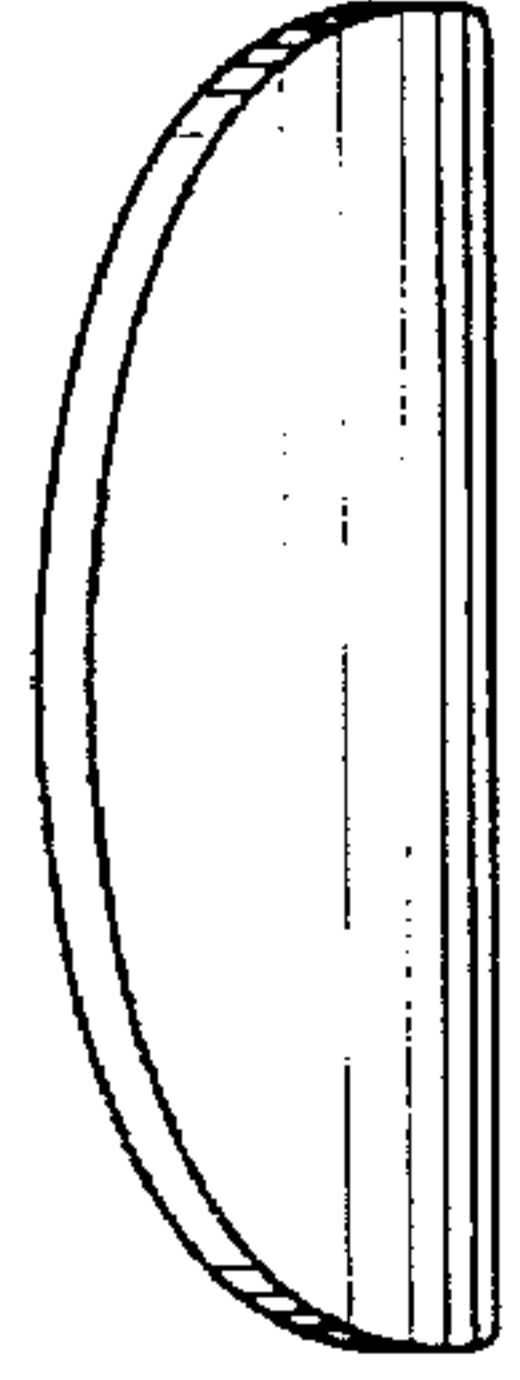

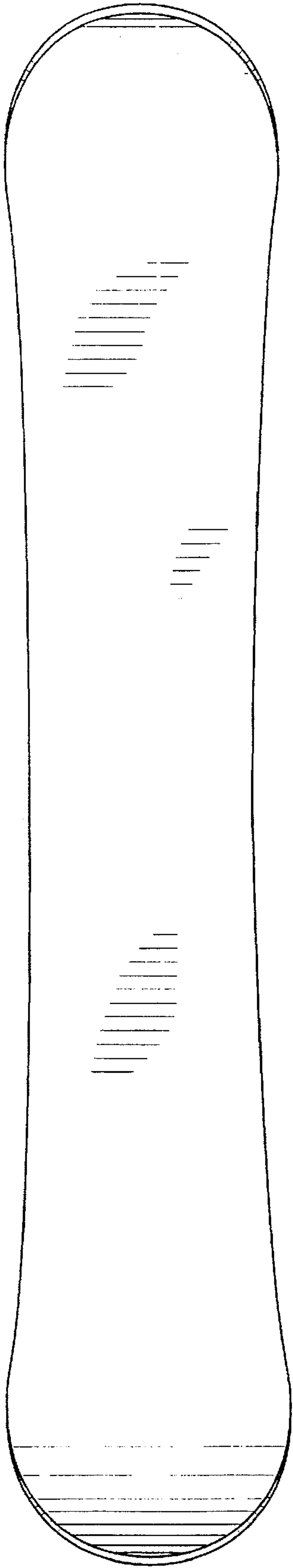

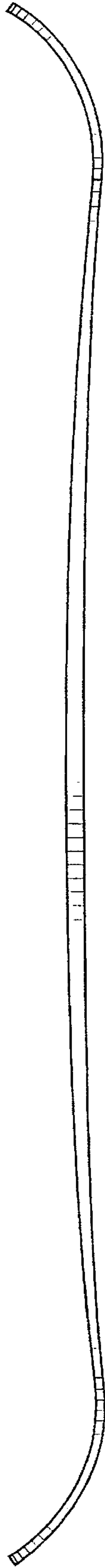

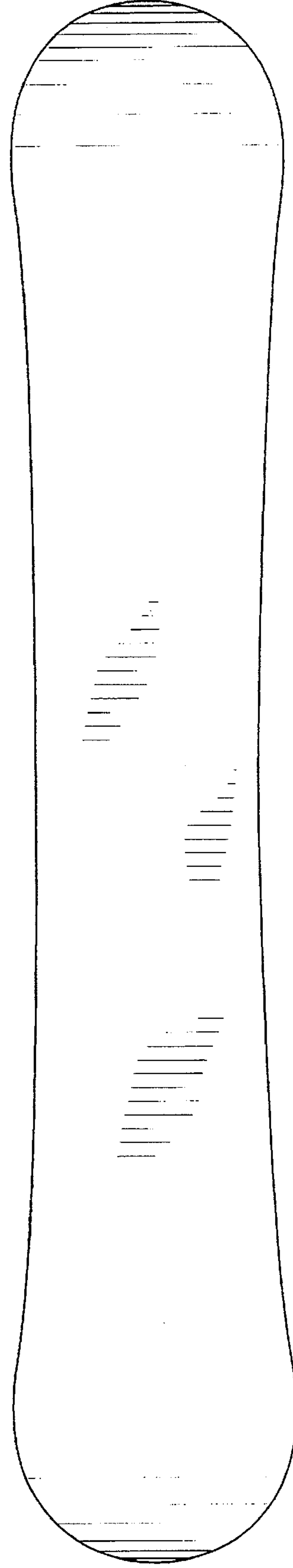
