[57] **CLAIM**

The ornamental design for a combined pet feeding and watering dish, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of my claimed design; FIG. 2 shows a side view of my claimed design of which the other side is identical; FIG. 3 shows a top view of my claimed design; FIG. 4 shows a bottom view of my claimed design; FIG. 5 shows an end view of my claimed design; FIG. 6 shows a view from the other end of my claimed design; and, FIG. 7 shows a cross-sectional view along the line VII—VII of FIG. 3, and provided to show the tapered nature of the upstanding walls of my claimed design.

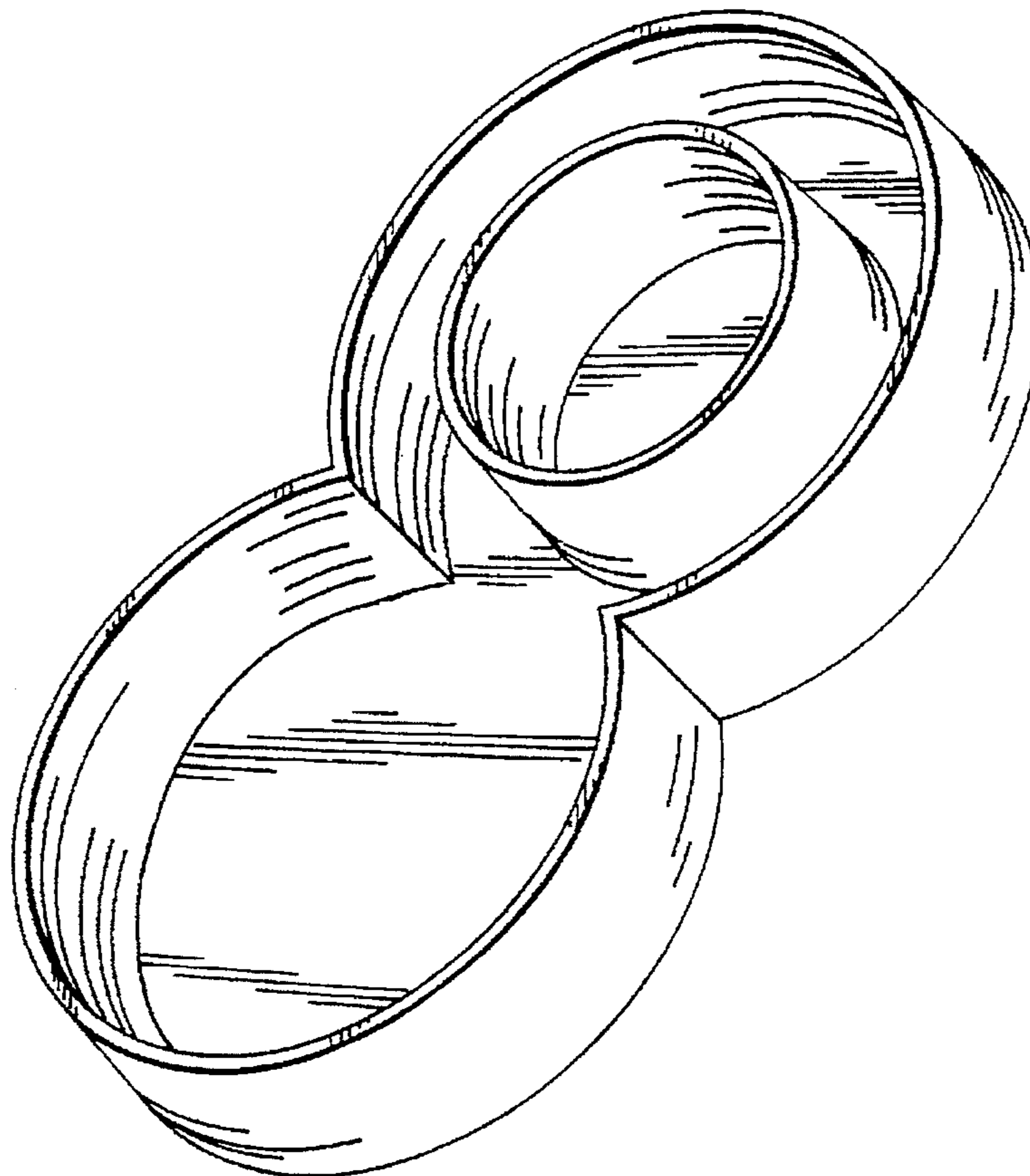

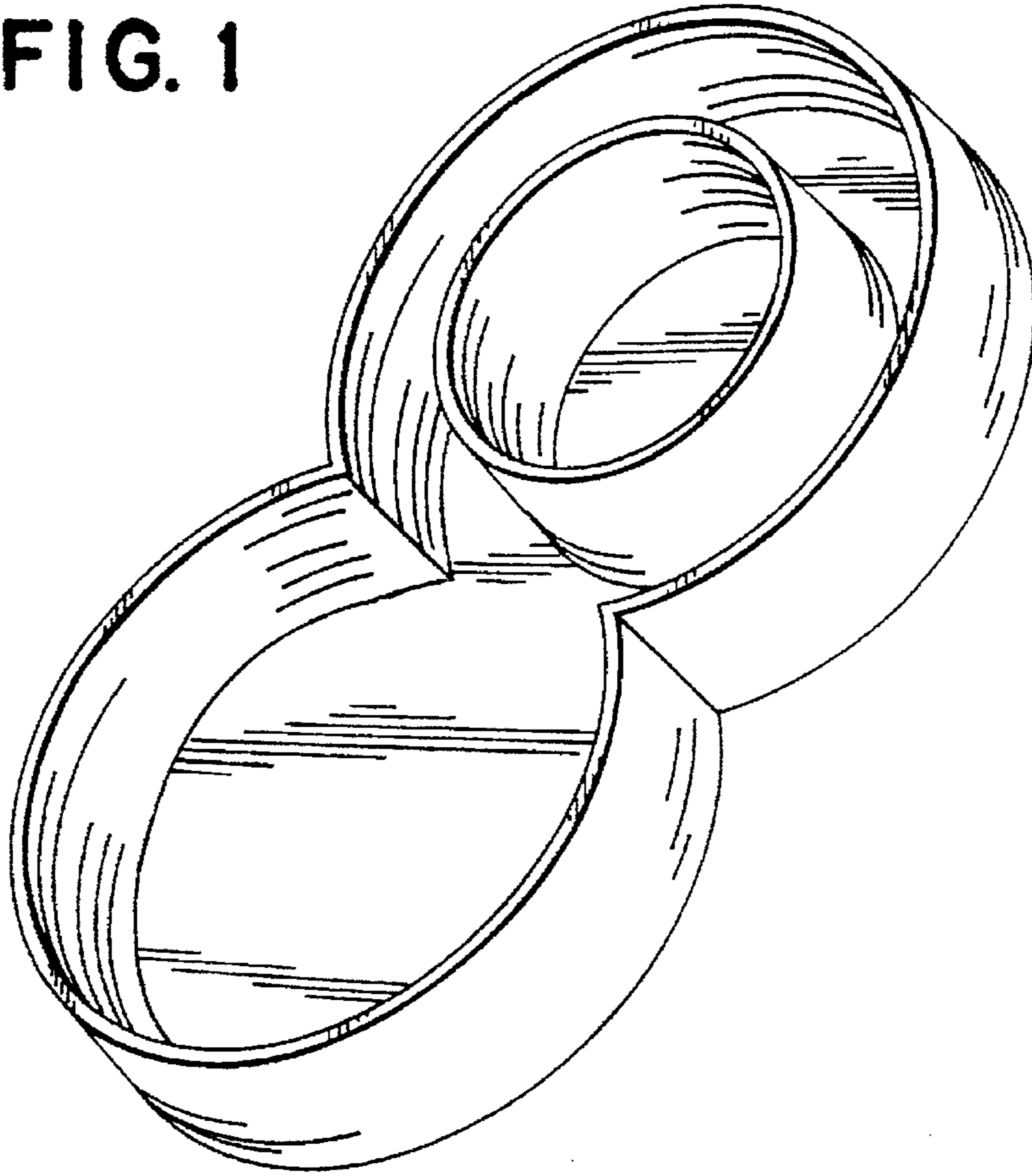

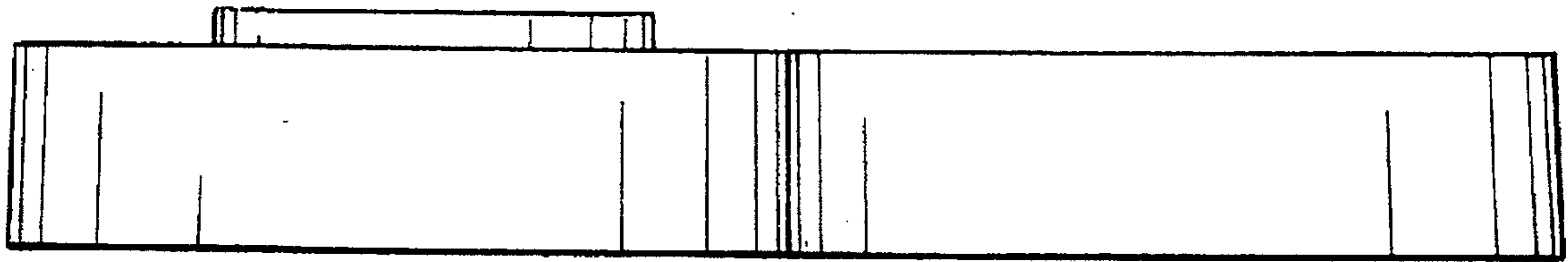

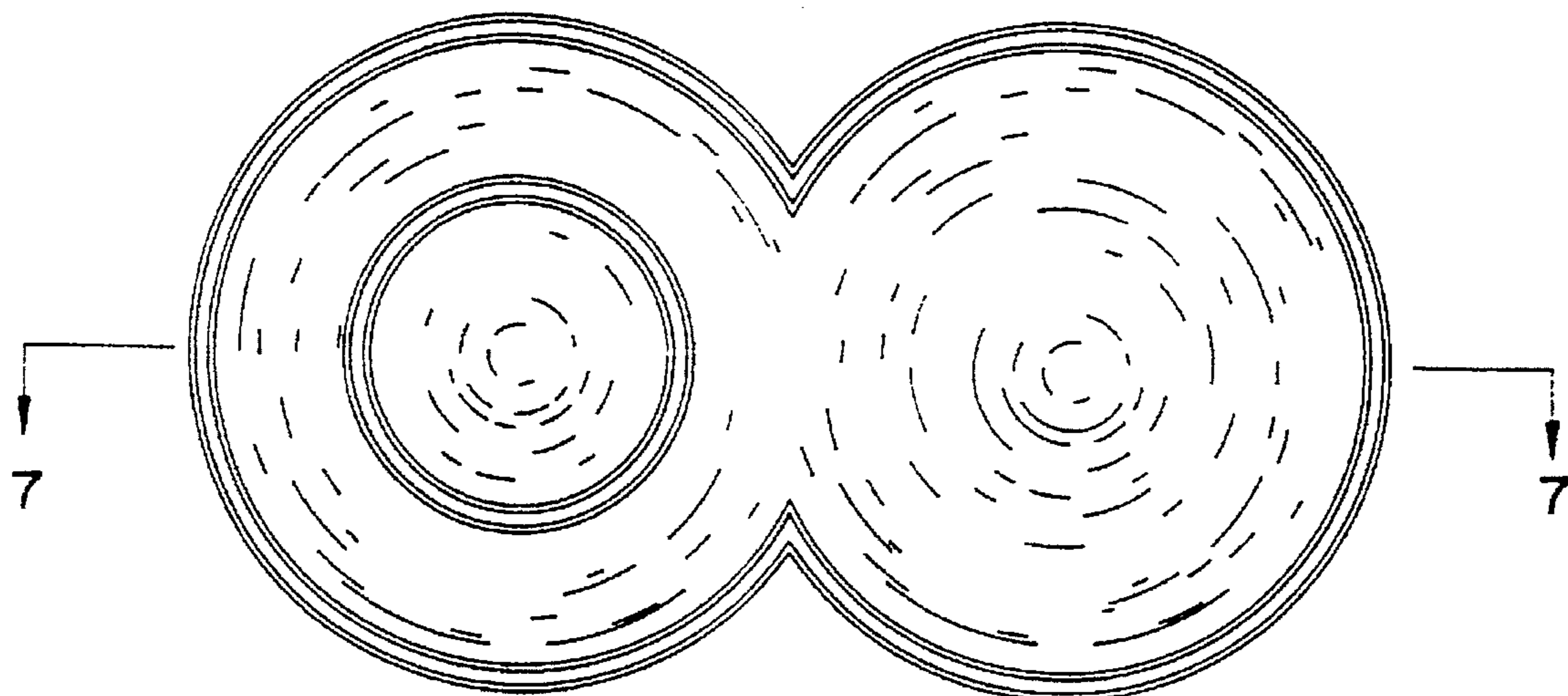

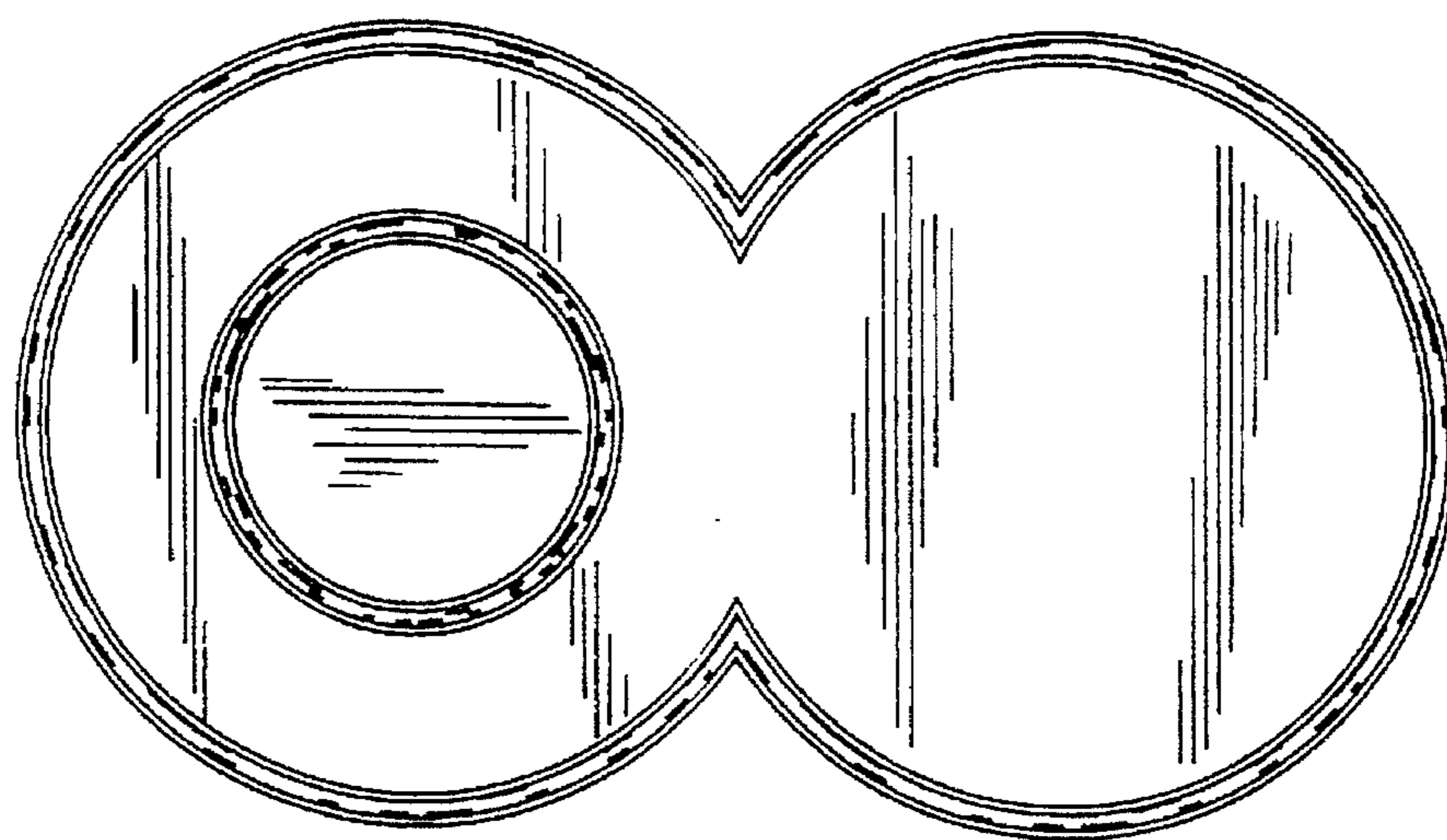

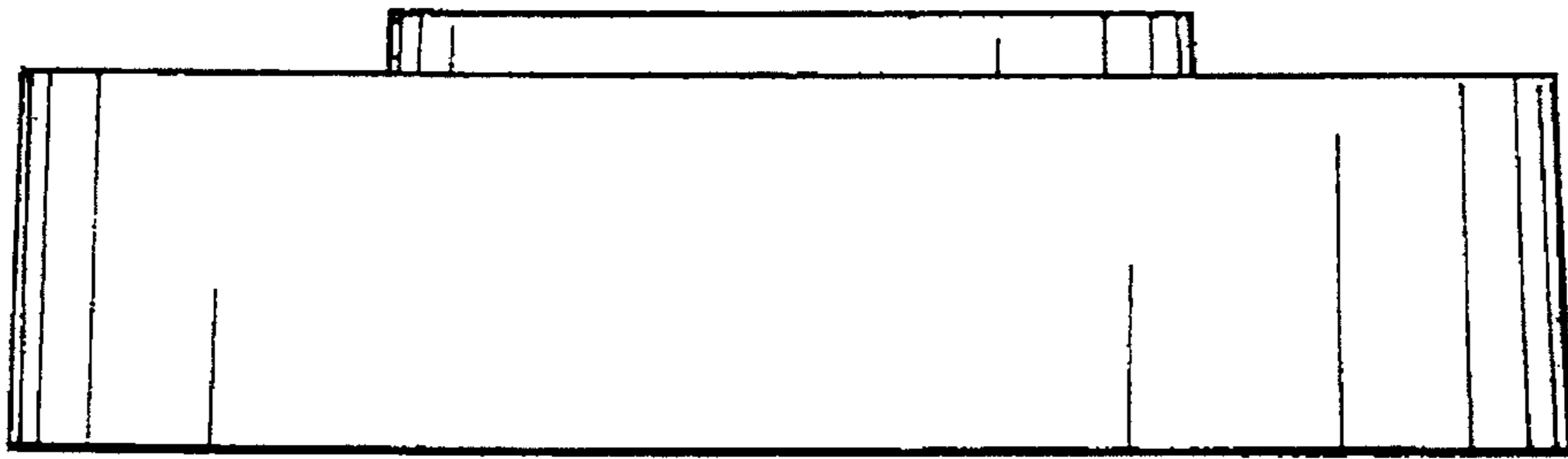

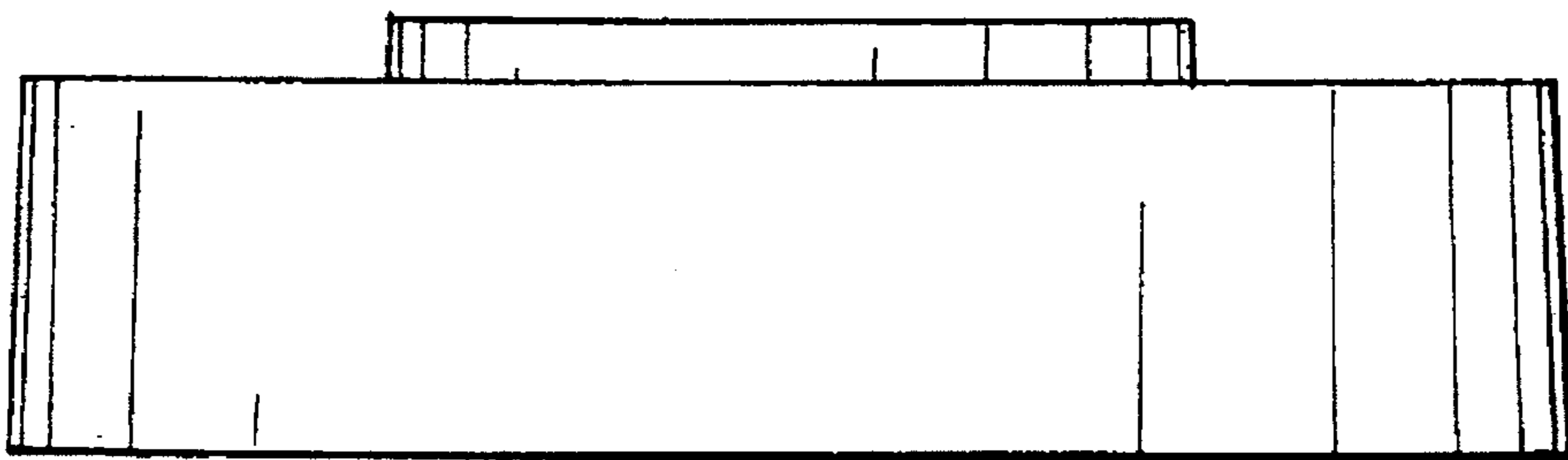
