[57] **CLAIM**

The ornamental design for a combined housing for a pet leash and flashlight, as shown.

DESCRIPTION

FIG. 1 is a left side perspective view of the combined housing for a pet leash and flashlight of our new design; FIG. 2 is left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is front end view thereof; FIG. 5 is a rear end view thereof; FIG. 6 is top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

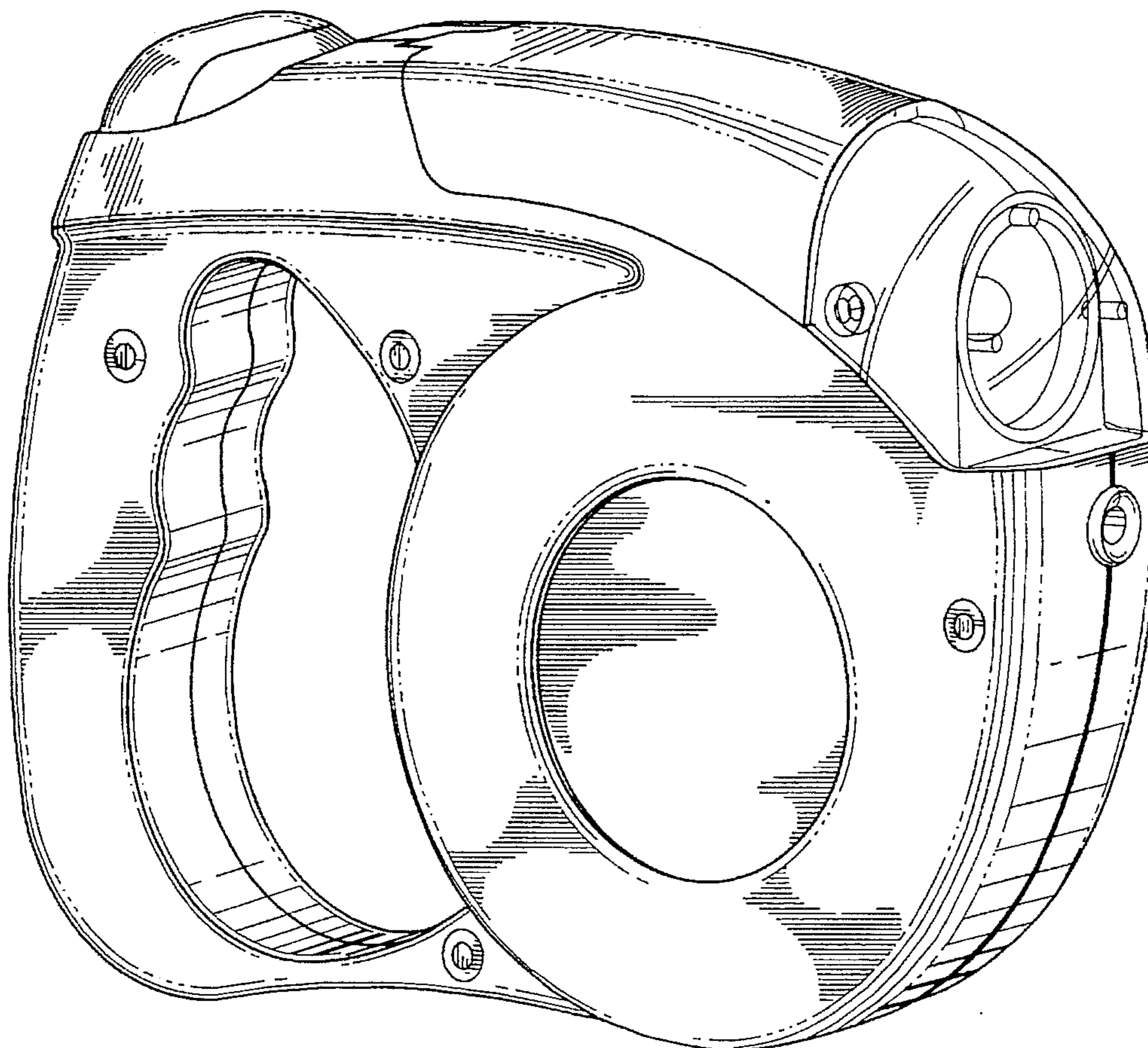

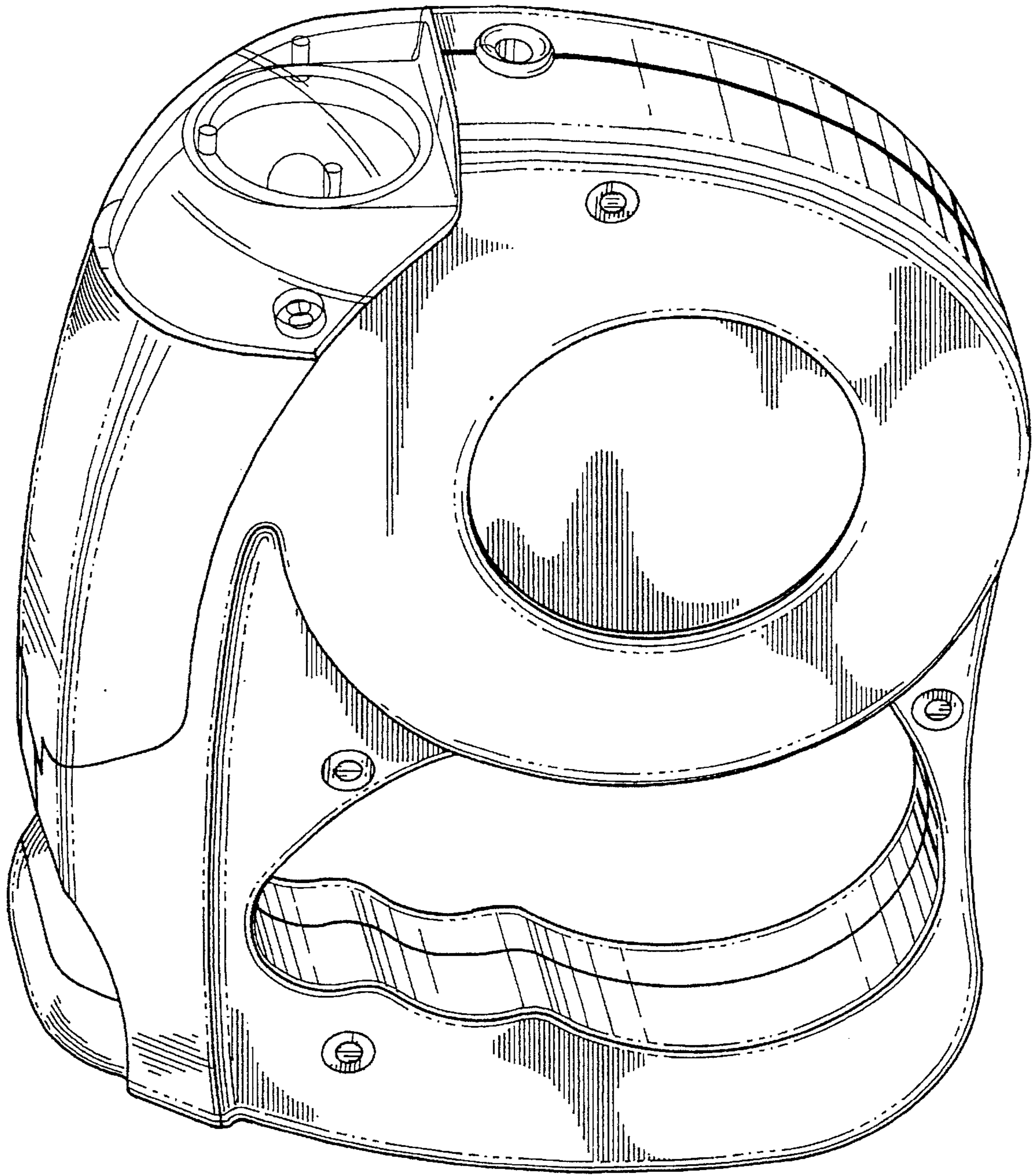

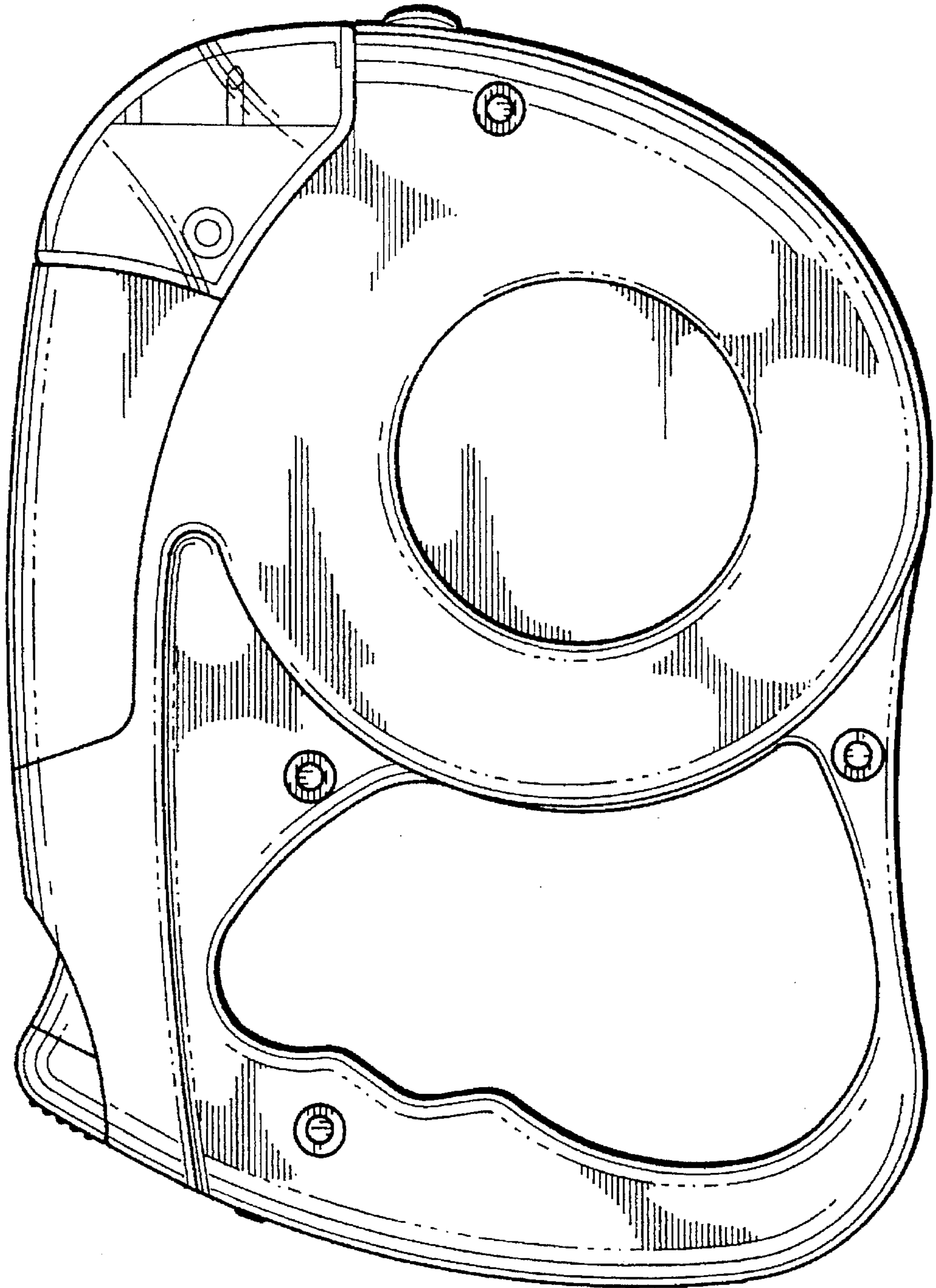
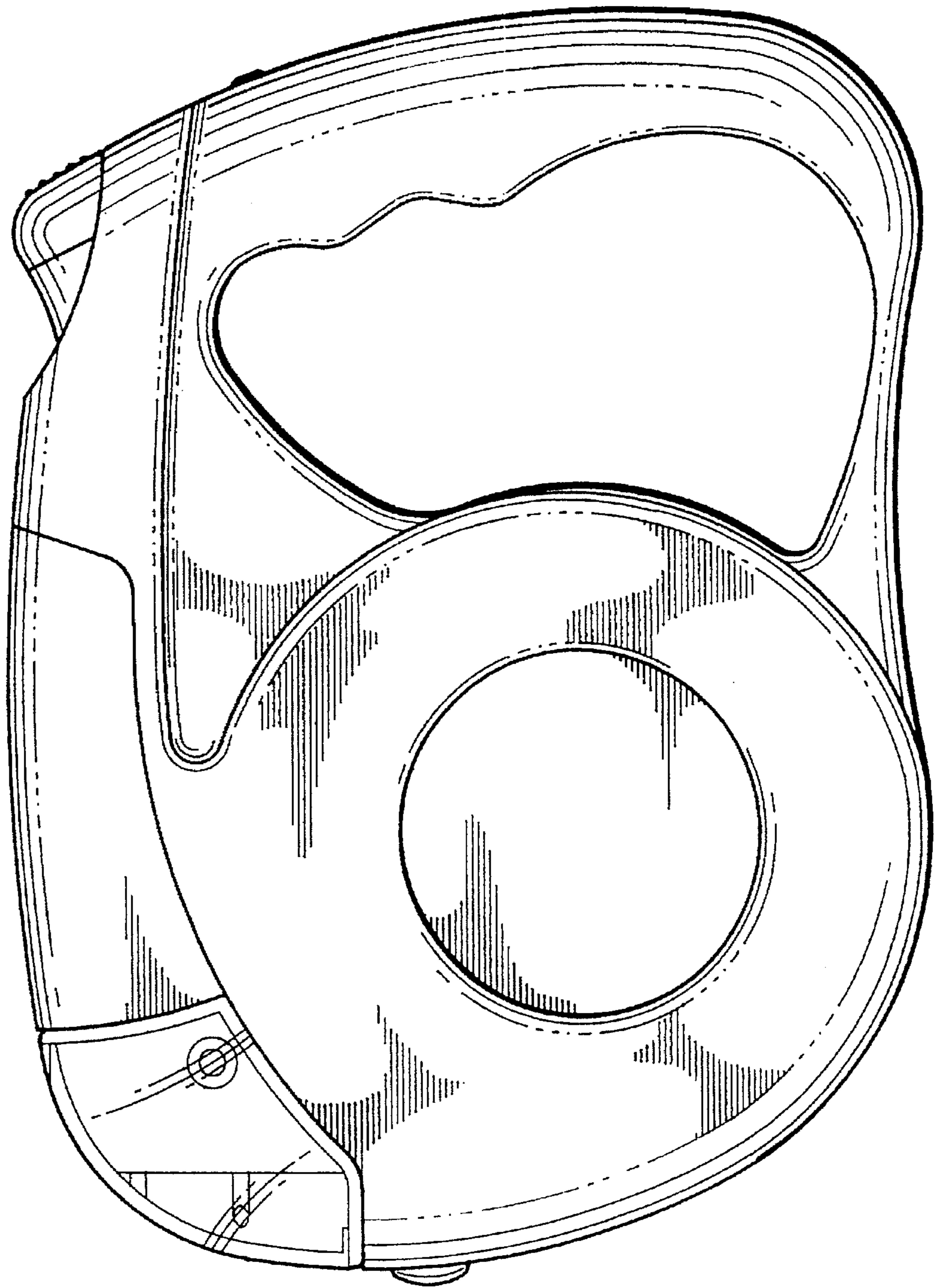

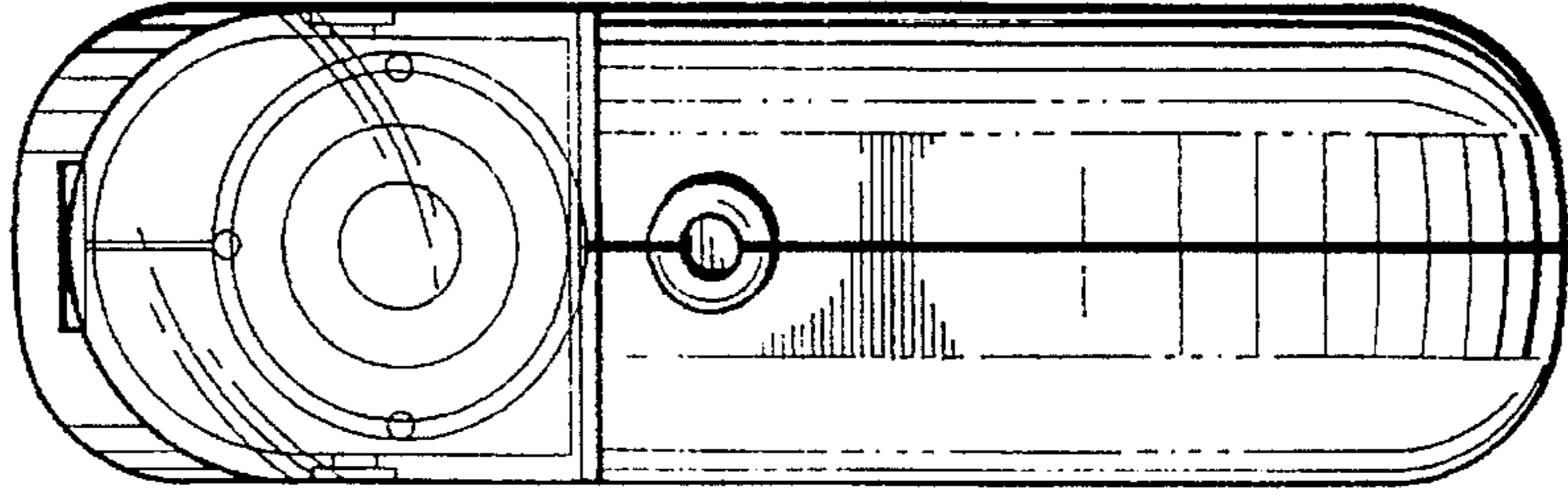

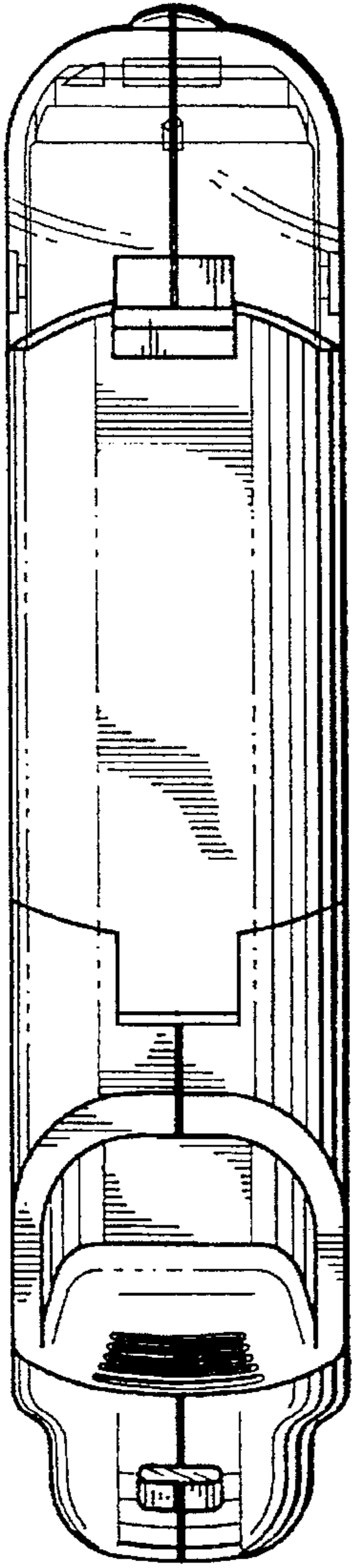

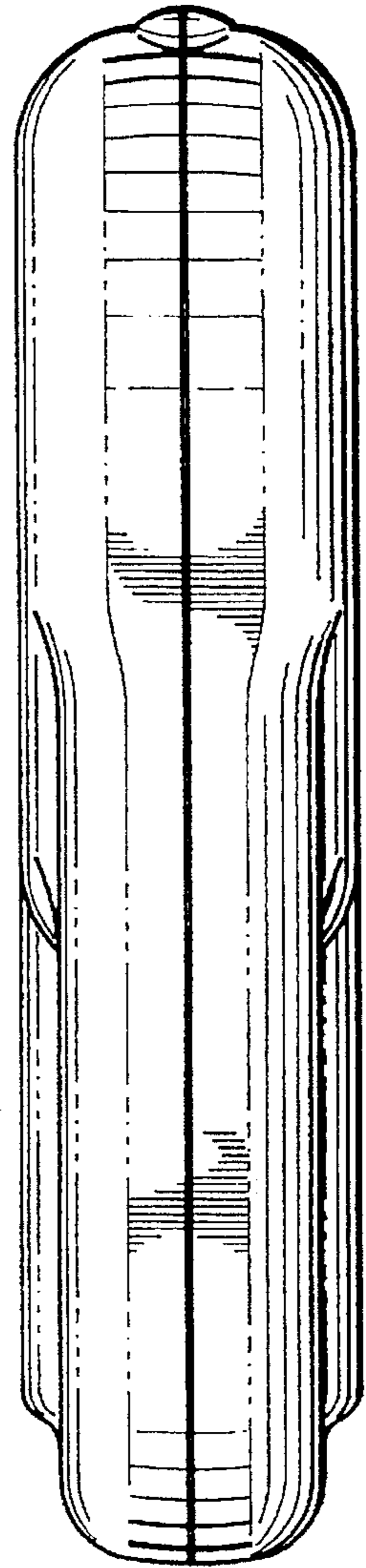

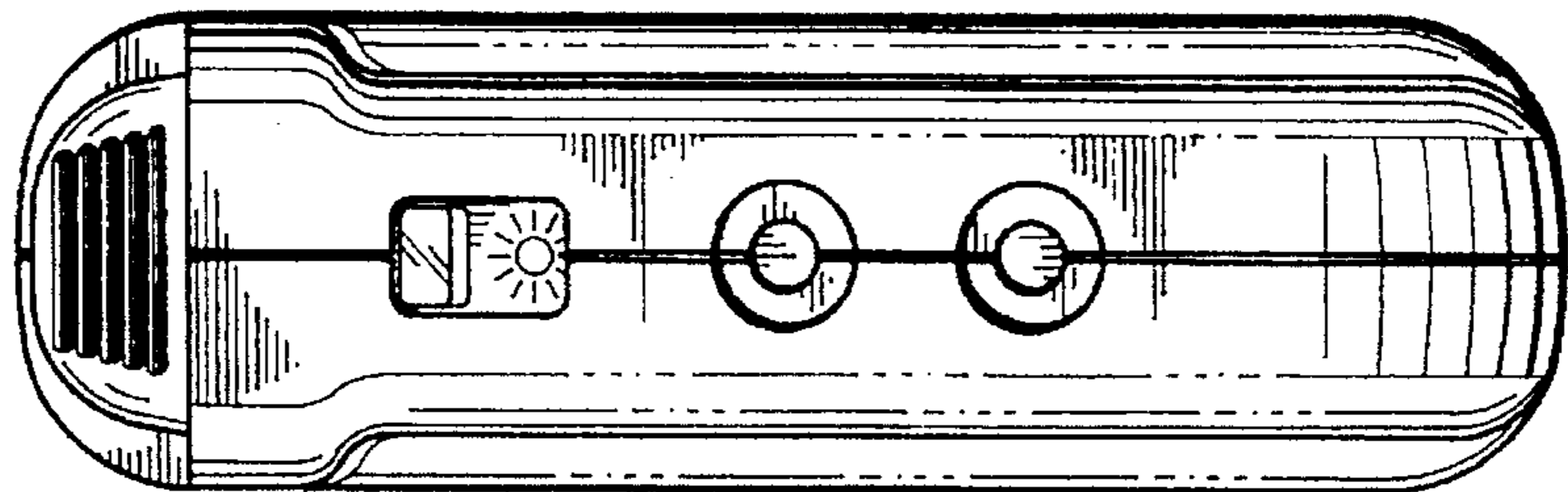
