[57] **CLAIM**

The ornamental design for a holiday display with miniature ferris wheels, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a holiday display with miniature ferris wheels showing our new design;

FIG. 2 is a front elevational view of the base module, shown separately for clarity of illustration;

FIG. 3 is a left side elevational view of FIG. 2;

FIG. 21 is a front elevational view of FIG. 20;

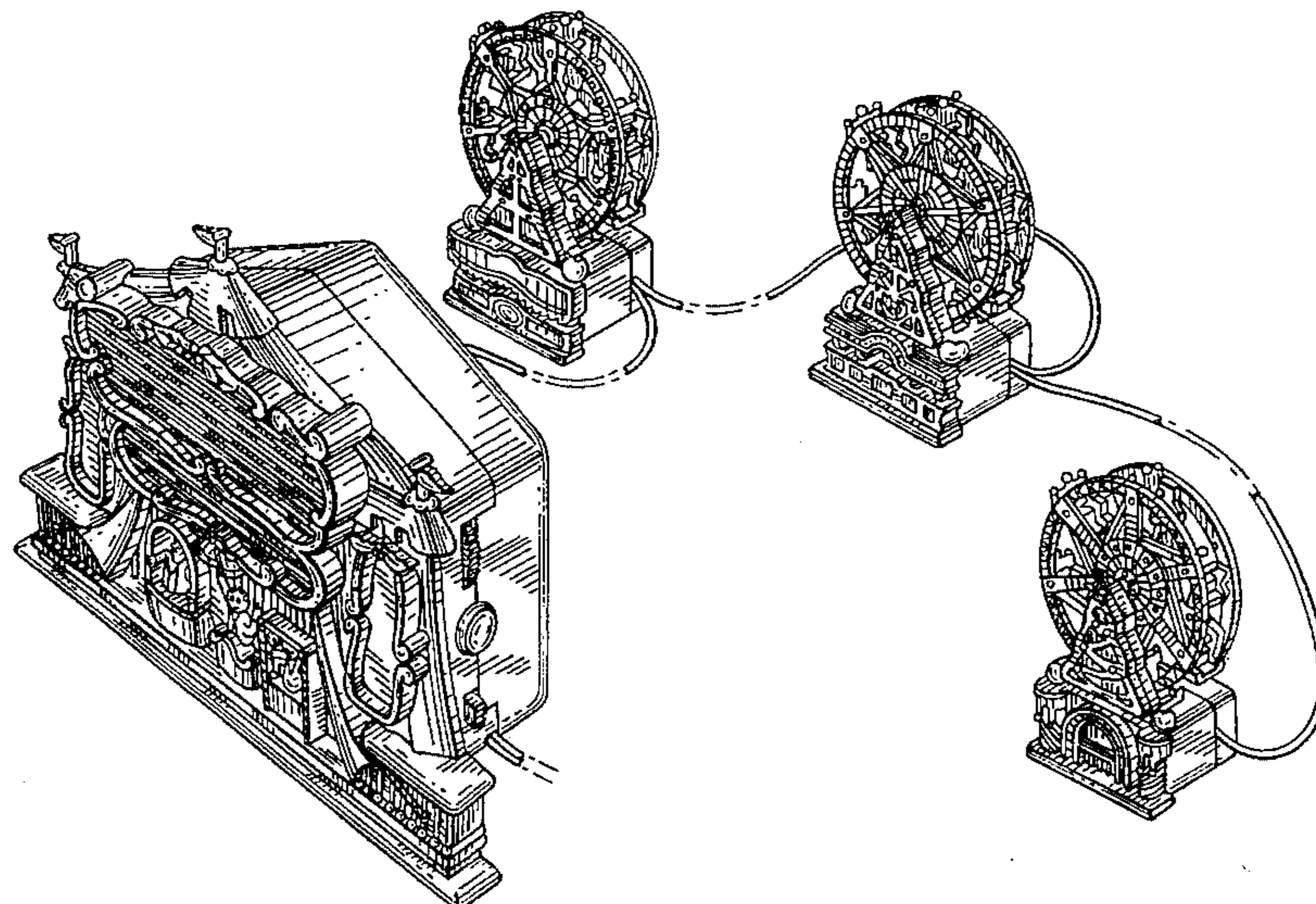
FIG. 22 is a right side elevational view of FIG. 20;

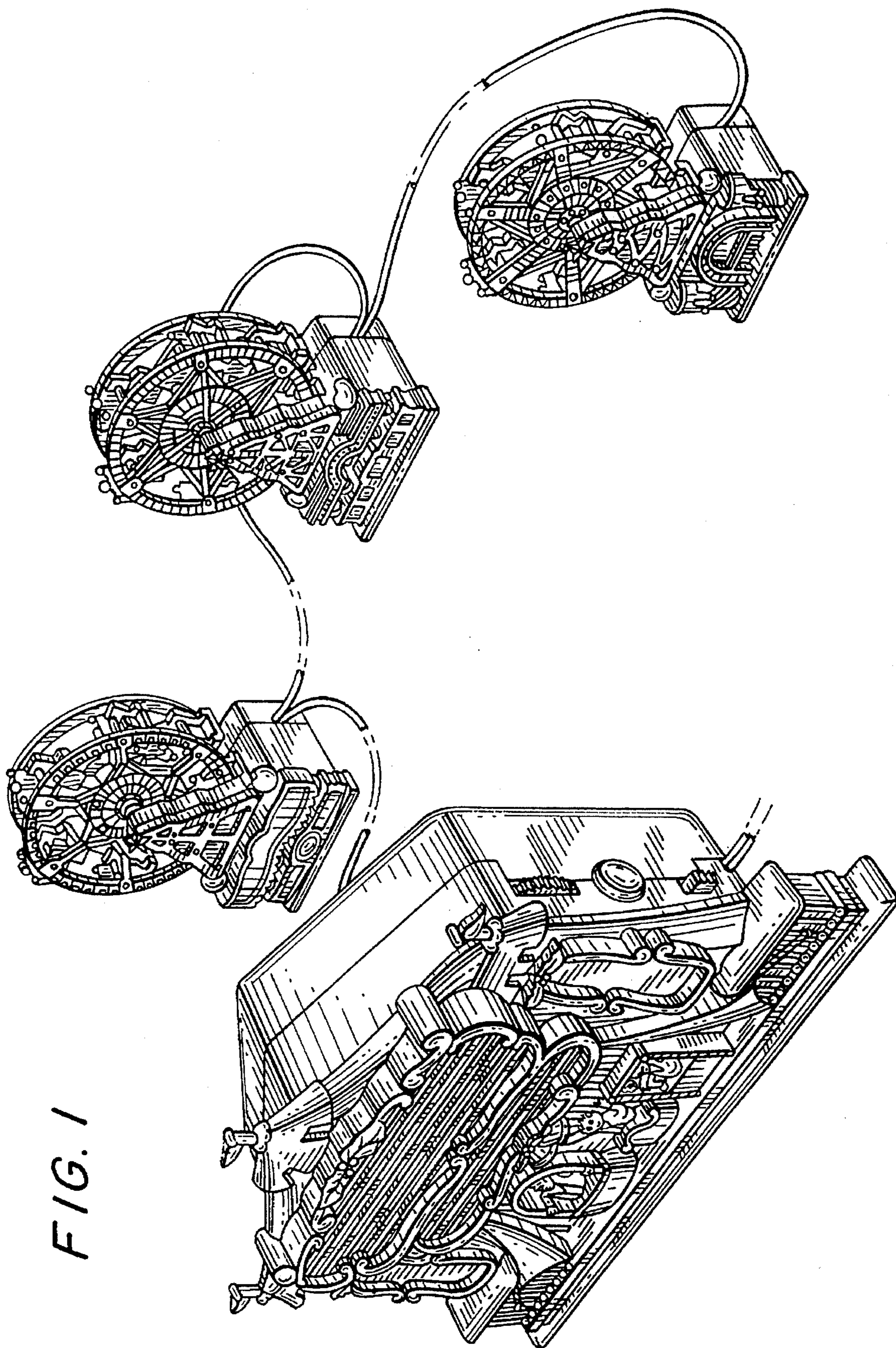

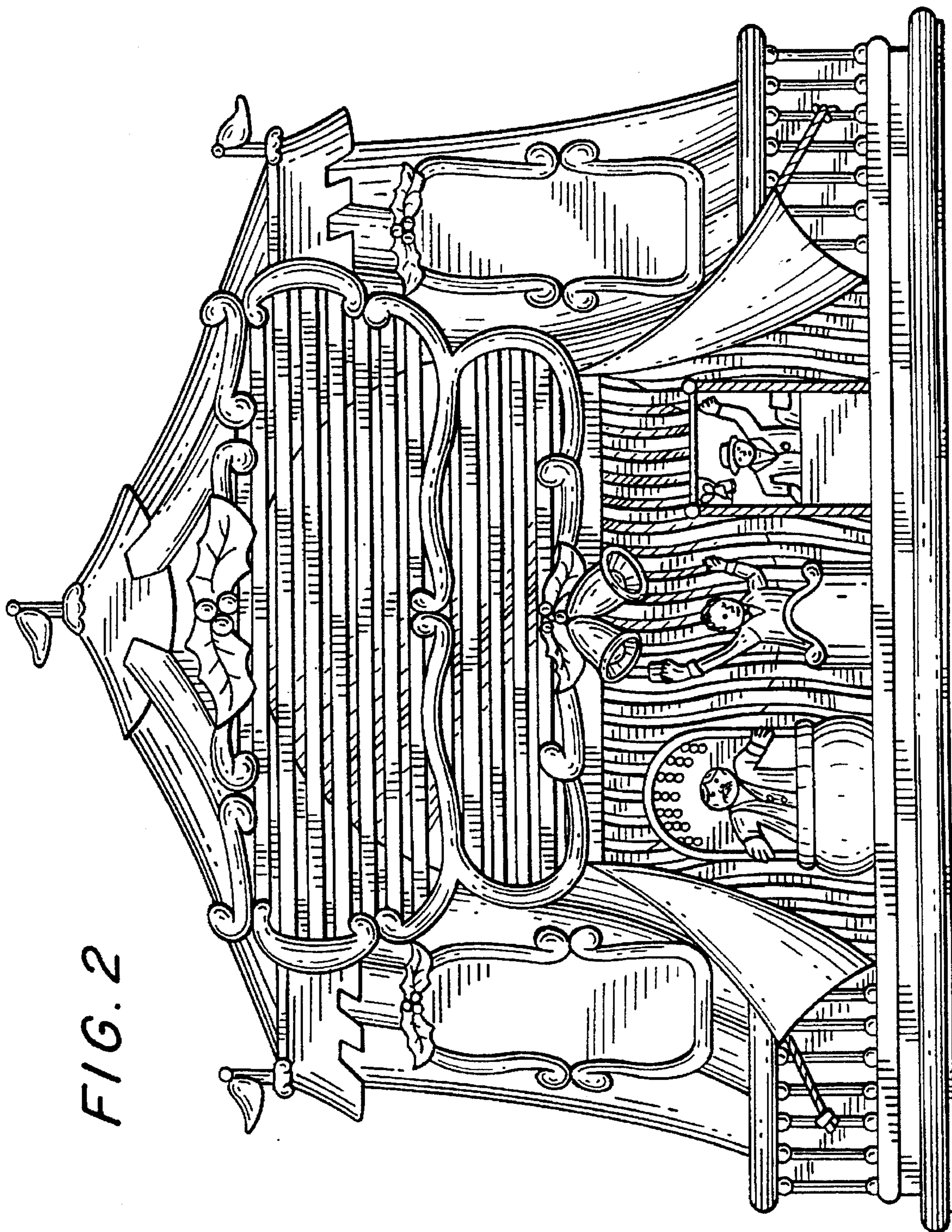

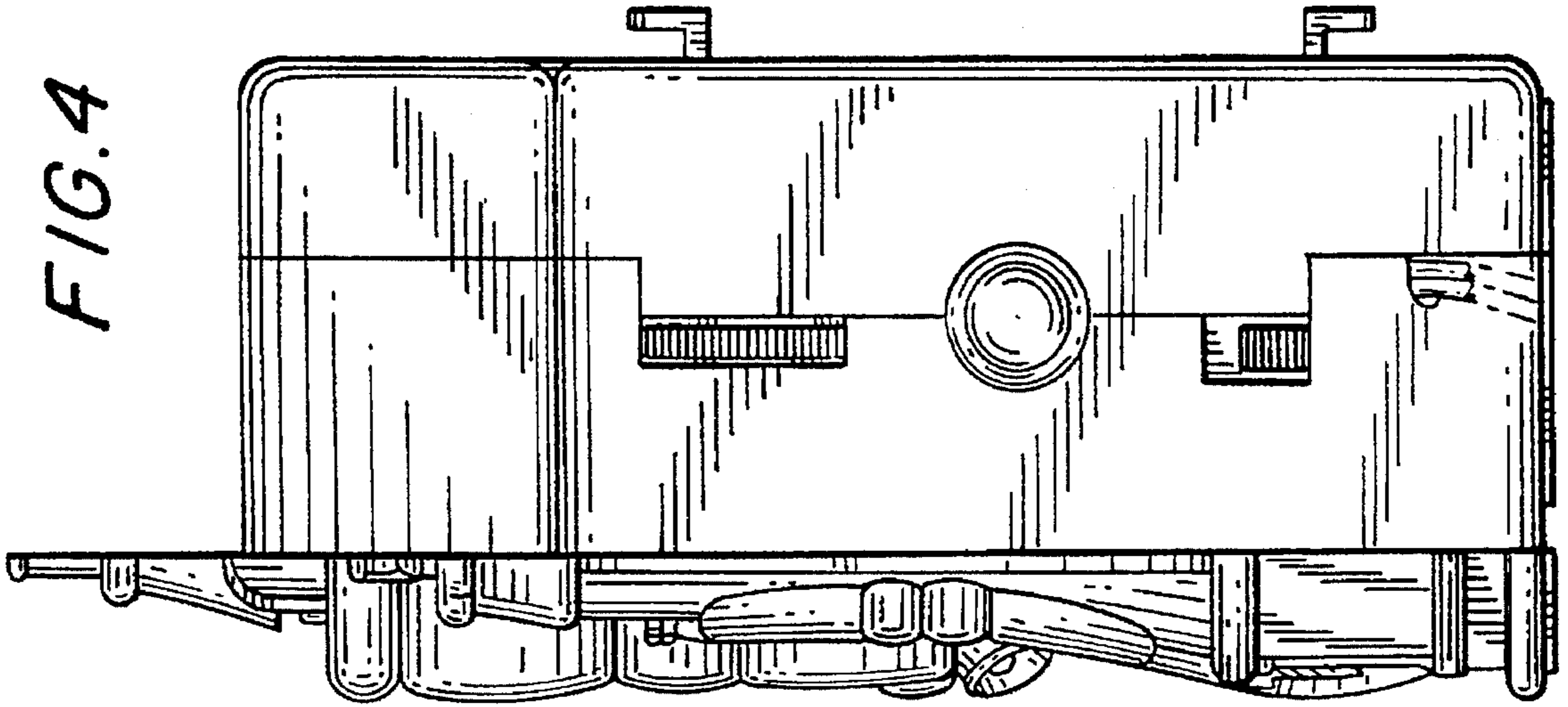
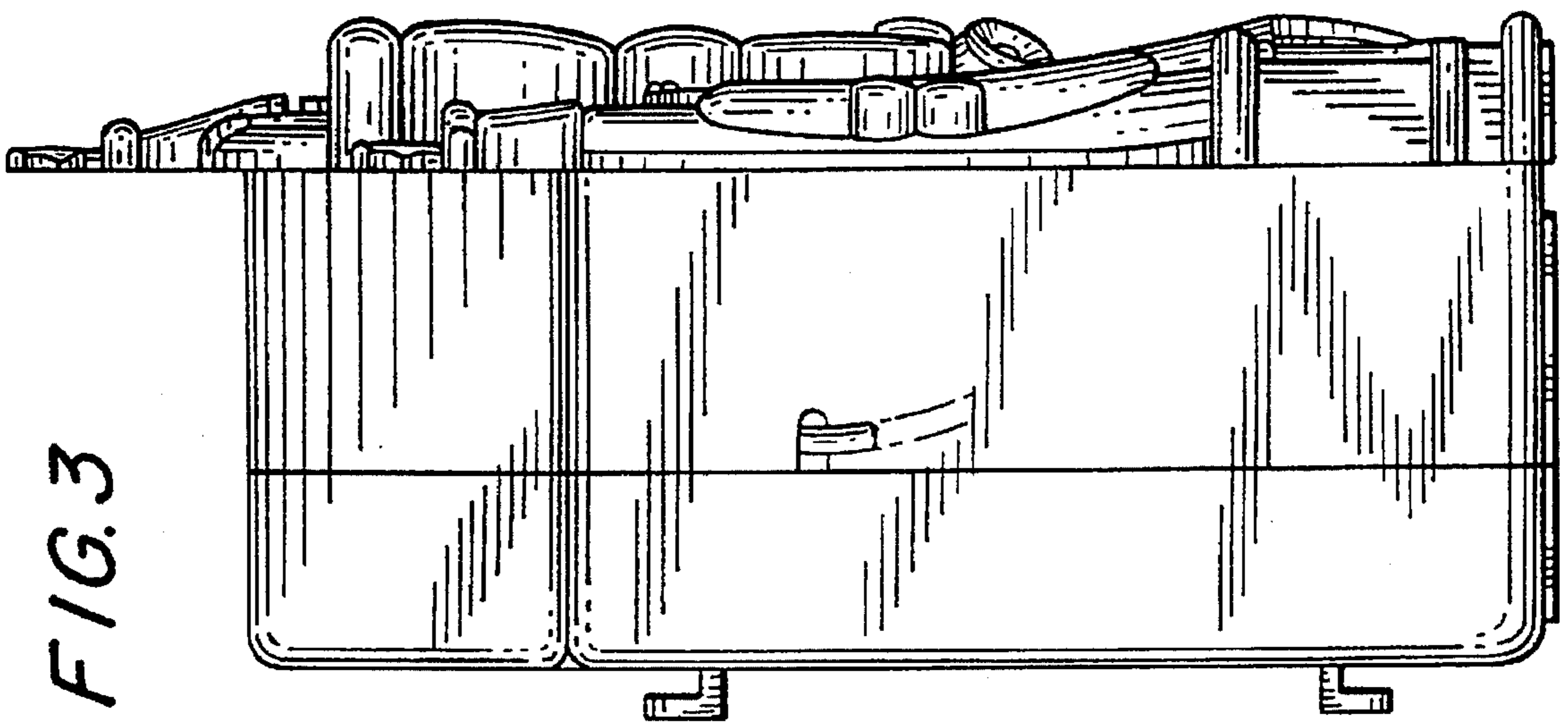

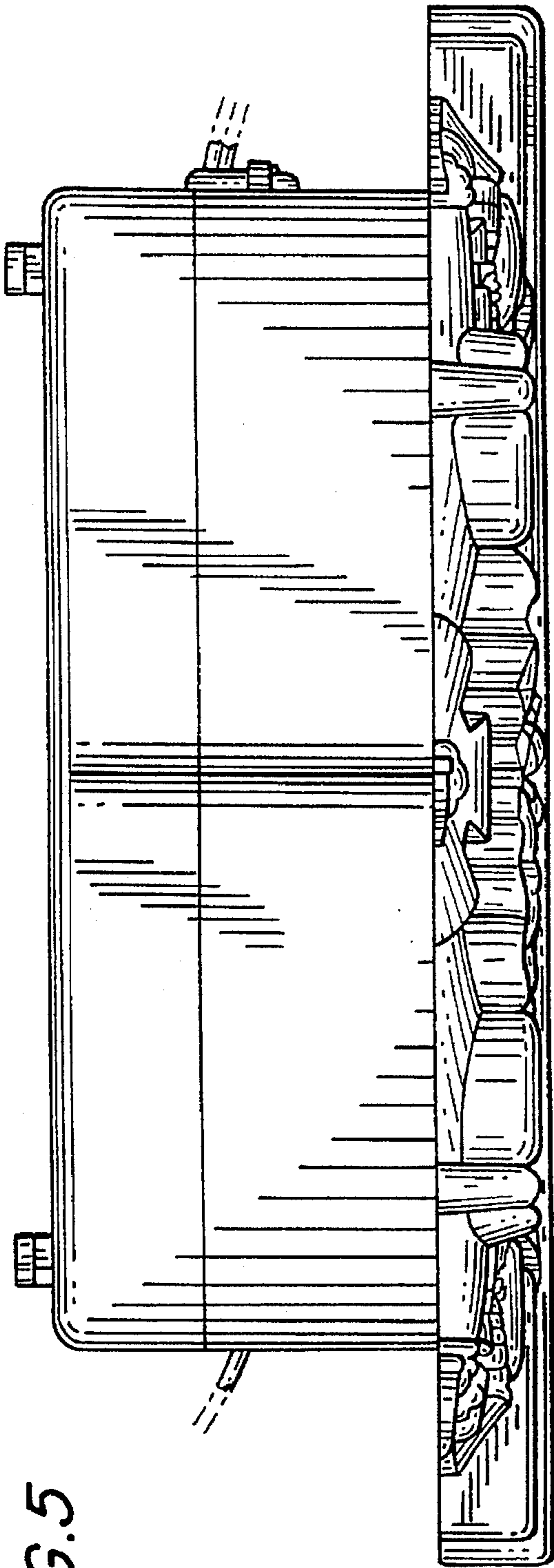

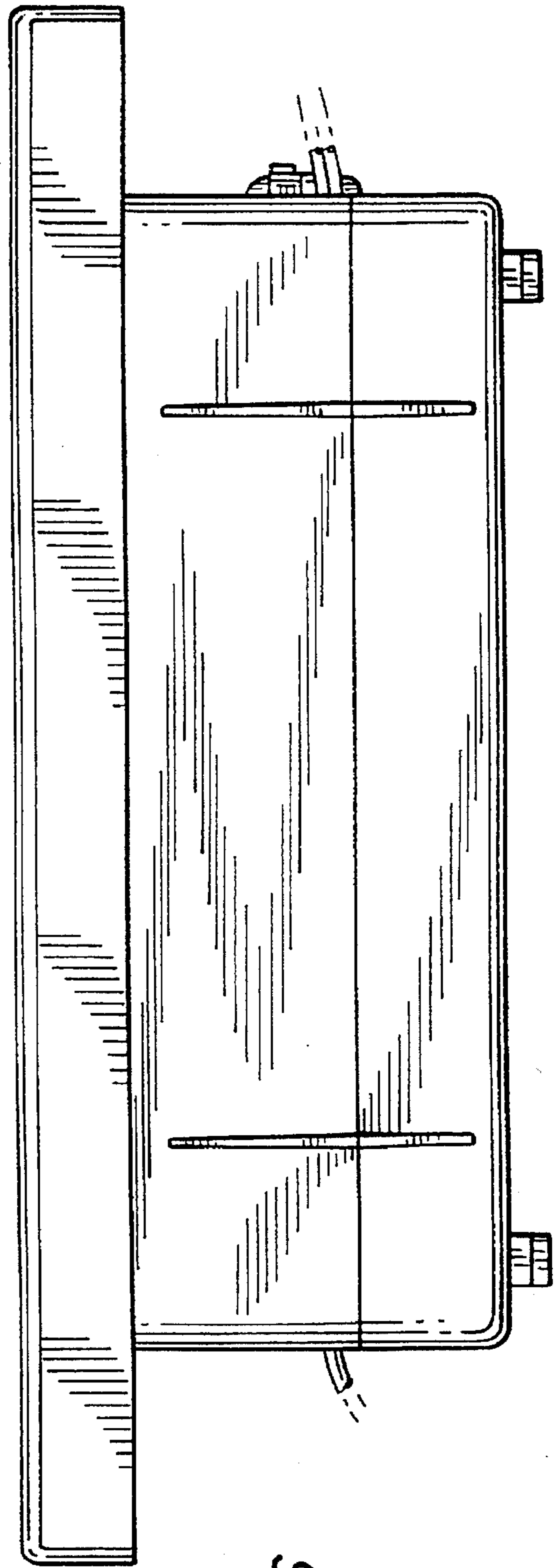

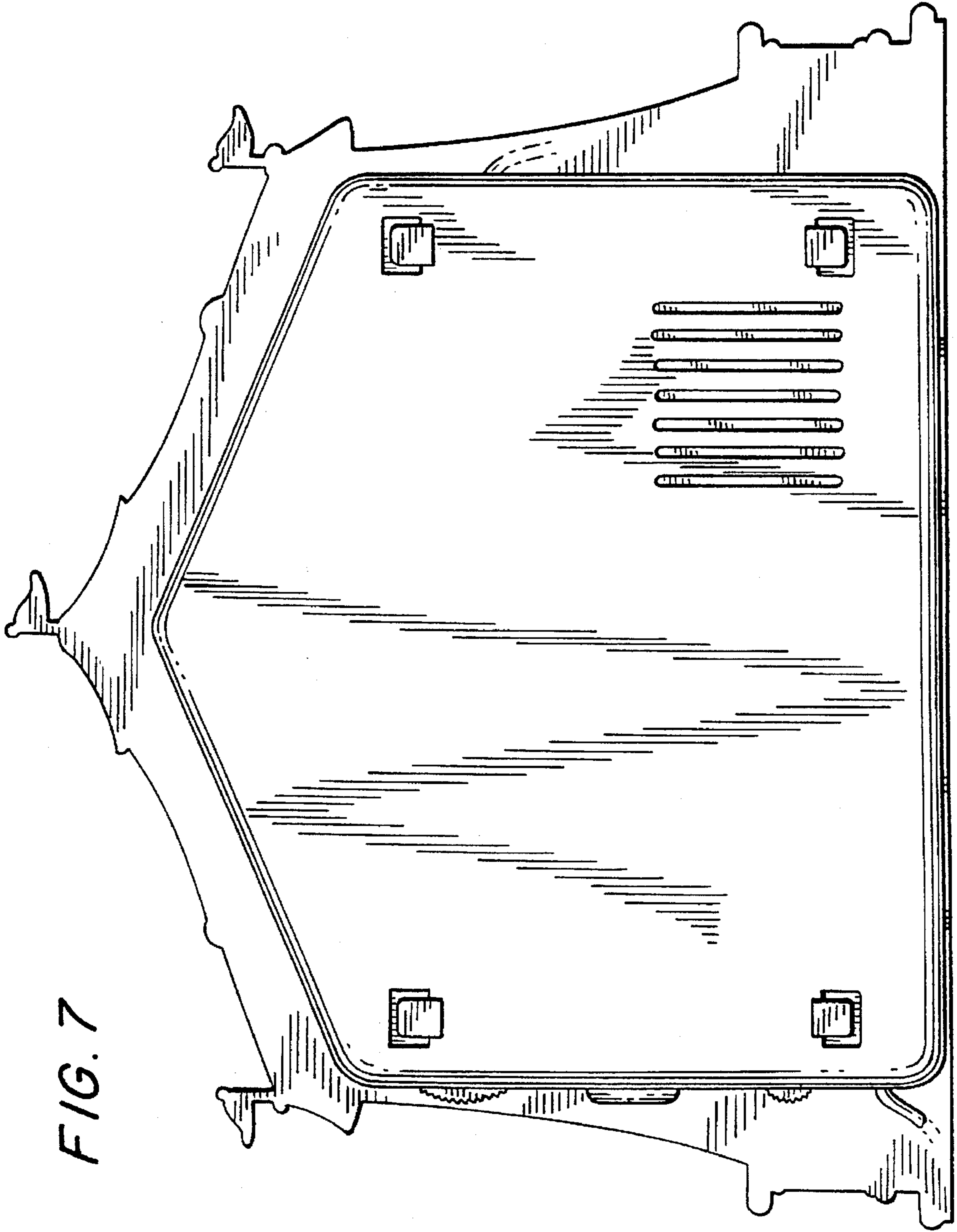

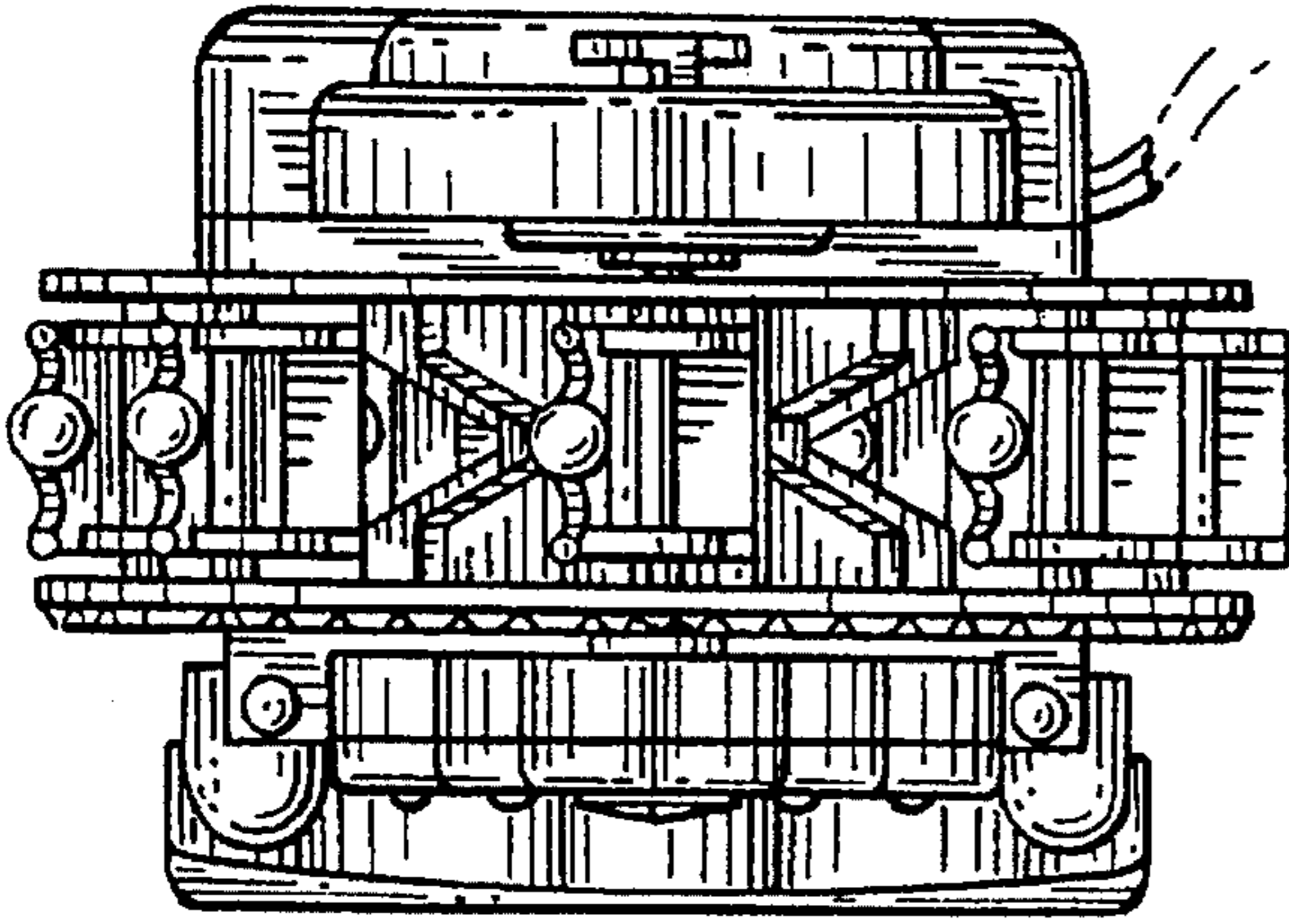

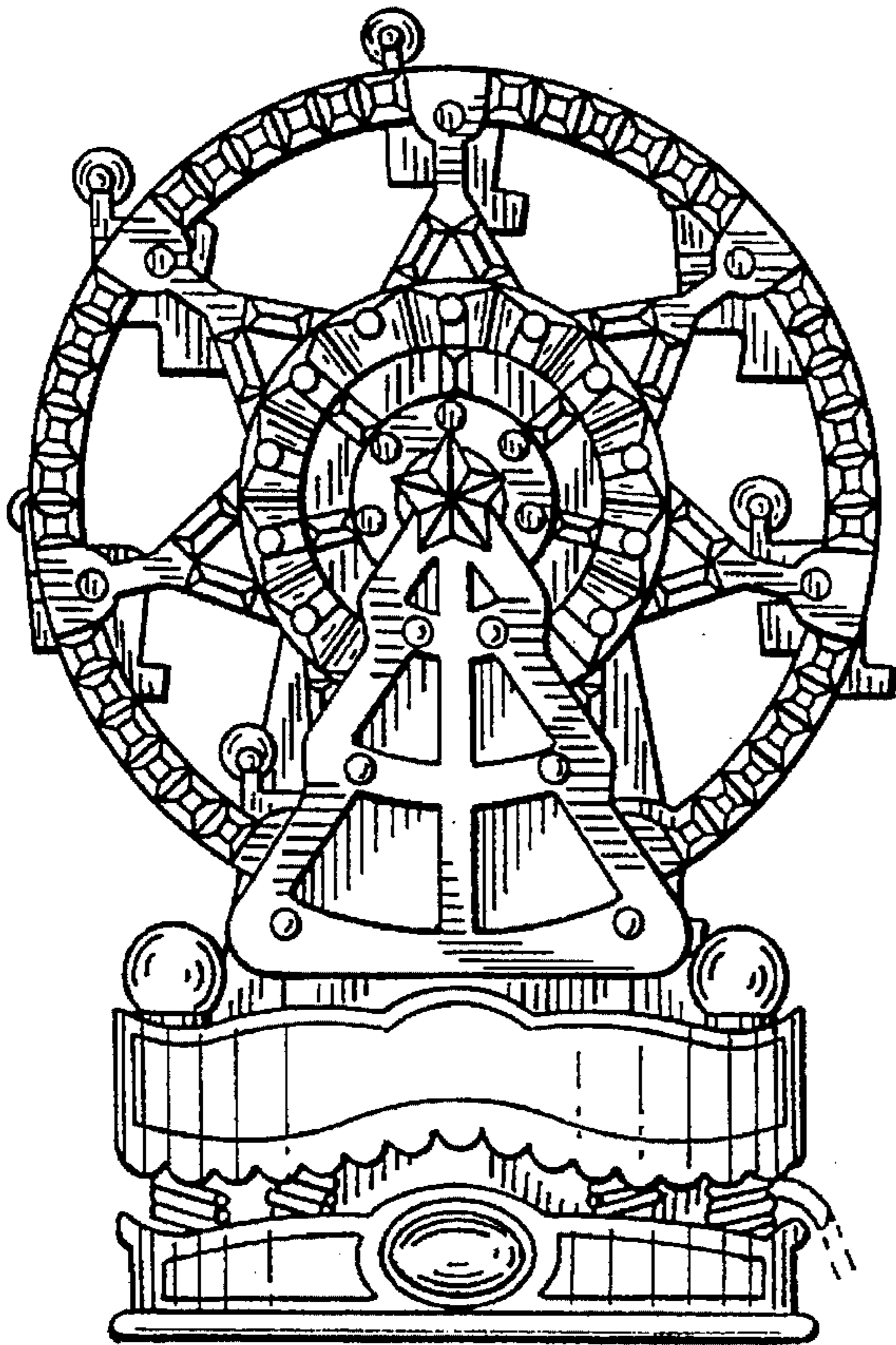

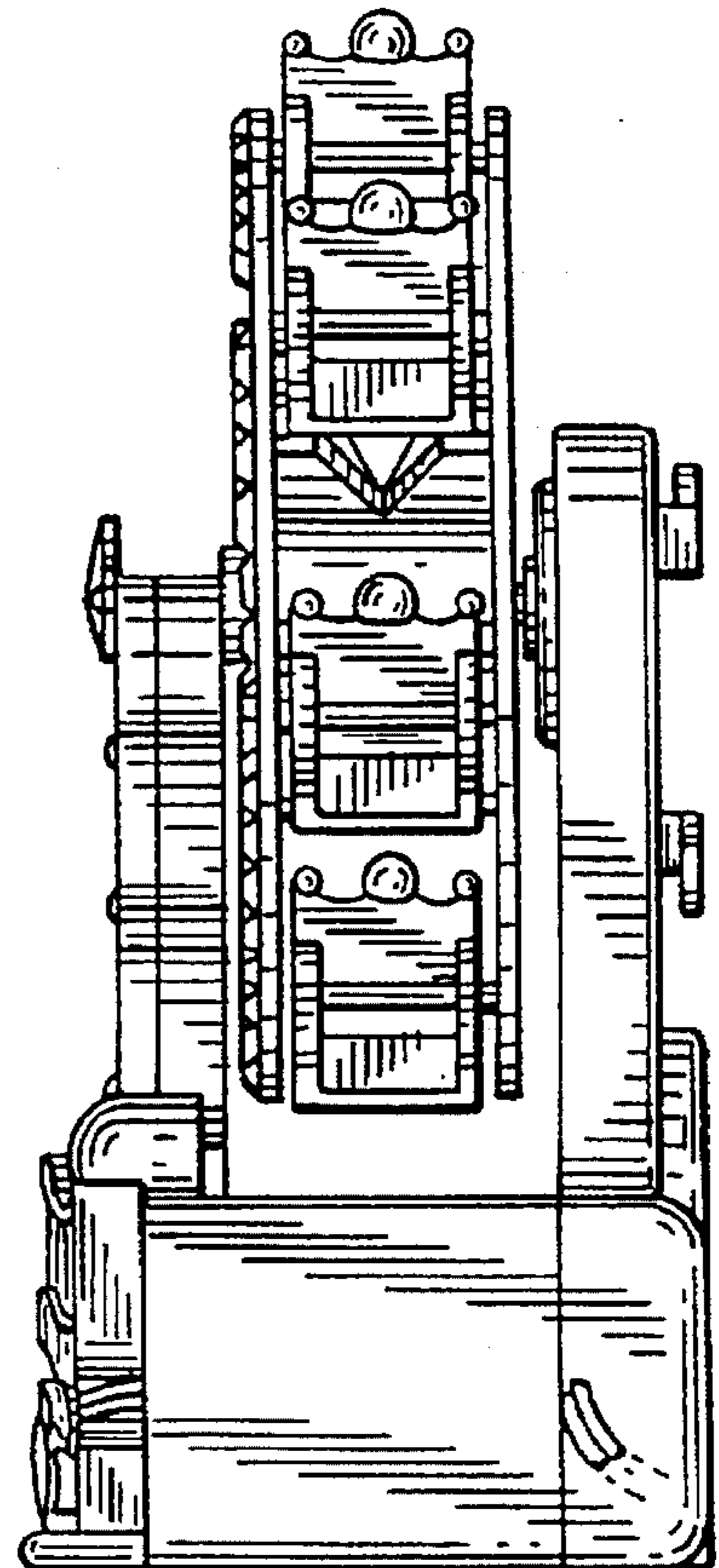

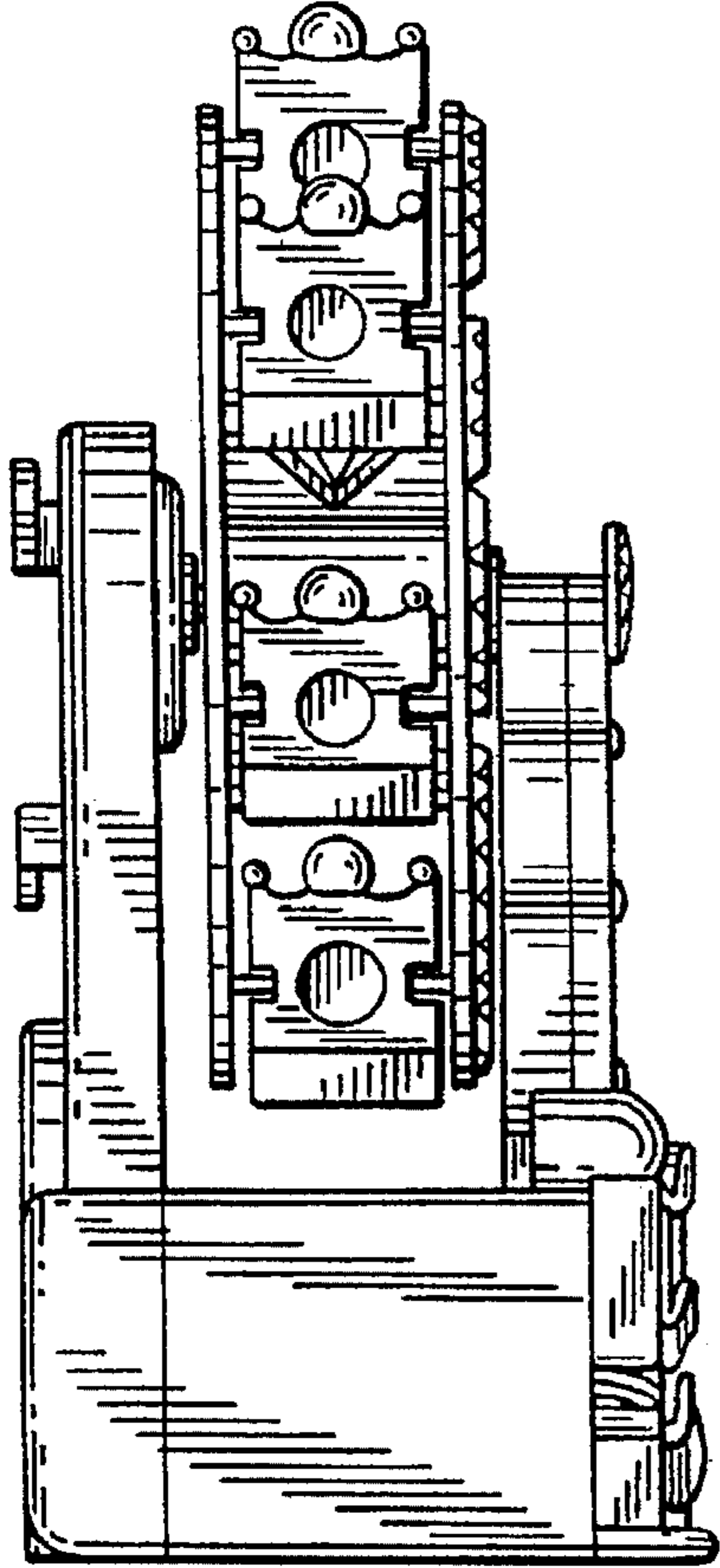

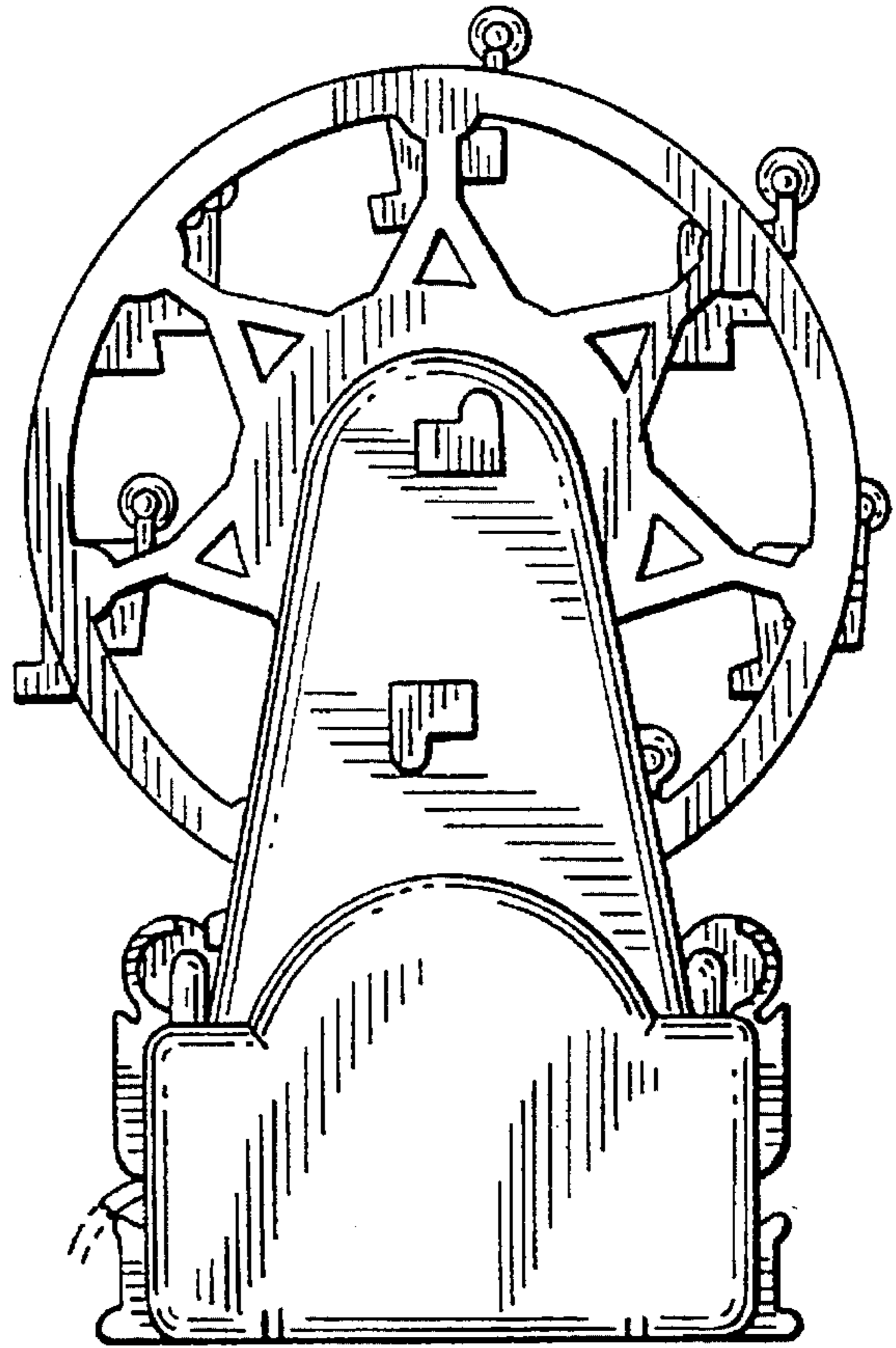
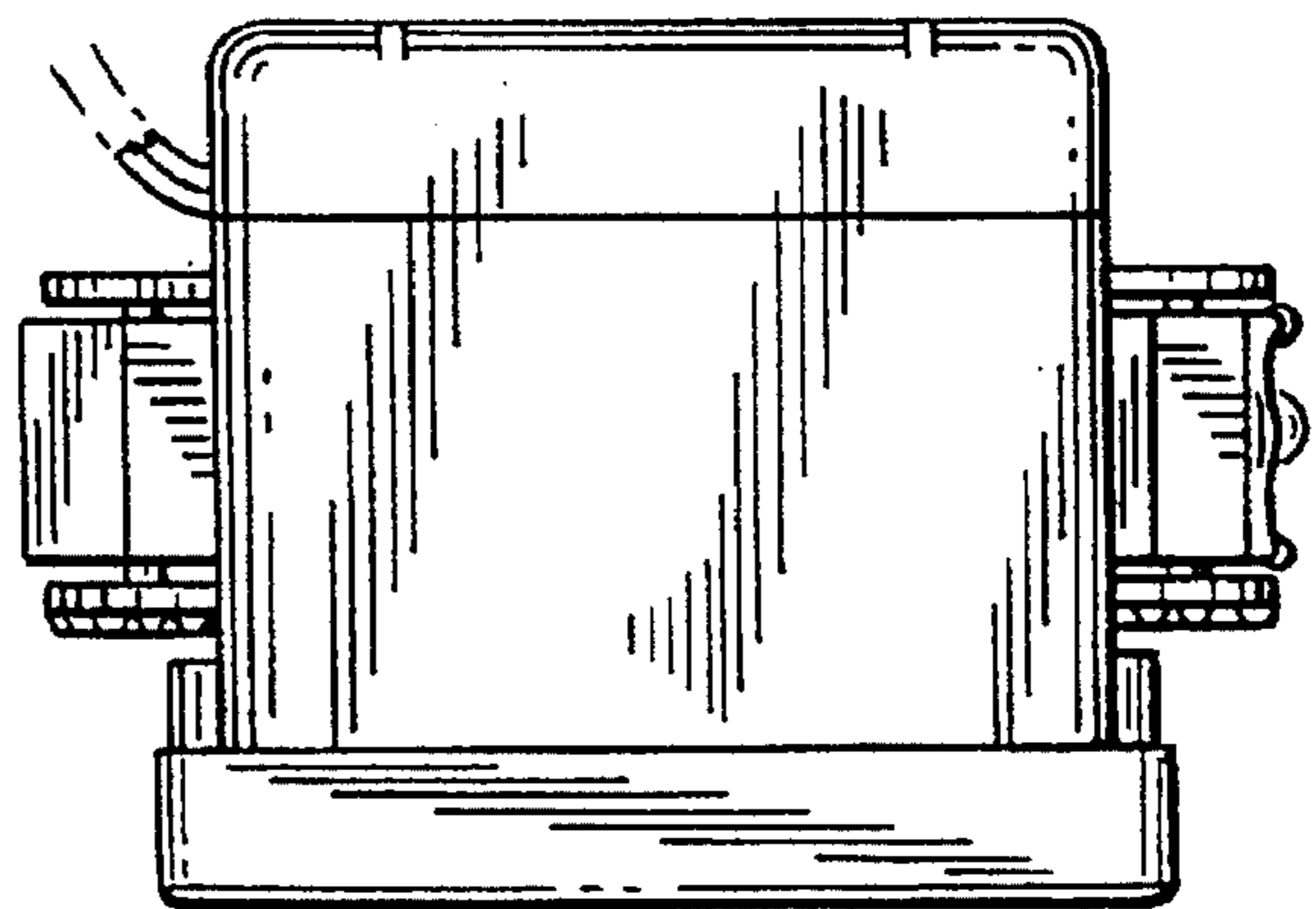

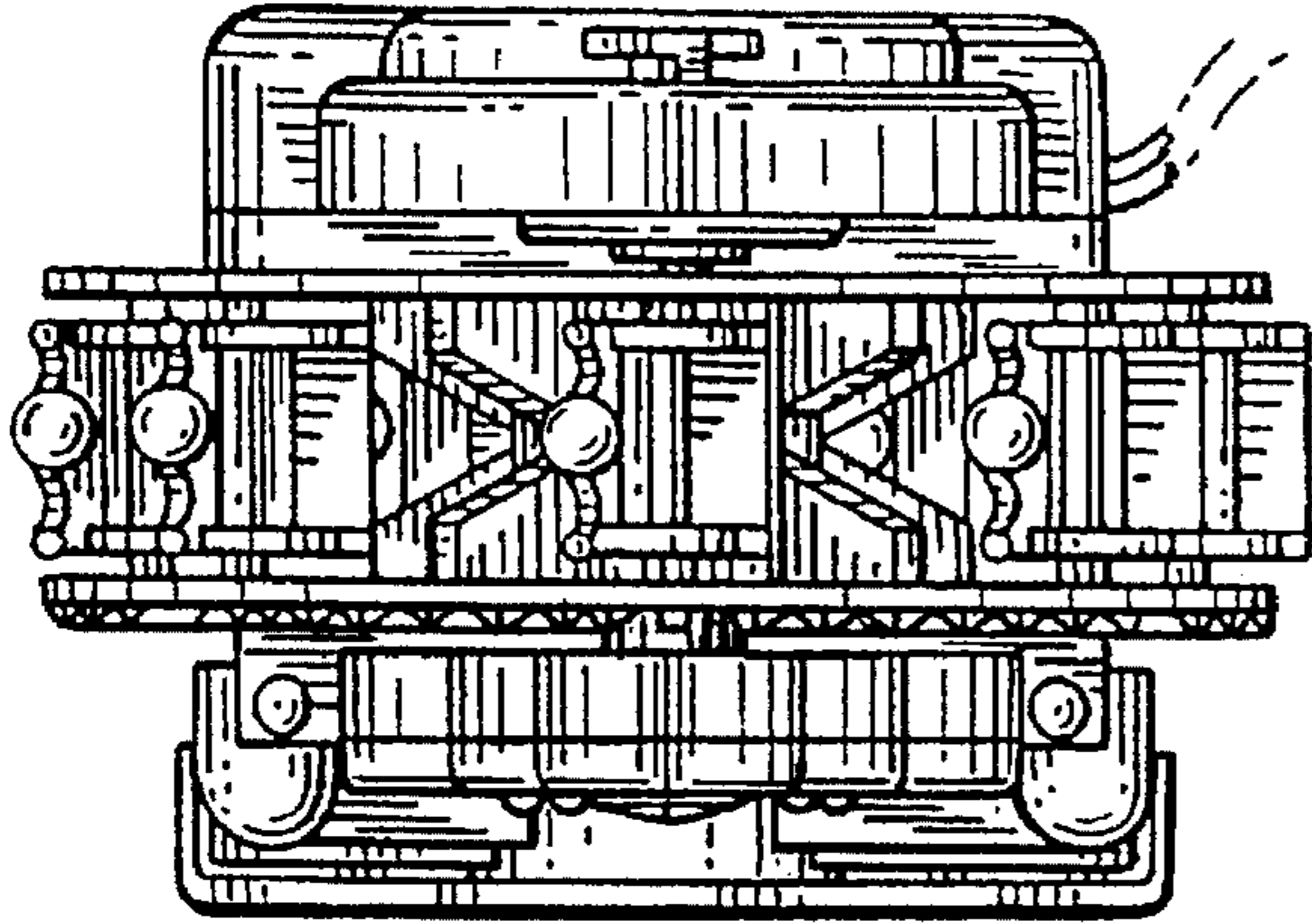

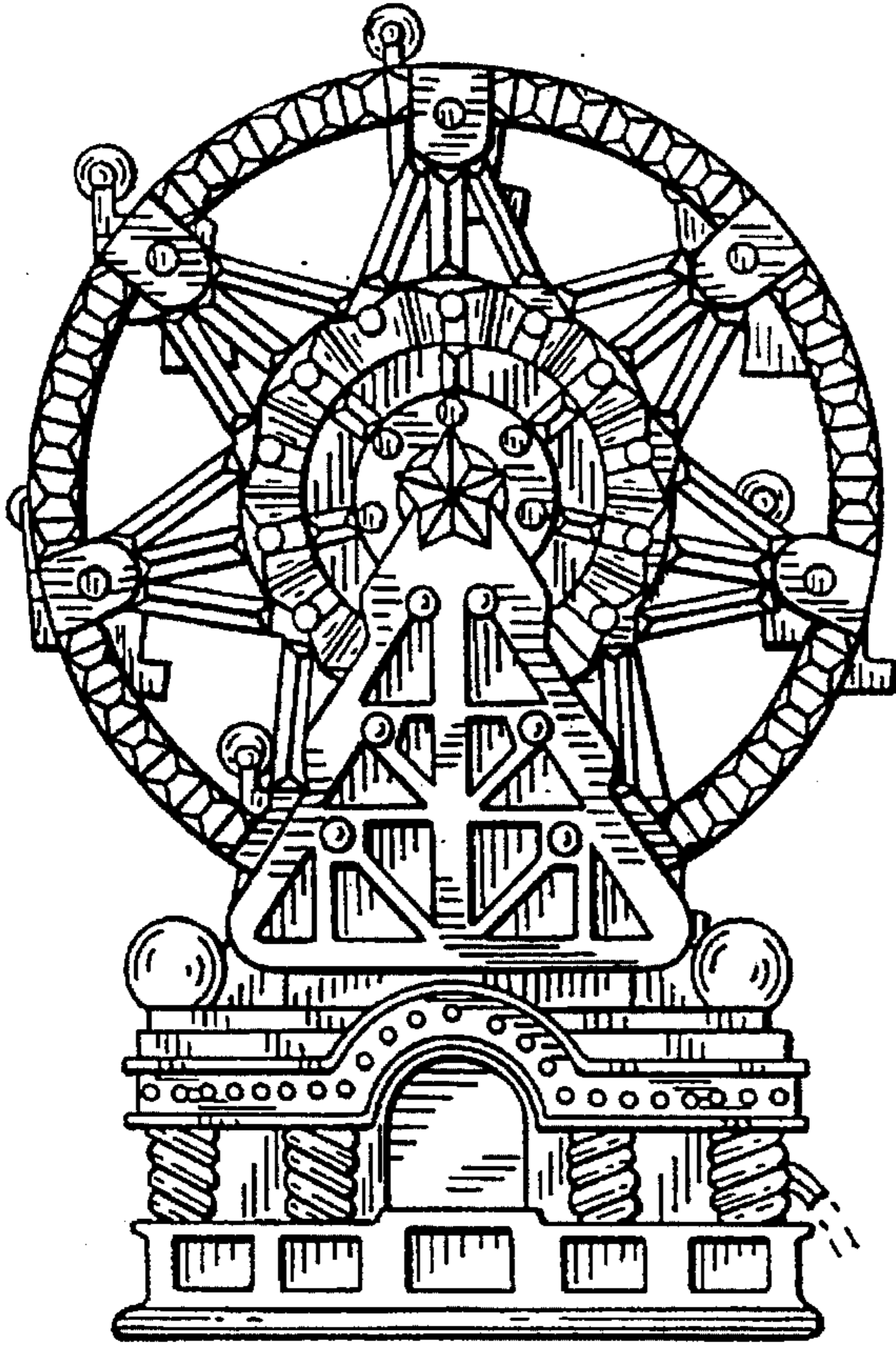

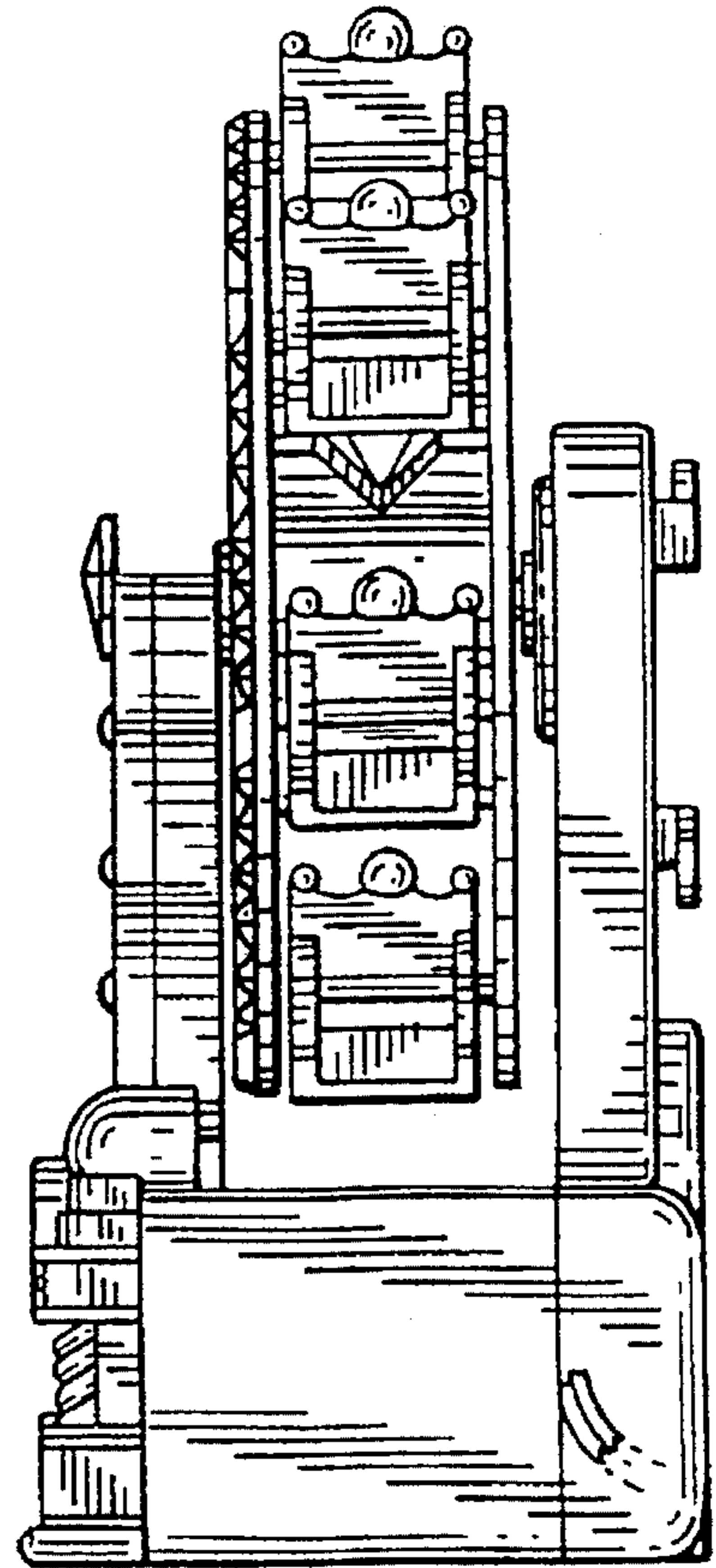

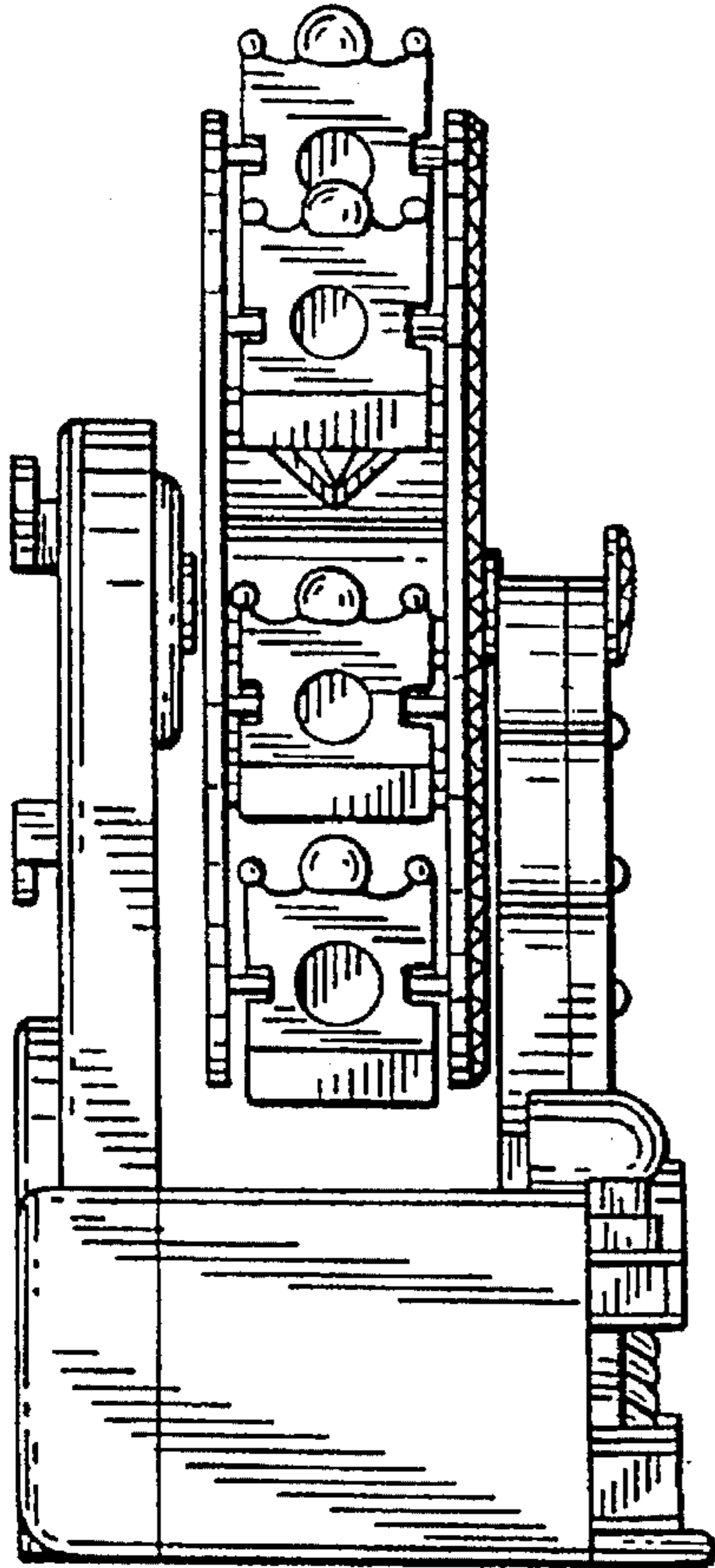

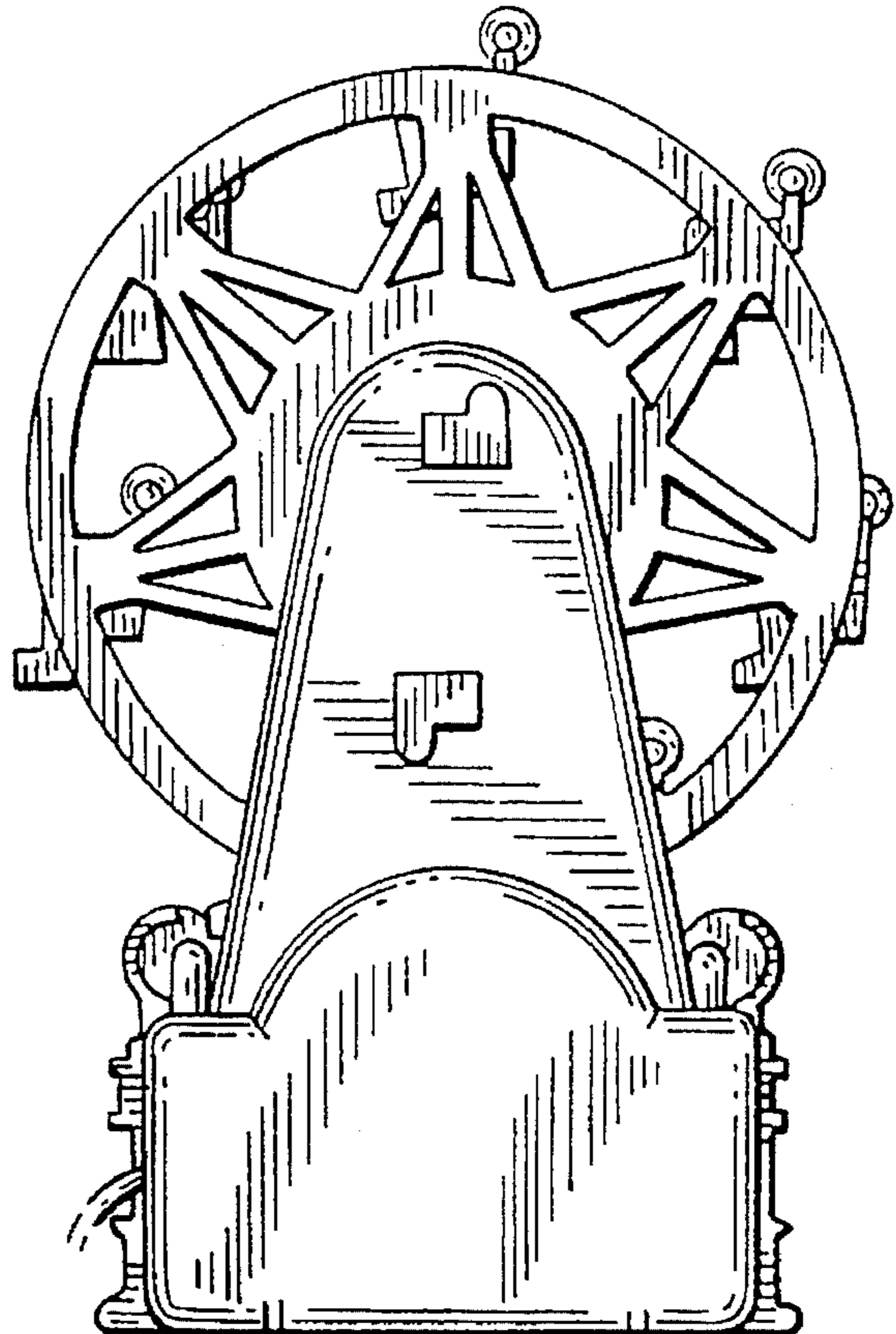
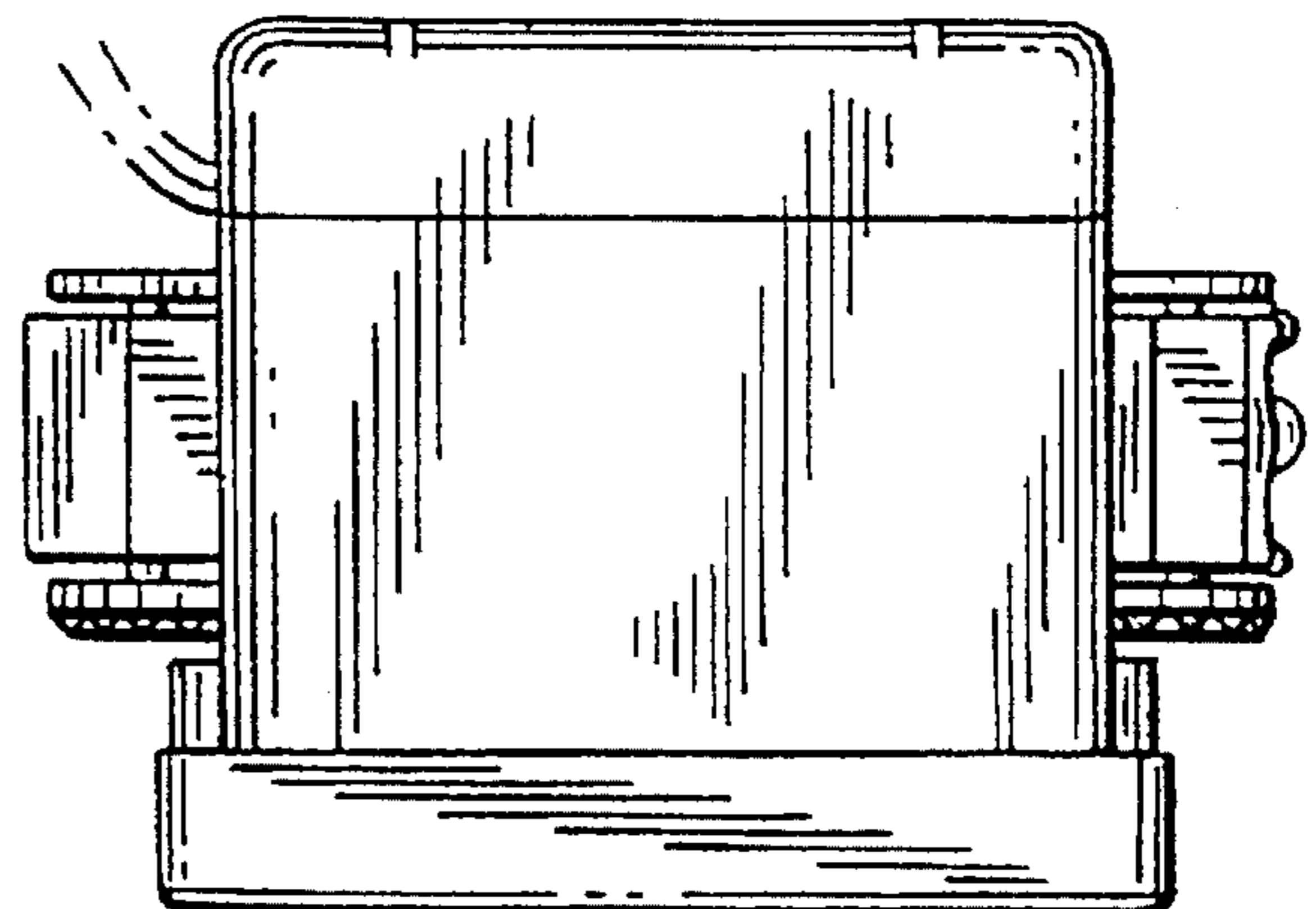

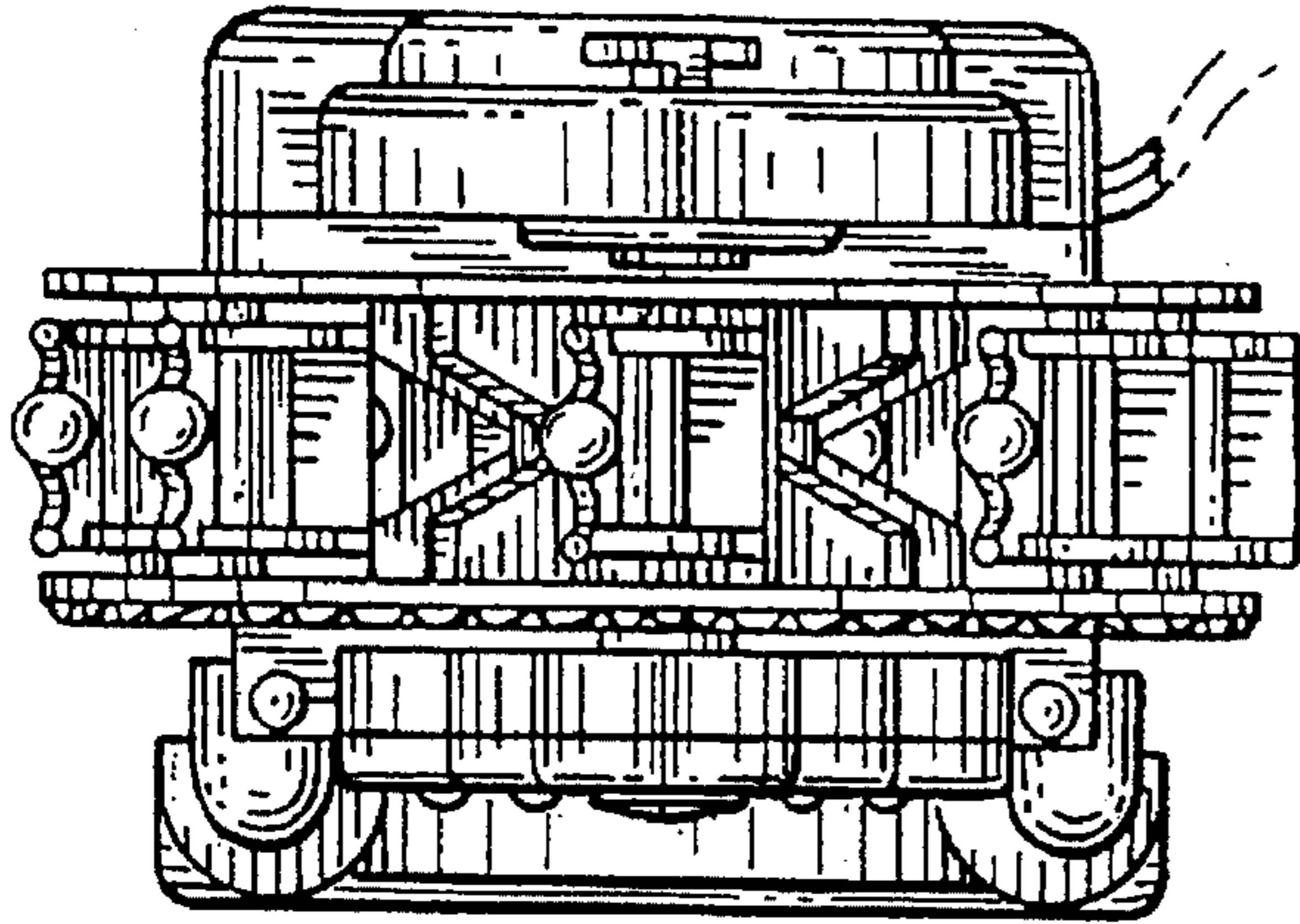

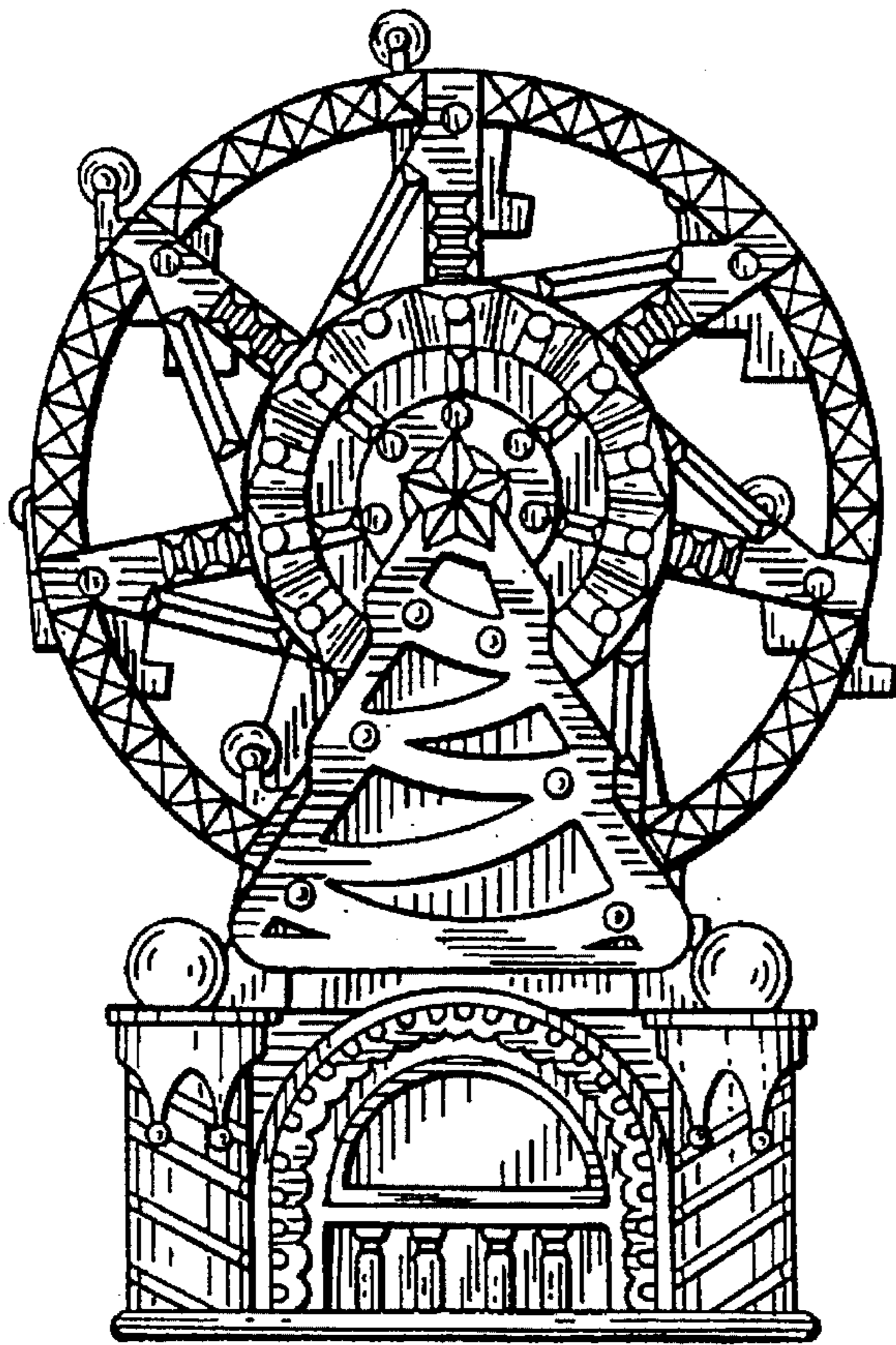

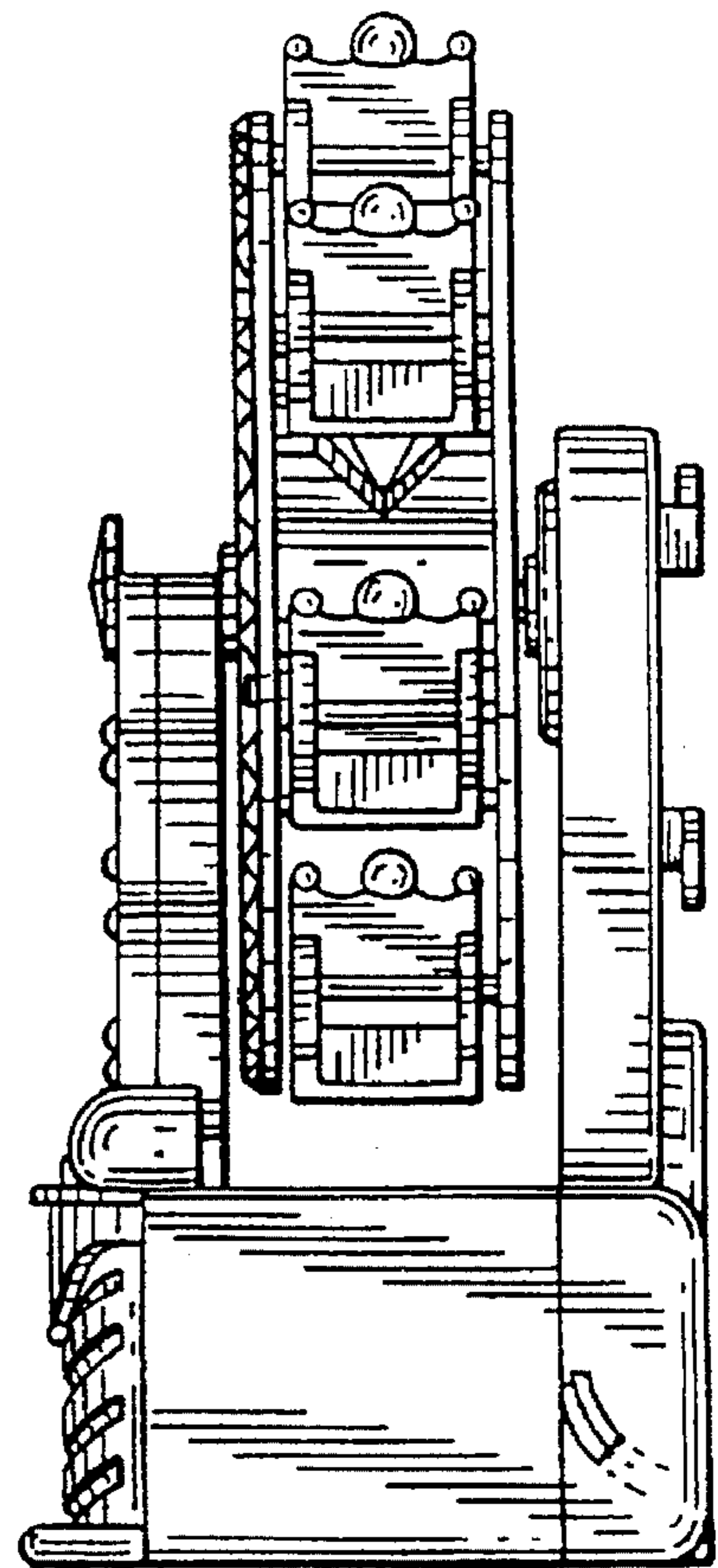

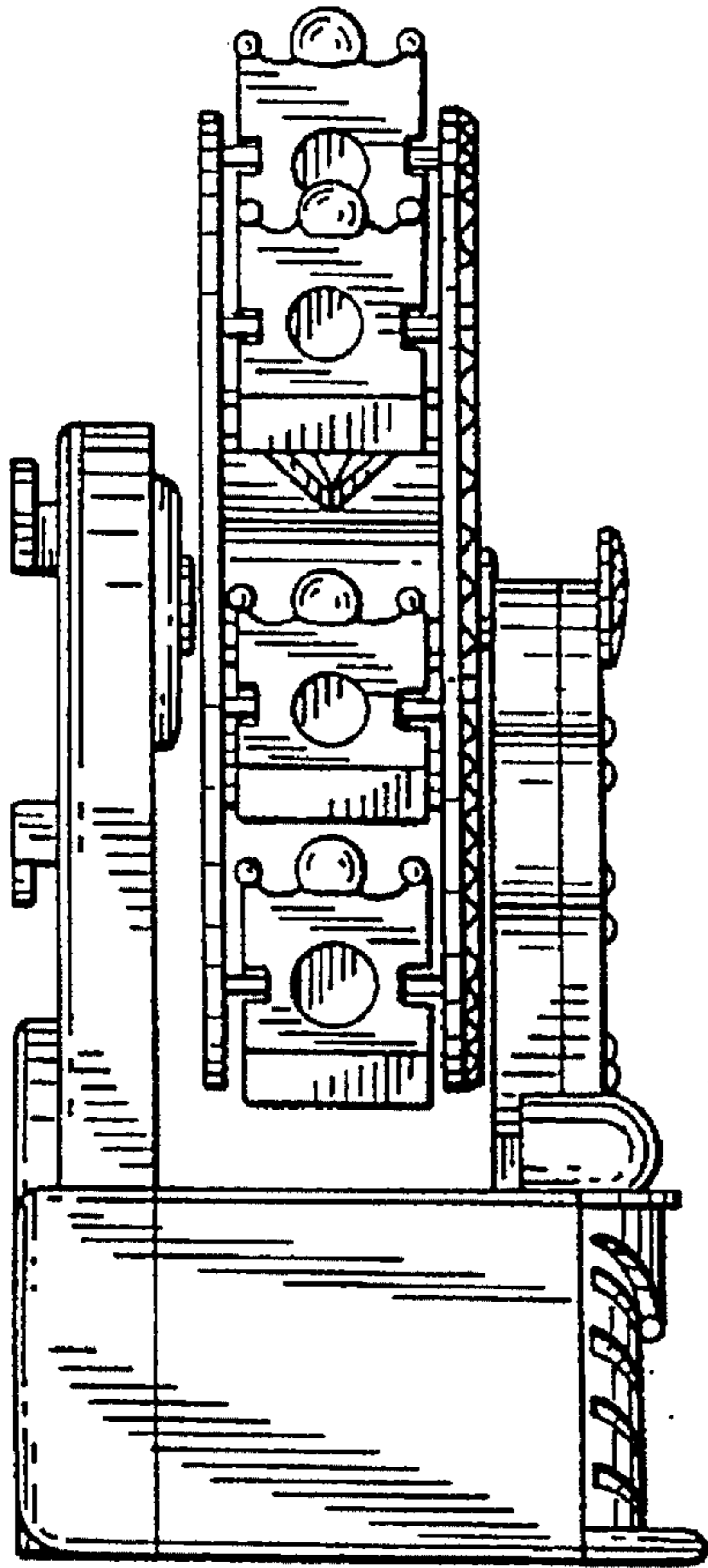

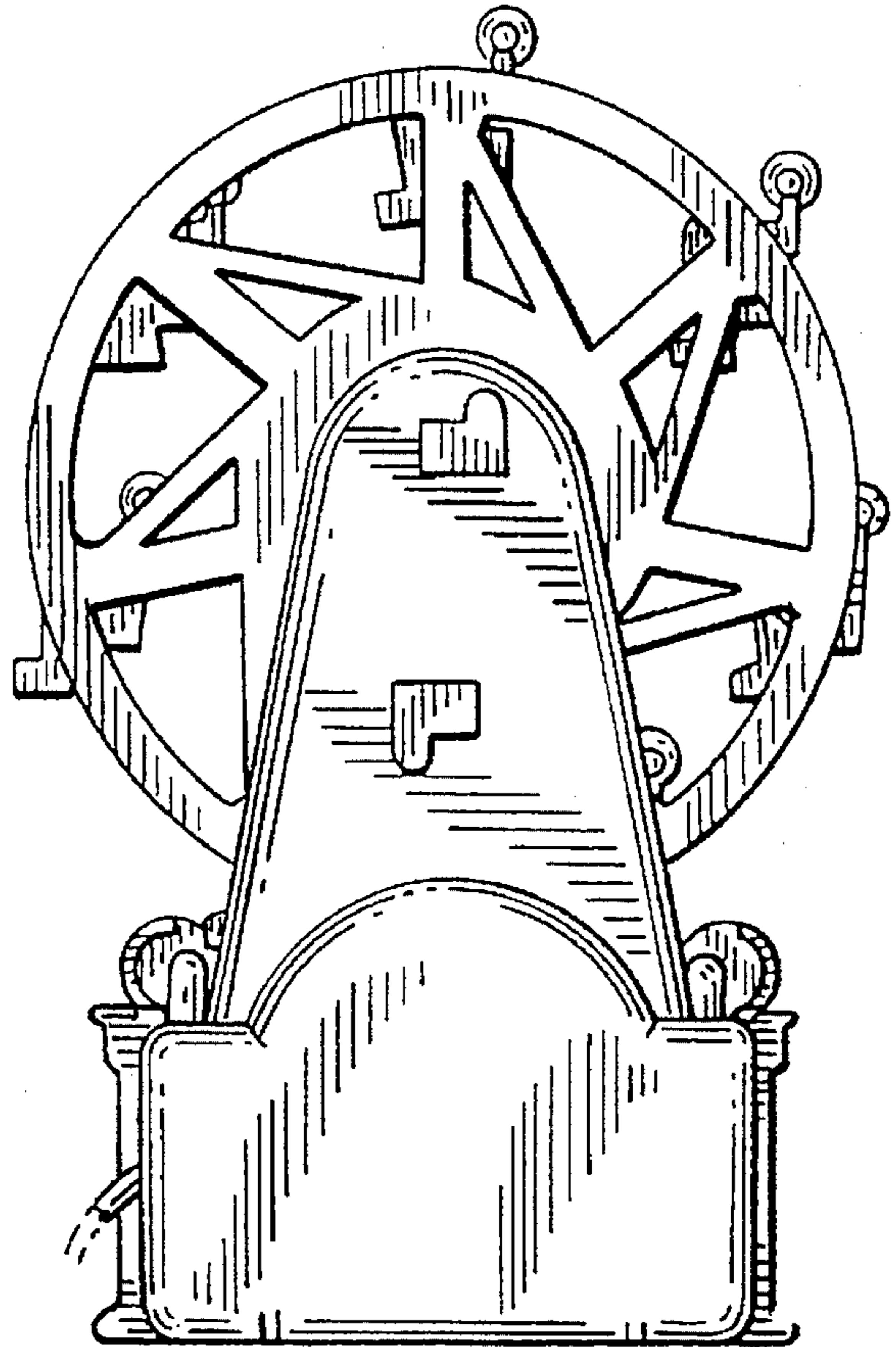
