FIG. 6 is a left side elevational view of a shoe upper showing an alternate embodiment of our new design;

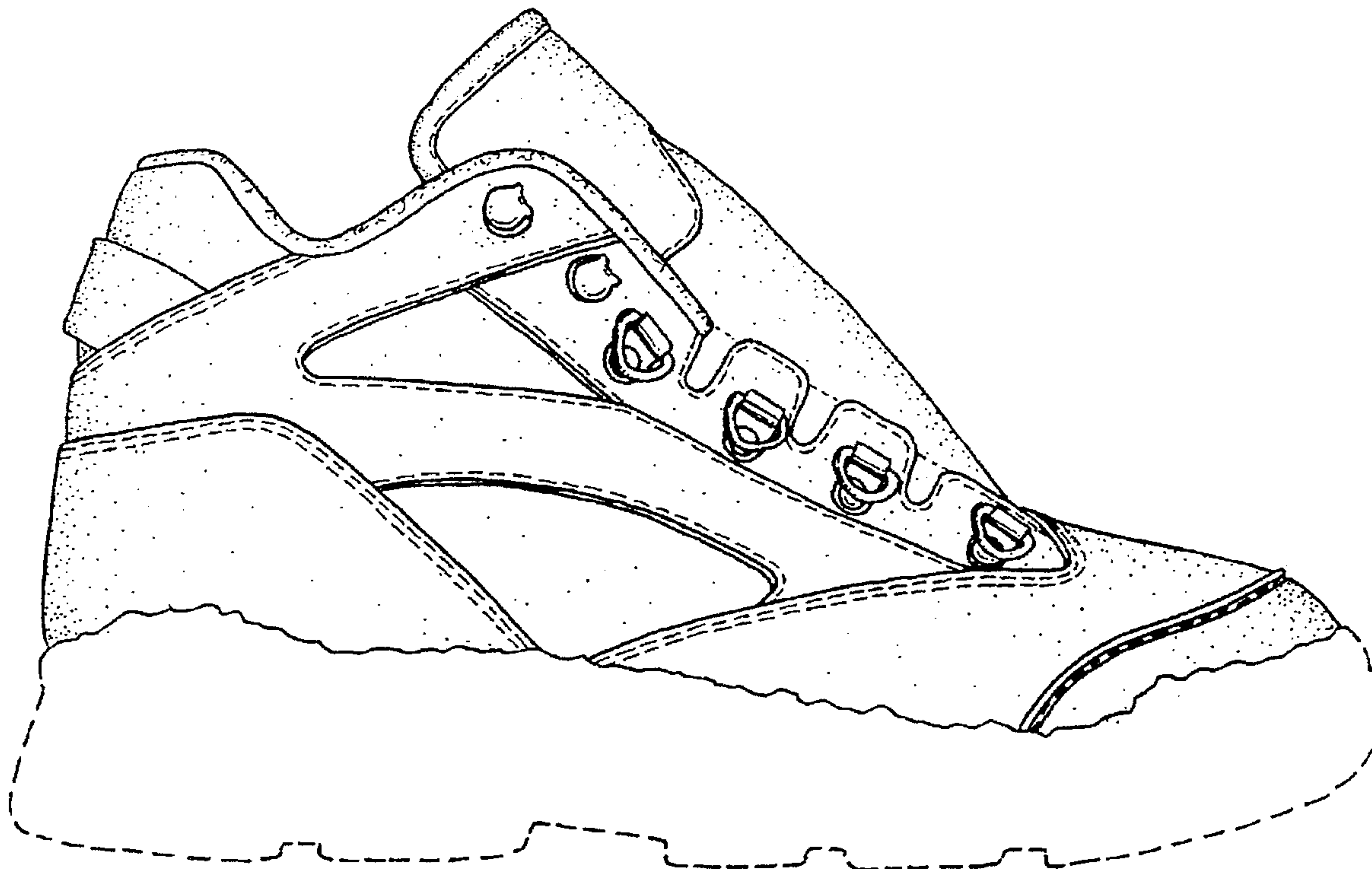
FIG. 7 is a right side elevational view thereof;

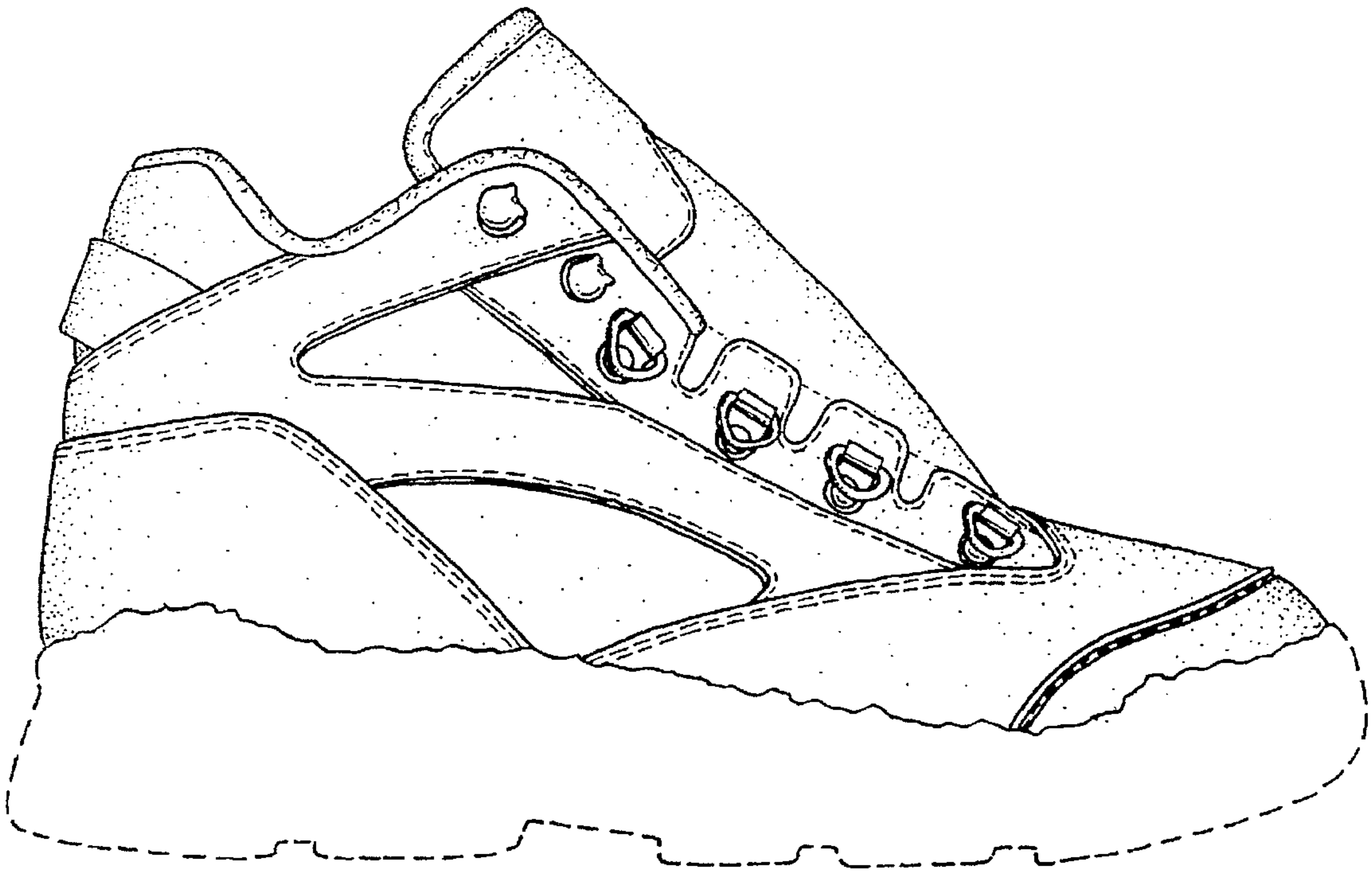

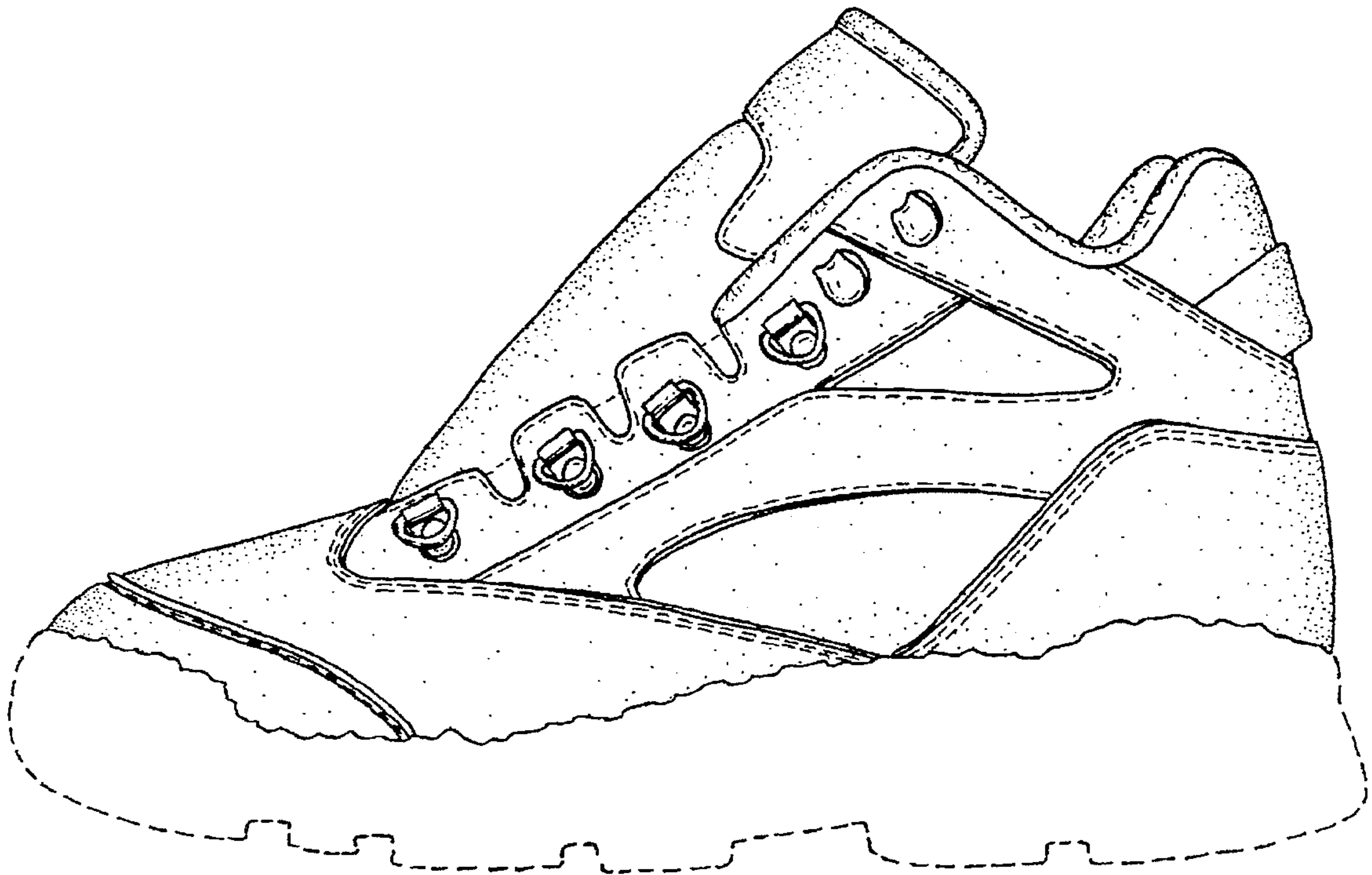

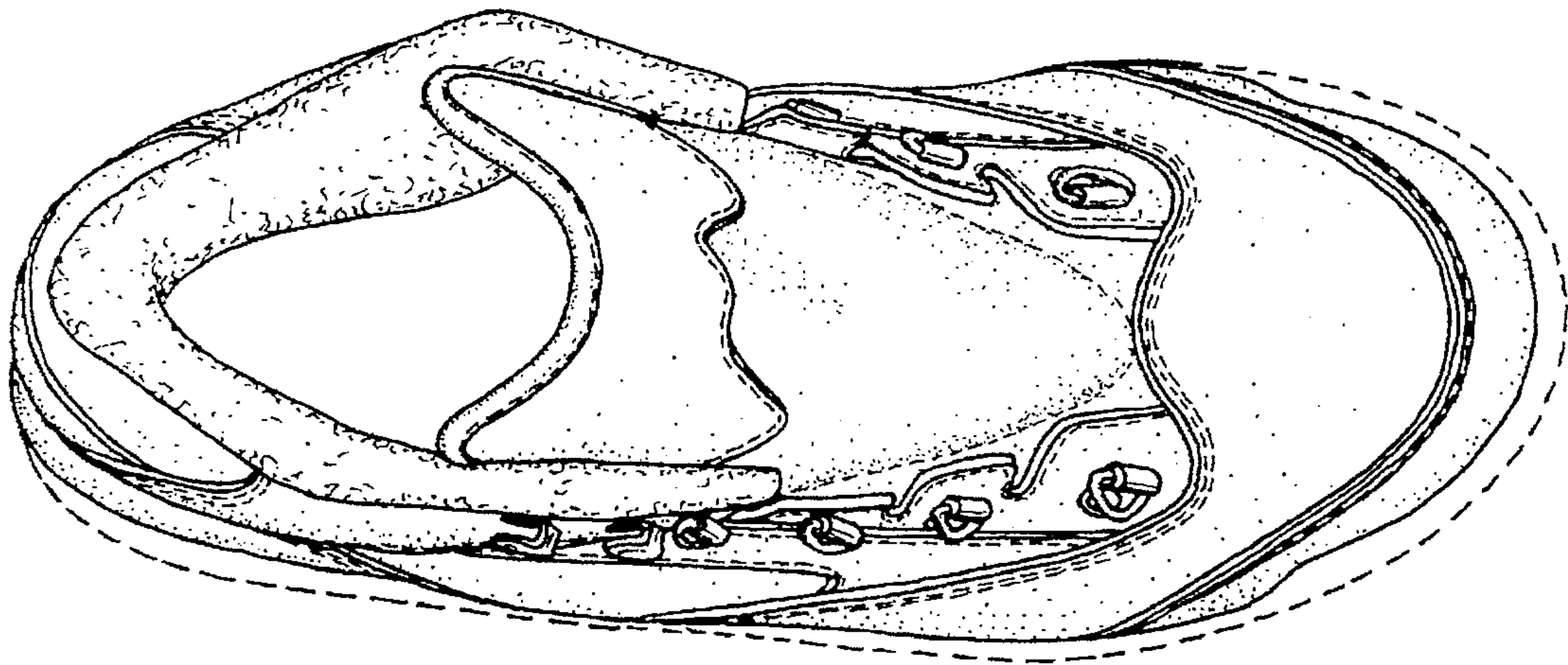

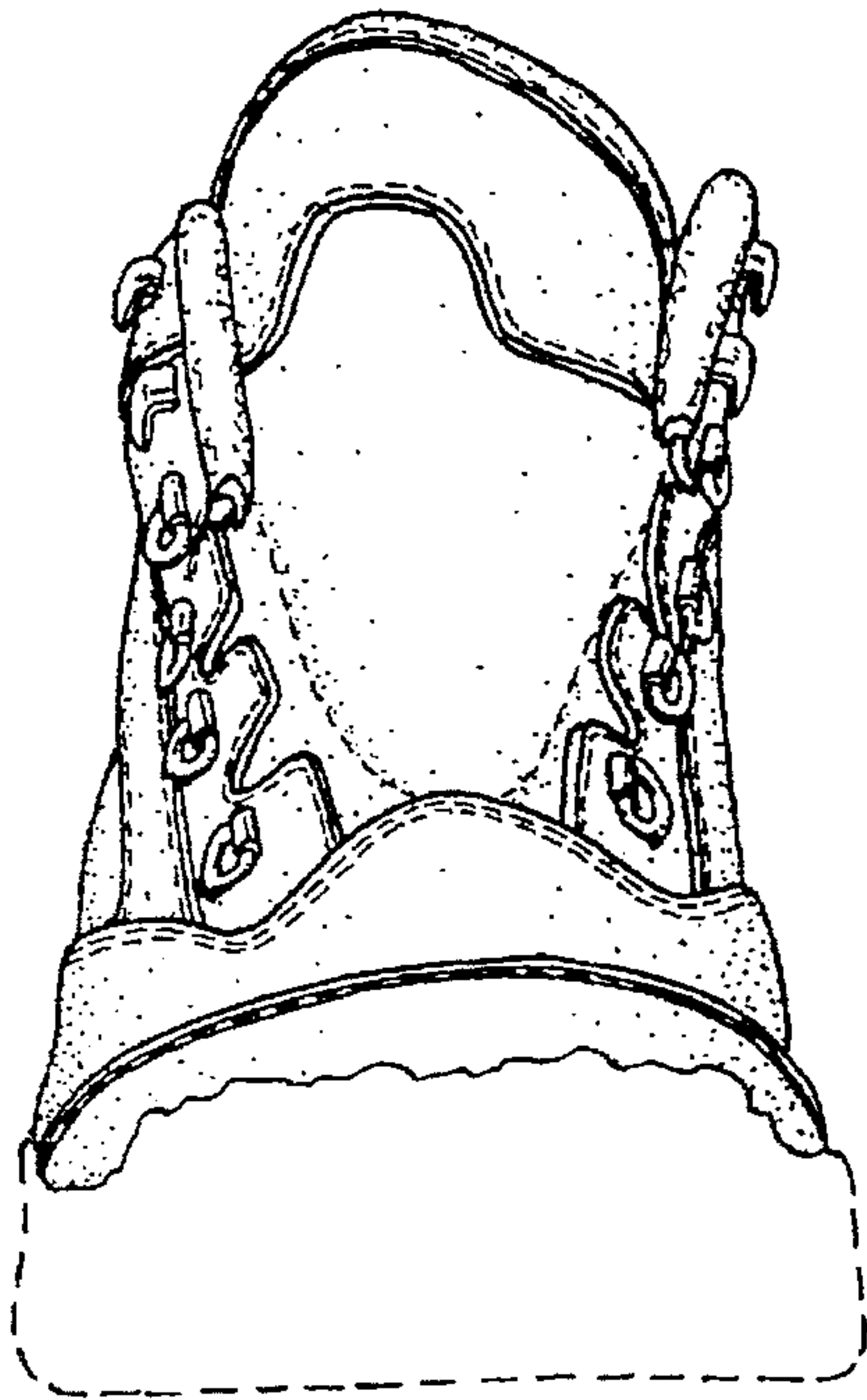

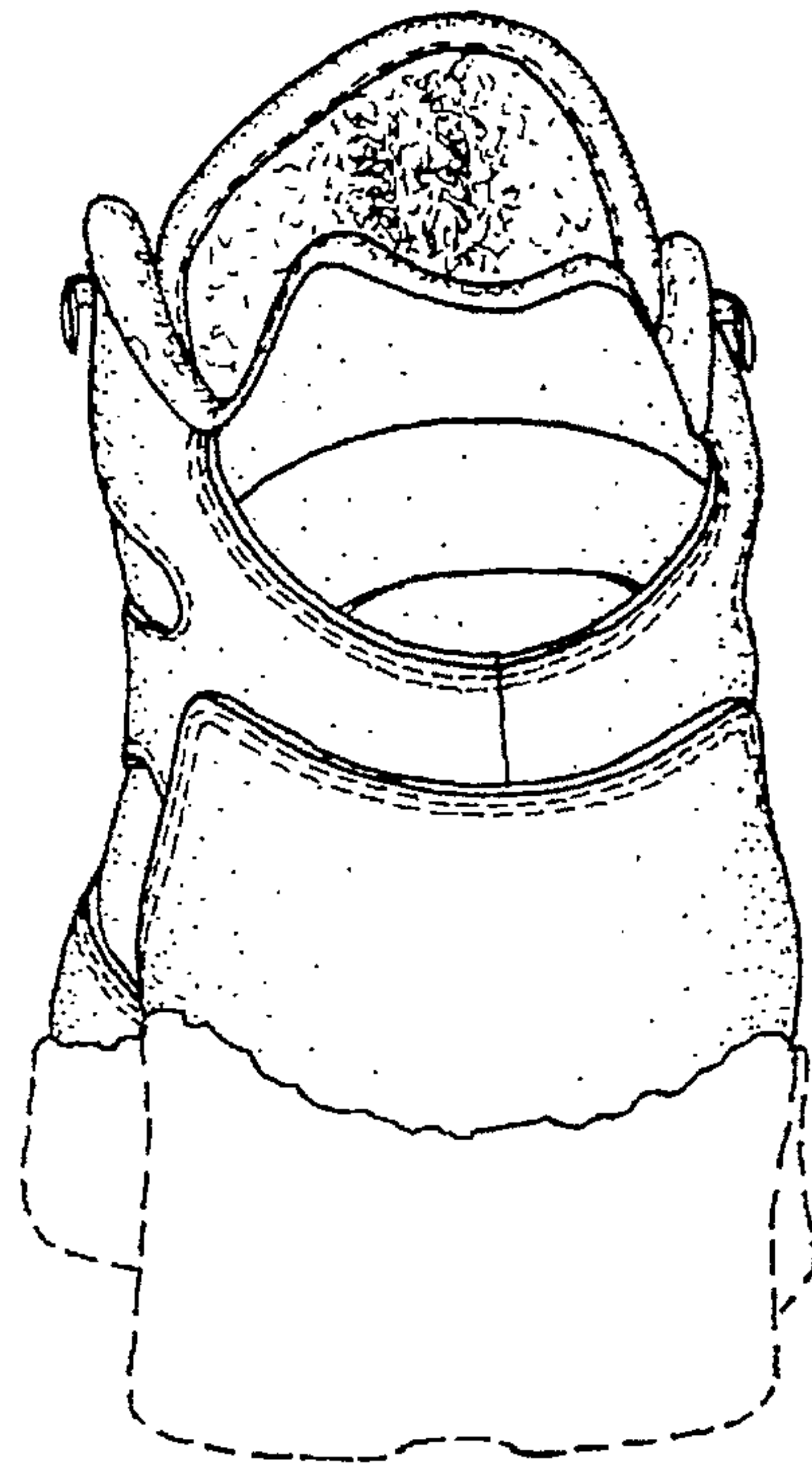

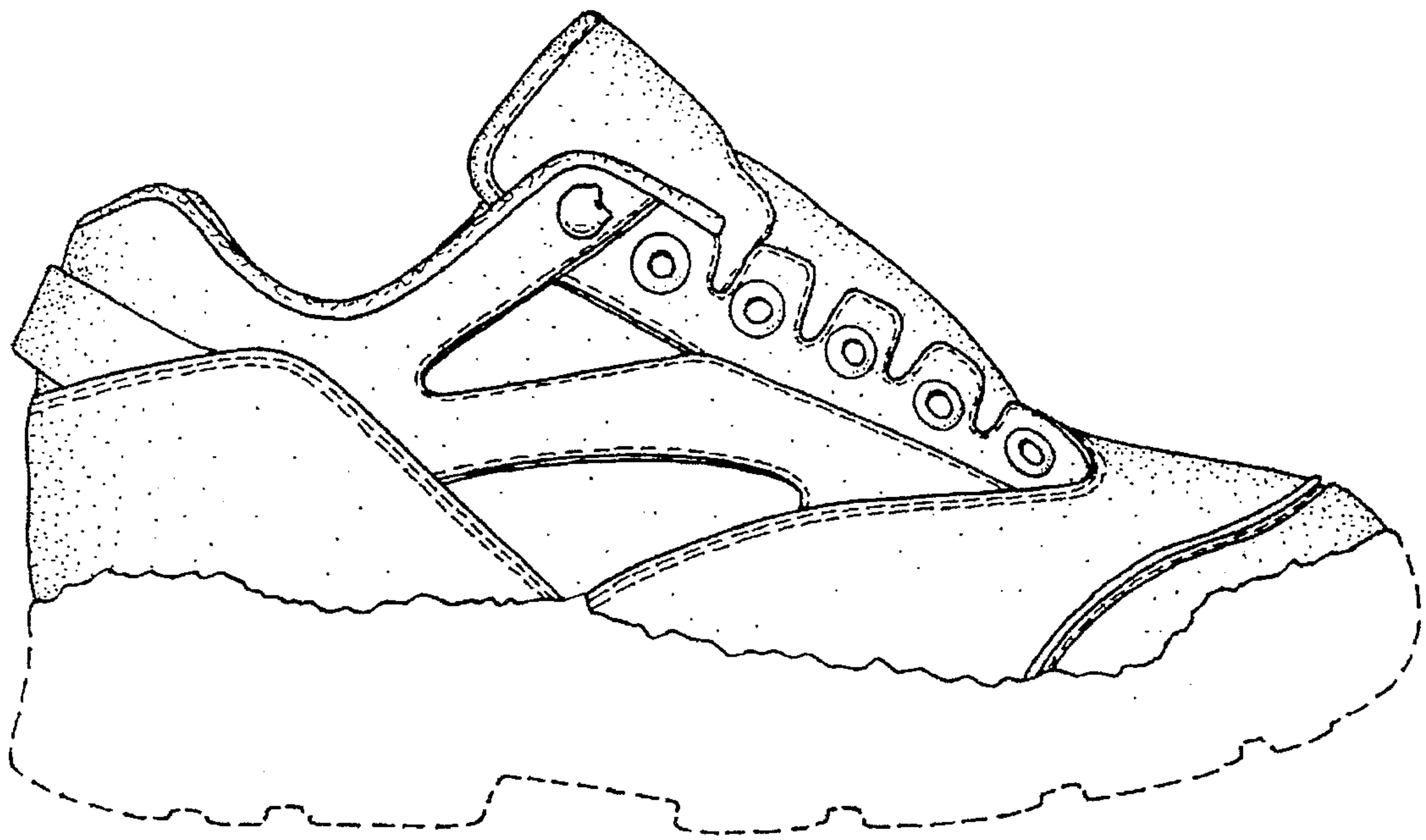

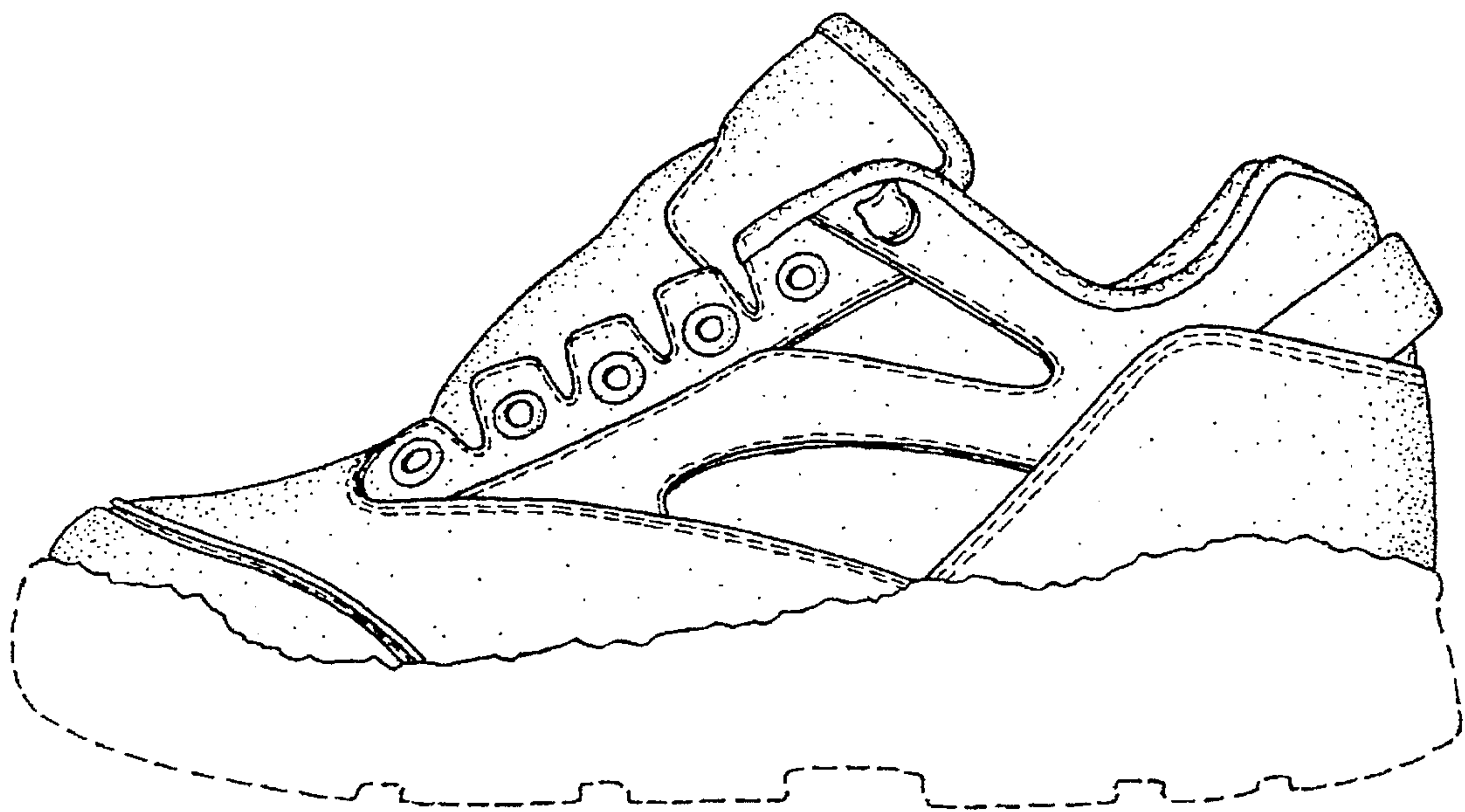

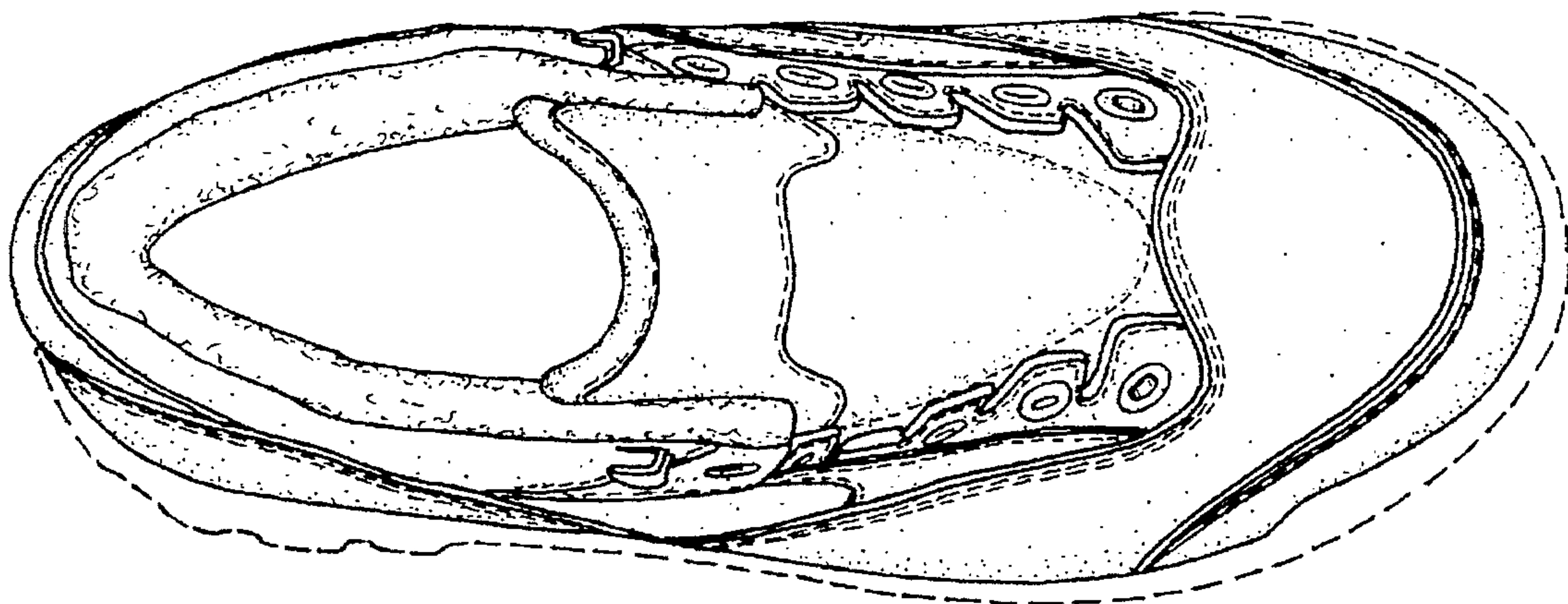

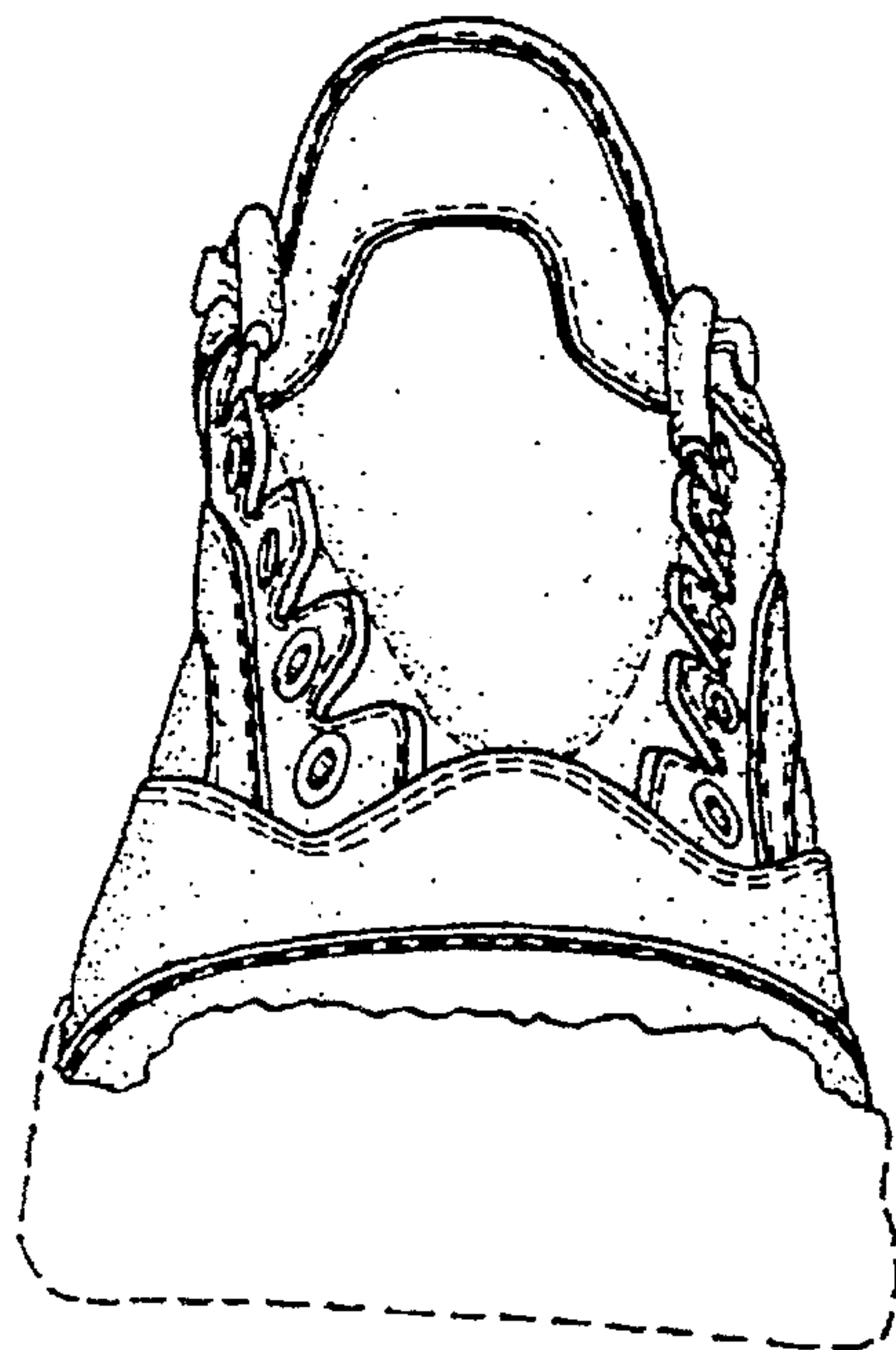

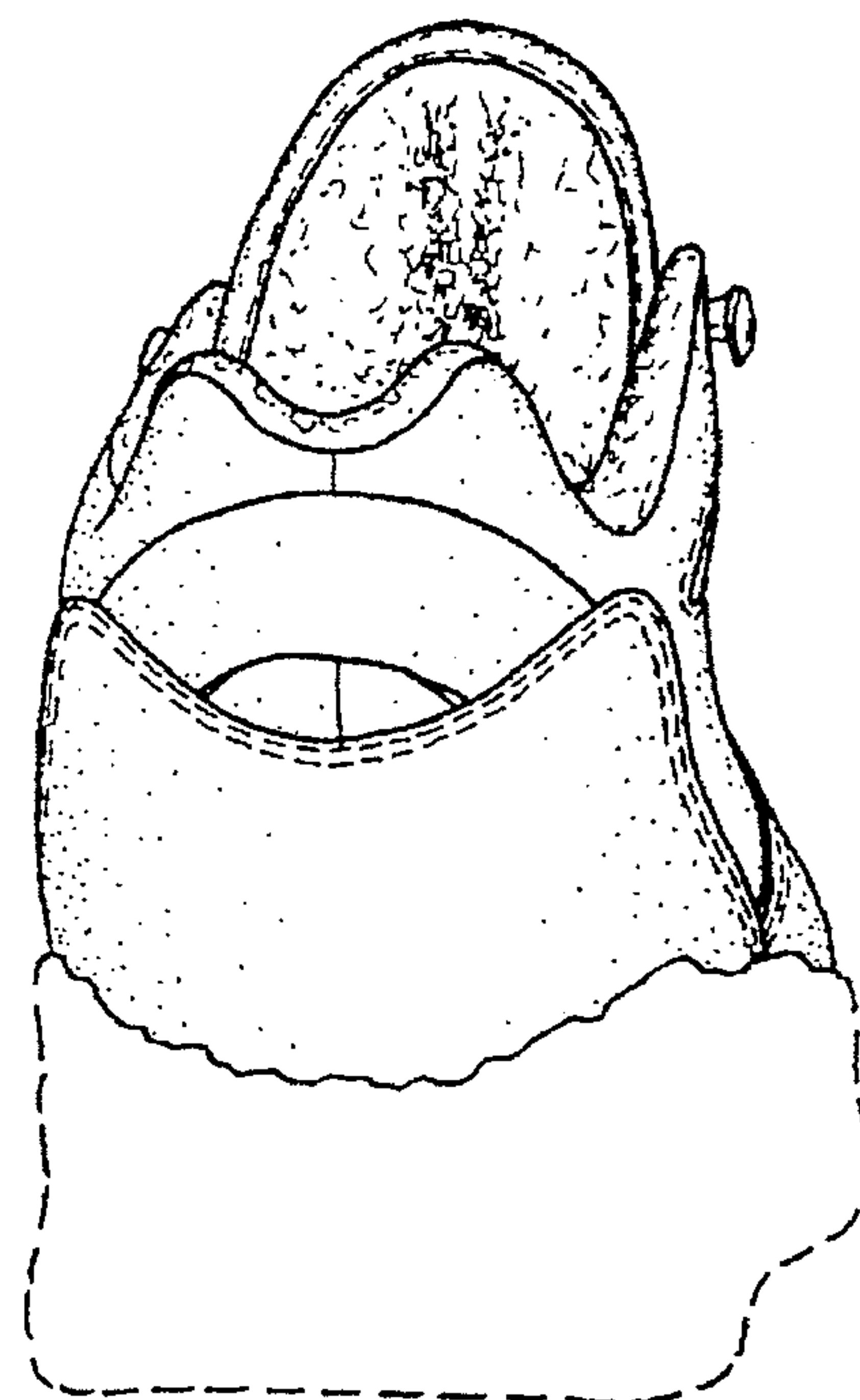
