FIG. 7 is an end elevational view as seen from the right side of FIG. 4; and,

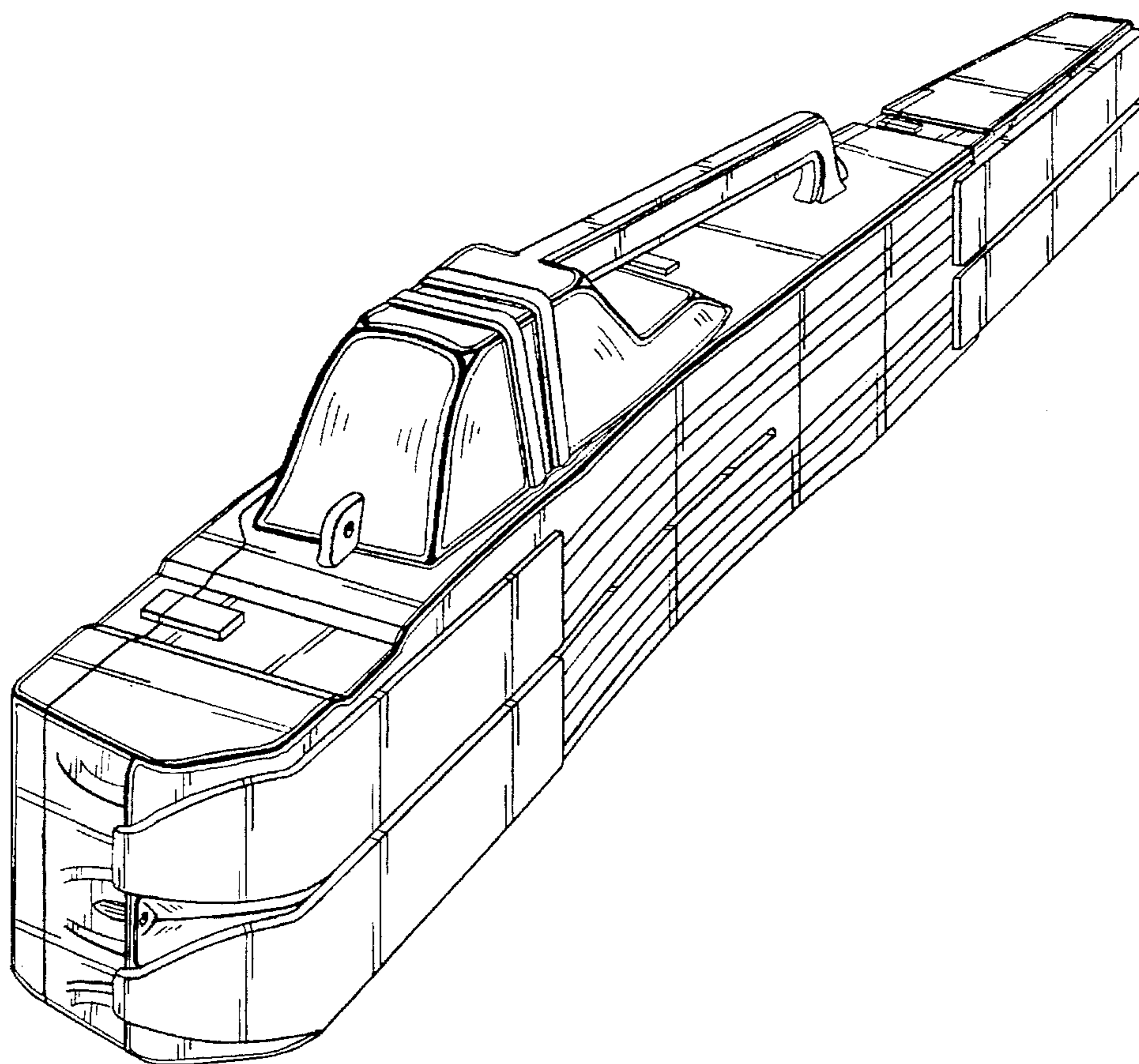
FIG. 8 is an end elevational view as seen from the left side of FIG. 4.

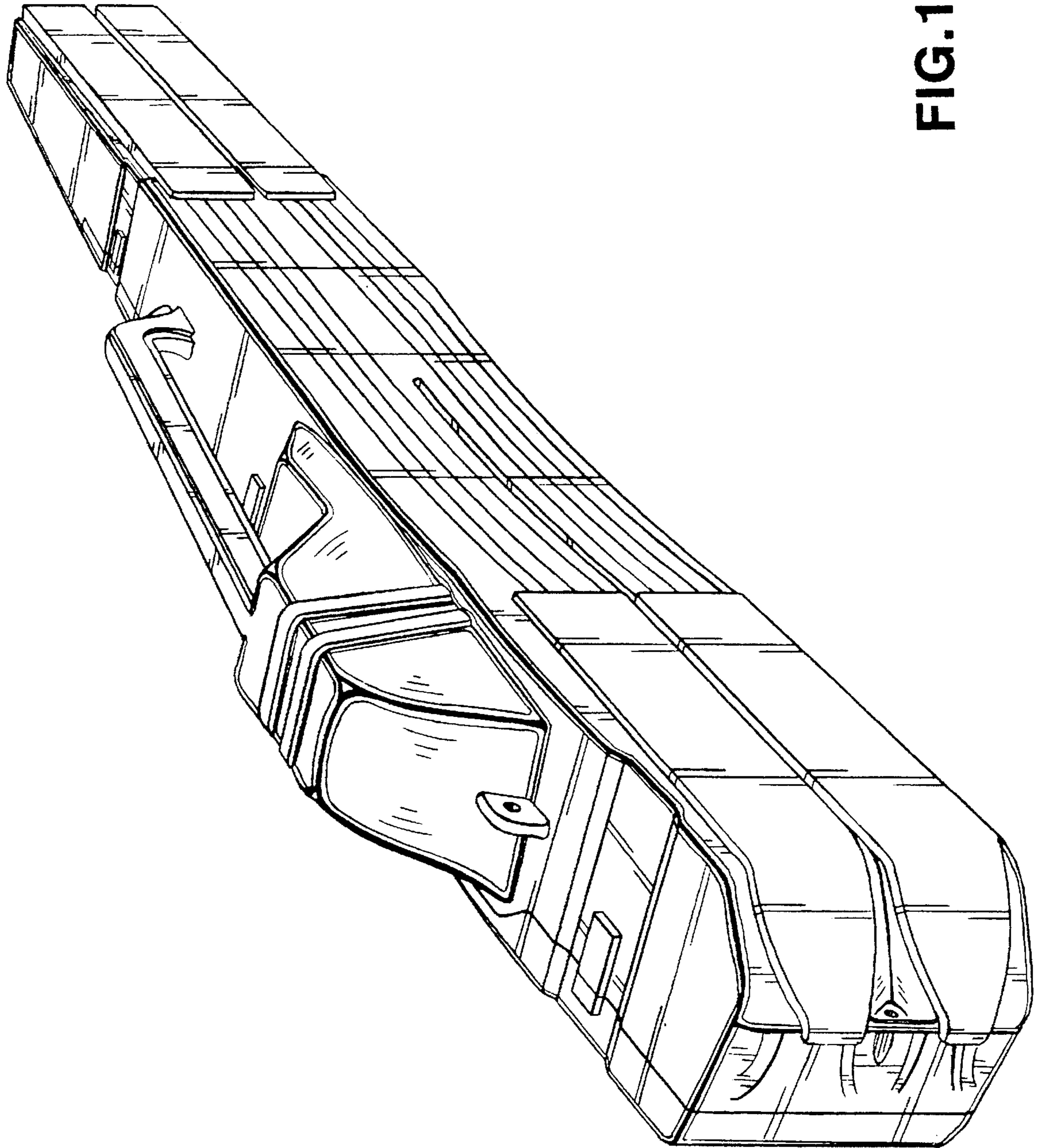

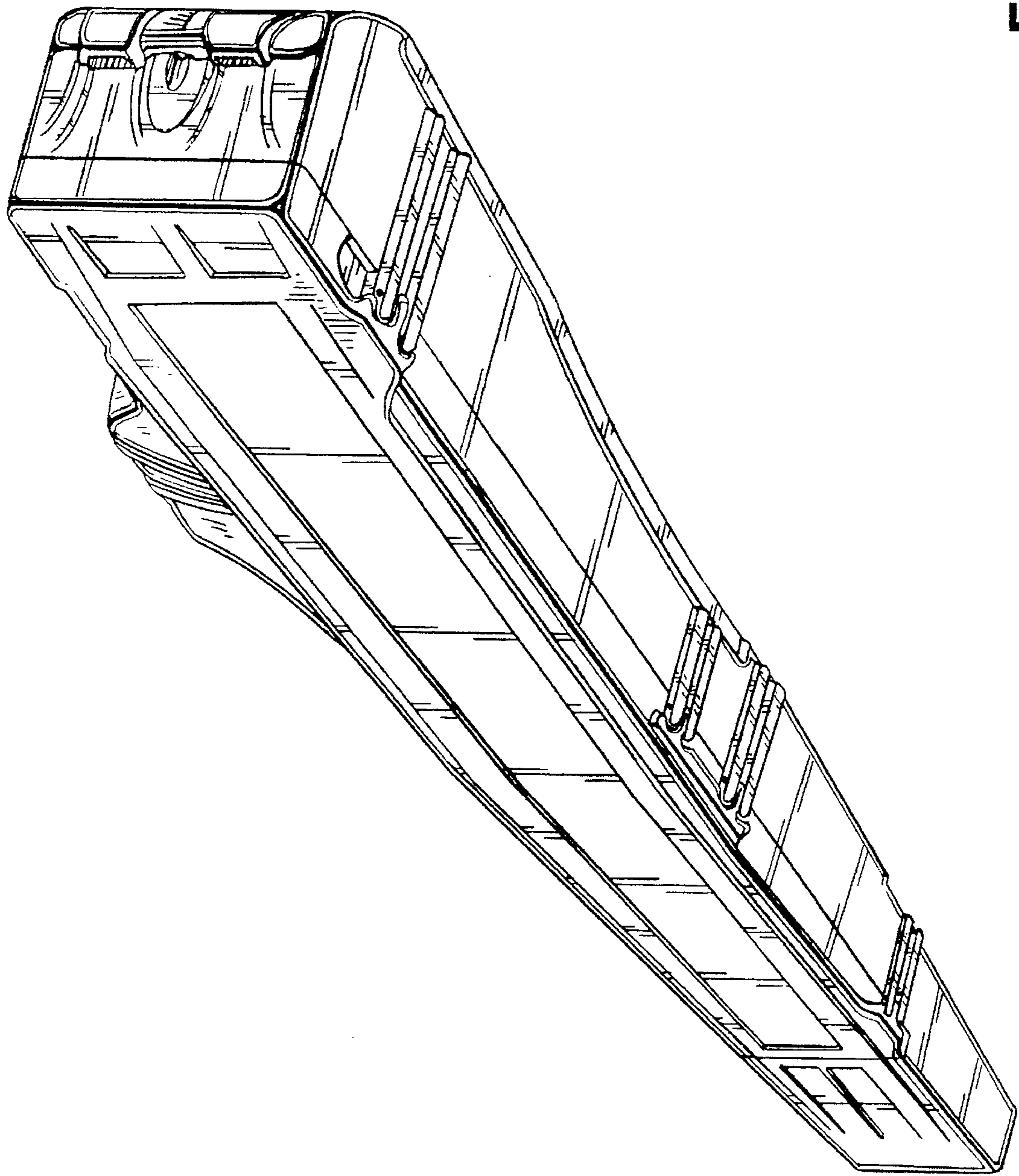

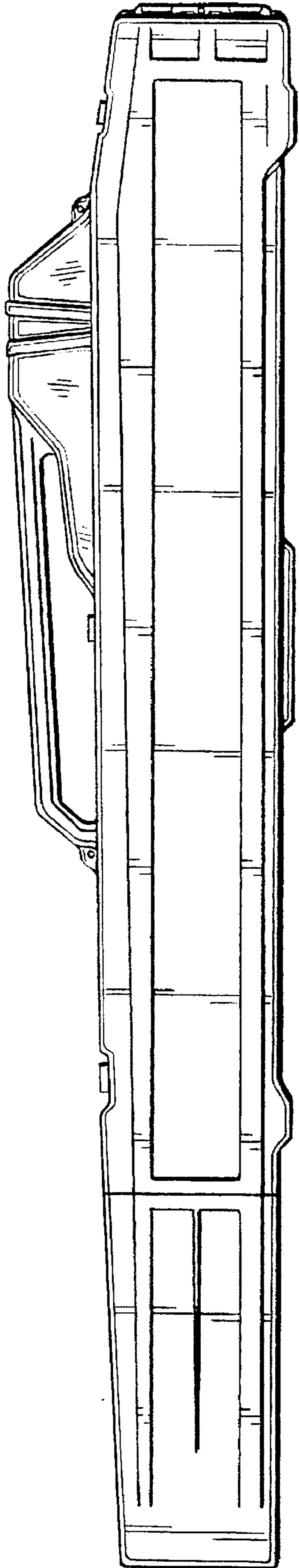

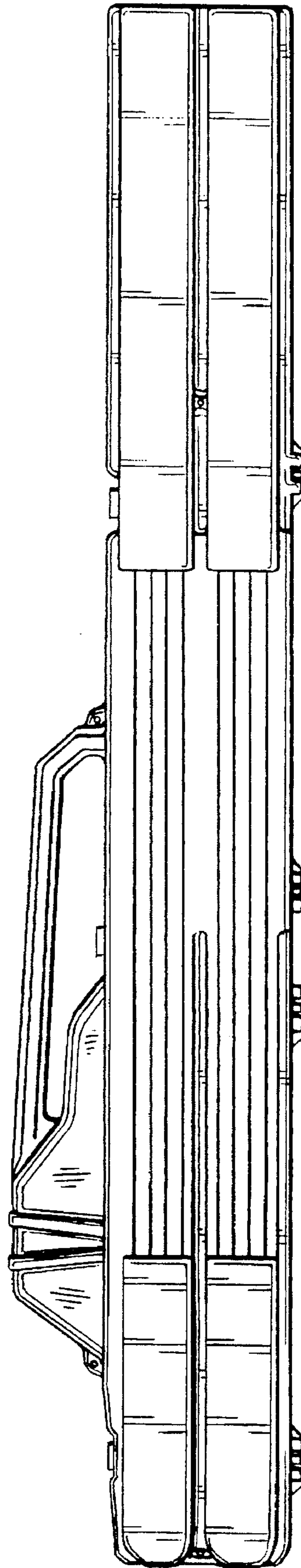

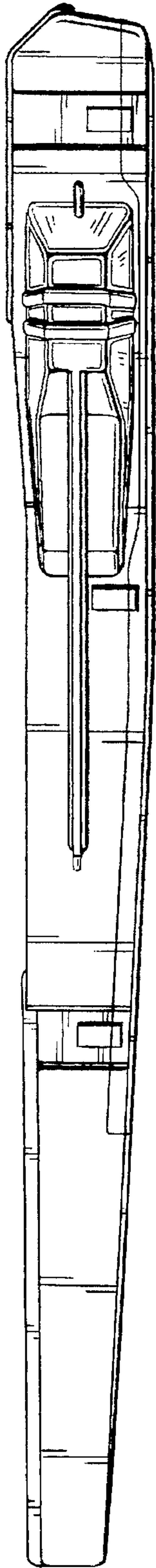

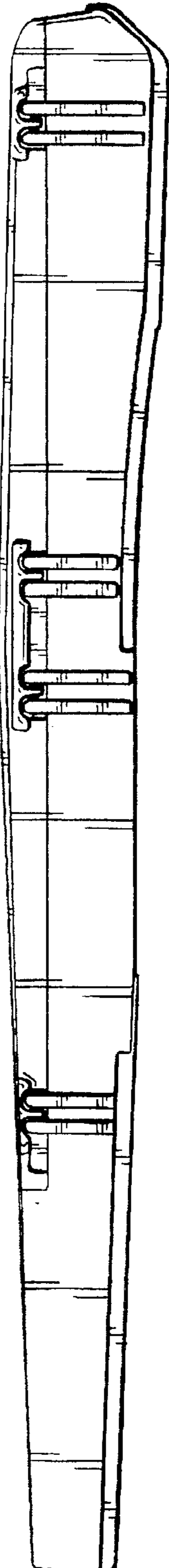

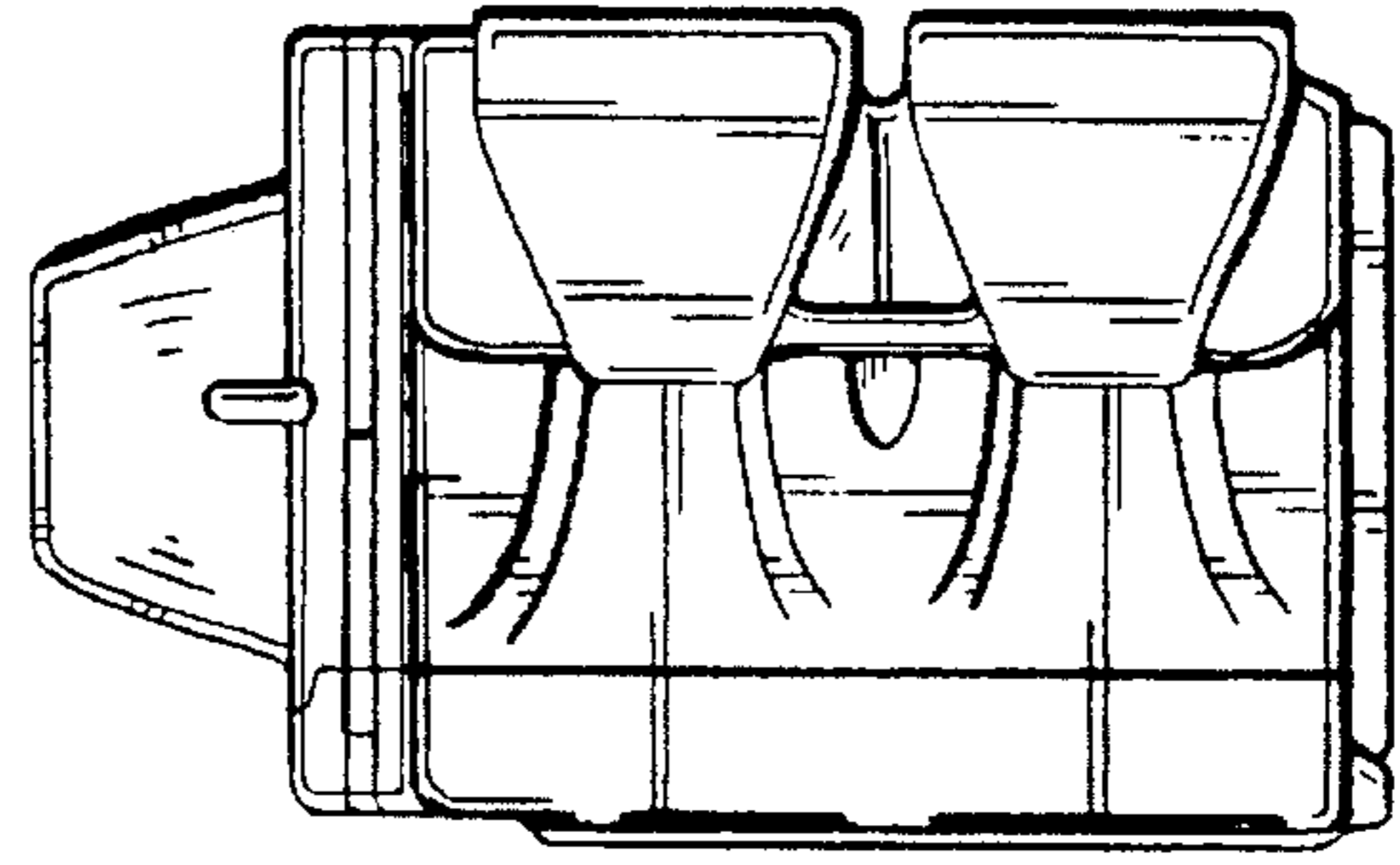

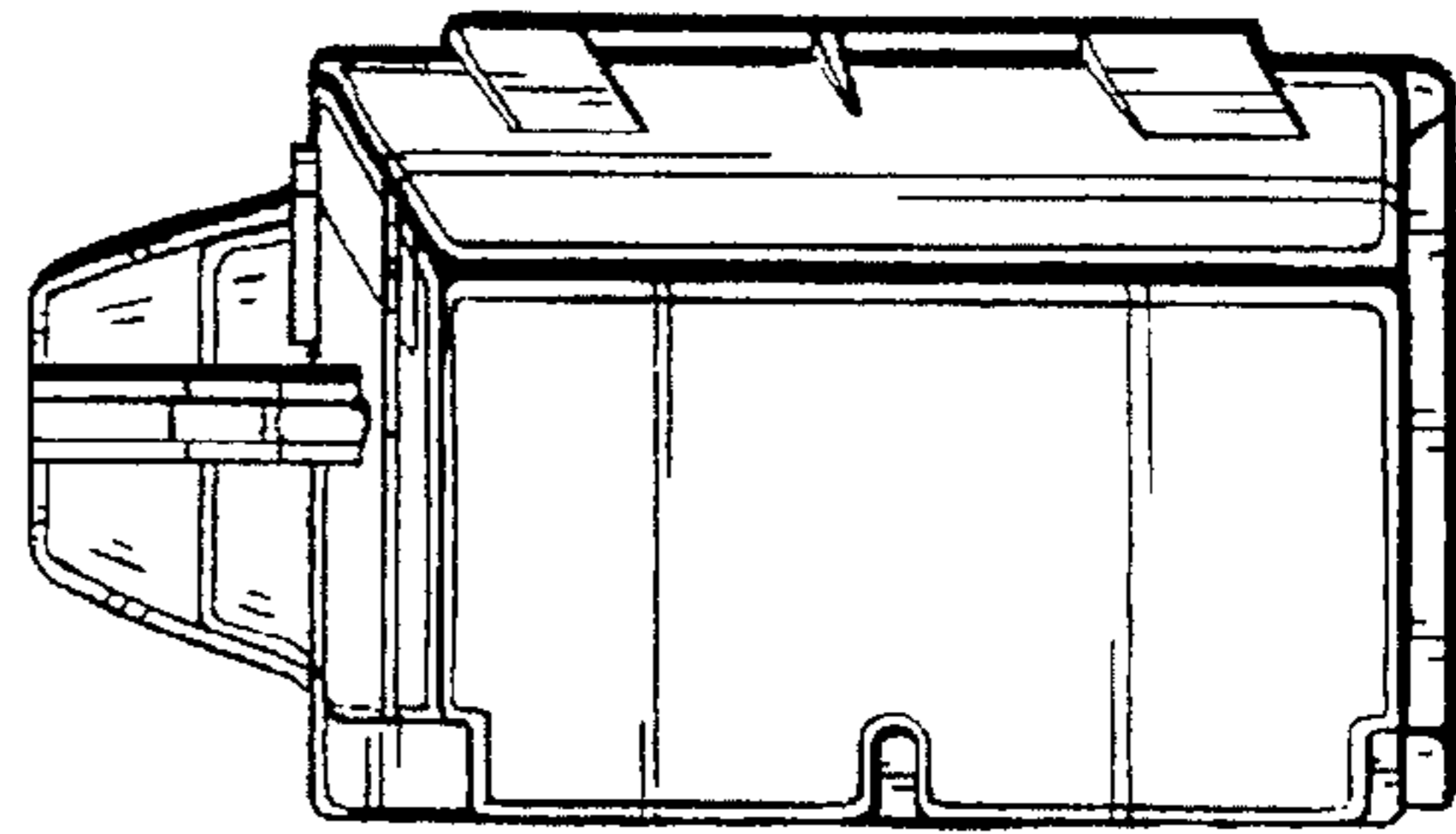
