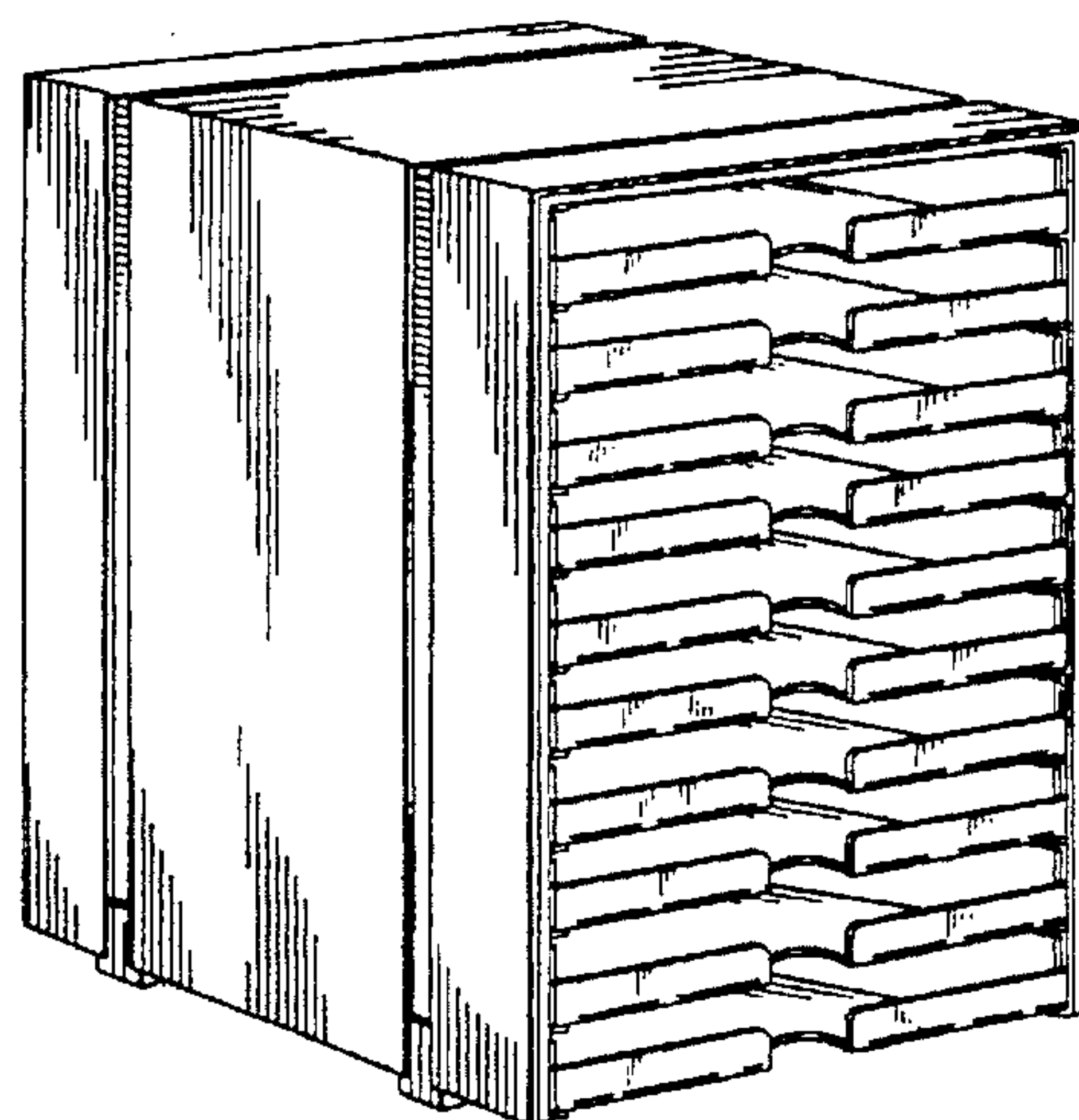
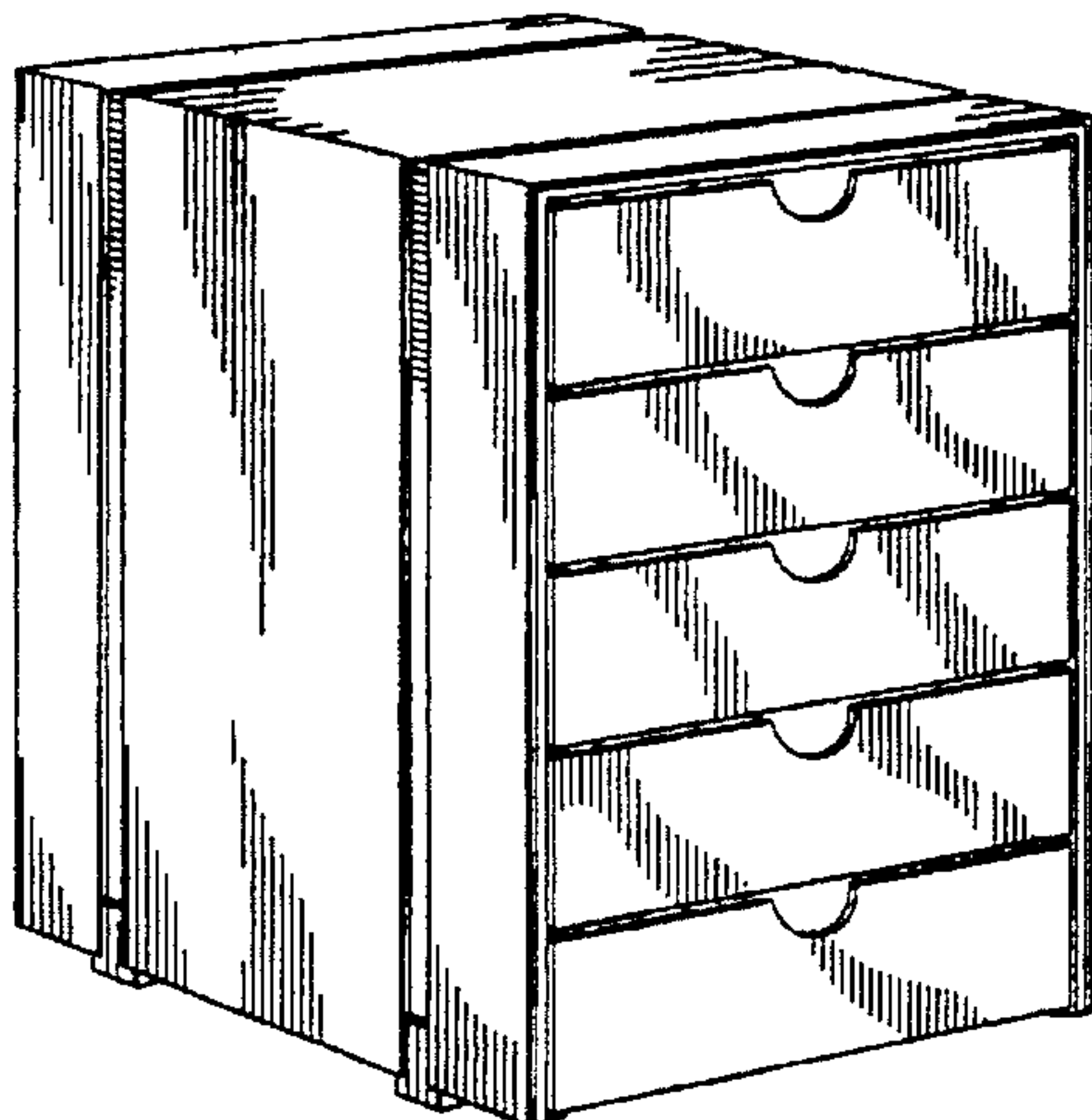
The ornamental design for a cabinet with sliding drawers, as shown and described.

### DESCRIPTION

FIG. 1 is a left side elevational view of a cabinet with sliding drawers, showing our new design;

FIG. 2 is a right side elevational view thereof;

 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a front elevational view thereof;  
 FIG. 6 is a rear elevational view thereof;

 FIG. 8 is a top, rear perspective view of a drawer of FIG. 1, the cabinet removed for convenience of illustration;  
 FIG. 9 is a left side, top and front perspective view of a second embodiment of the cabinet with sliding drawers shown in FIG. 1;

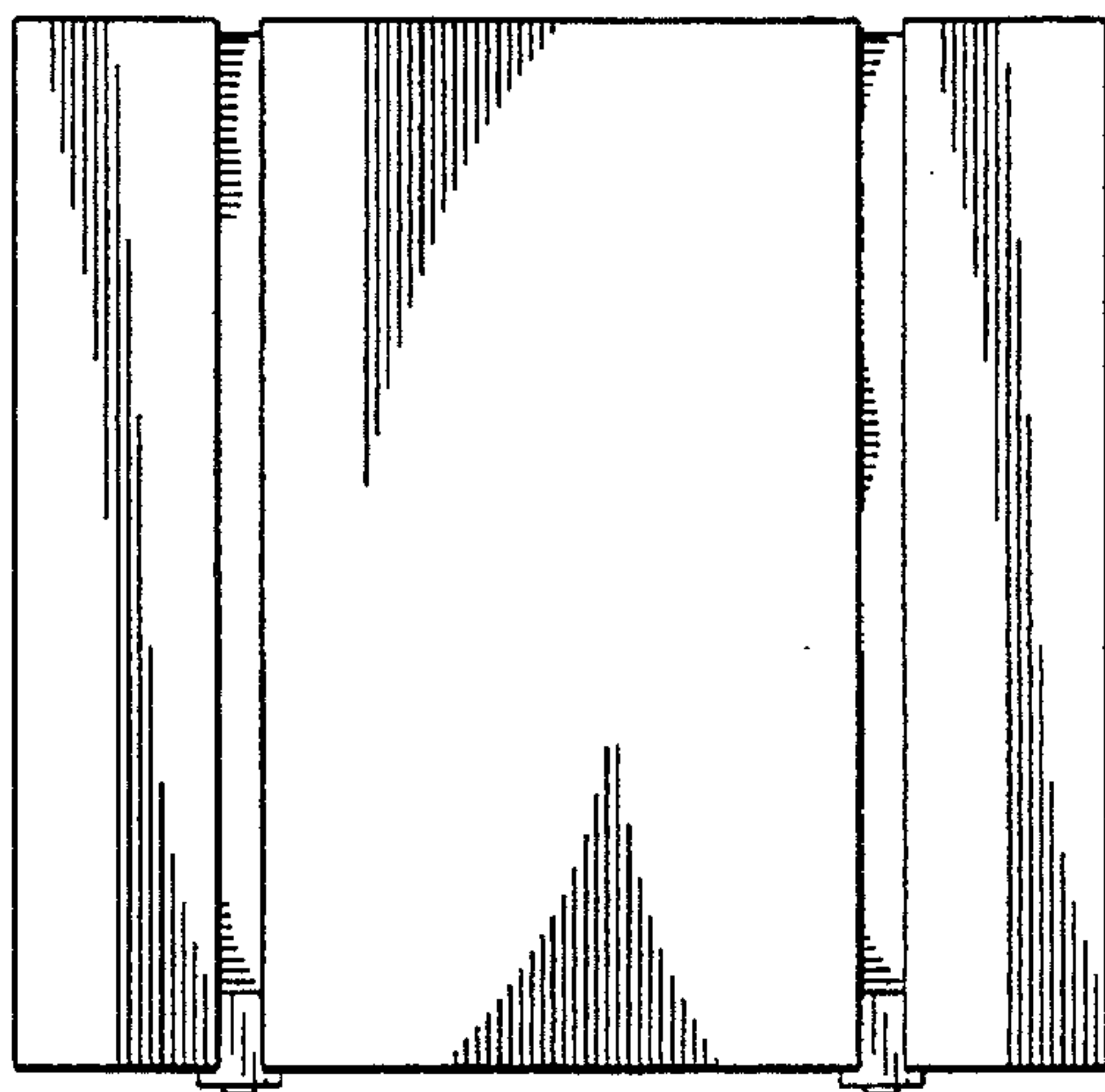

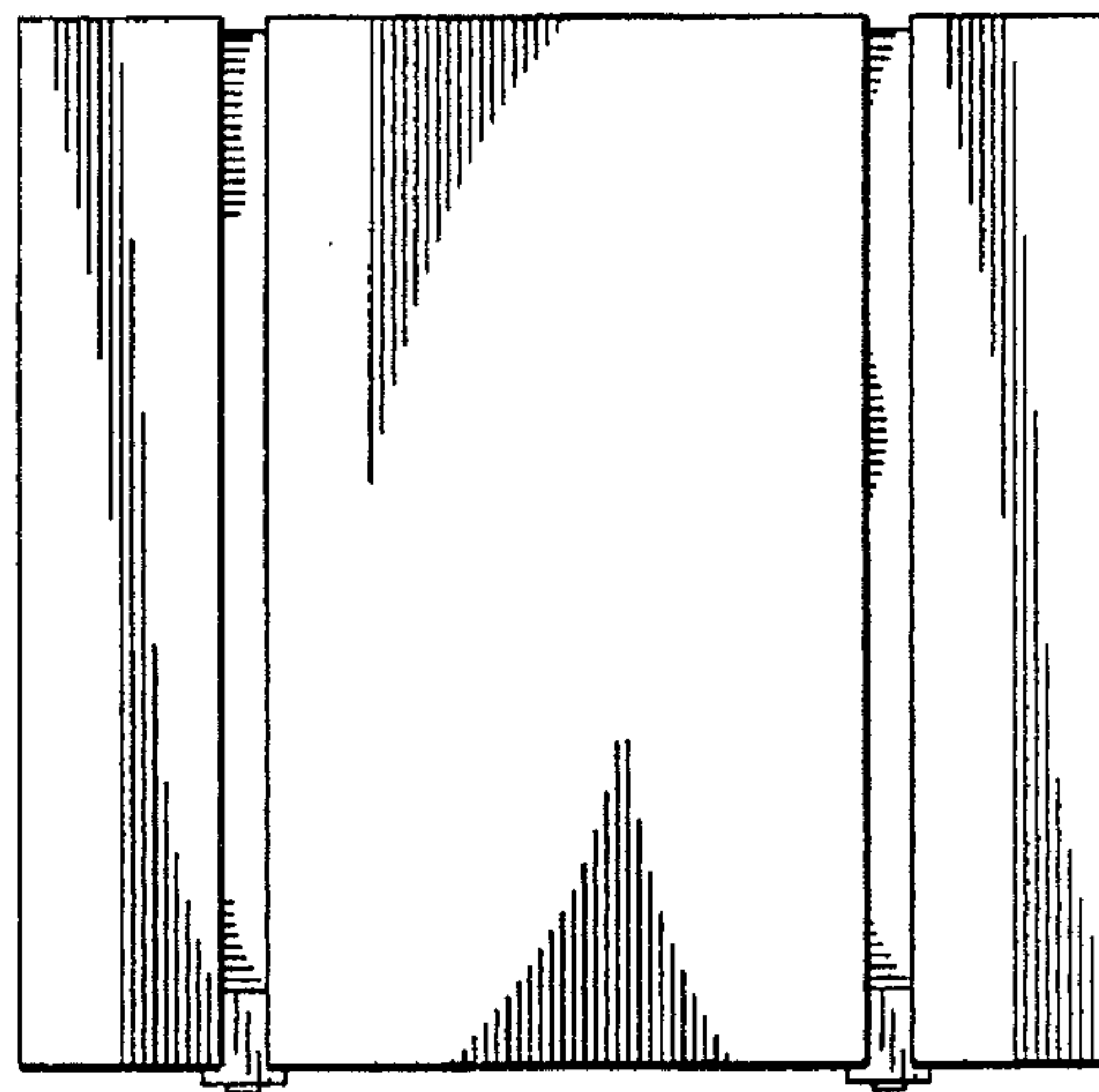

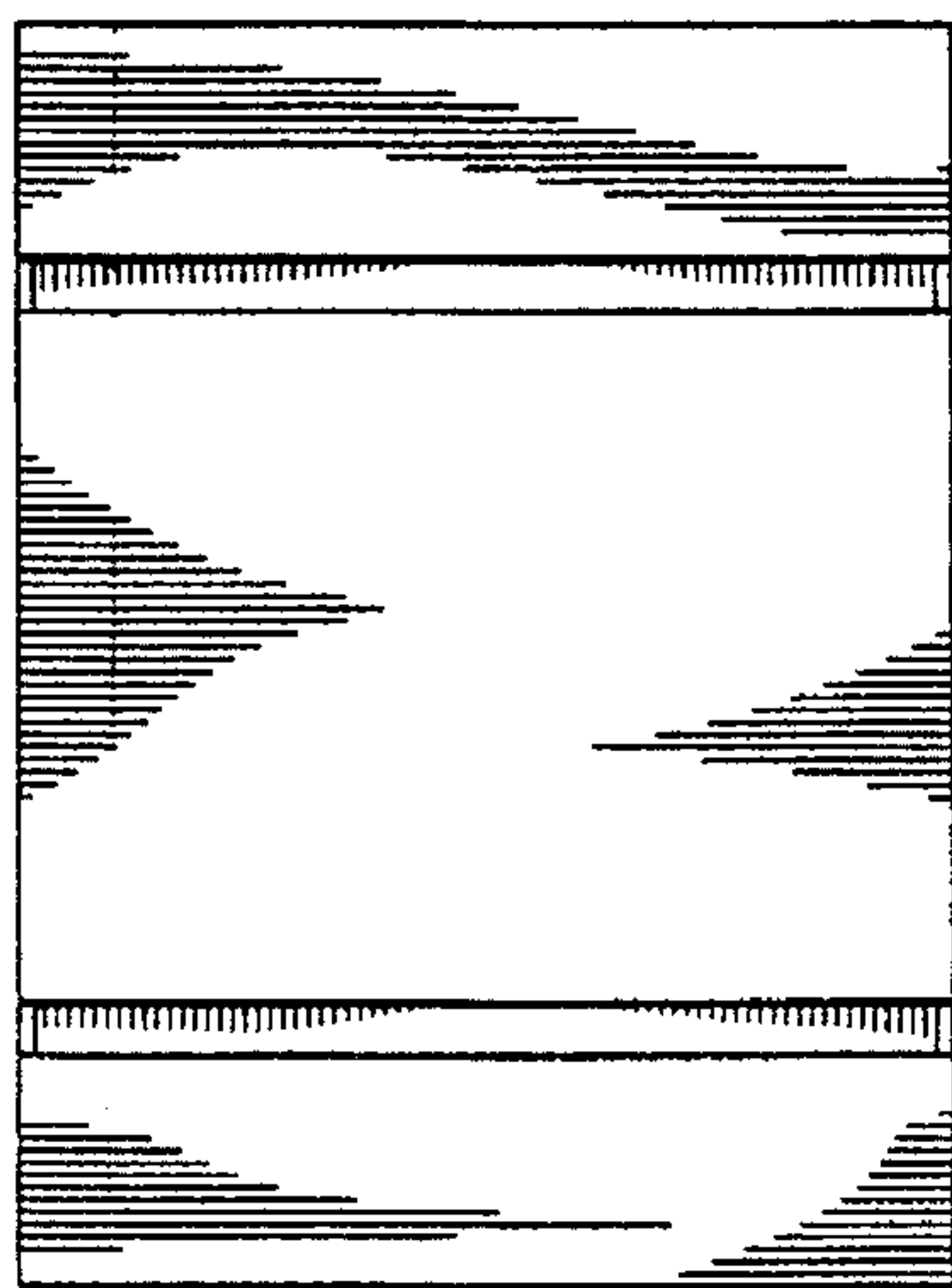

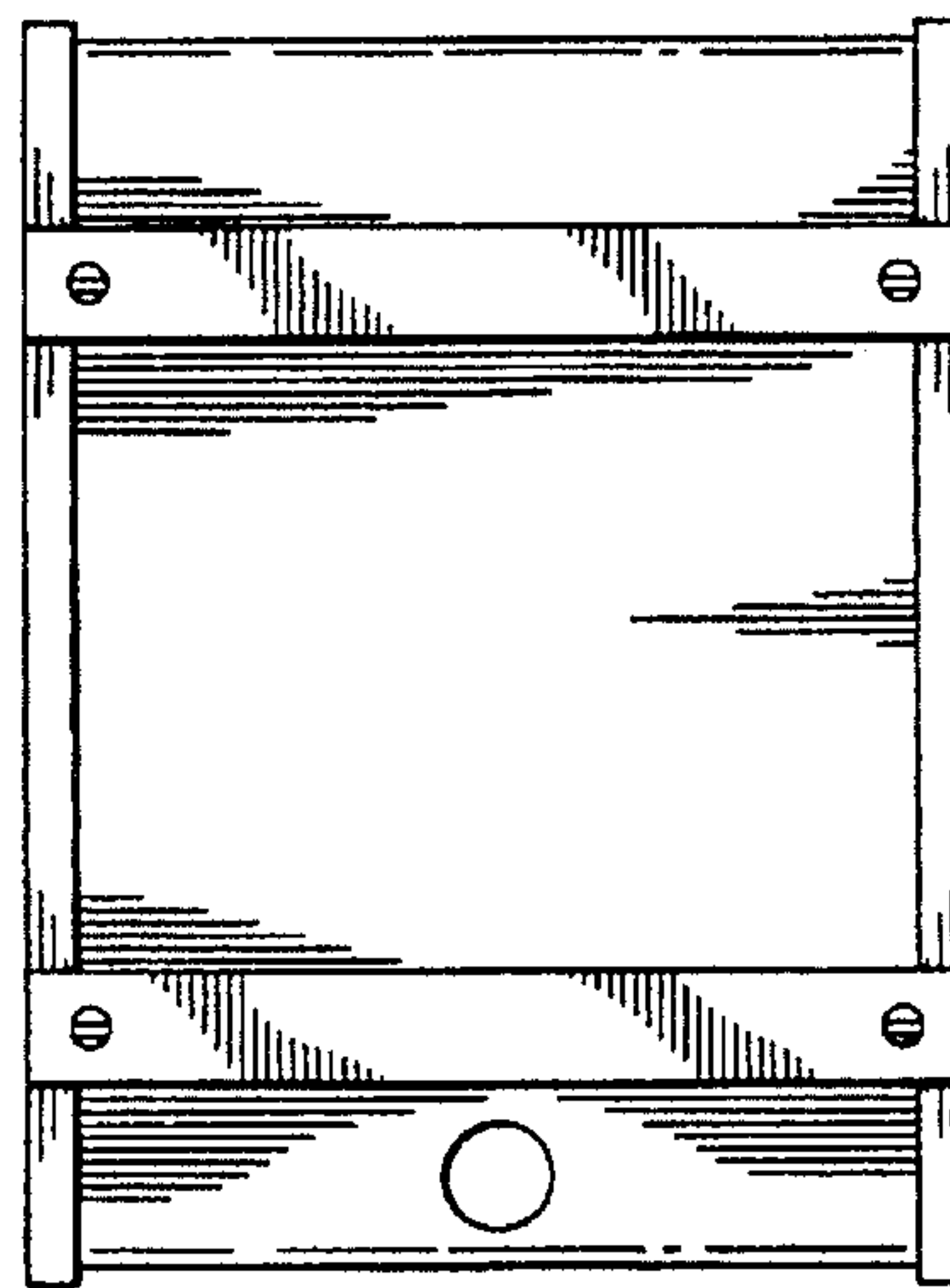

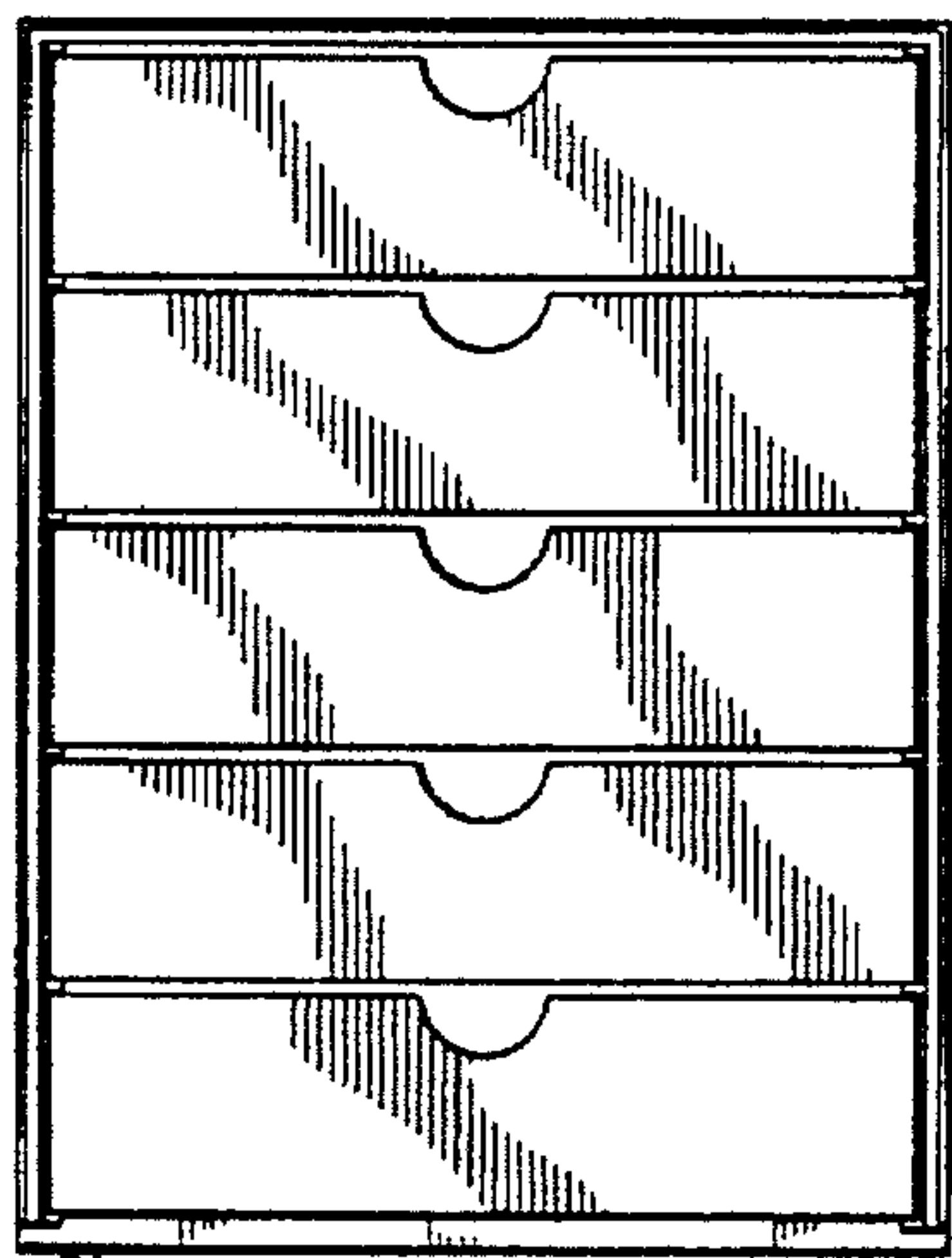

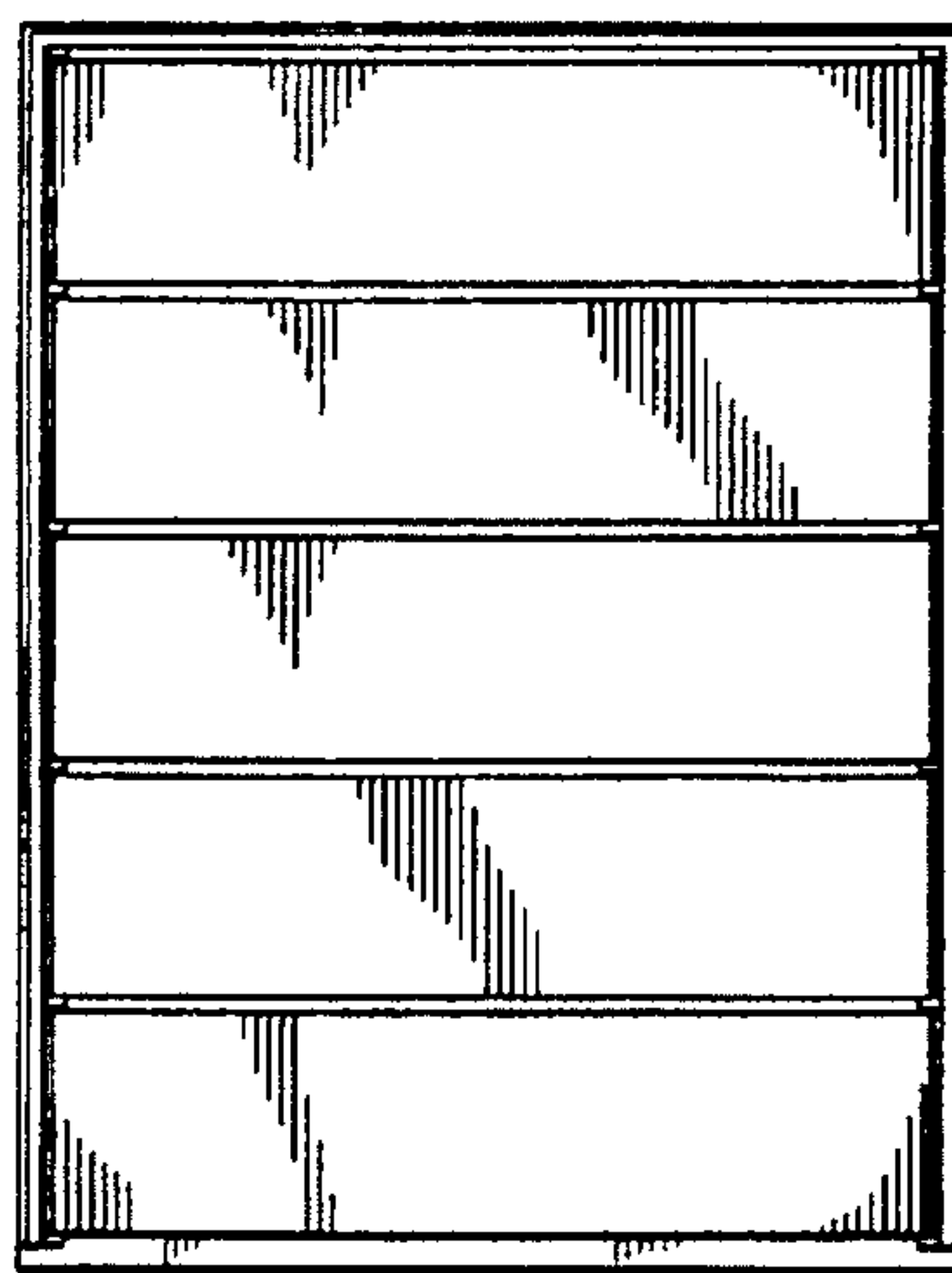

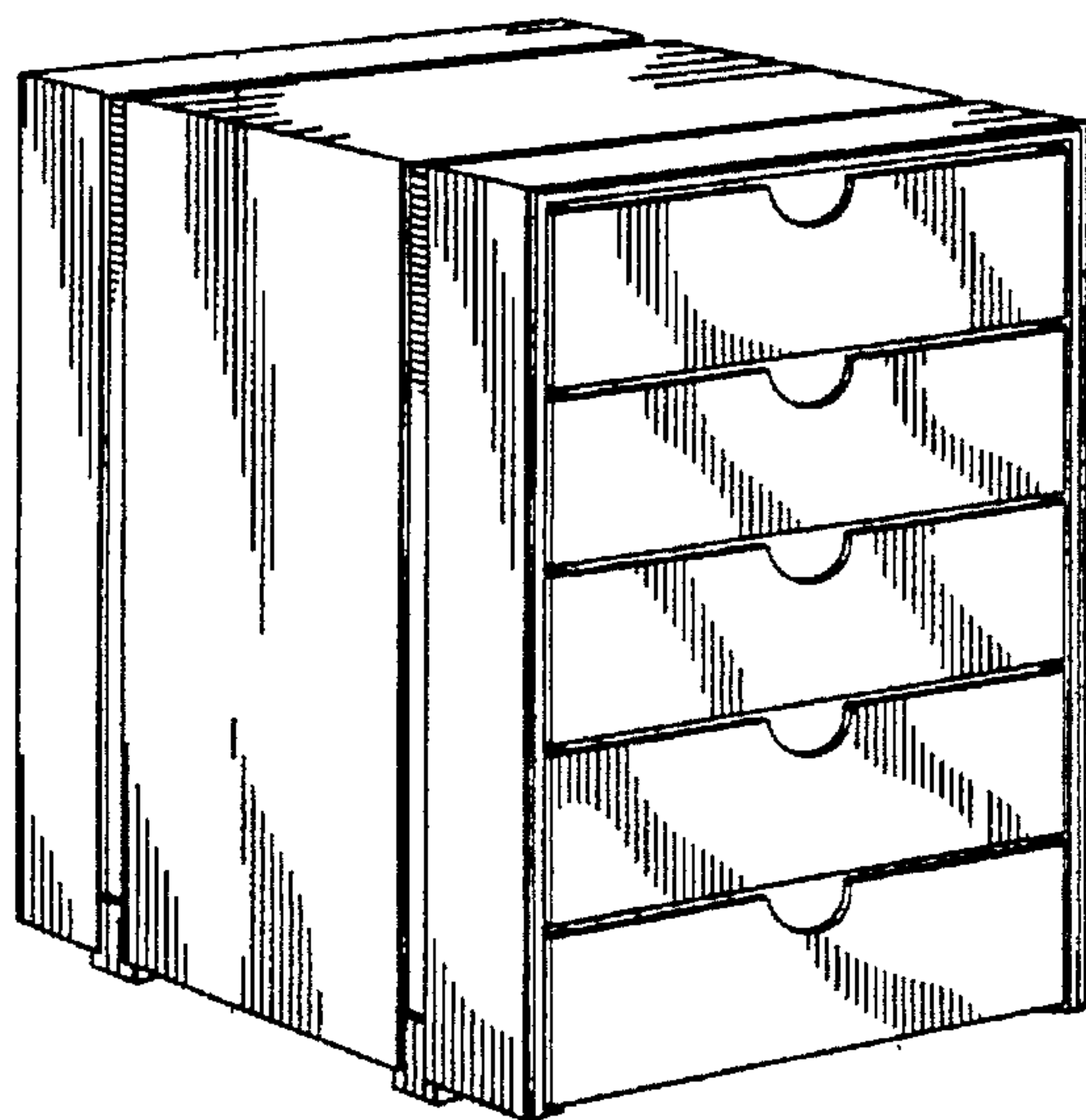

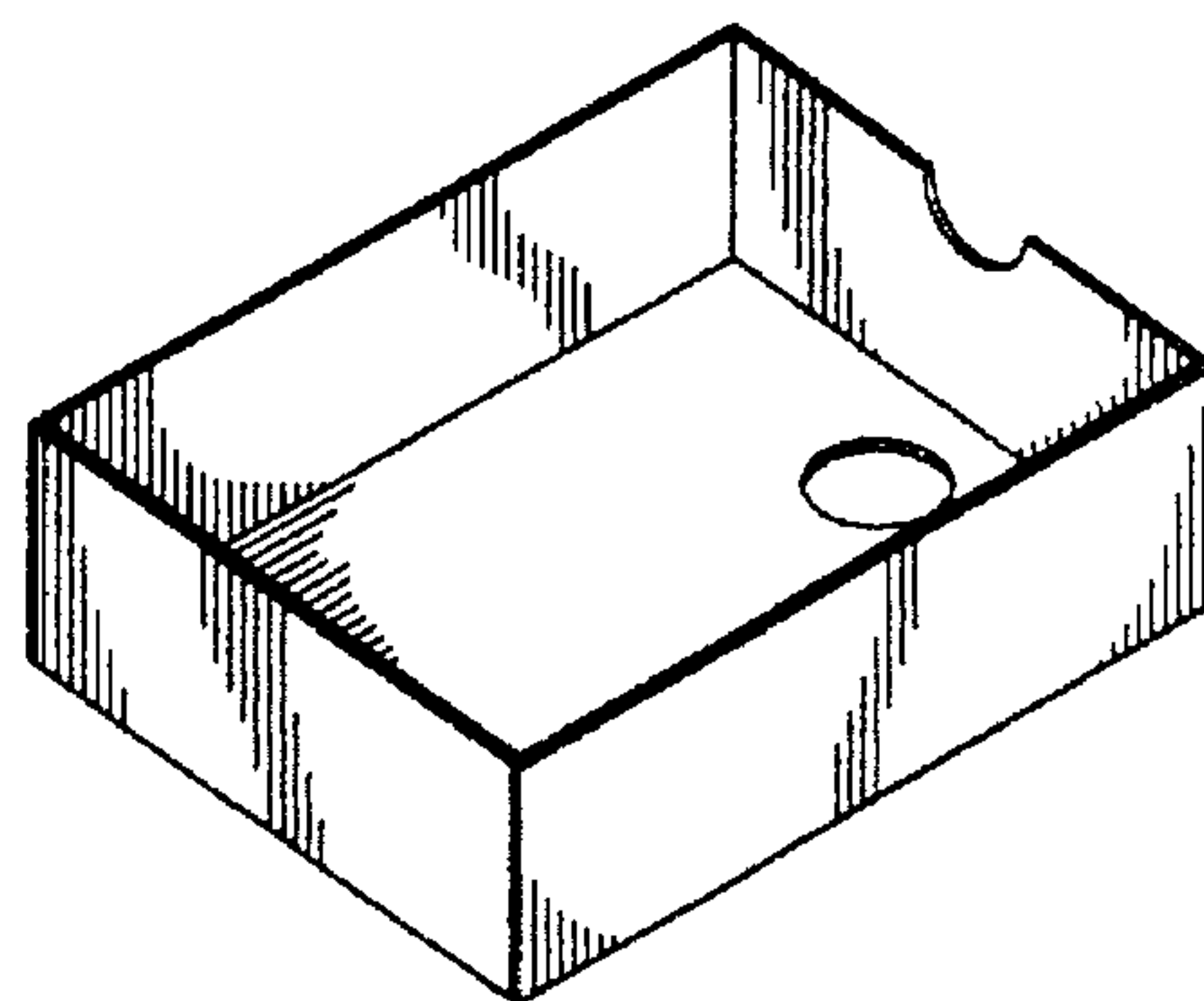

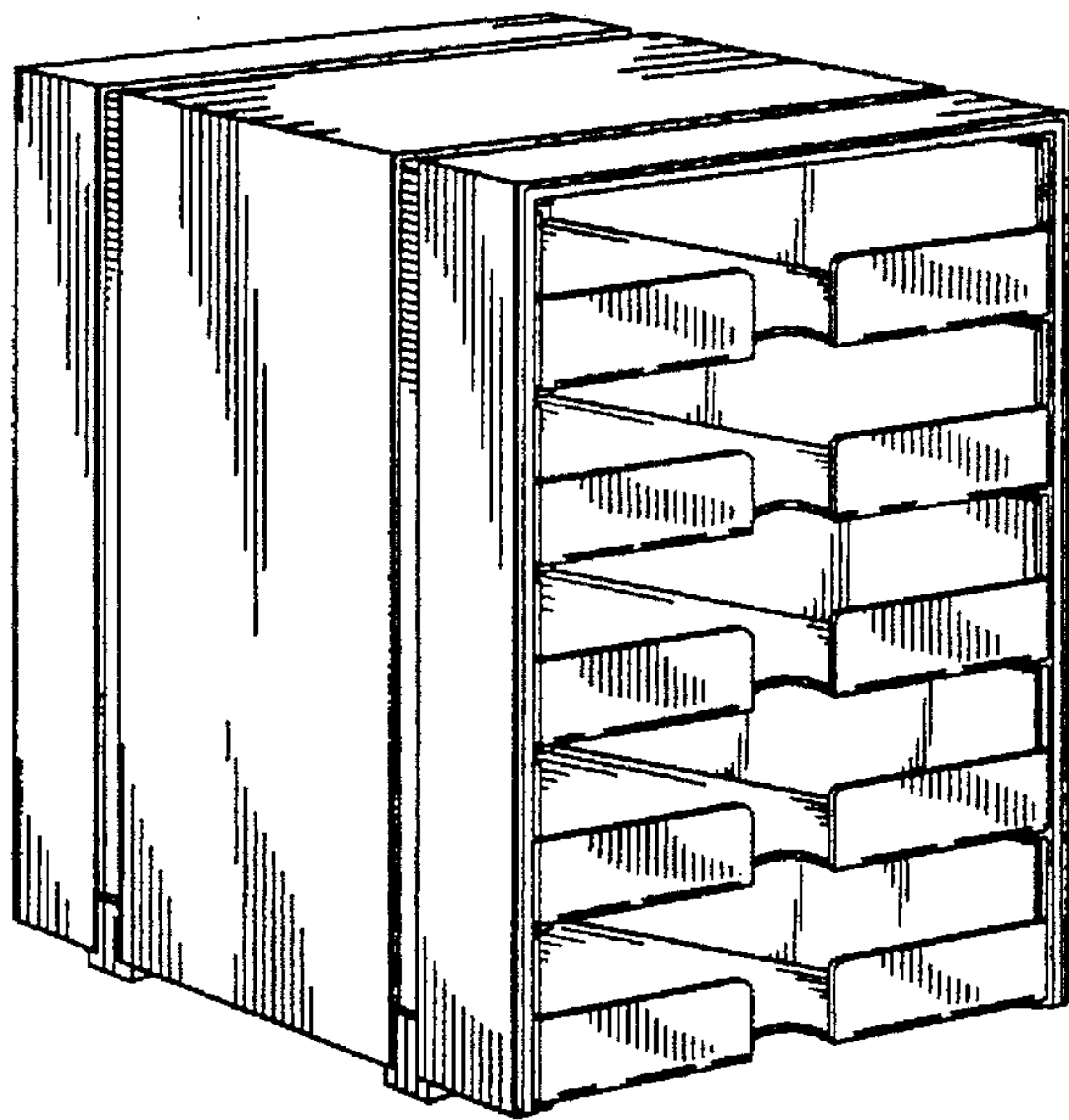

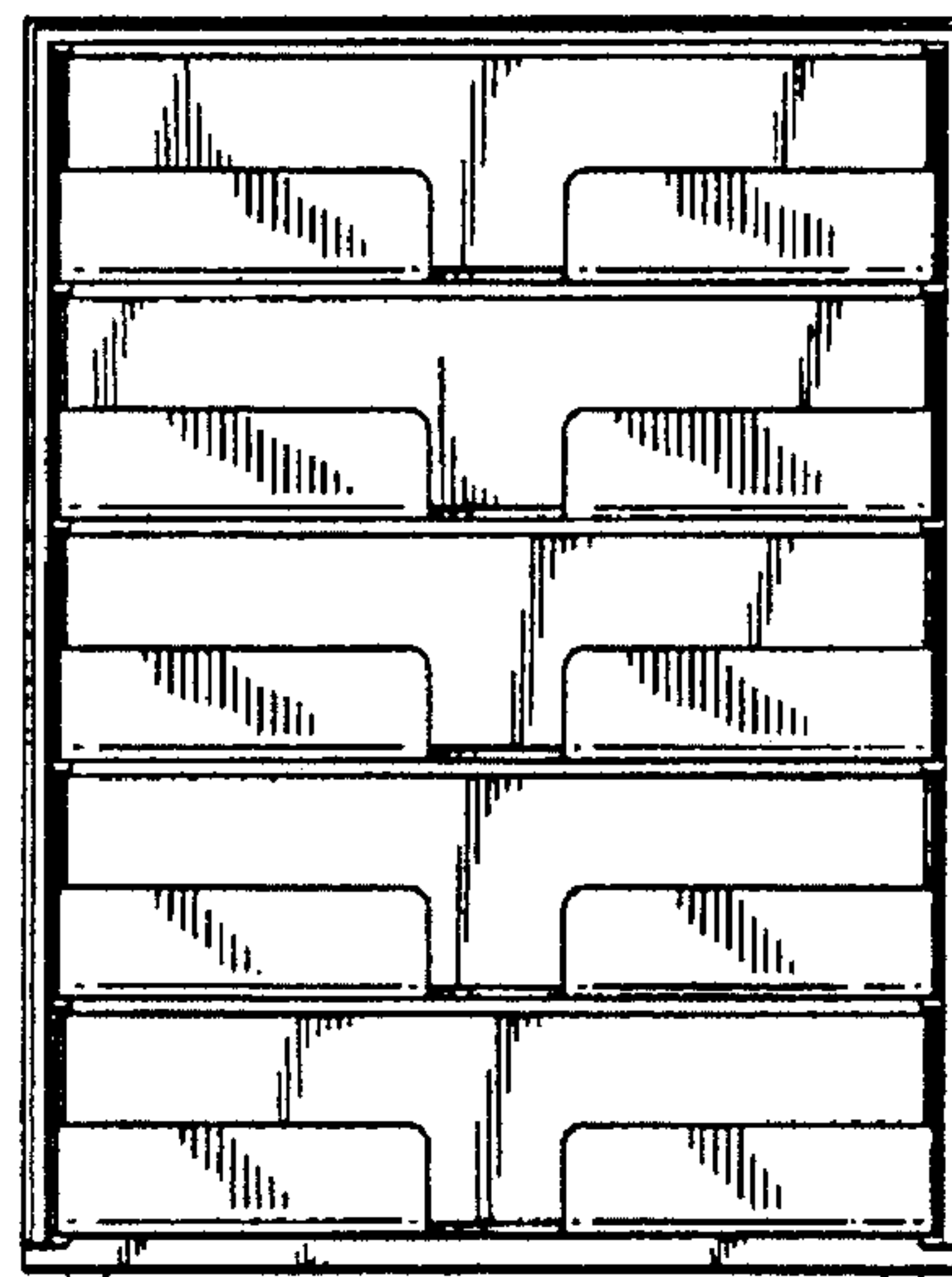

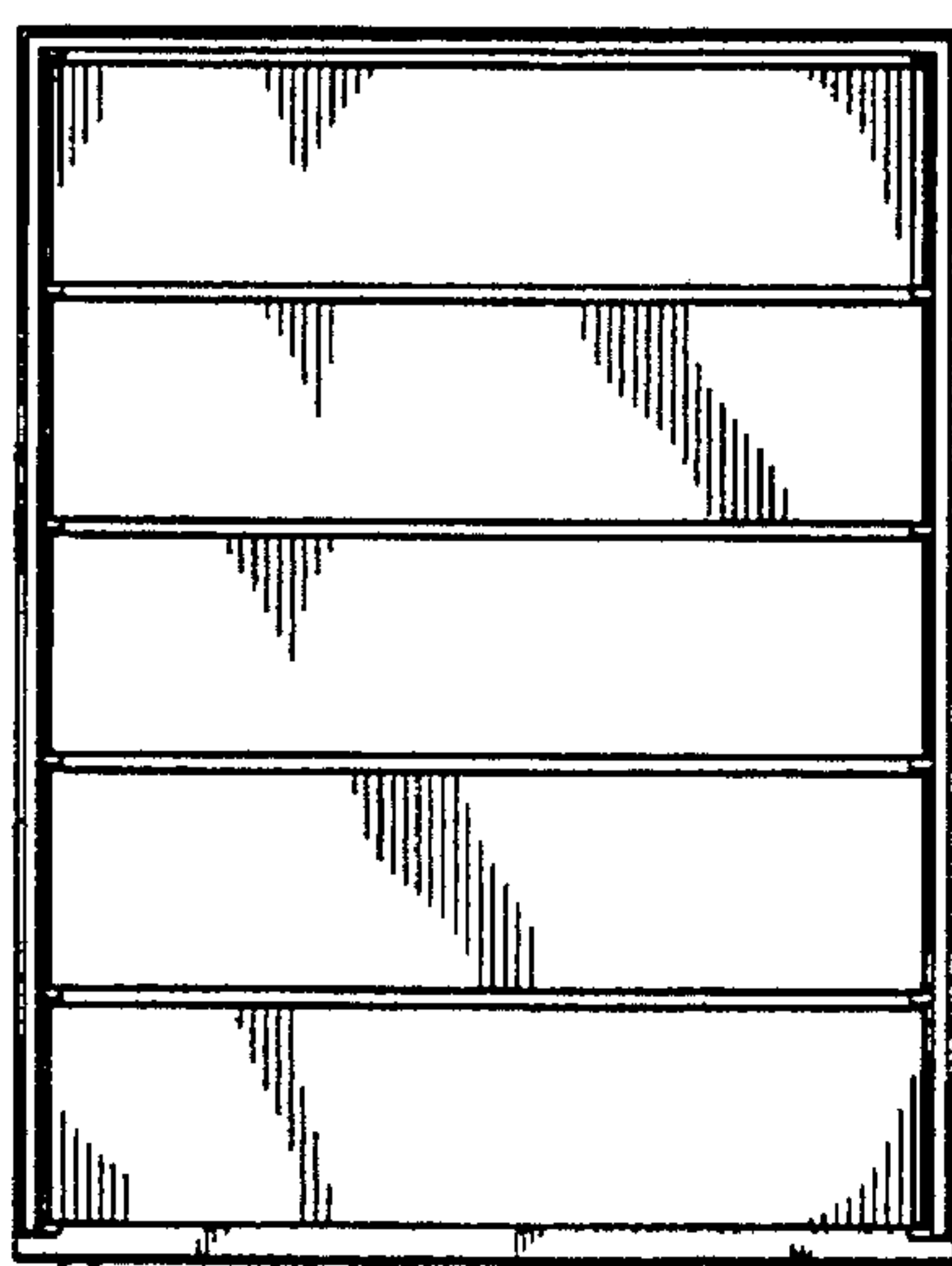

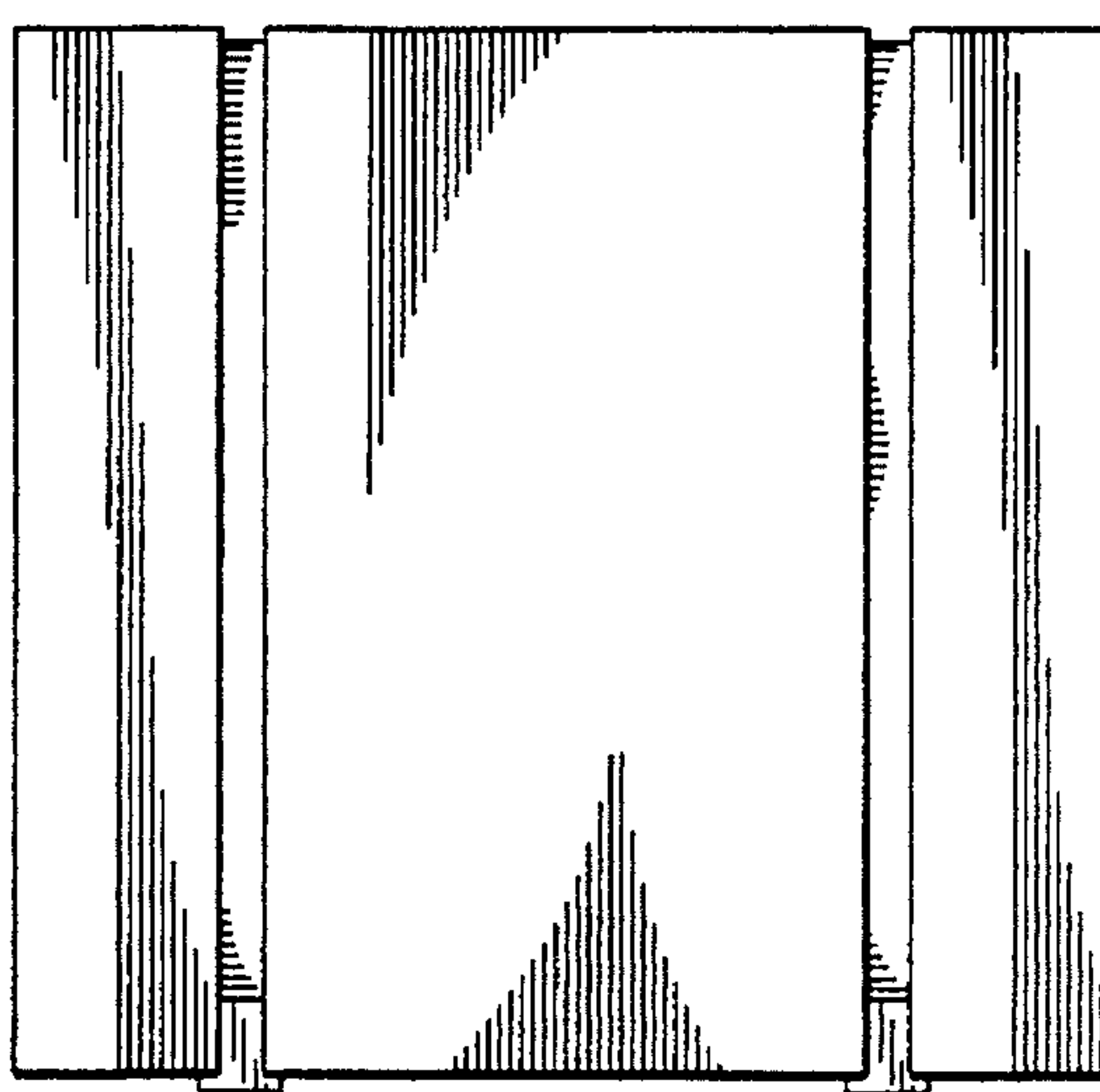

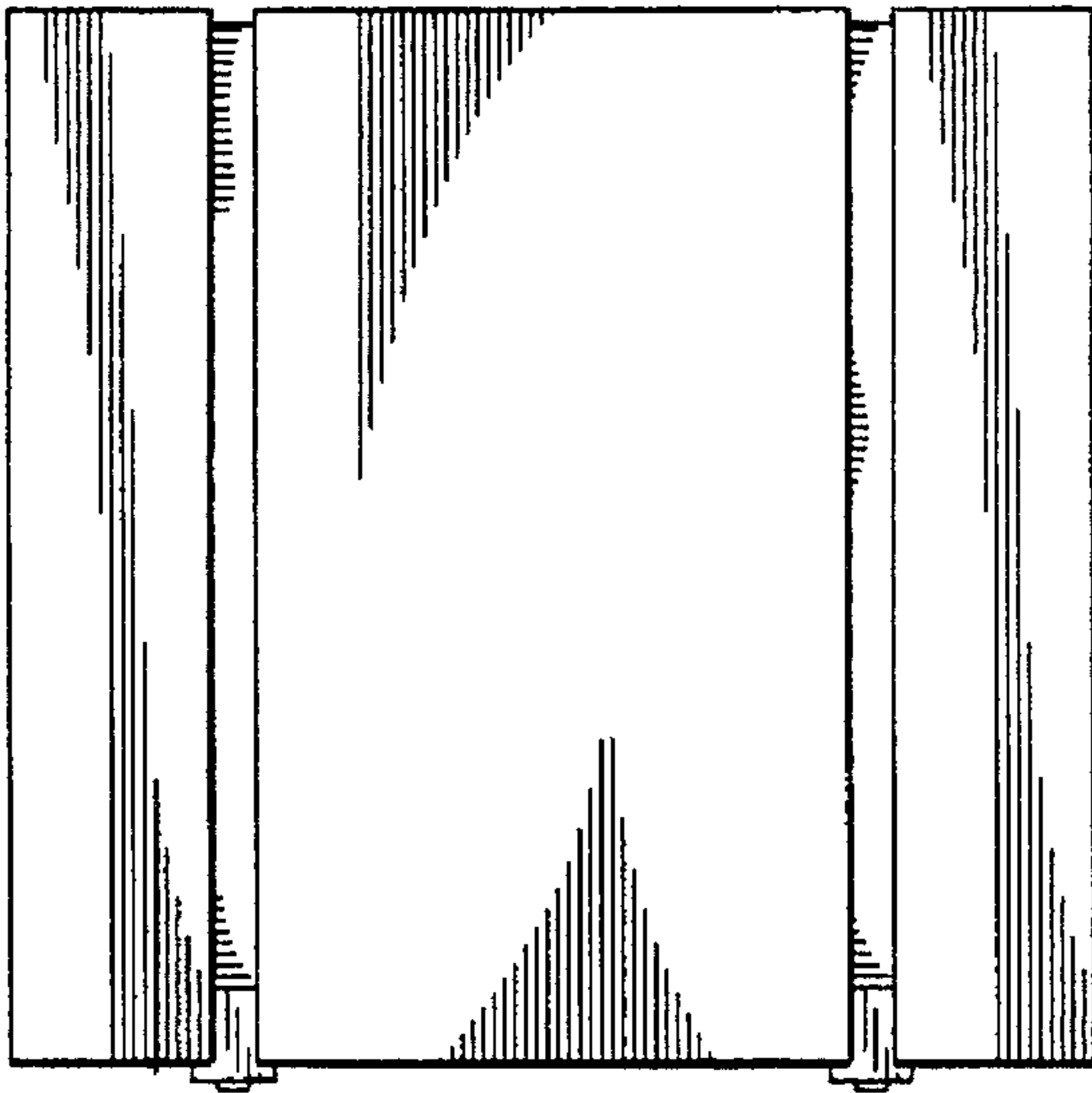

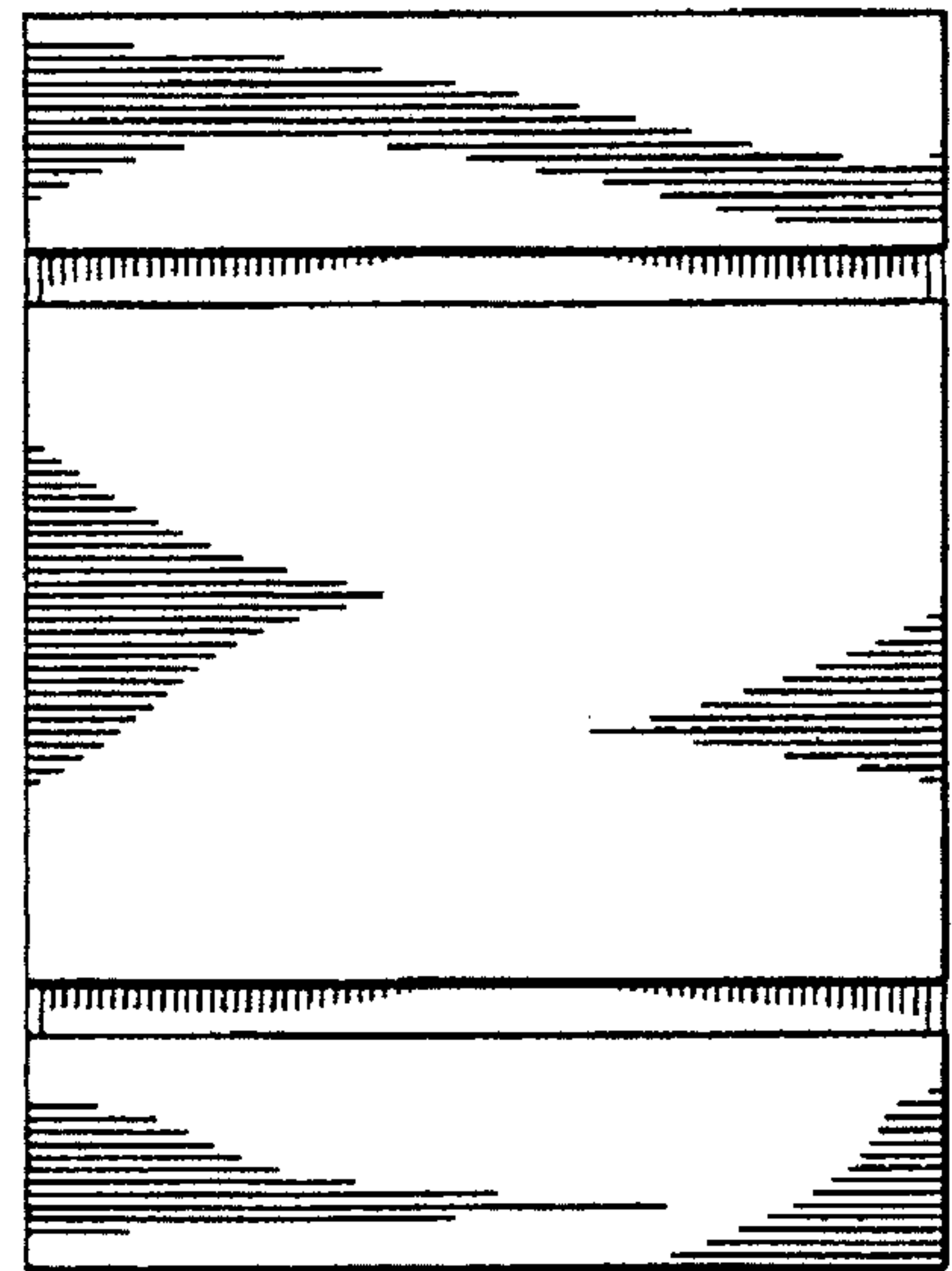

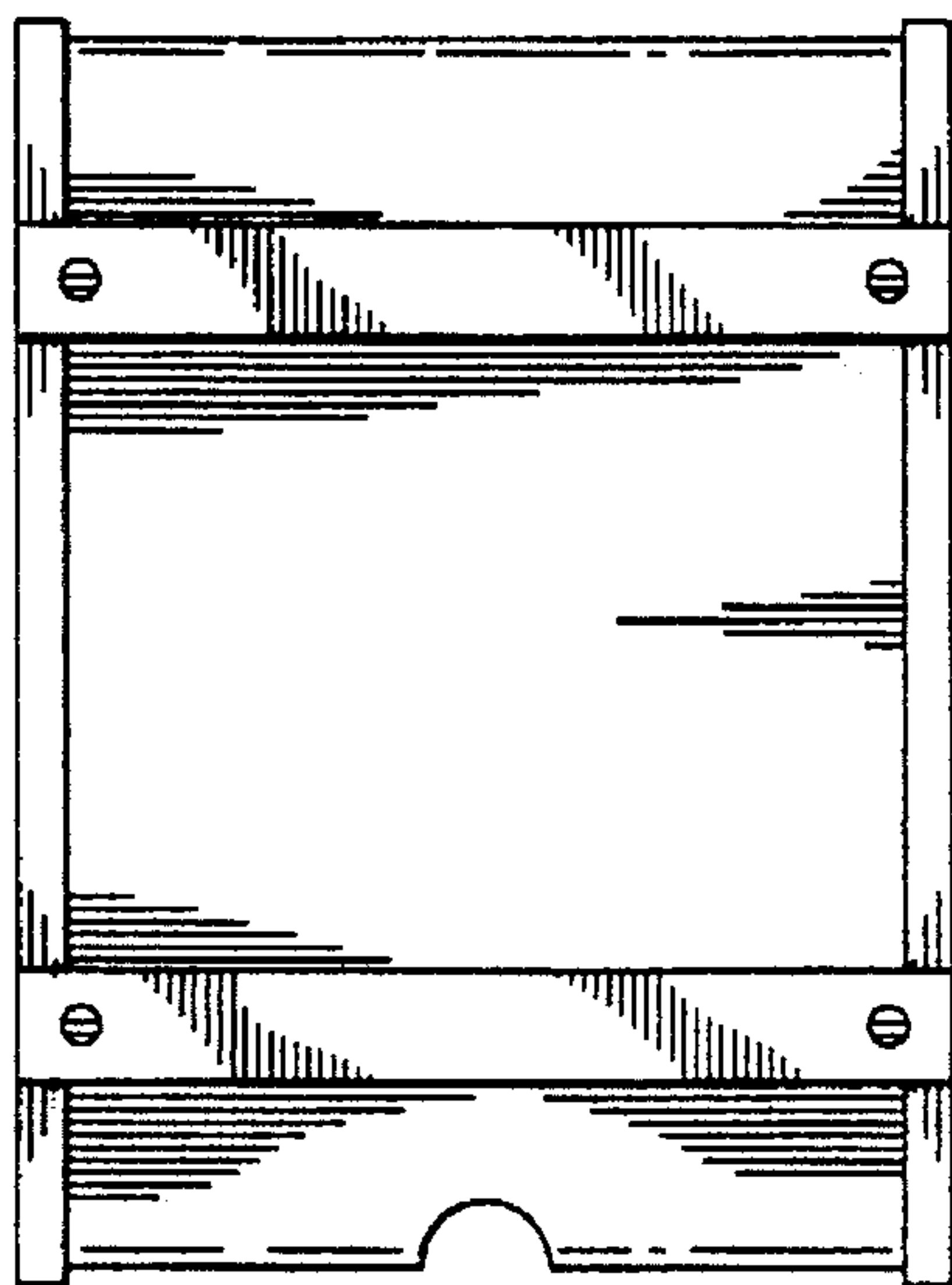

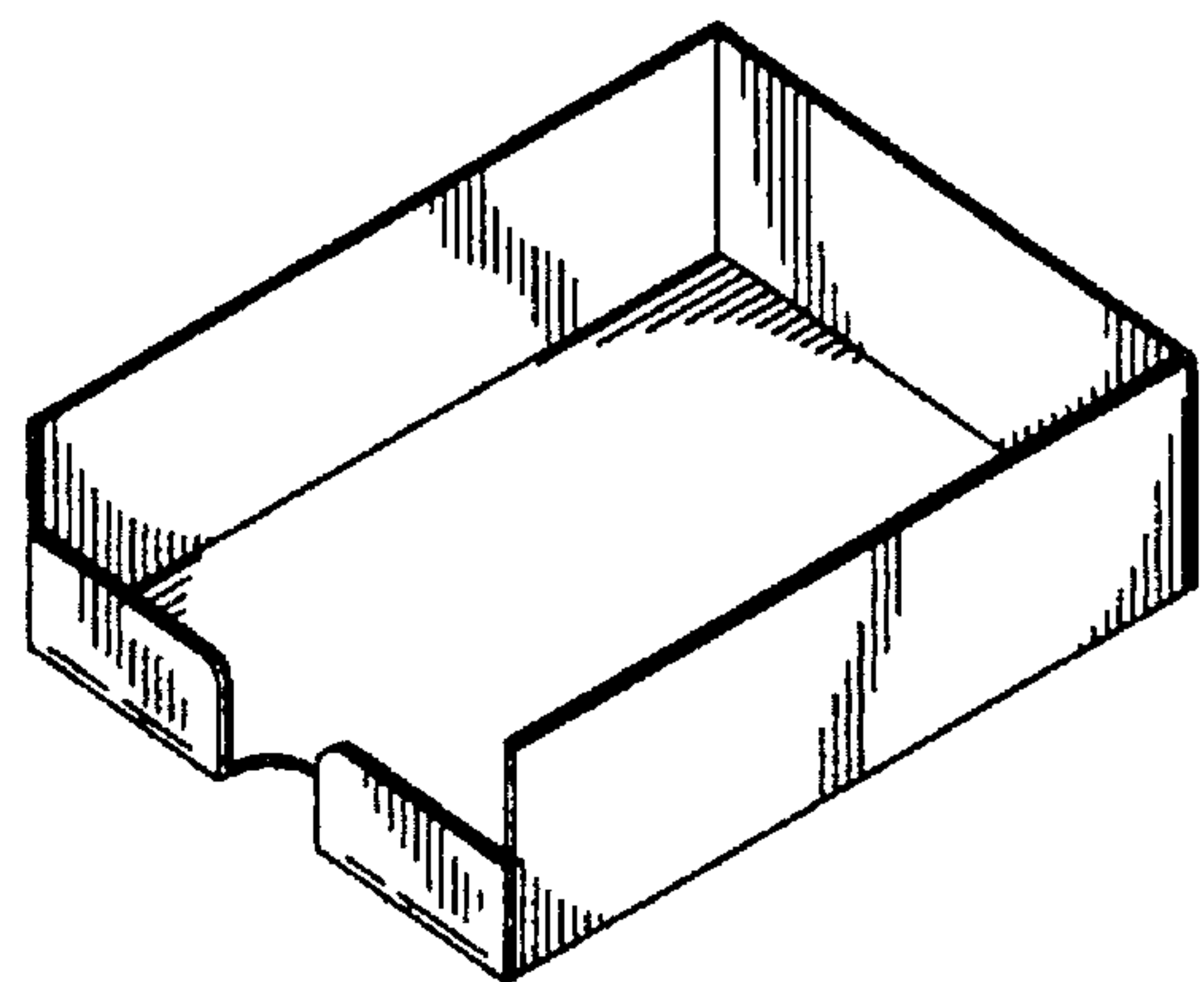

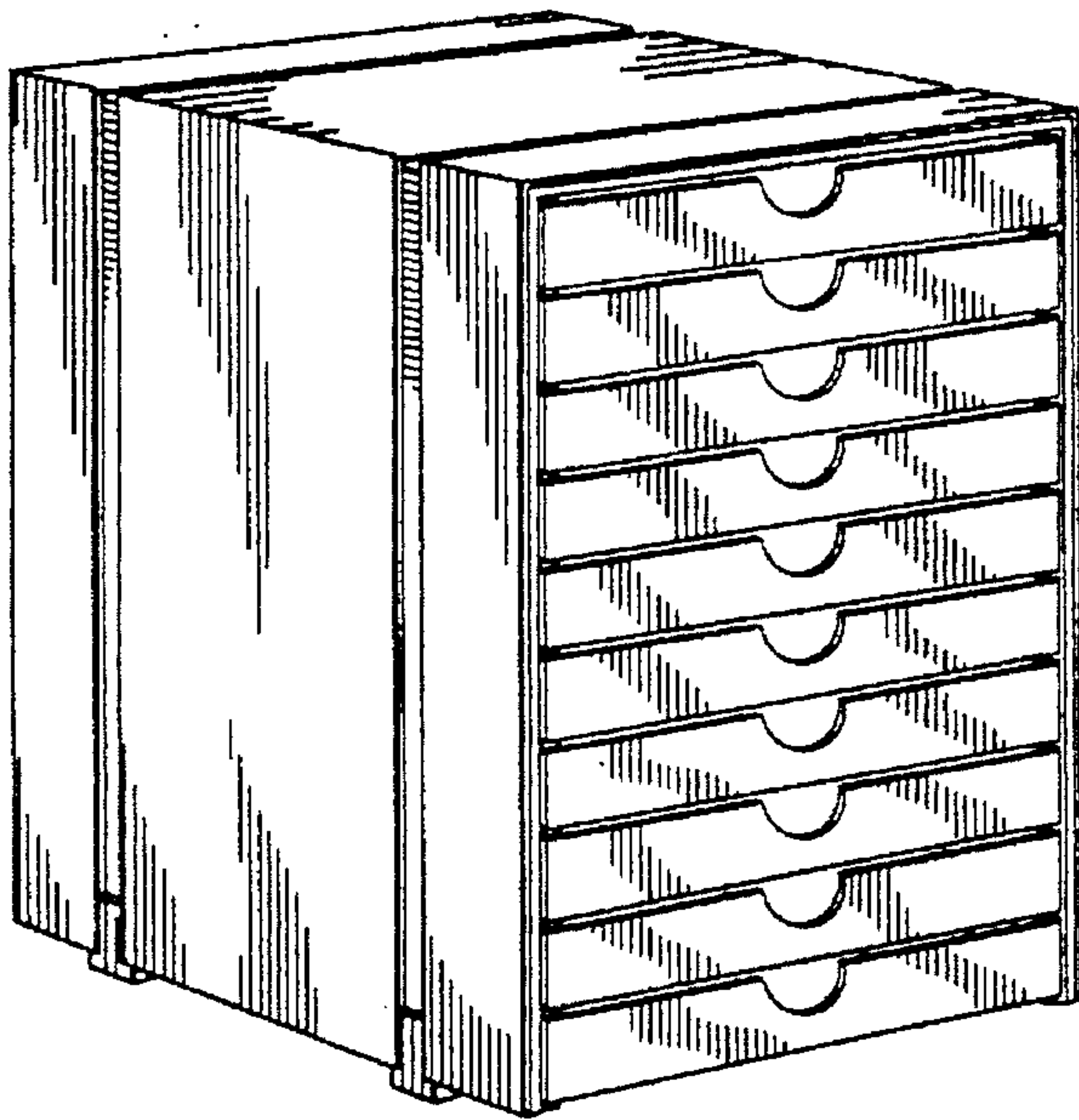

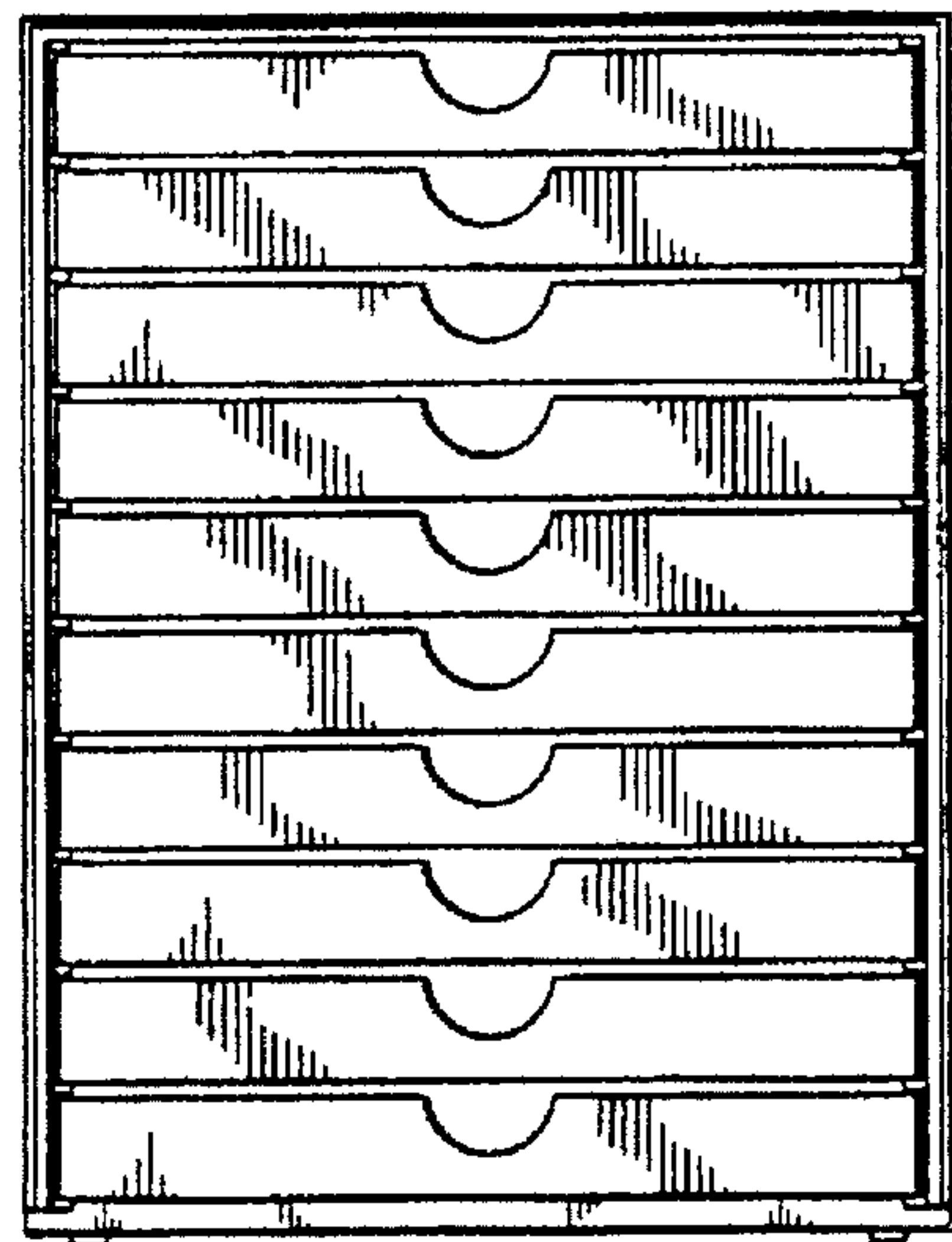

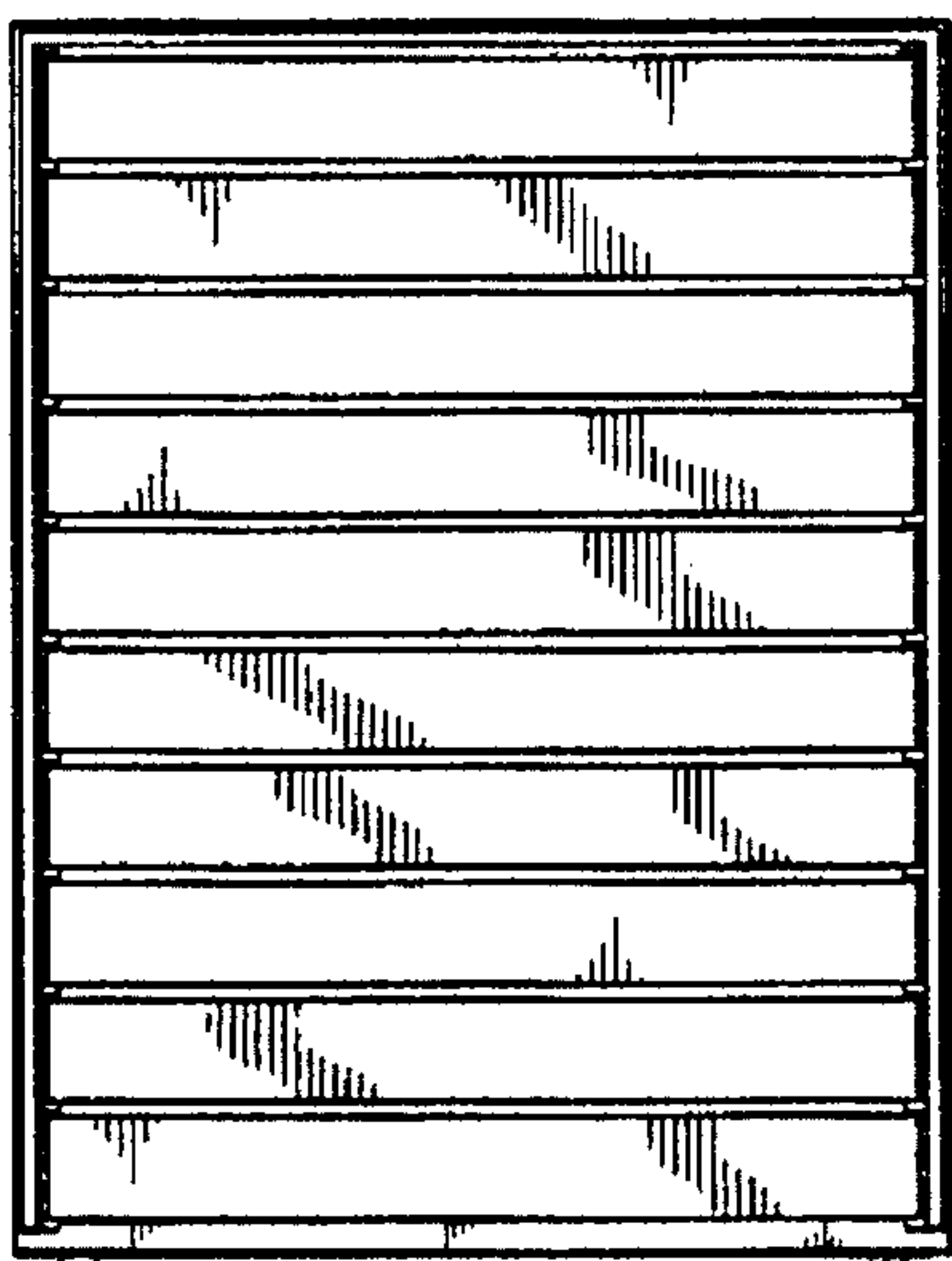

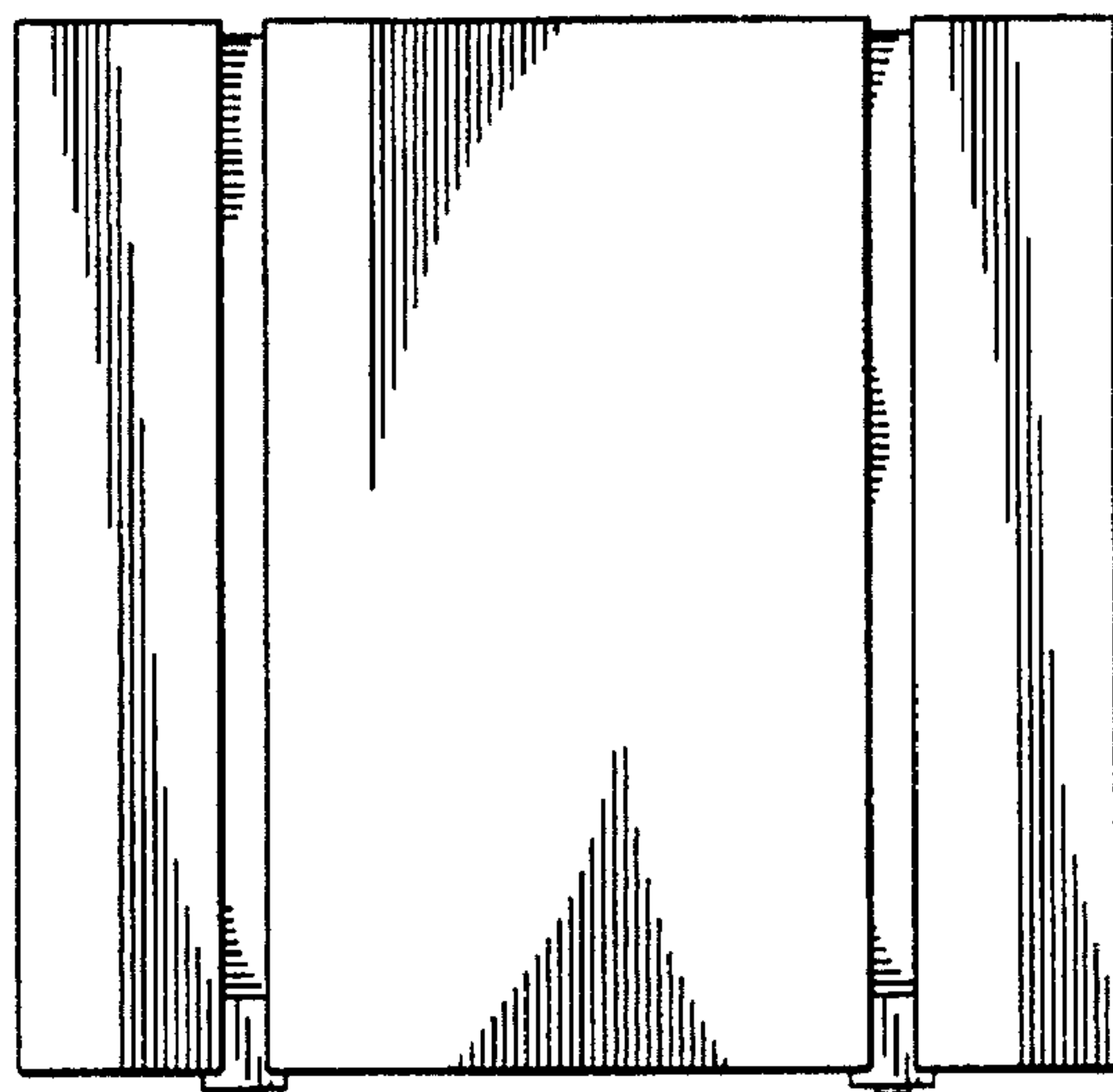

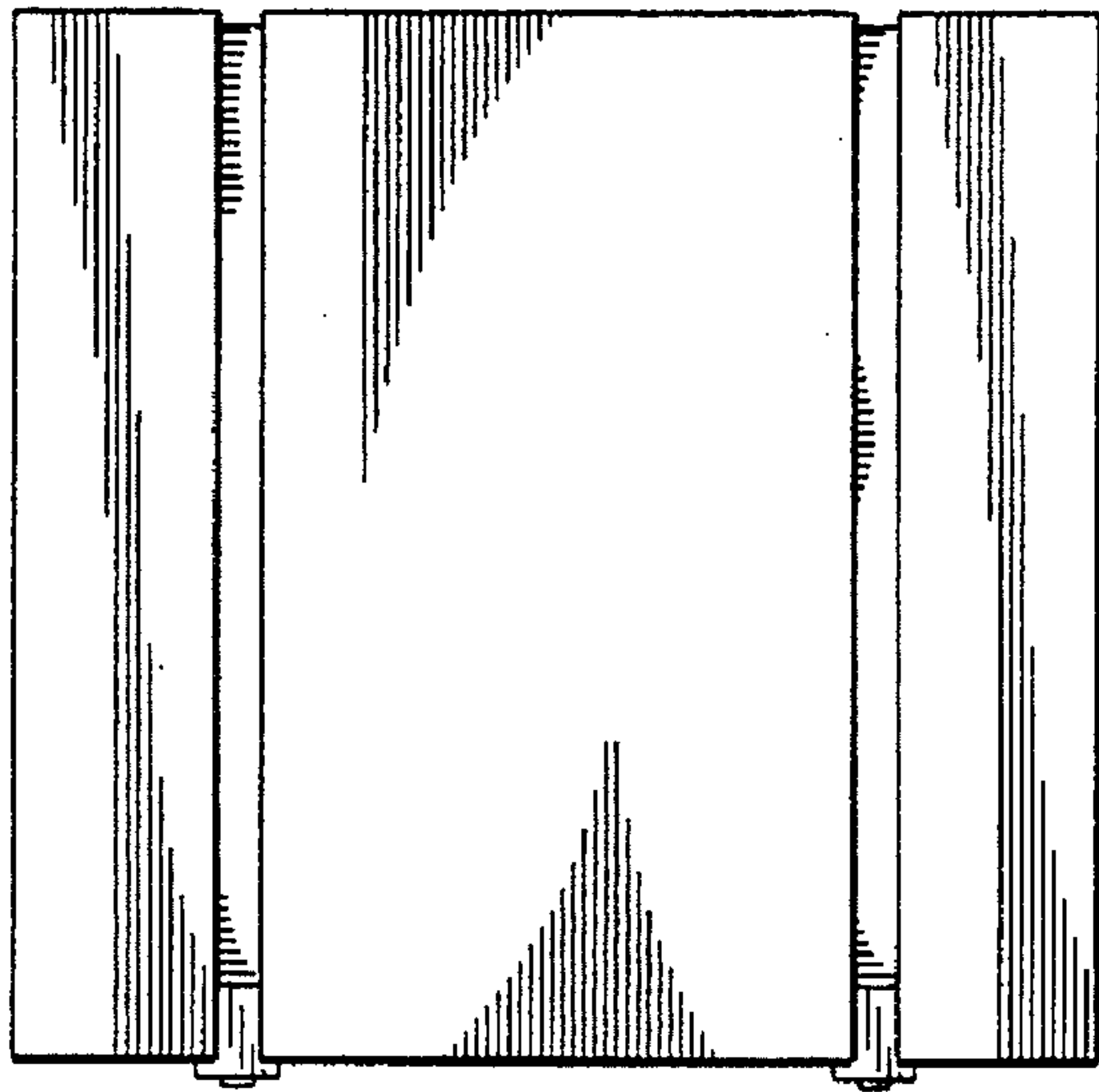

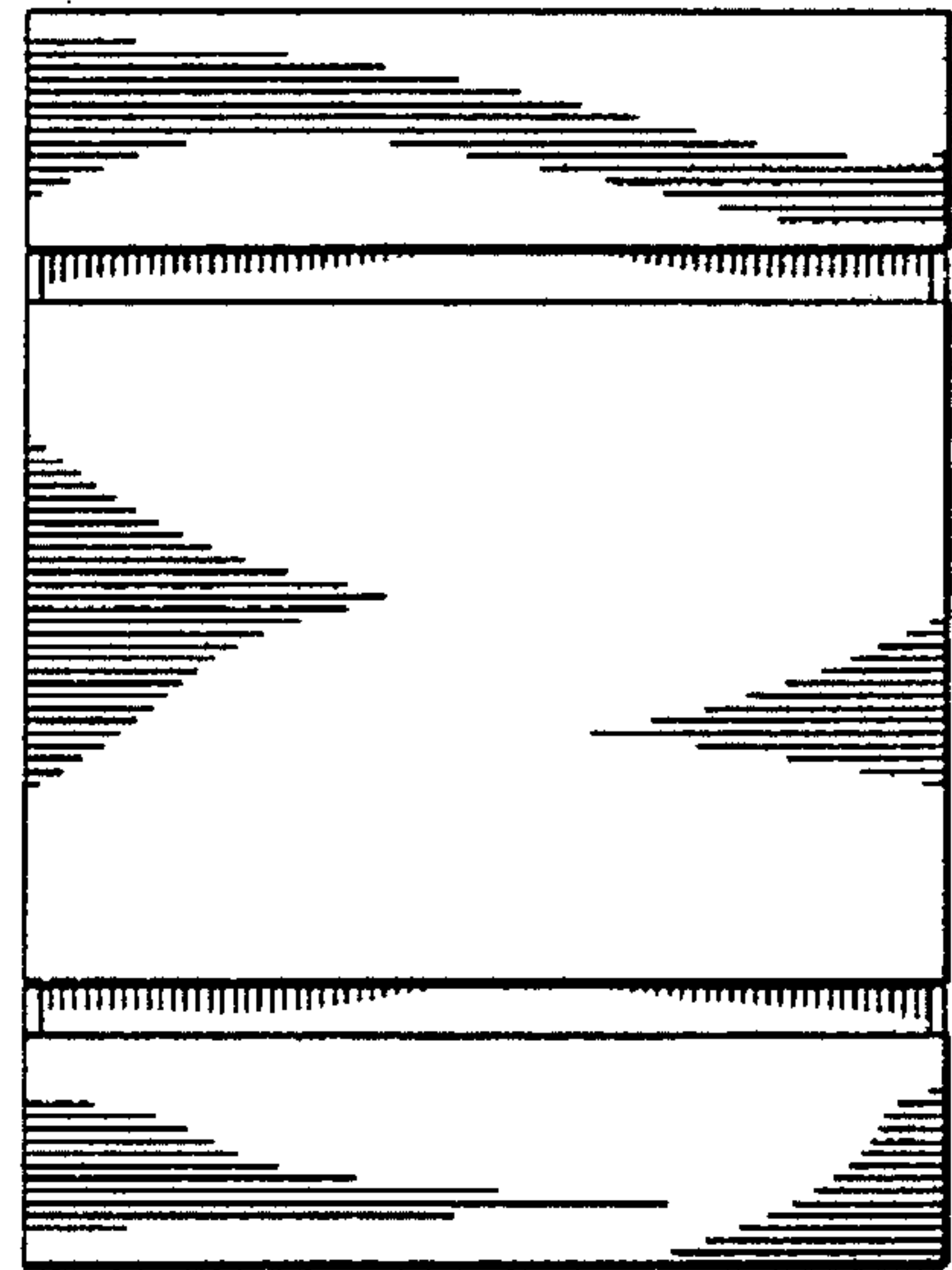

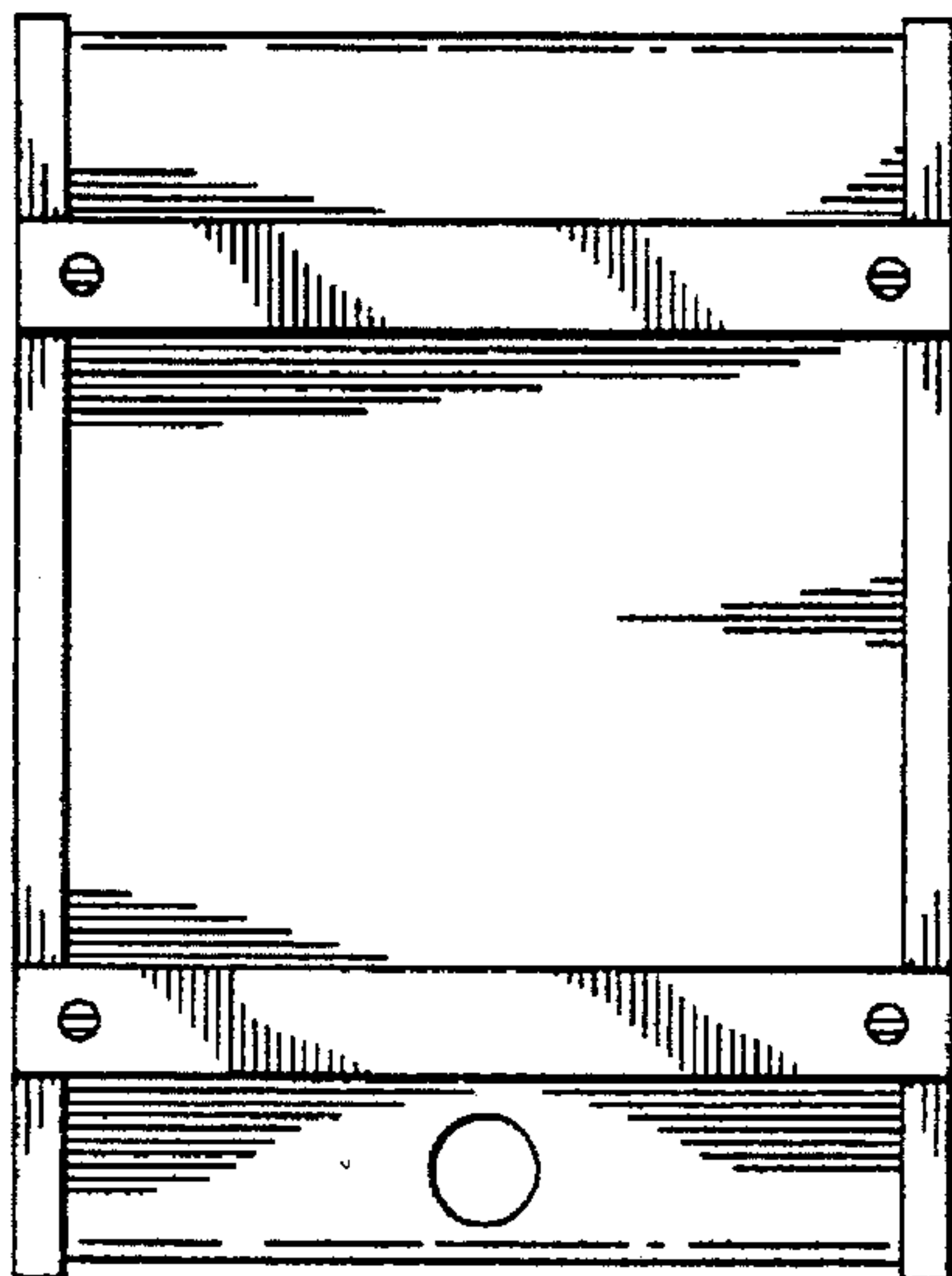

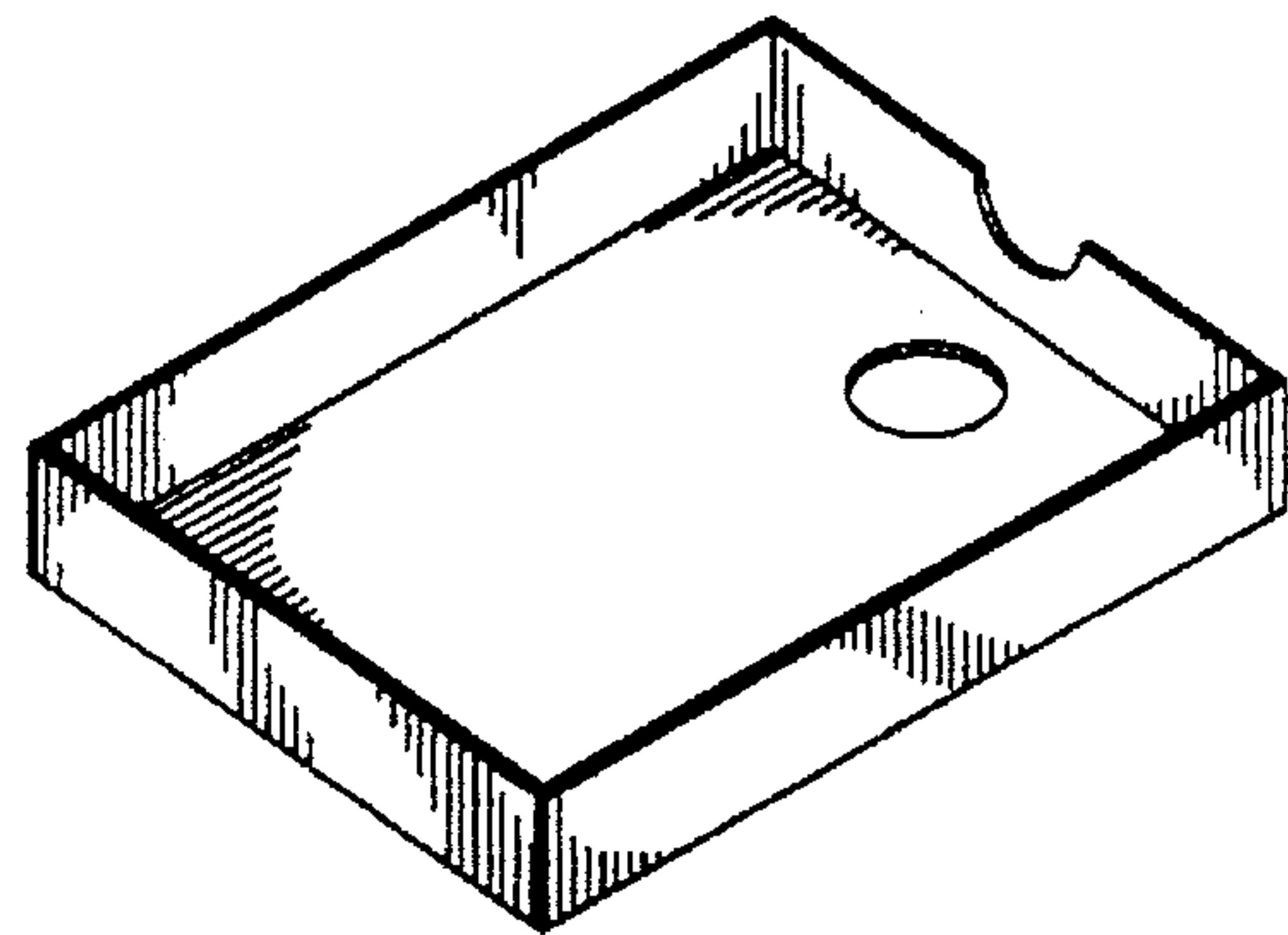

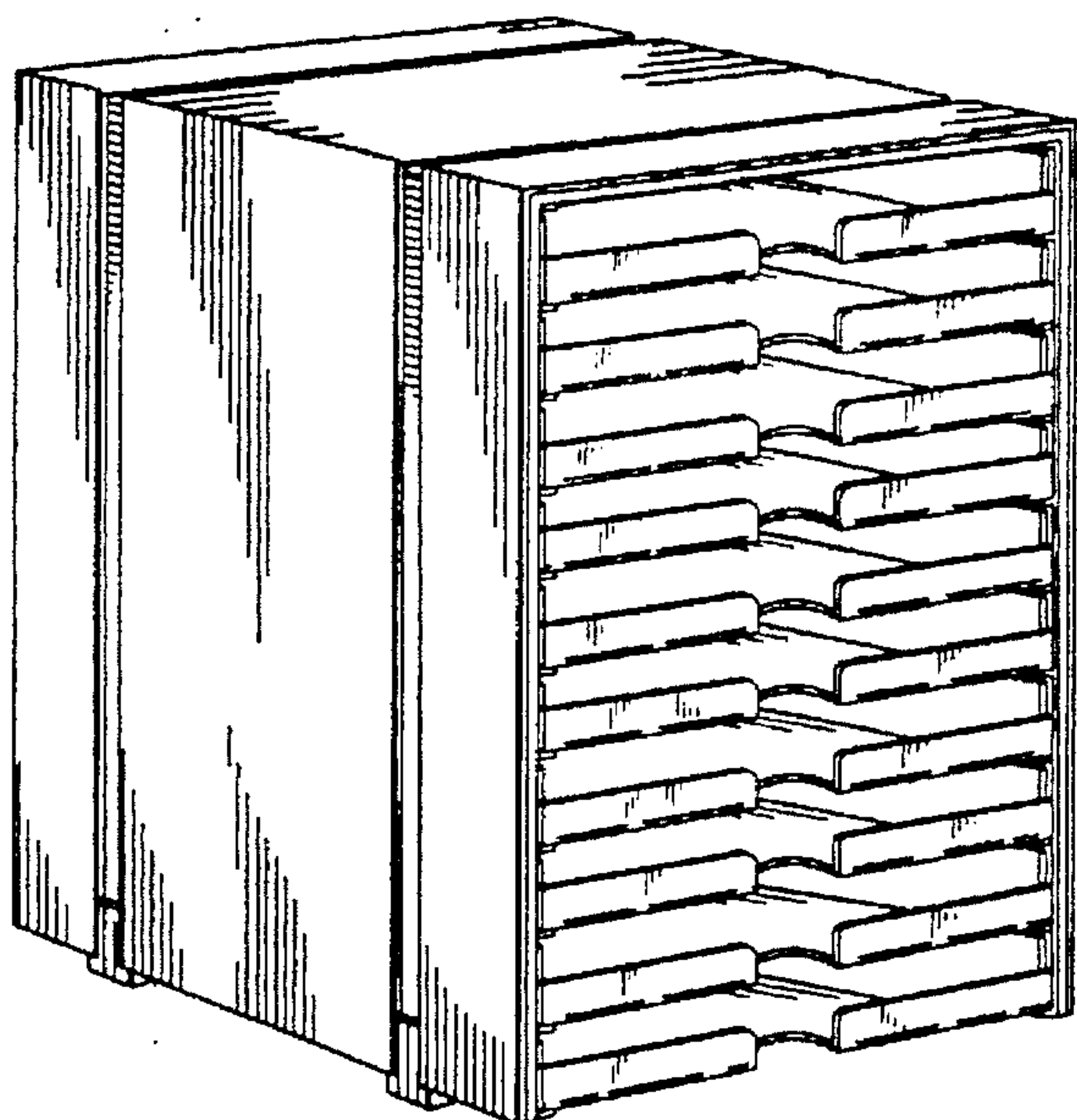

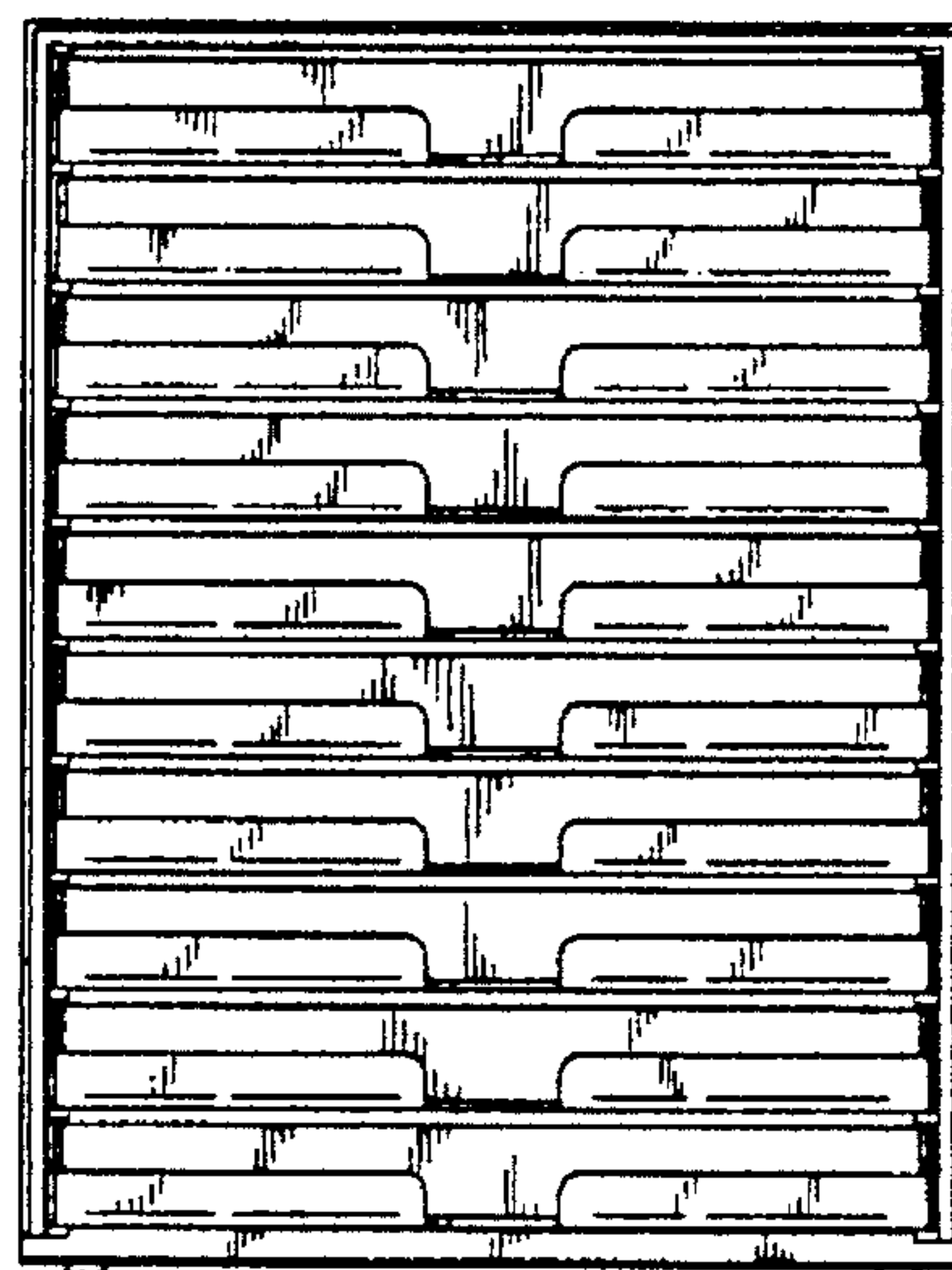

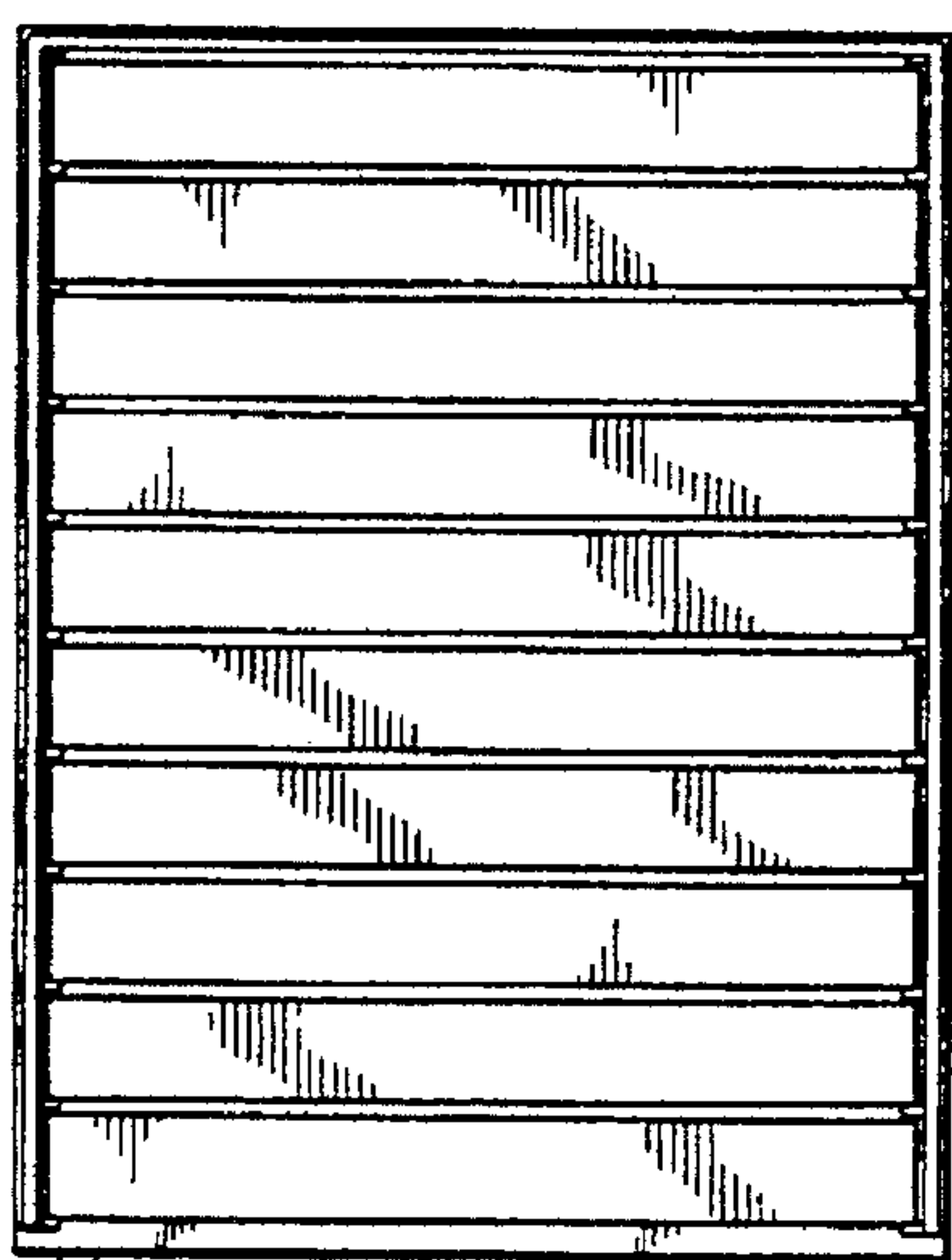

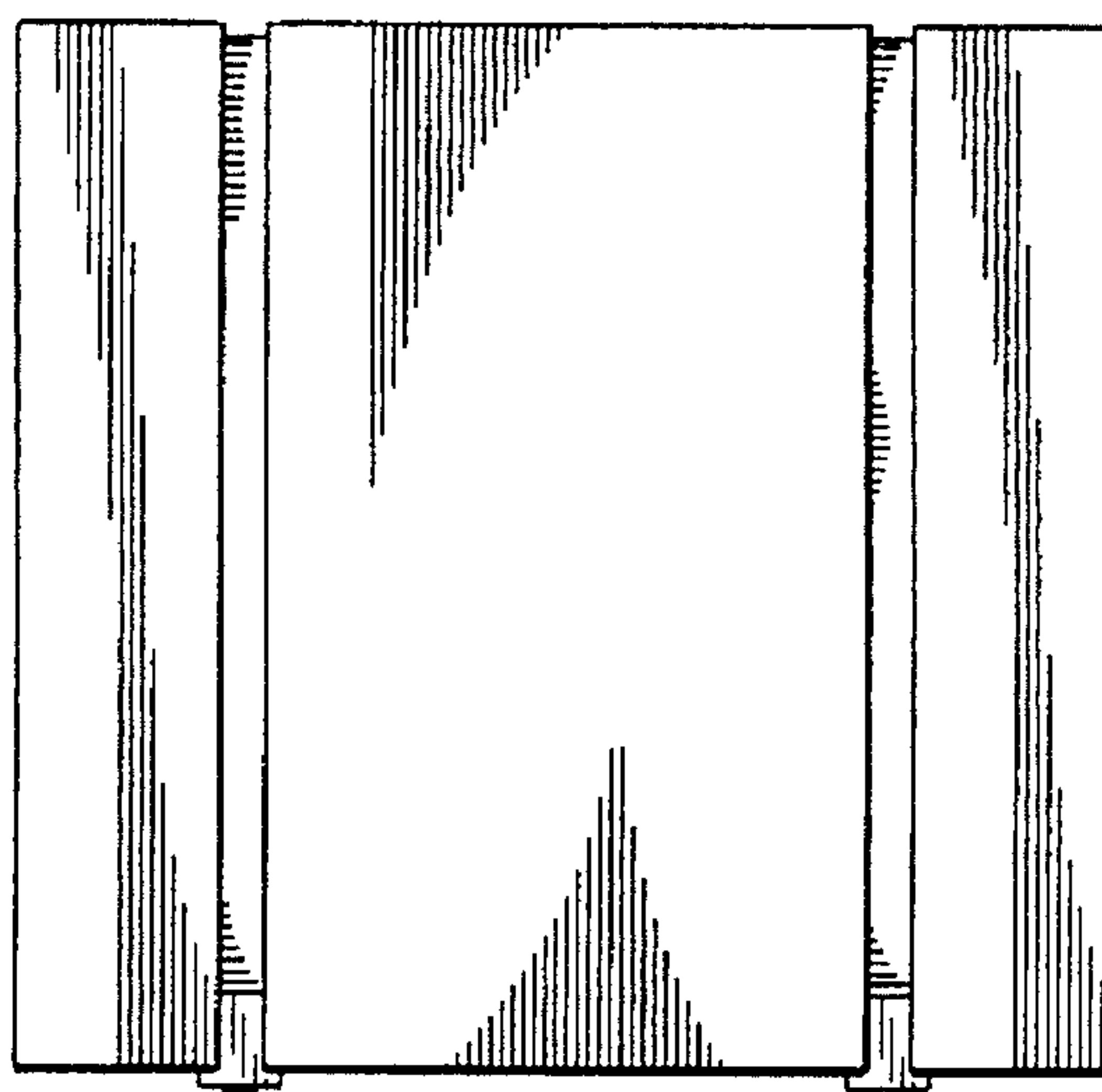

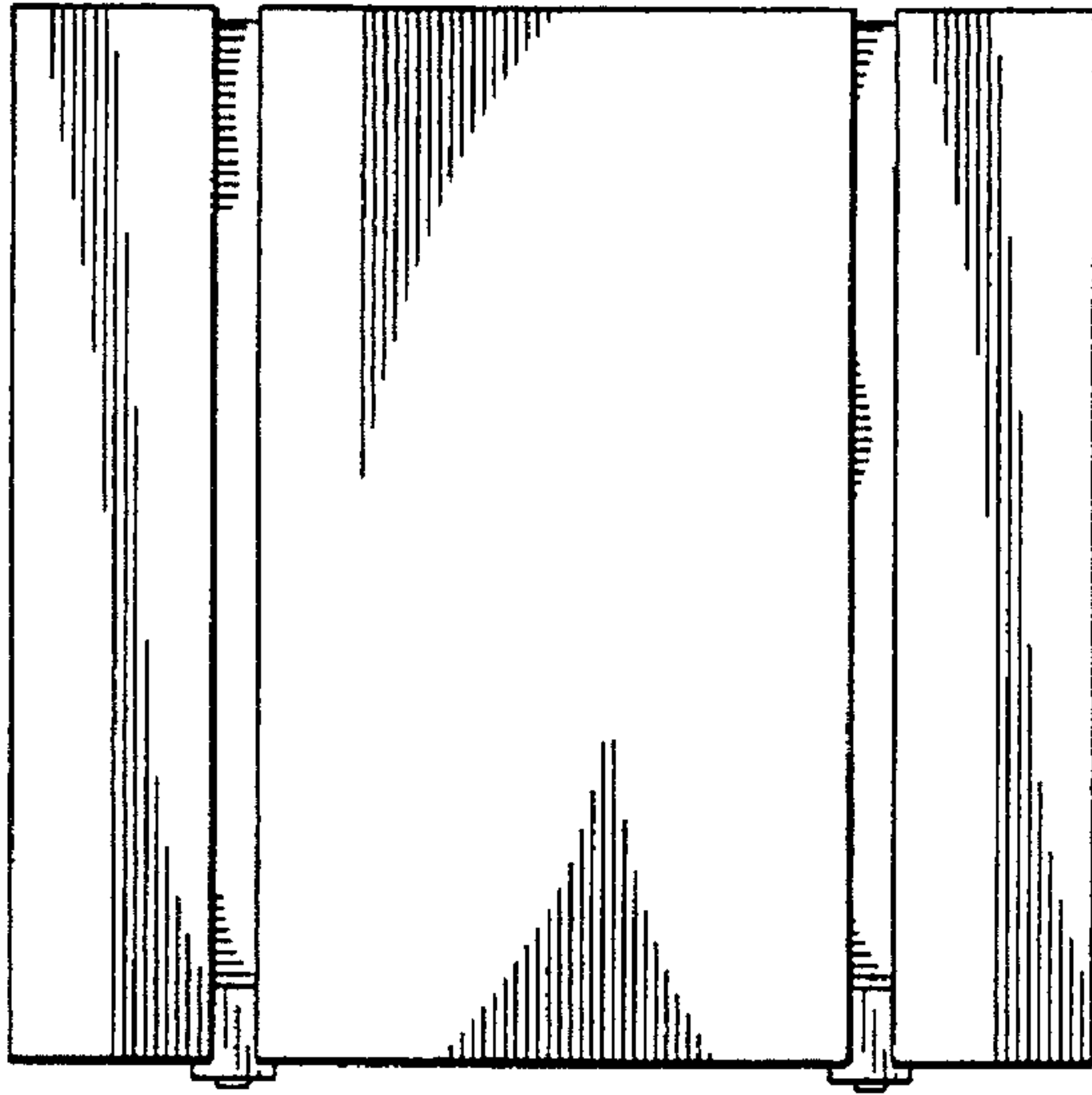

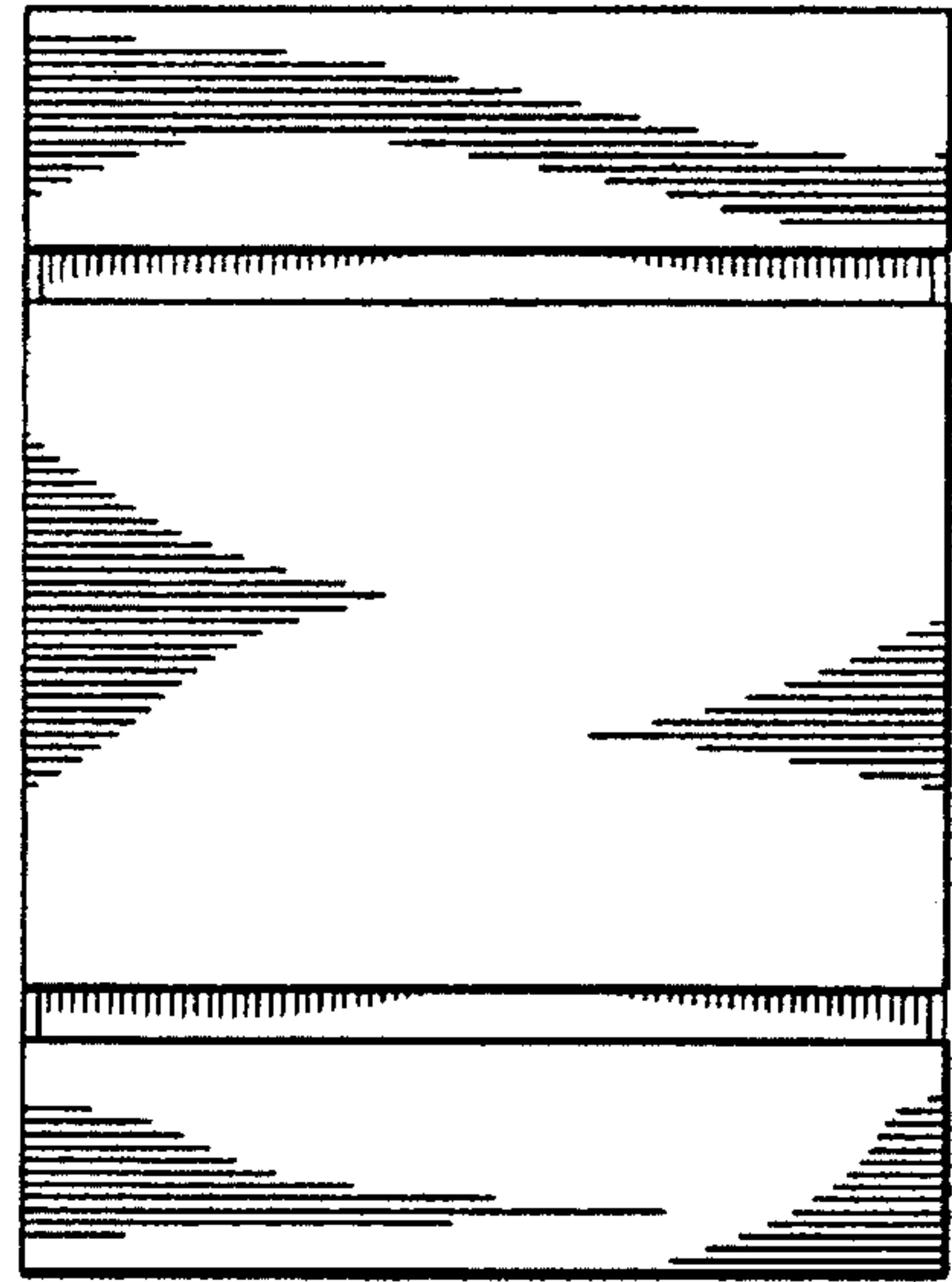

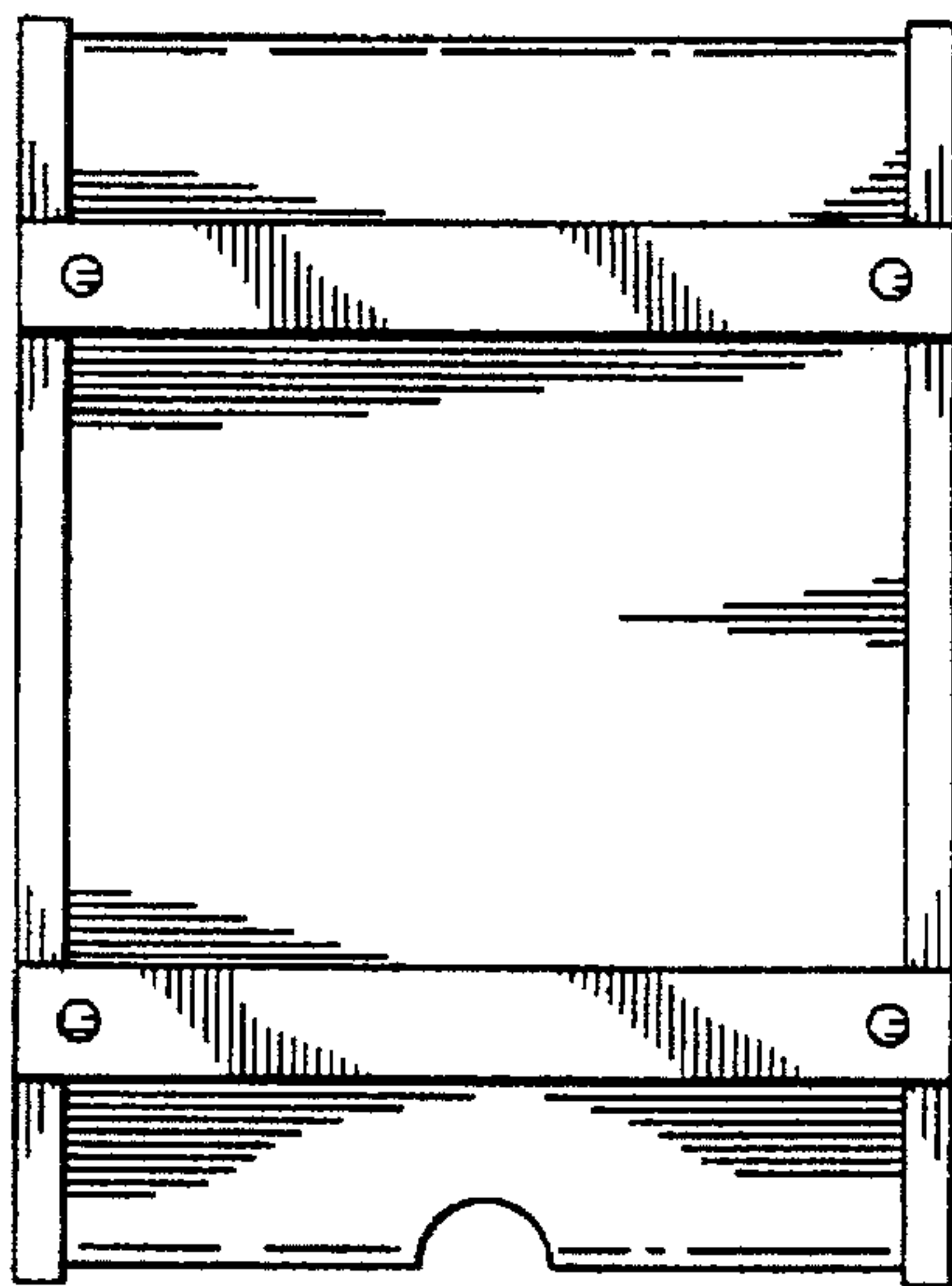

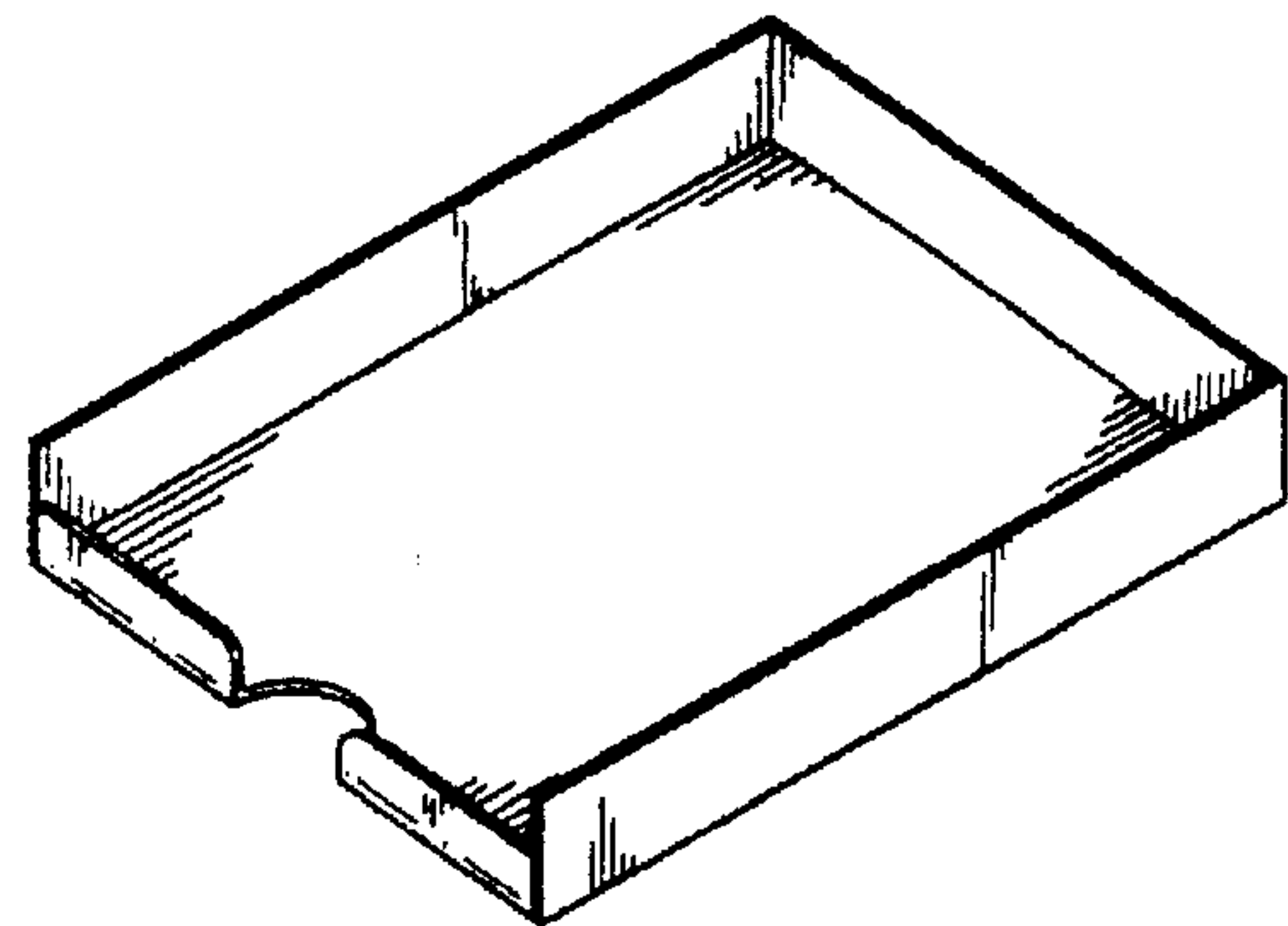
