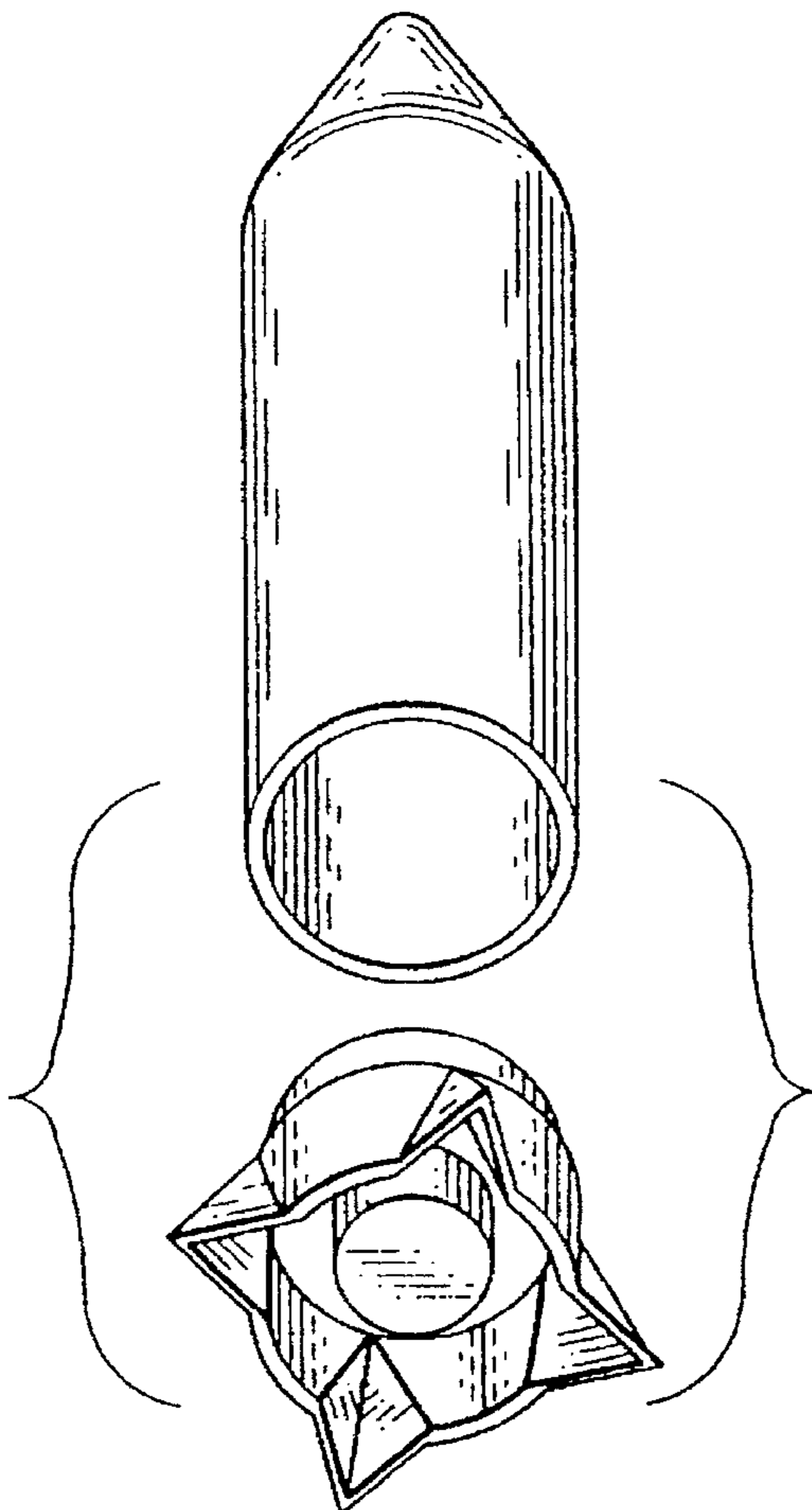
[57] **CLAIM**

The ornamental design for packaging for fingernail products, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the assembled packaging of this design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front elevation of the packaging of this design. Side and rear elevations are mirror images thereof;  
FIG. 5 is a top plan view of the cap portion of this design;  
FIG. 6 is a perspective view of the cap portion of this design; and,  
FIG. 7 is a bottom exploded perspective view of the housing portion and of the cap portion of this packaging of this design.

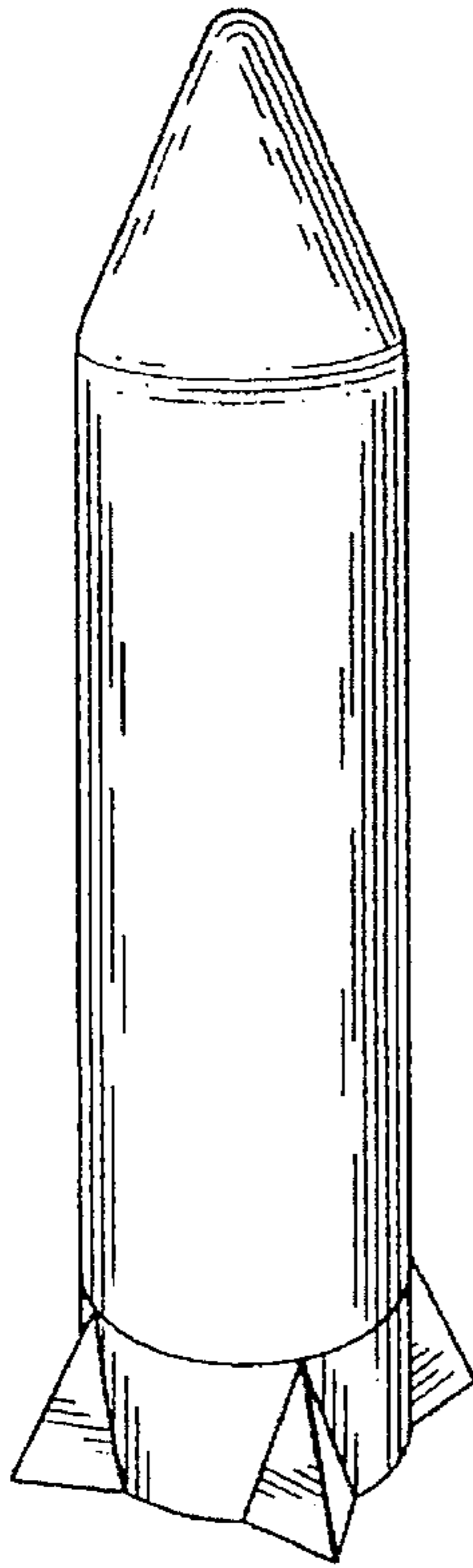

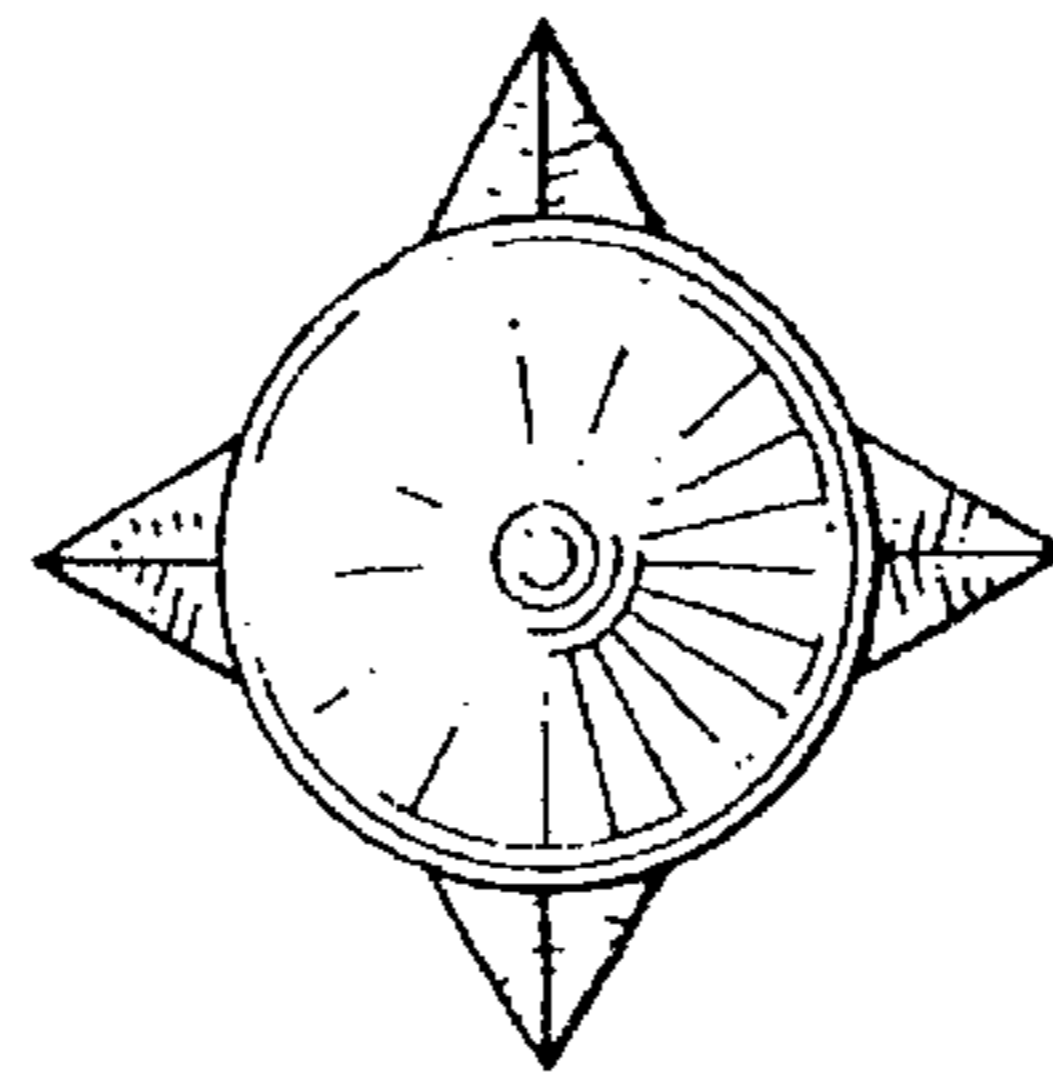

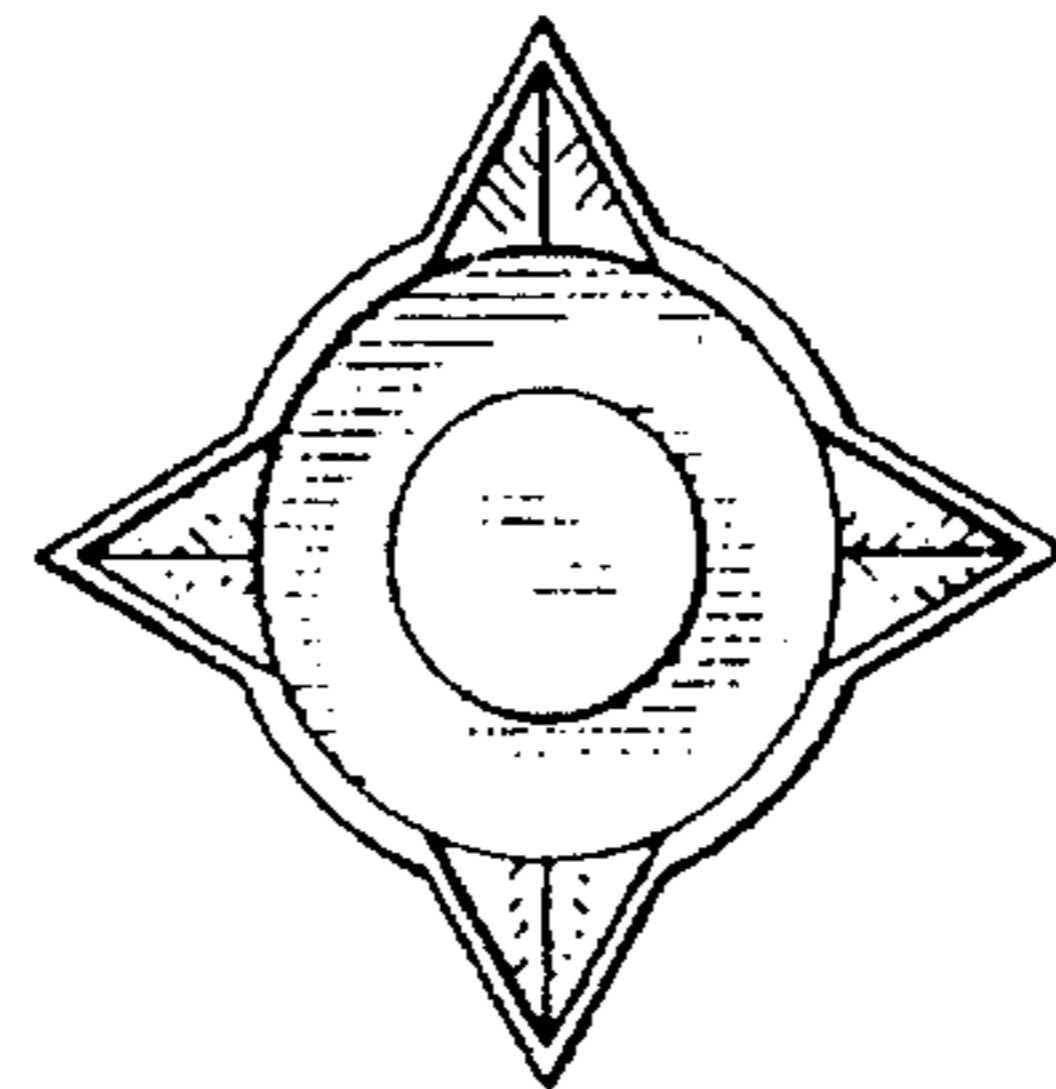

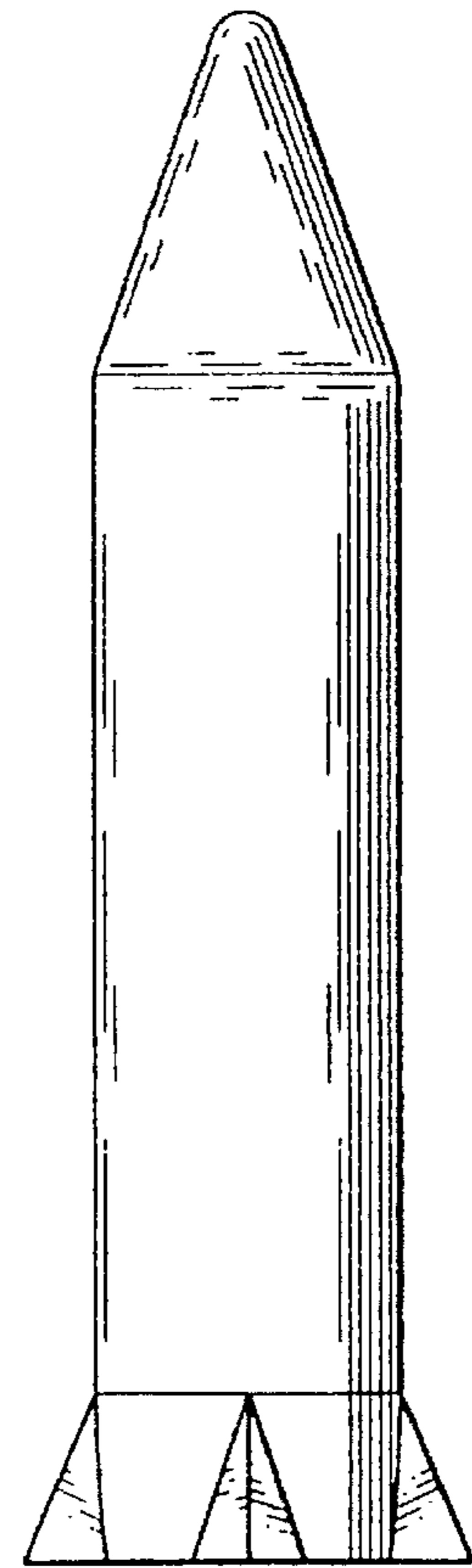

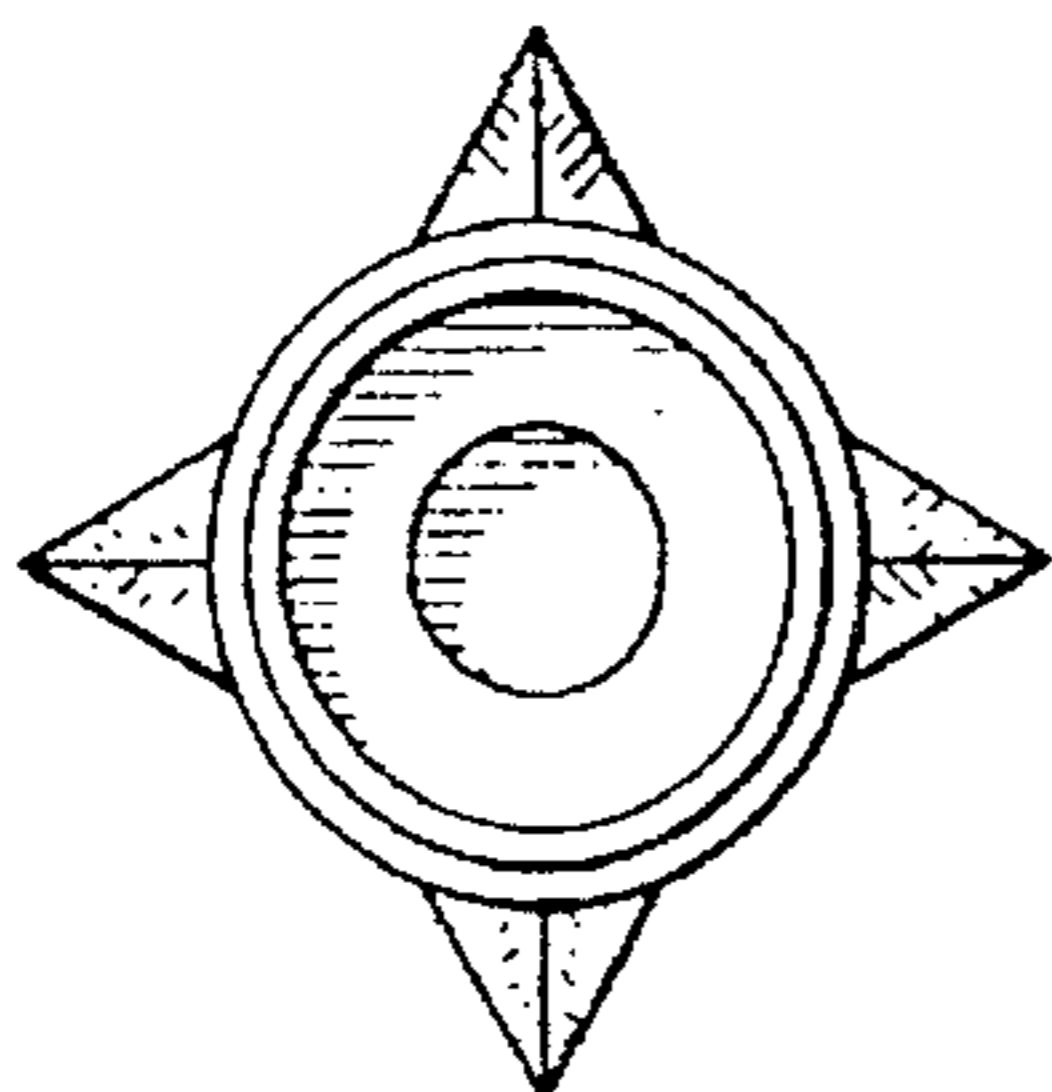

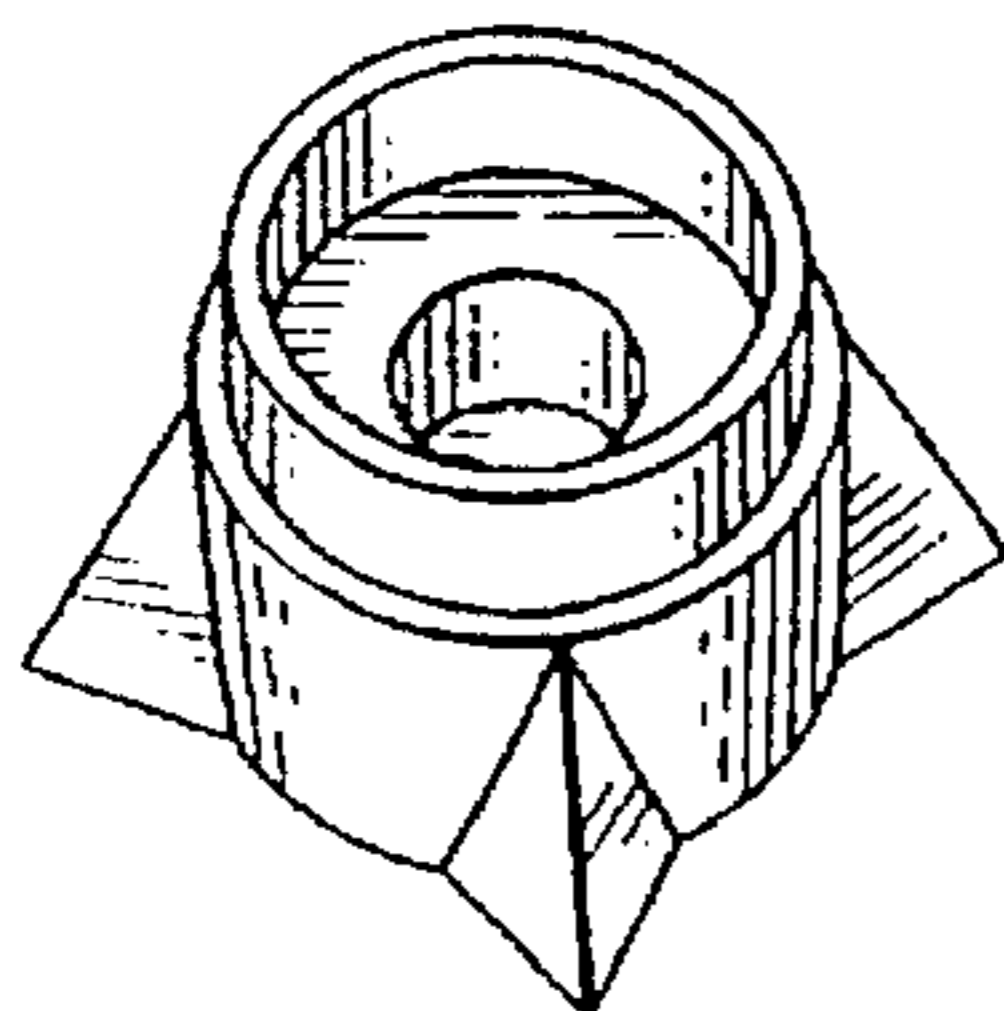
