[57] **CLAIM**

The ornamental design for a combined bottle and cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined bottle and cap, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side elevational view thereof; its other side being a mirror copy of this view;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a perspective view of the first variant of my design;

FIG. 7 is a front elevational view of the first variant;

FIG. 8 is a side elevational view of the first variant, the view of the other side being a mirror copy of this view;

FIG. 9 is a top view of the first variant;

FIG. 10 is a bottom plan view of the first variant;

FIG. 11 is a perspective view of a second variant of my design;

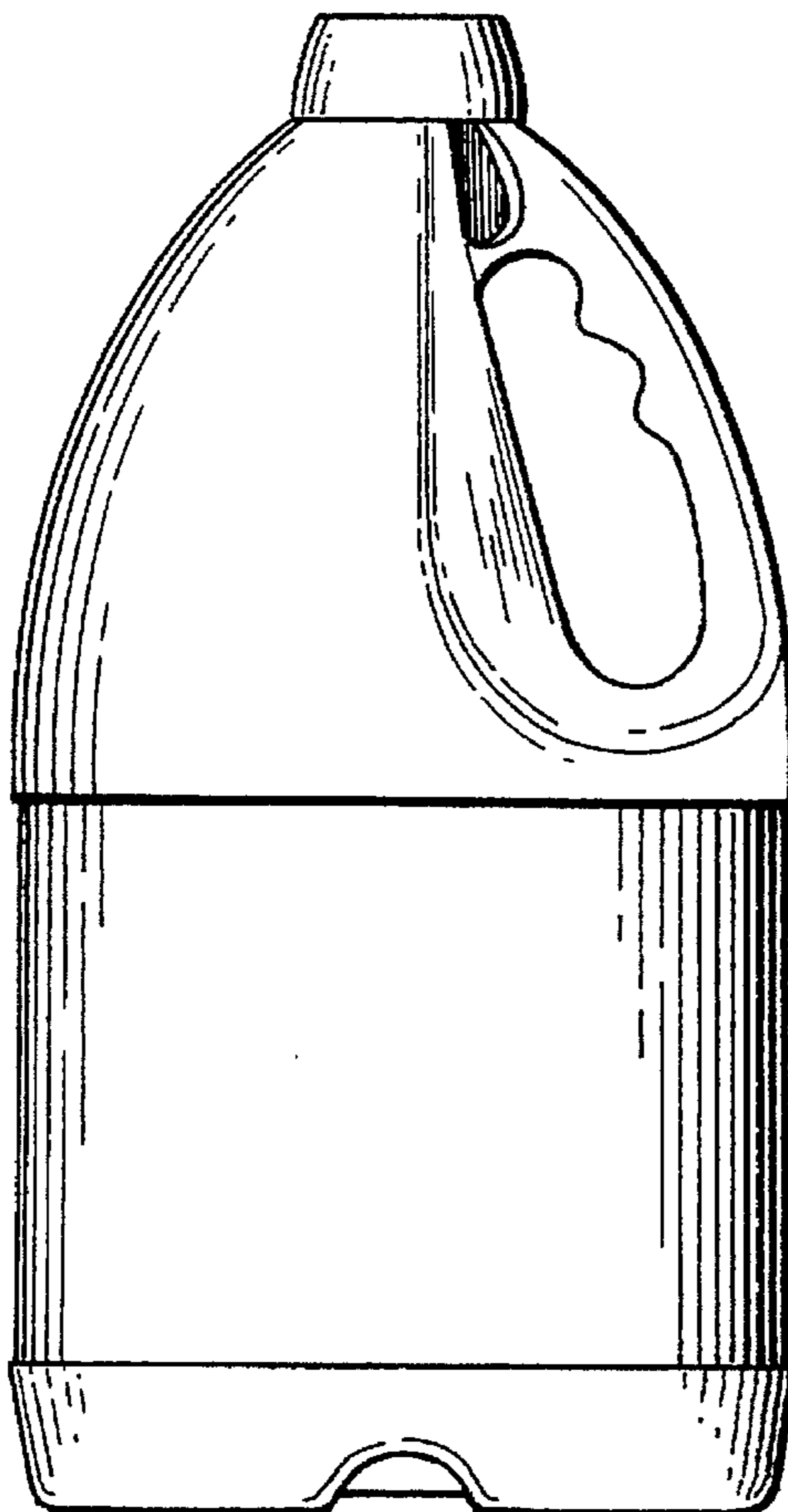
FIG. 12 is a front elevation view of the second variant;

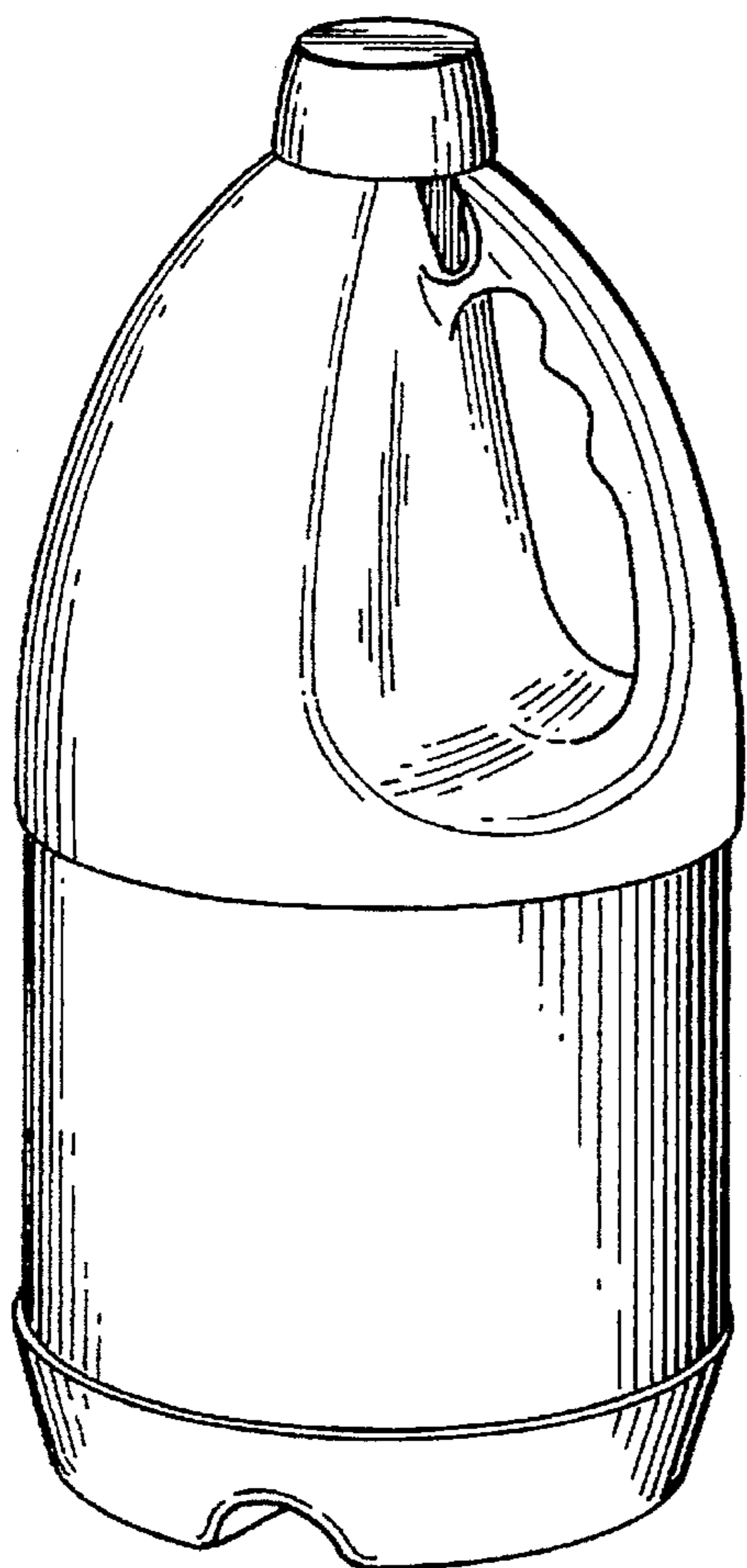

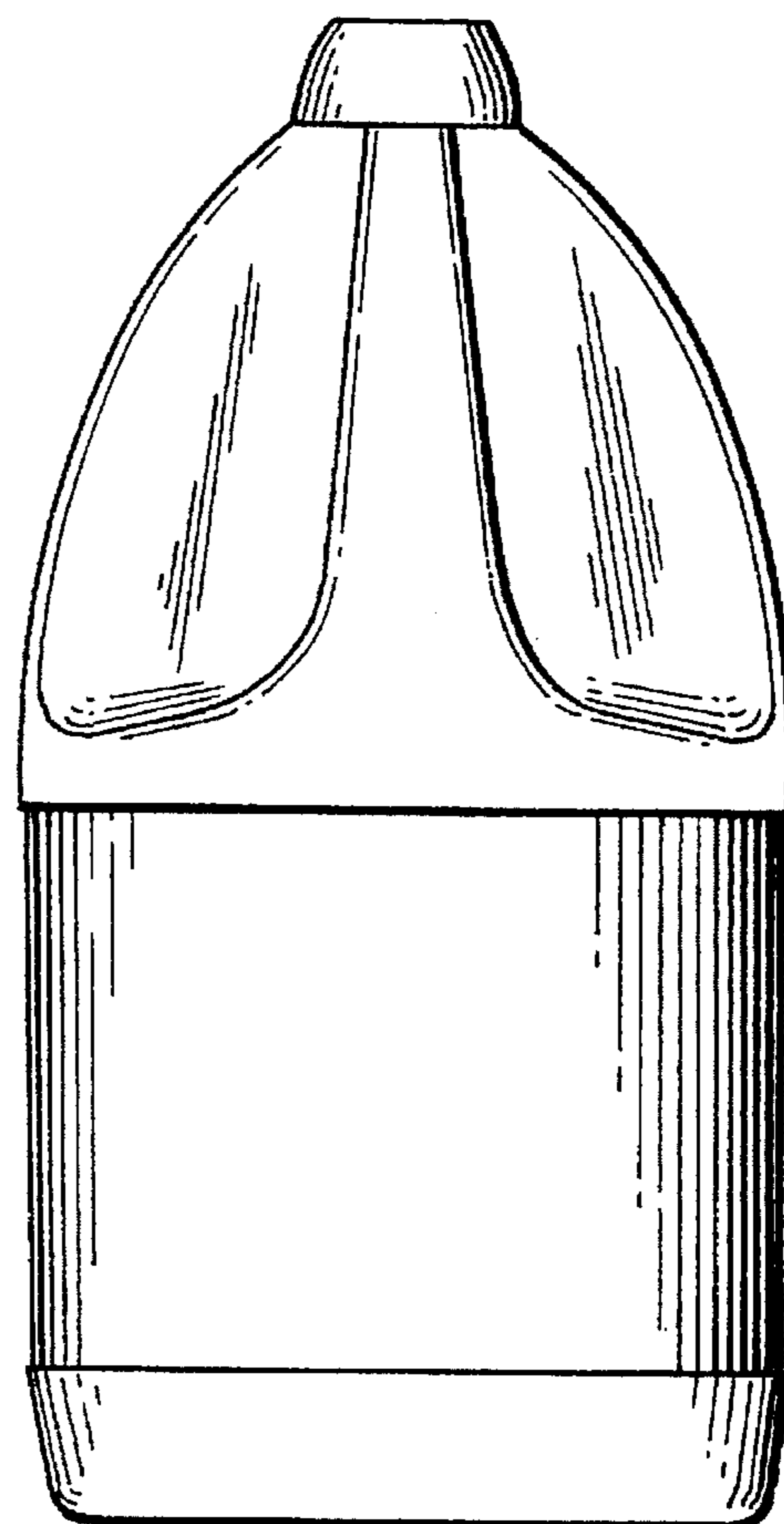

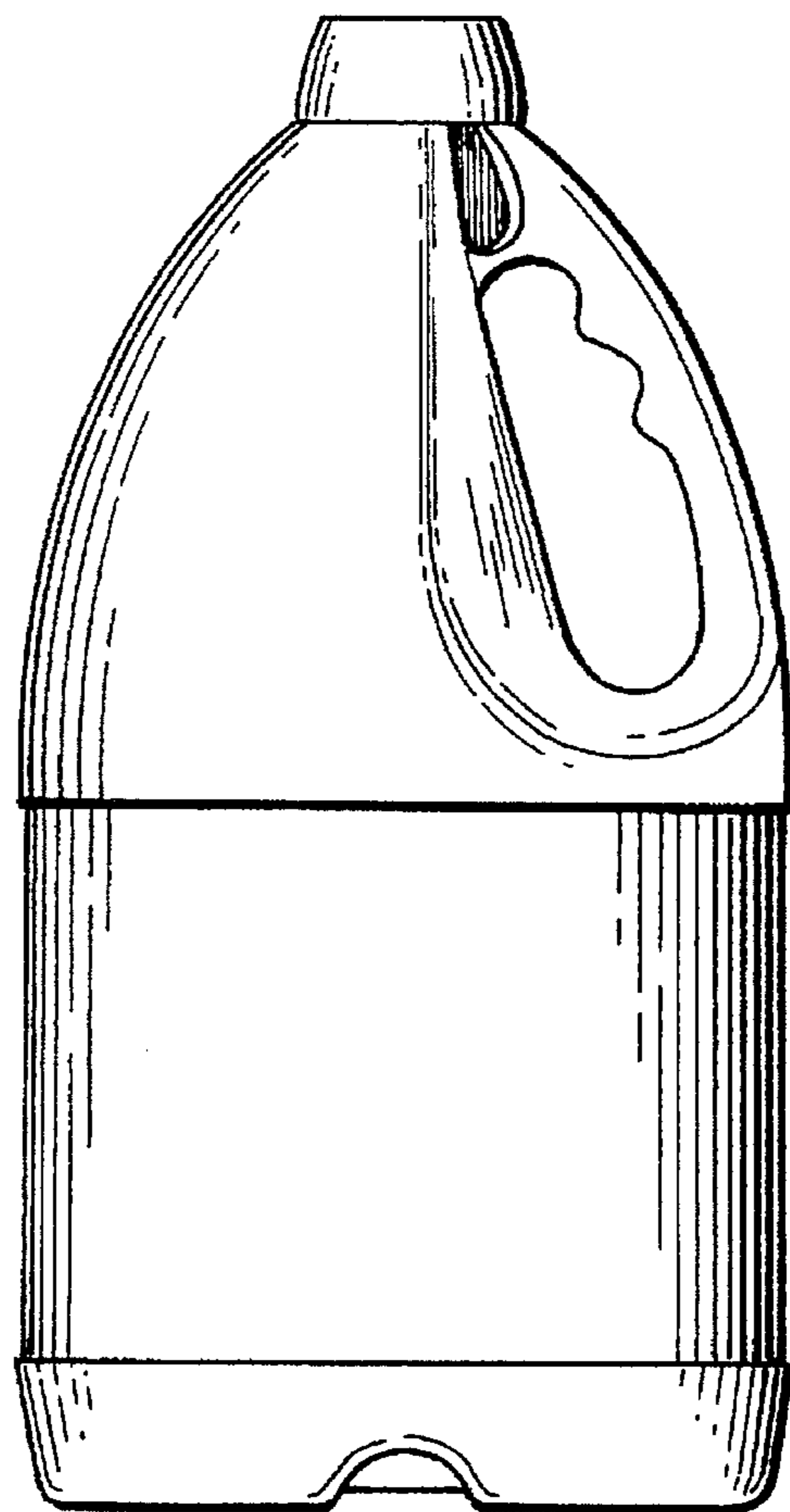

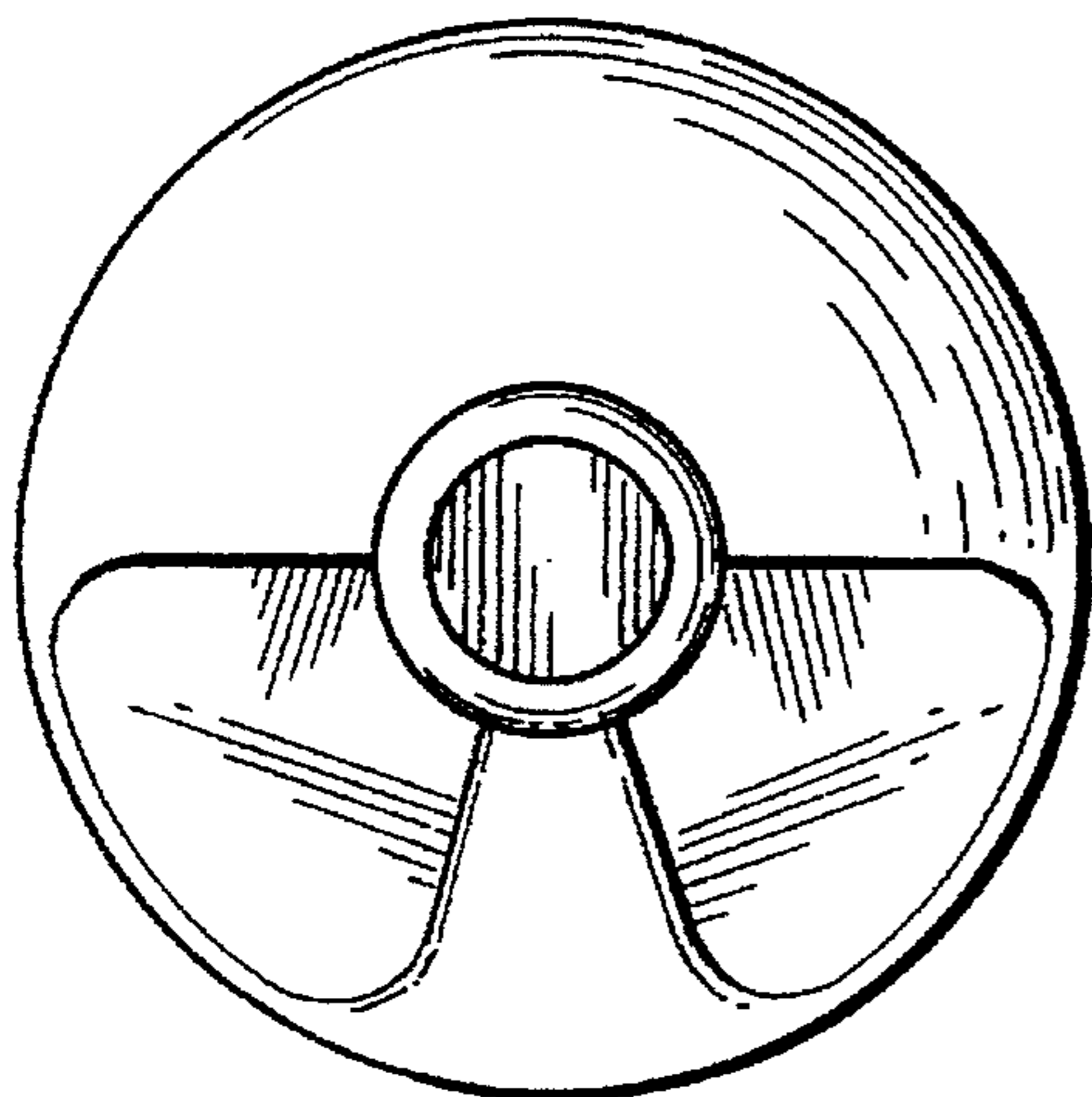

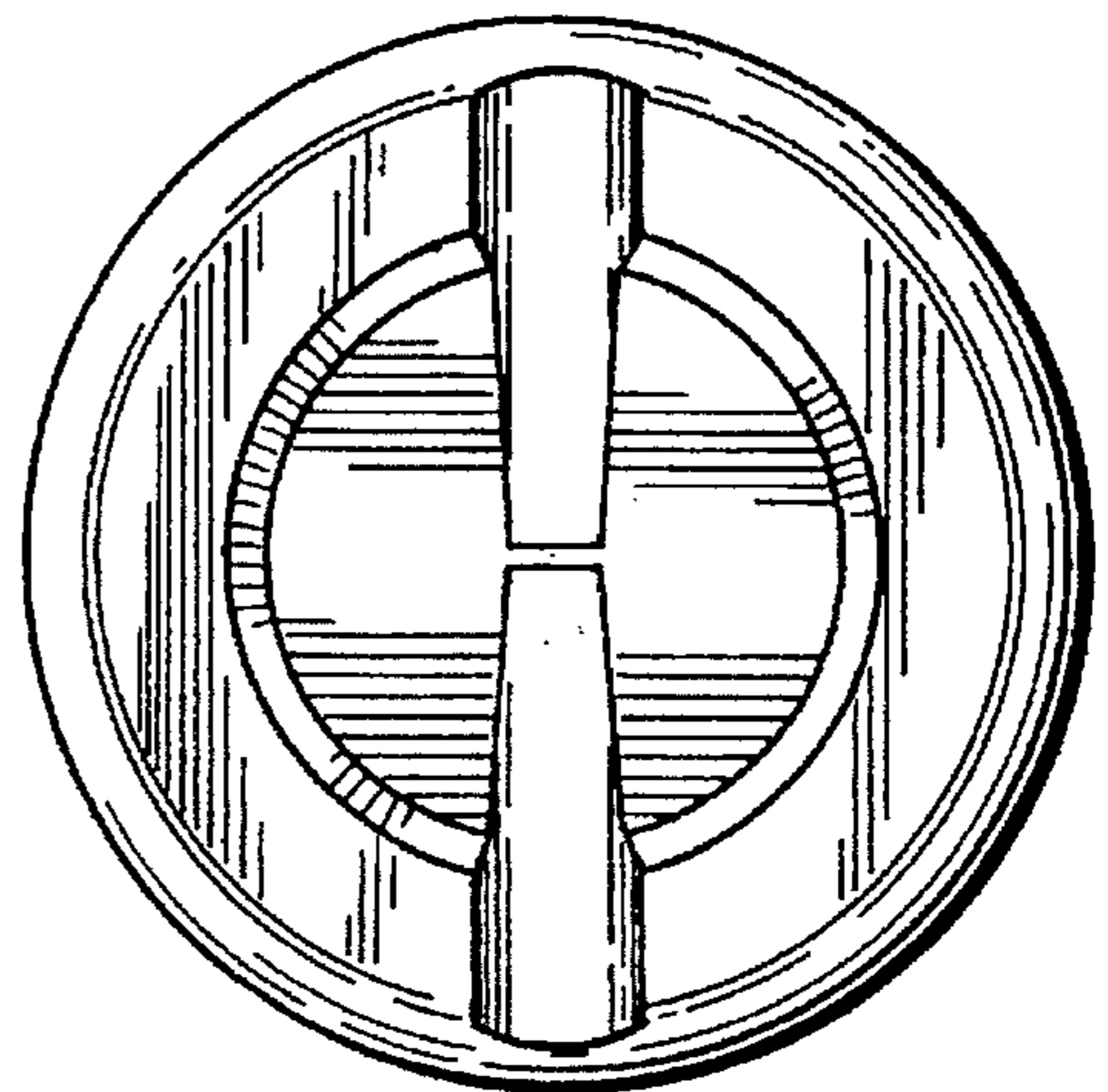

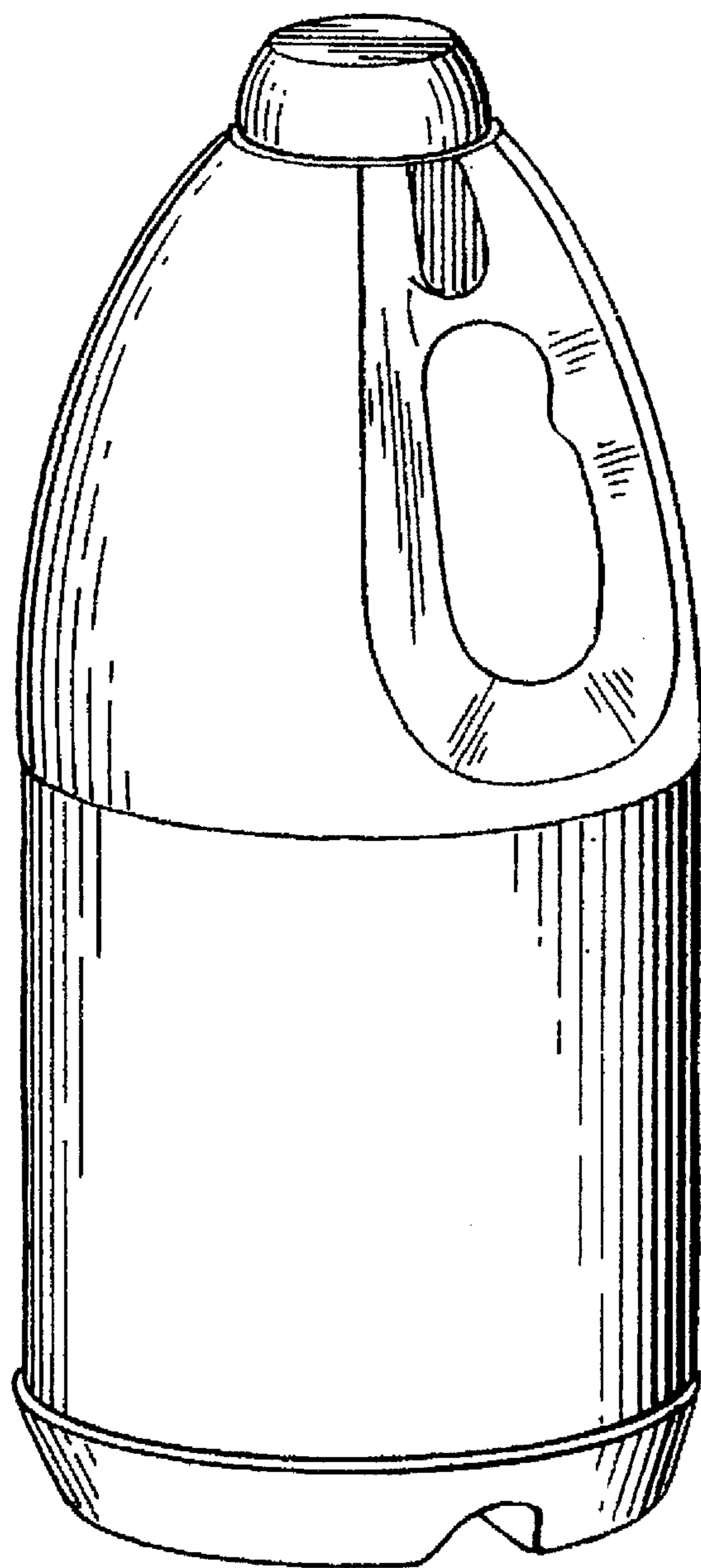

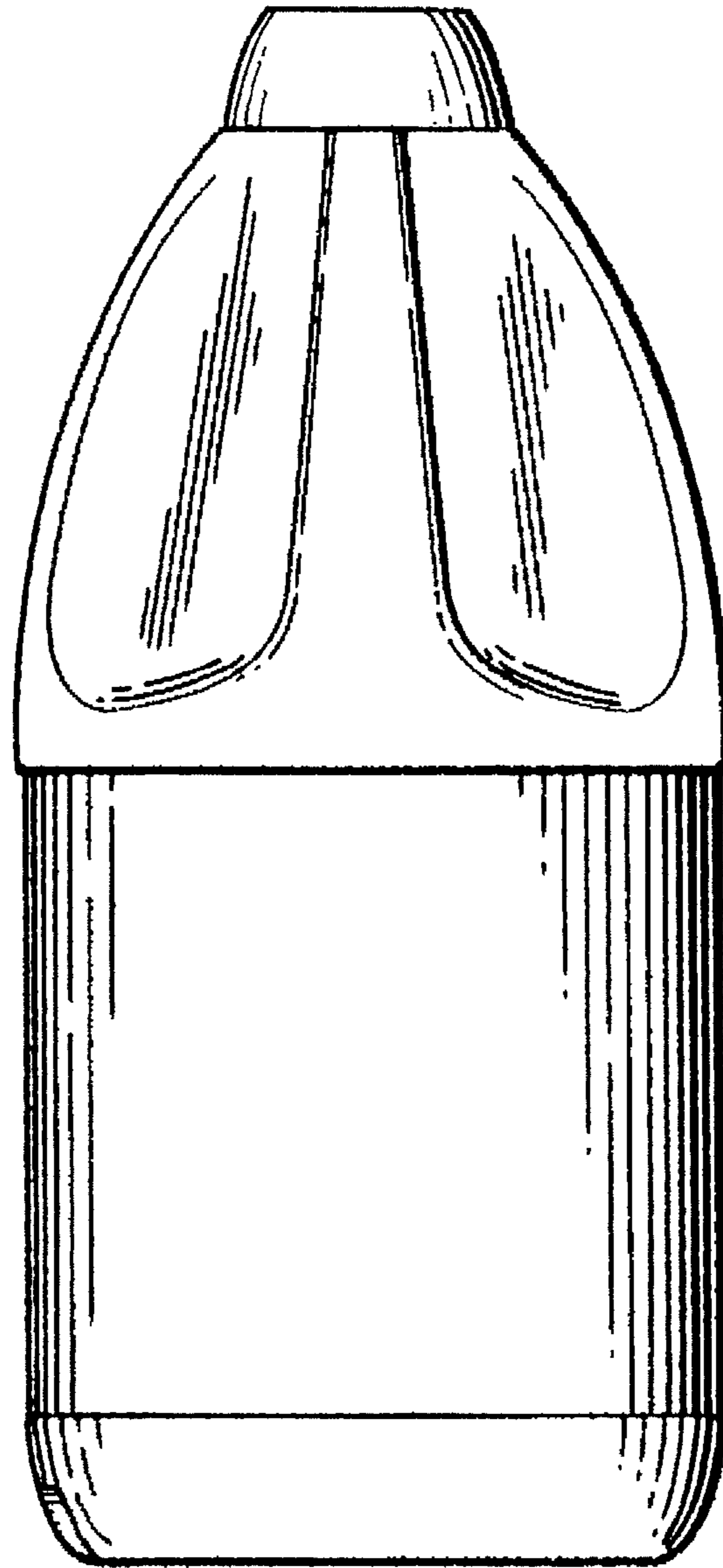

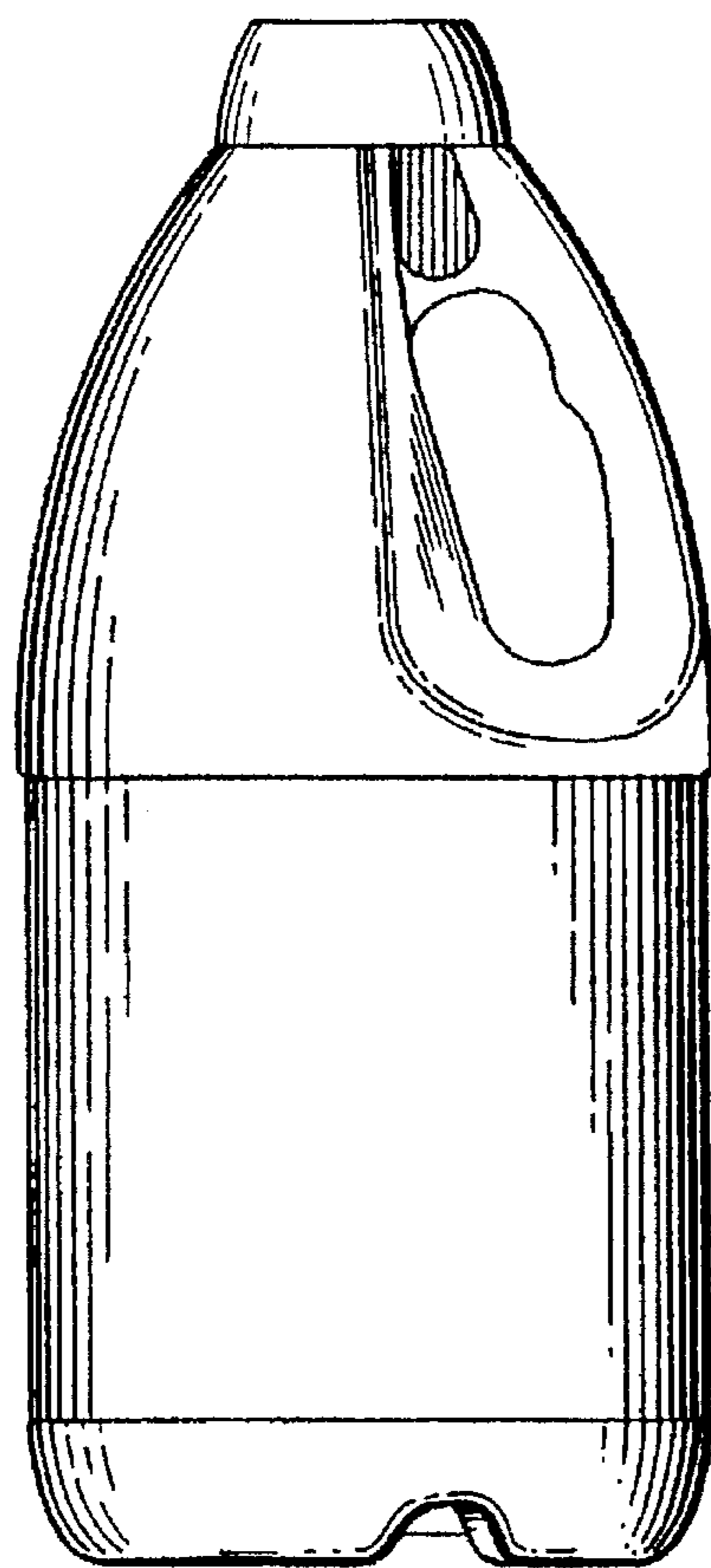

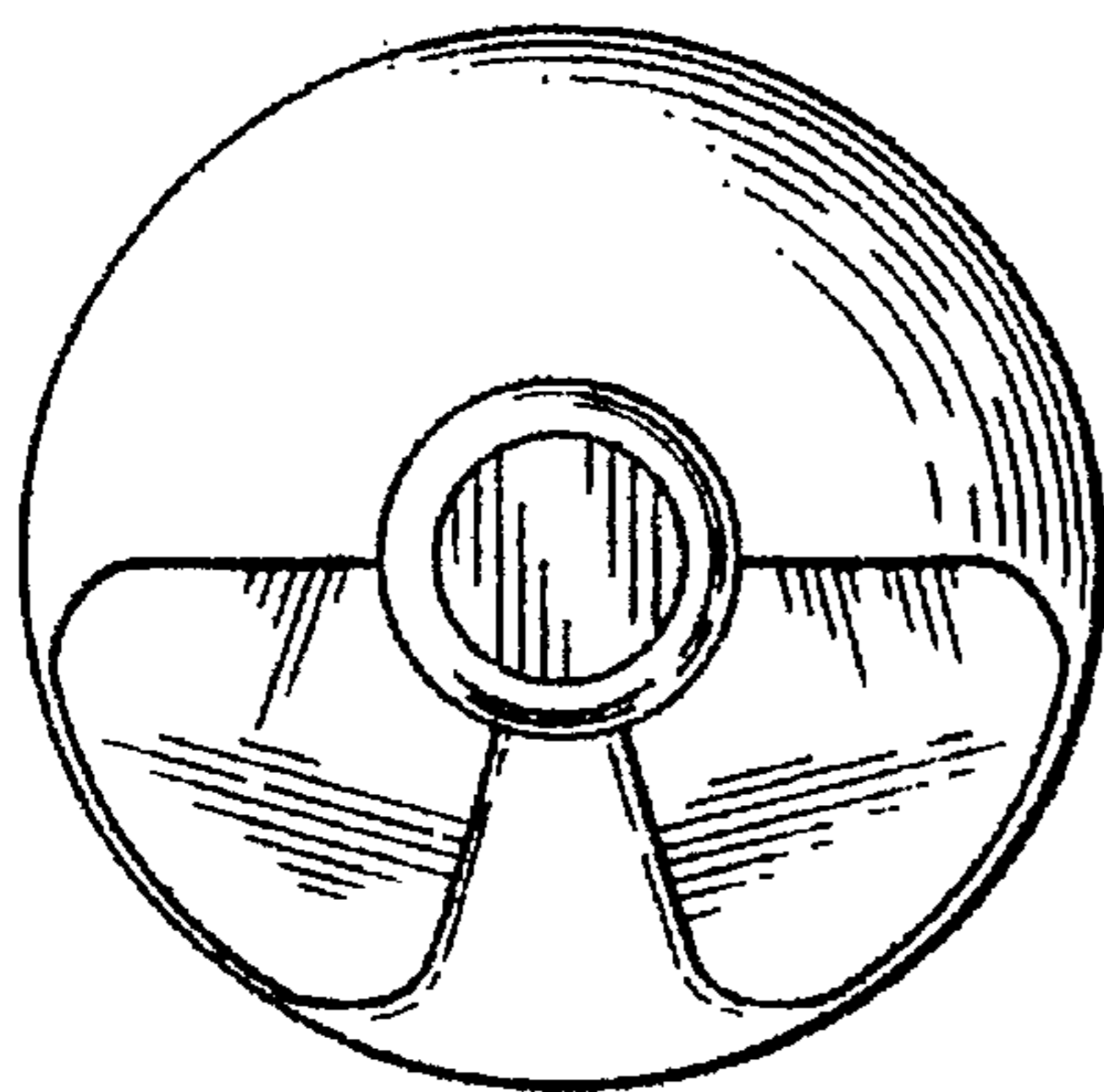

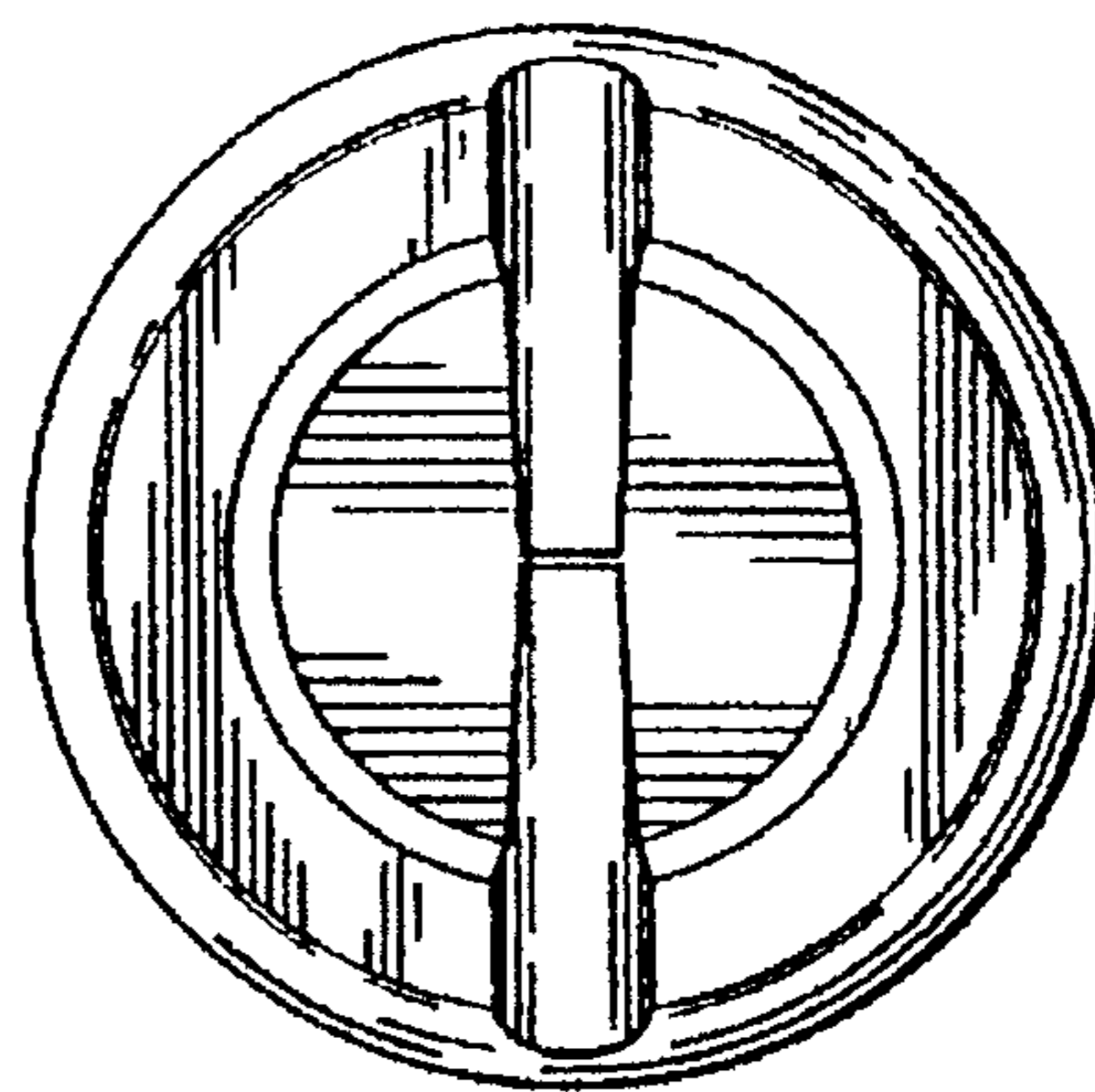

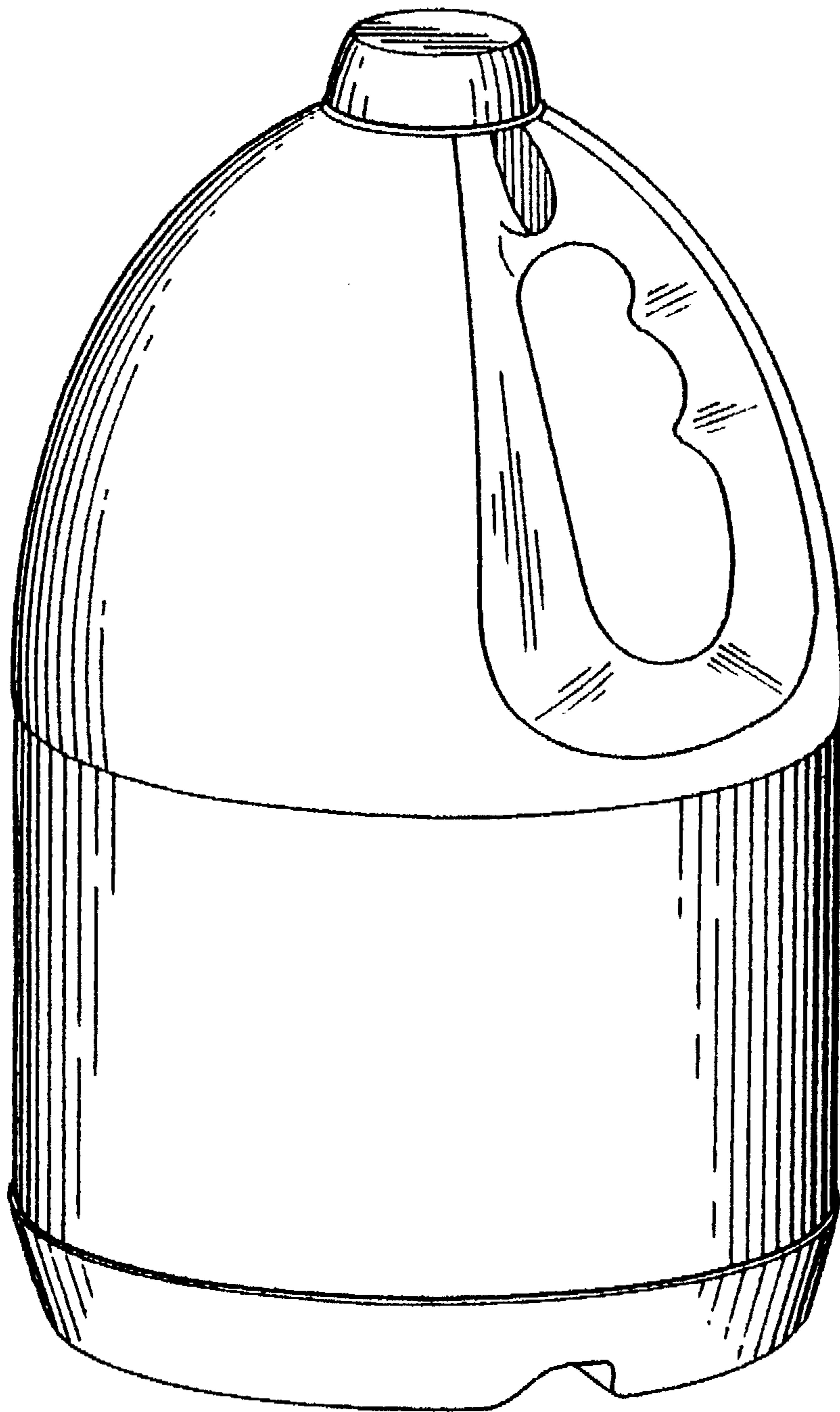

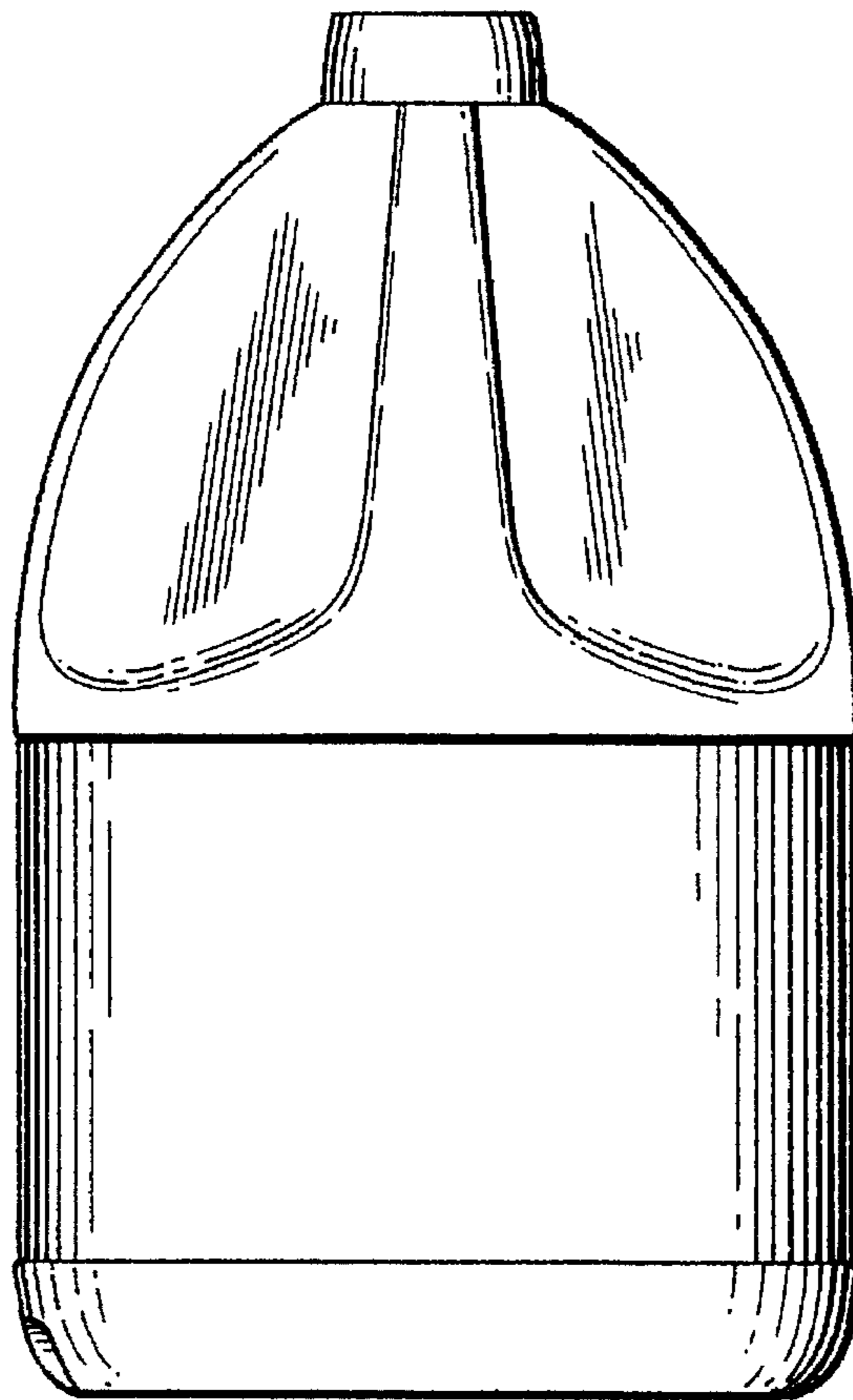

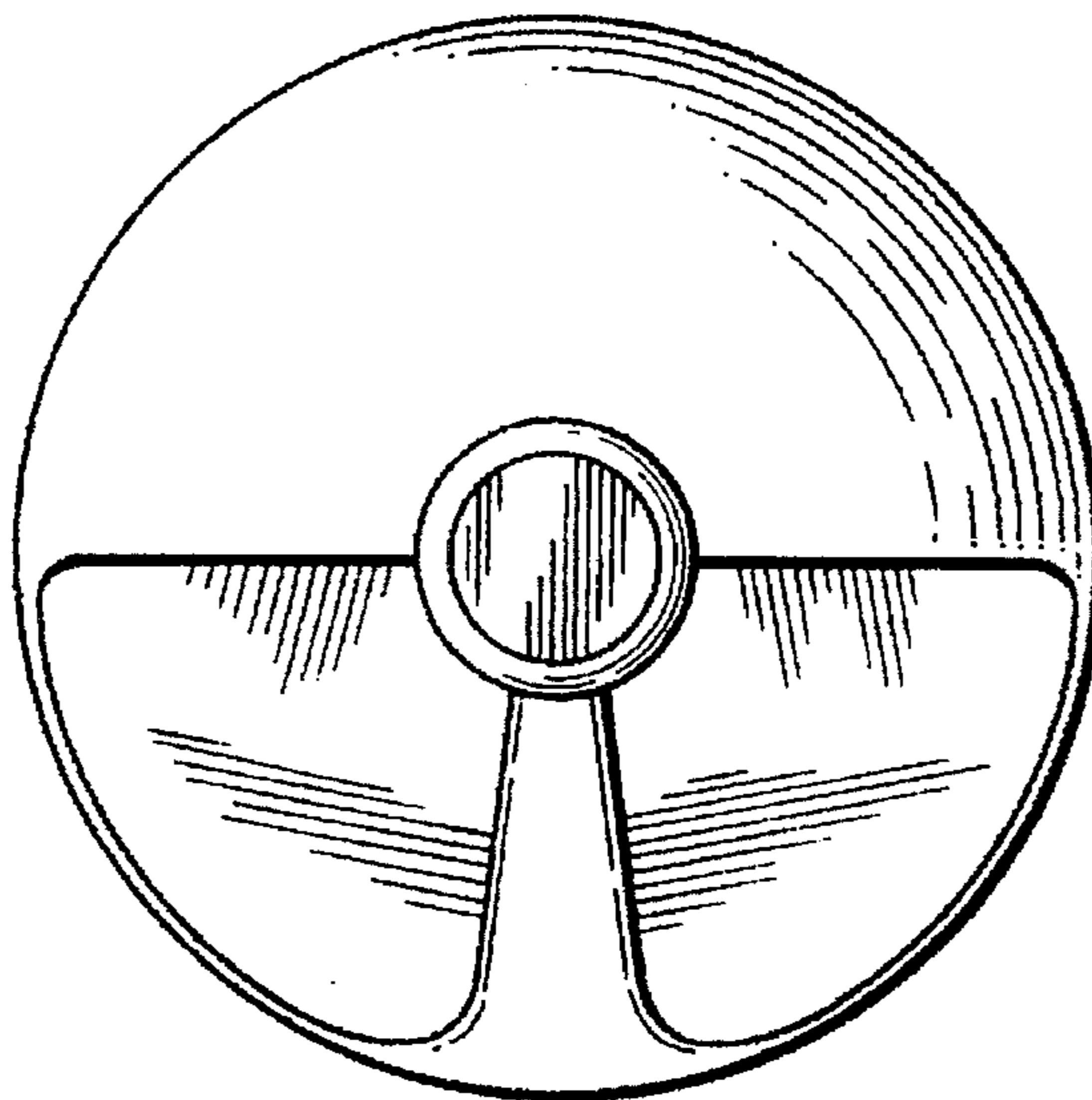

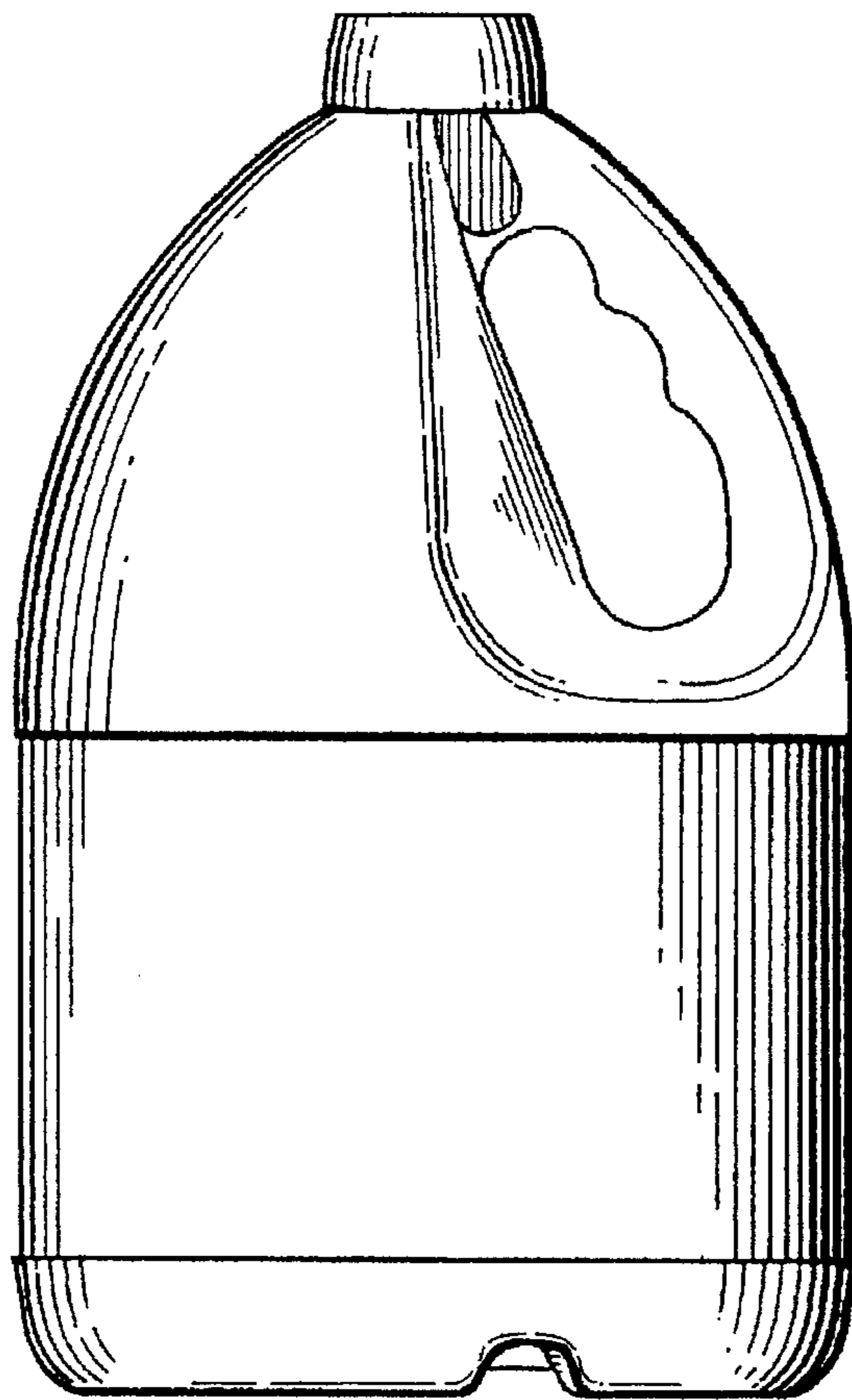

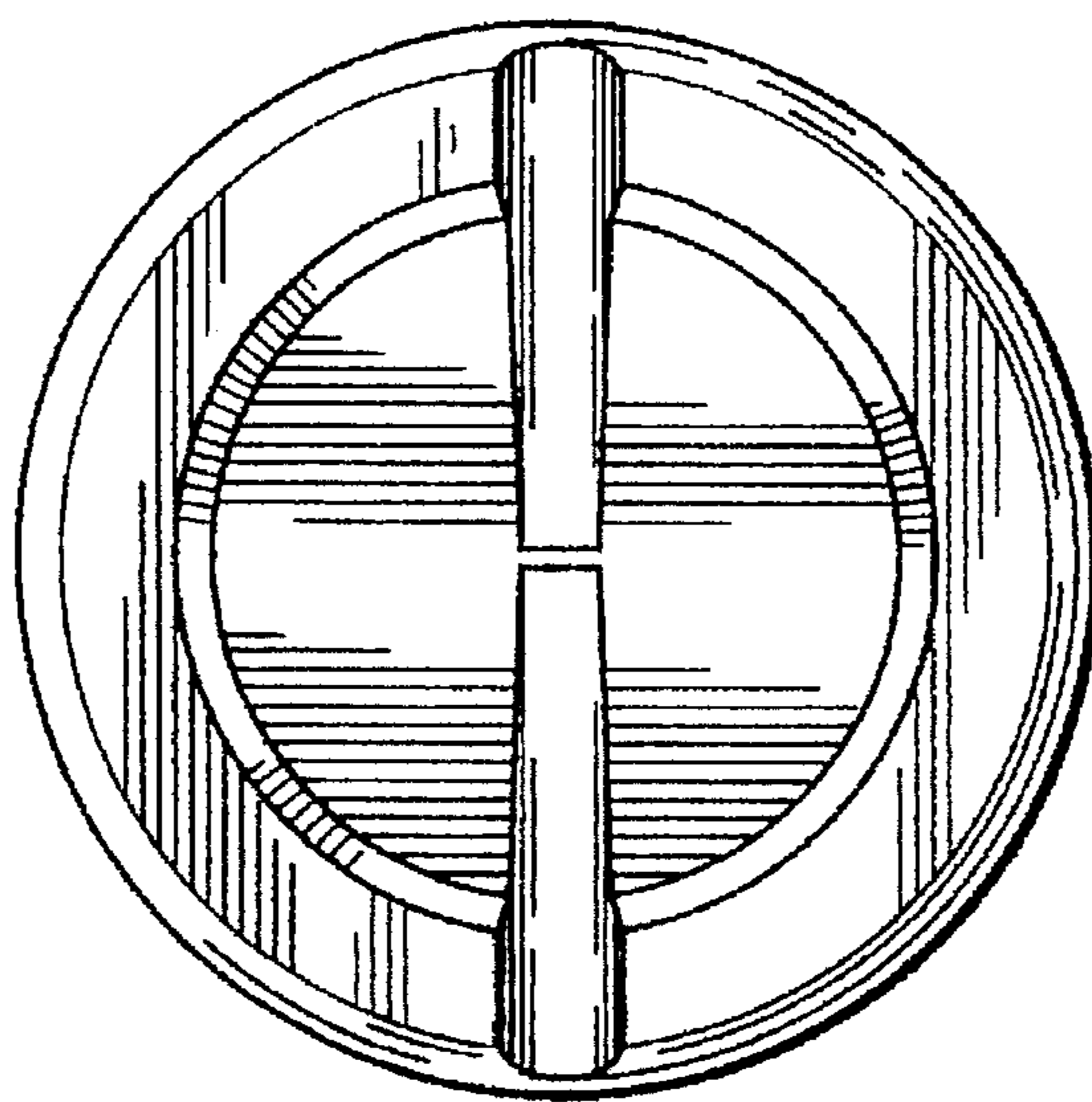
