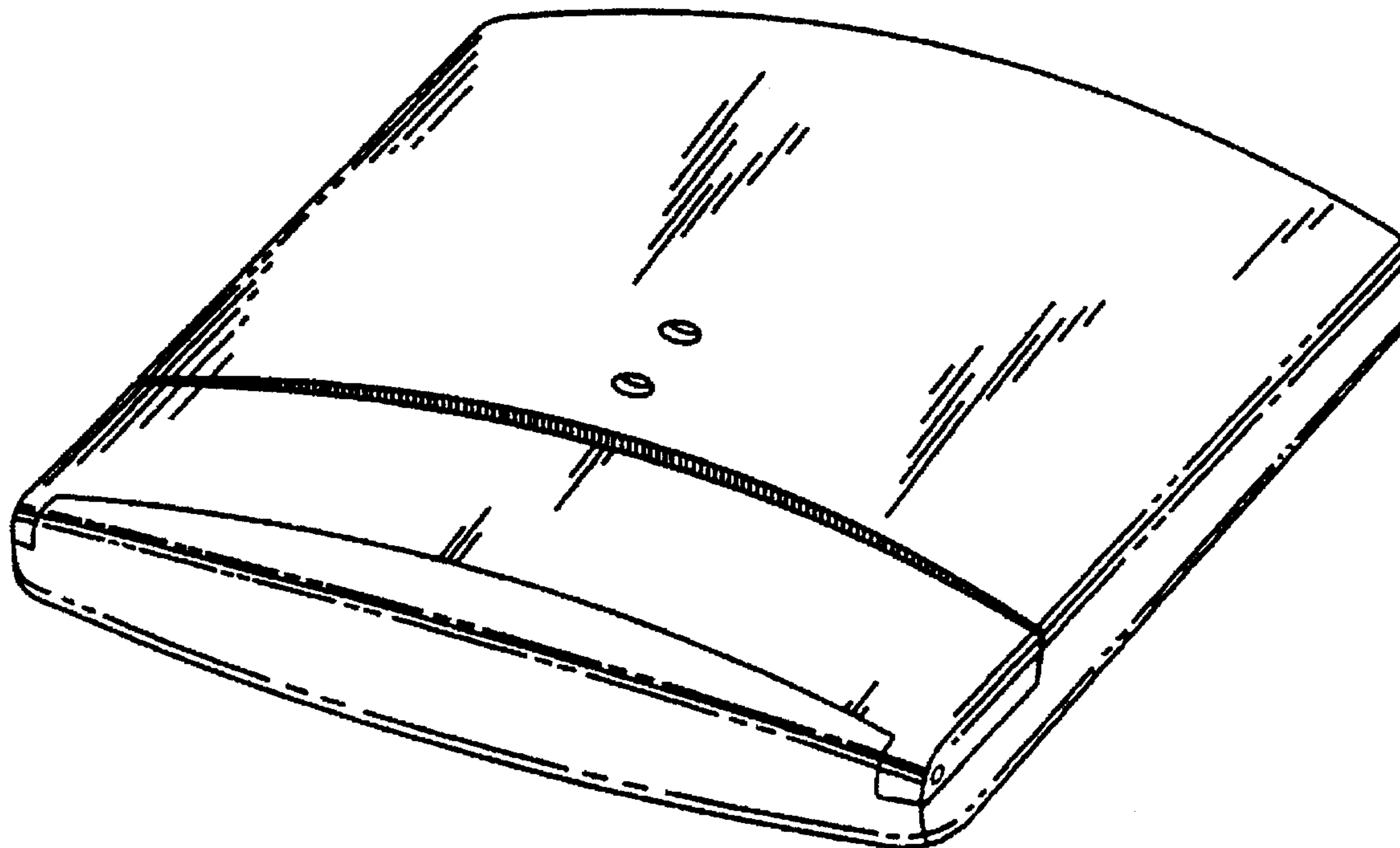
[57] **CLAIM**

The ornamental design of a telephone module, as shown and described.

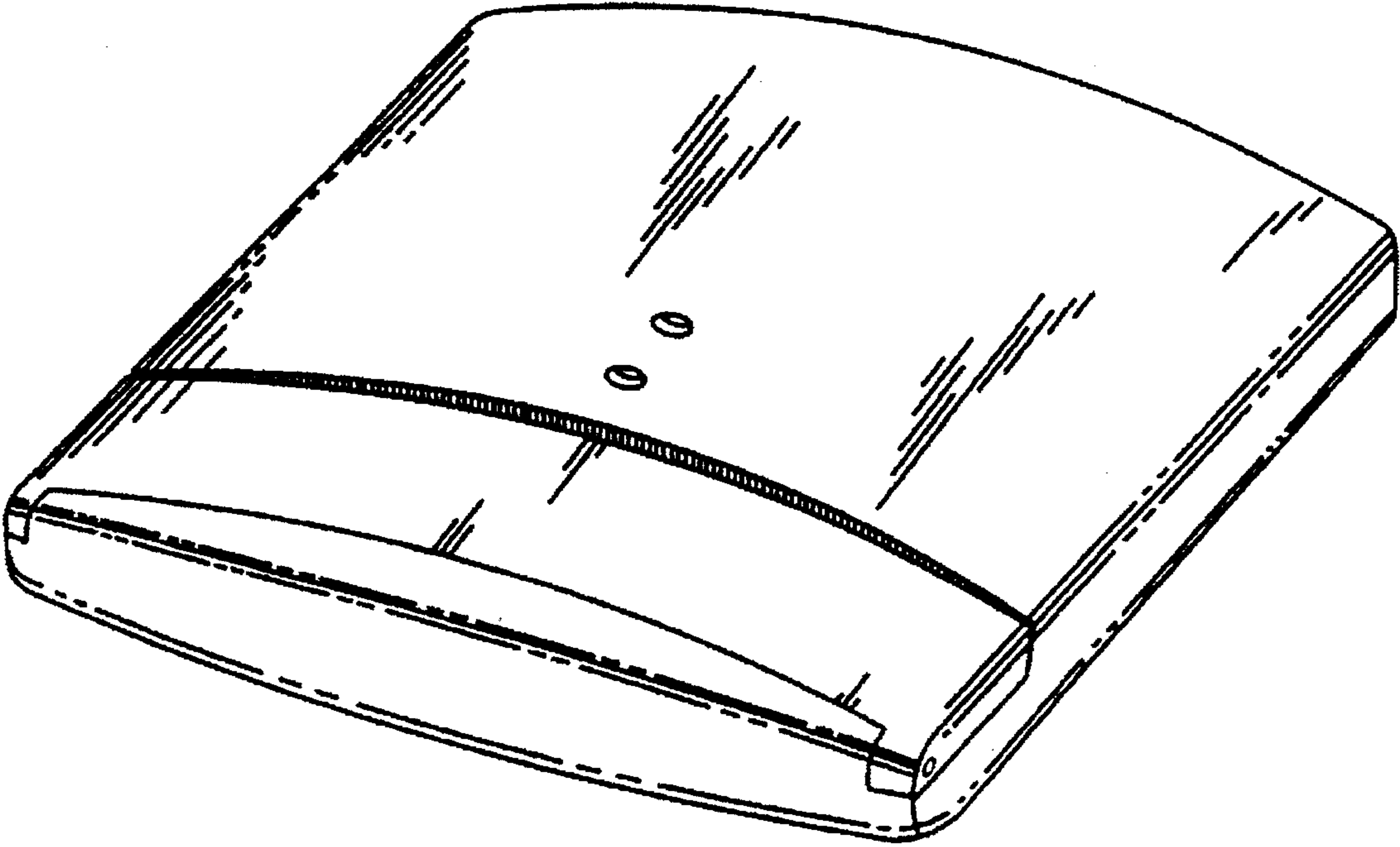
**DESCRIPTION**

FIG. 7 is a bottom plan view thereof.

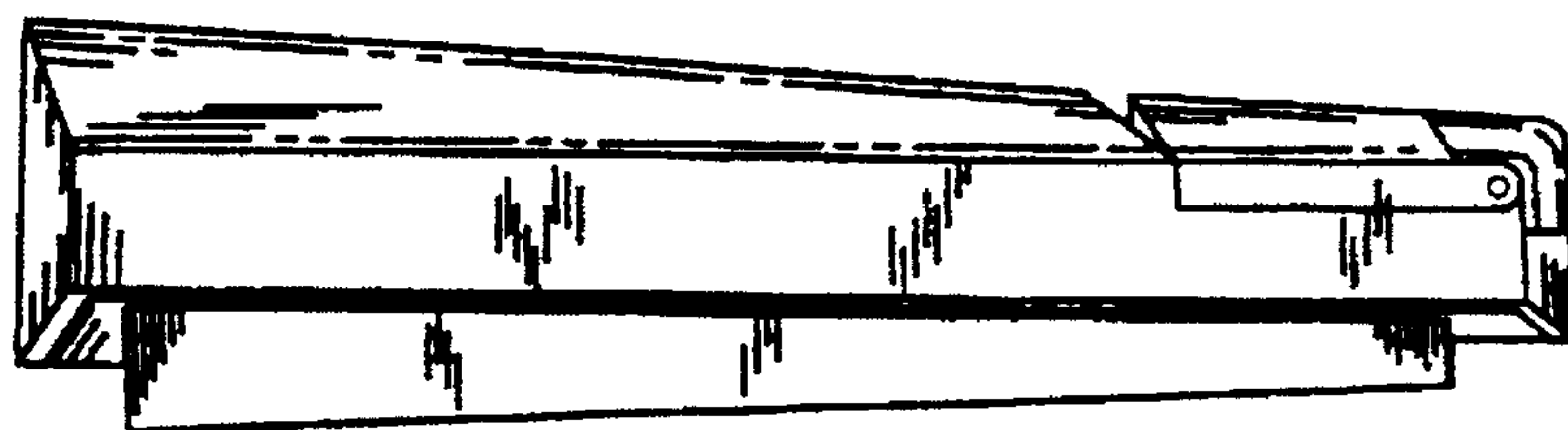

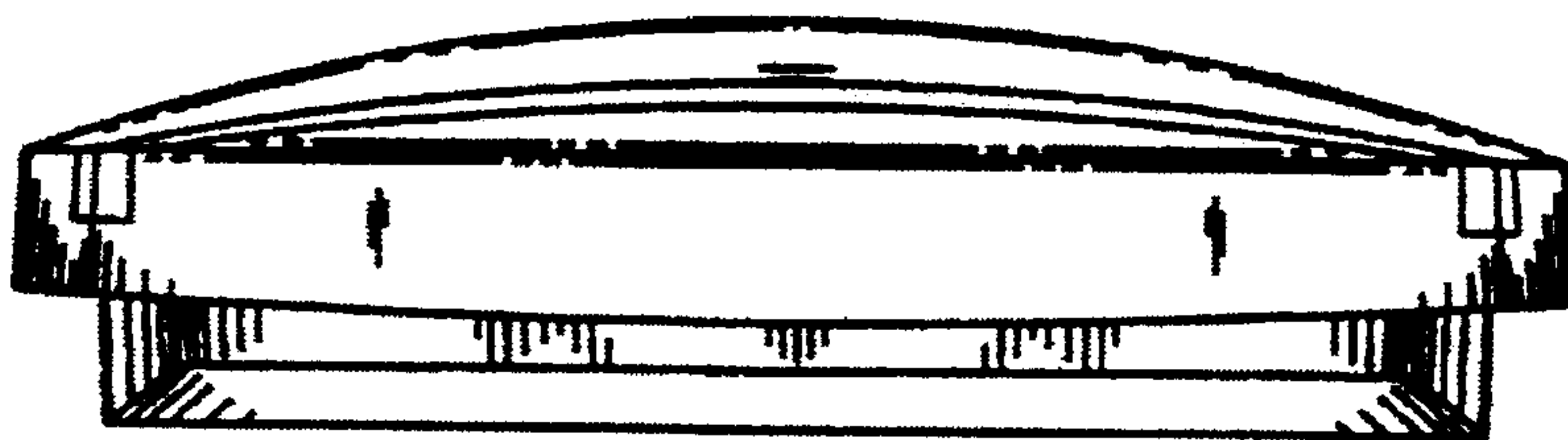

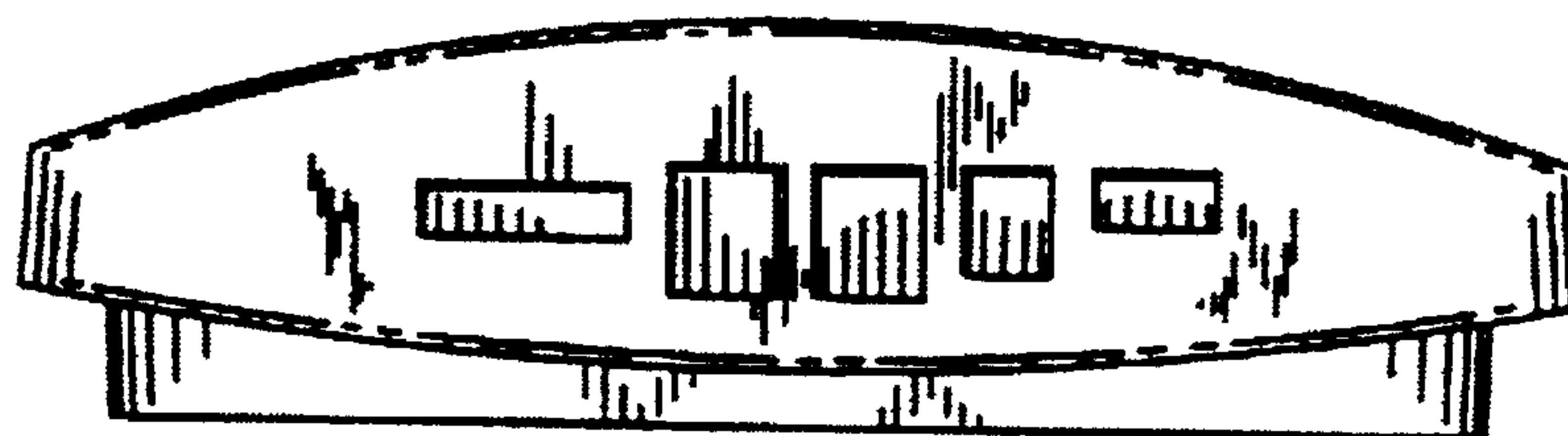

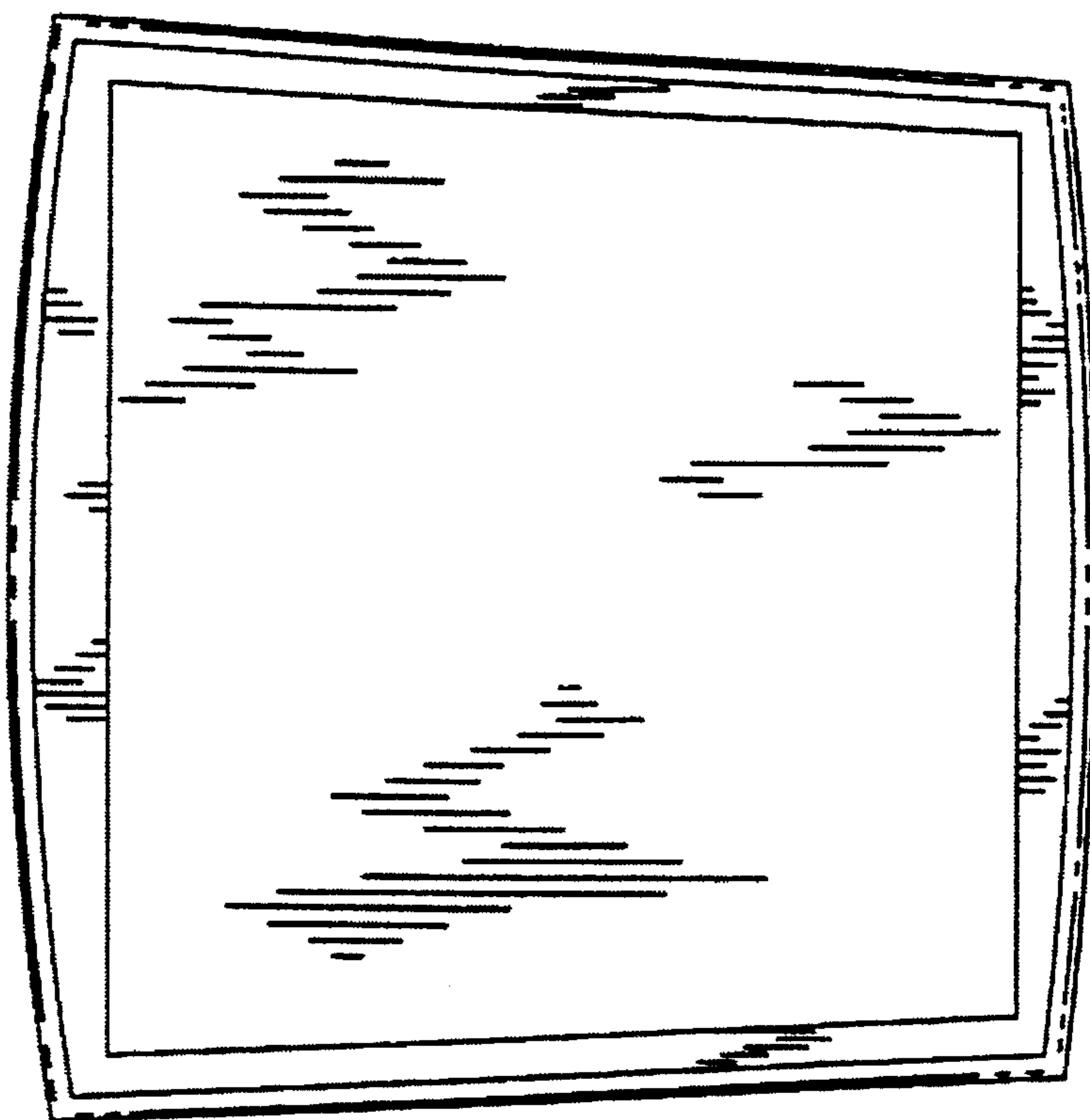
