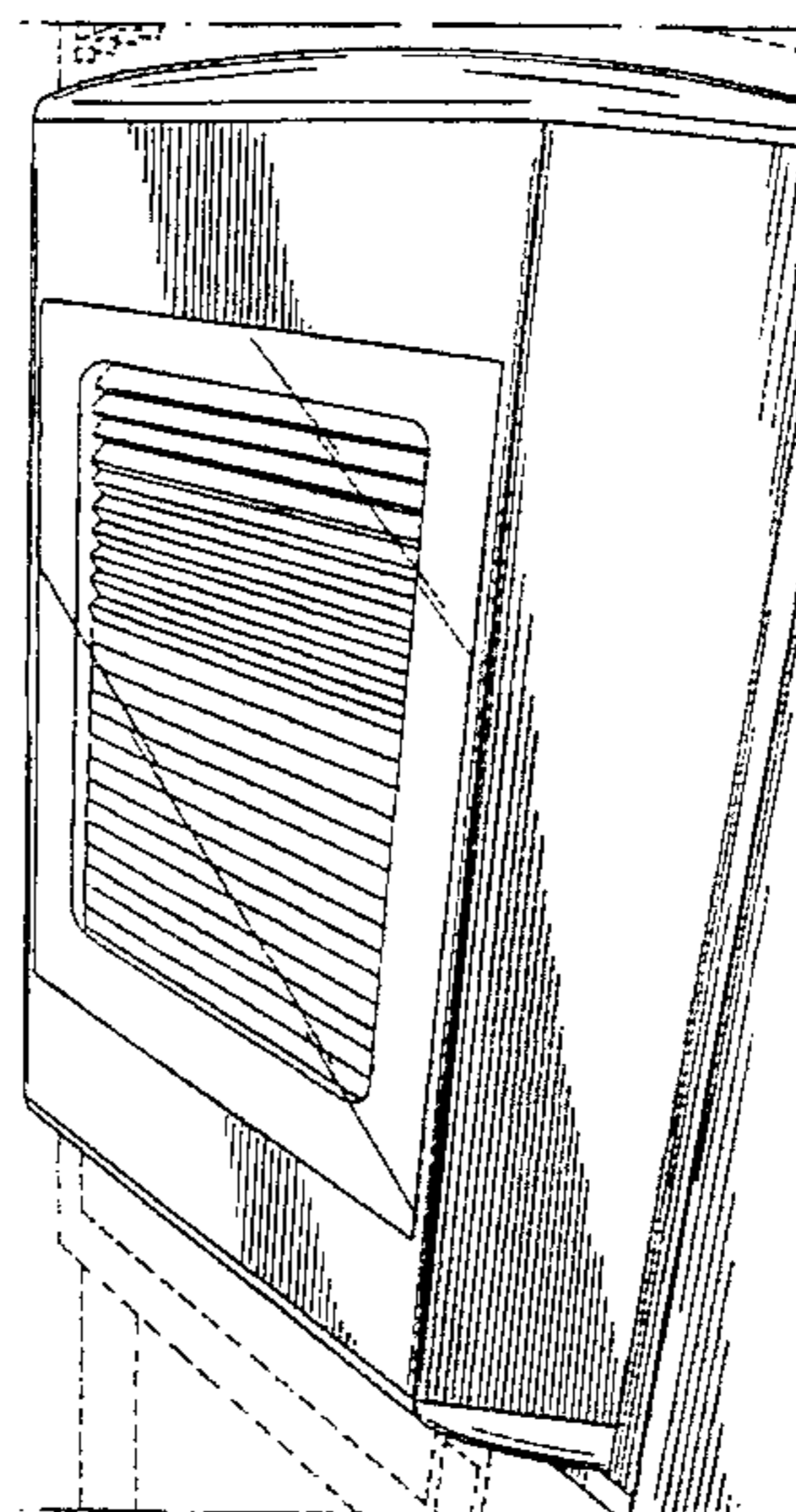
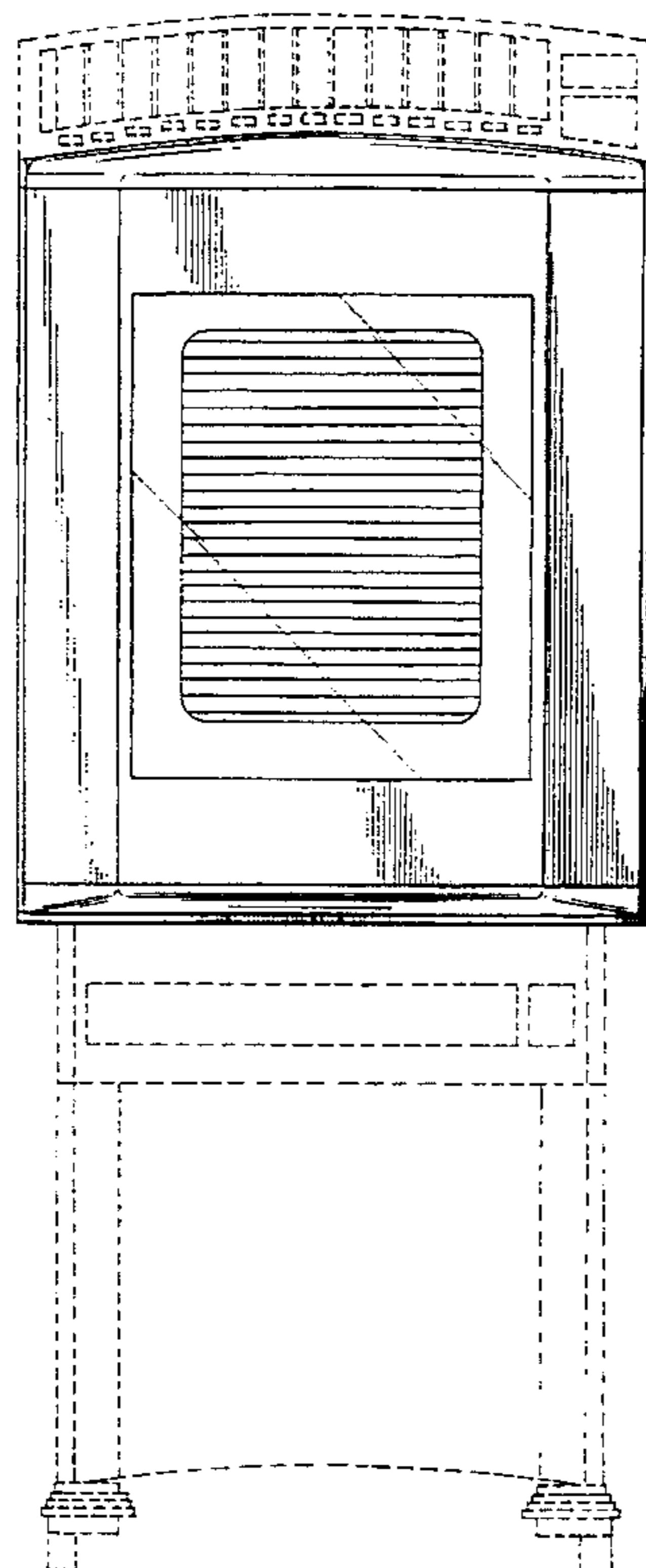
[57] **CLAIM**

The ornamental design for a rotary vane display for a vending machine, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational of a rotary vane display for a vending machine showing our new design;
 FIG. 2 is a front elevational view thereof, with the rotary vanes in an alternate position;
 FIG. 3 is an enlarged fragmented perspective of FIG. 1, shown for clarity of illustration;
 FIG. 4 is an enlarged fragmented perspective of FIG. 2, shown for clarity of illustration;
 FIG. 5 is a front elevational view of a second embodiment of the rotary vane display as disclosed in FIG. 1;
 FIG. 6 is a front elevational view of FIG. 5, with the rotary vanes in an alternate position;
 FIG. 7 is an enlarged fragmented perspective of FIG. 5, shown for clarity of illustration;
 FIG. 8 is an enlarged fragmented perspective of FIG. 6, shown for clarity of illustration;
 FIG. 9 is a left side elevational view of FIGS. 1 and 5;
 FIG. 10 is a right side elevational view of FIGS. 1 and 5;
 FIG. 11 is a top plan view of FIGS. 1 and 5;
 FIG. 12 is a bottom plan view of FIGS. 1 and 5; and,
 FIG. 13 is a rear elevational view of FIGS. 1 and 5.

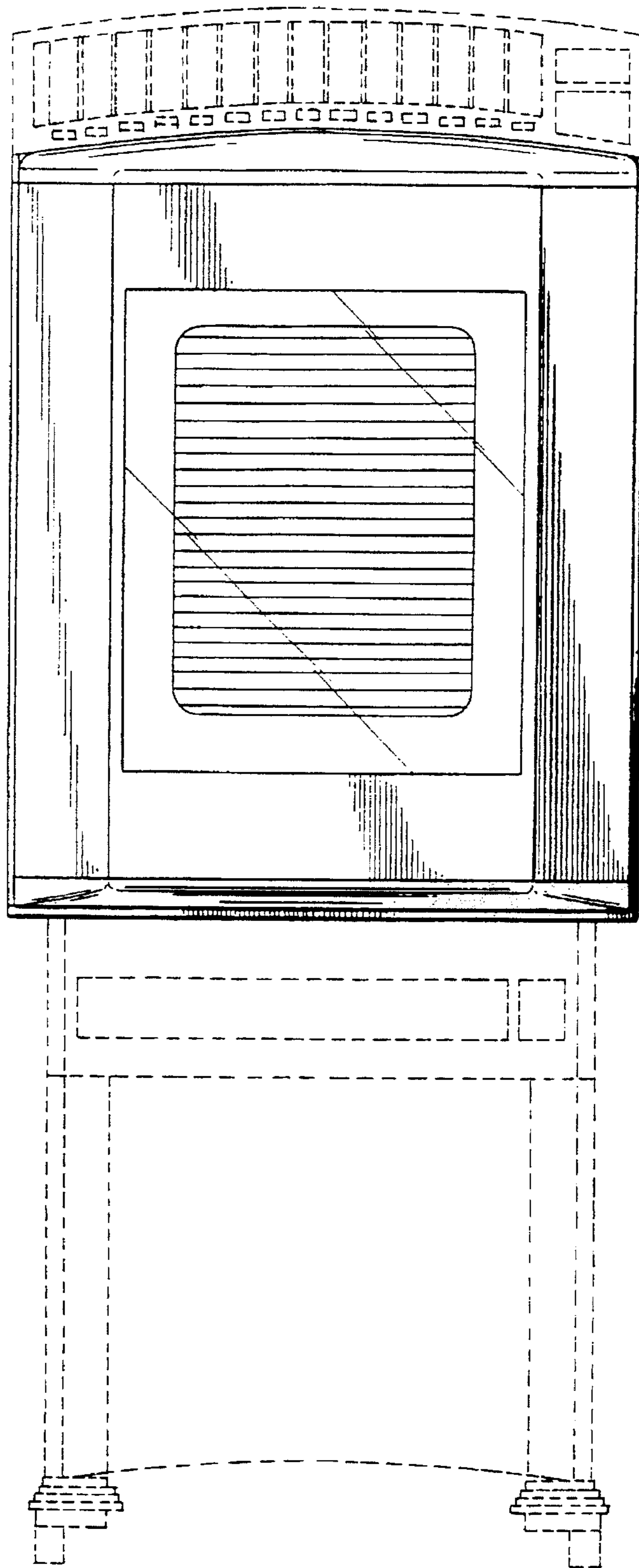

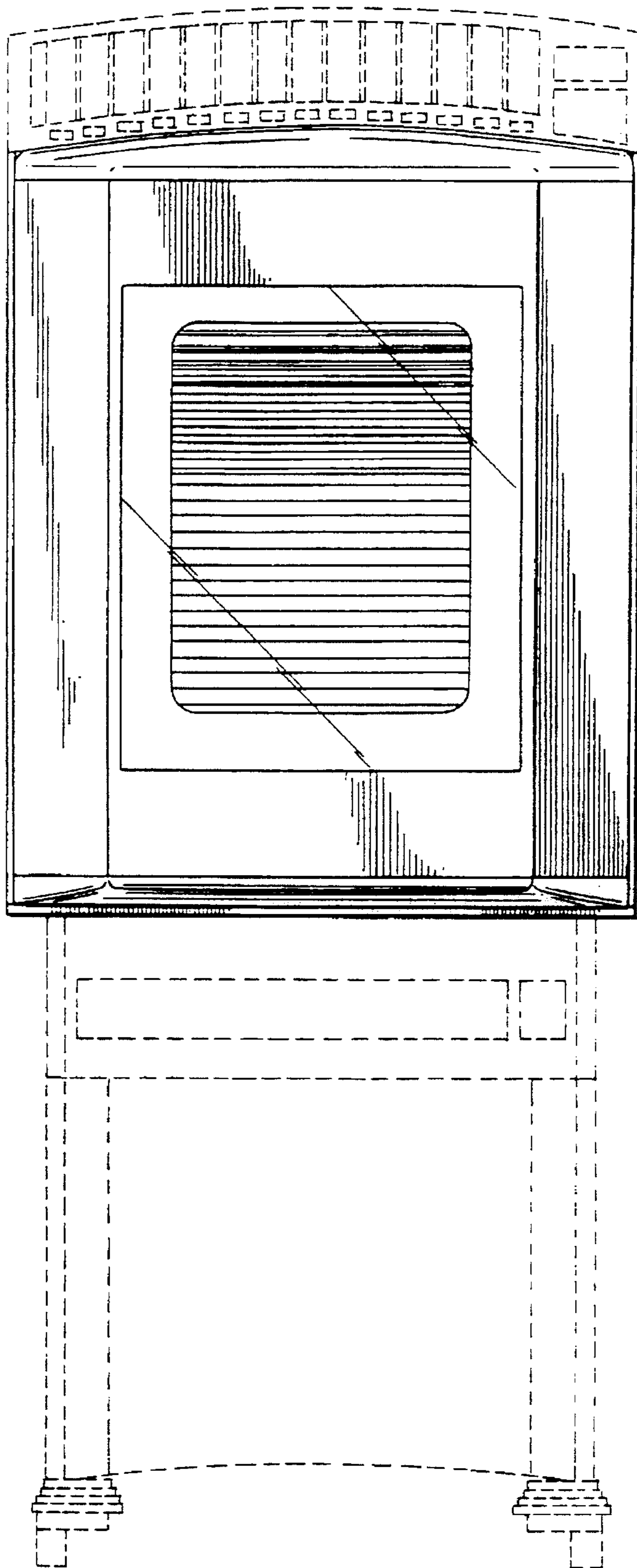

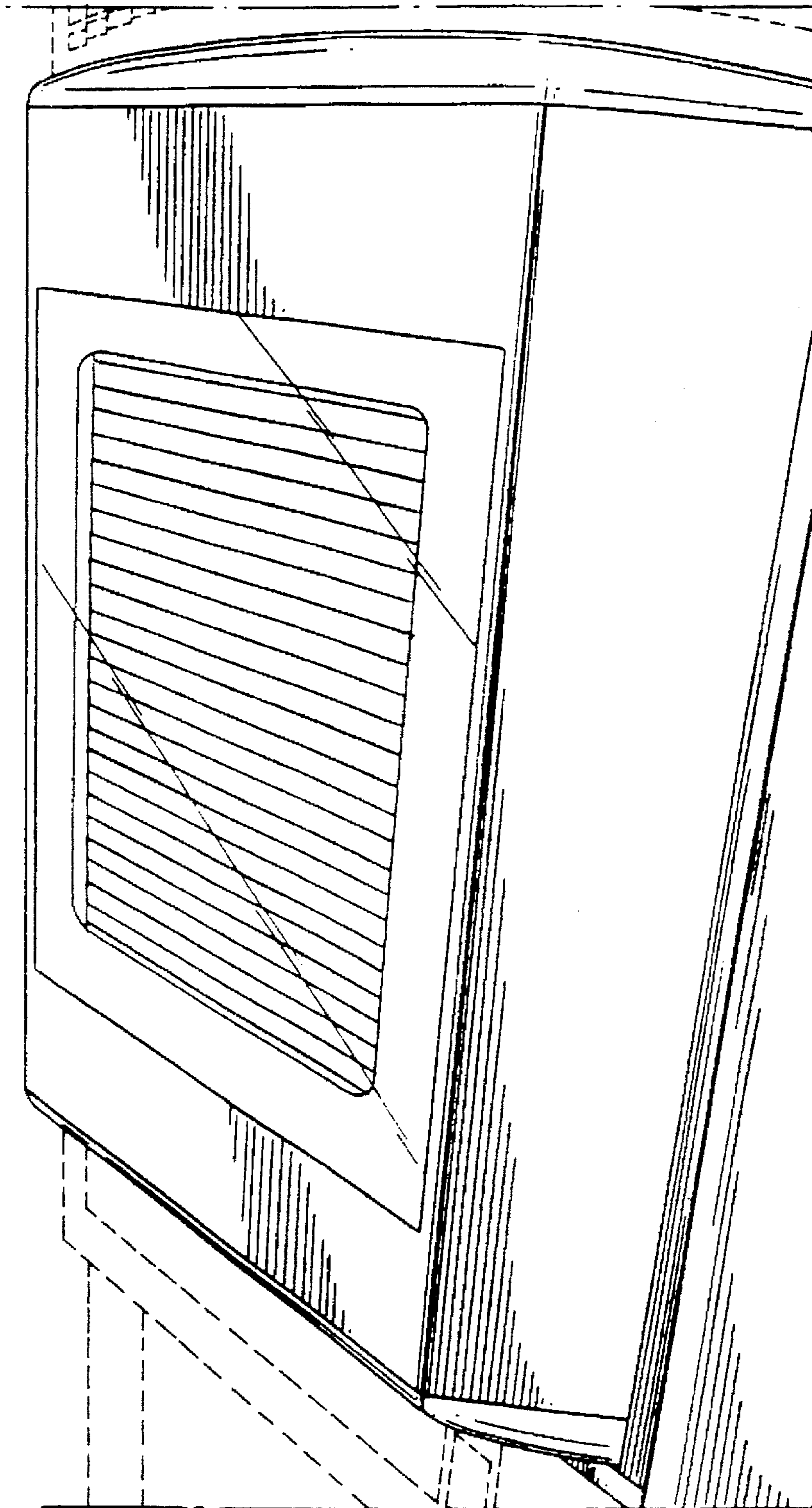

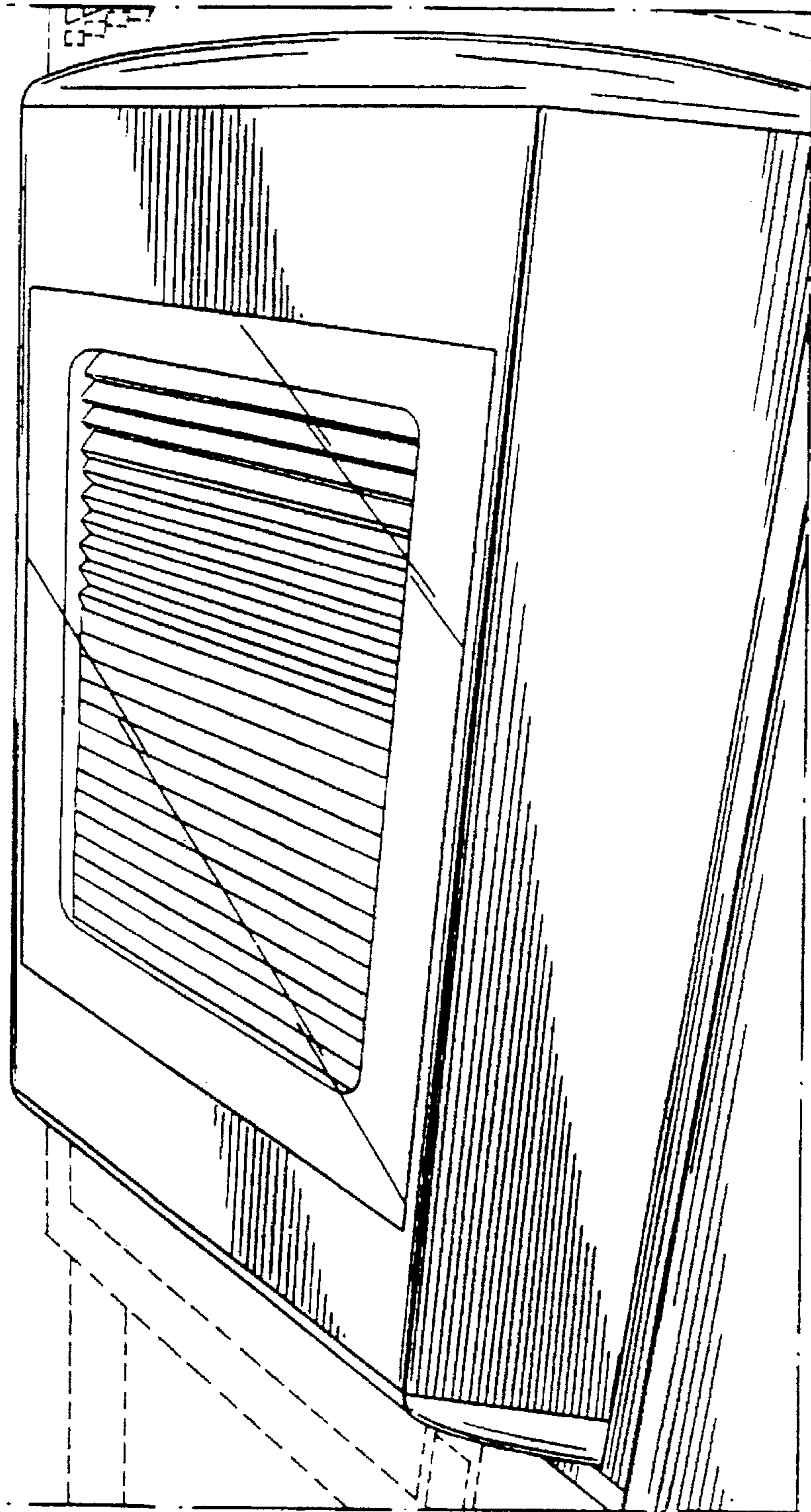

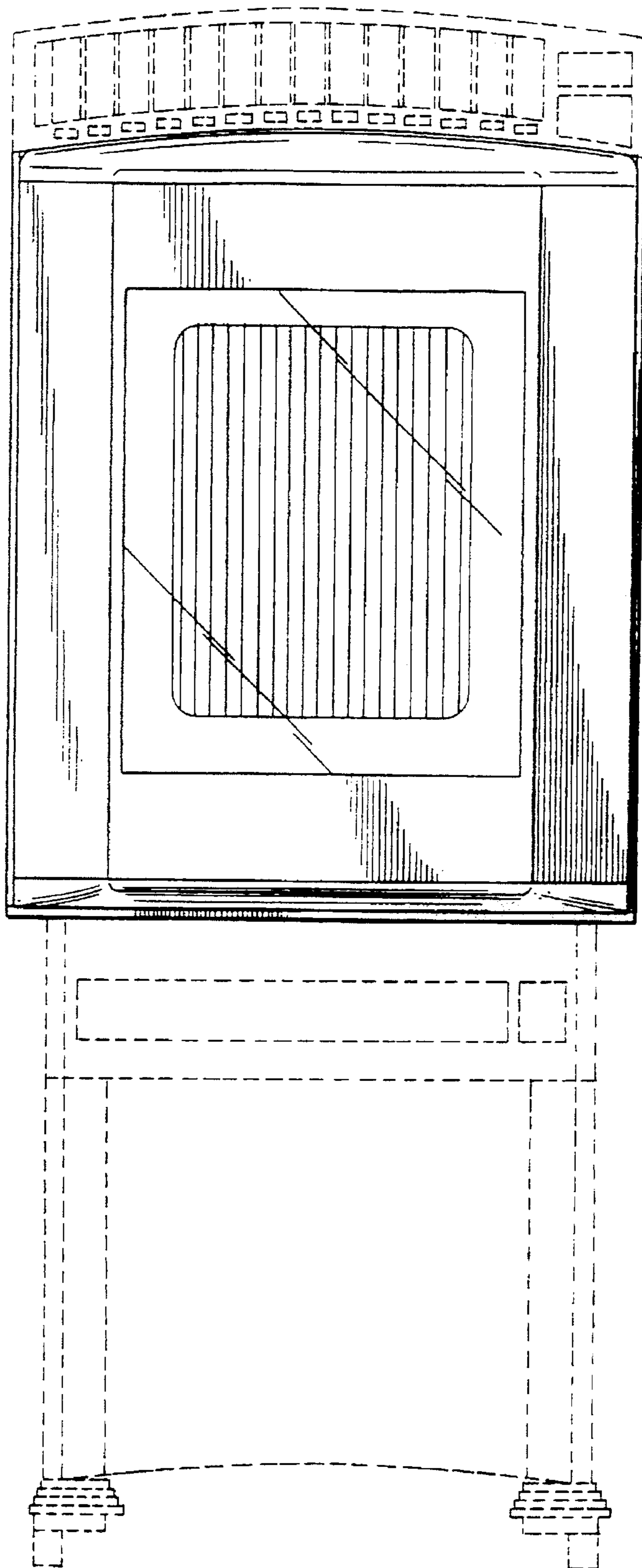

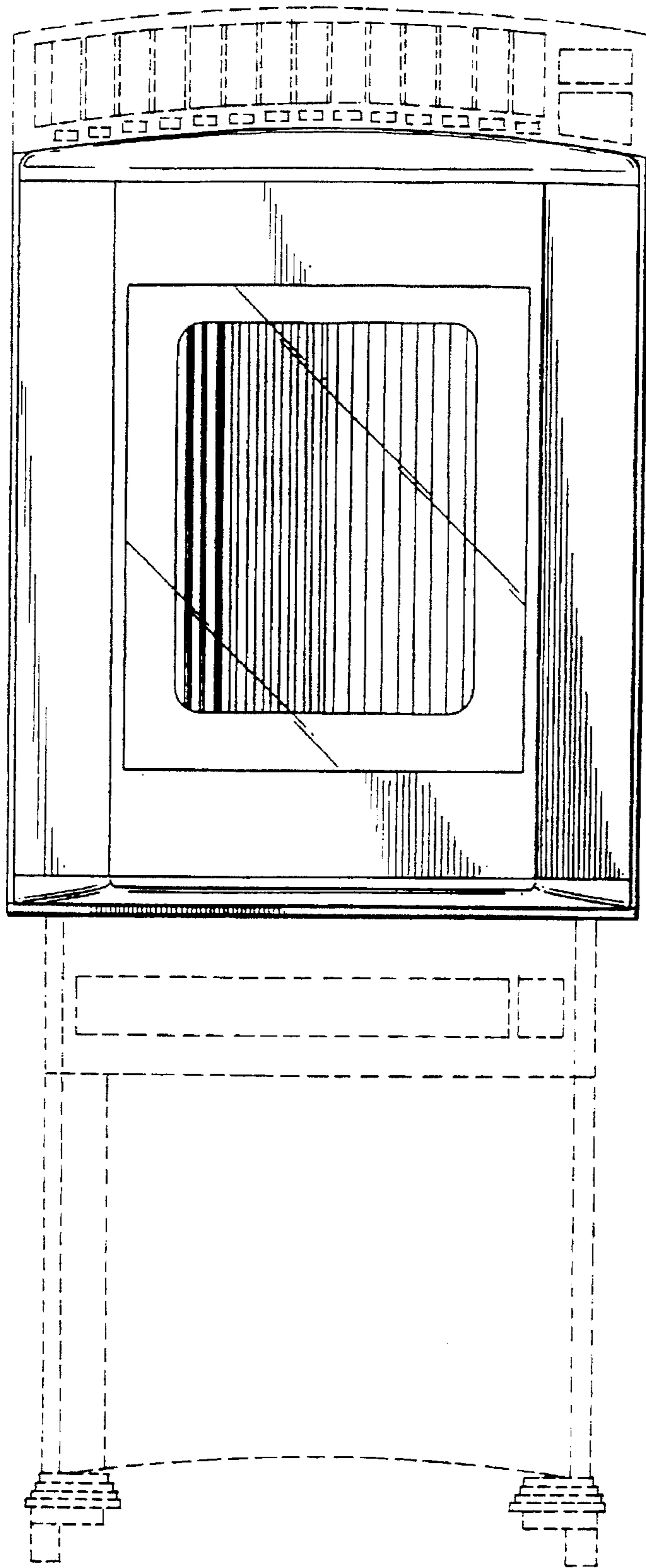

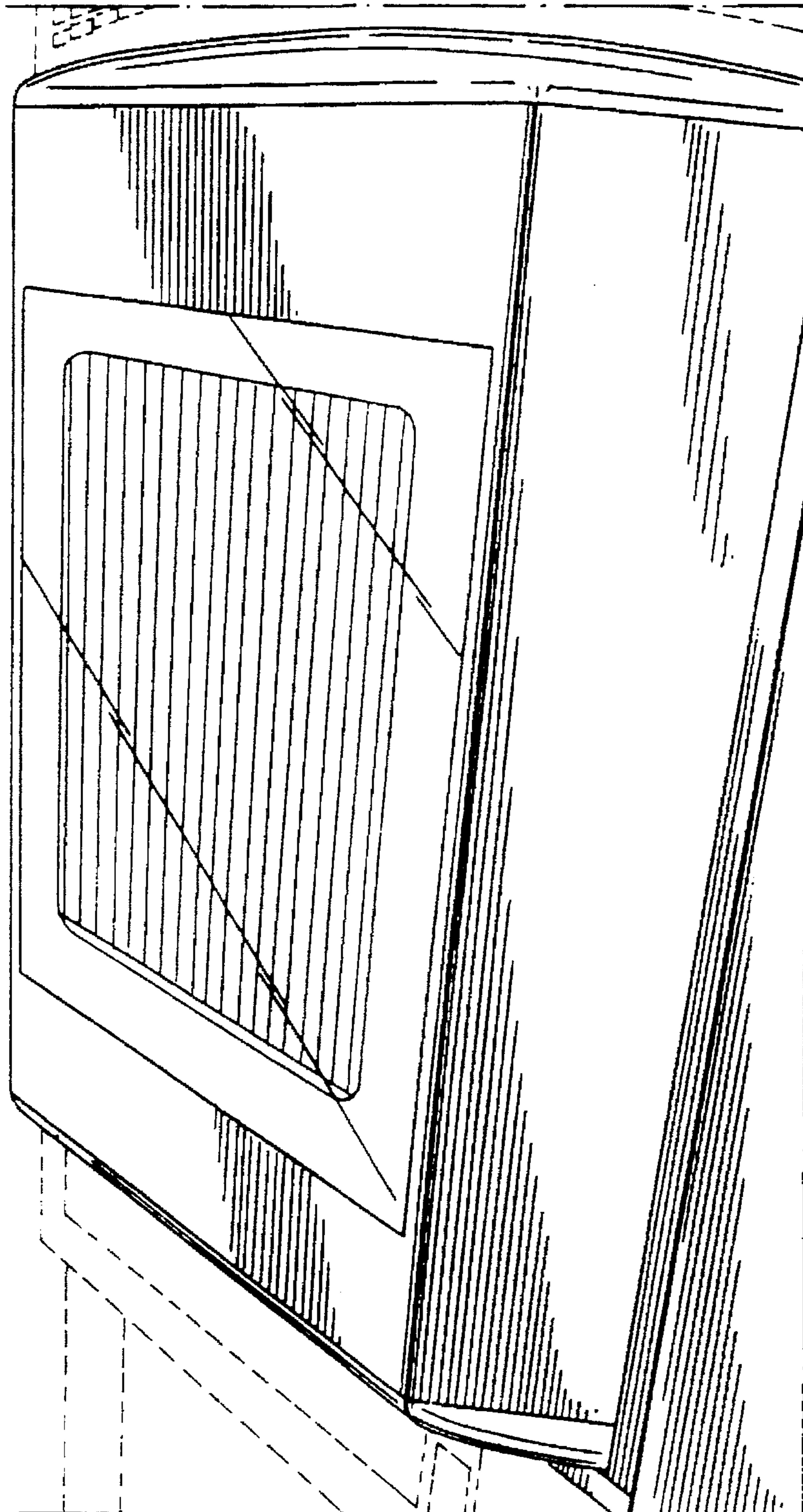

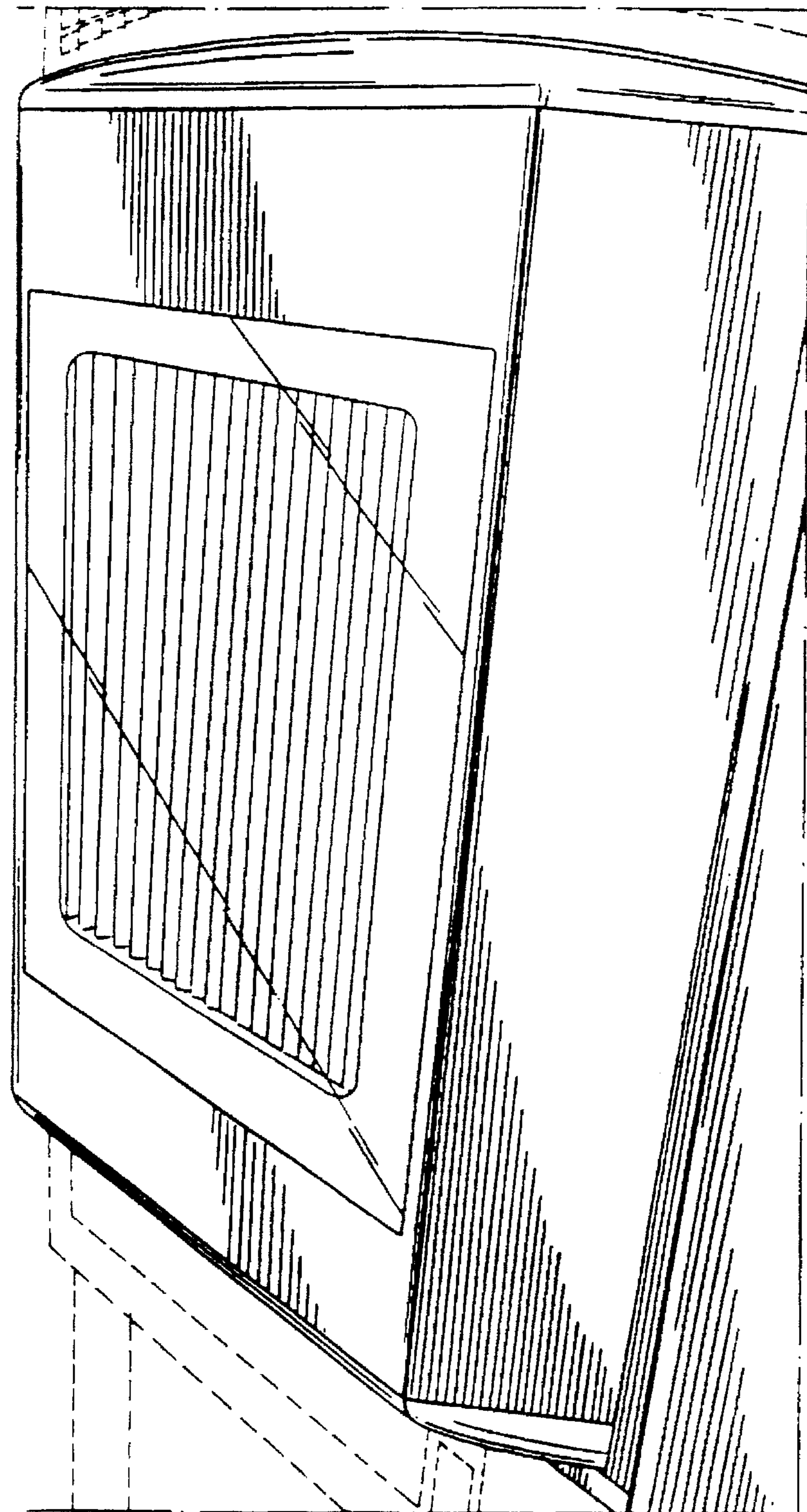

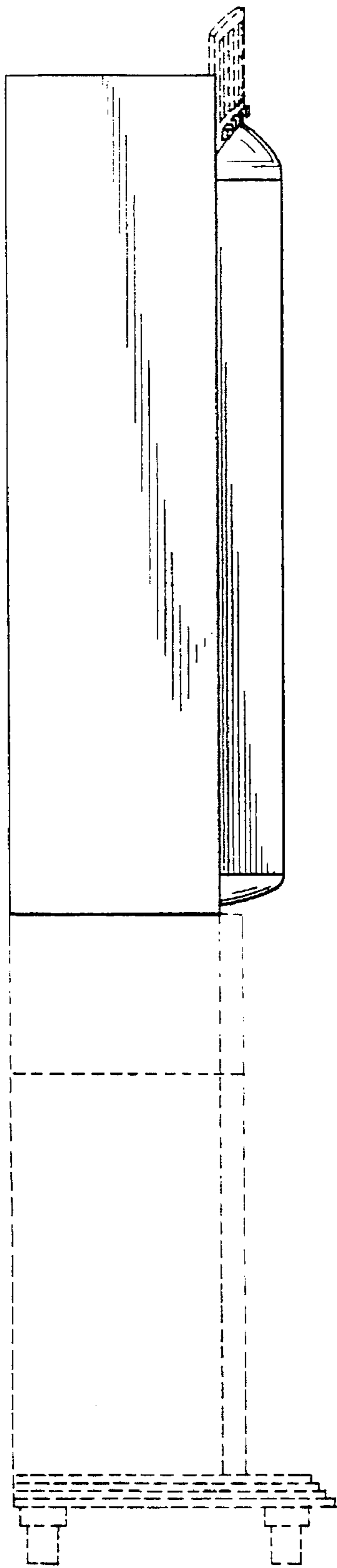

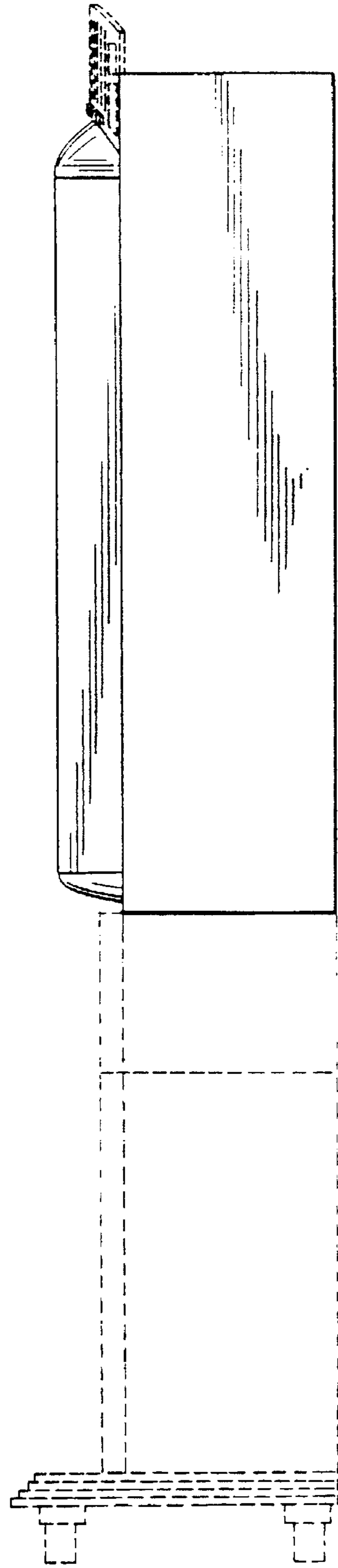

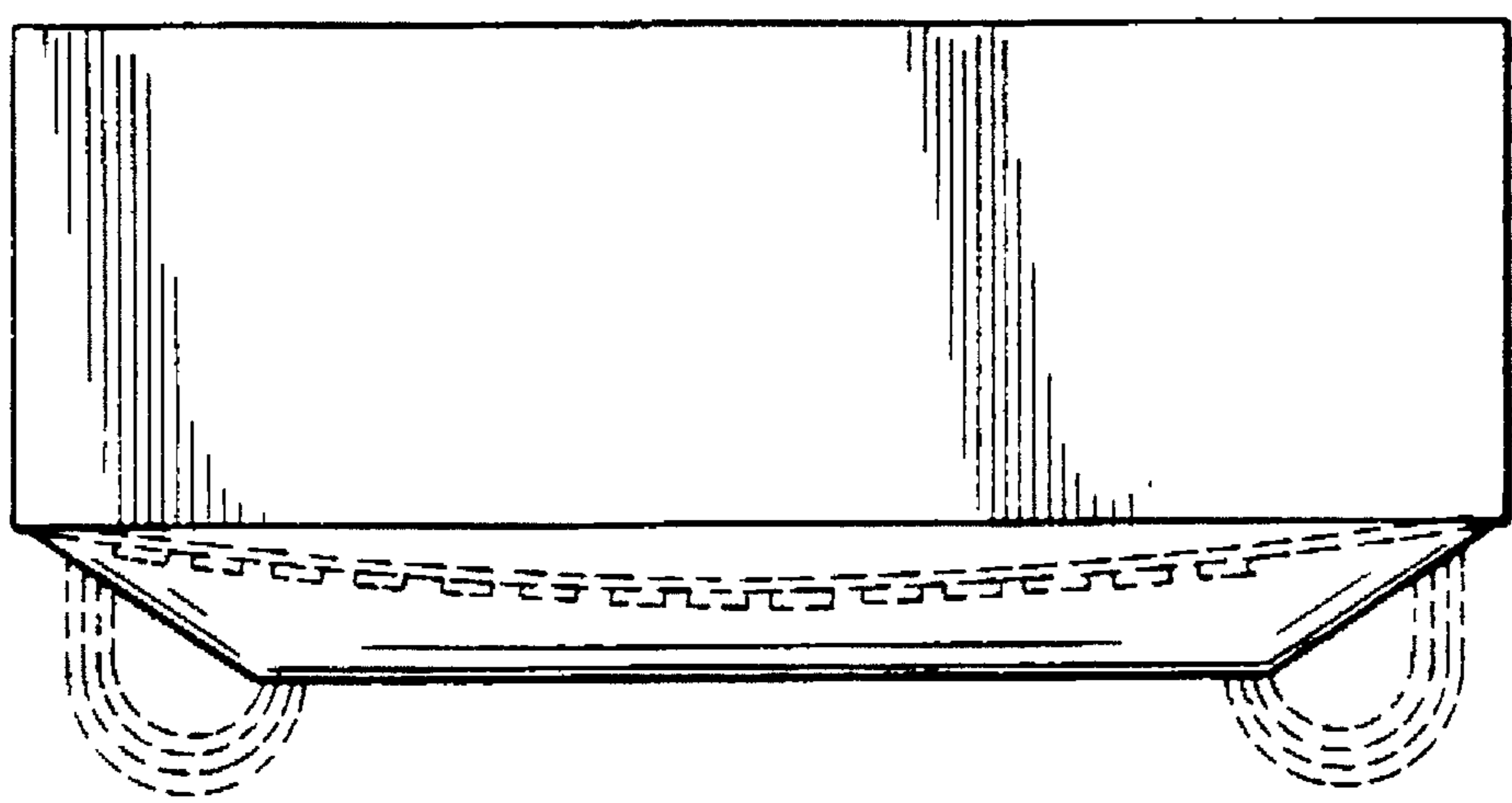

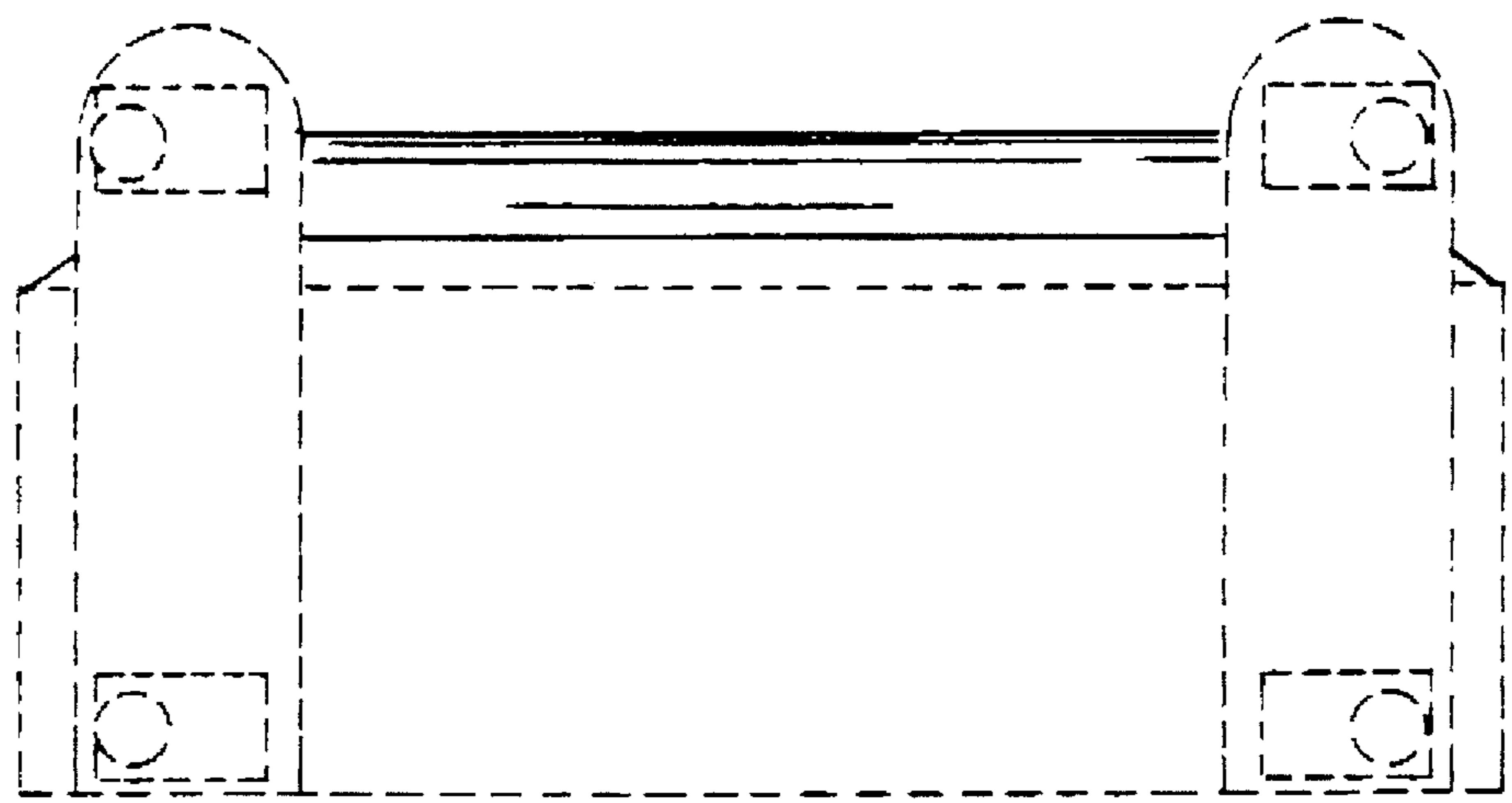

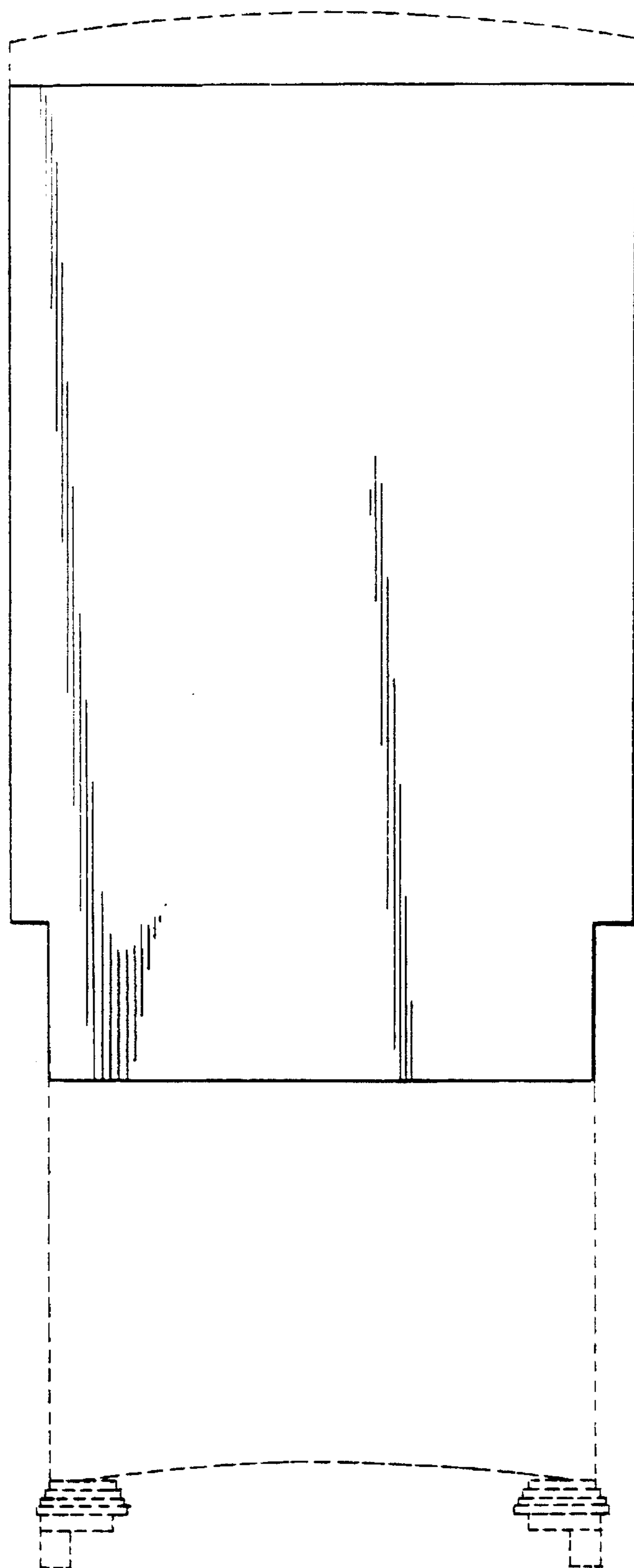
