[57] CLAIM

The ornamental design for a golf ball retriever, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf ball retriever showing our new design;
FIG. 2 is a front view of the golf ball retriever;
FIG. 3 is a side view of the golf ball retriever;
FIG. 4 is a rear view of the top portion of the golf ball retriever;
FIG. 5 is a top view of the golf ball retriever; and,
FIG. 6 is a bottom view of the golf ball retriever.
