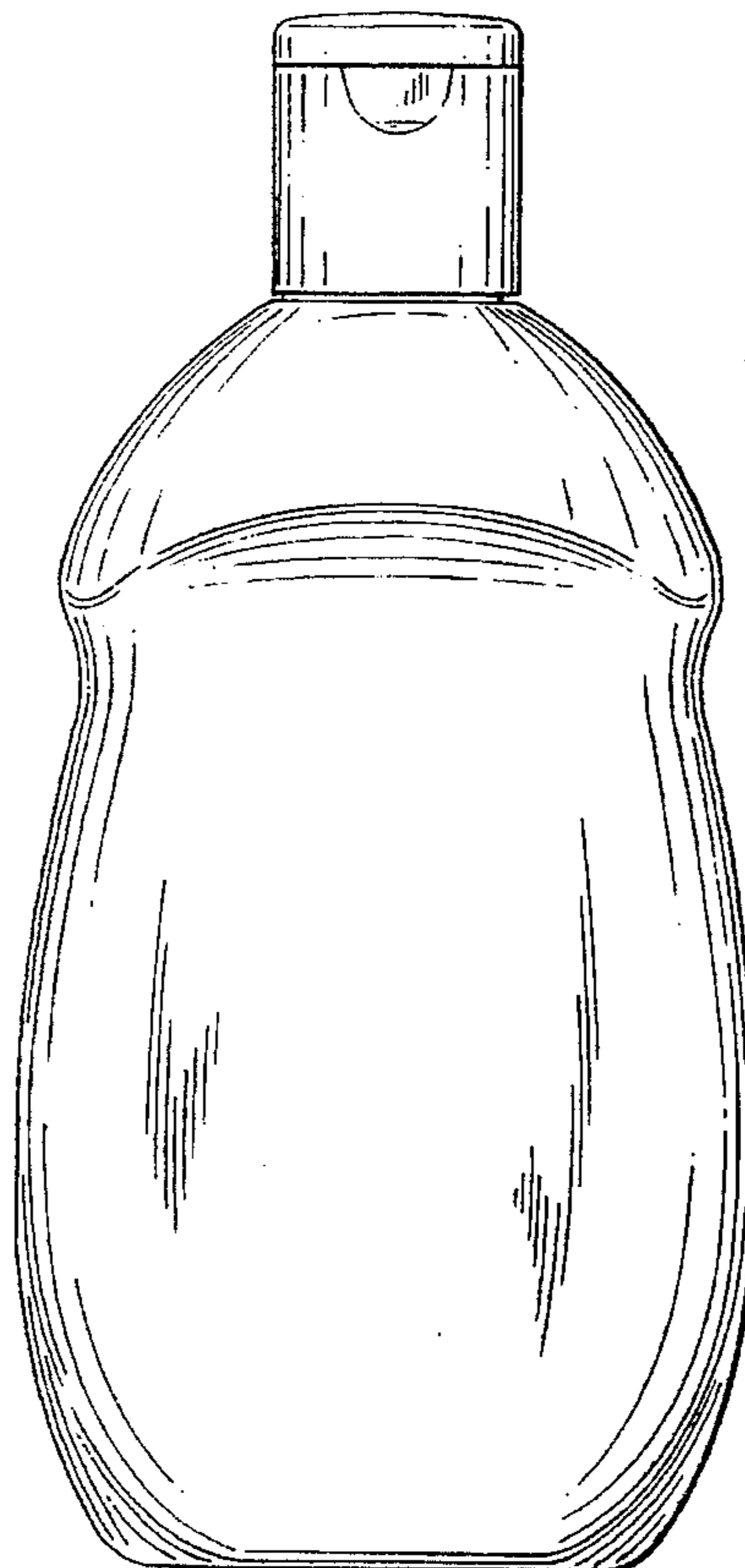
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the combined container and cap of my design;  
FIG. 2 is a front elevational view thereof;

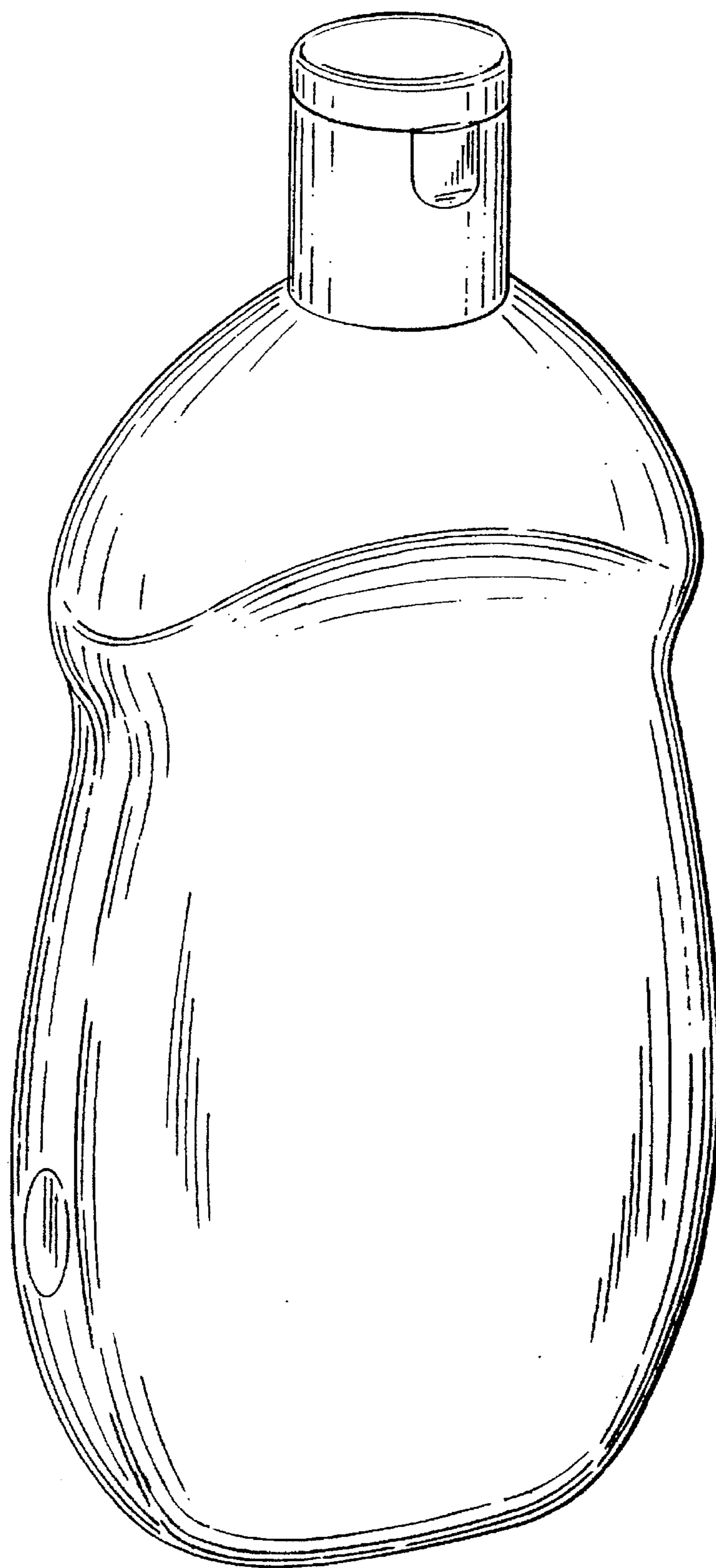

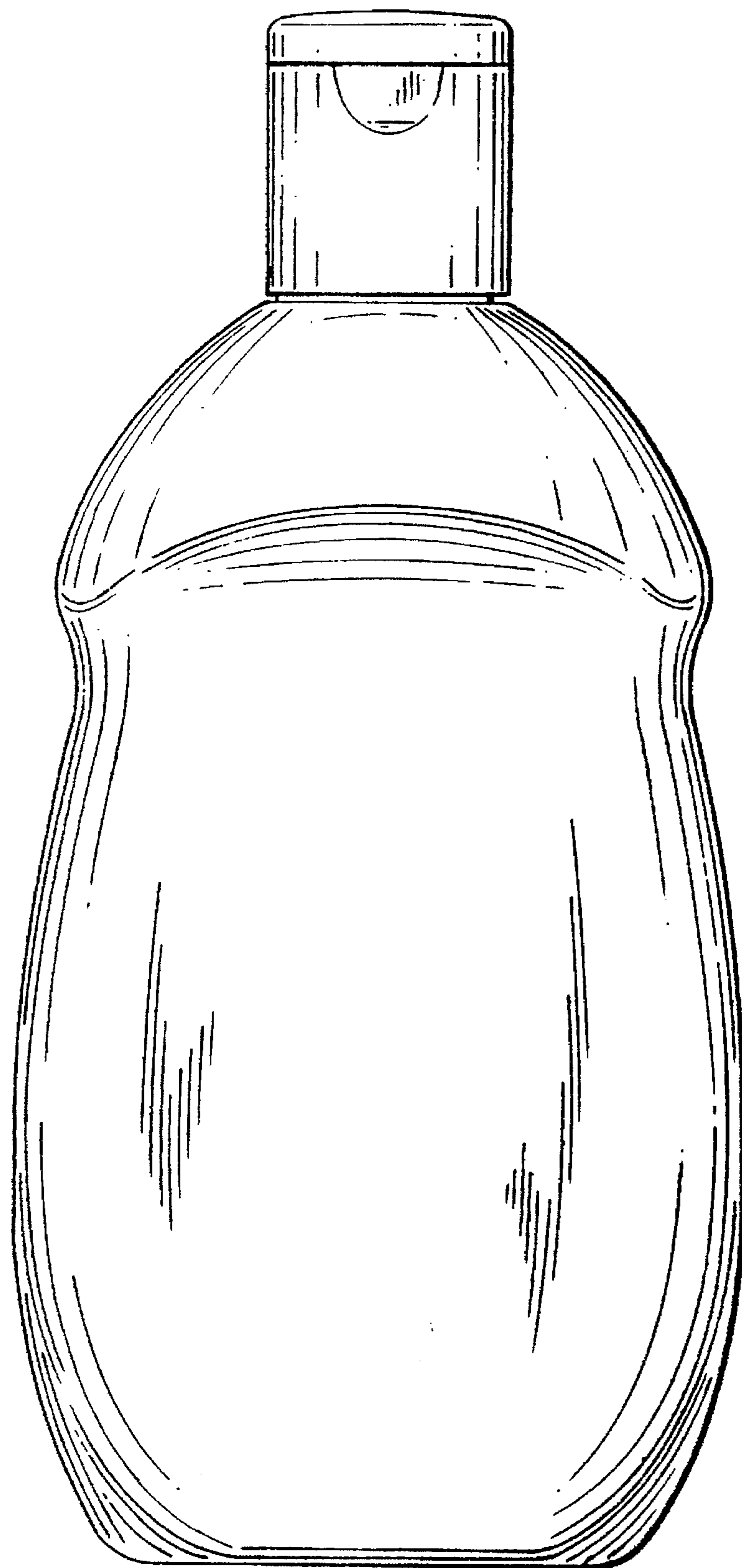

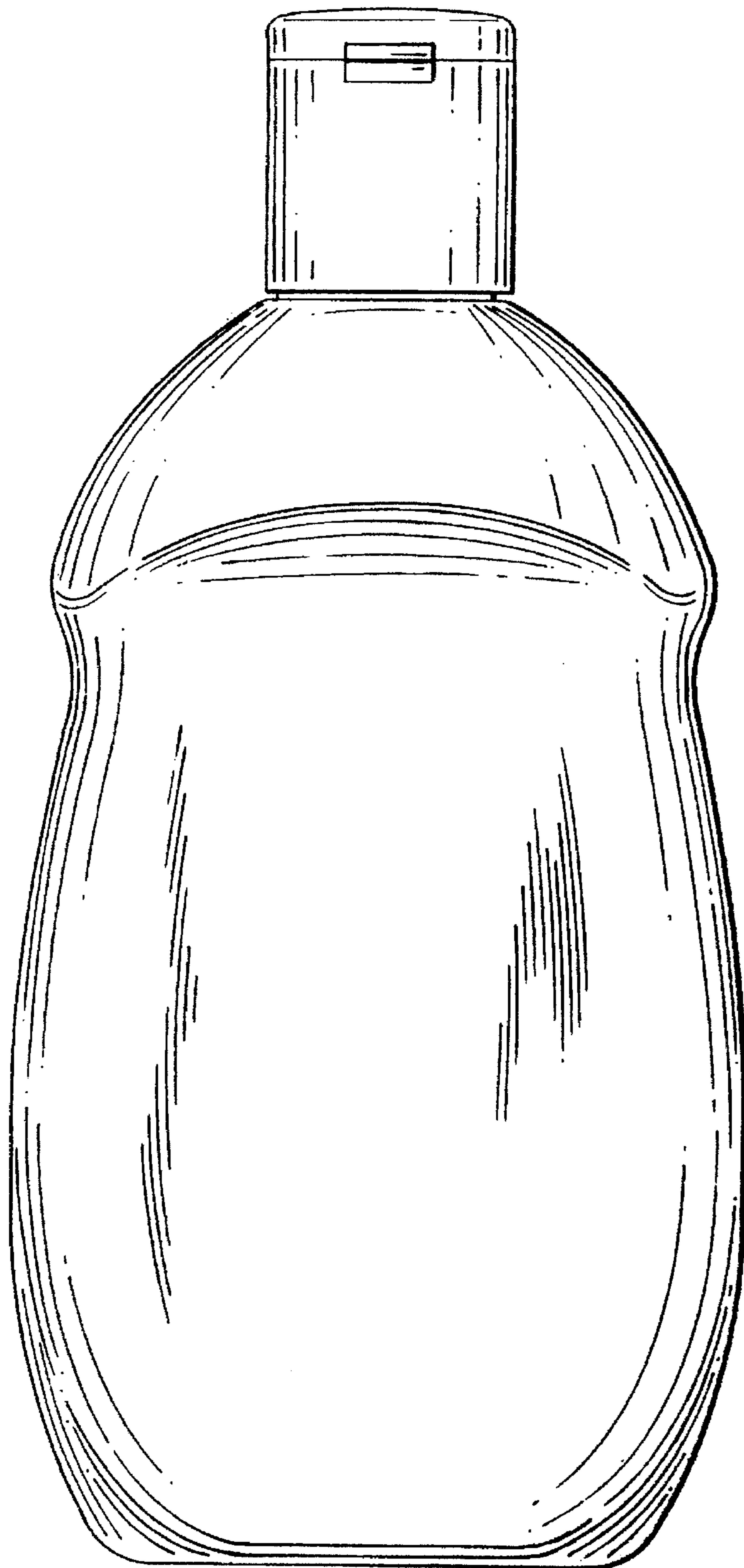

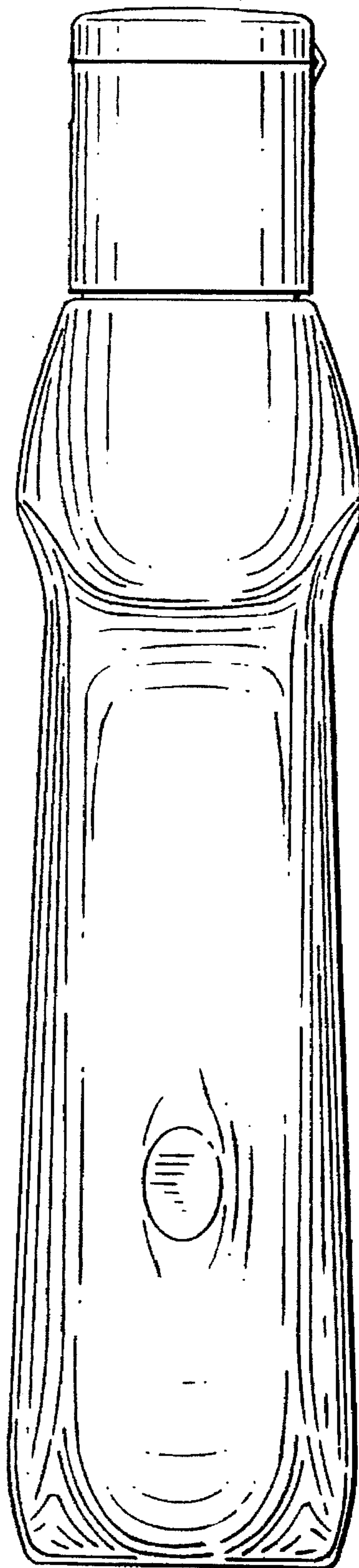

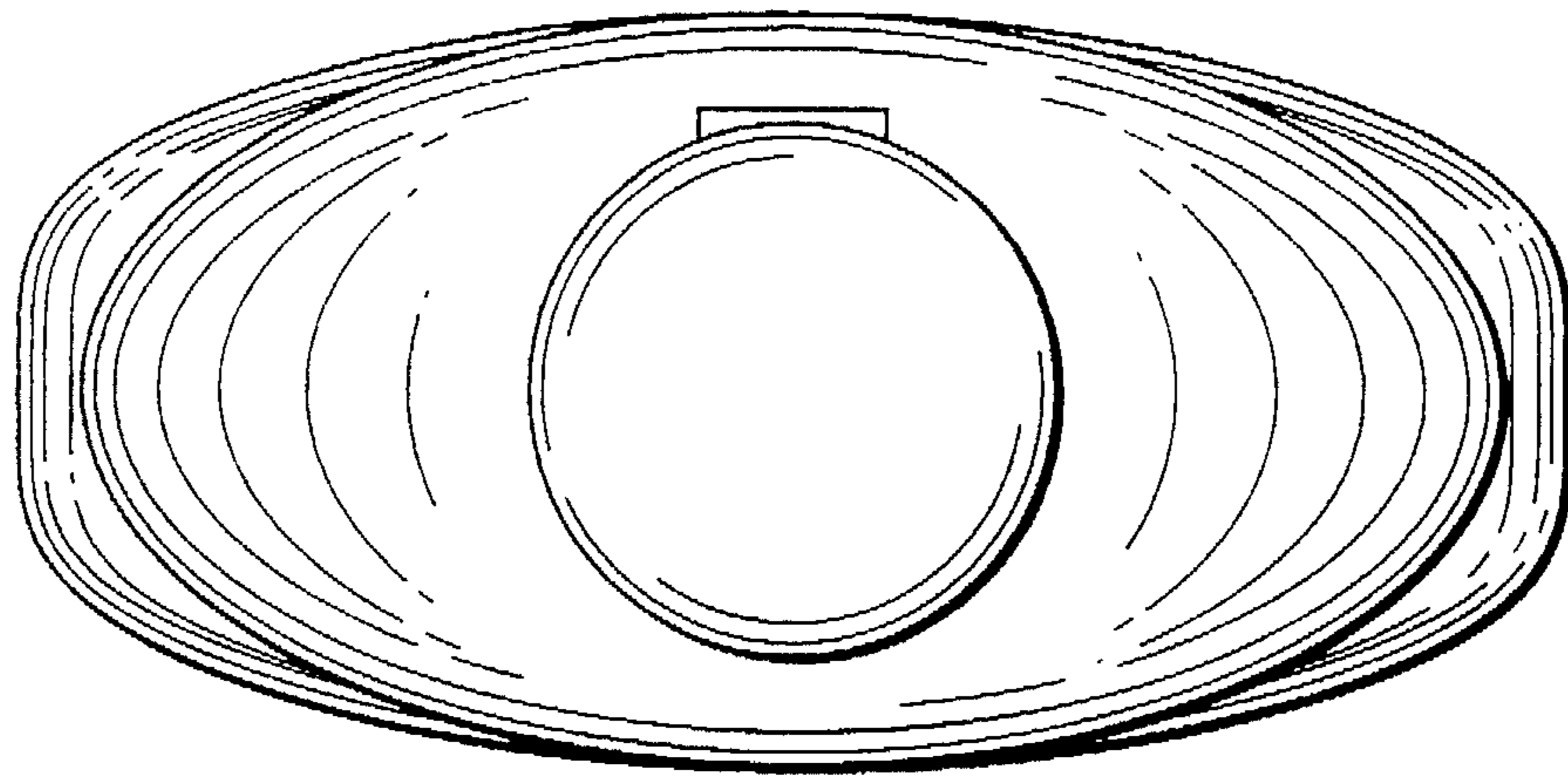

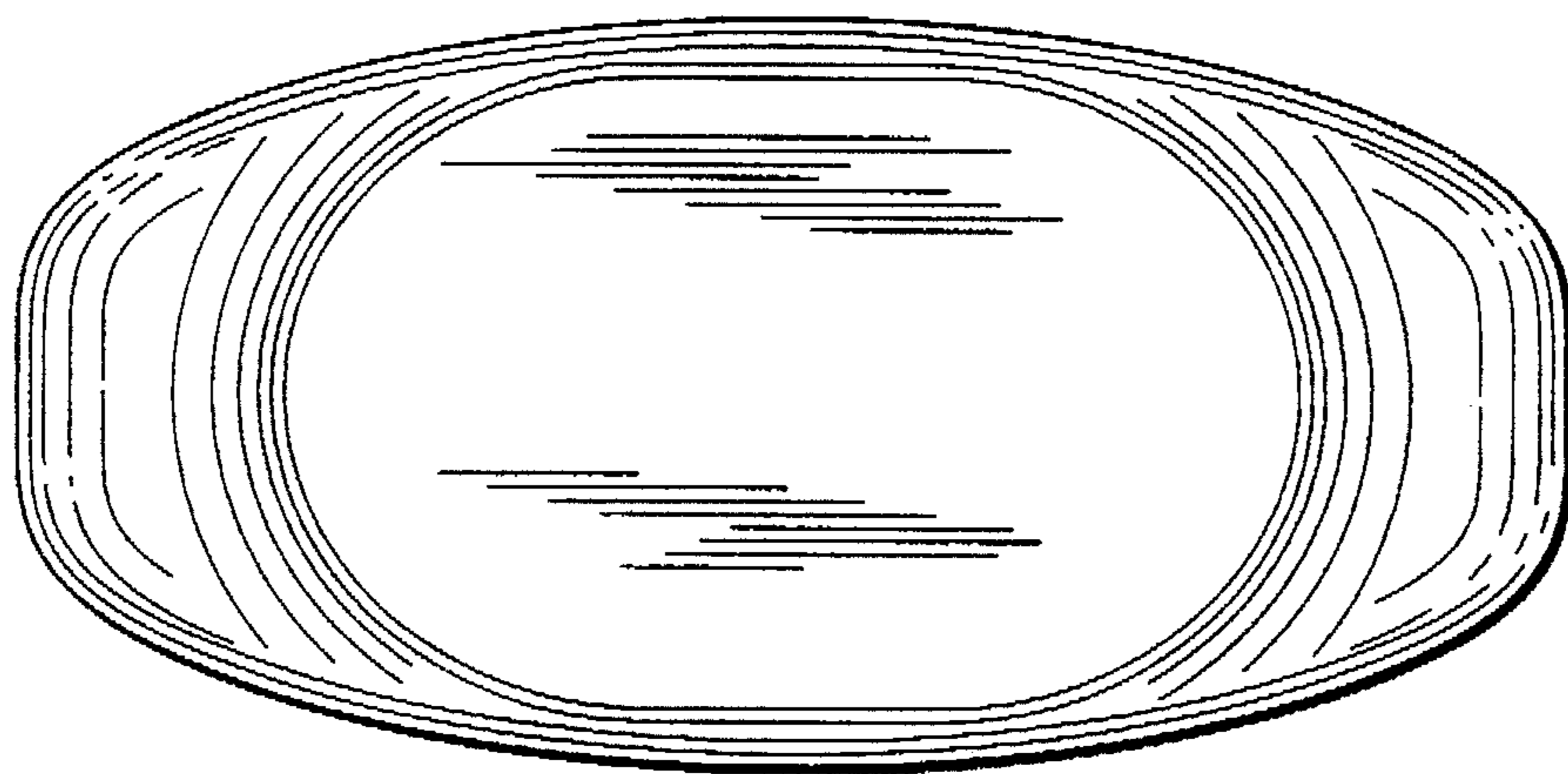
