**DESCRIPTION**

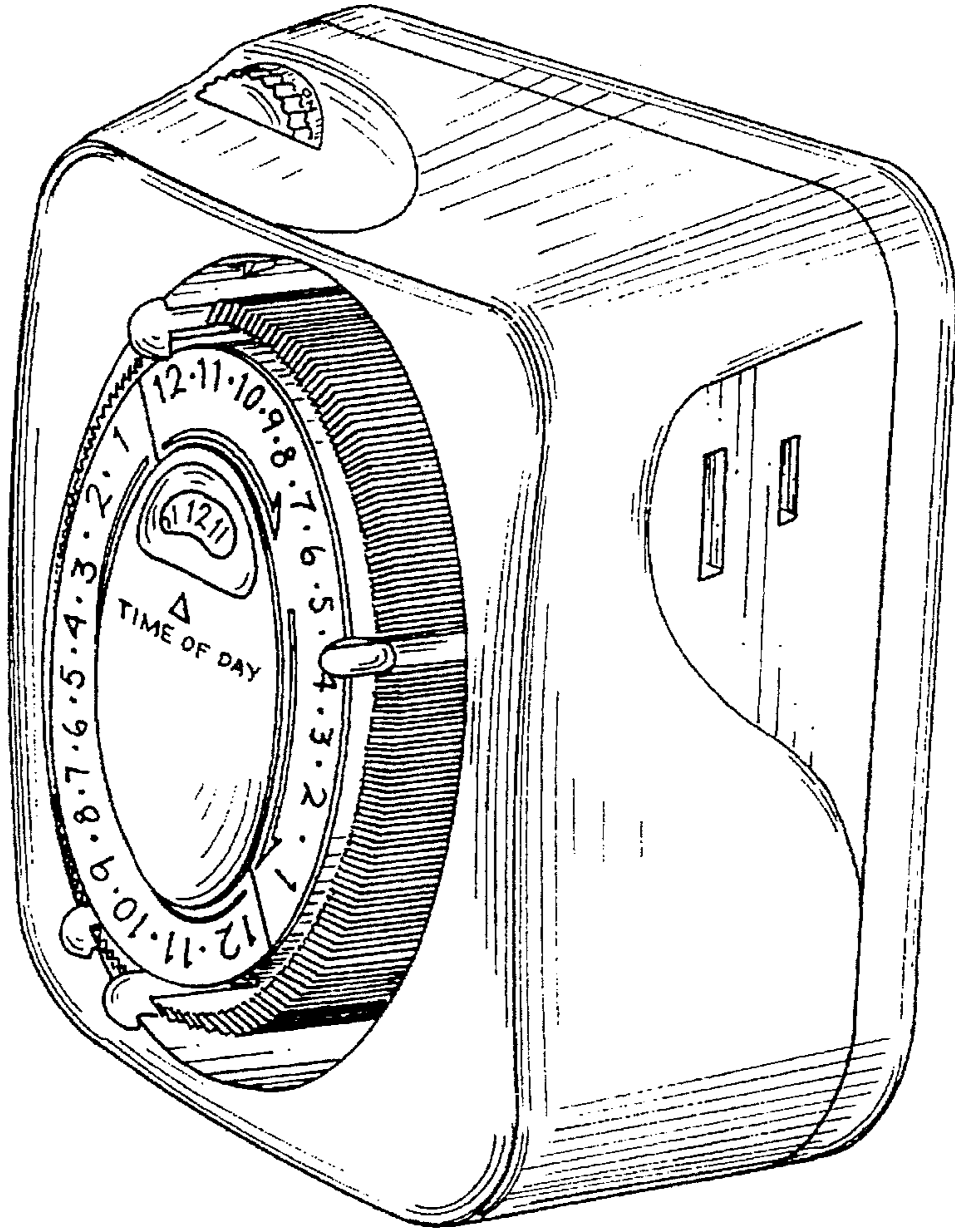
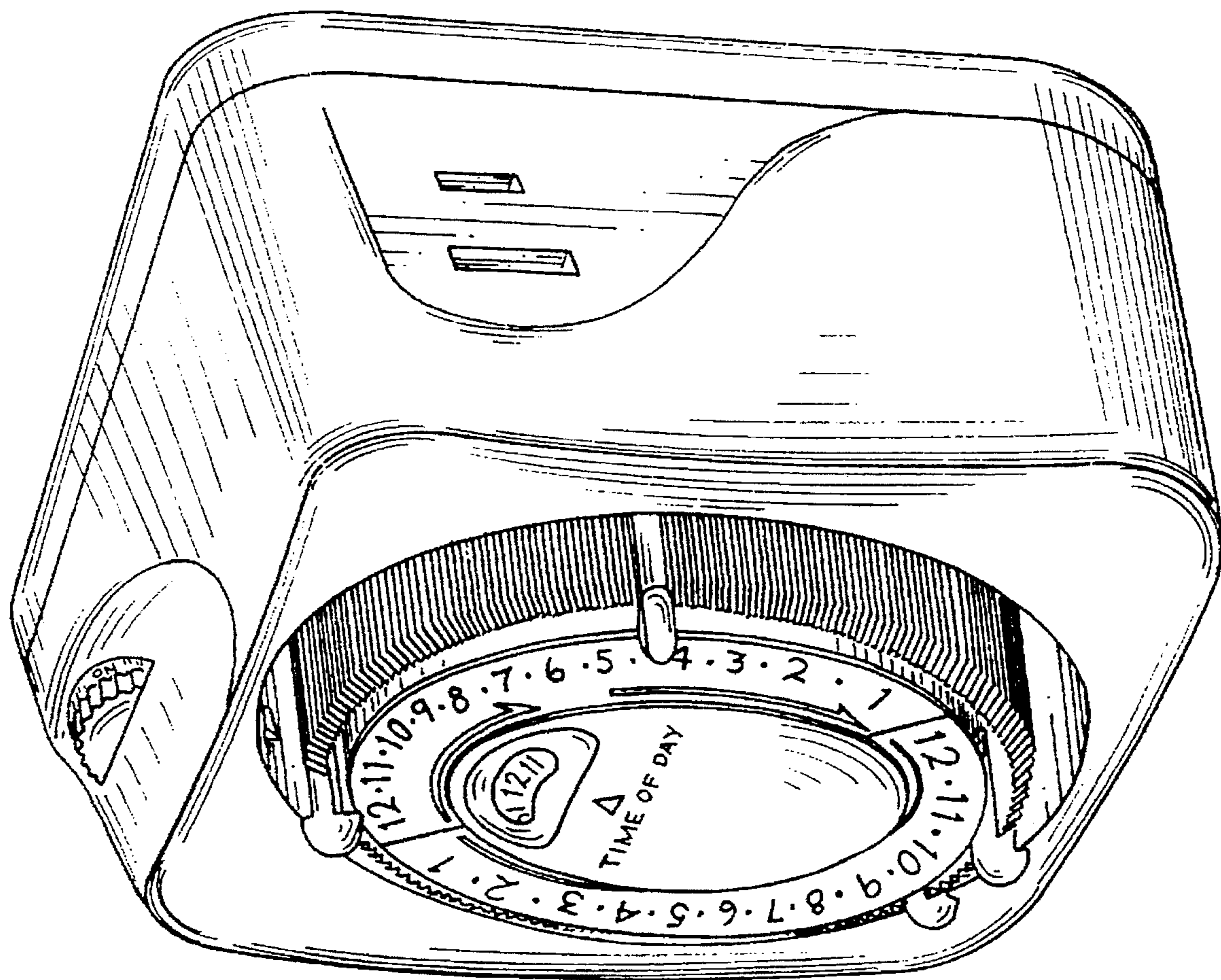
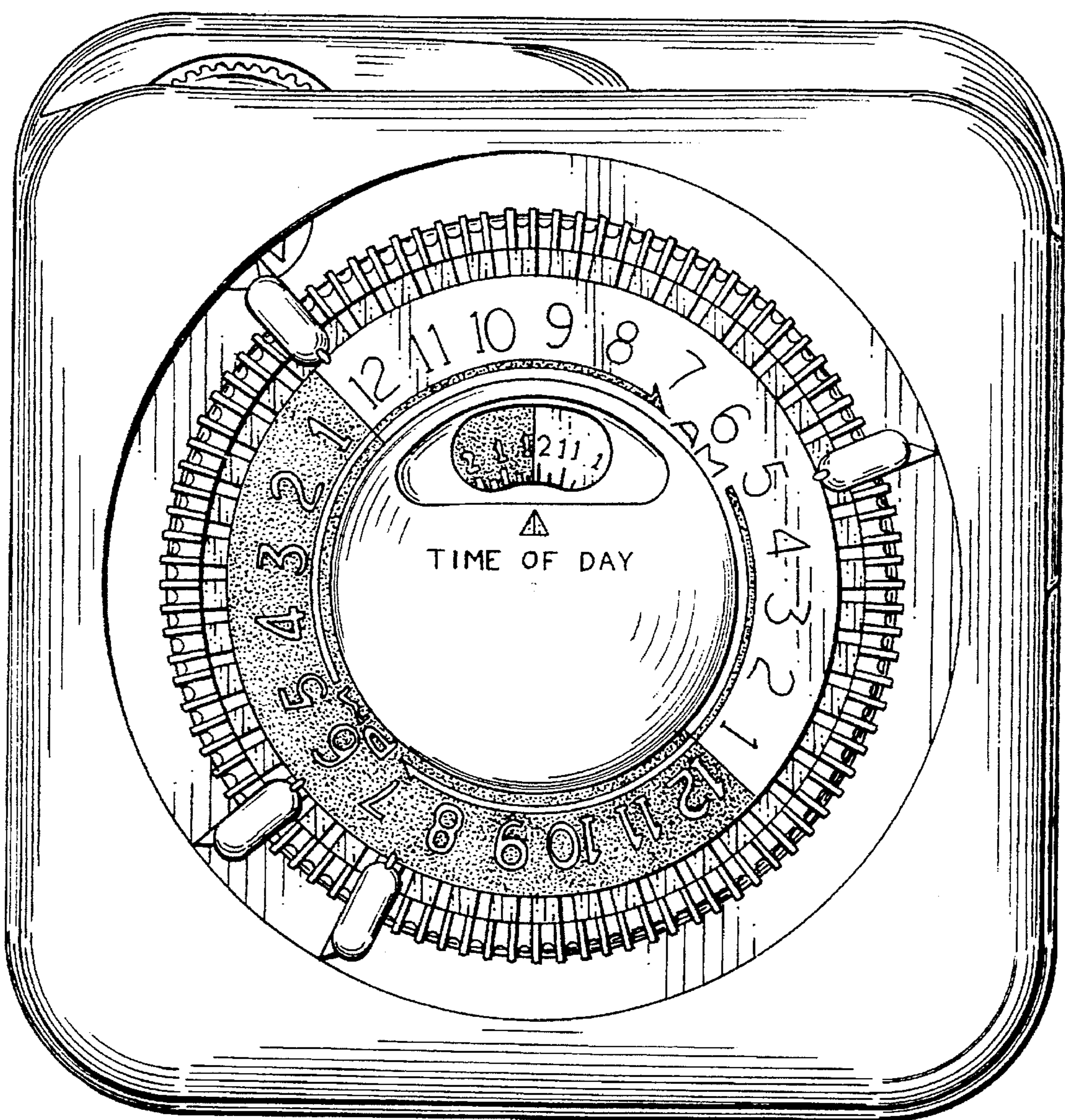


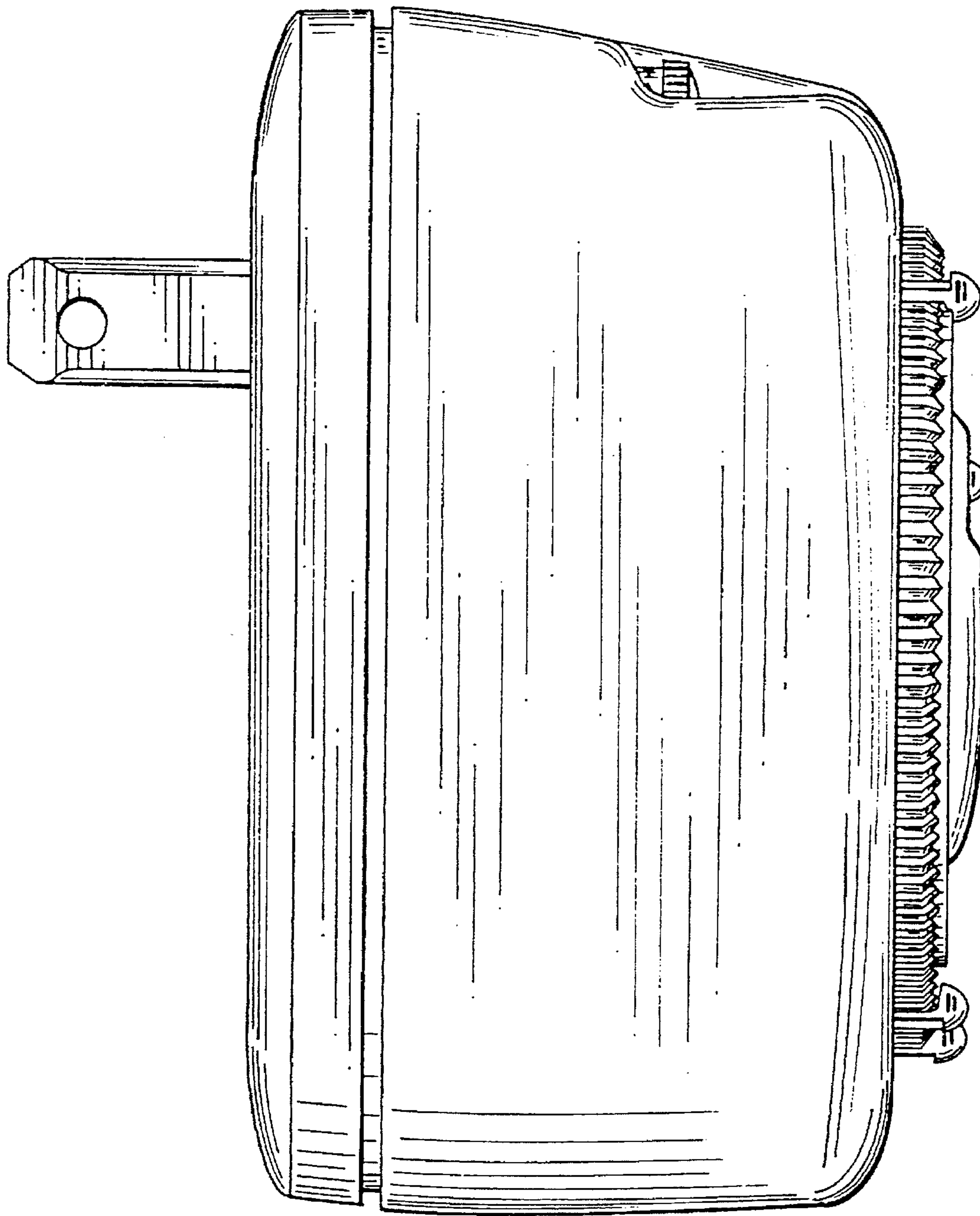

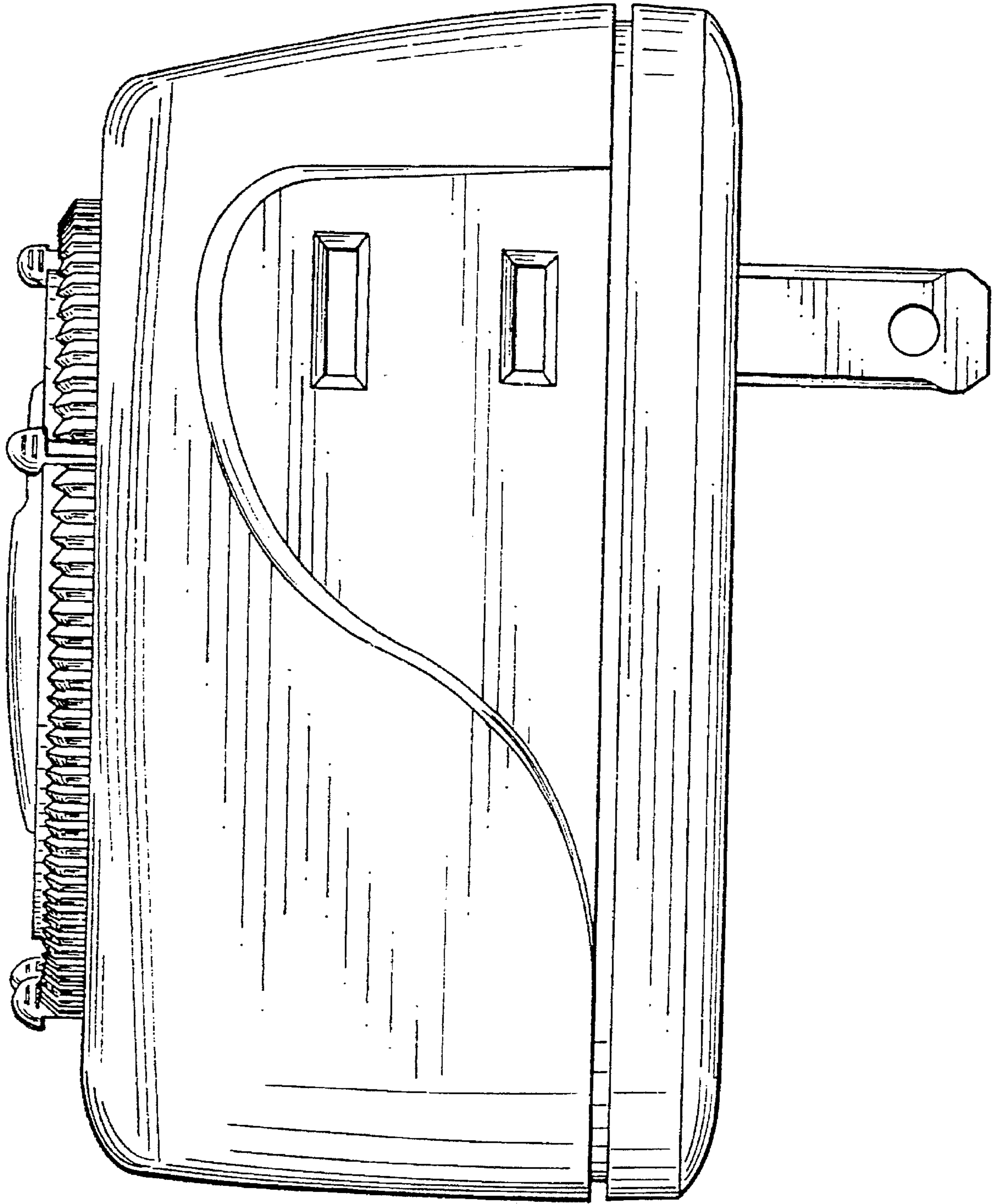

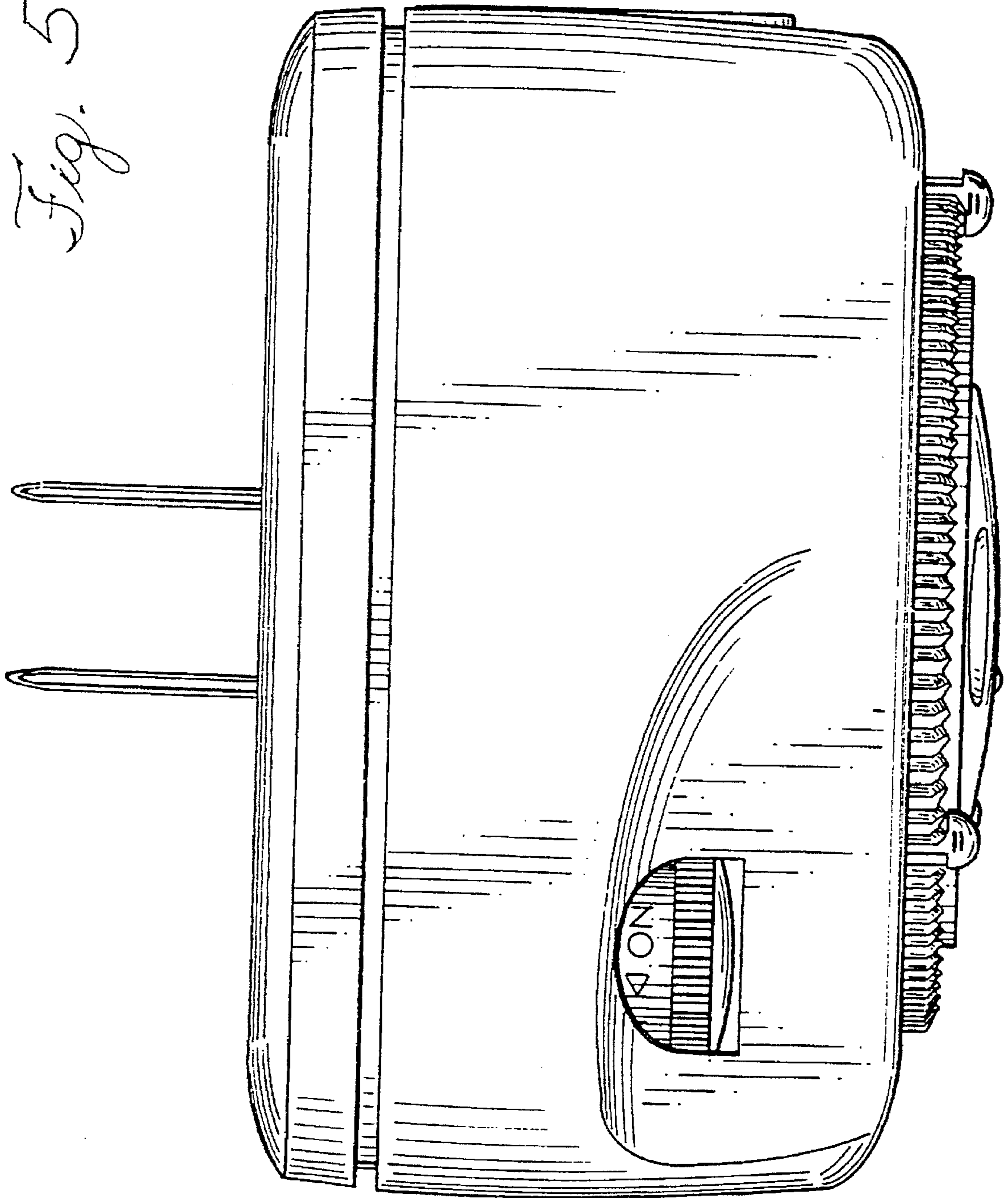

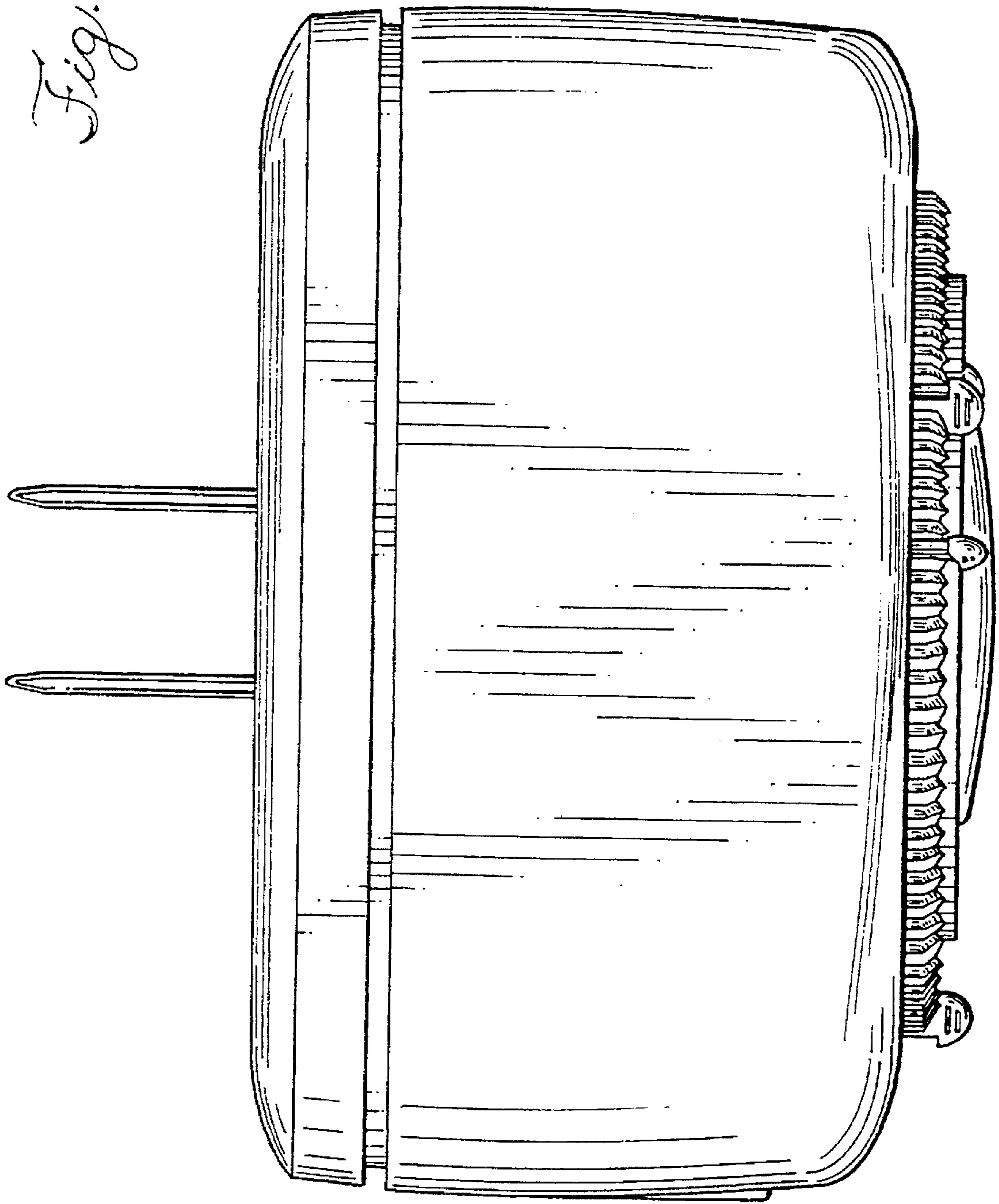
