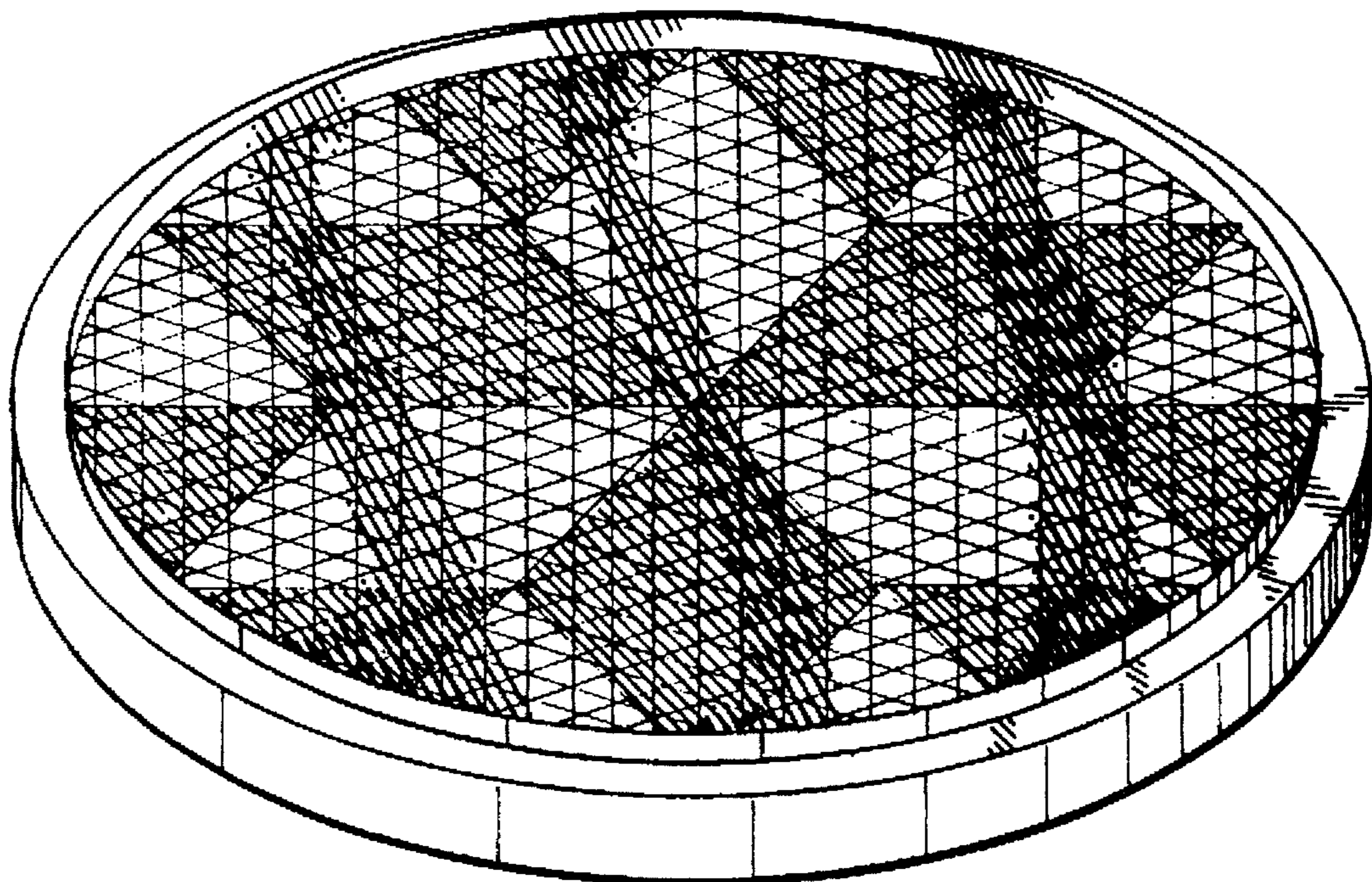
[57] **CLAIM**

The ornamental design for a star reflector, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a star reflector embodying my design;
FIG. 2 is a rear elevational view;
FIG. 3 is a left side elevational view, with the opposite sides being a mirror image; and,
FIG. 4 is a front perspective view.

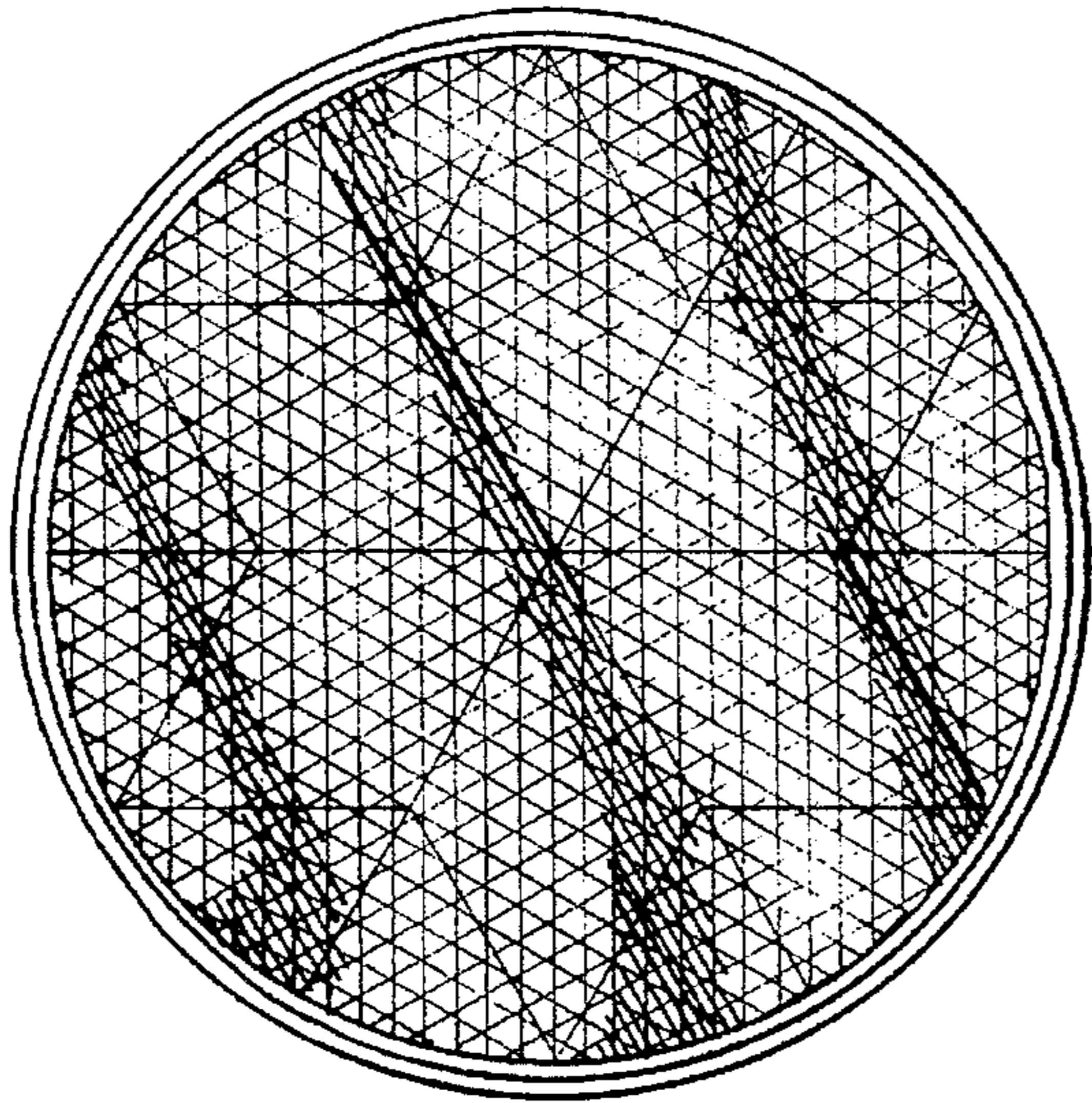

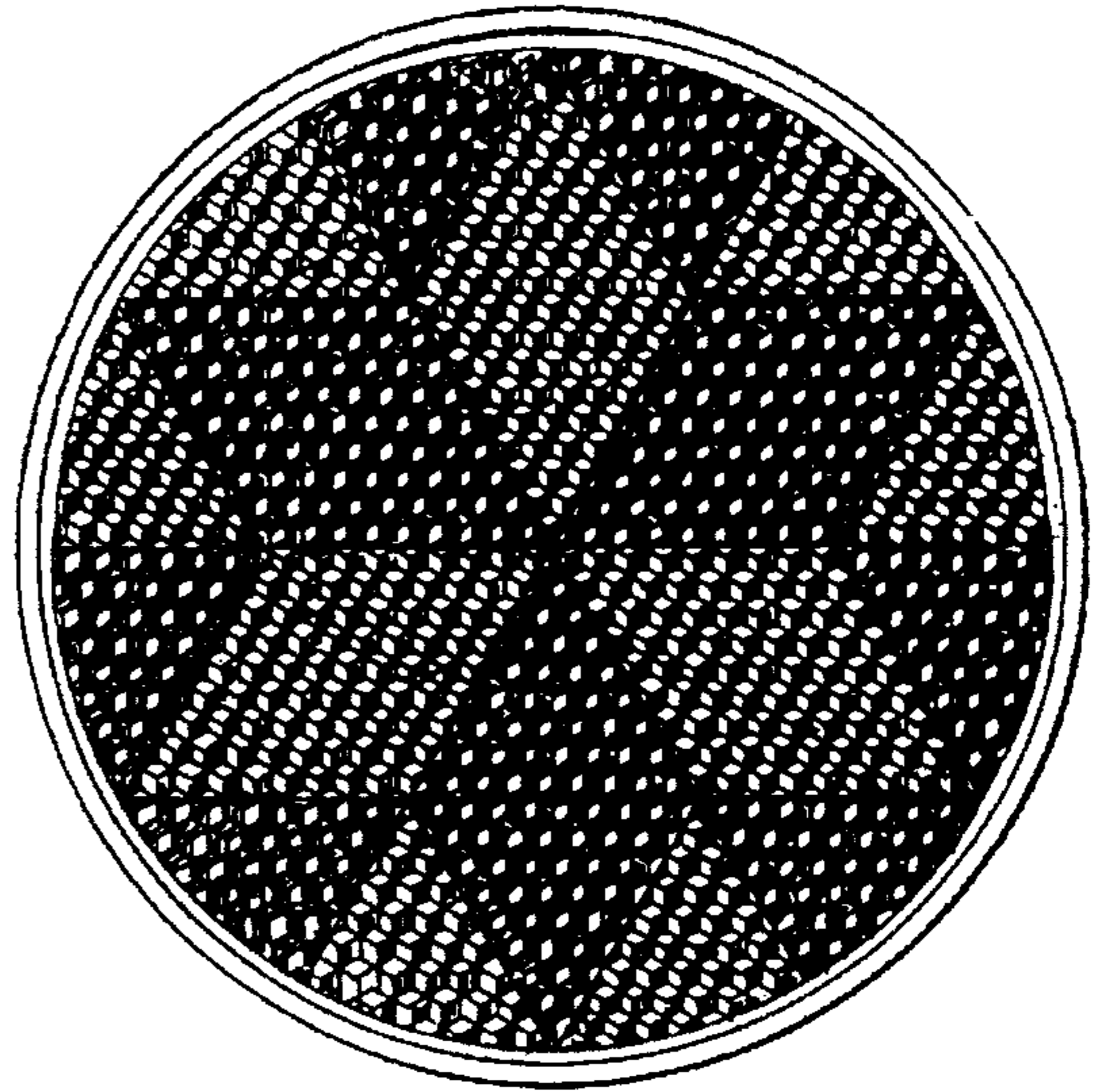

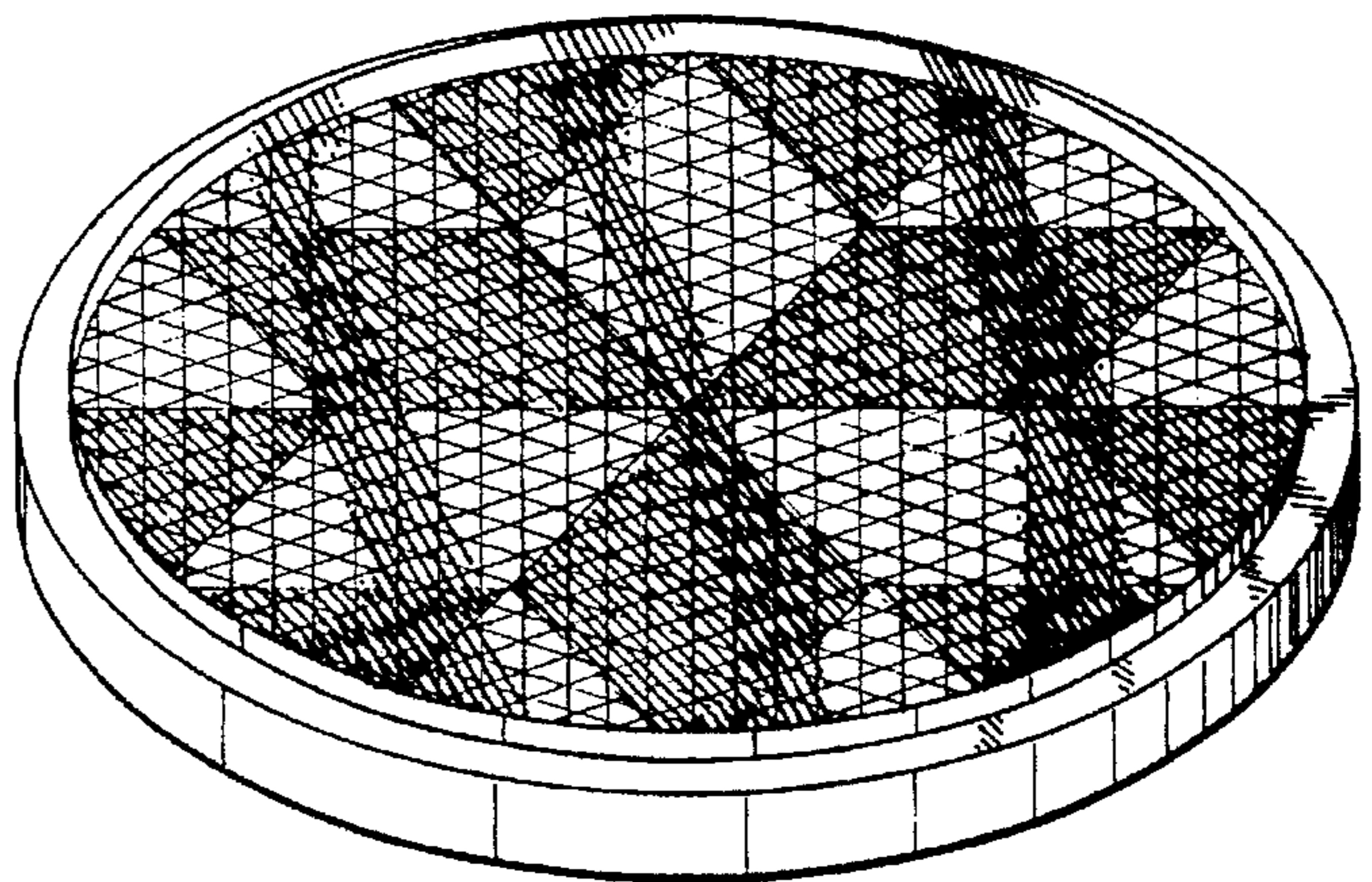
