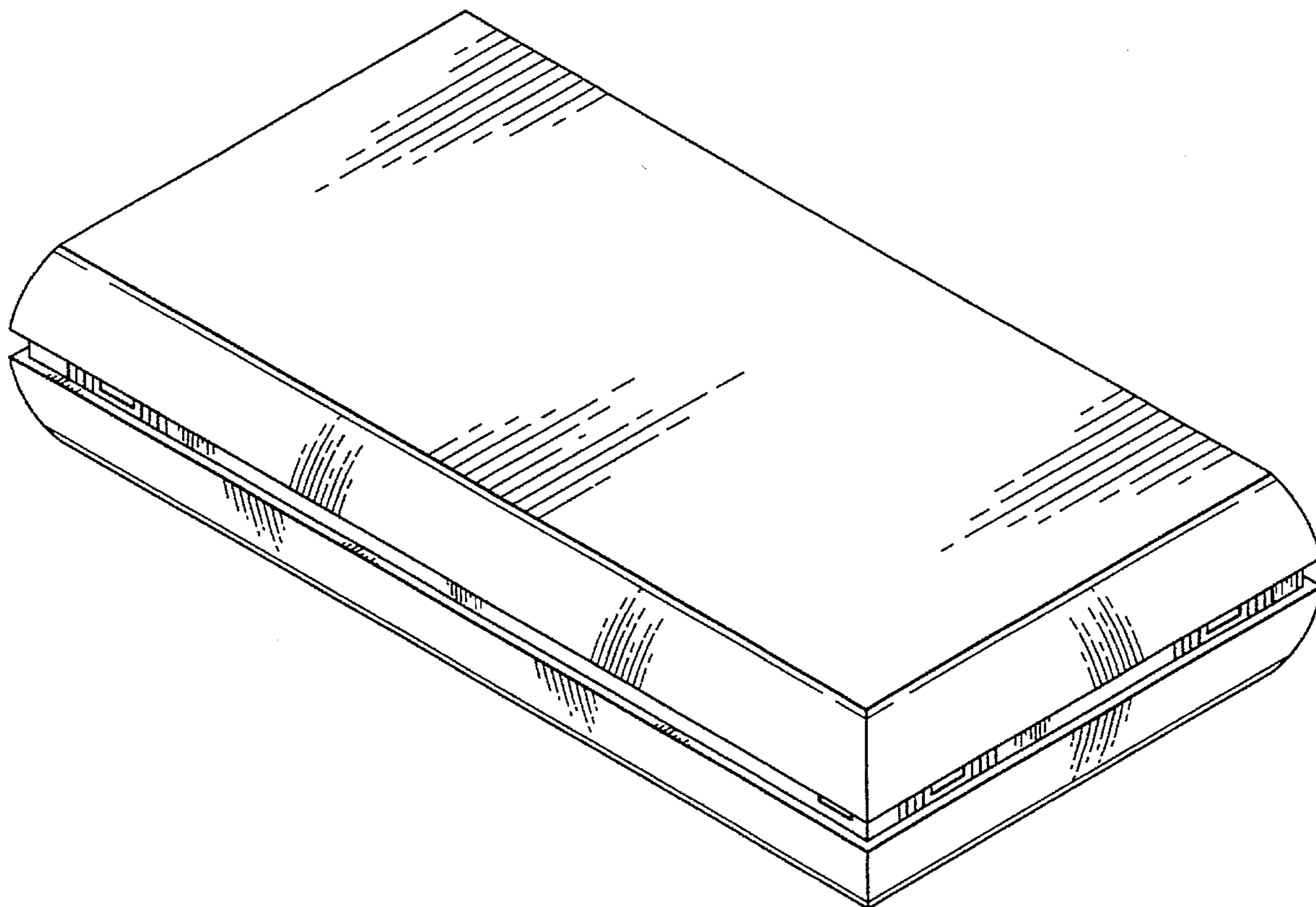
[57] **CLAIM**

The ornamental design for telecommunication apparatus housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the telecommunication apparatus housing embodying the invention;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a rear elevation view thereof, the front side being a mirror image thereof;  
FIG. 5 is a left end elevation view thereof; and,  
FIG. 6 is a bottom plan view thereof.

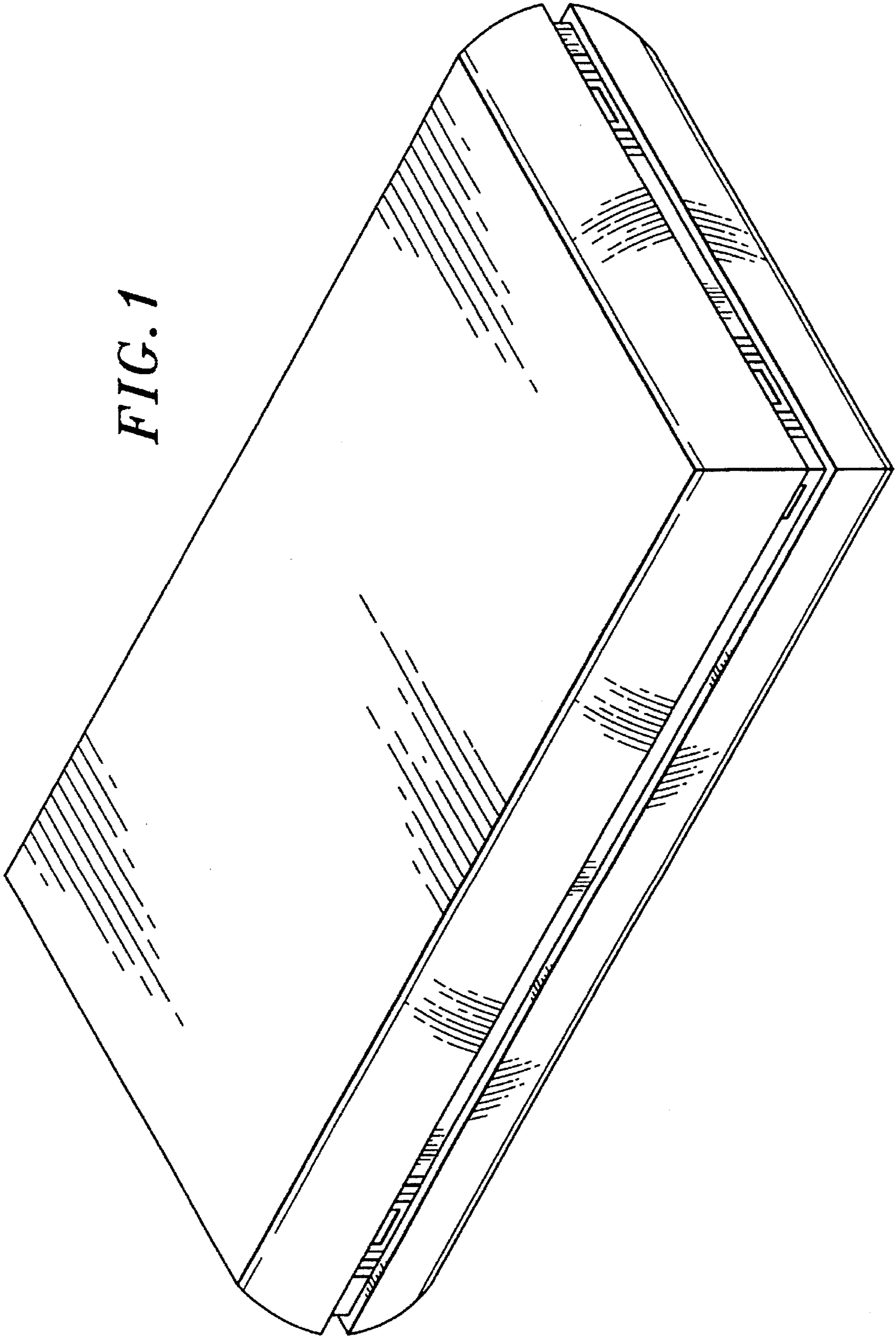

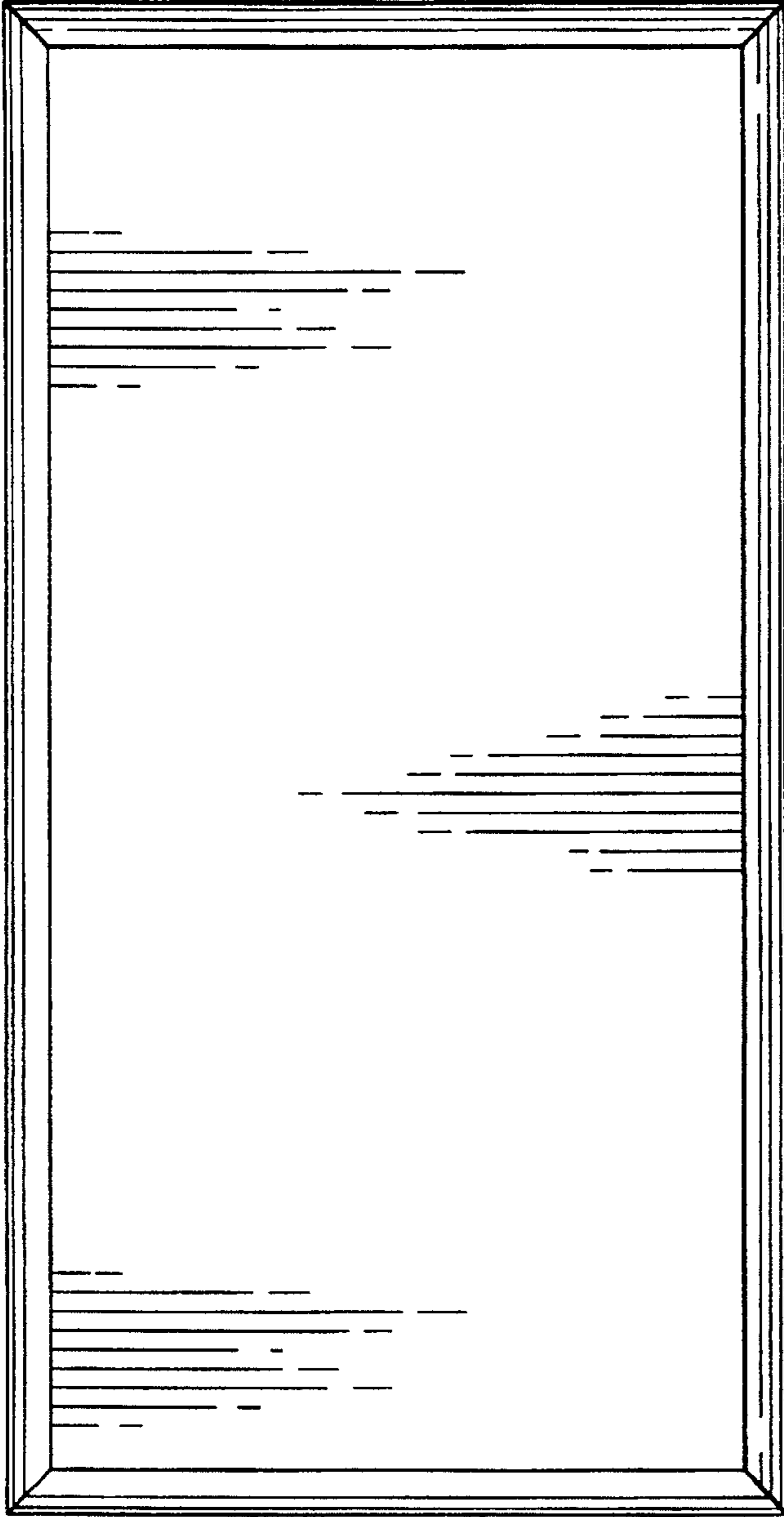
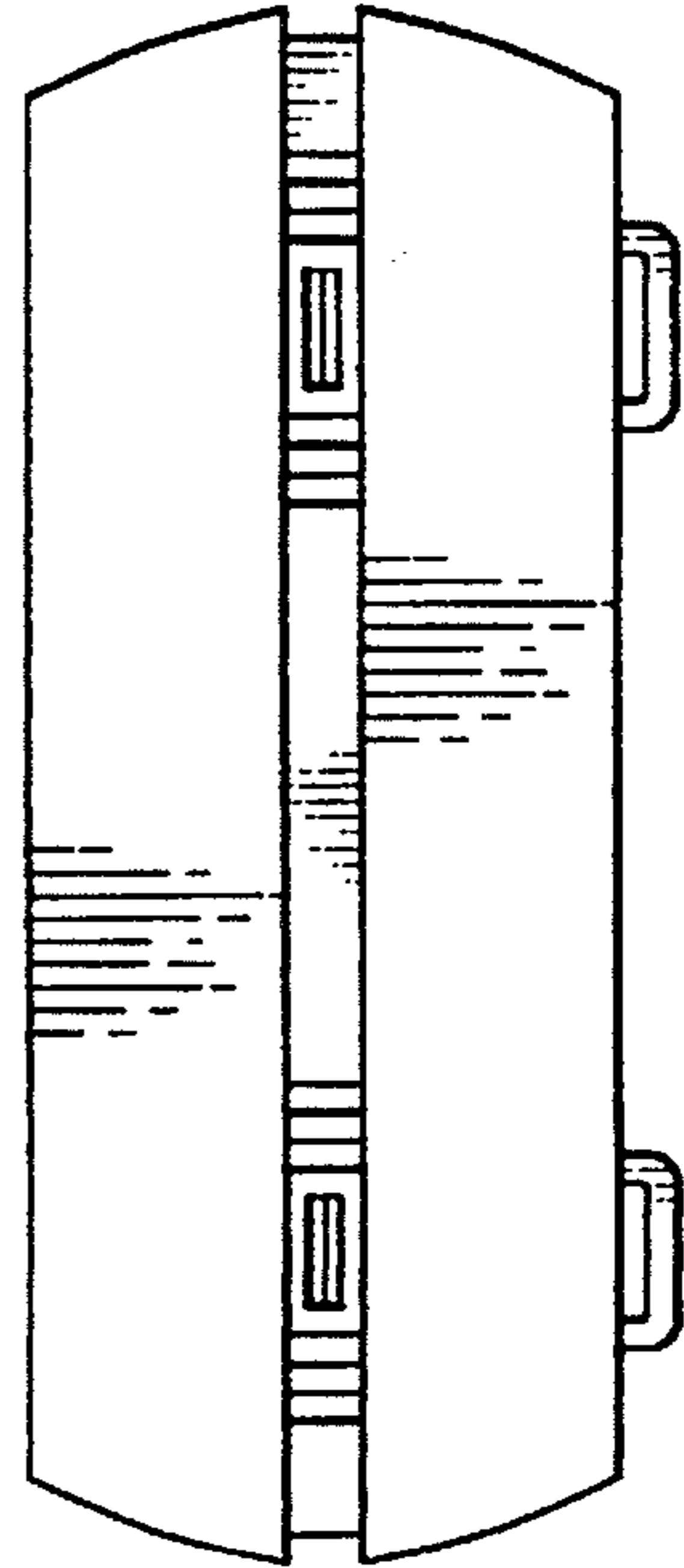
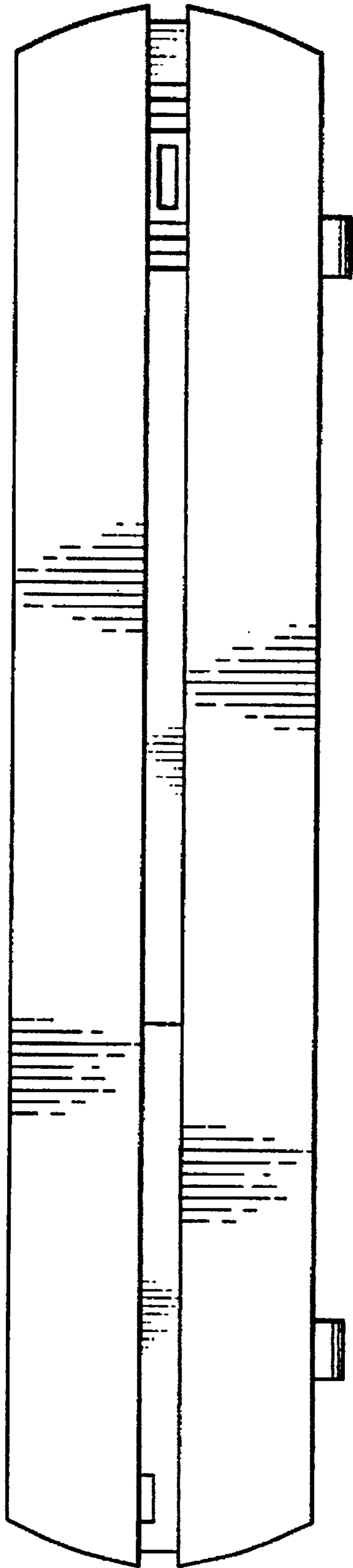

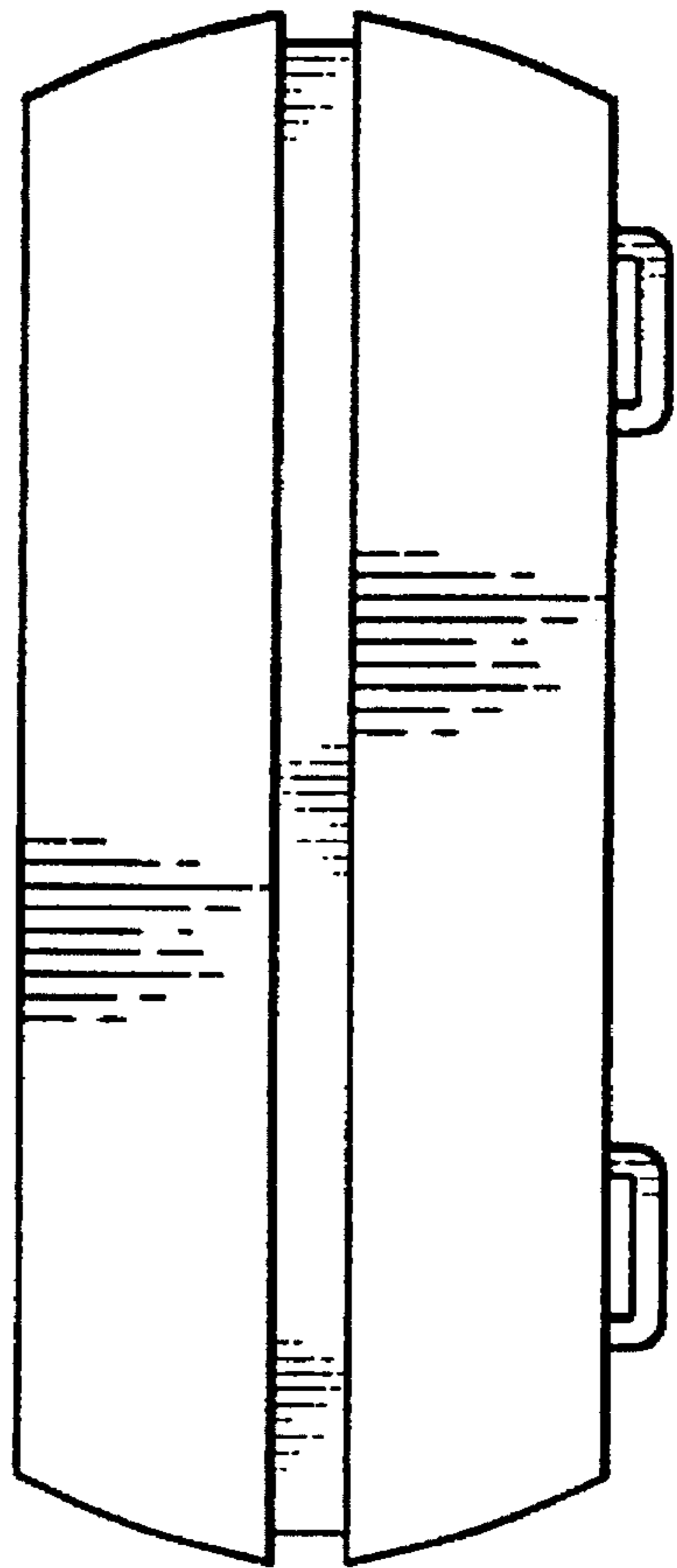
