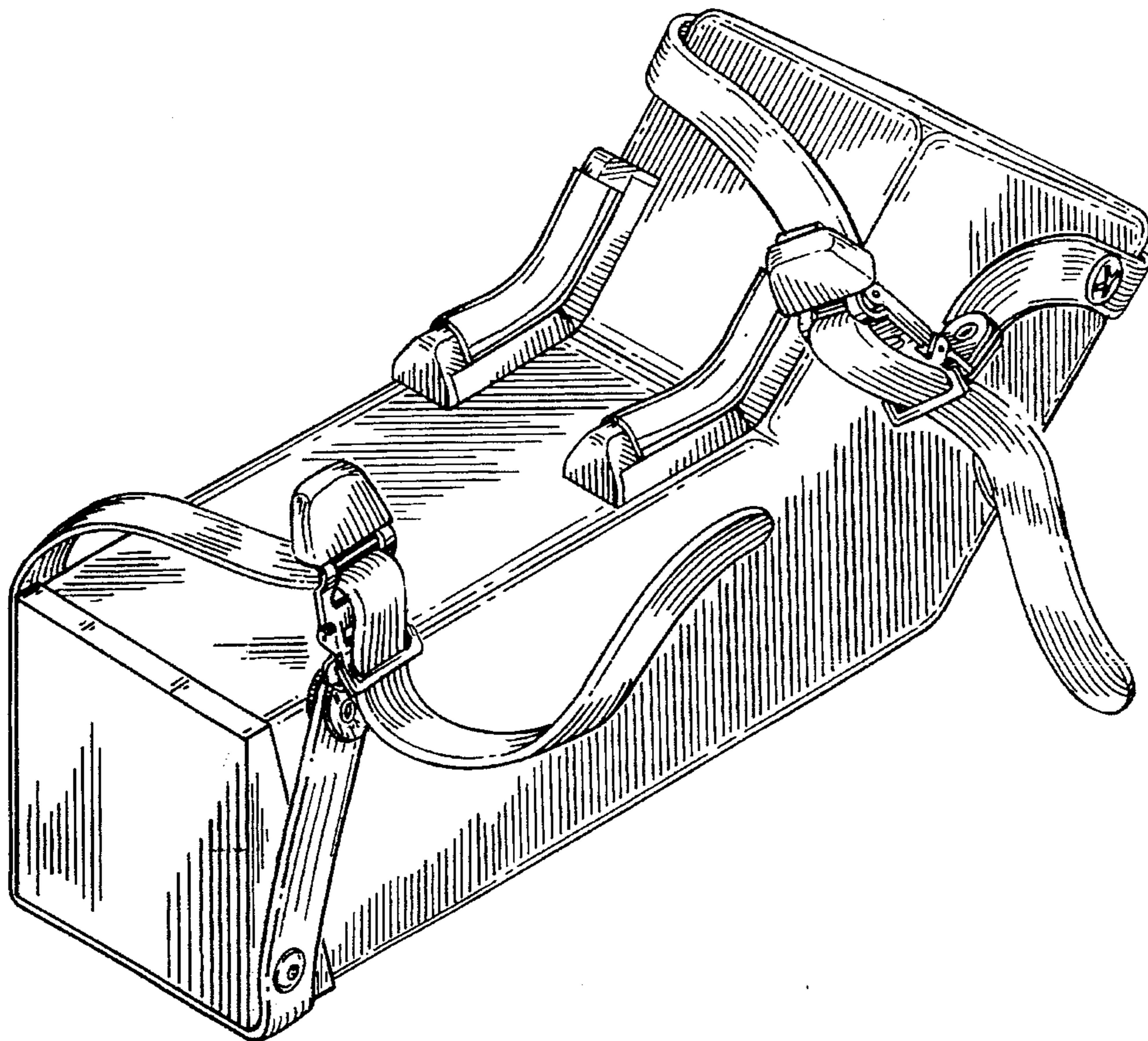

DESCRIPTION

FIG. 1 is a perspective view of a bicycle training weight showing the new design;
FIG. 2 is a side elevation view thereof;
FIG. 3 is a side elevation view thereof, opposite that shown in FIG. 2;
FIG. 4 is an end elevation view thereof;
FIG. 5 is an end elevation view thereof, opposite that shown in FIG. 4;

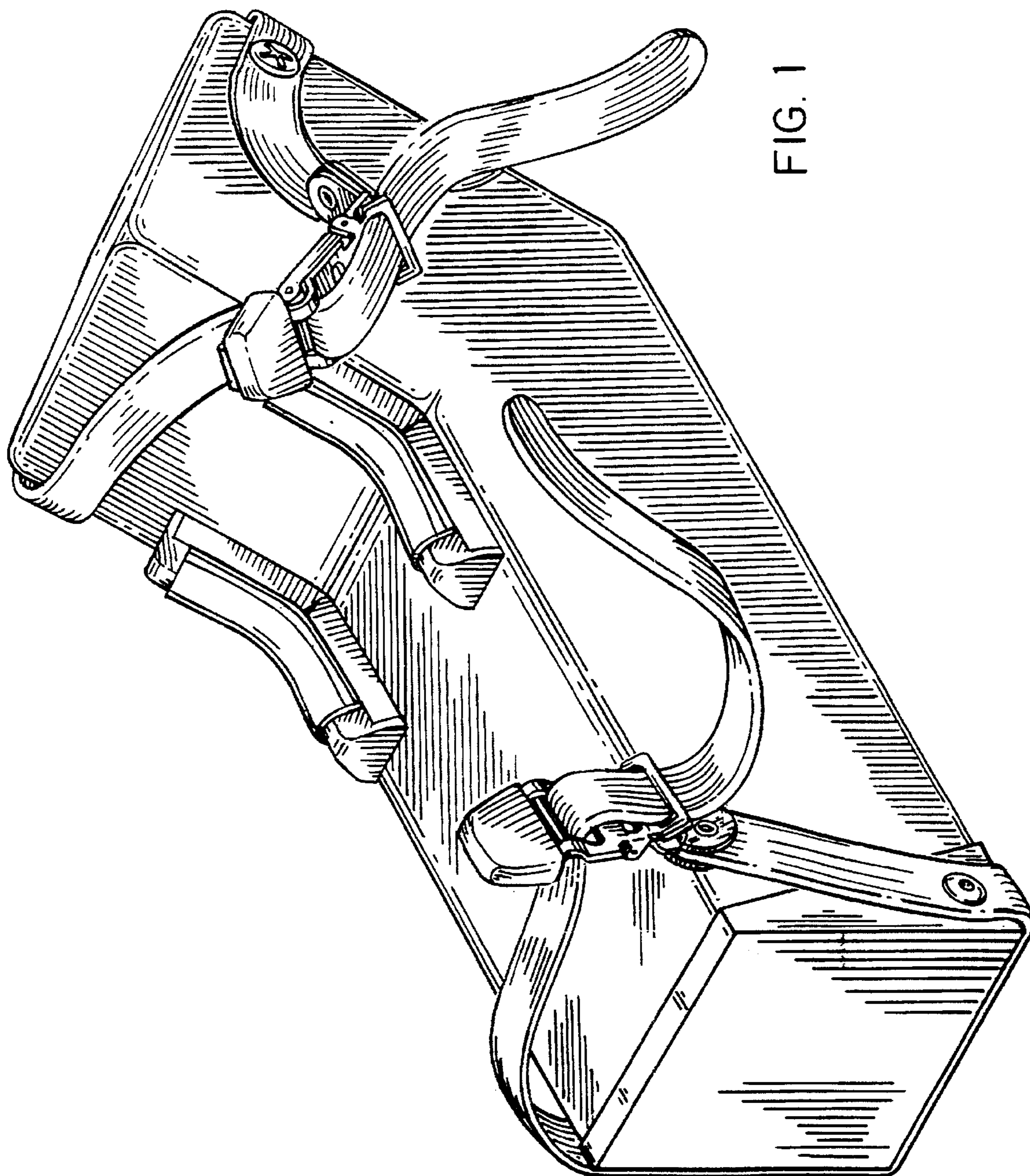

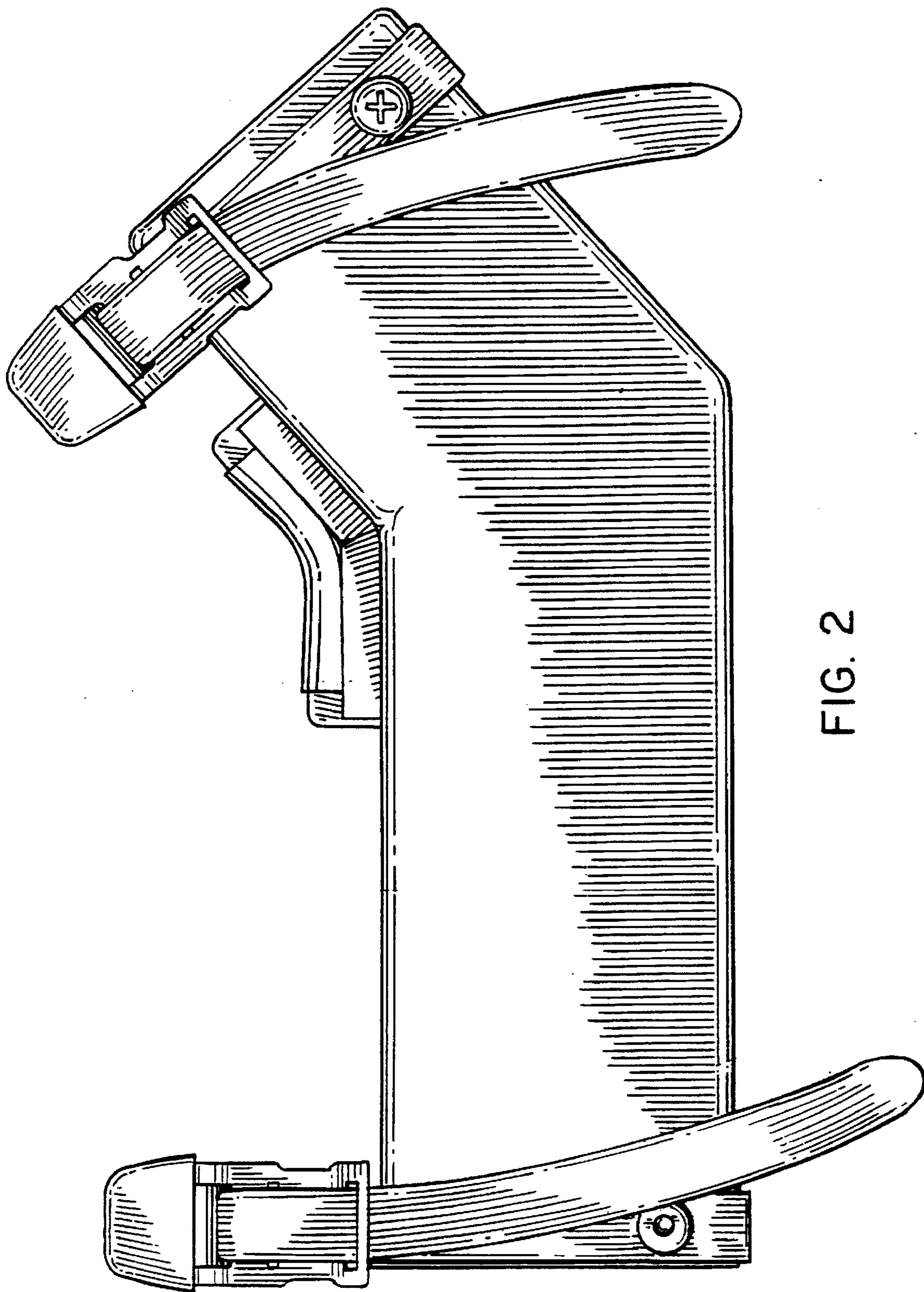

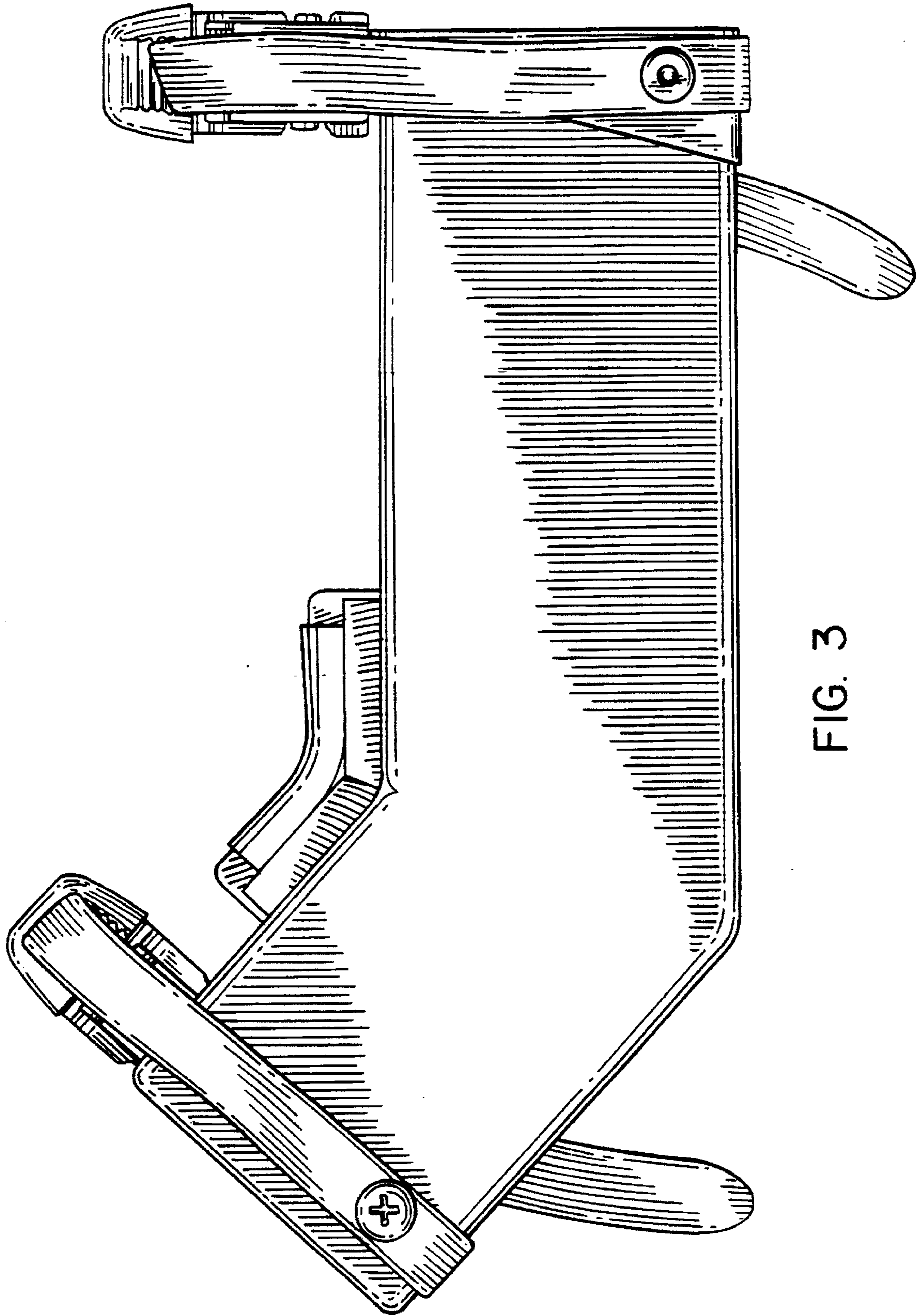

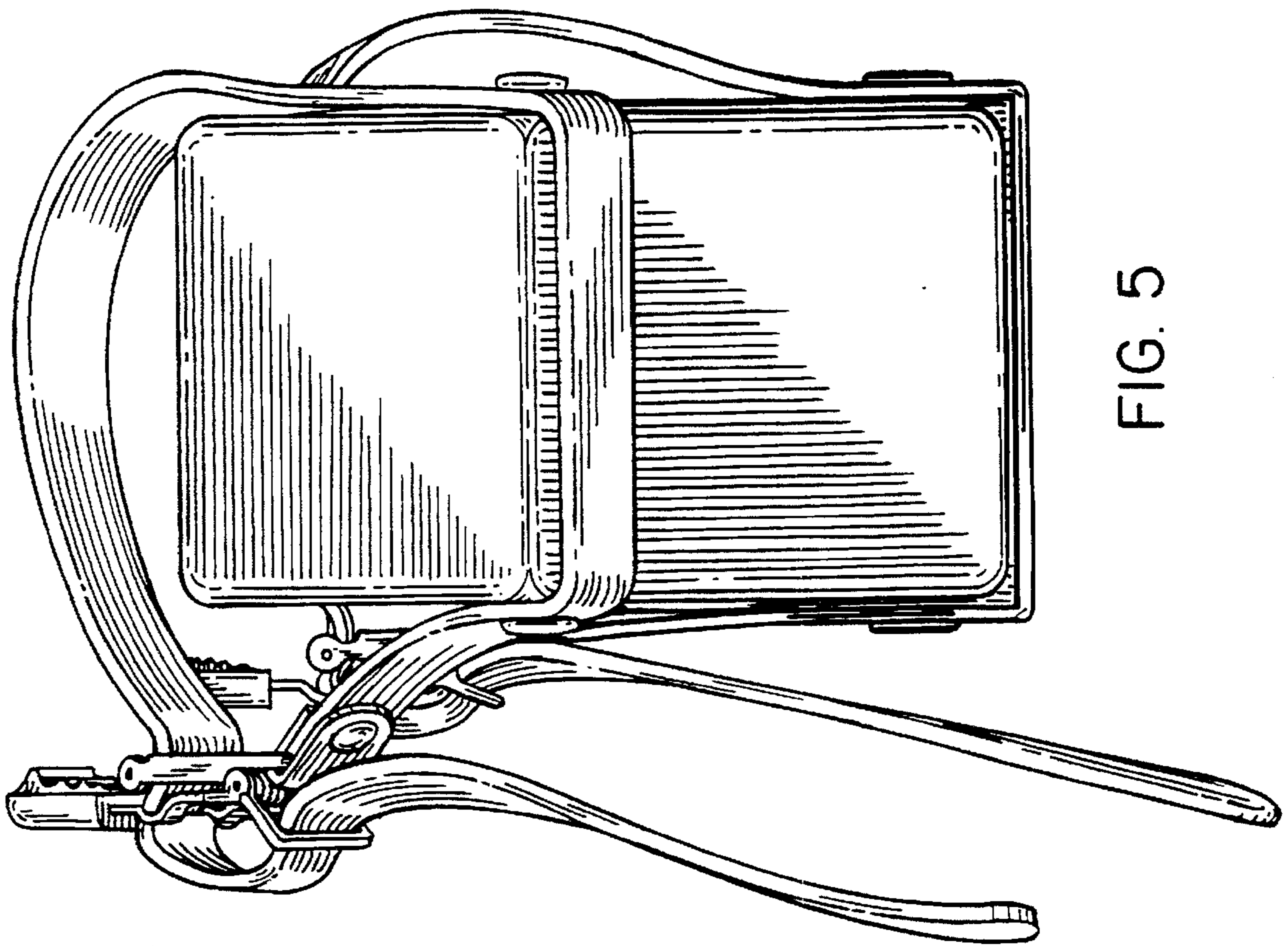

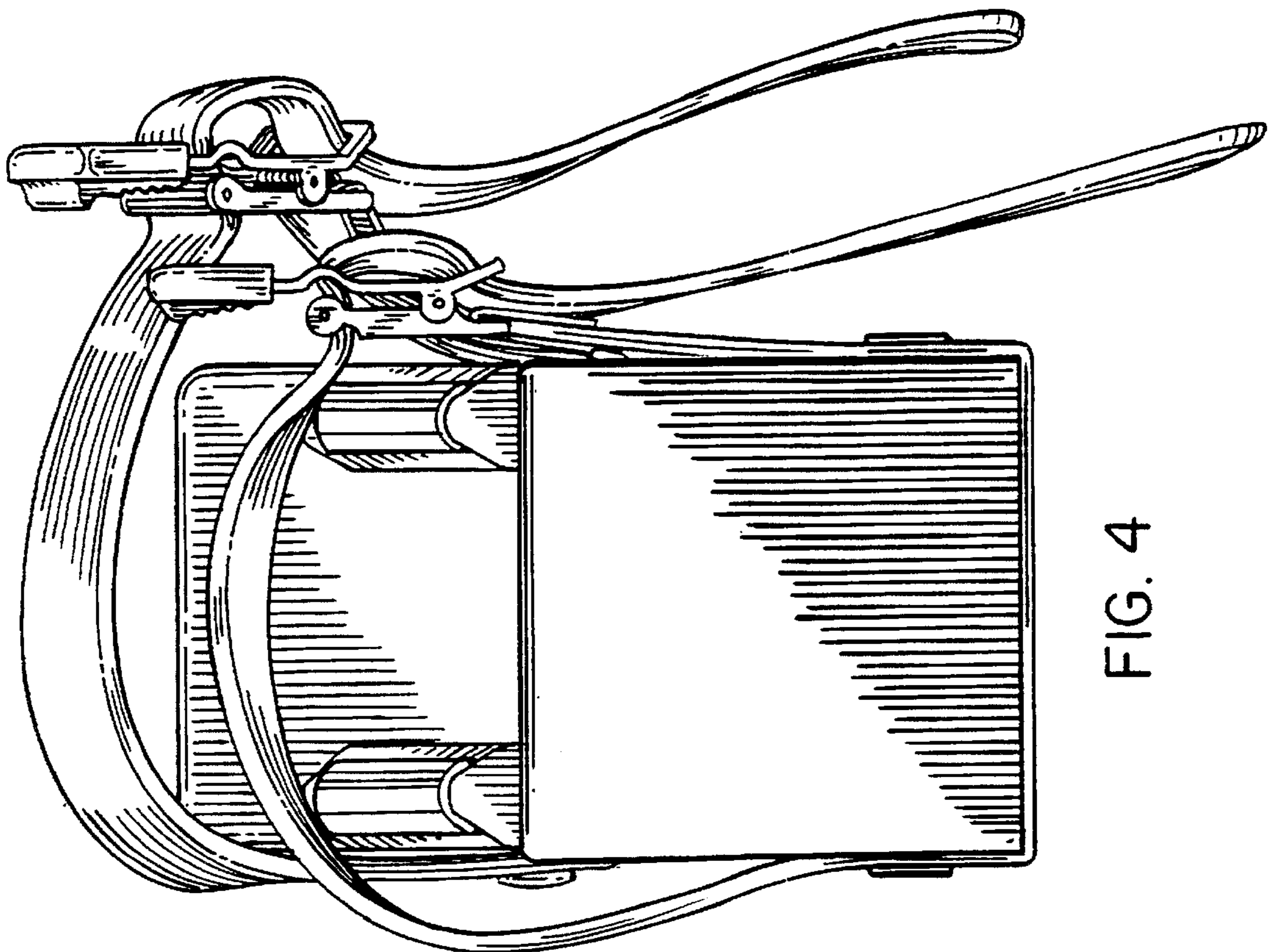

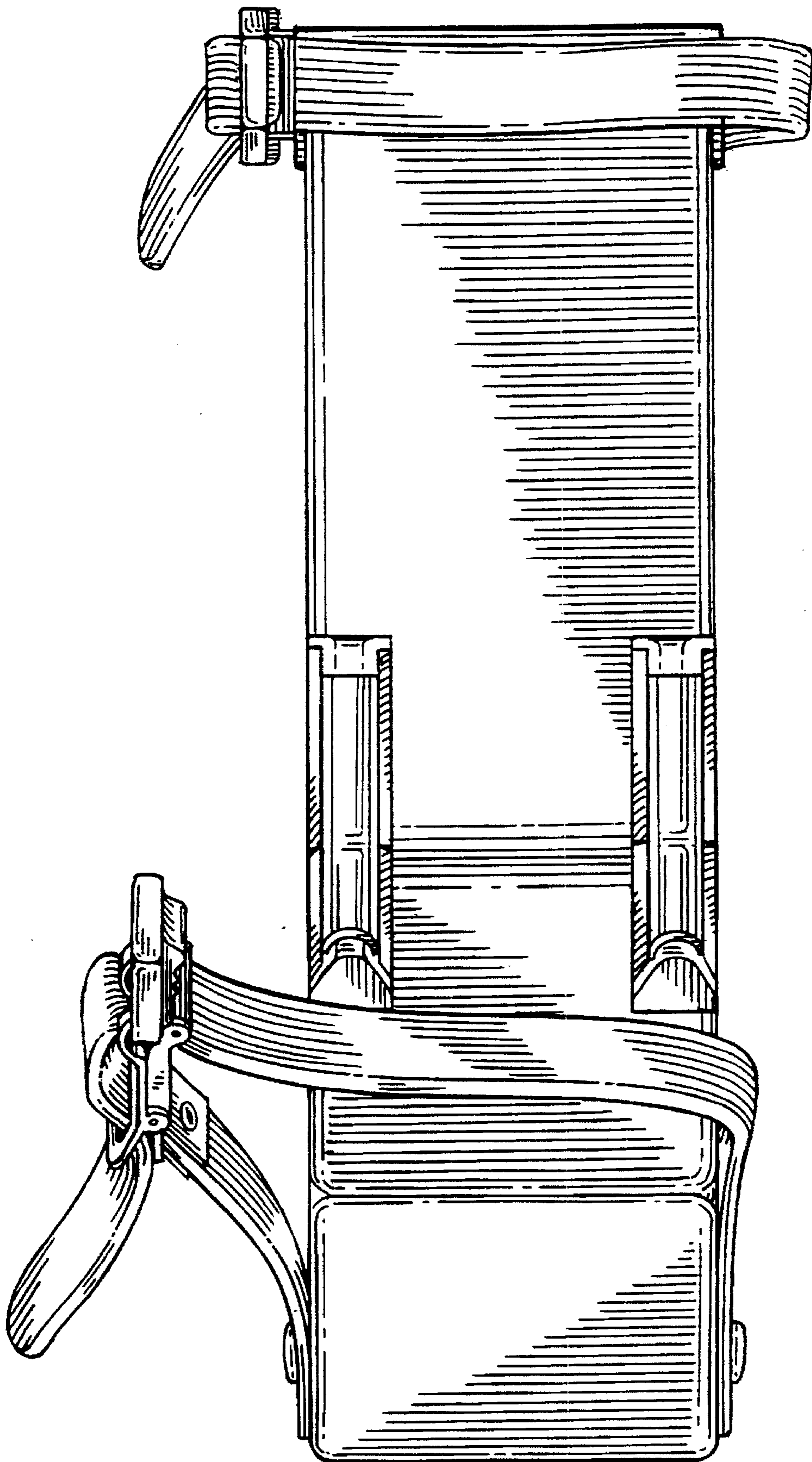

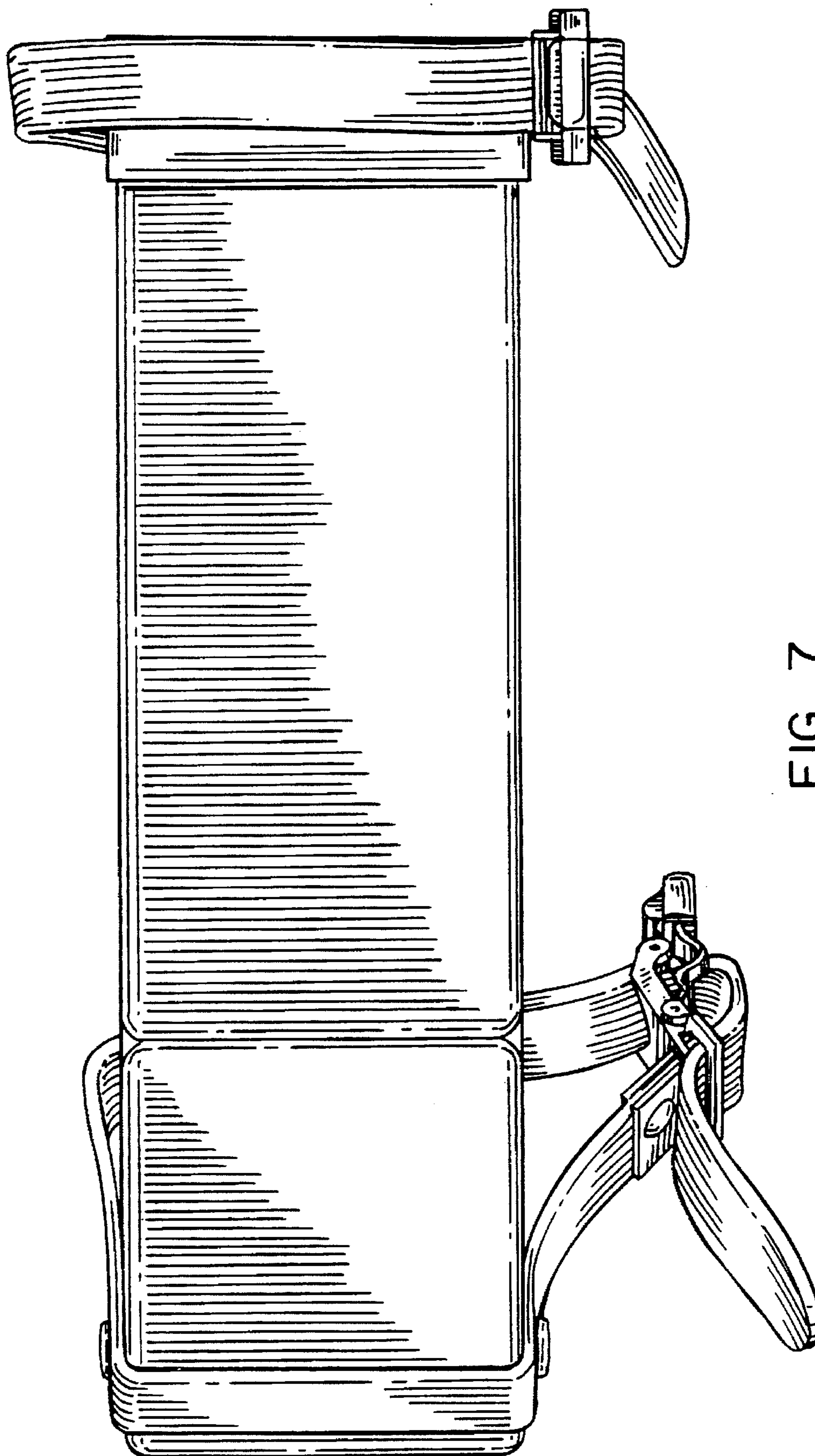
