**DESCRIPTION**

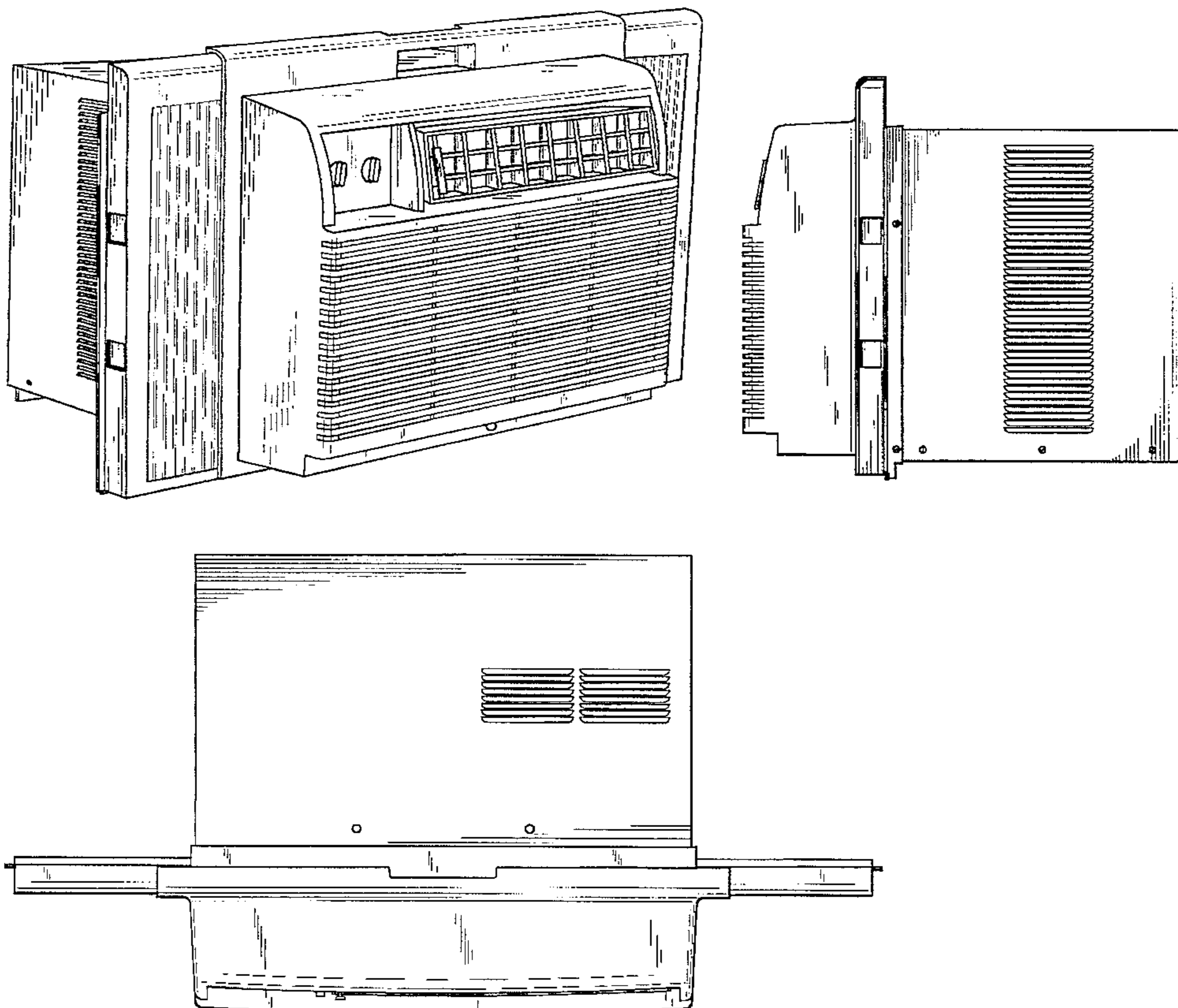
FIG. 1 is a perspective view of an integrated compact air conditioner, showing my new design;

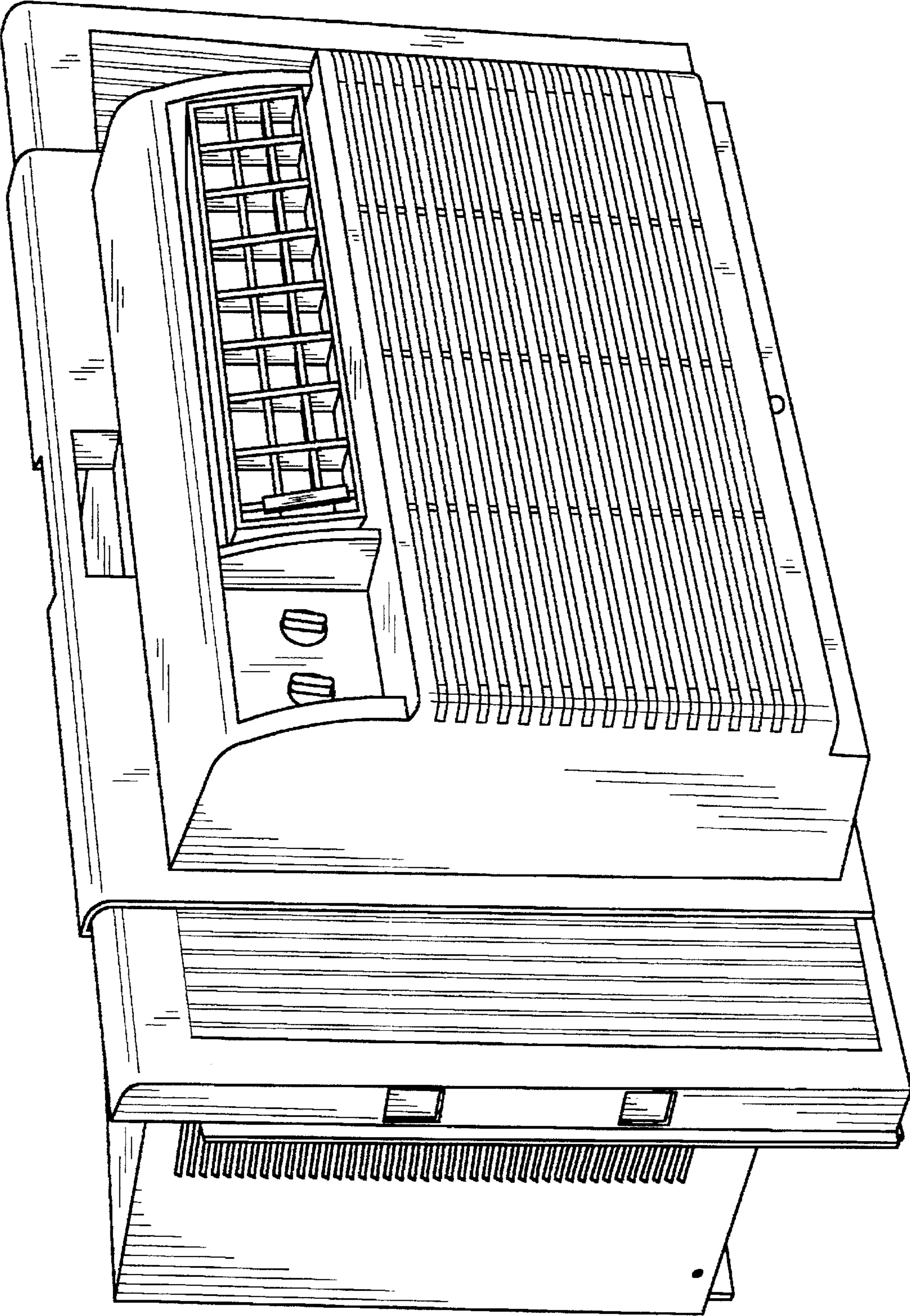

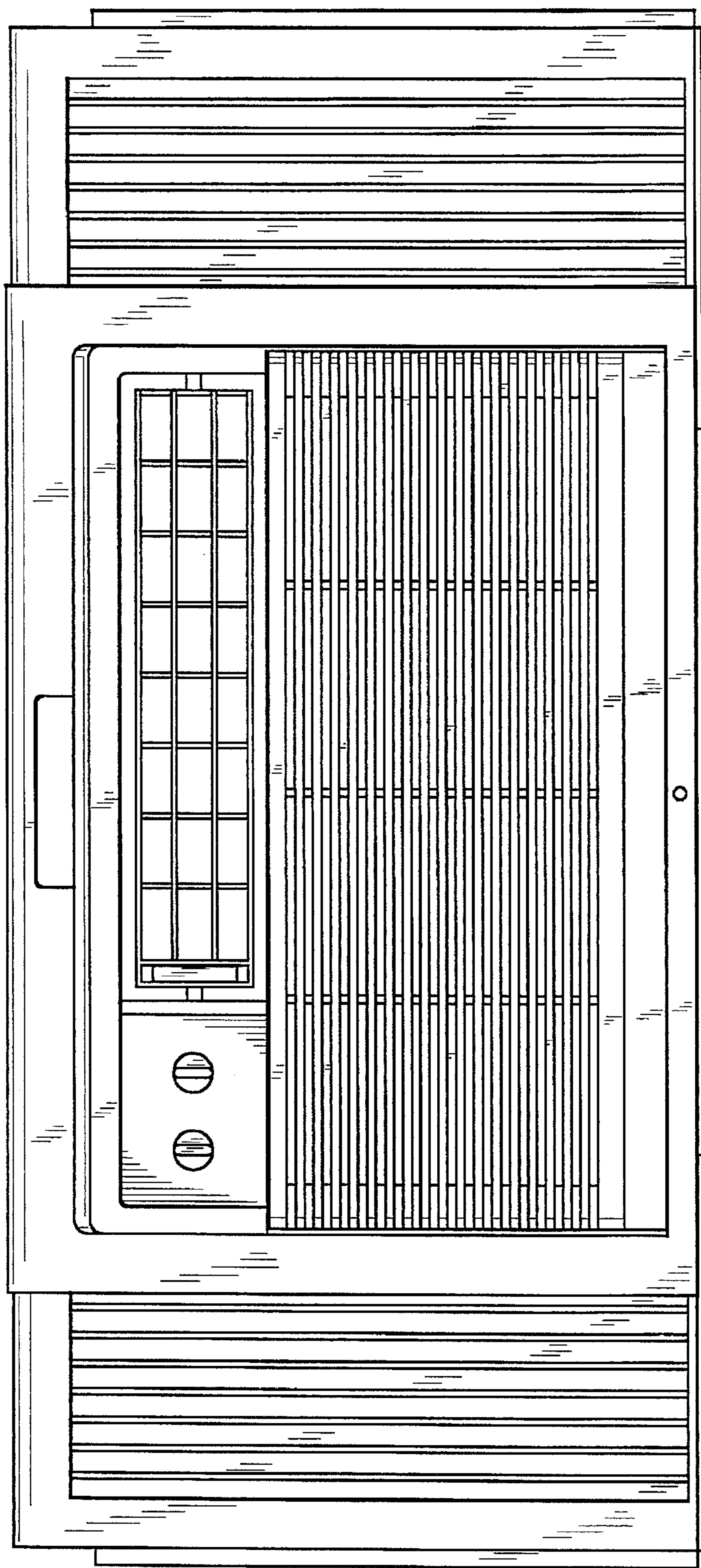

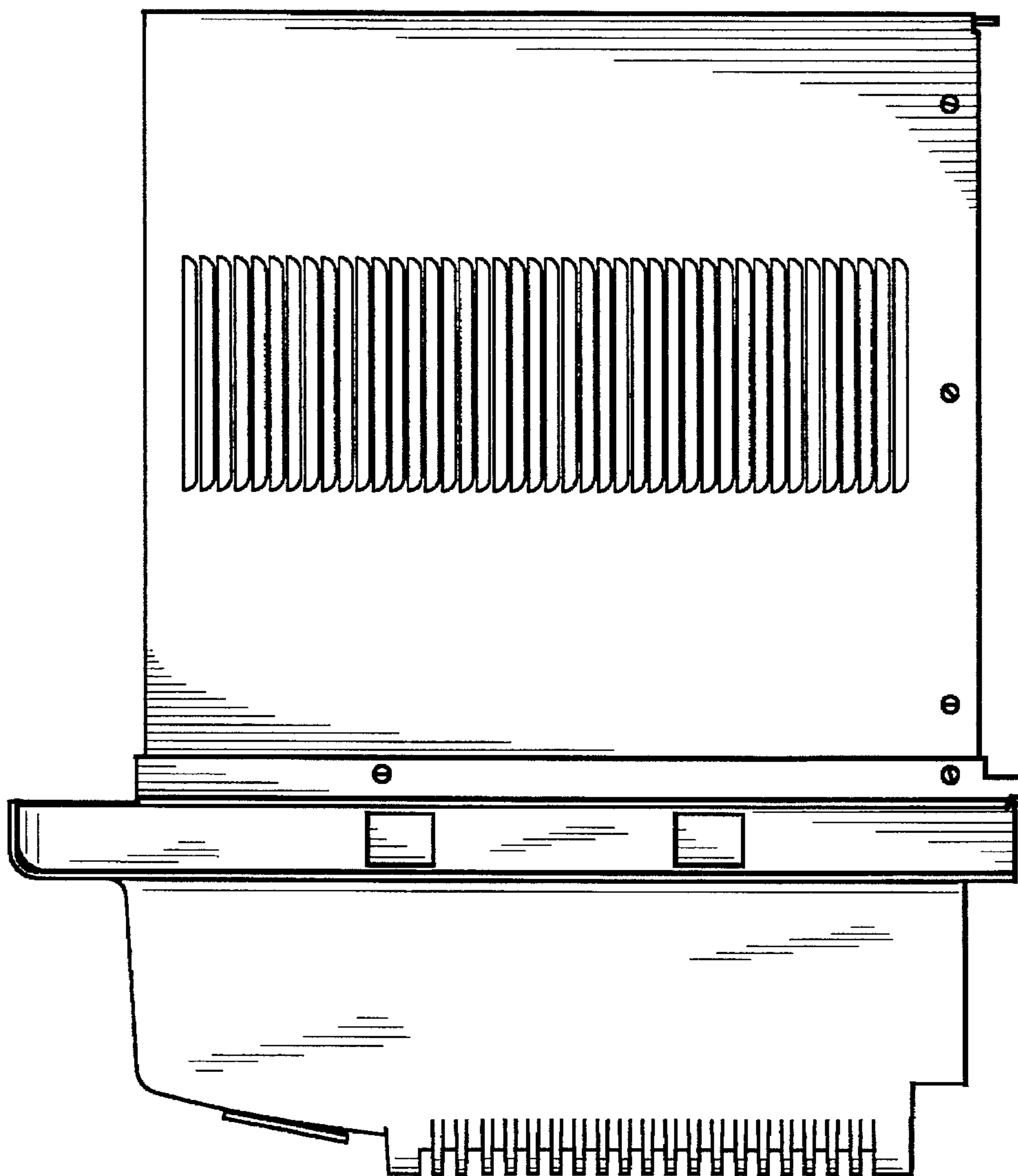

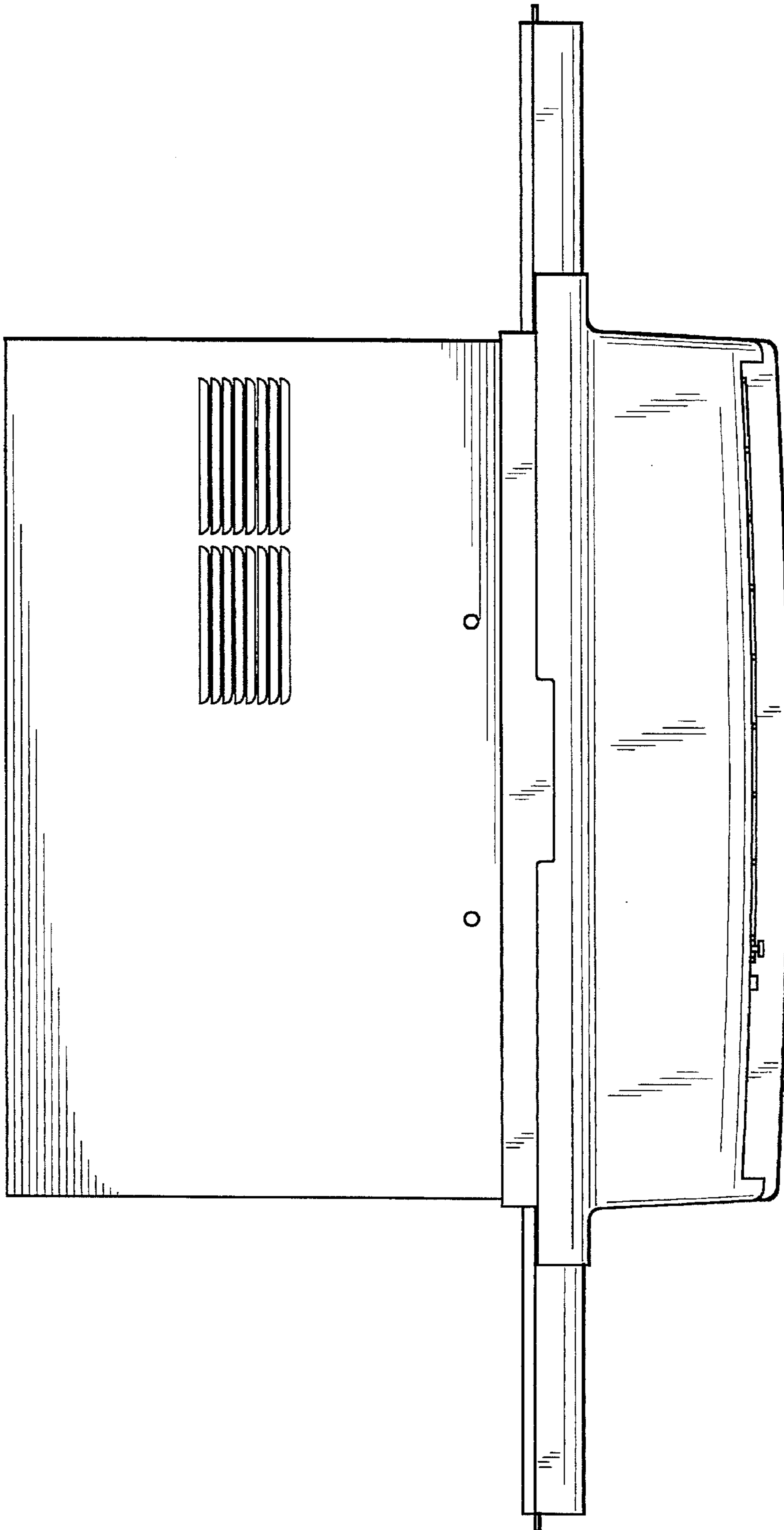

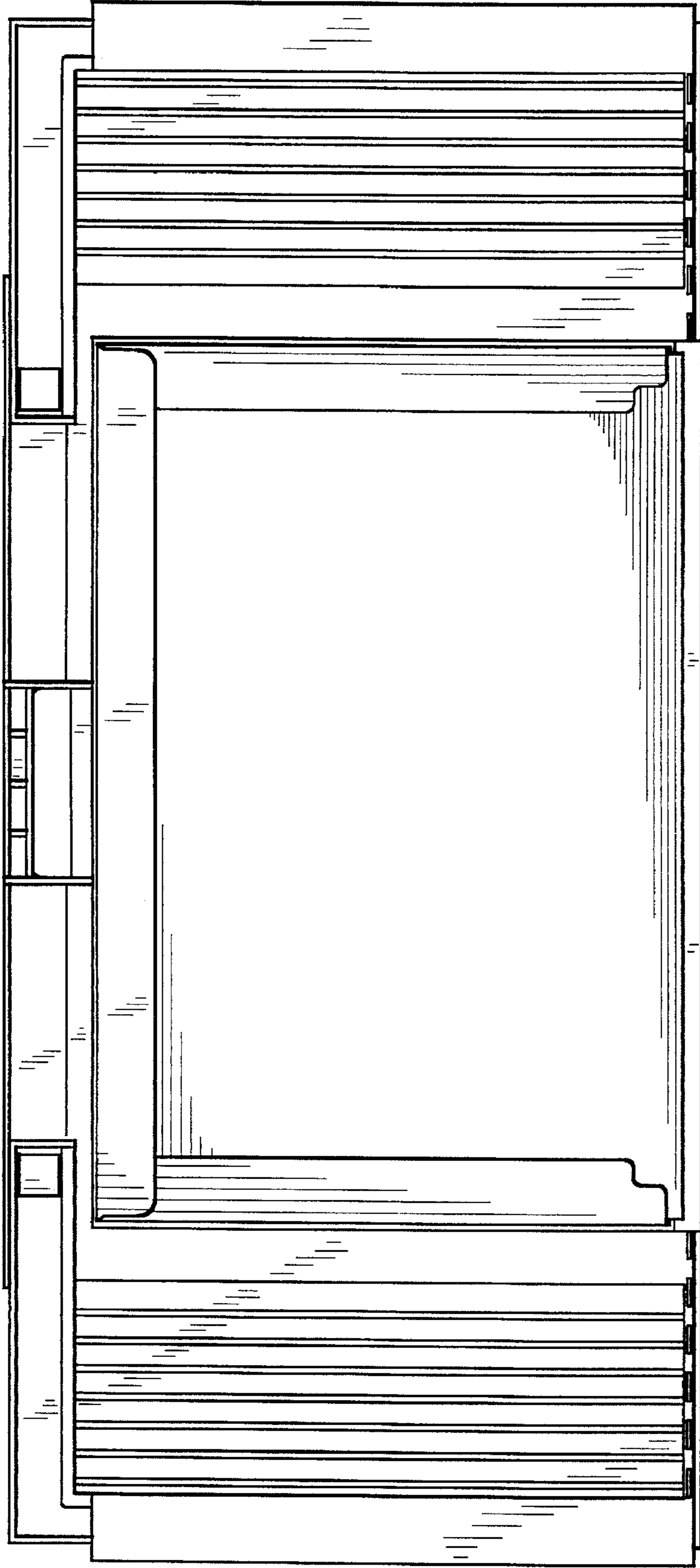

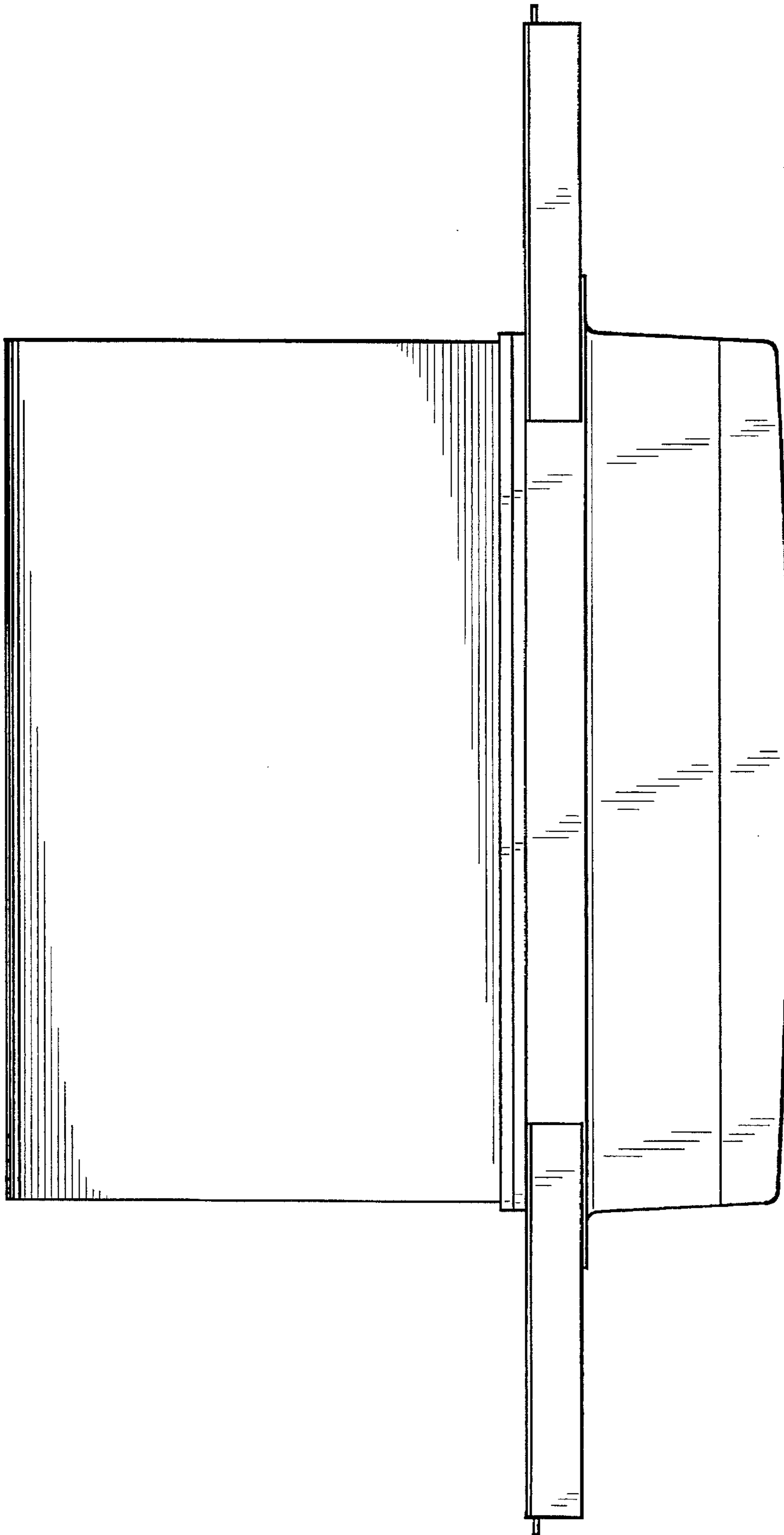
