[57] CLAIM

The ornamental design for a sample analysis cuvette, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a sample analysis cuvette showing our new design, the rear view being essentially identical thereto;

FIG. 2 is a top plan view of the embodiment of FIG. 1;

FIG. 3 is a right side view of the embodiment of FIG. 1, the left side view being essentially identical thereto;

FIG. 4 is a bottom plan view of the embodiment of FIG. 1;

FIG. 5 is an elevated perspective view of the embodiment of FIG. 1;

FIG. 6 is a front view of a second embodiment of a sample analysis cuvette showing our new design, the rear view being essentially identical thereto;

FIG. 7 is a top plan view of the embodiment of FIG. 6;

FIG. 8 is a right side view of the embodiment of FIG. 6, the left side view being essentially identical thereto;

FIG. 9 is a bottom plan view of the embodiment of FIG. 6;

FIG. 10 is an elevated perspective view of the embodiment of FIG. 6.

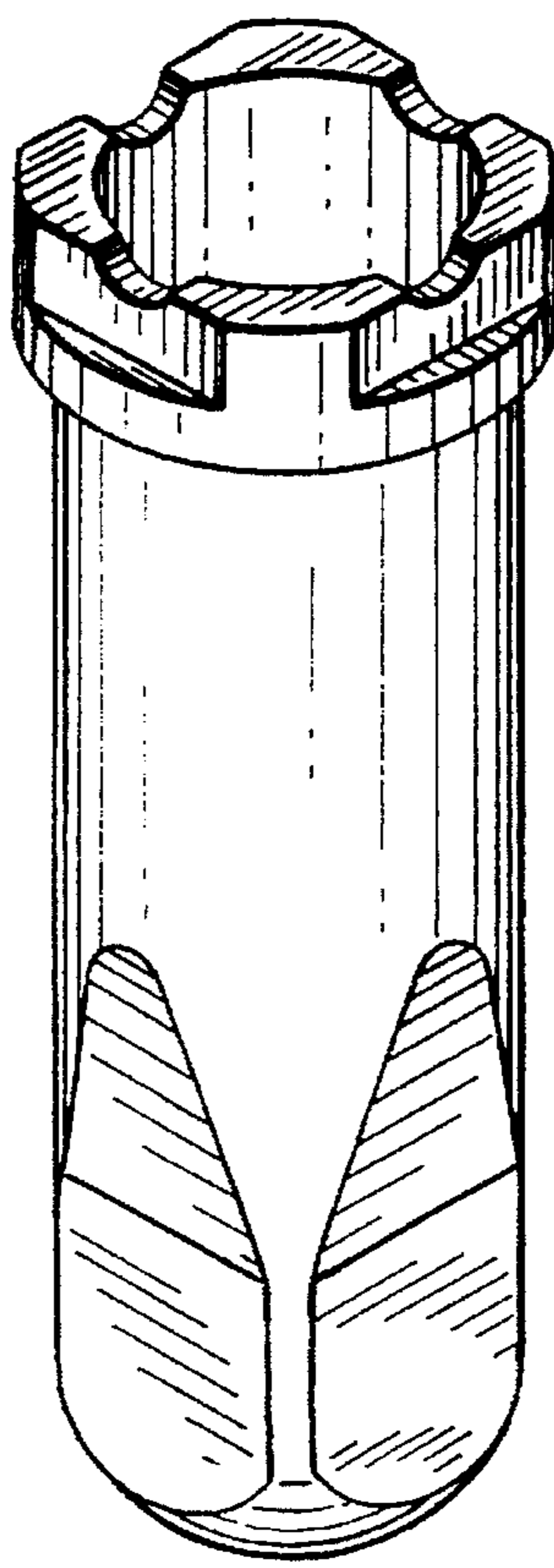
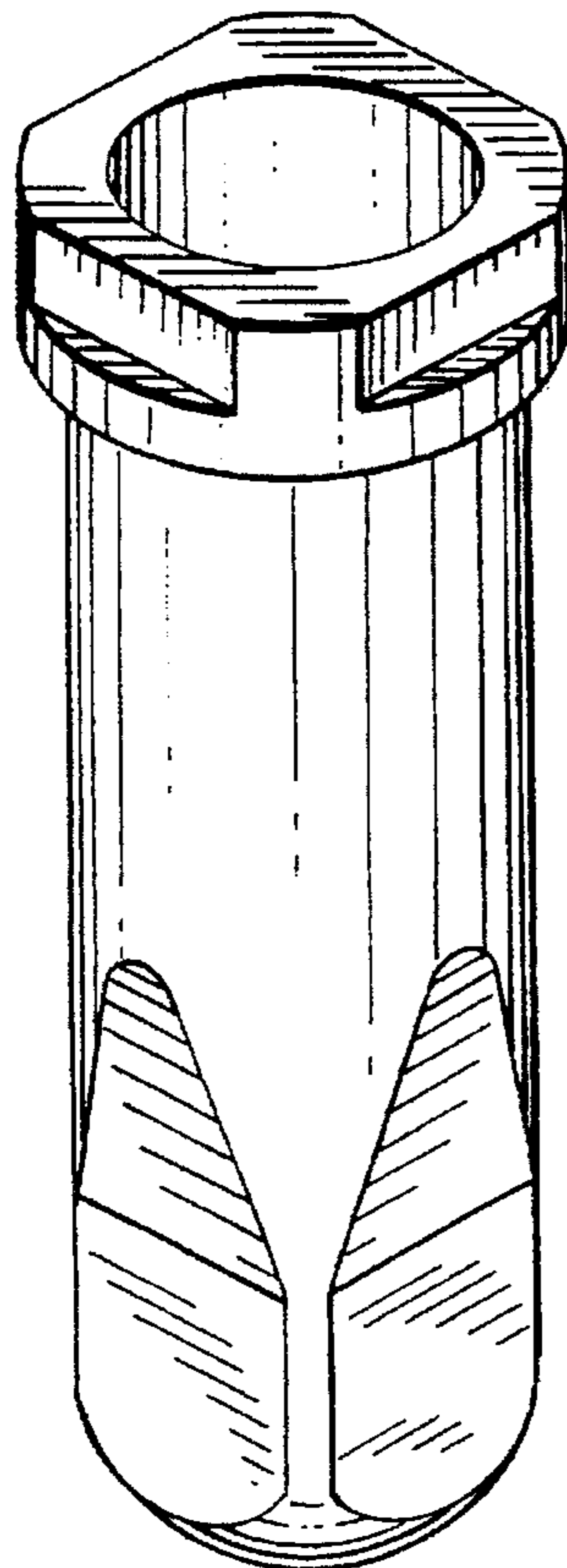

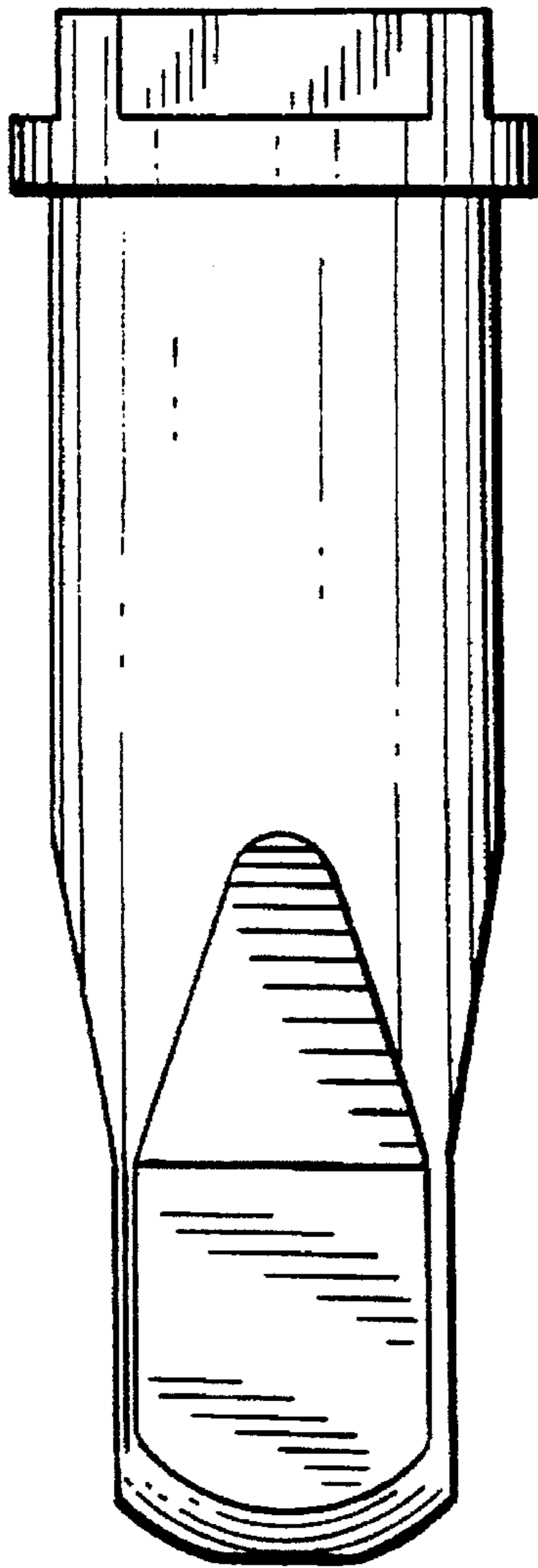

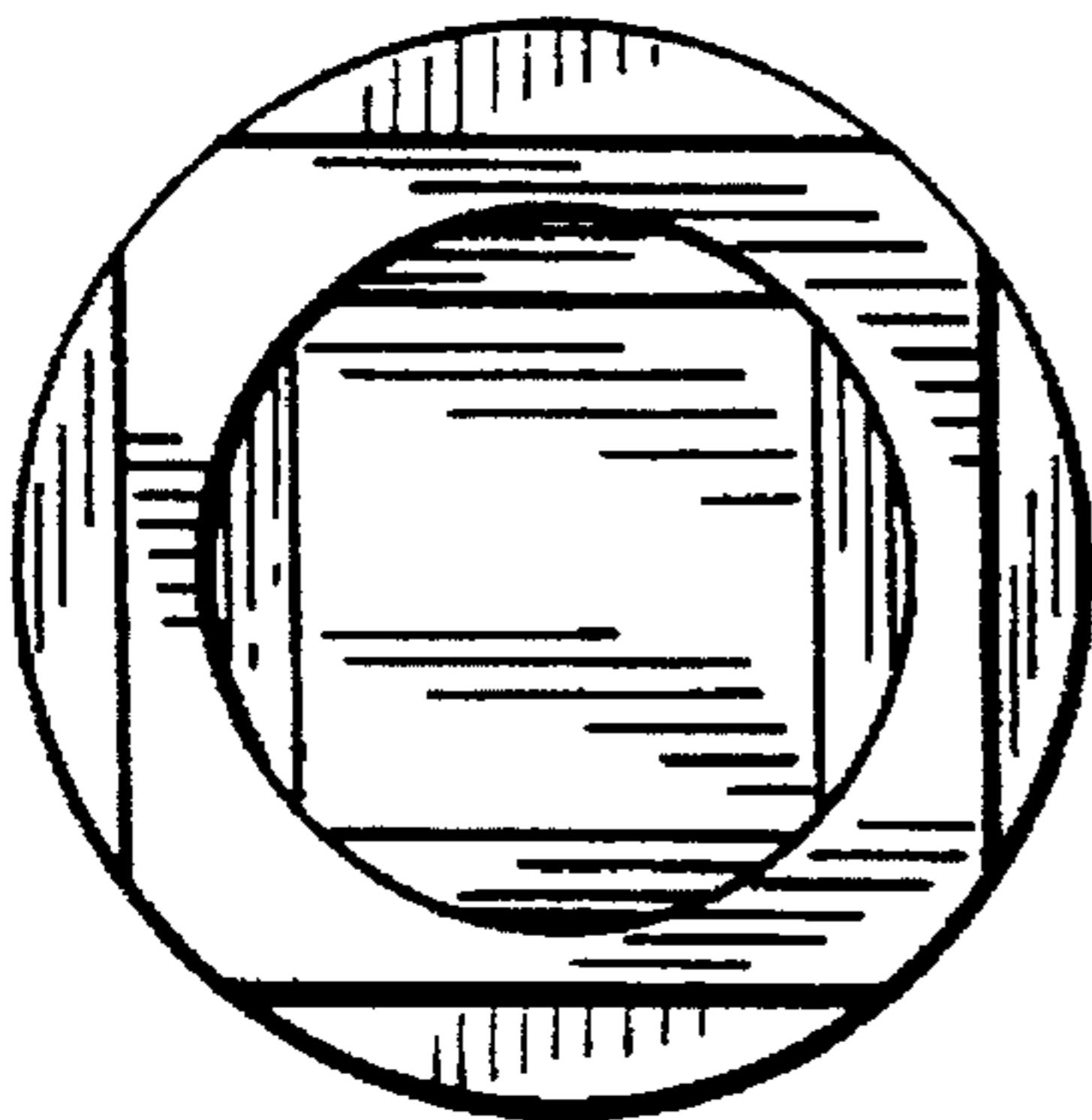
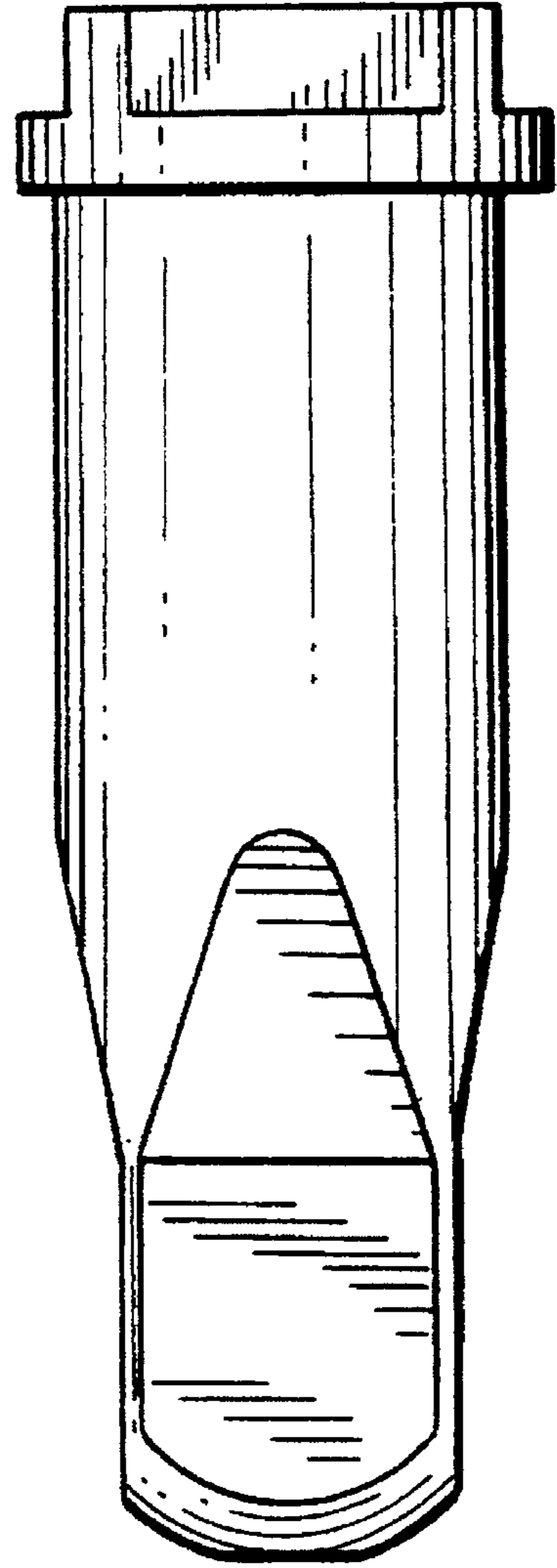

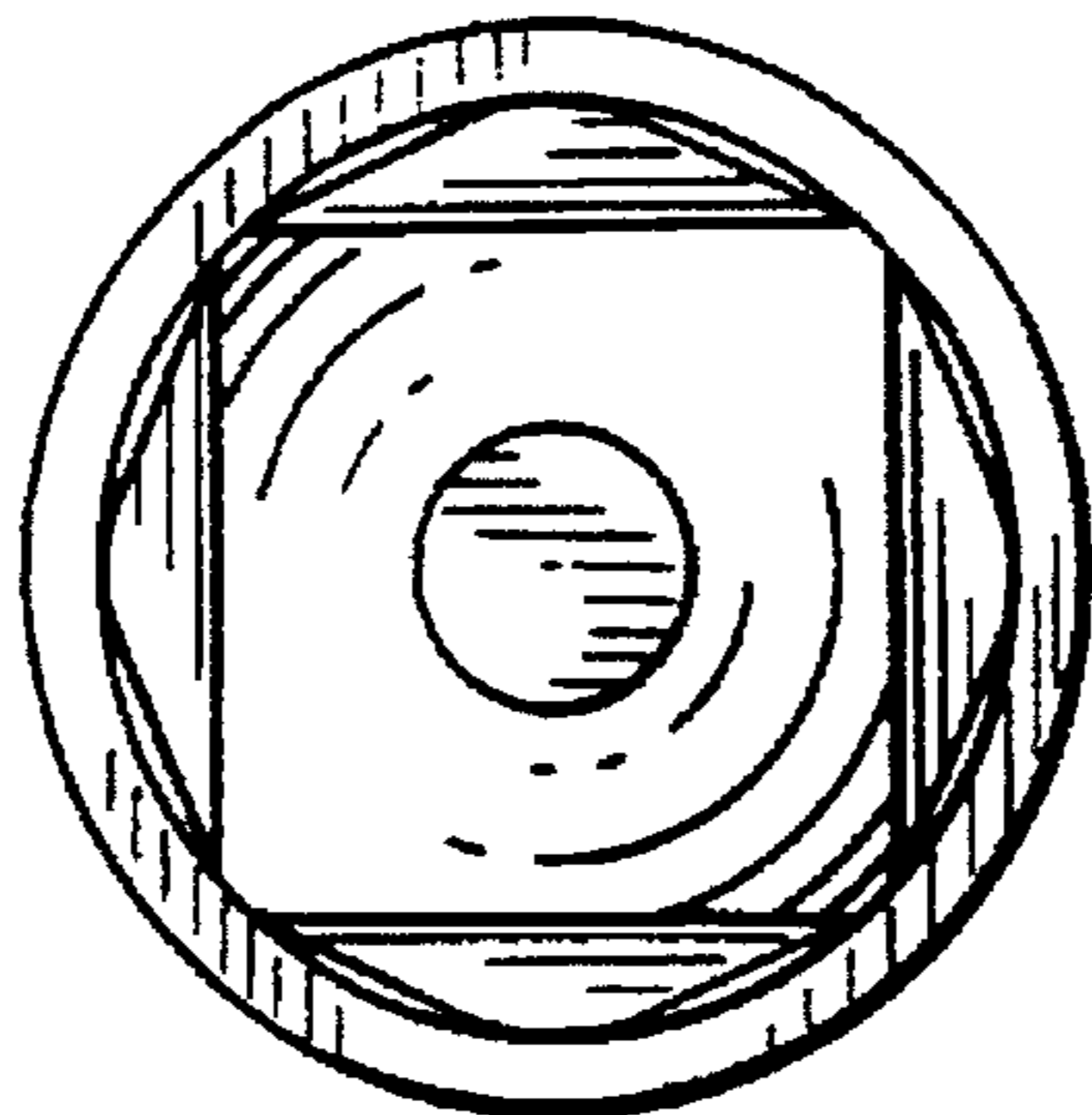

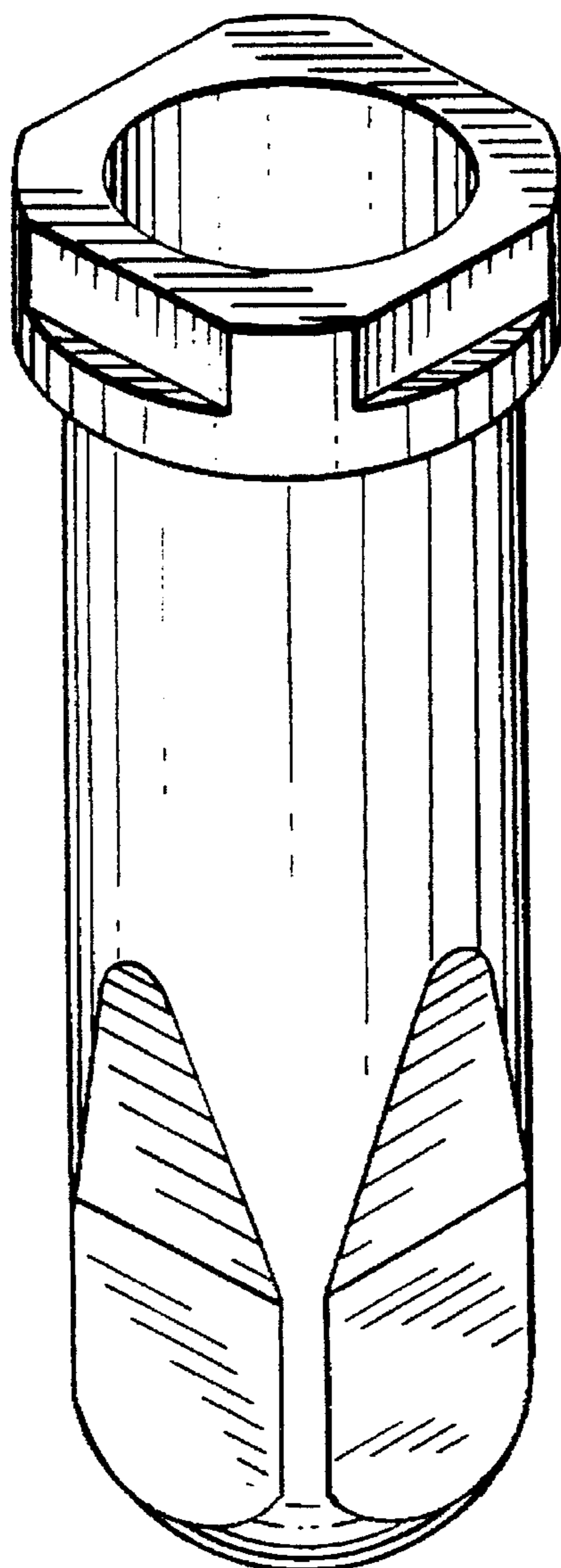

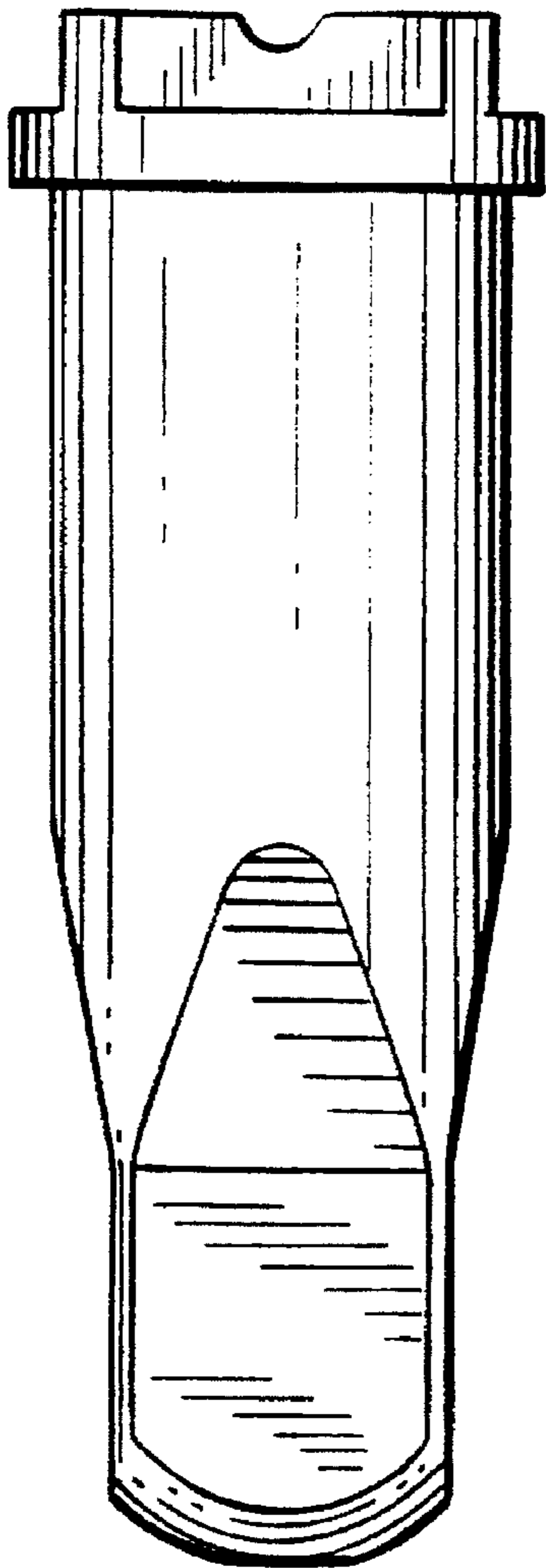

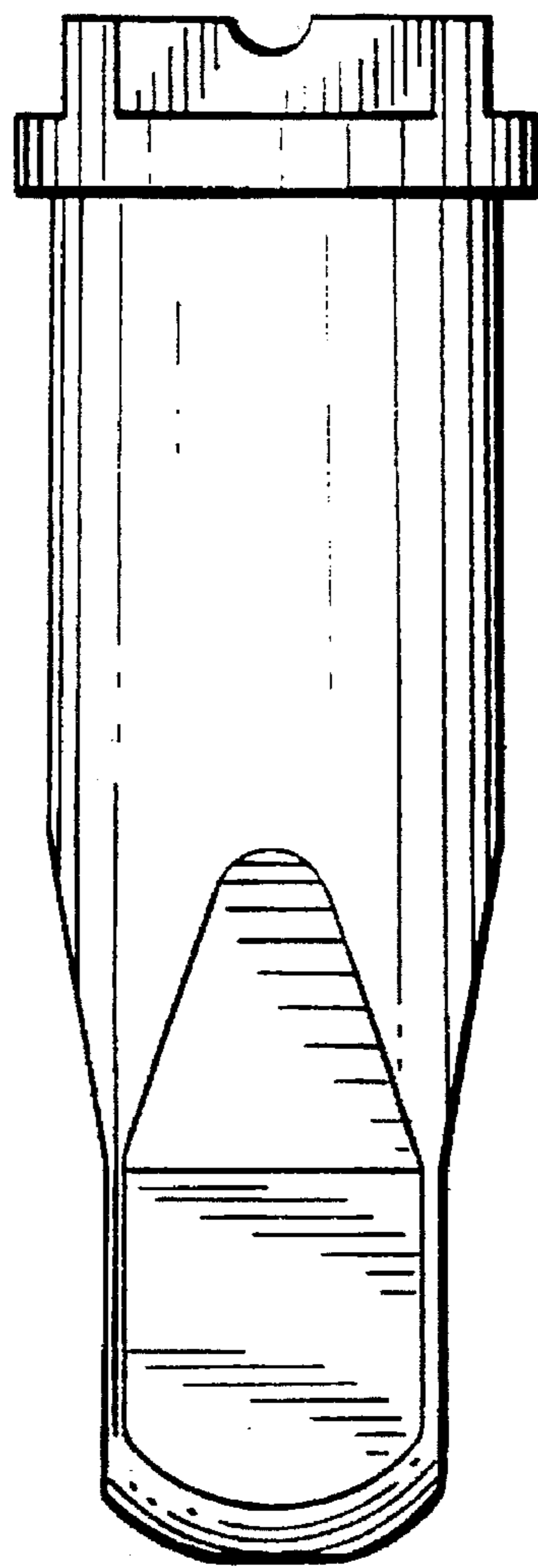

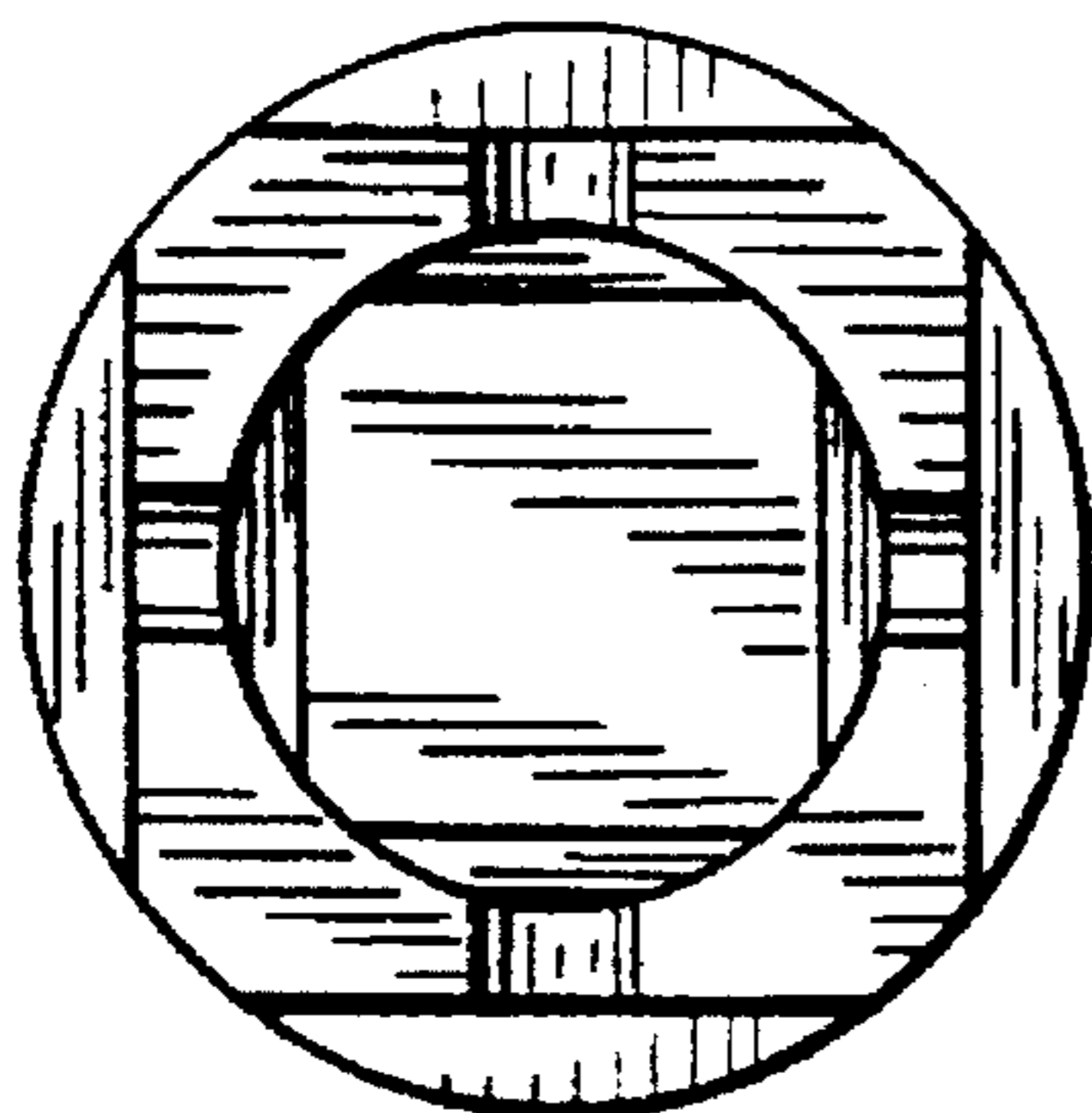

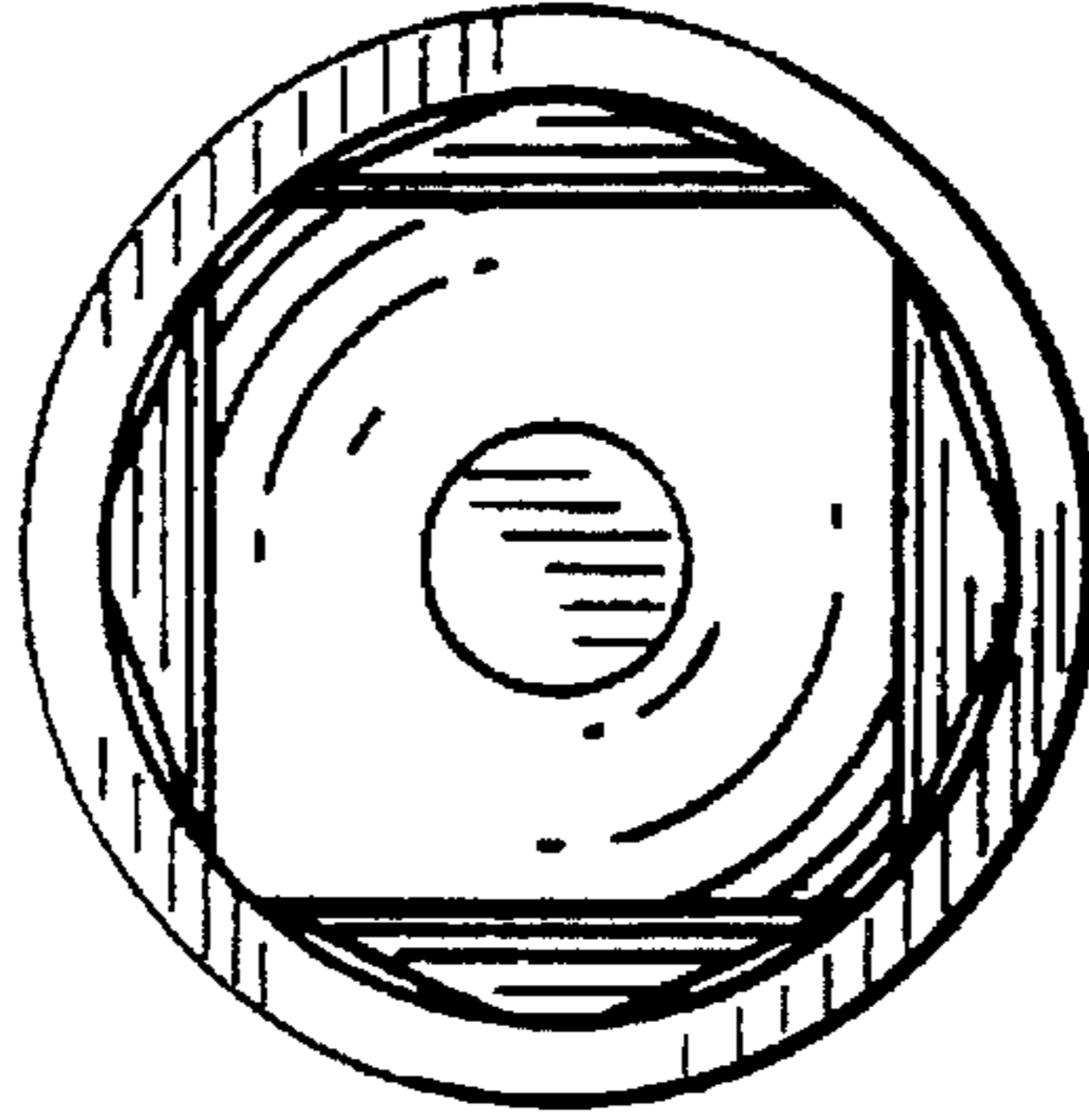
